The ornamental design for a card, as shown and described.

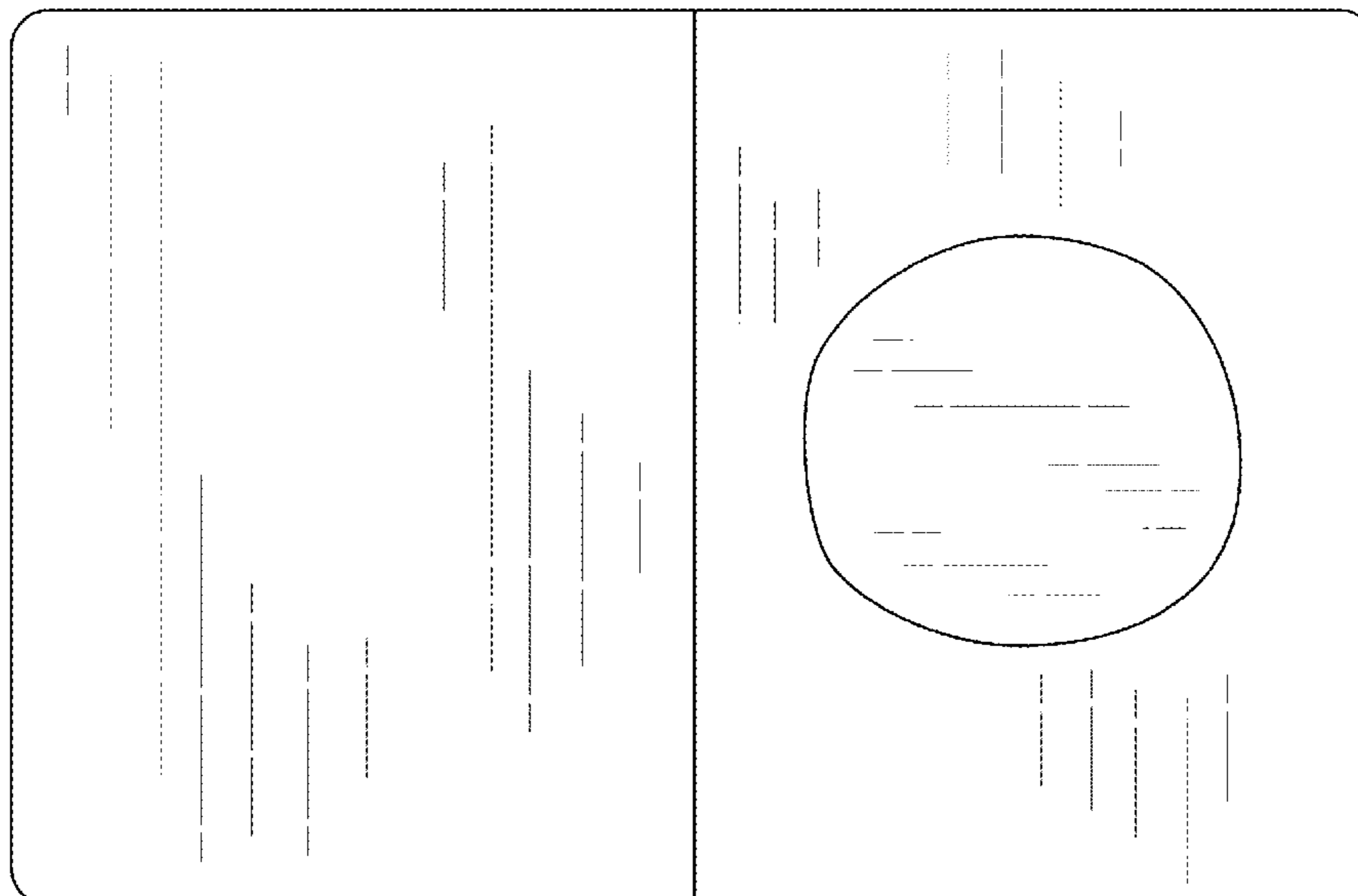
DESCRIPTION

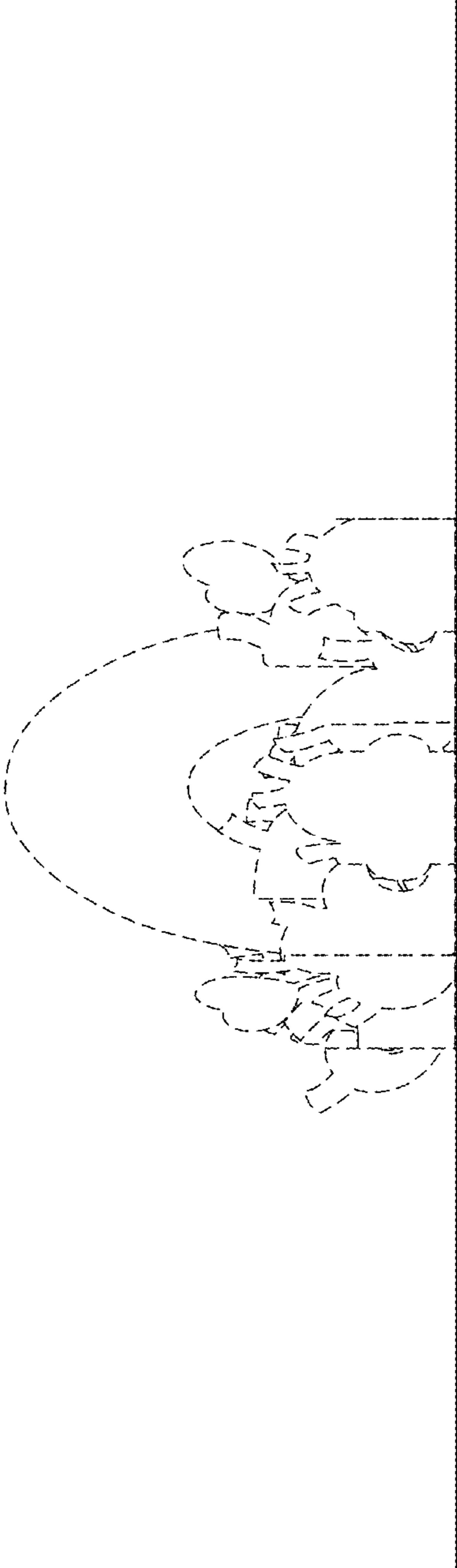

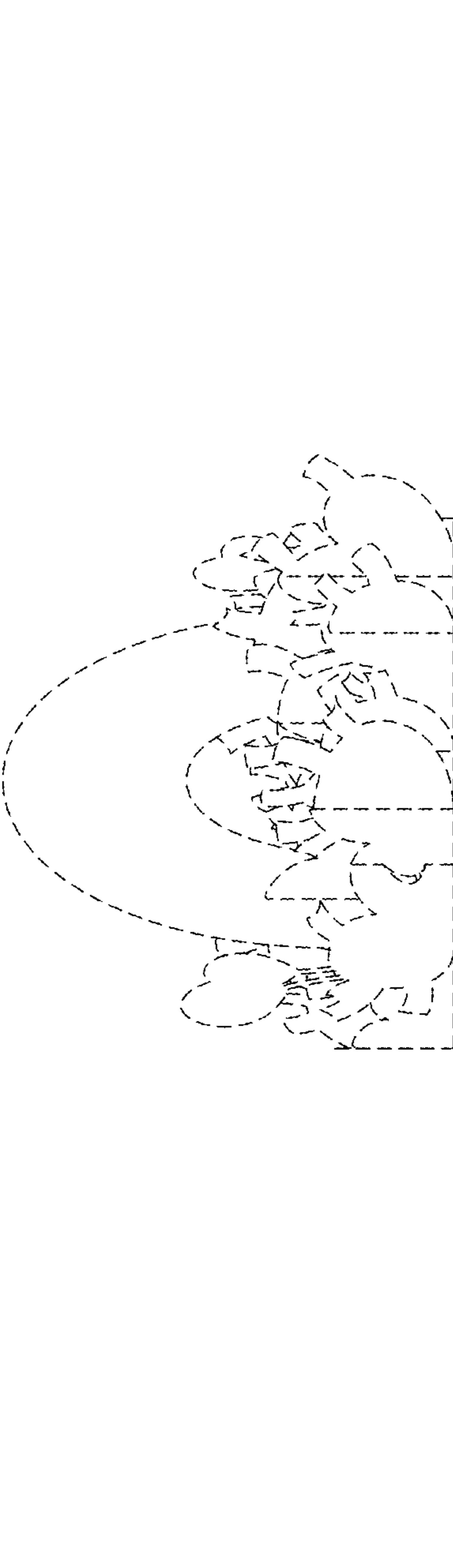

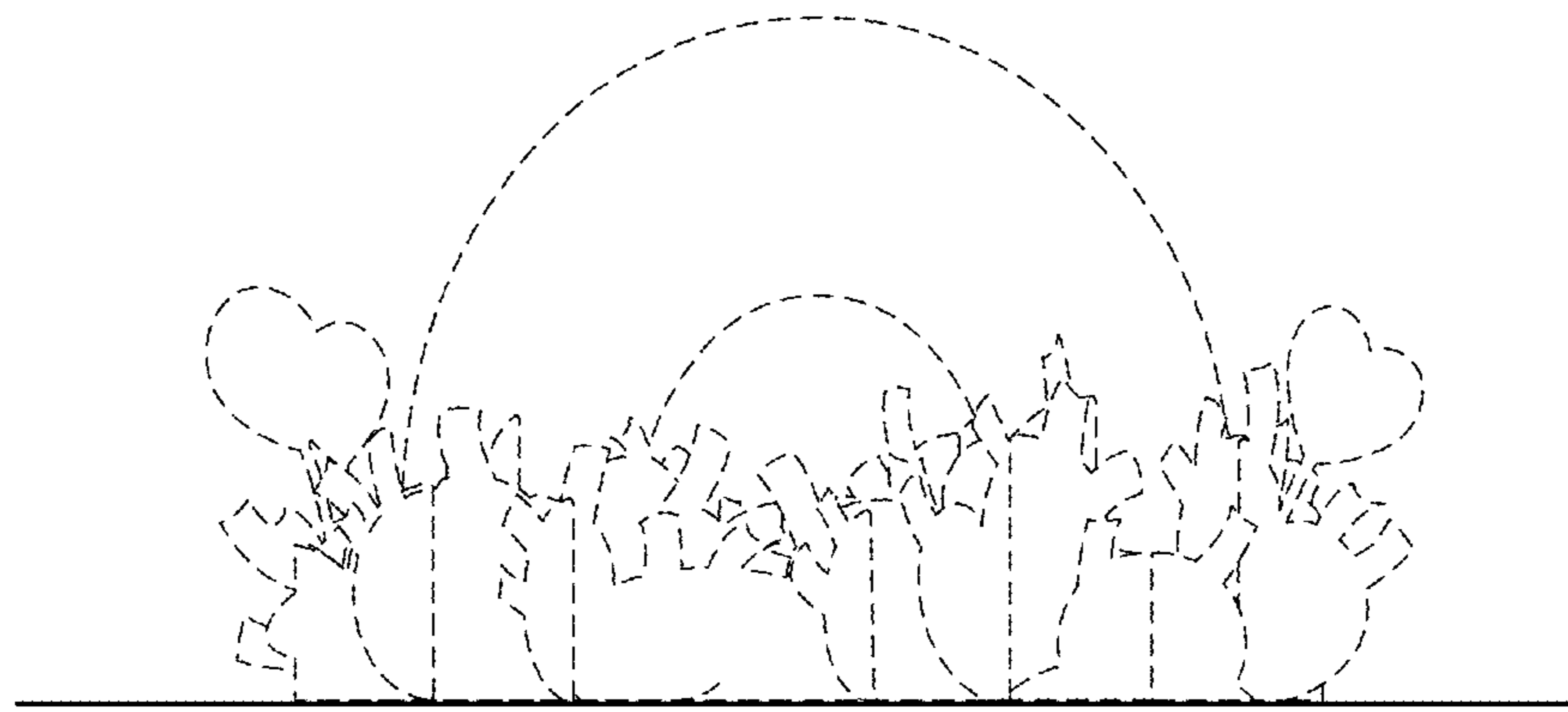

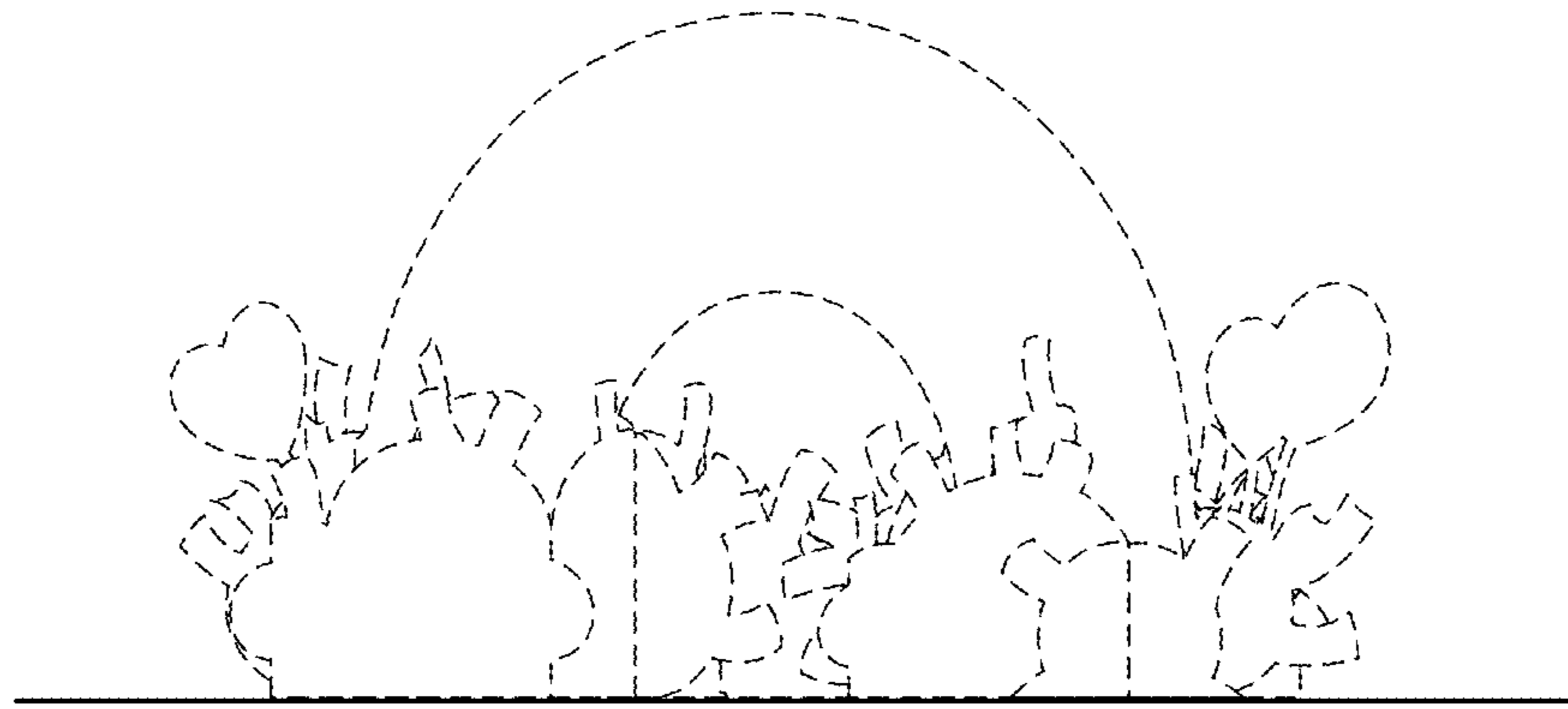

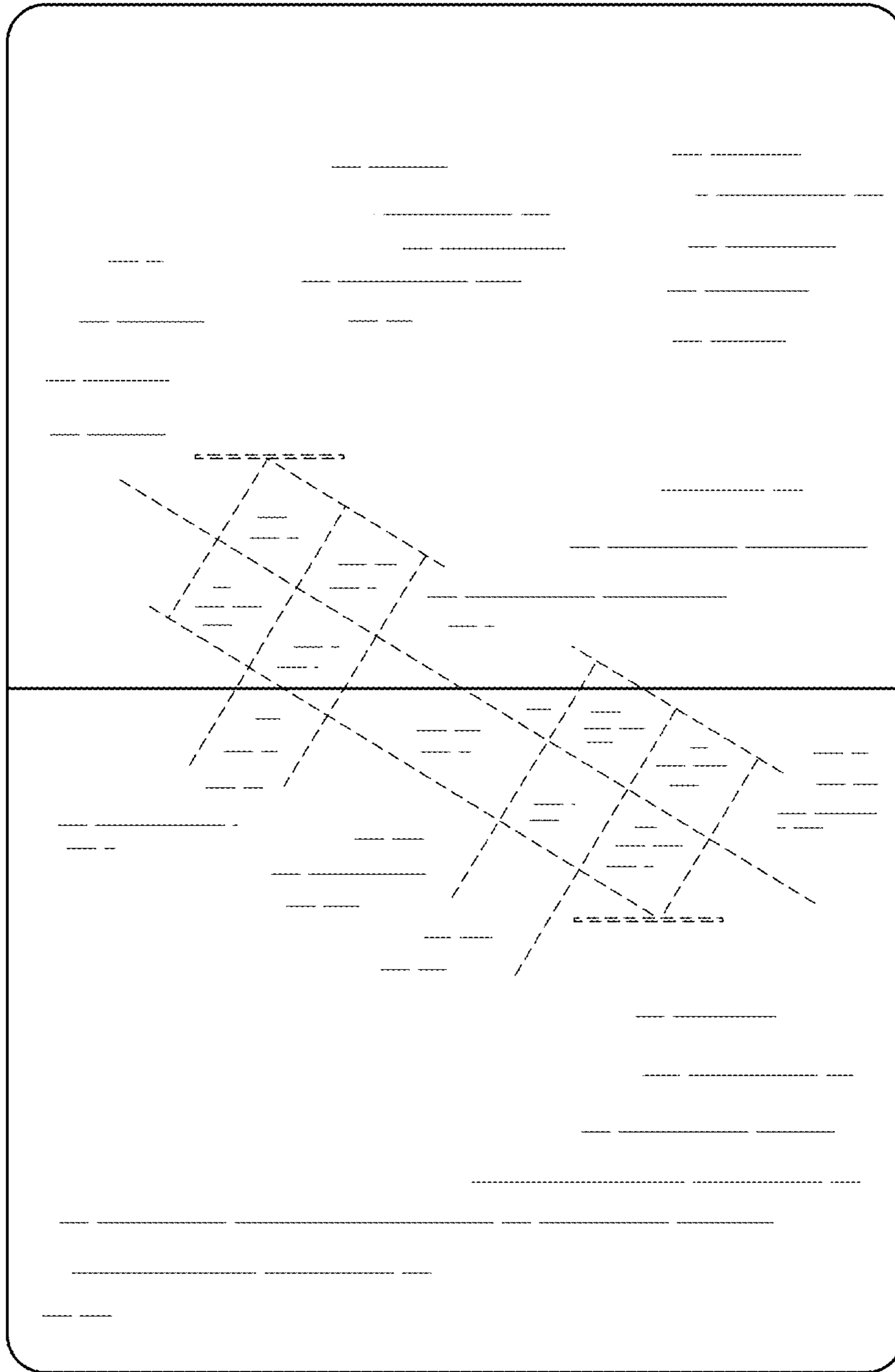

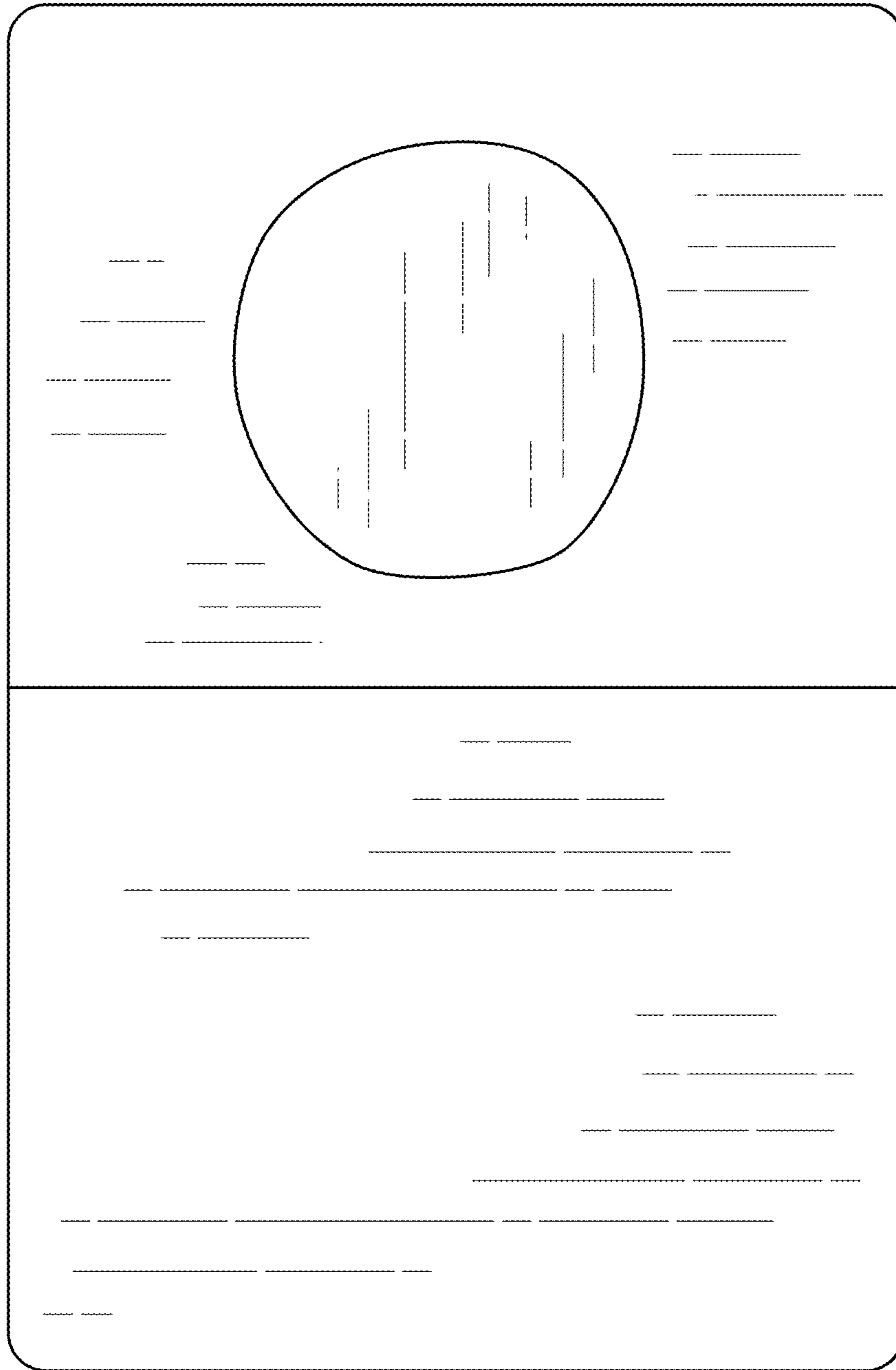
