(57) **CLAIM**

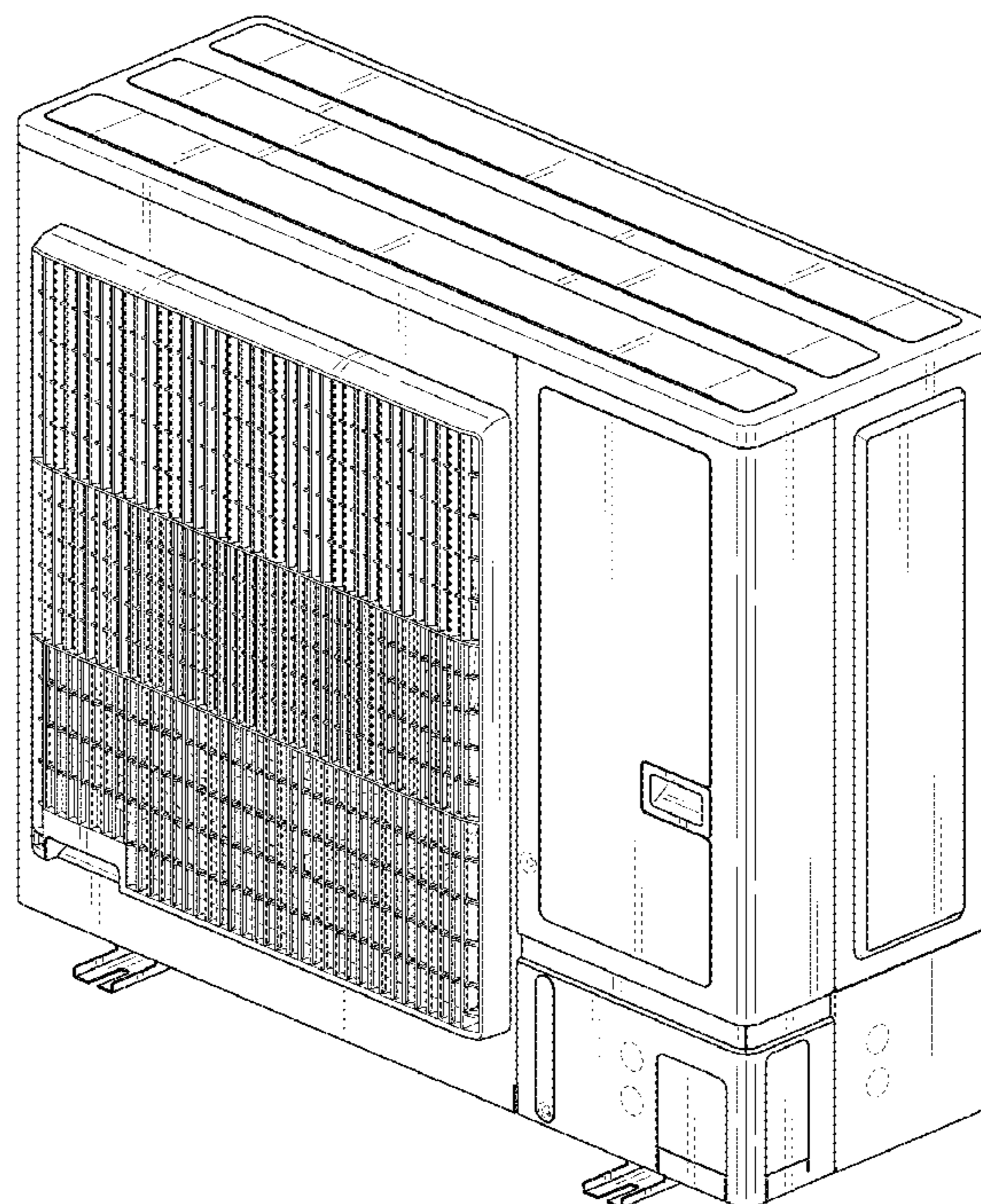
The ornamental design for an outdoor unit for air conditioner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an outdoor unit for air conditioner showing my new design;

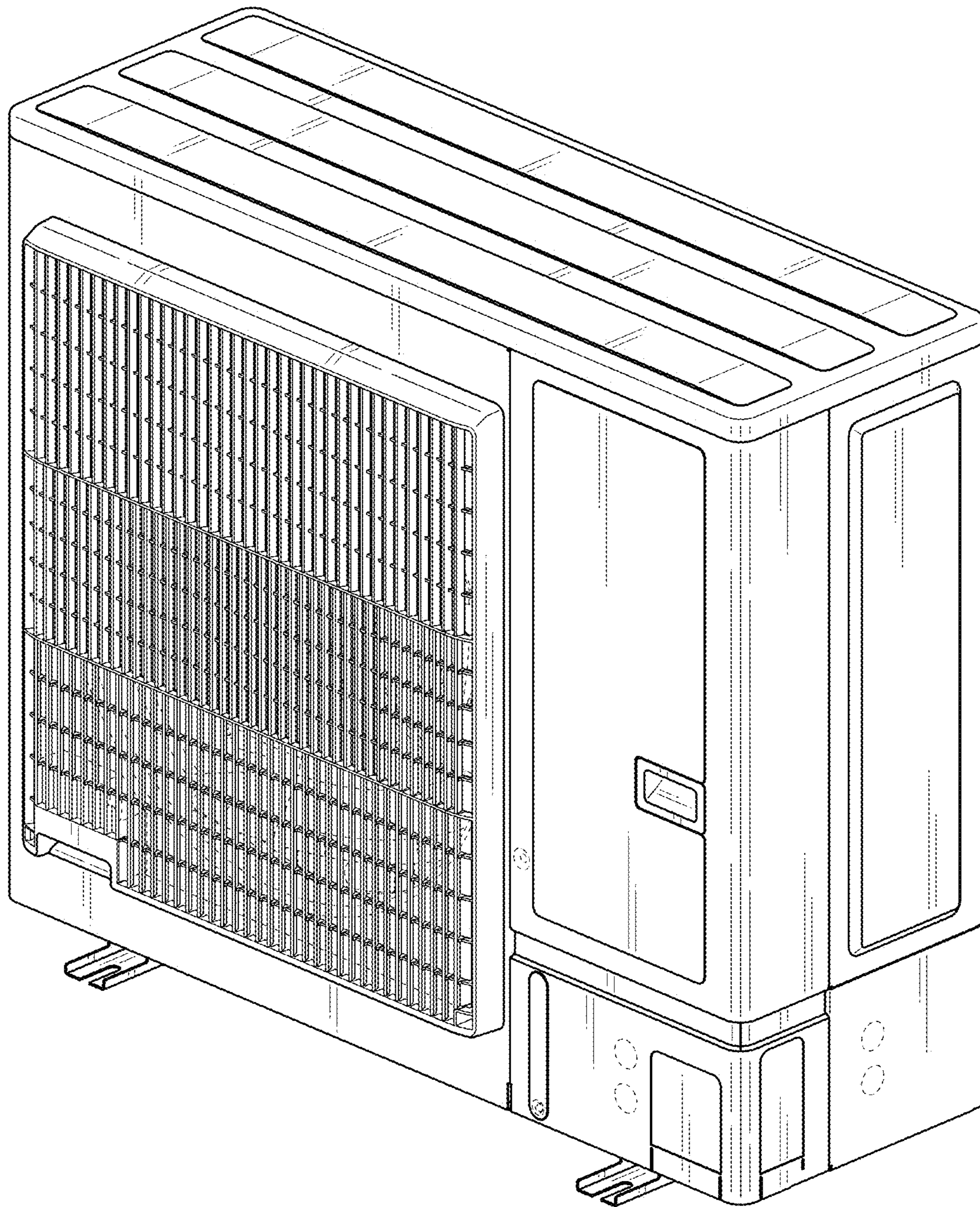

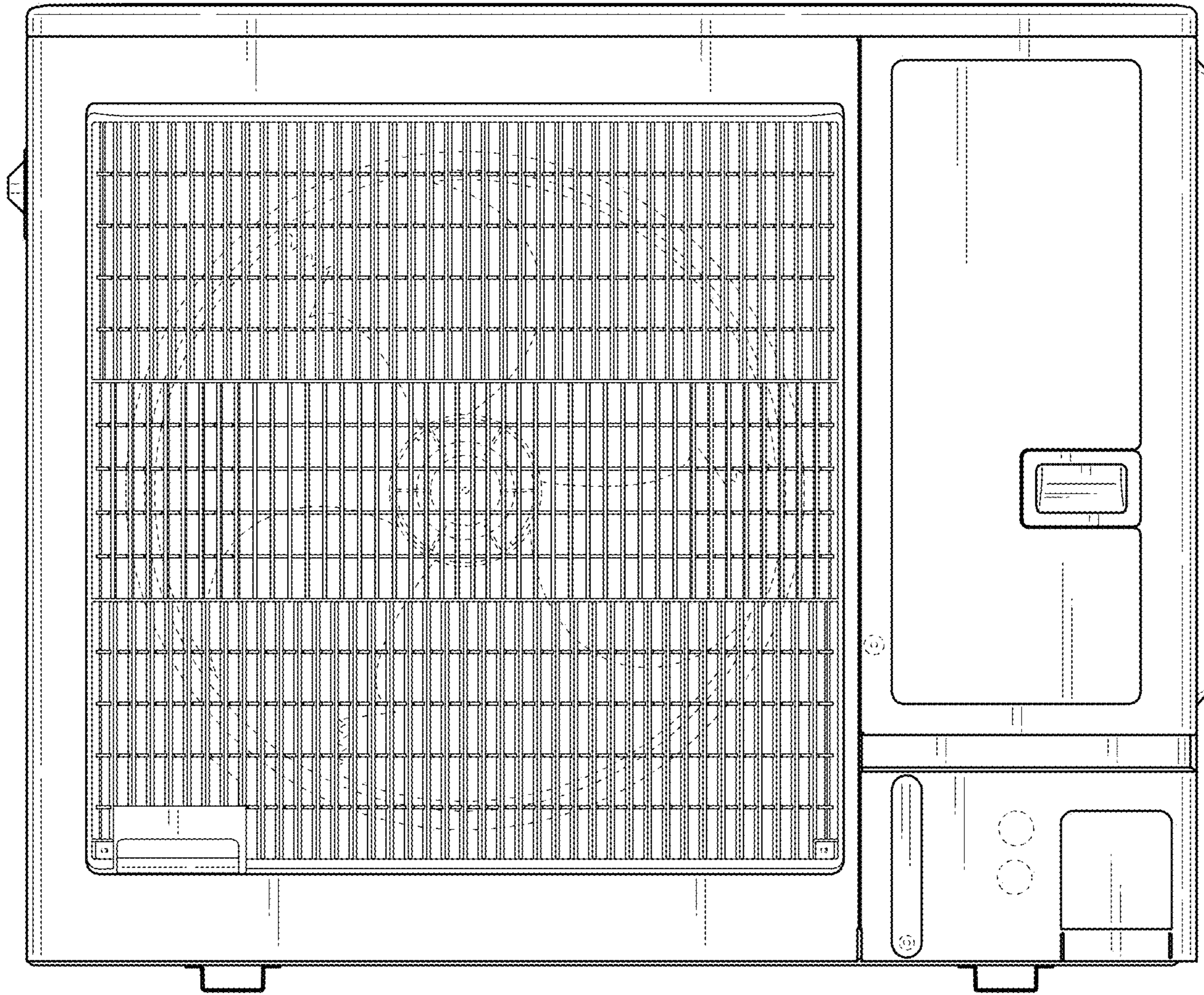

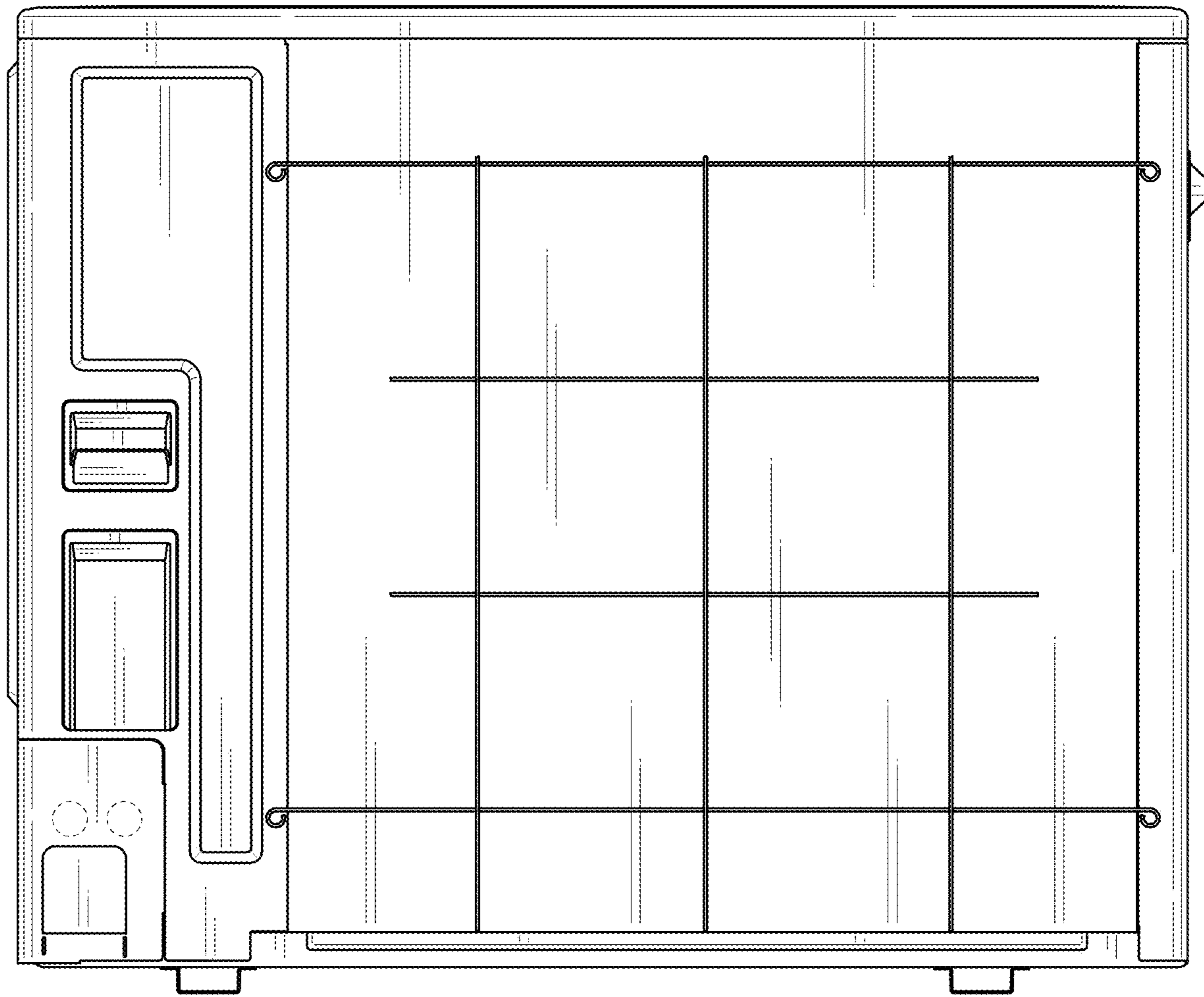

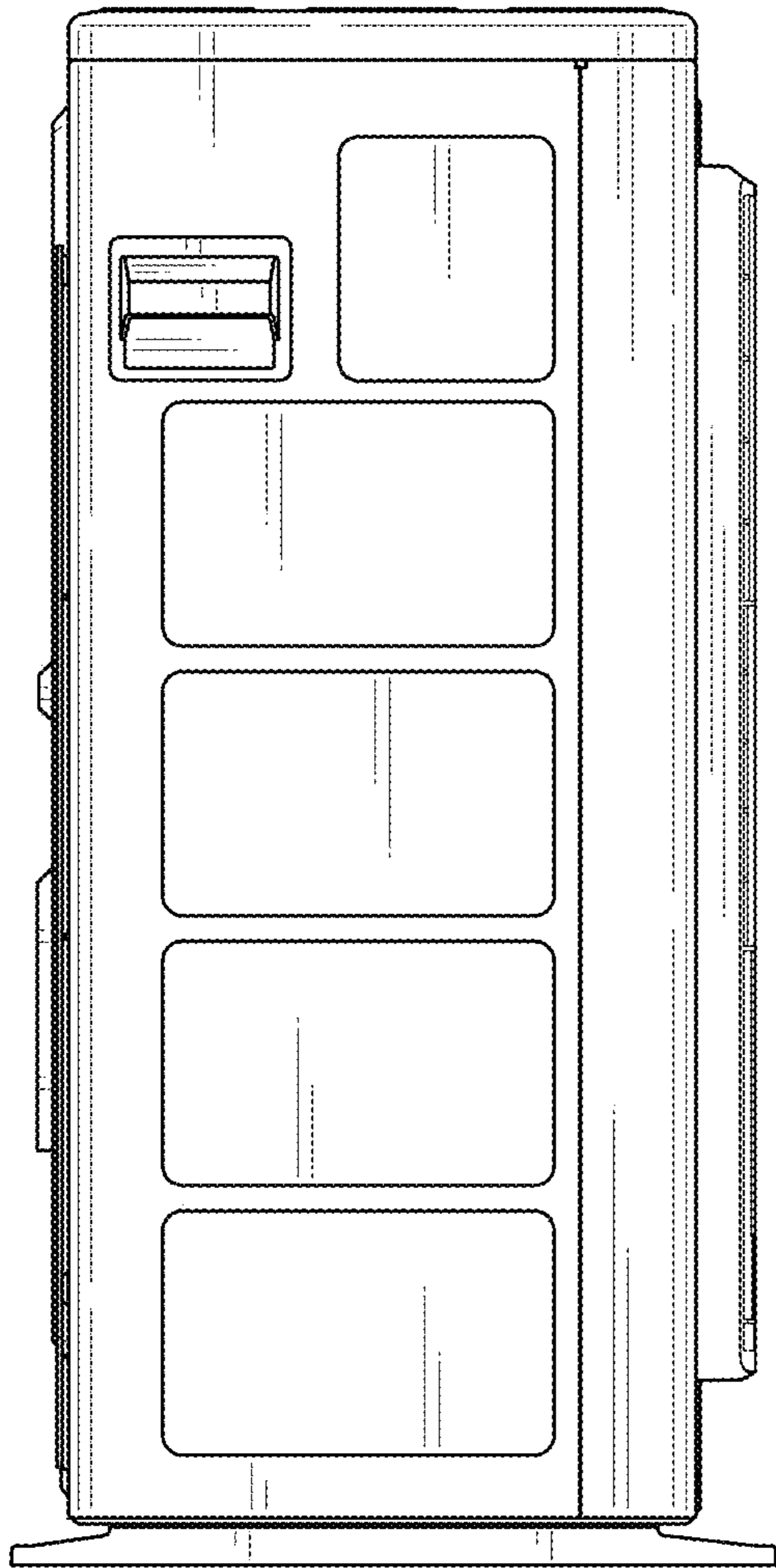

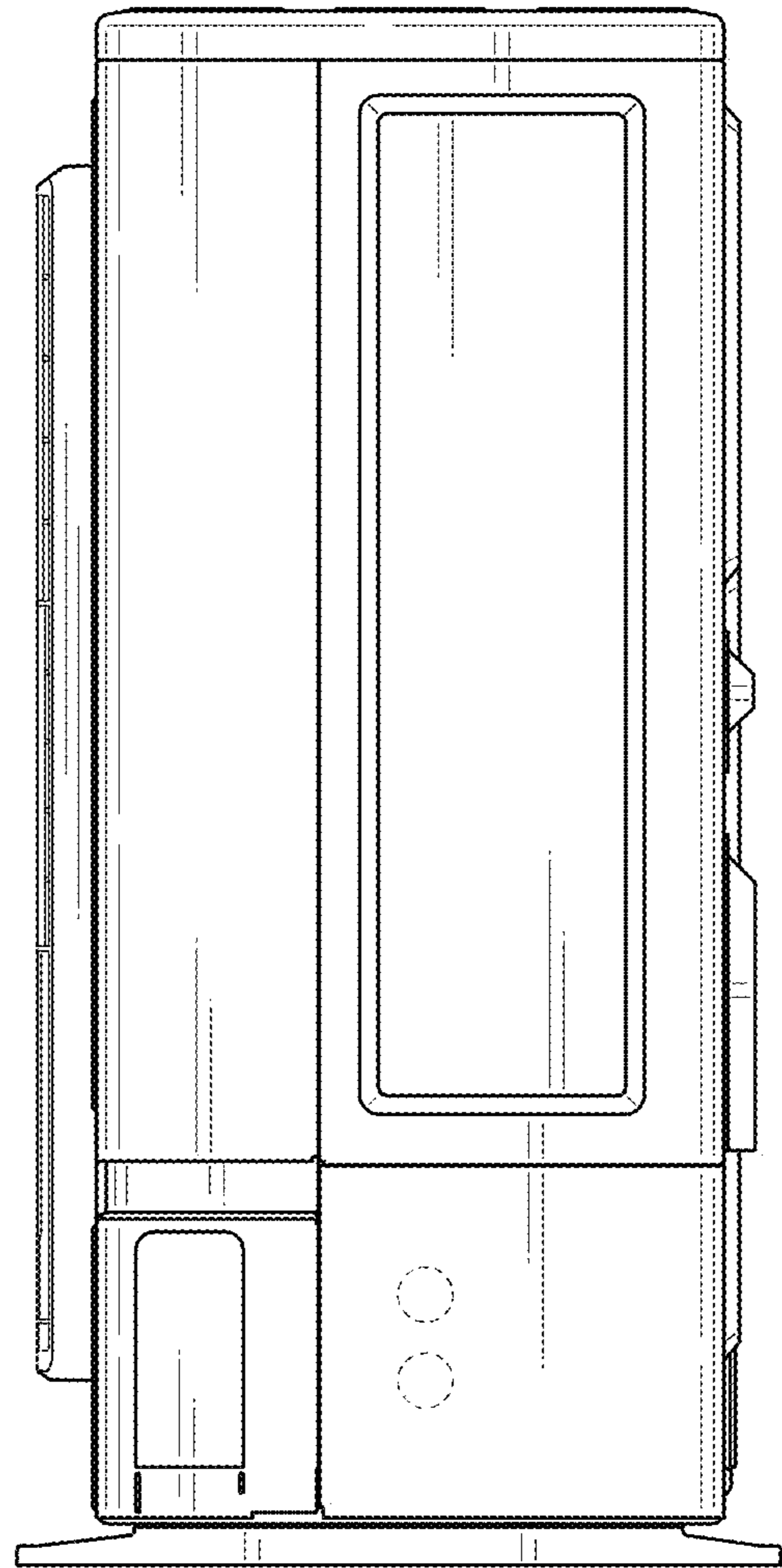

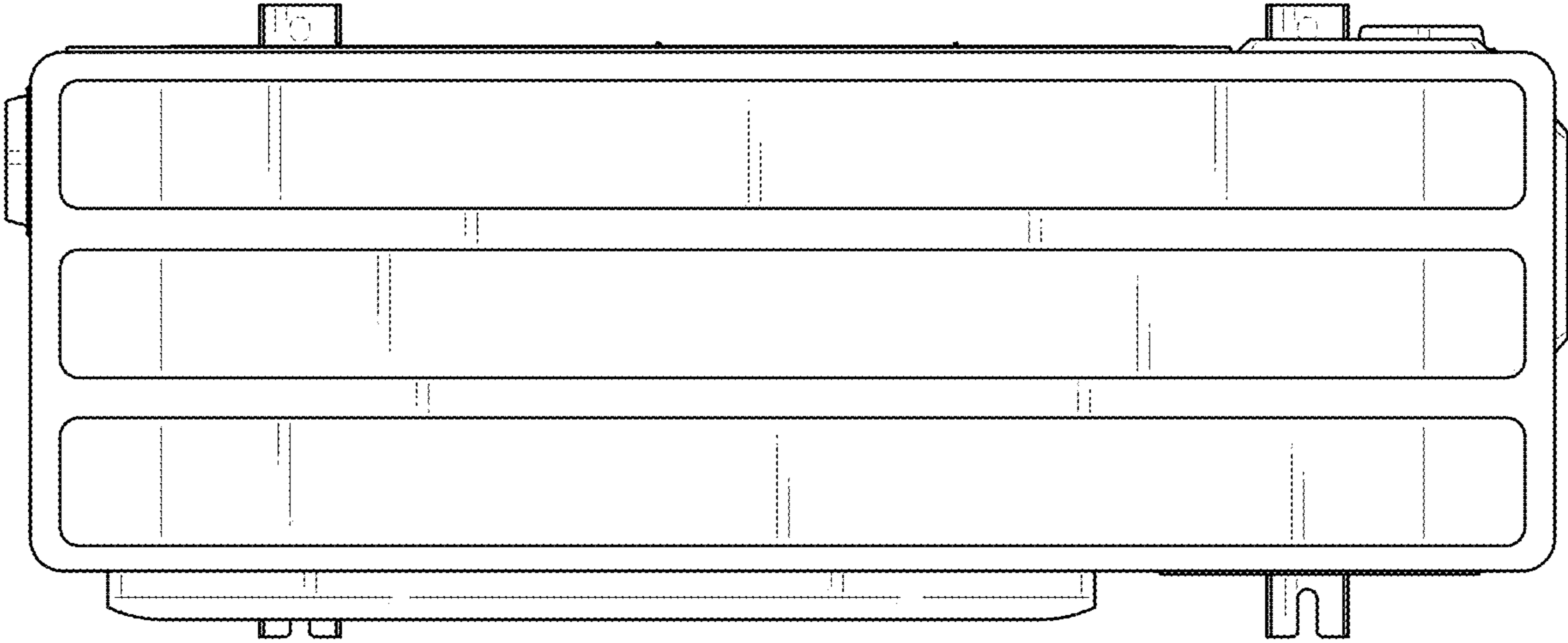

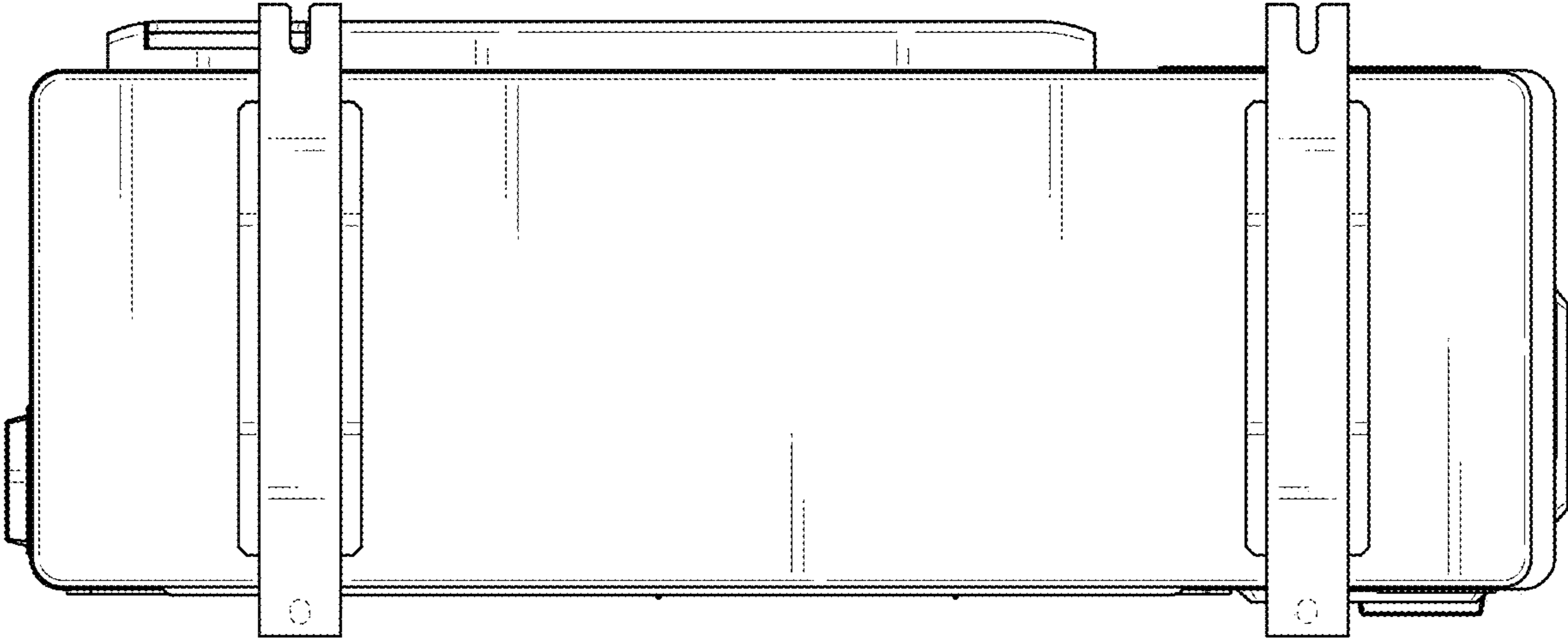
