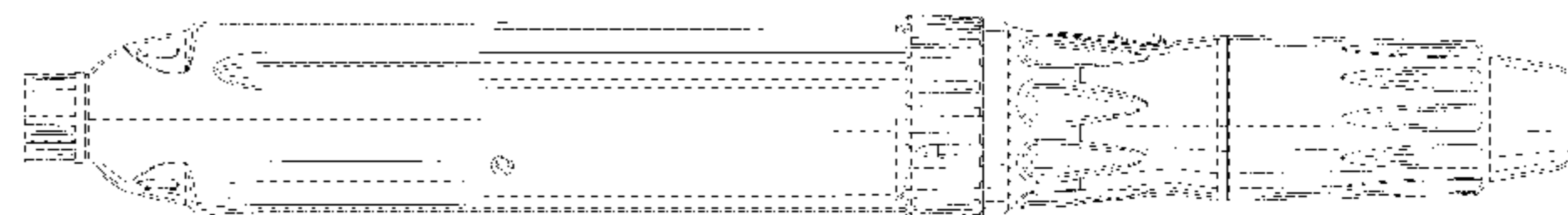
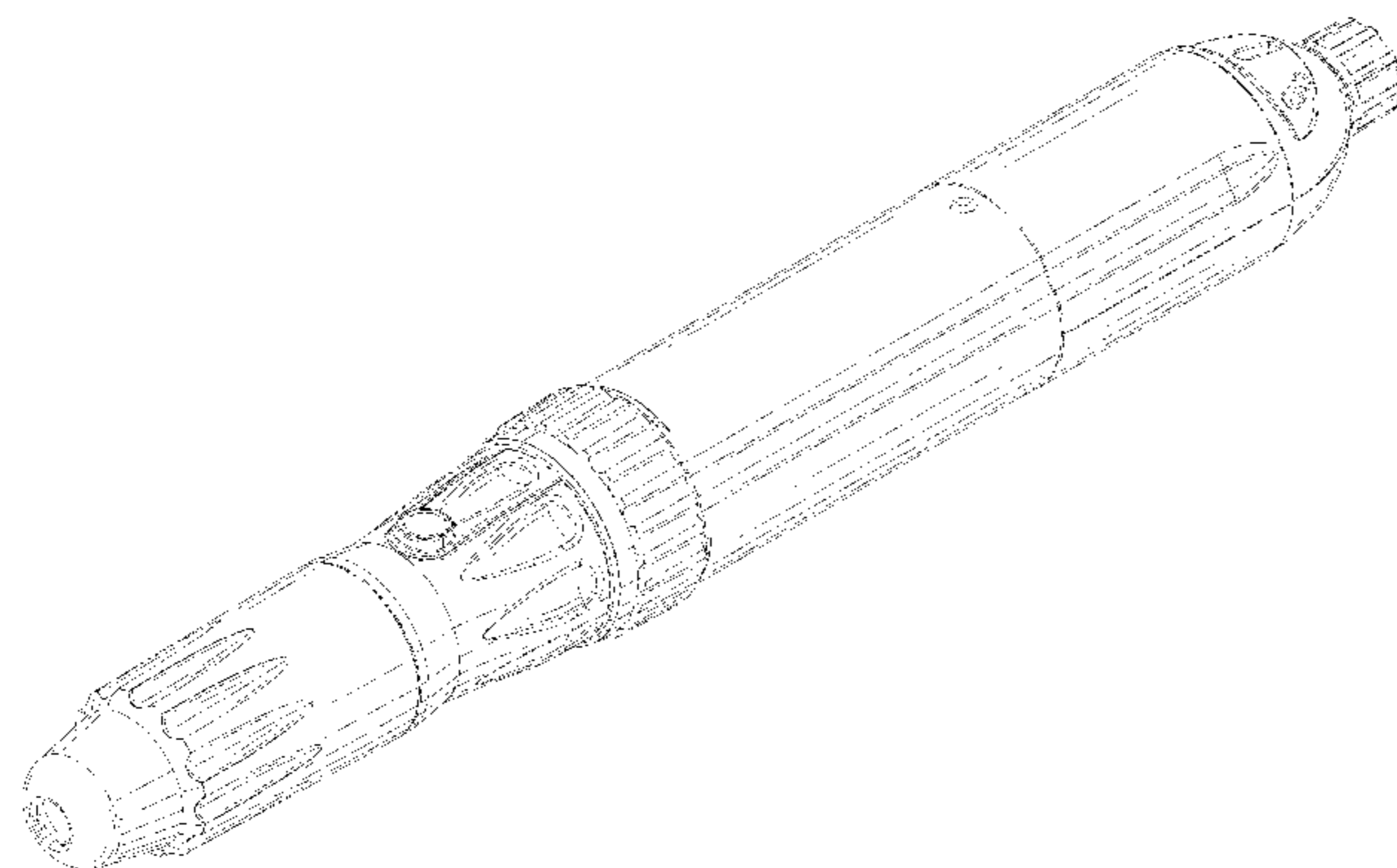
(57) **CLAIM**

The ornamental design for a modular micro tool handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a modular micro tool handle showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is an enlarged left side elevational view thereof; and,  
FIG. 9 is an enlarged right side elevational view thereof.  
The broken lines depict portions of a modular micro tool handle in which the design is embodied that form no part of the claimed design.

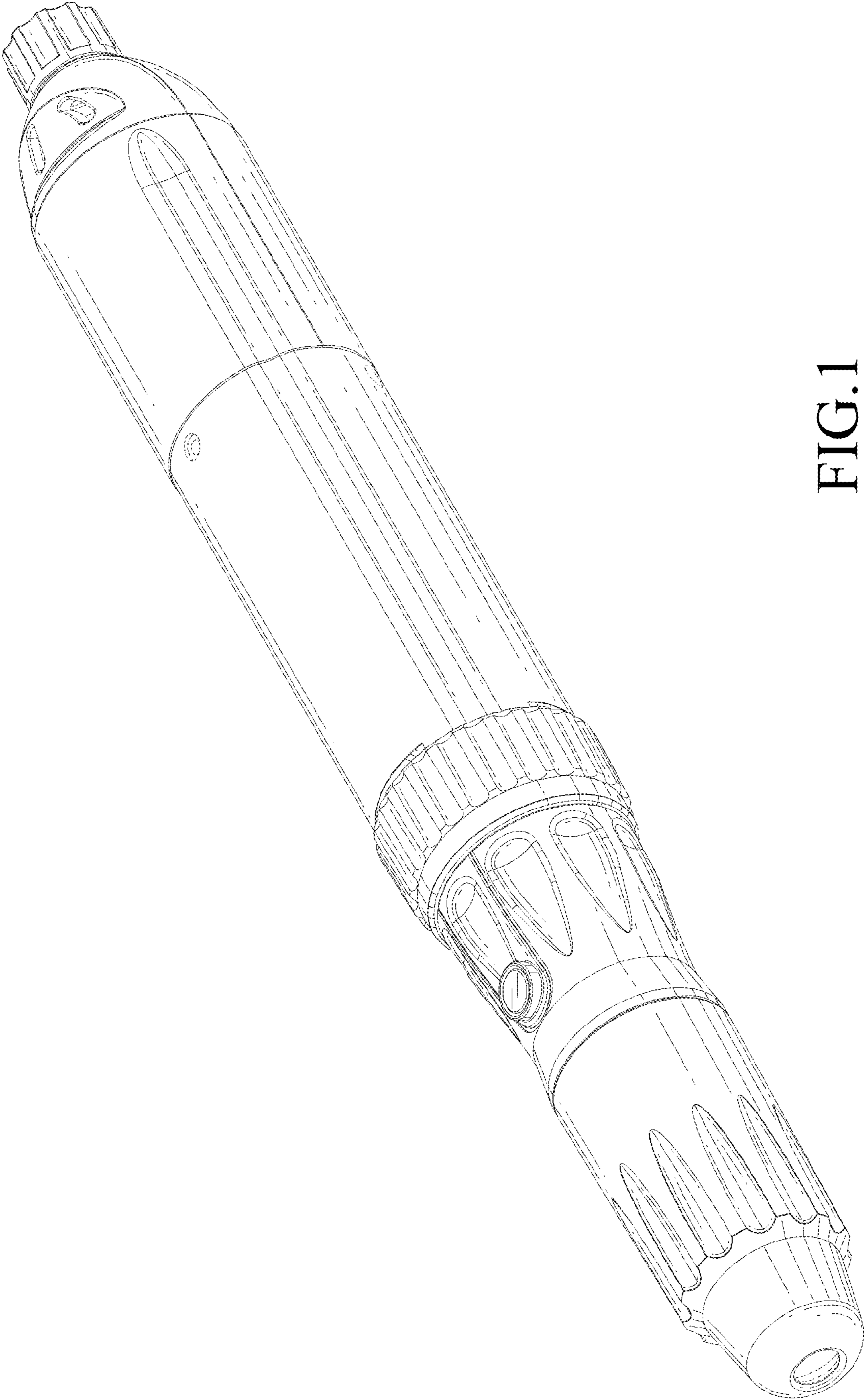

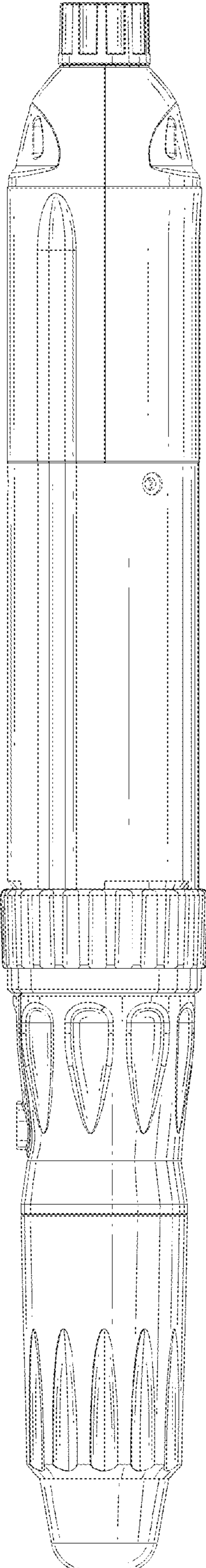

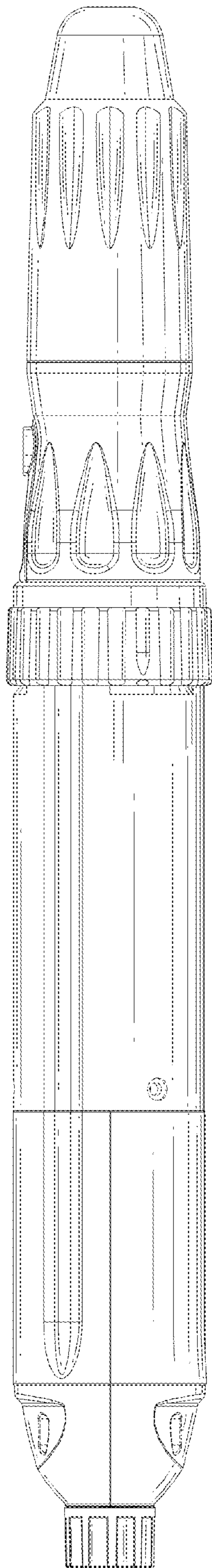

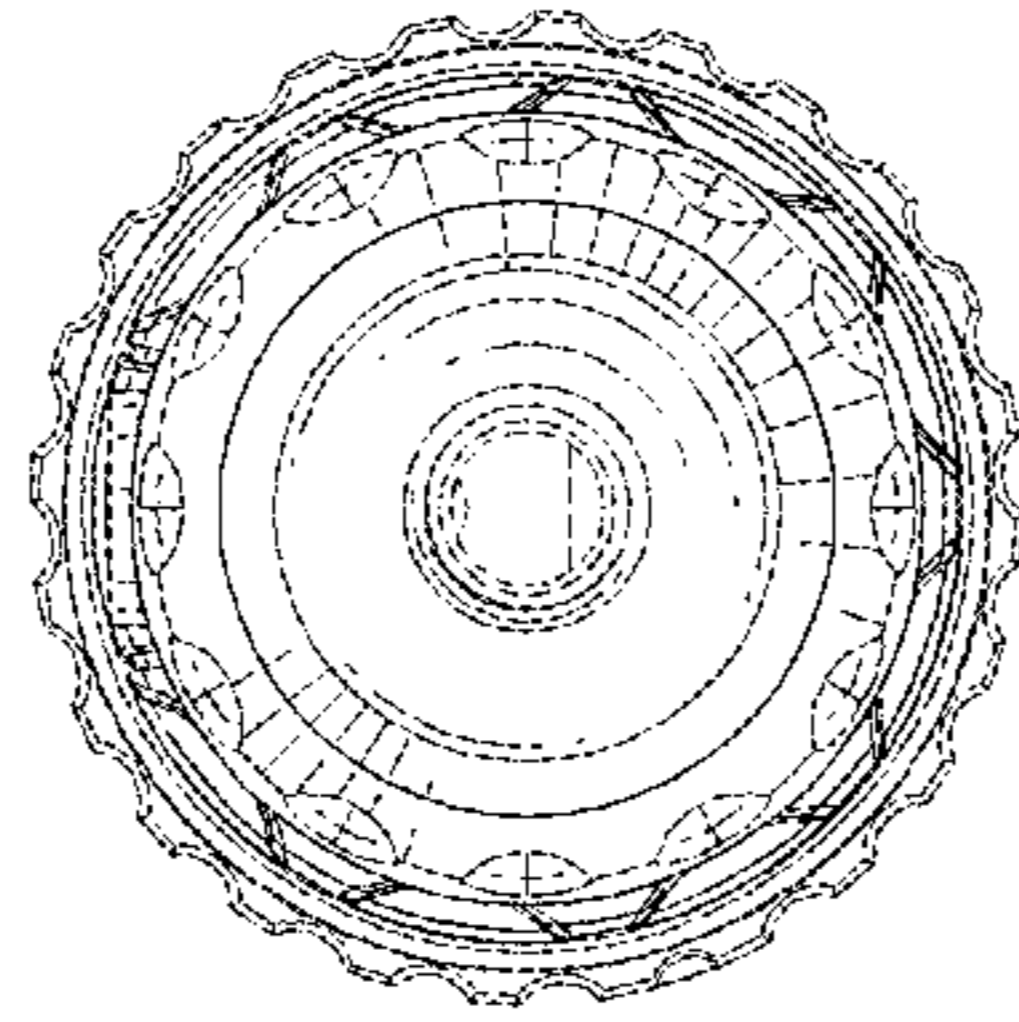

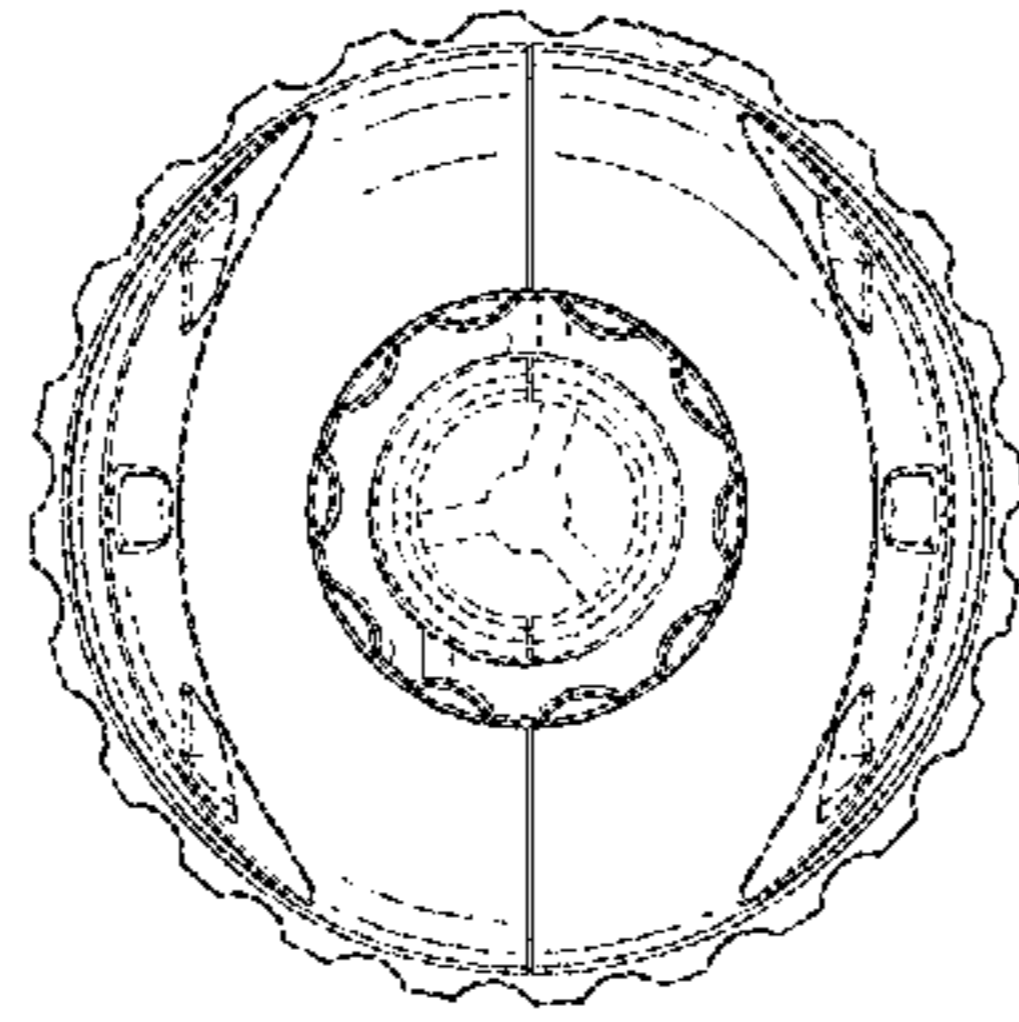

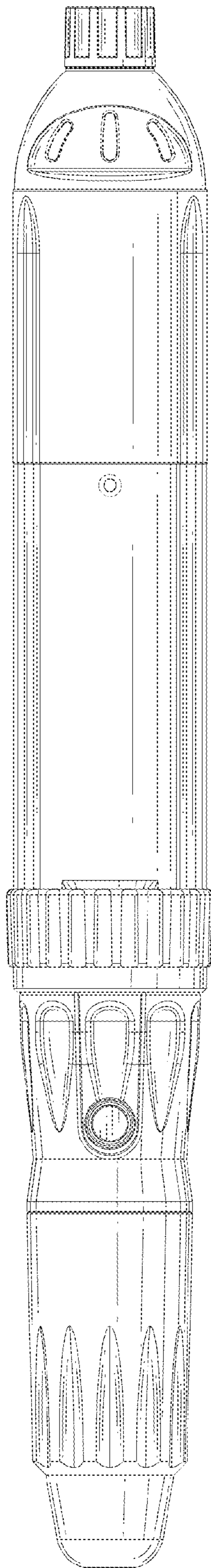

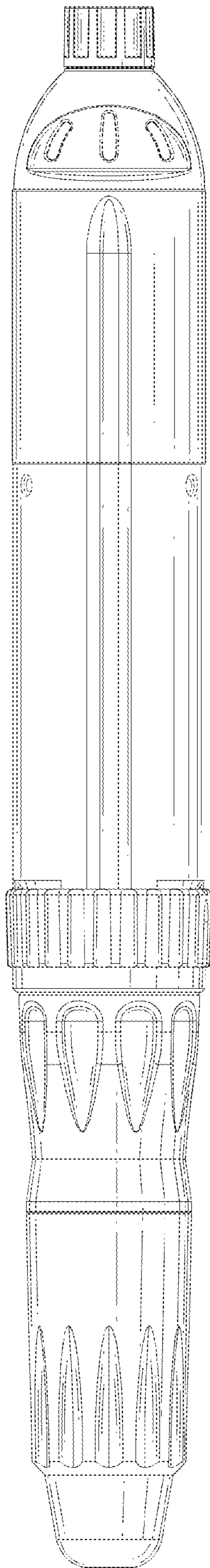

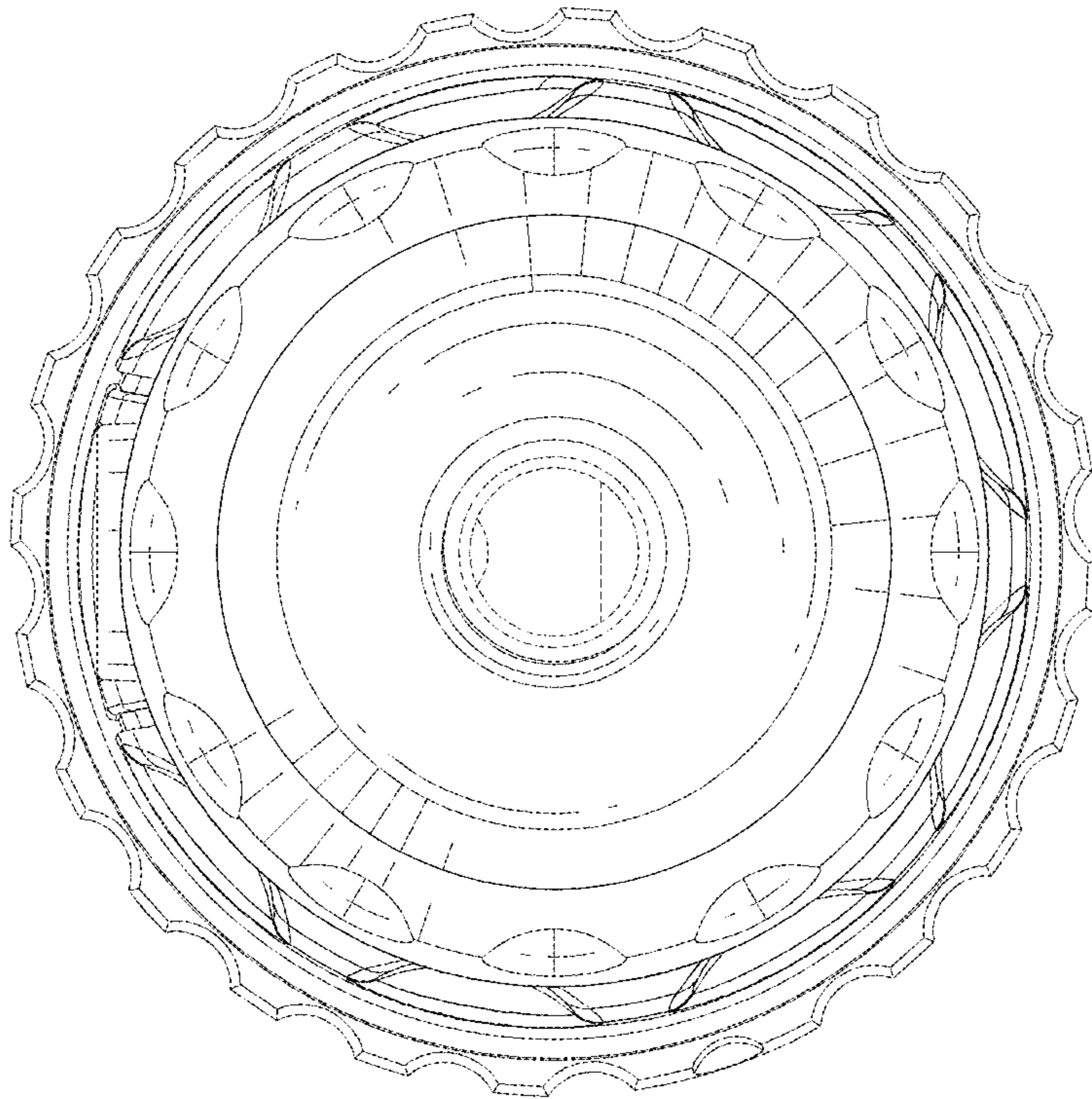

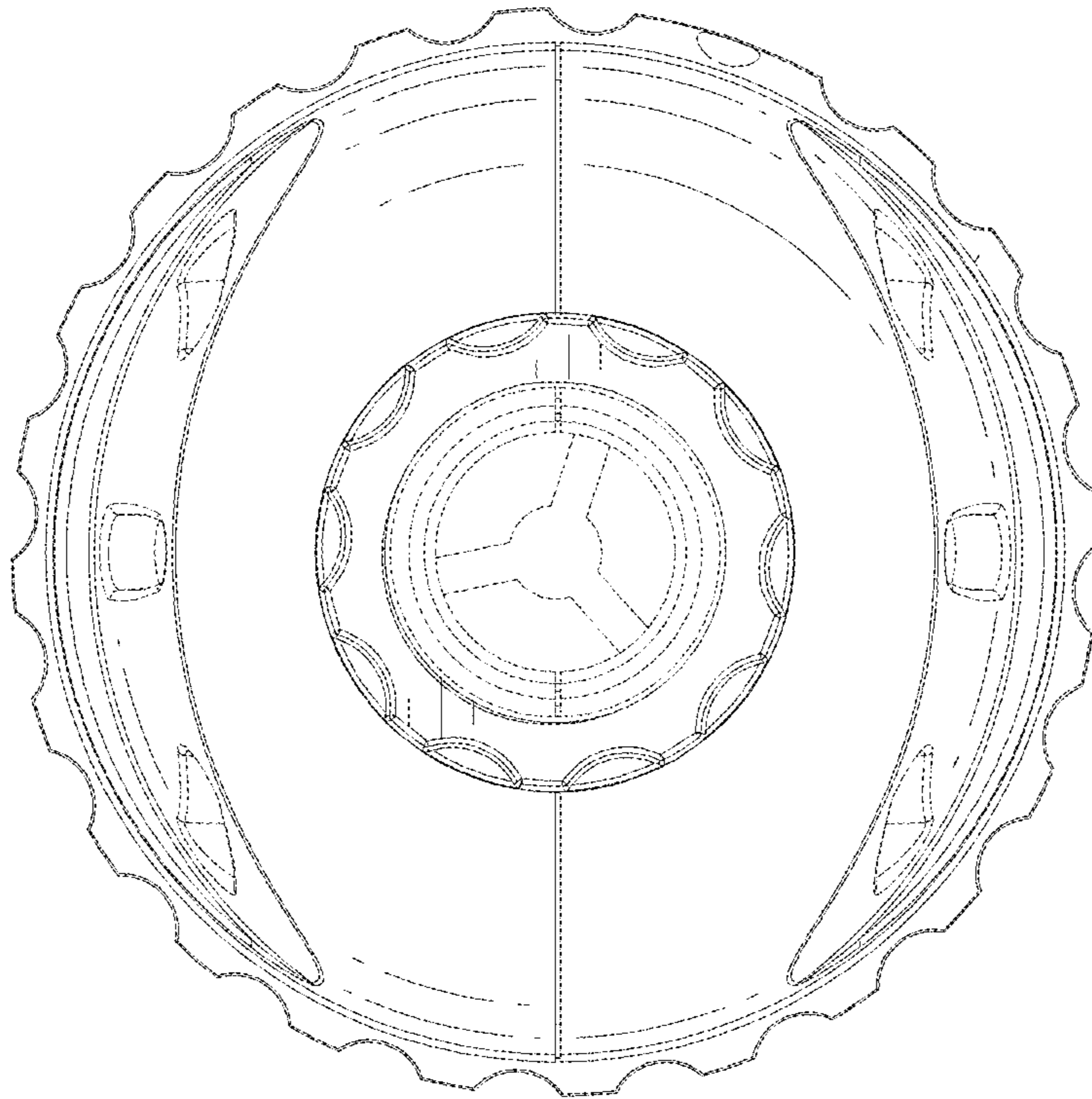
