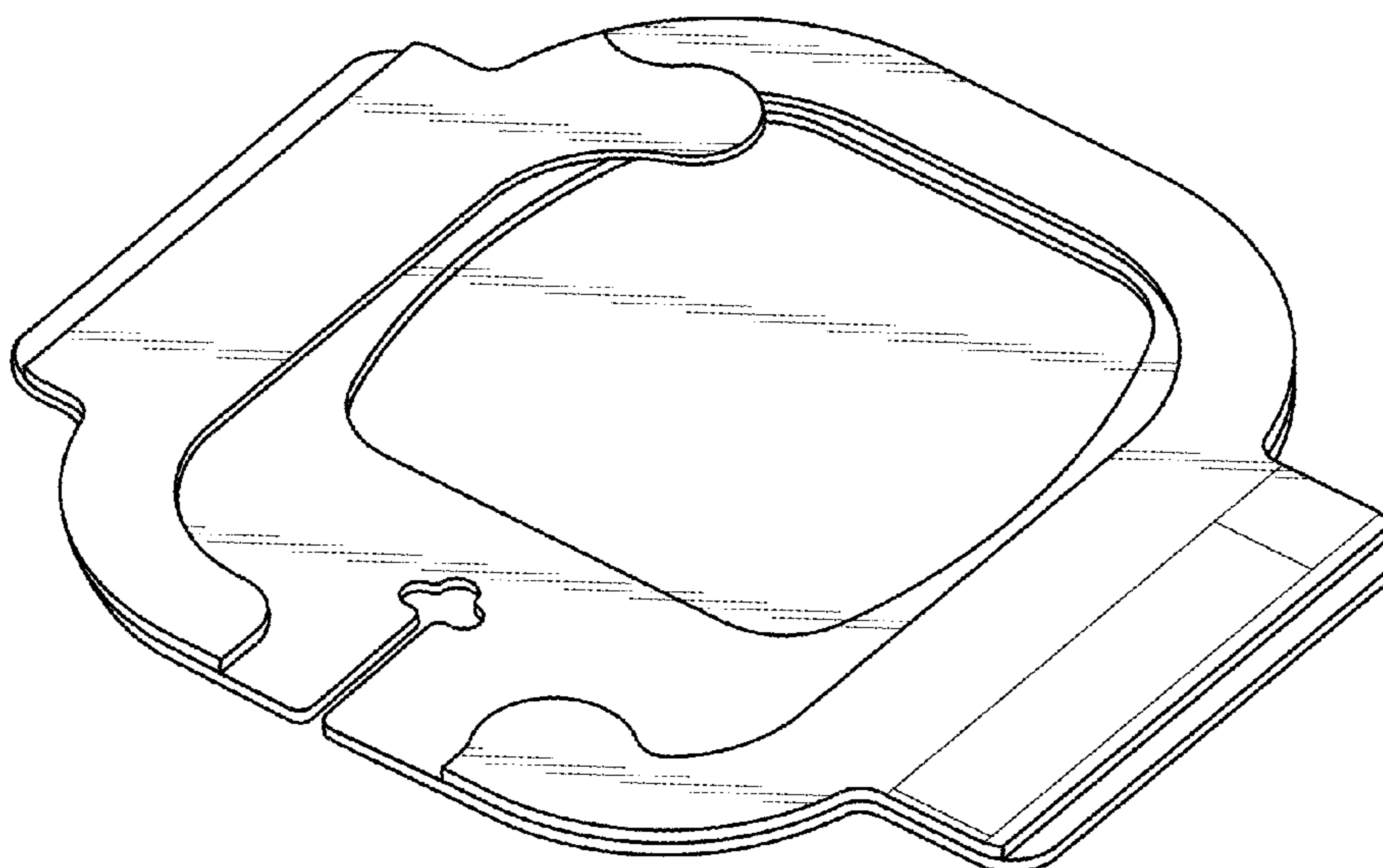

FIG. 4 is an elevation view of the front of the window dressing illustrated in FIG. 1;  
FIG. 5 is an elevation view of the rear of the window dressing illustrated in FIG. 1;  
FIG. 6 is an elevation view of the right side of the window dressing illustrated in FIG. 1; and,  
FIG. 7 is an elevation view of the left side of the window dressing illustrated in FIG. 1.

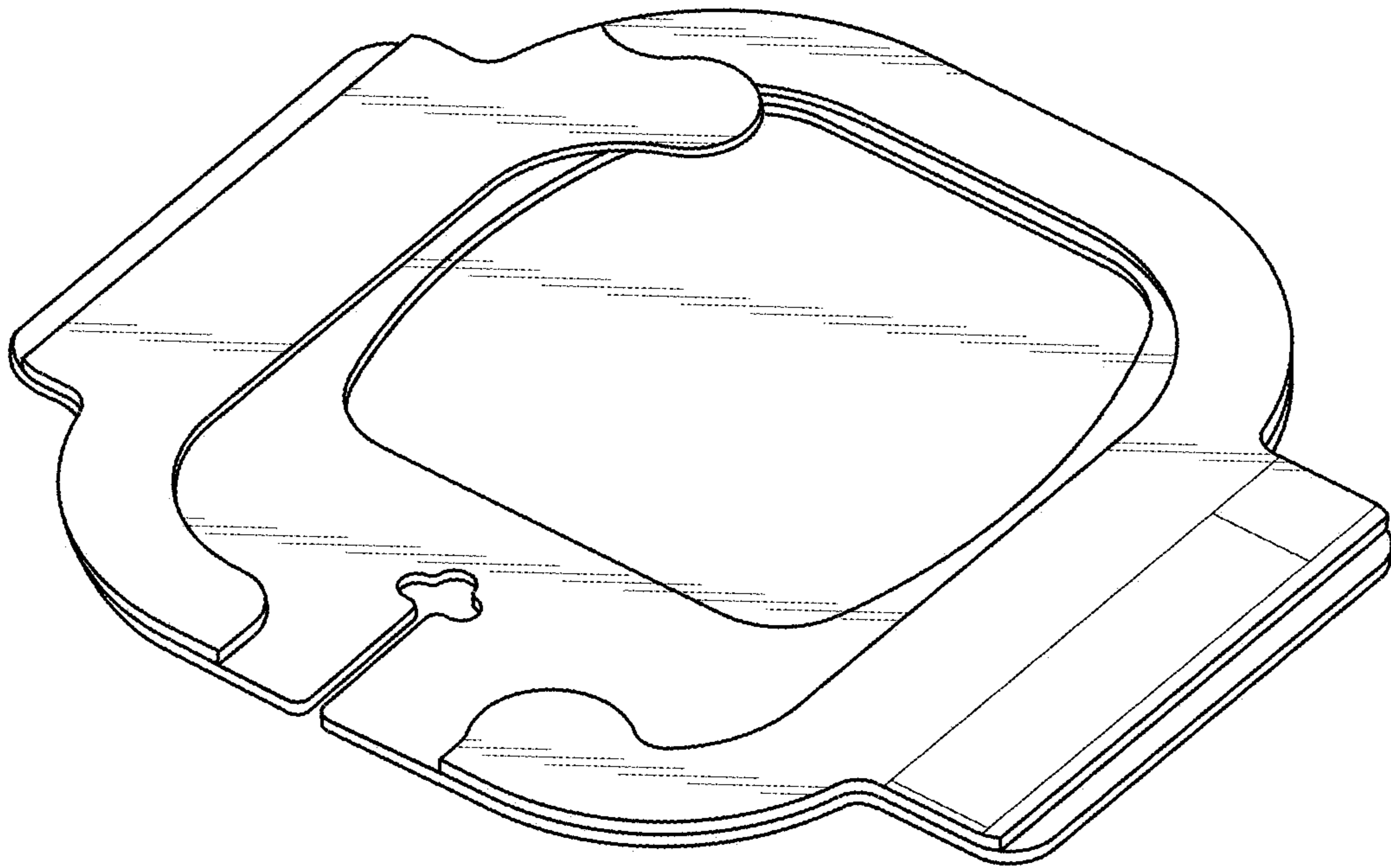

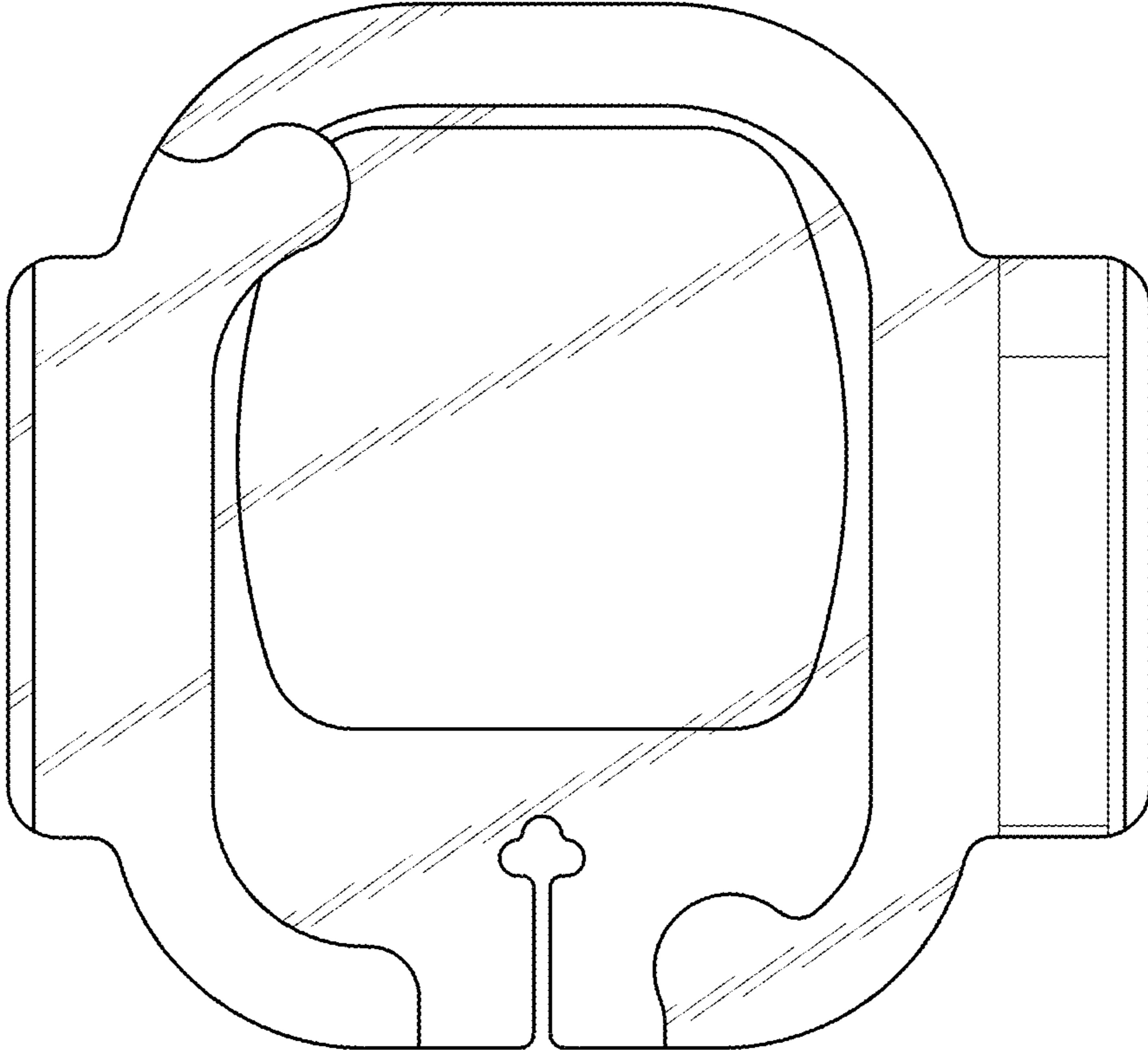

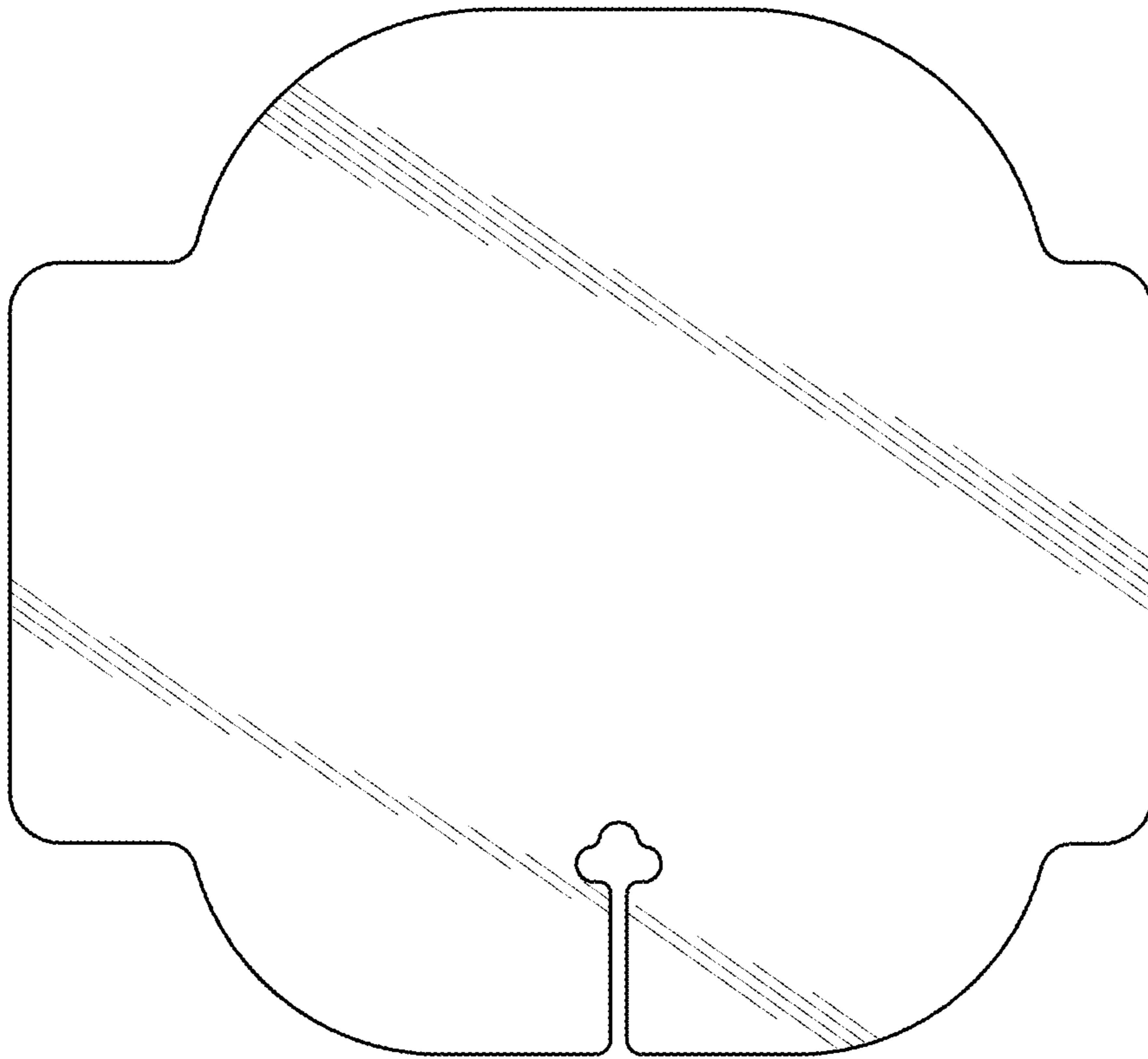

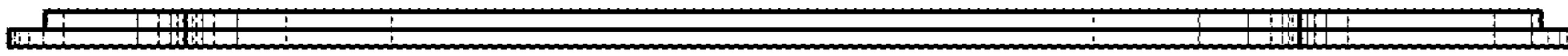

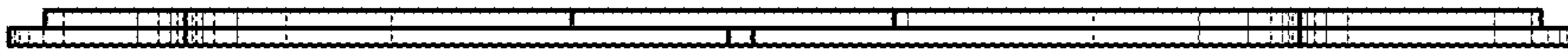

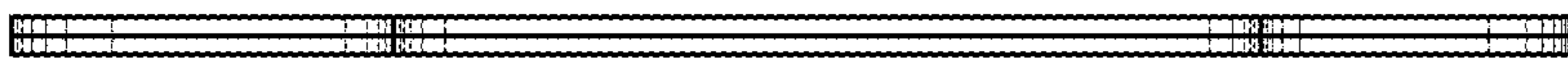

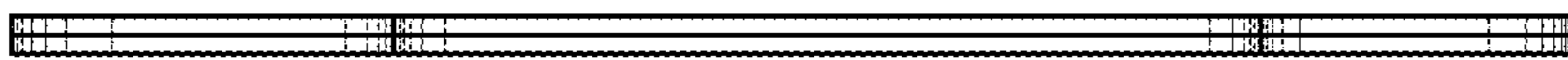
