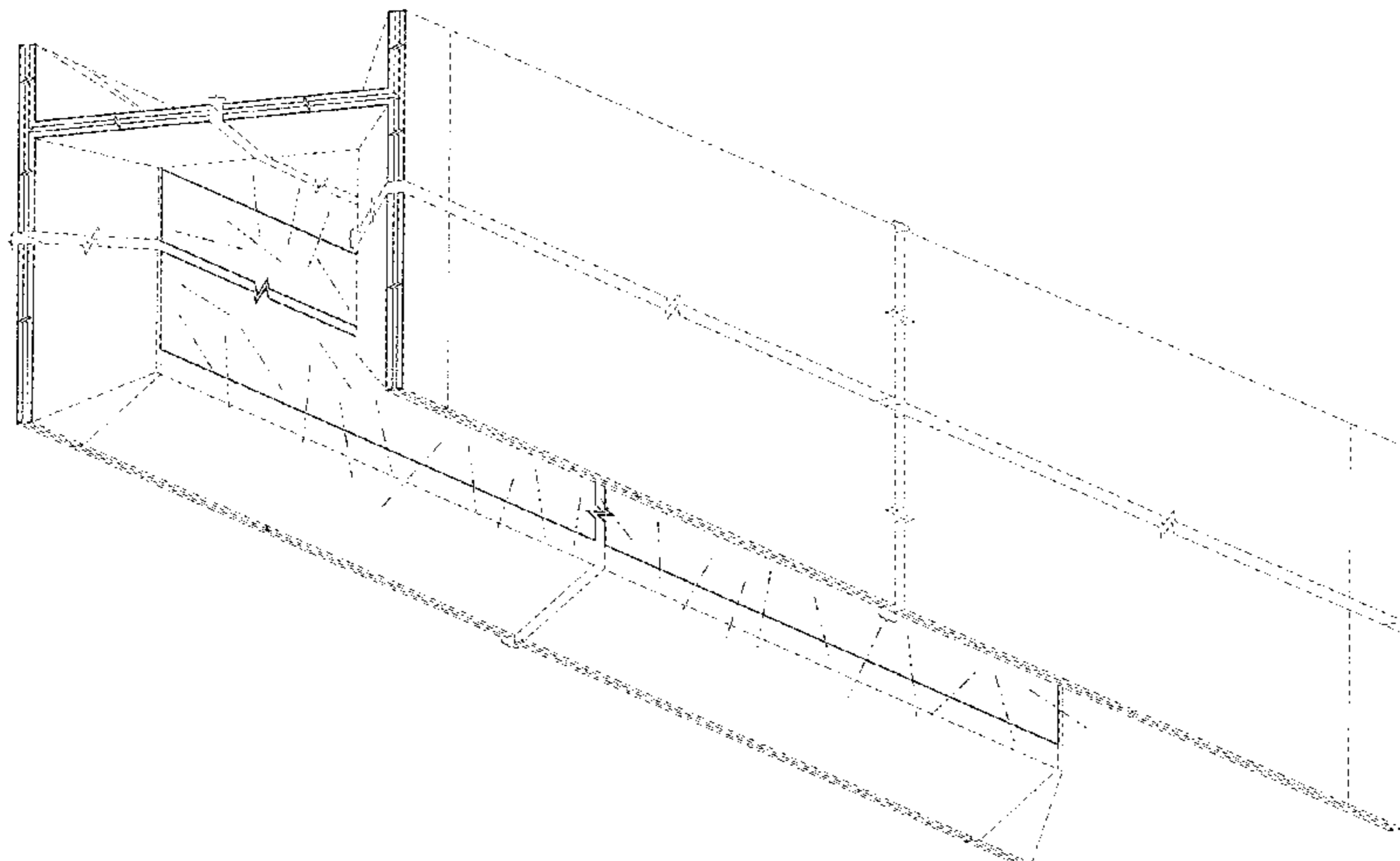
(57) **CLAIM**

We claim, the ornamental design for a luminaire structure, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, perspective view of a luminaire structure, showing our new design;

FIG. 3 is a side elevational view thereof, where the opposite side elevational view is a mirror of this view and, therefore, has been omitted;

FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a perspective view as viewed from below of another embodiment of the luminaire structure of our design;

FIG. 9 is a side elevational view thereof, where the opposite side elevational view is a mirror of this view and, therefore, has been omitted;  
FIG. 10 is a front elevational view thereof, where the rear elevational view is a mirror of this view and, therefore, has been omitted;

FIG. 13 is a perspective view as viewed from below of another embodiment of the luminaire structure of our design;

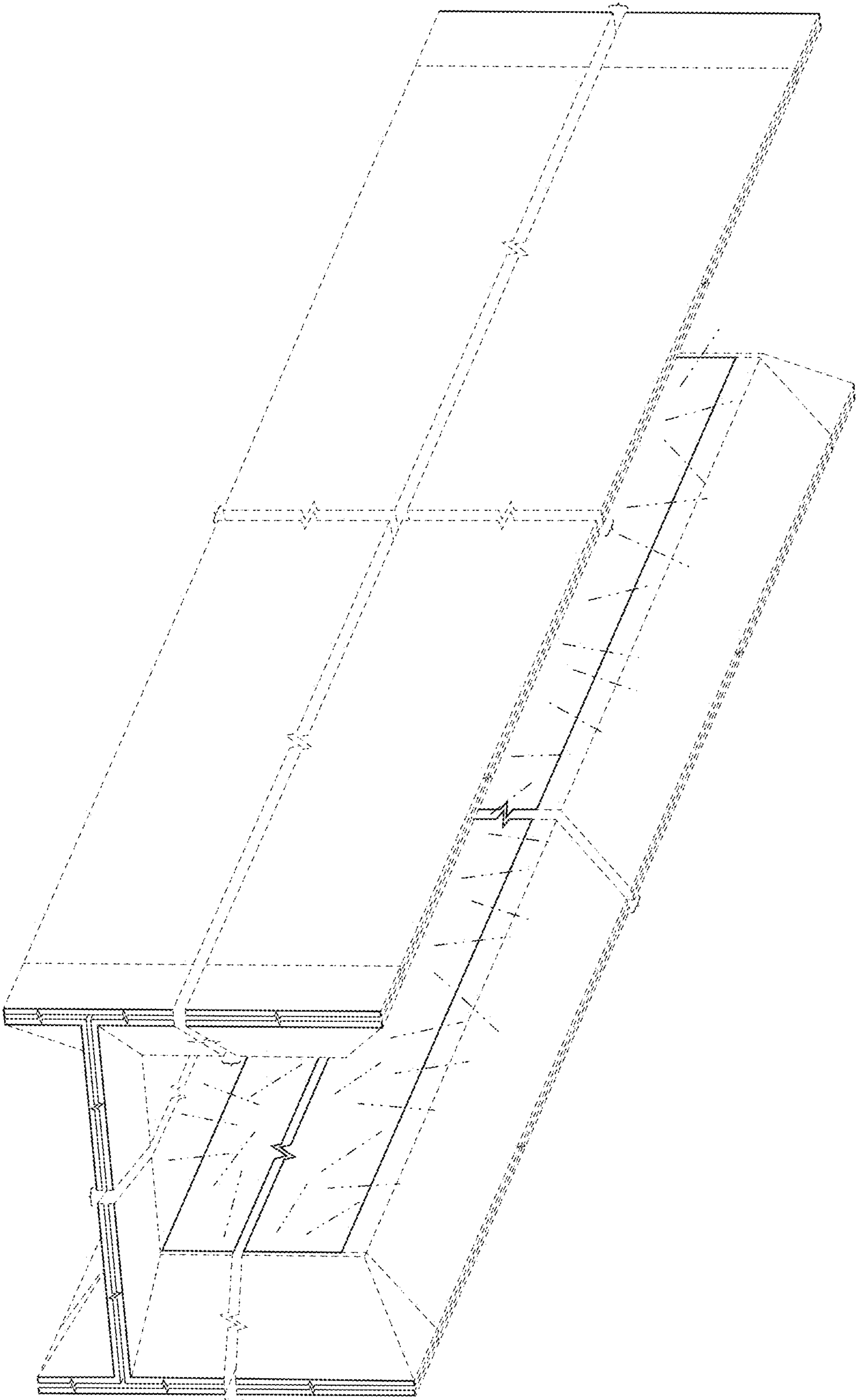

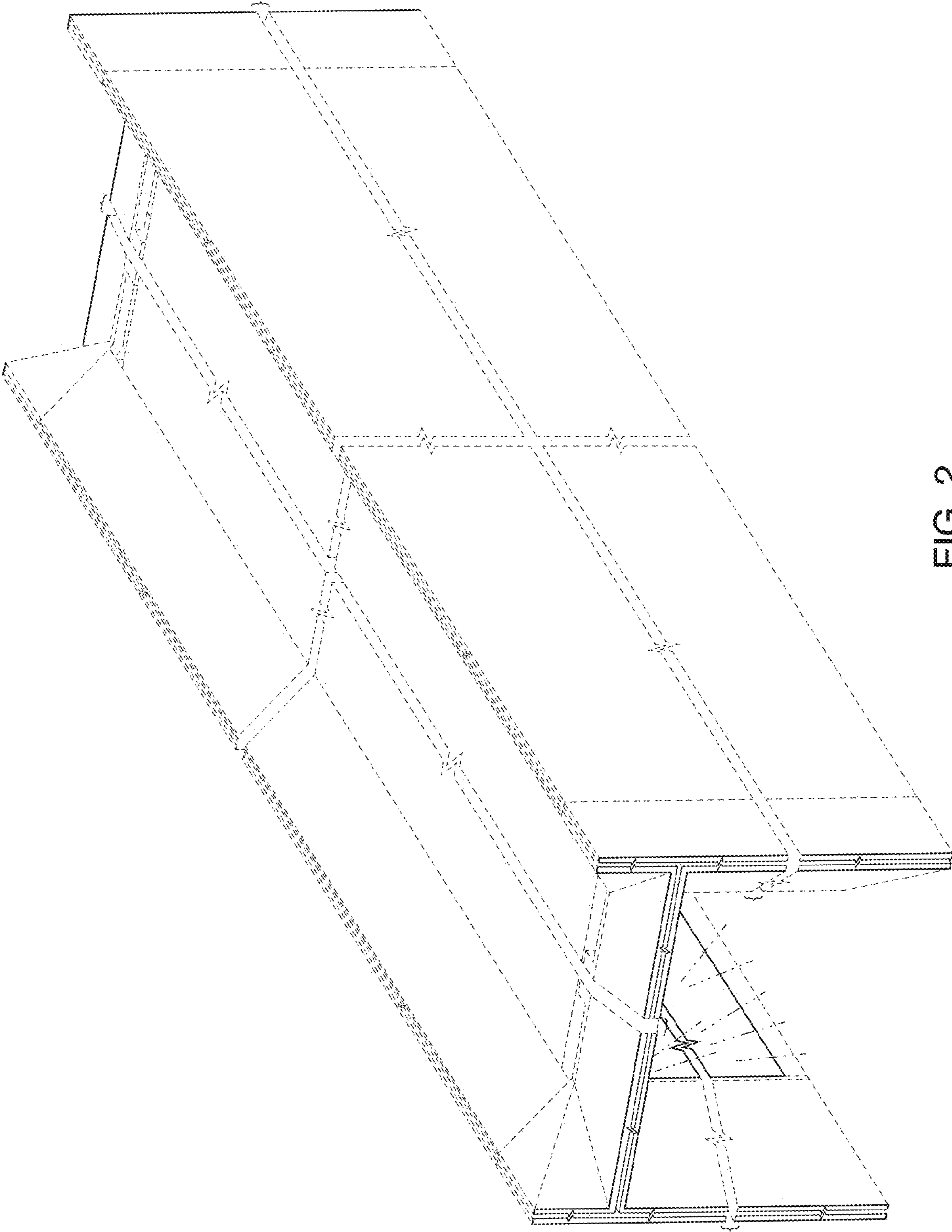

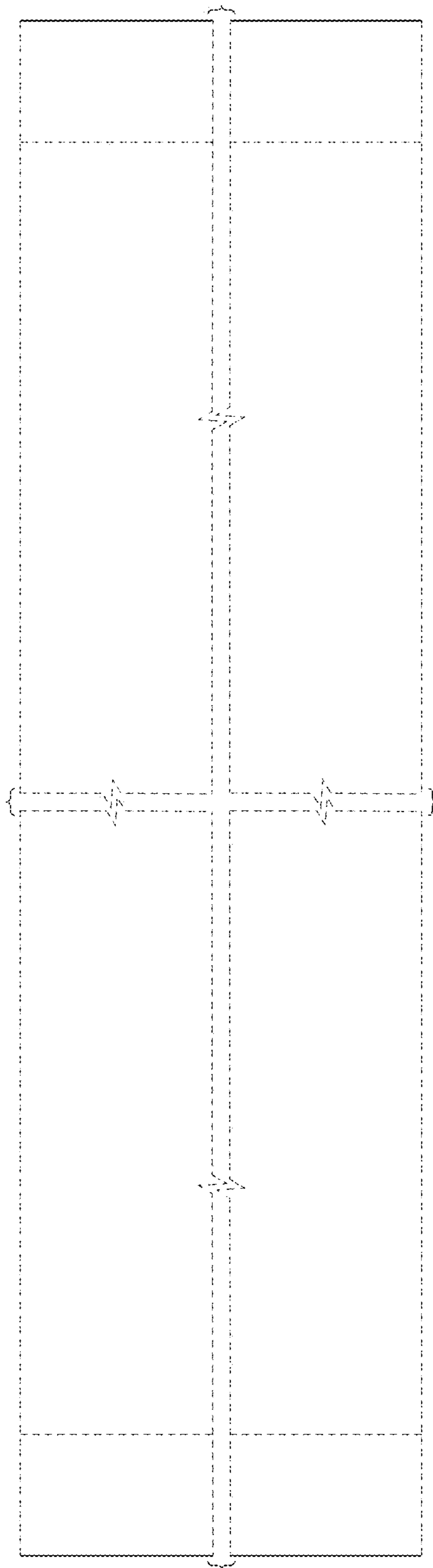

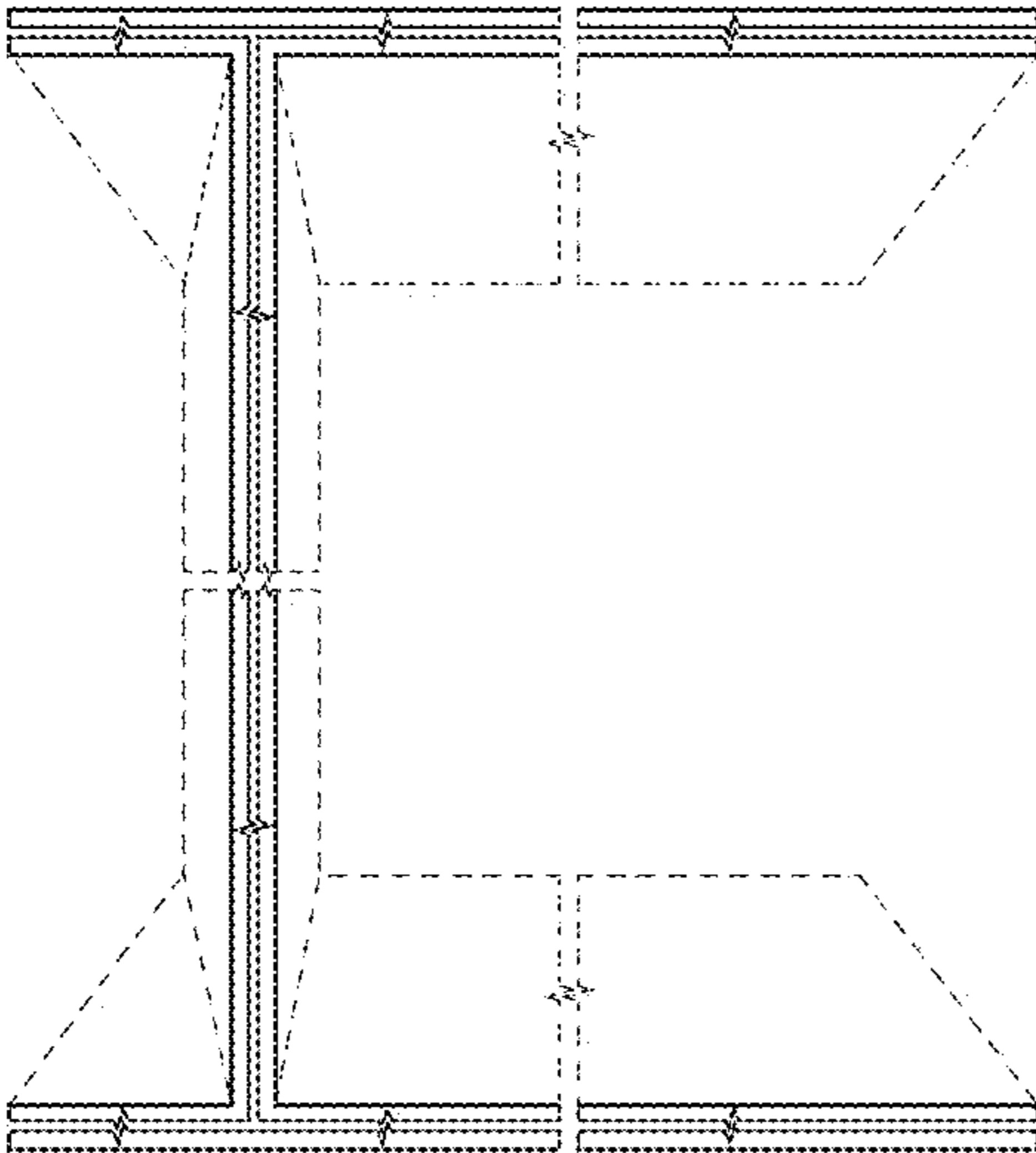

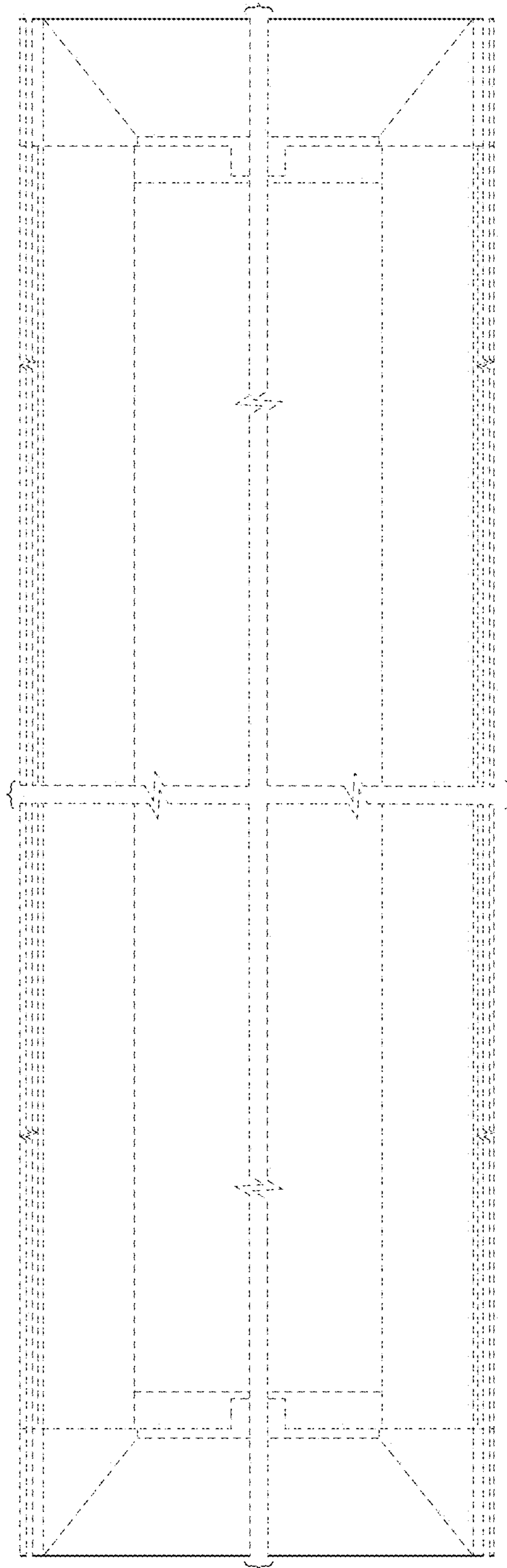

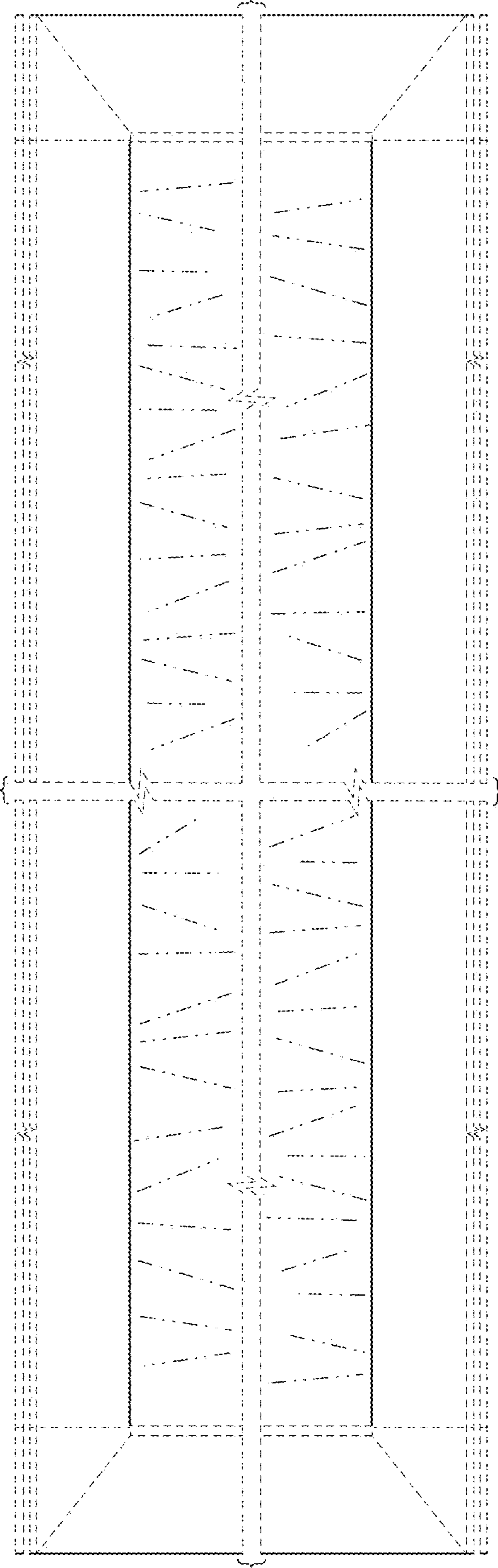

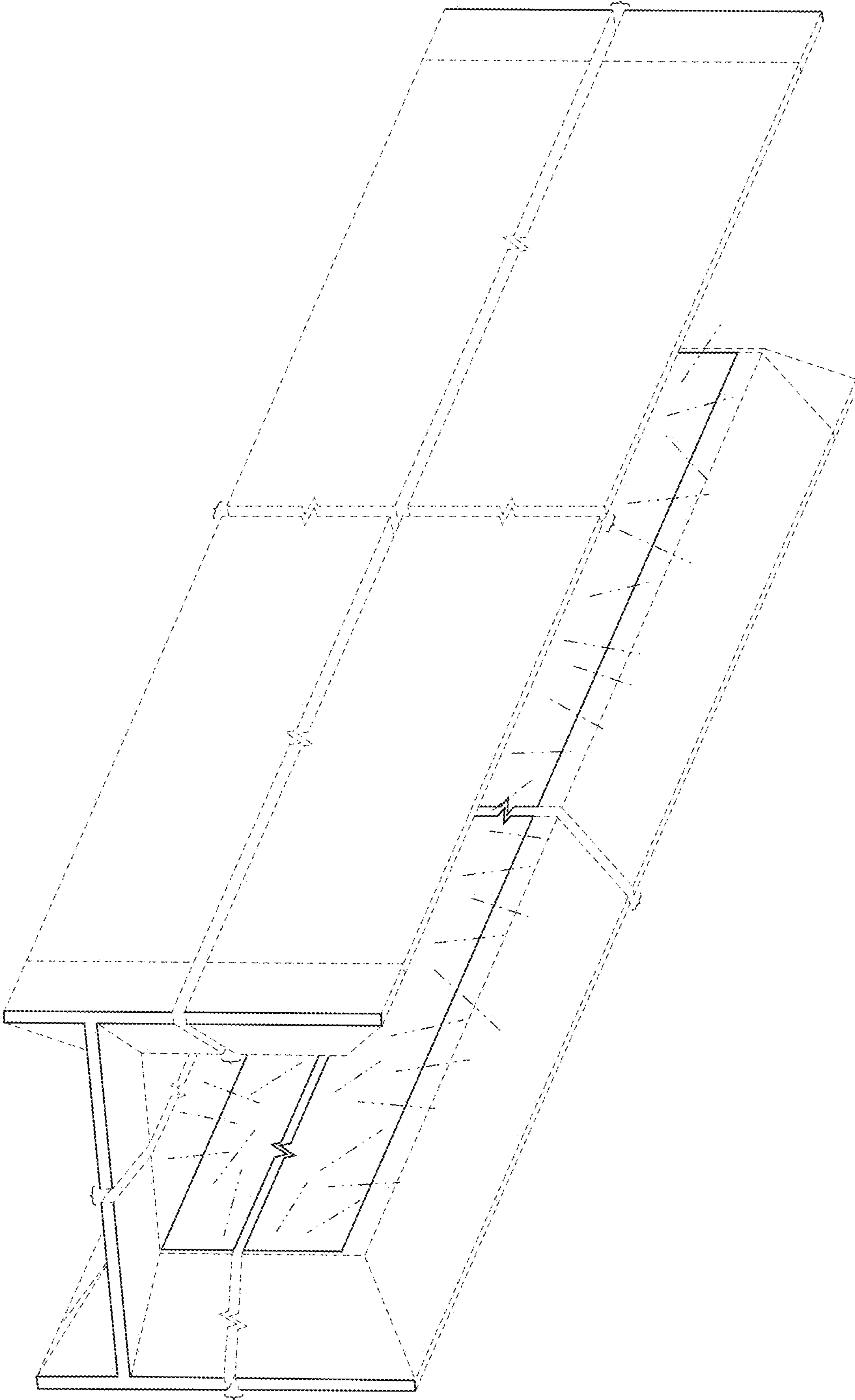

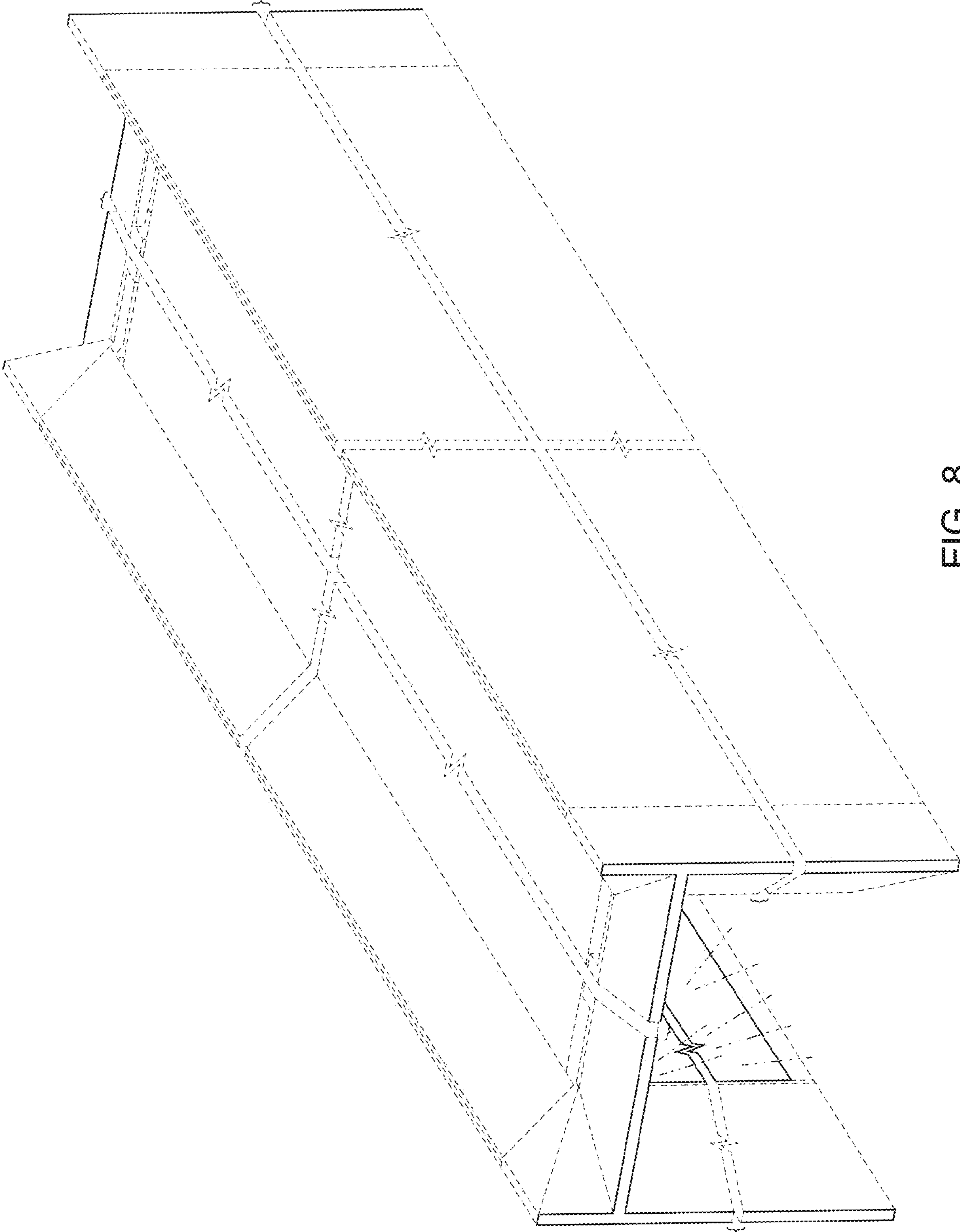

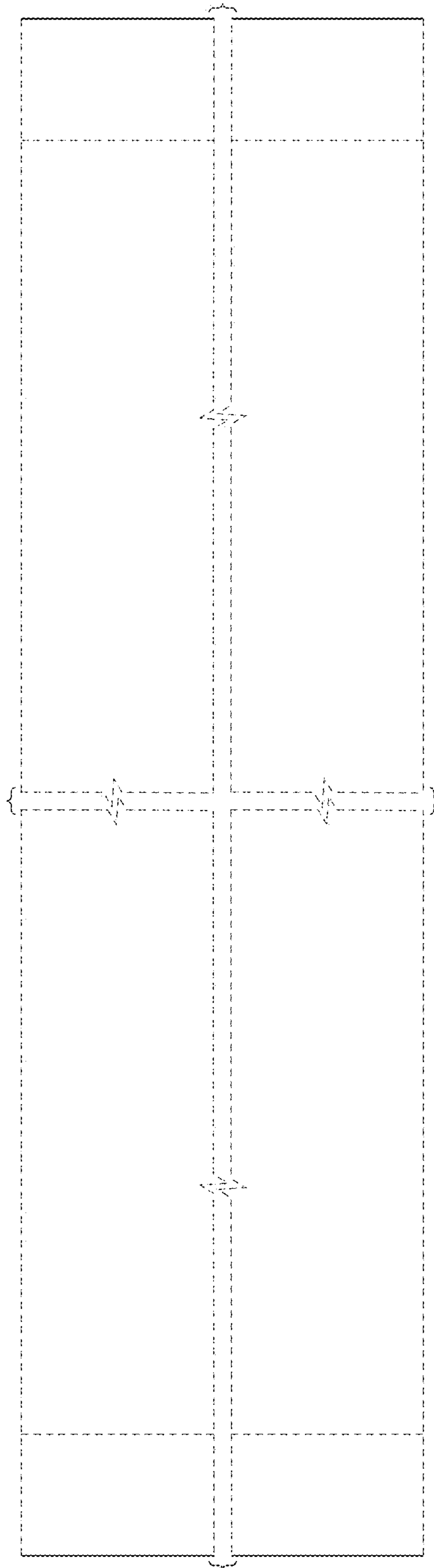

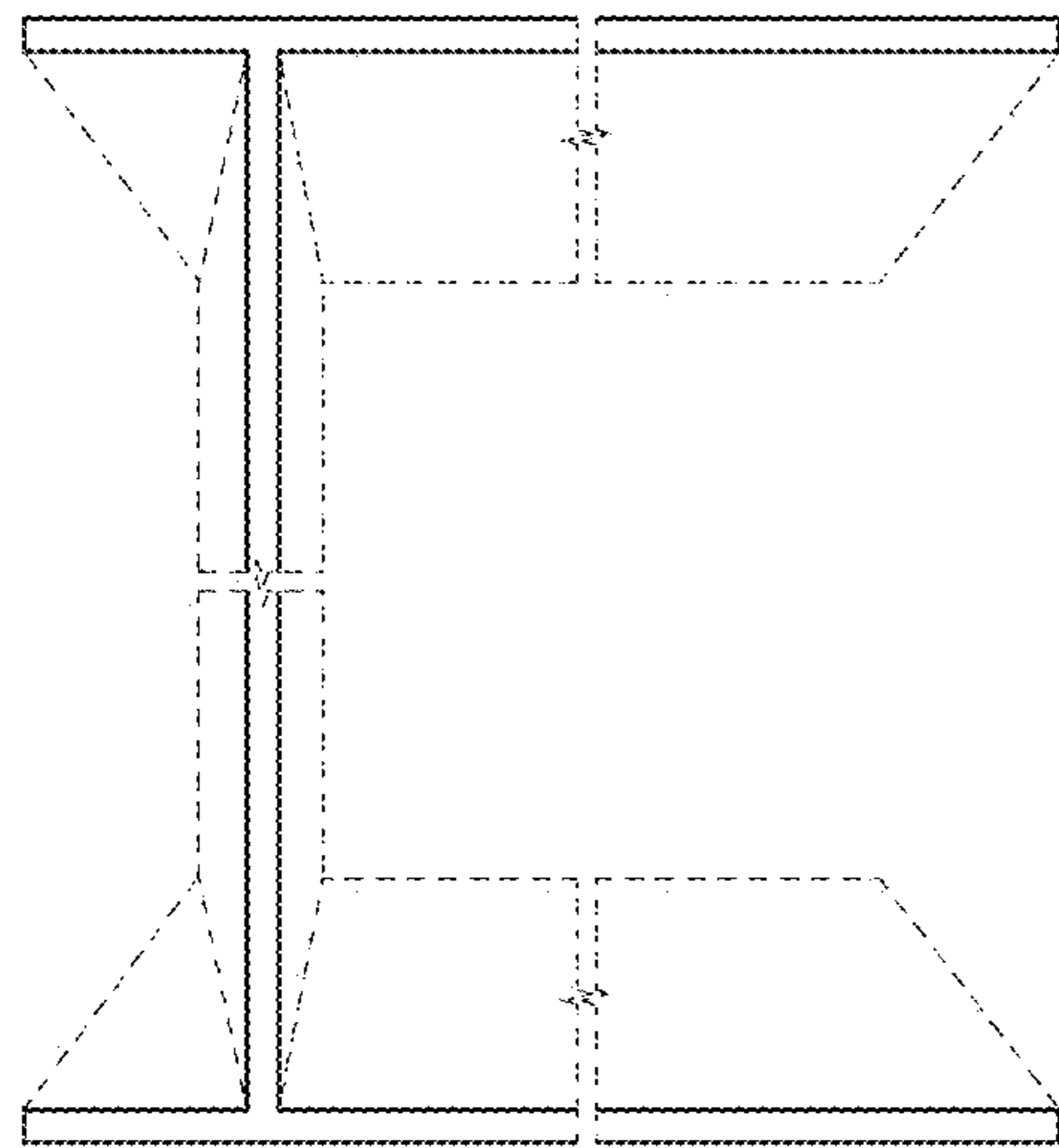

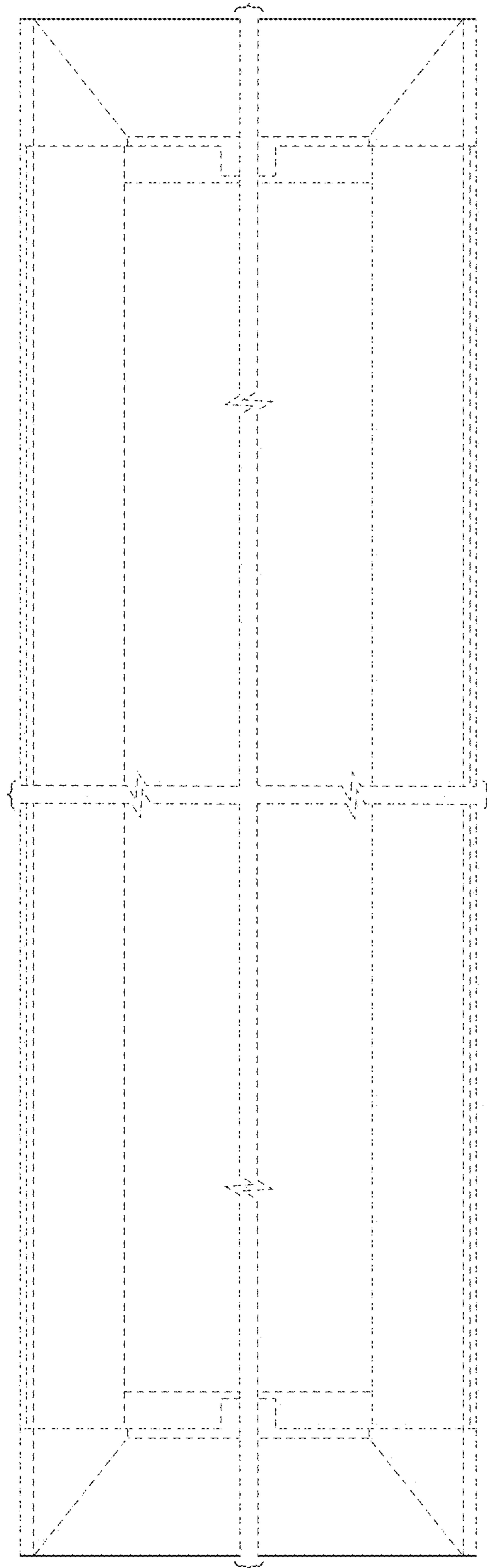

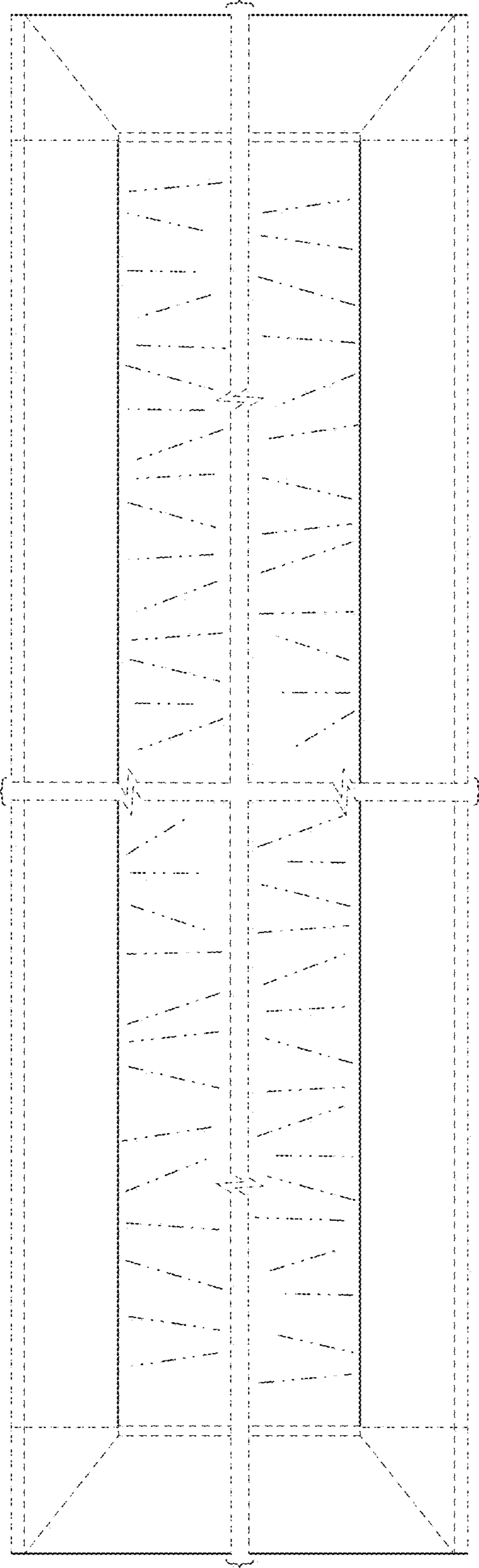

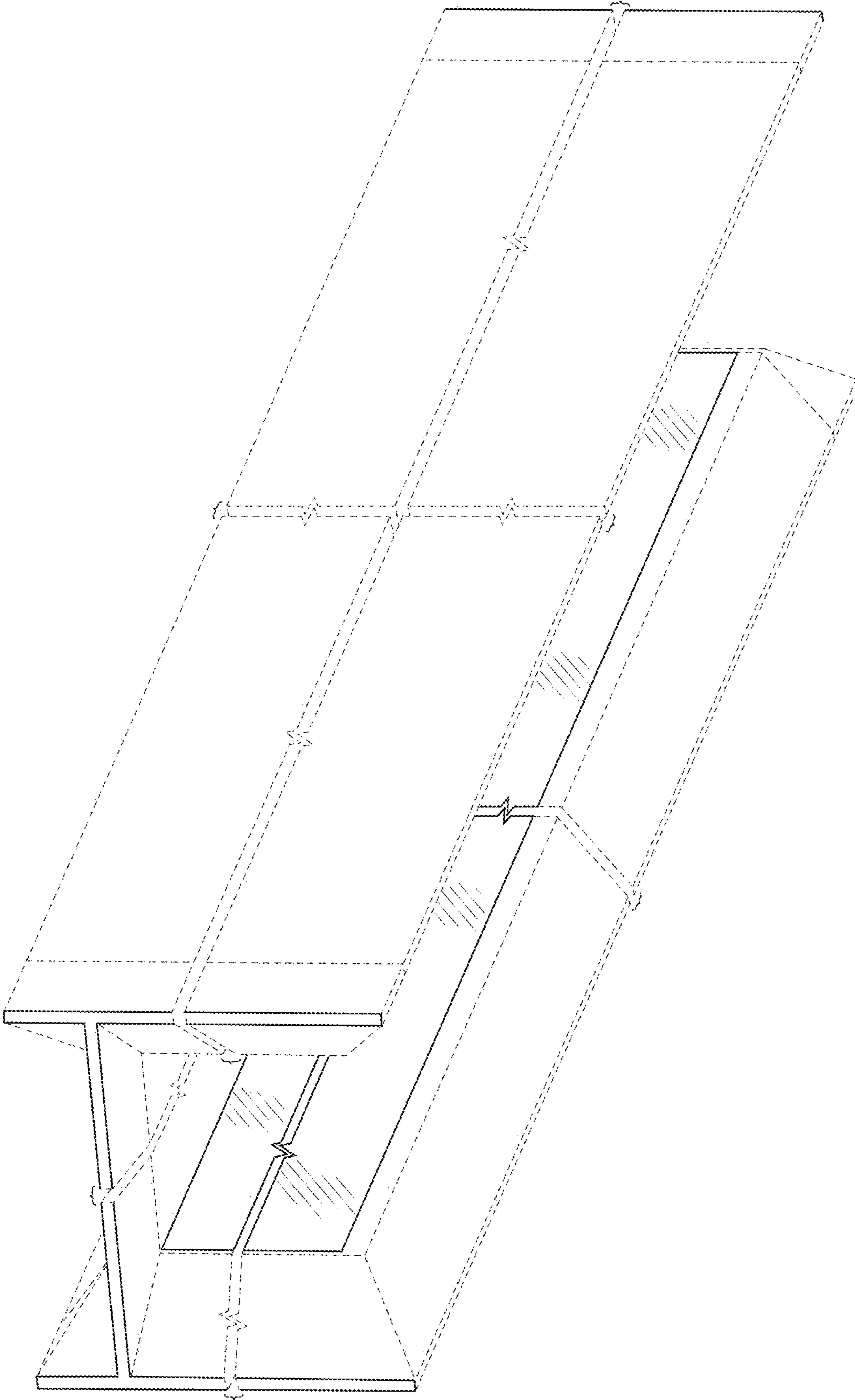

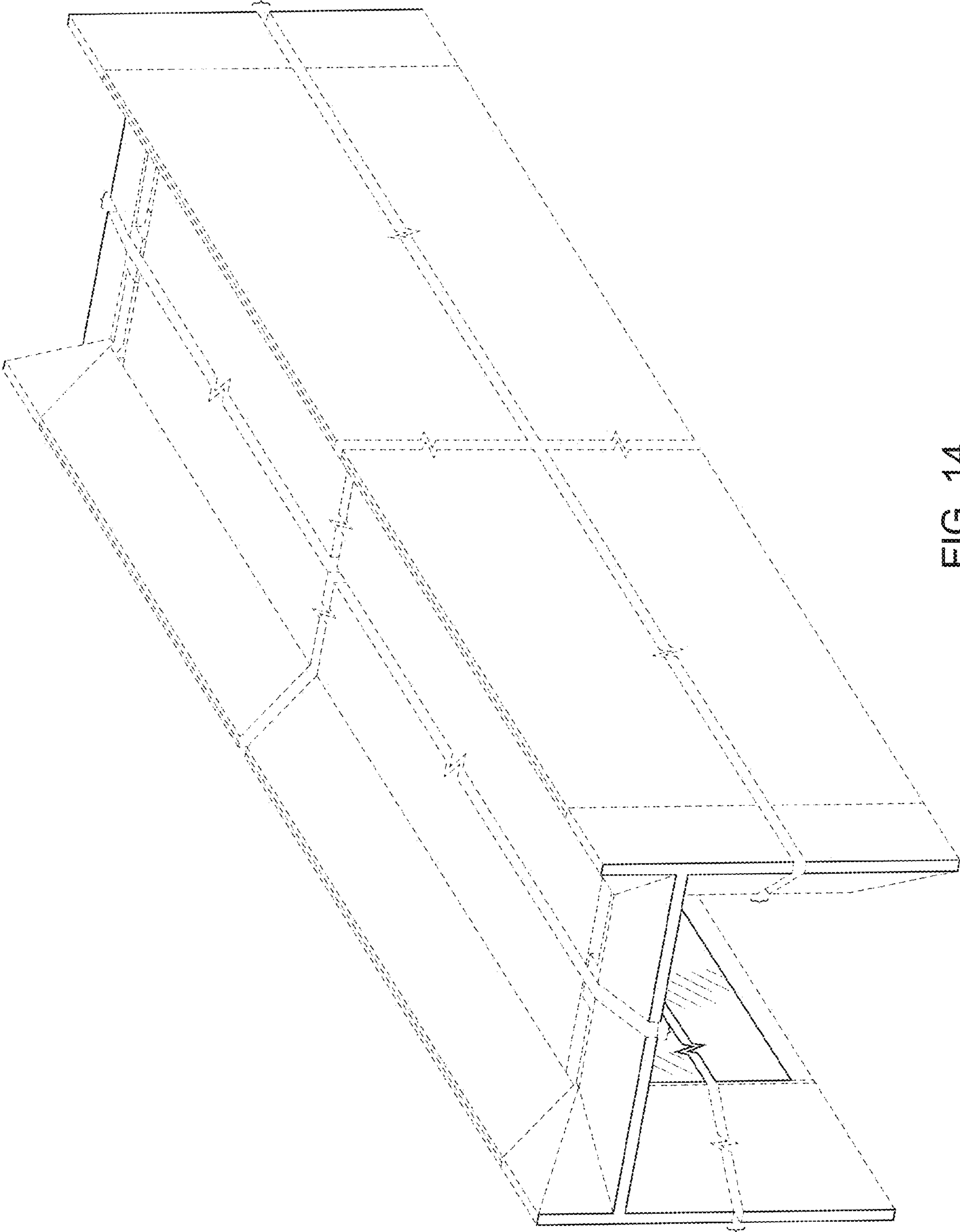

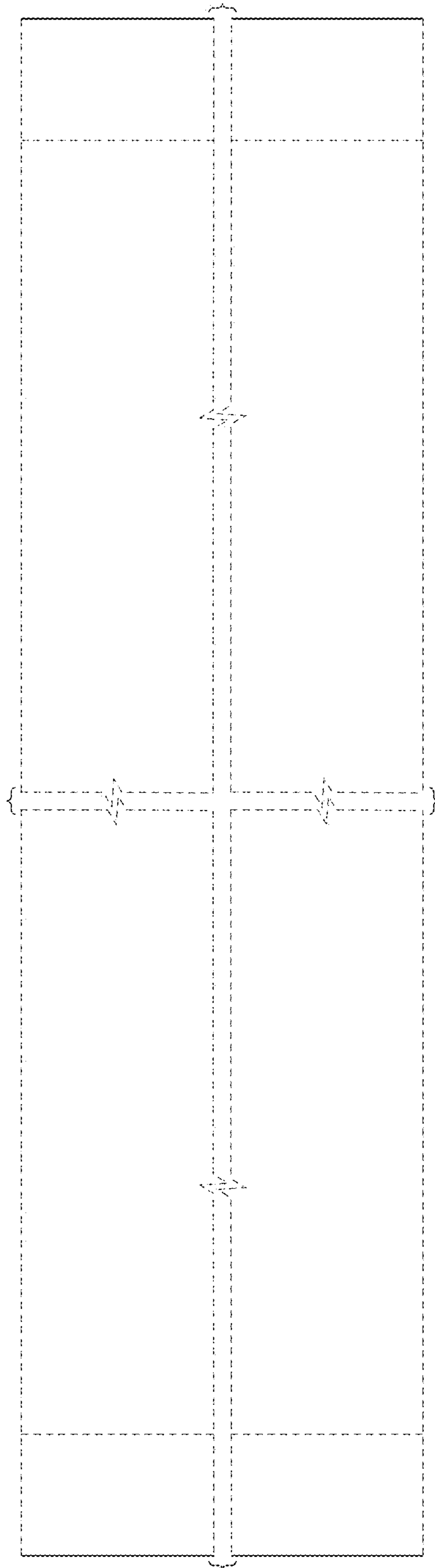

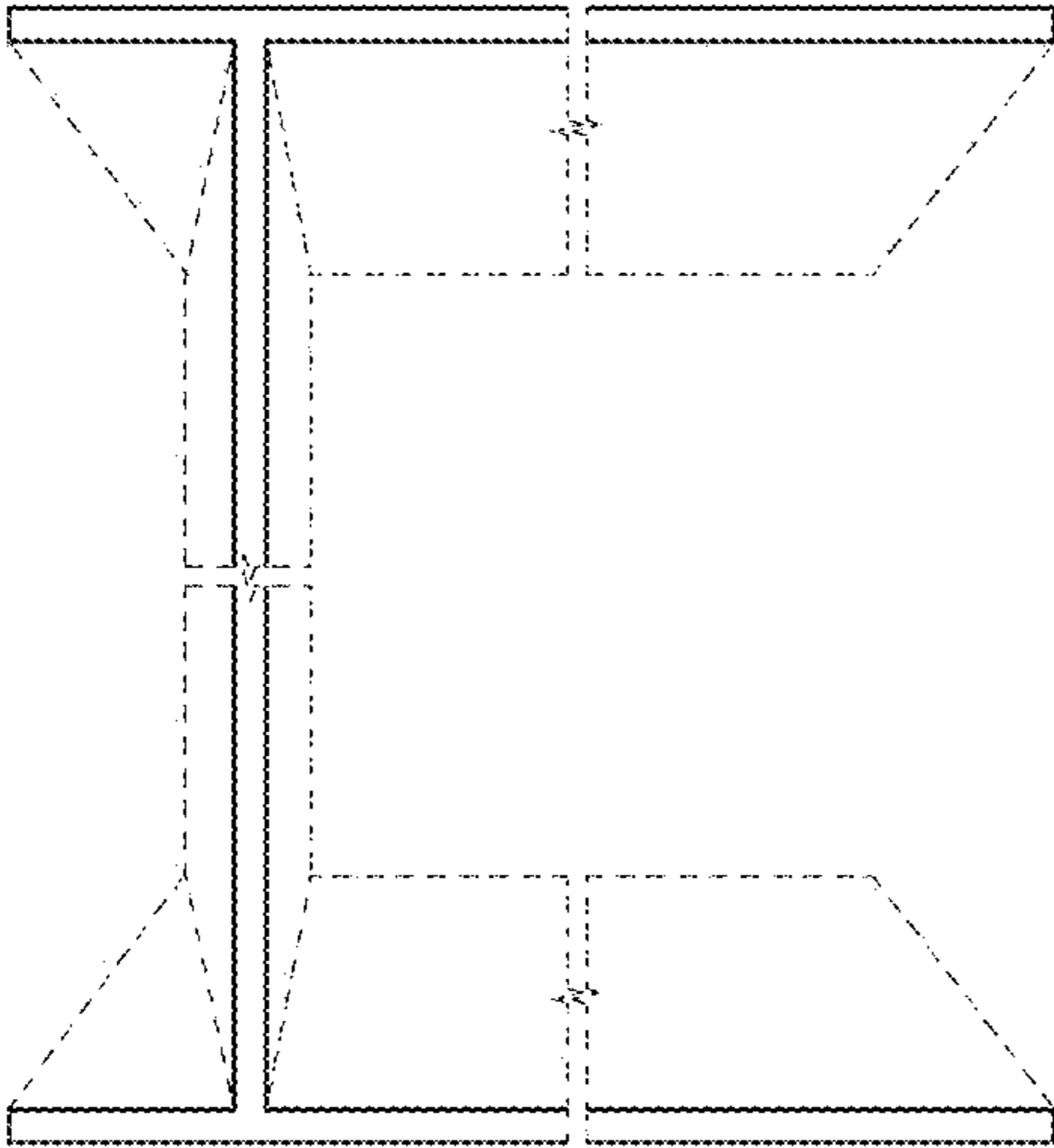

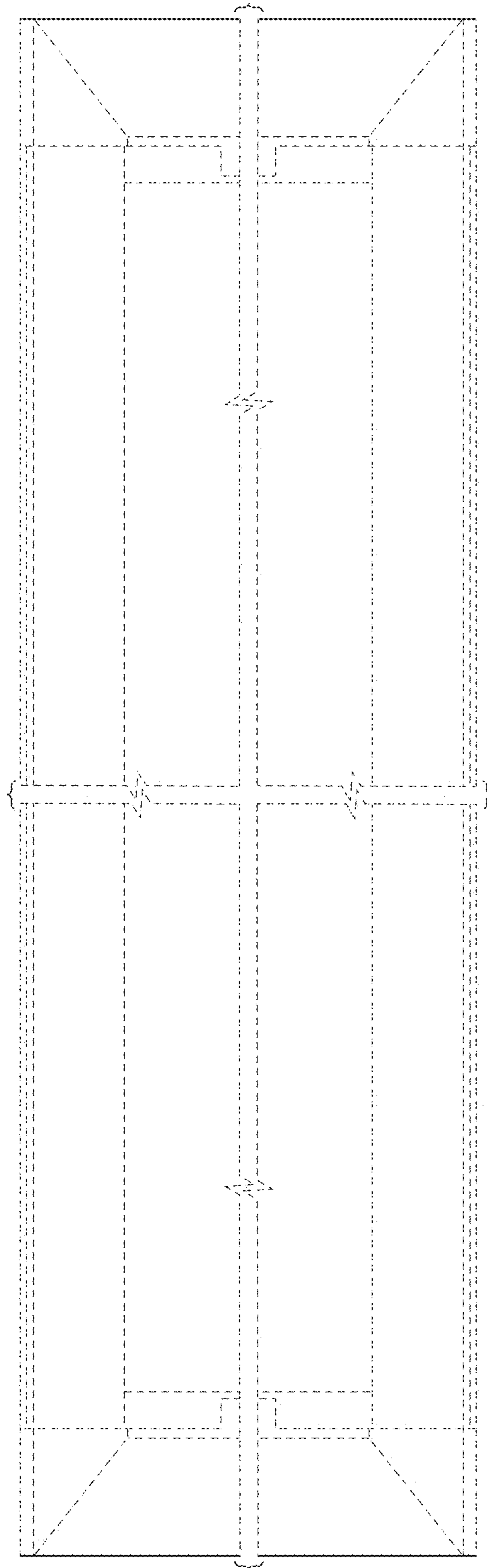

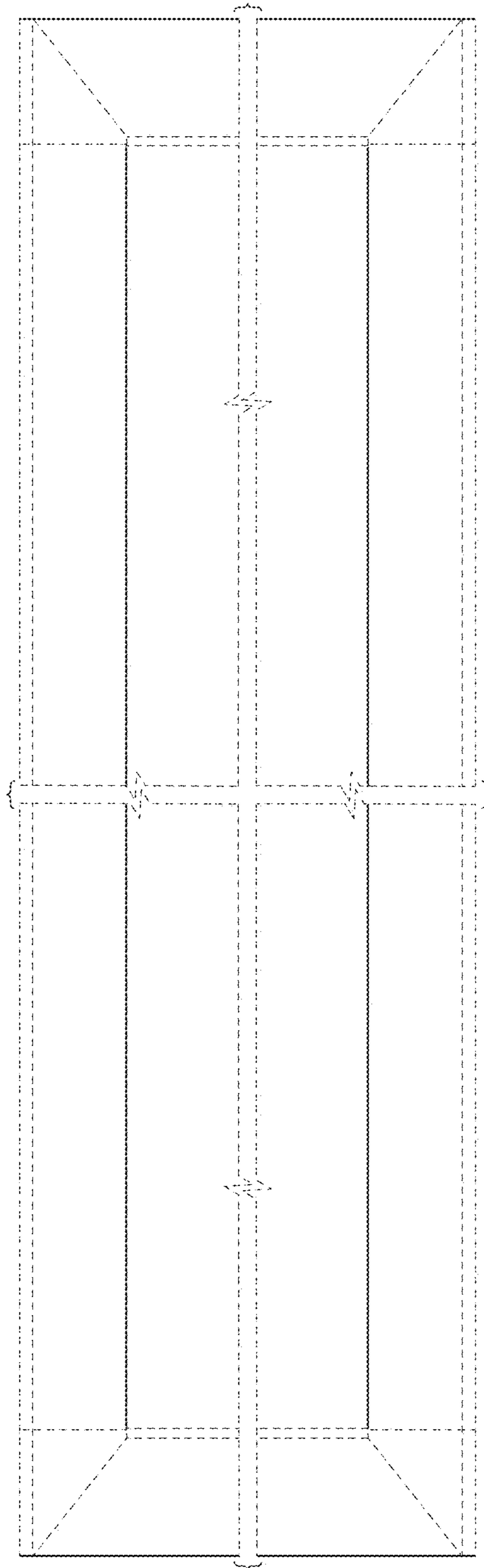
