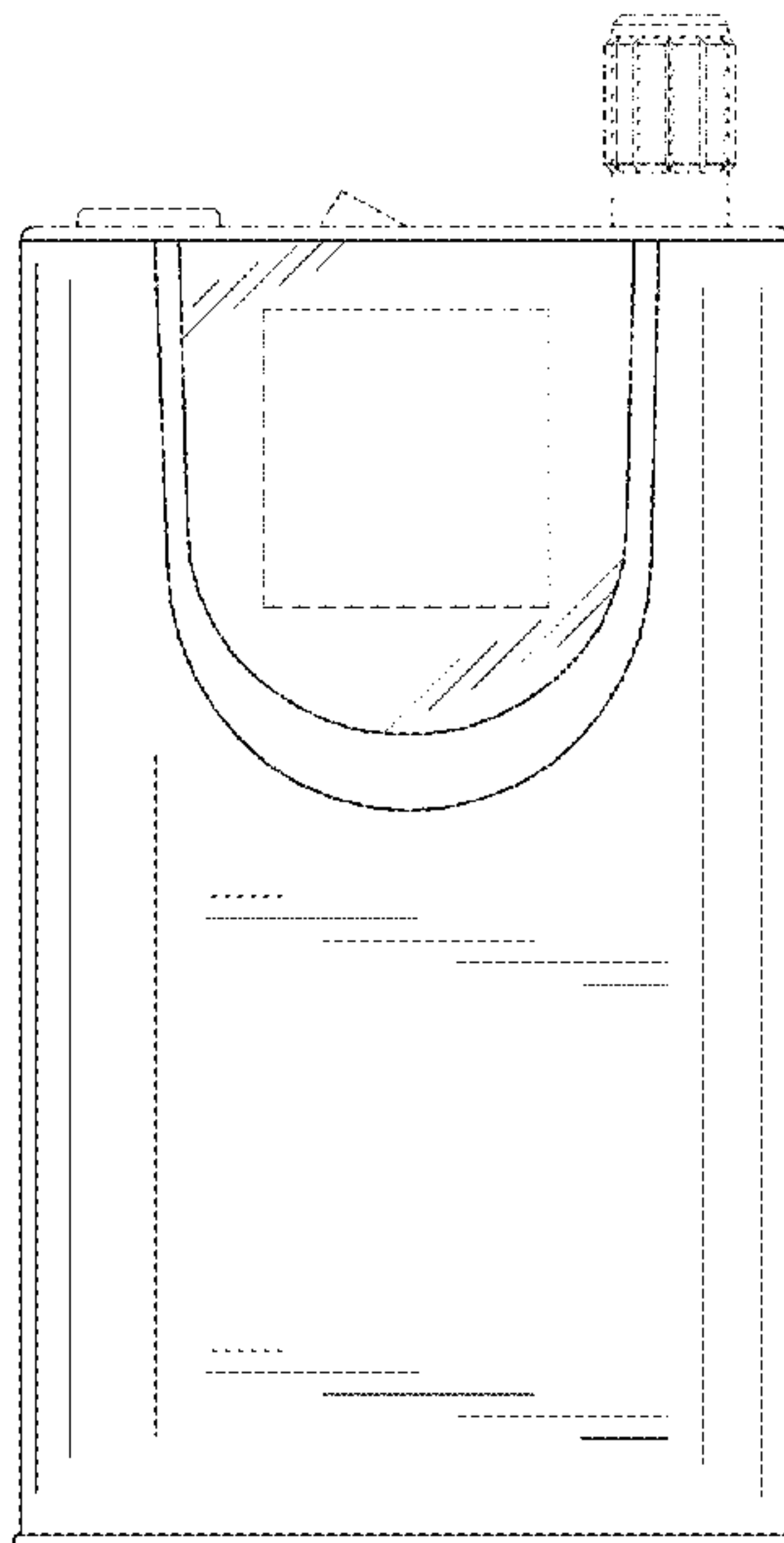
(57) **CLAIM**

The ornamental design for the nail drill housing, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the nail drill housing;
FIG. 2 is a right side view of the nail drill housing of FIG. 1;
FIG. 3 is a left side view of the nail drill housing of FIG. 1;
FIG. 4 is a back view of the nail drill housing of FIG. 1;
FIG. 5 is a top view of the nail drill housing of FIG. 4; and,
FIG. 6 is a bottom view of the nail drill housing of FIG. 4.

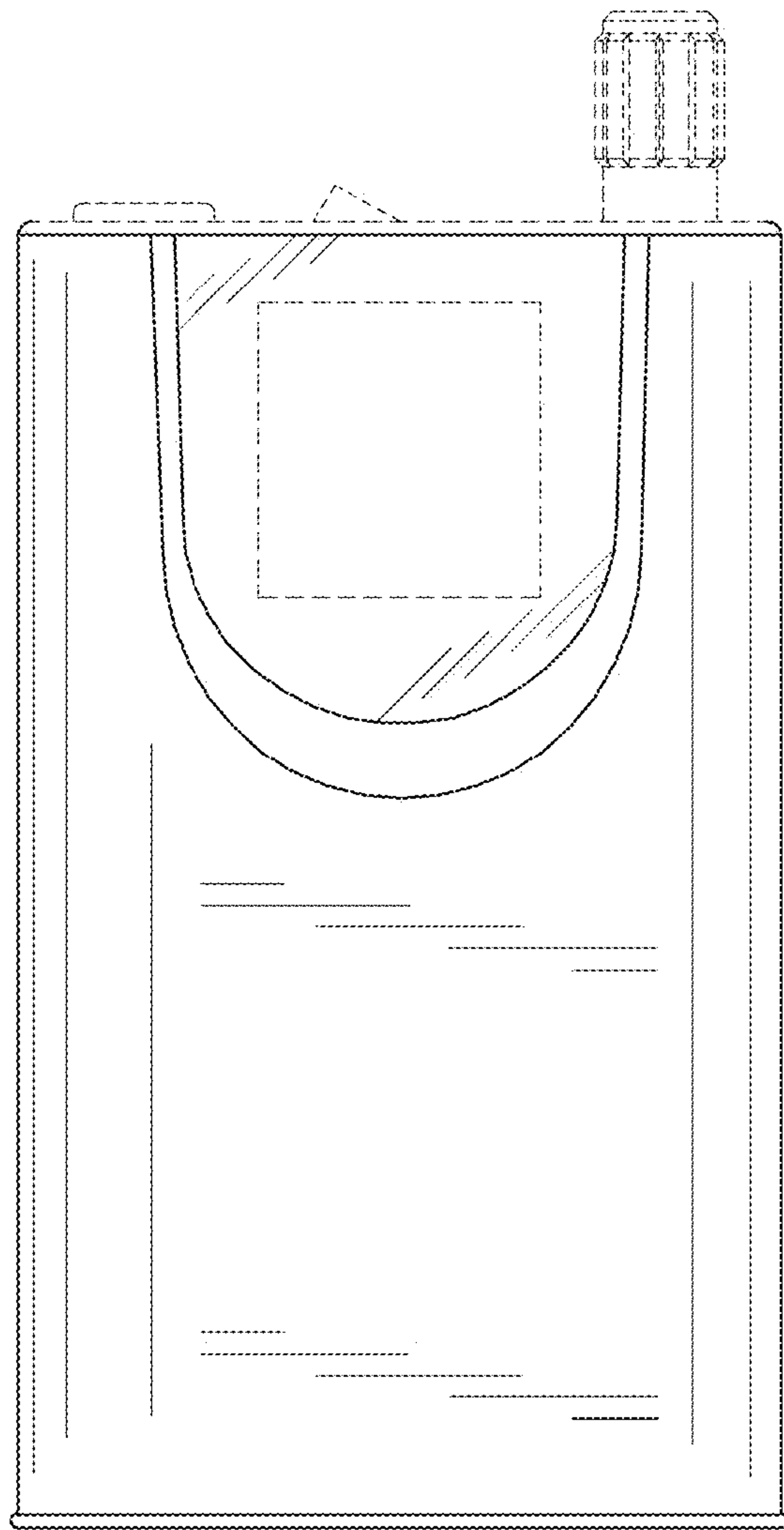

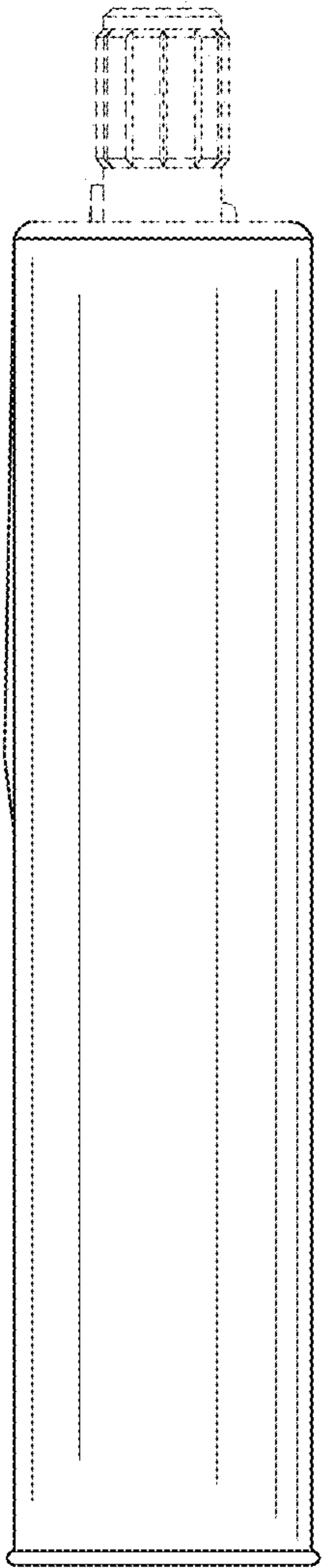

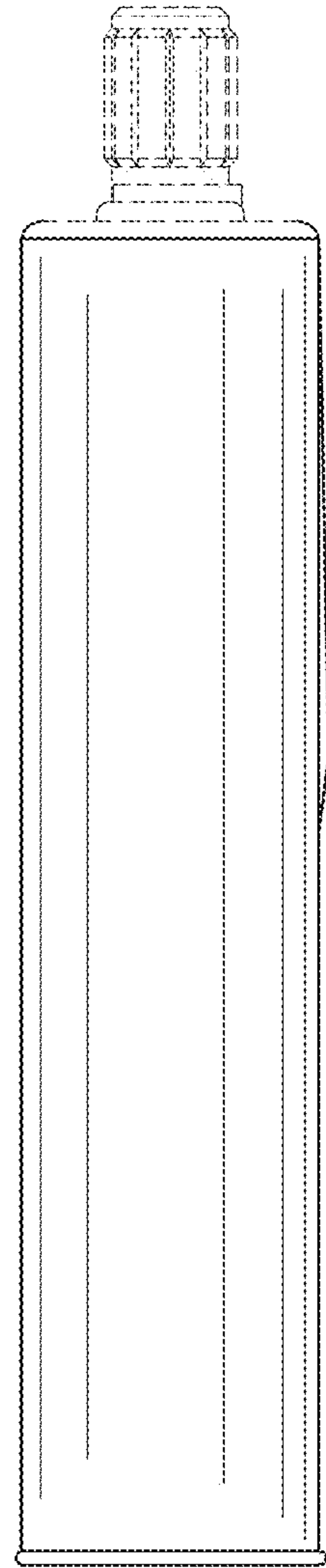

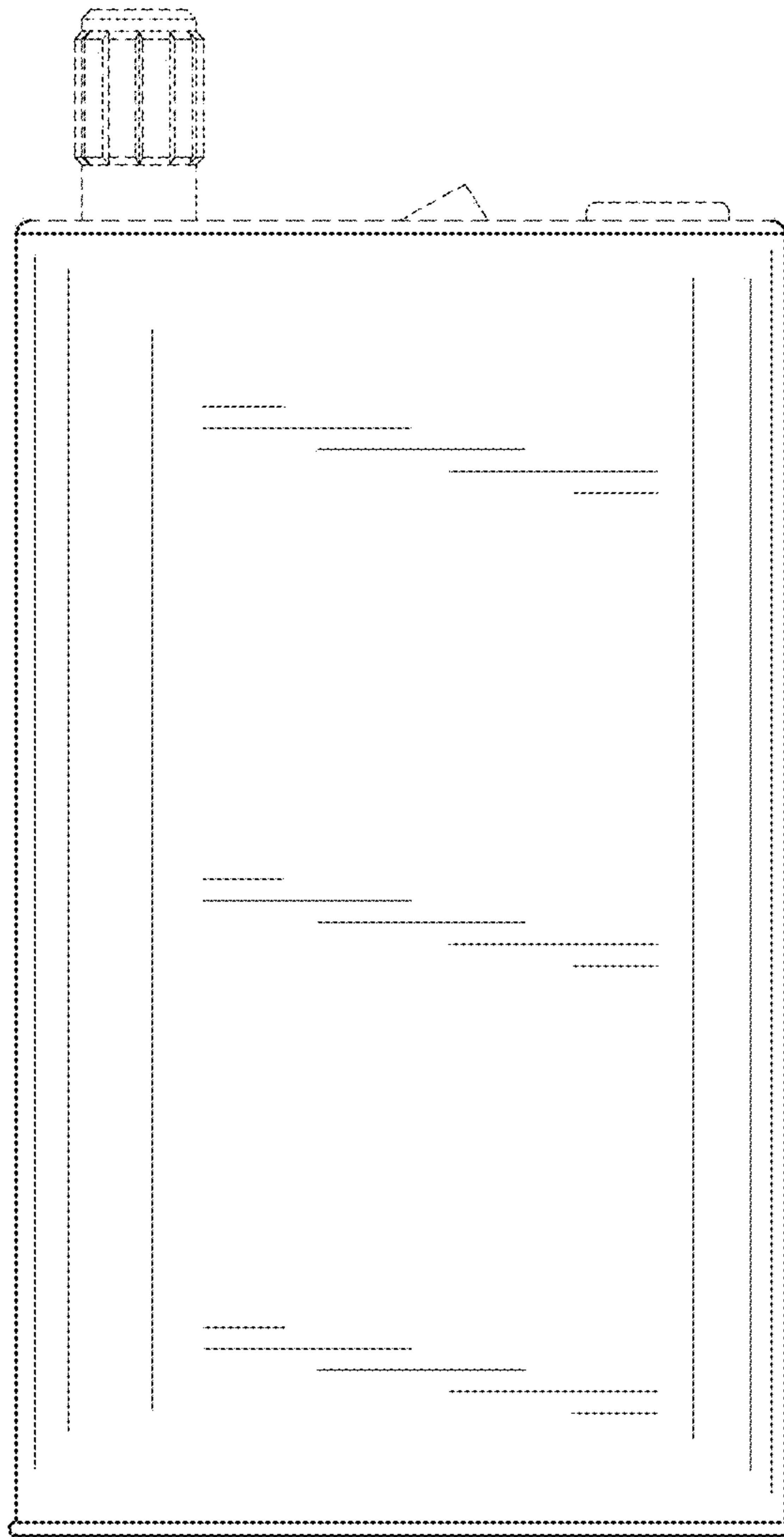

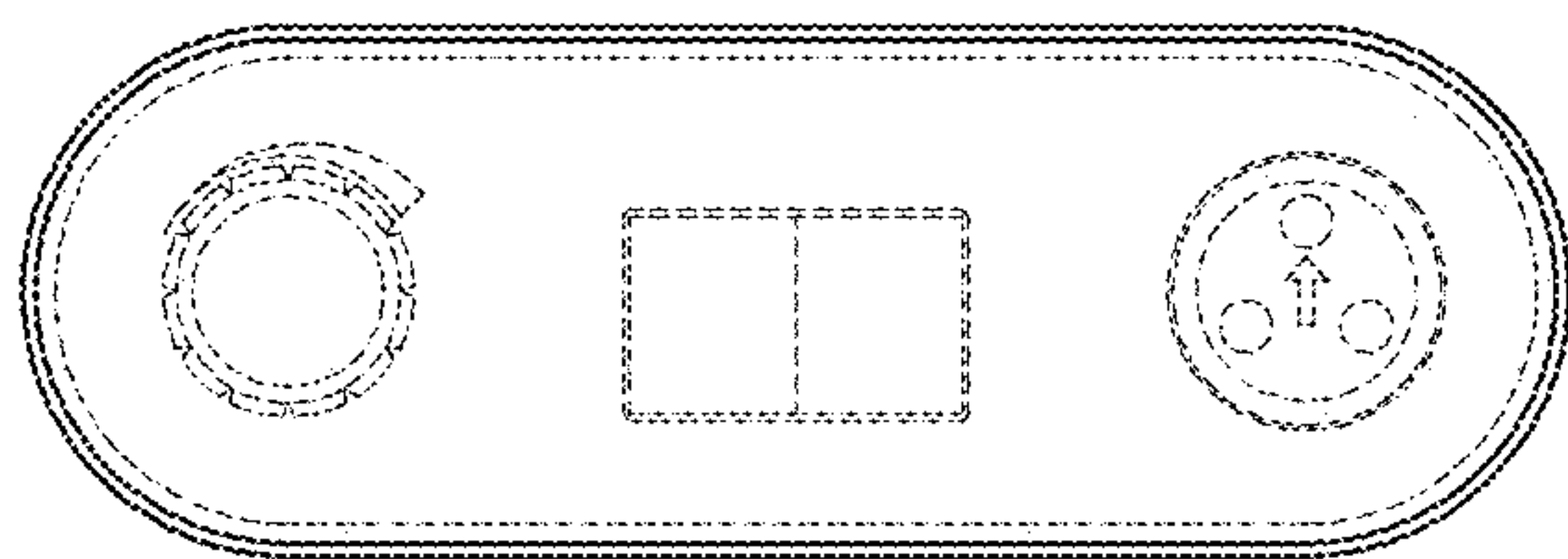

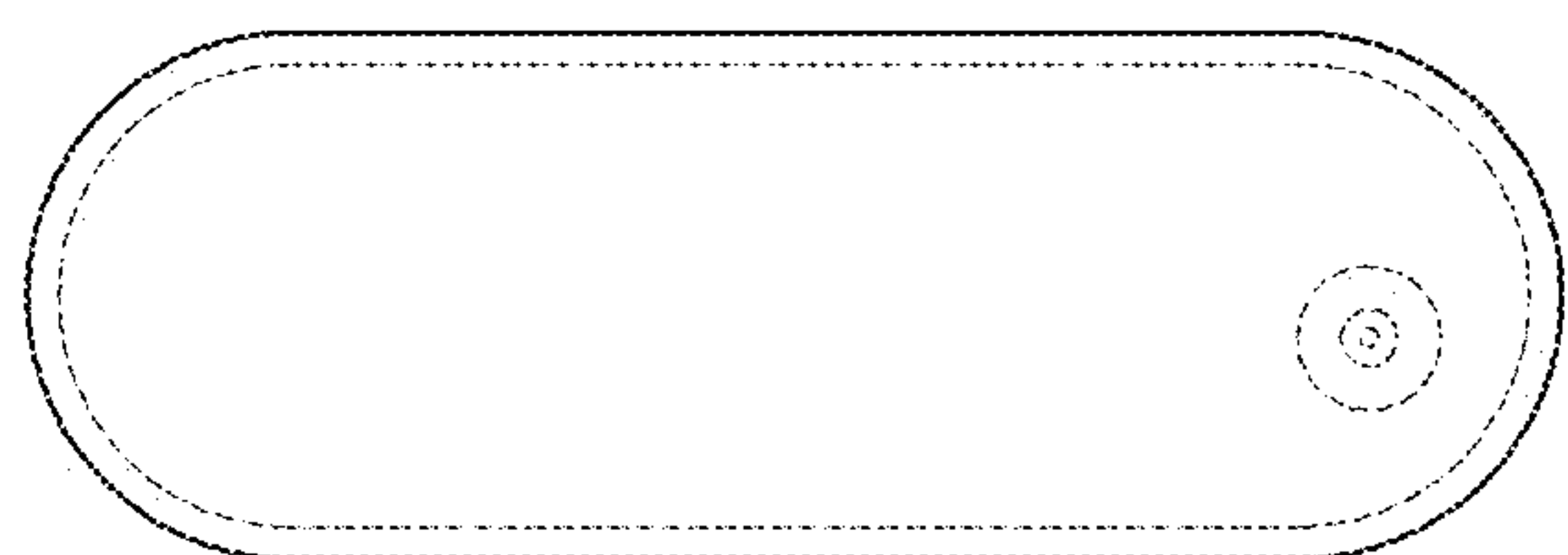
