FIG. 4 is side view thereof;

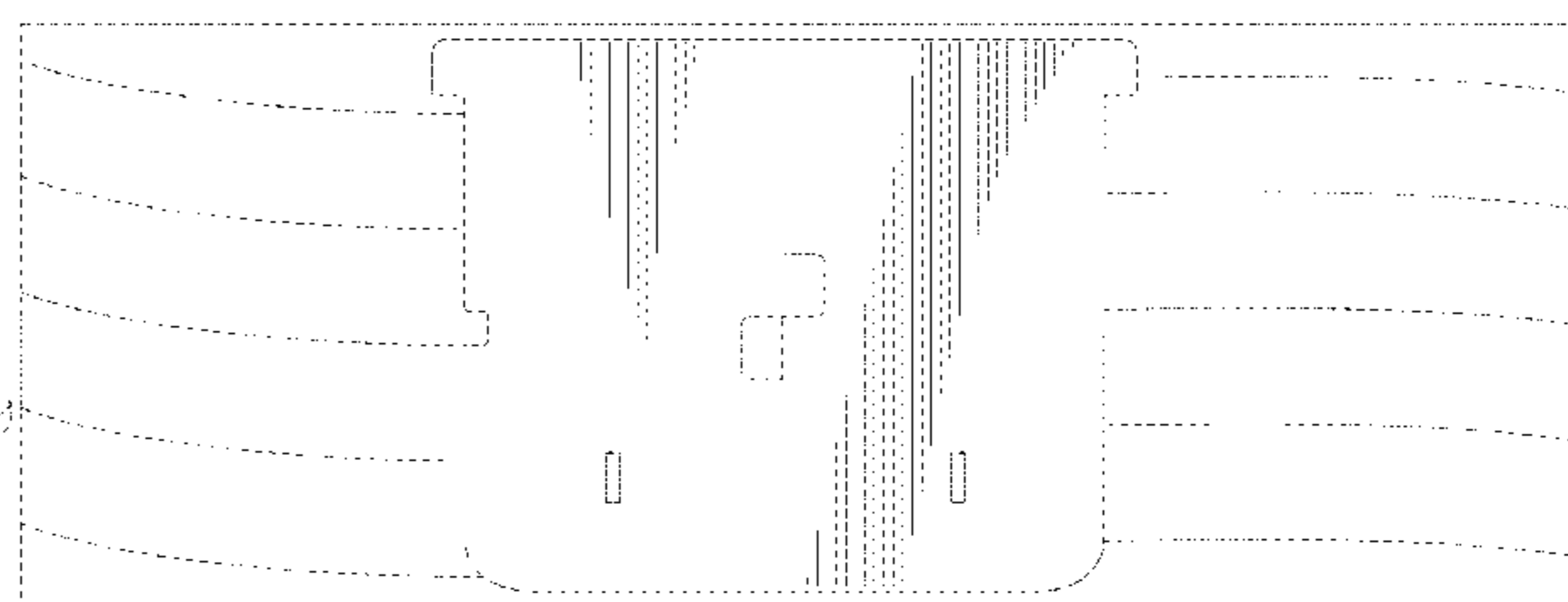
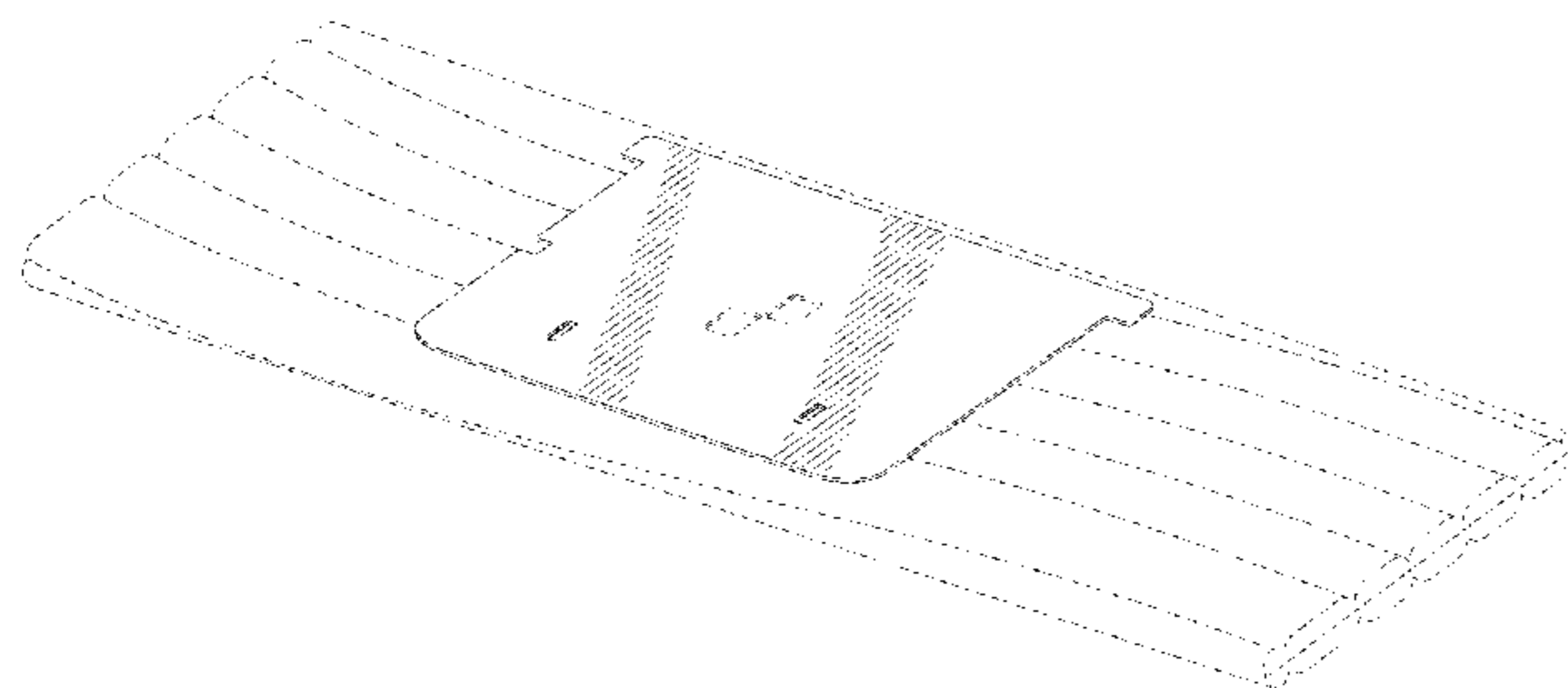
FIG. 5 is an opposing side view thereof;

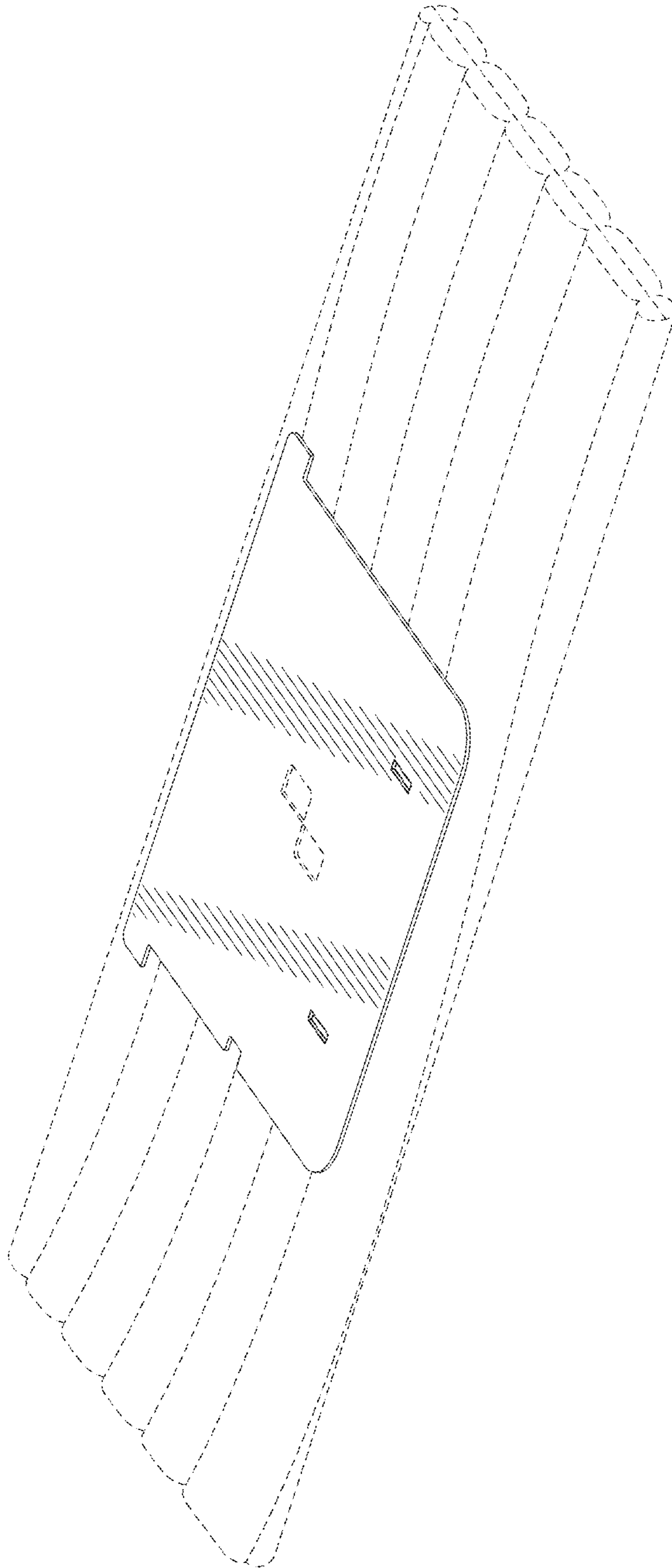

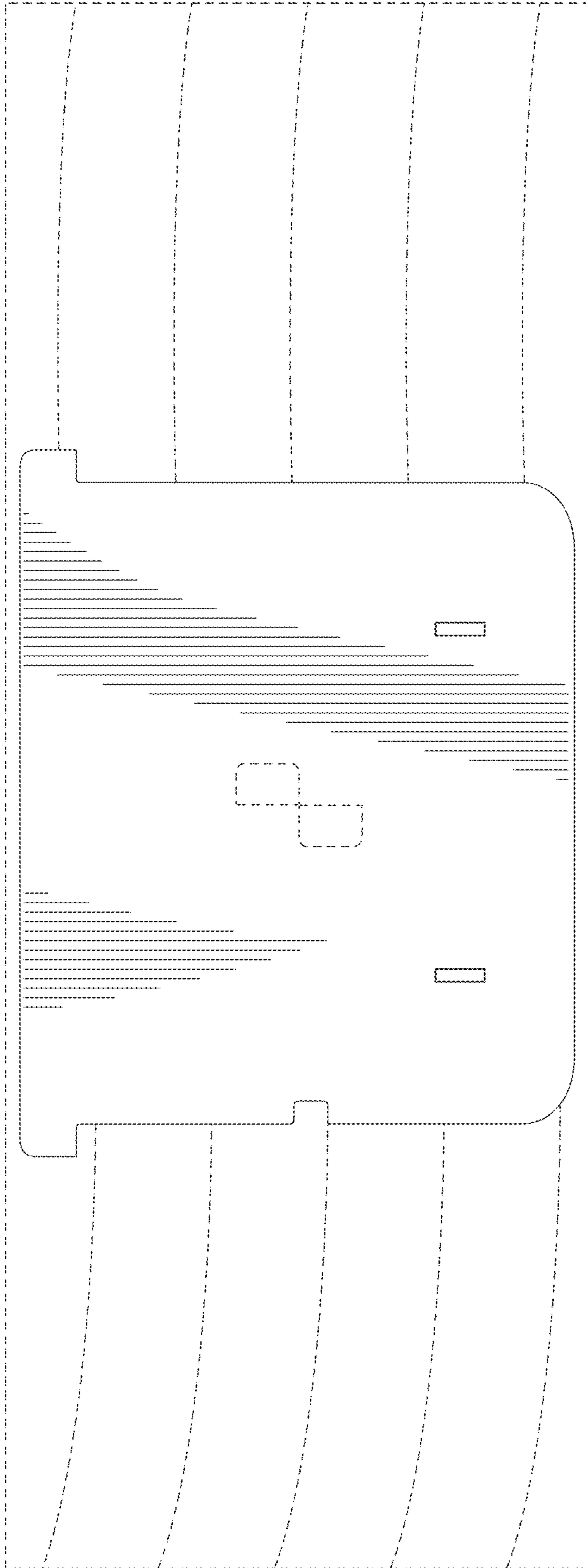

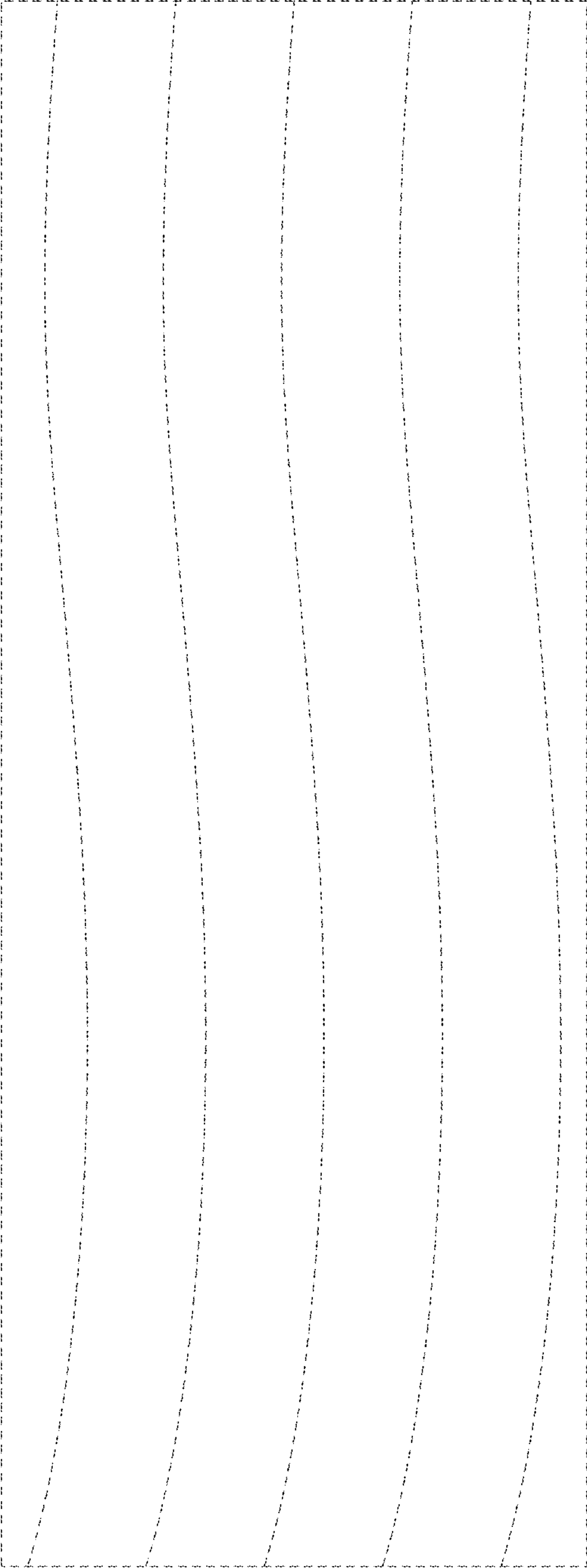
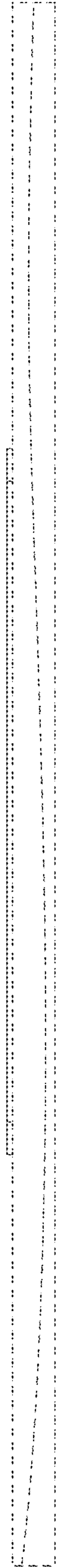
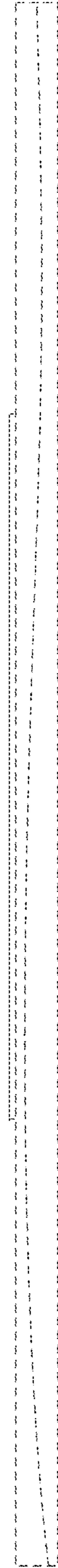


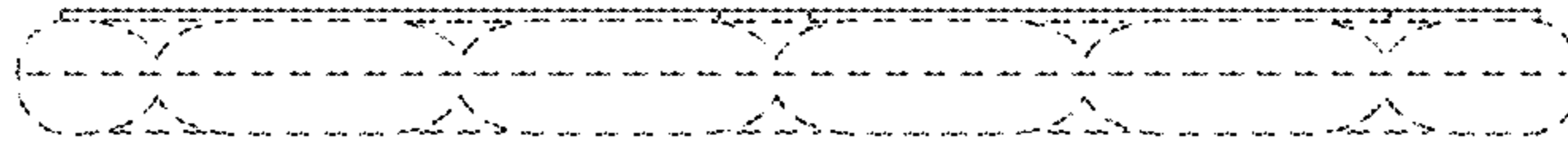

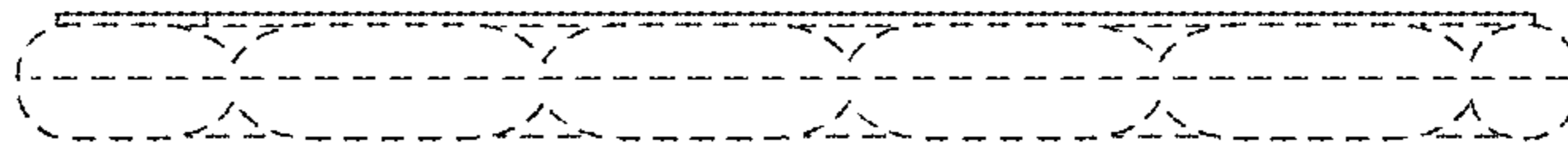
