The ornamental design for a pair of athletic hip shorts for men, as shown and described herein.

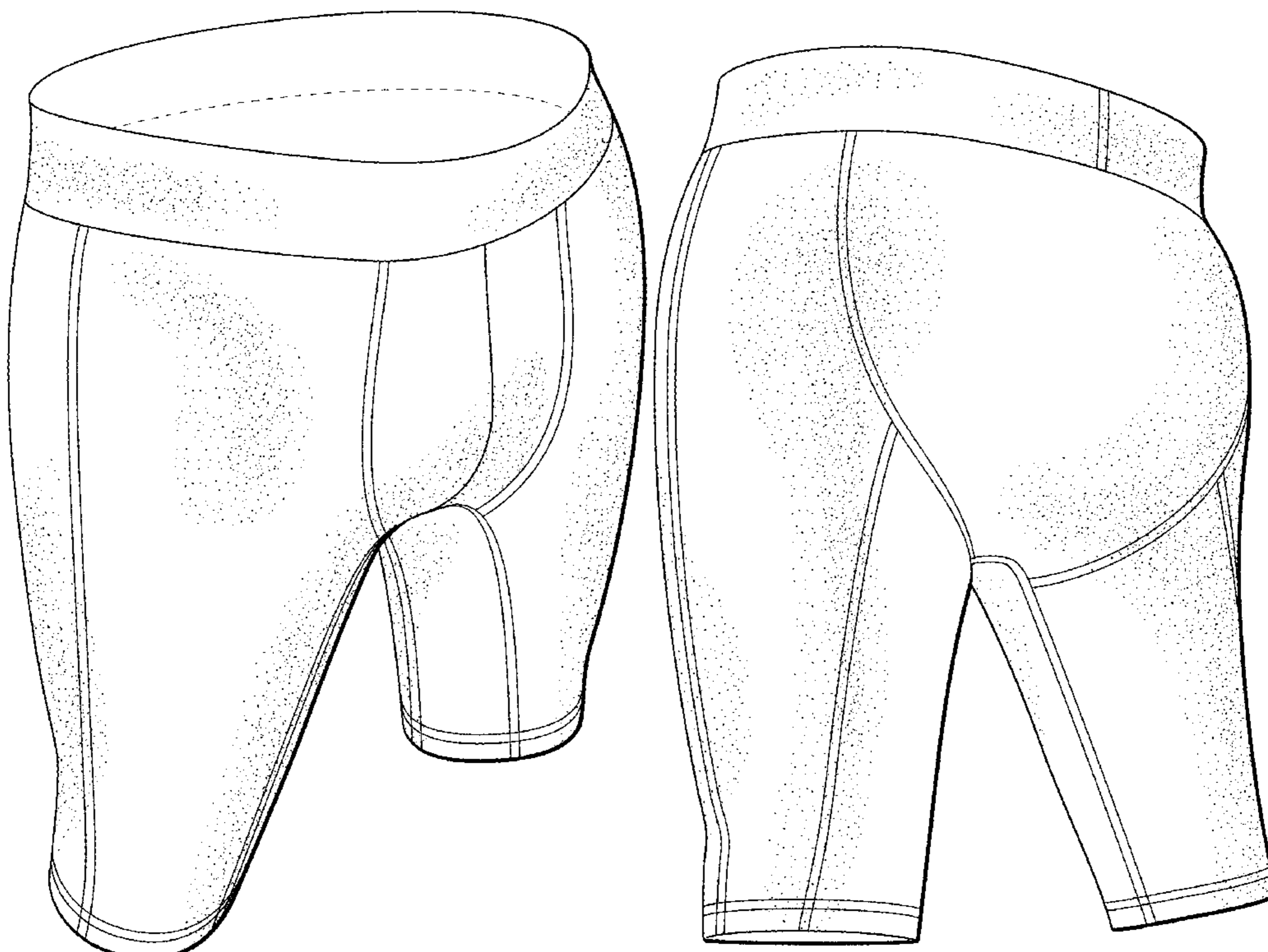
**DESCRIPTION**

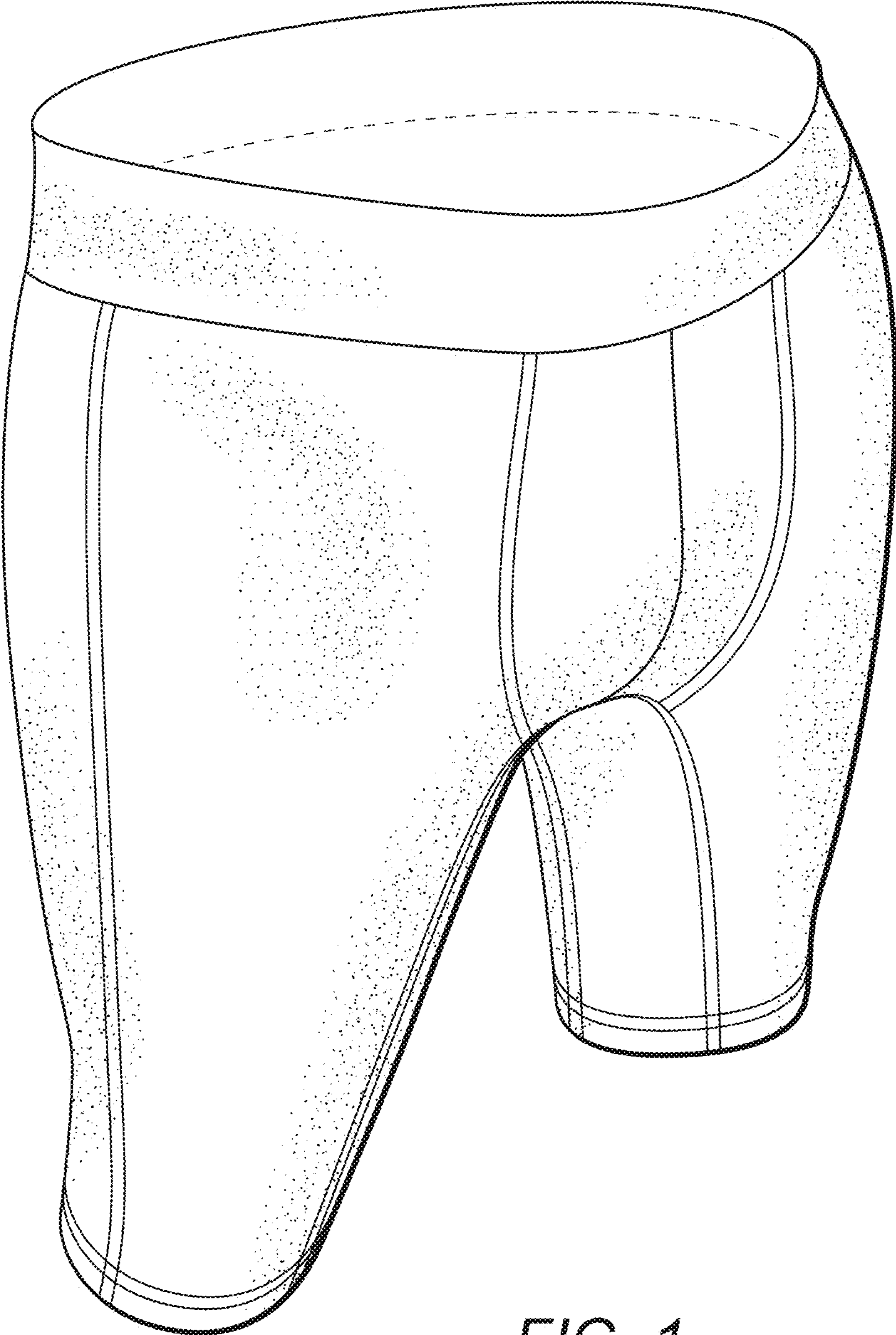

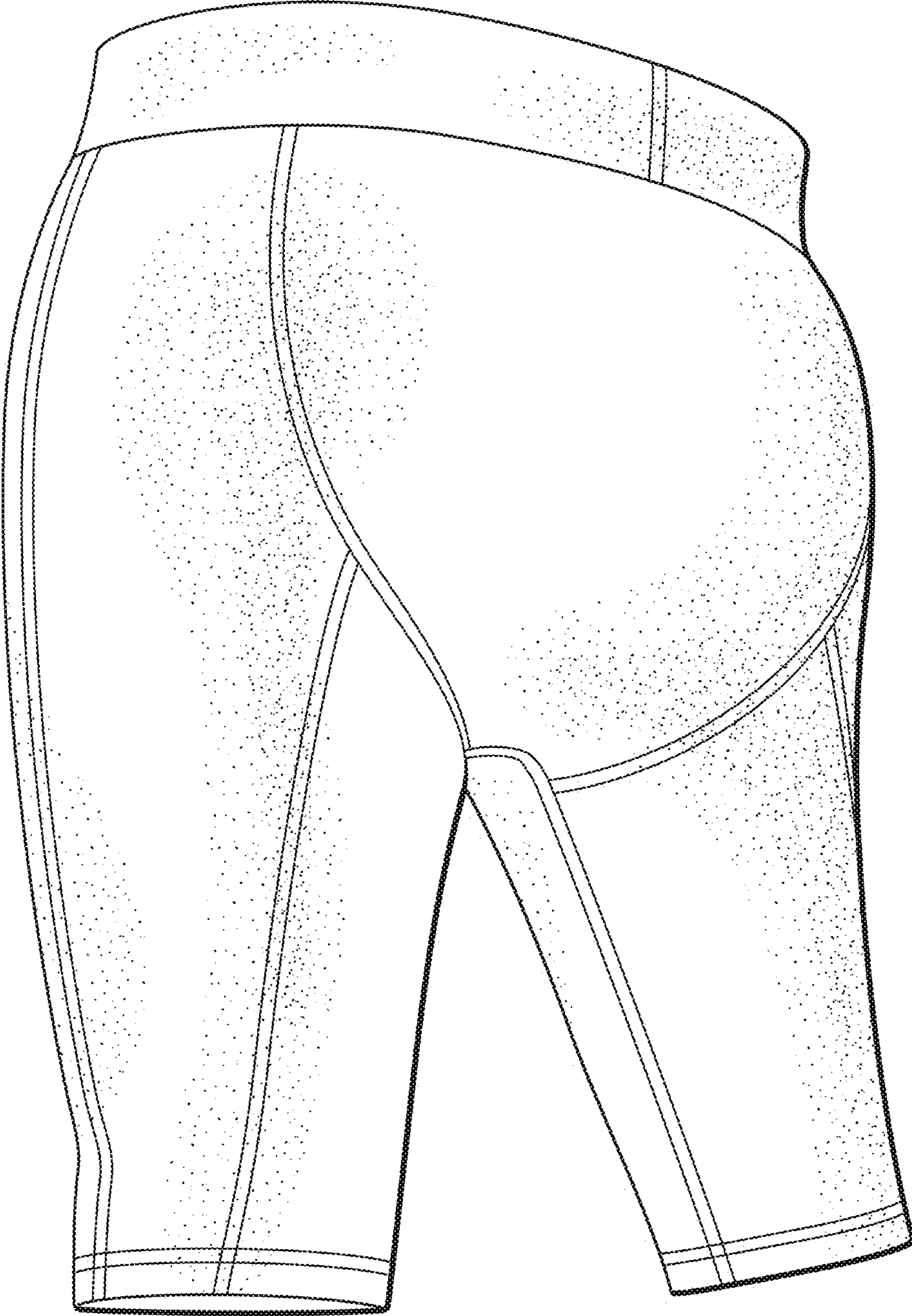
