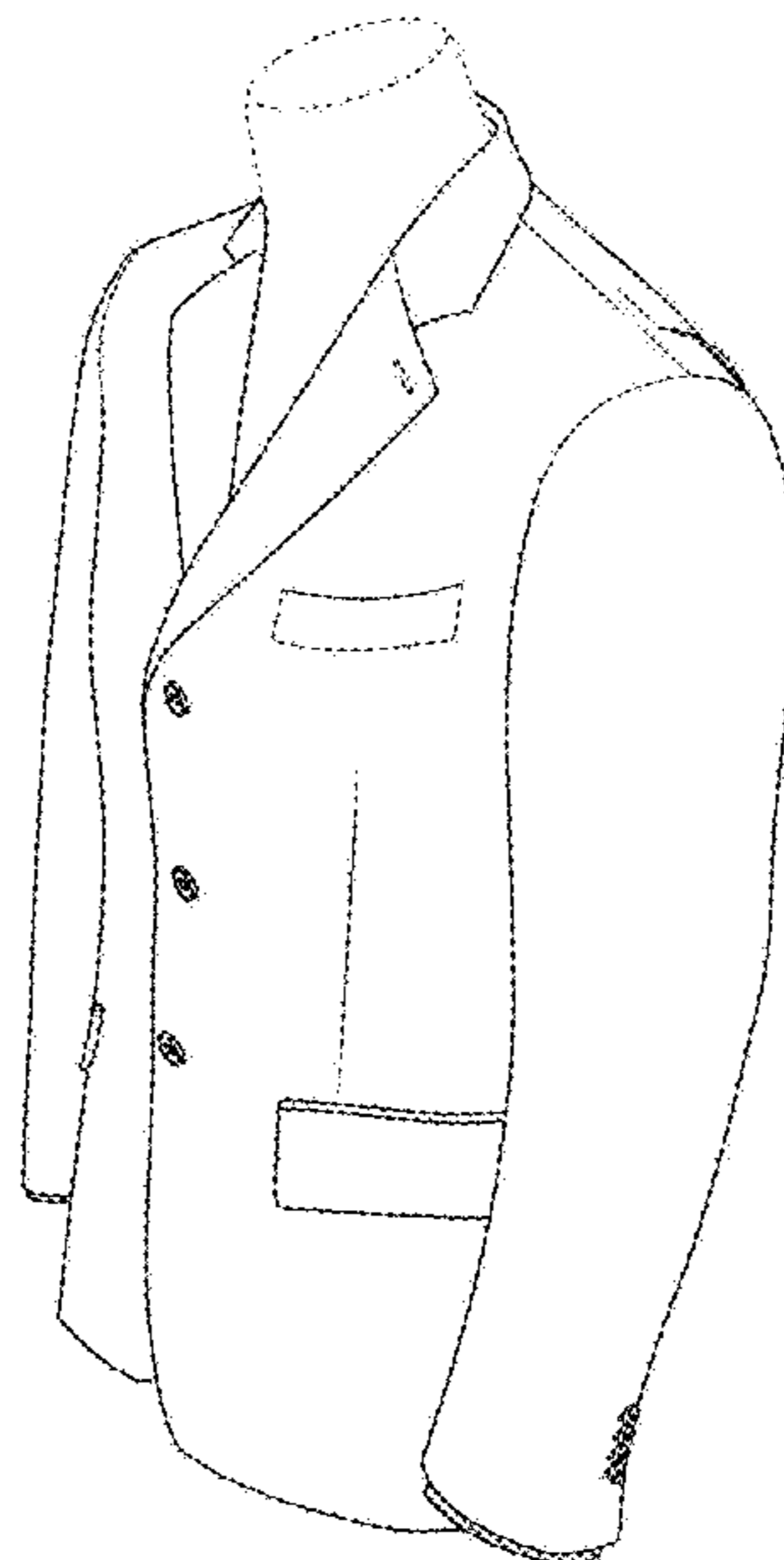
(57) **CLAIM**

The ornamental design for a motorcycle blazer, as shown and described.

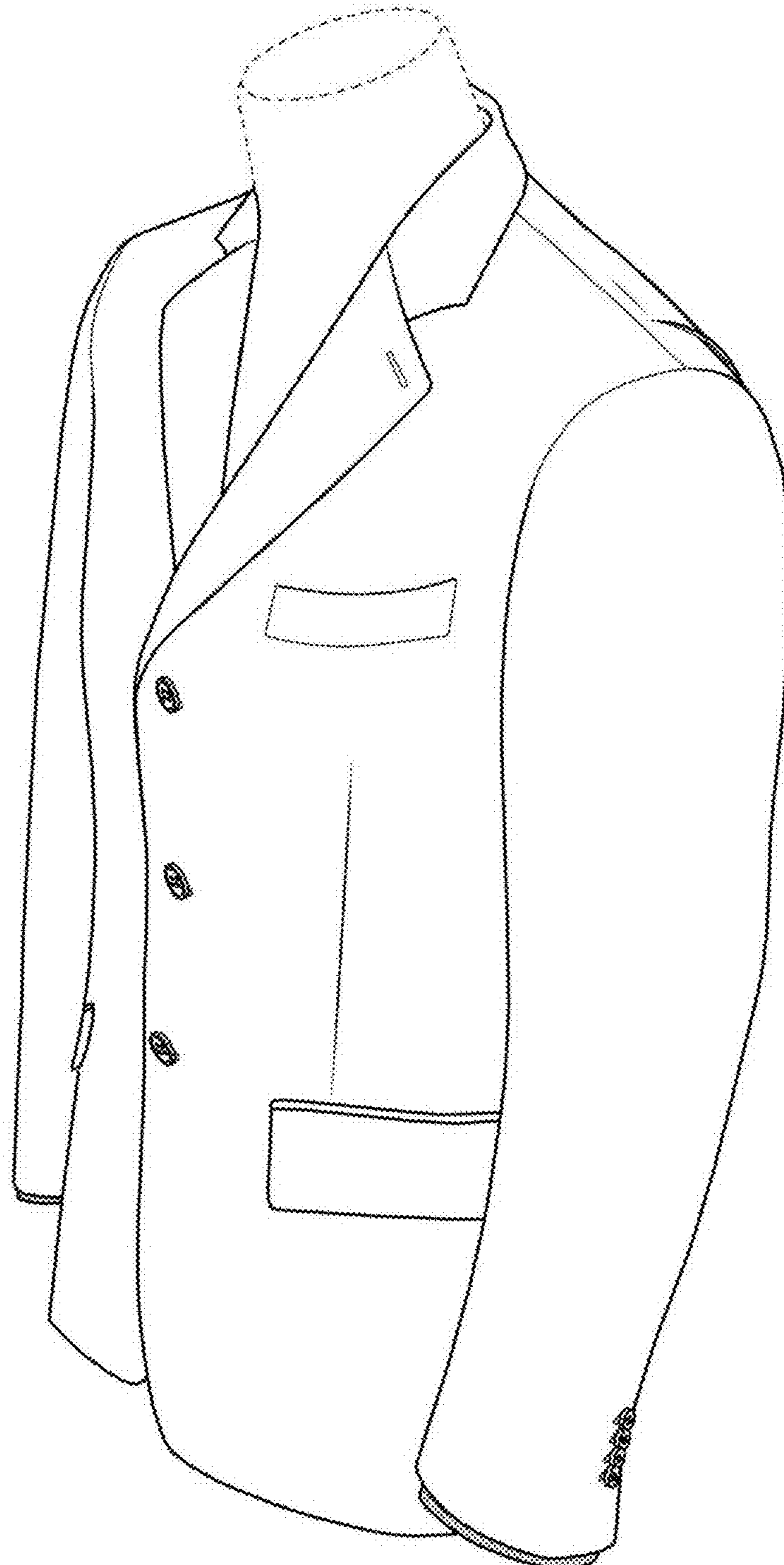
DESCRIPTION

The broken lines depict environment and form no part of the claim.

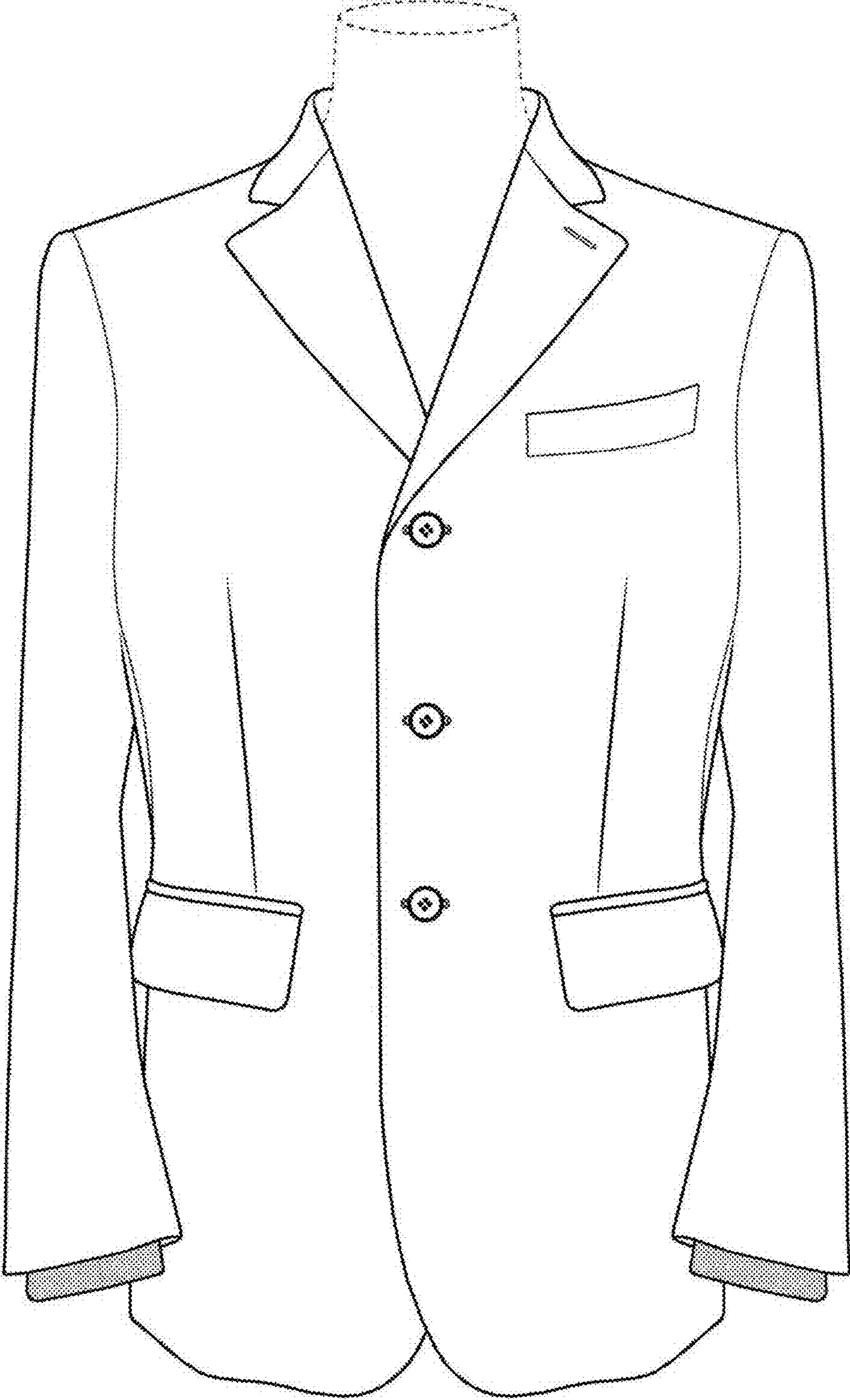

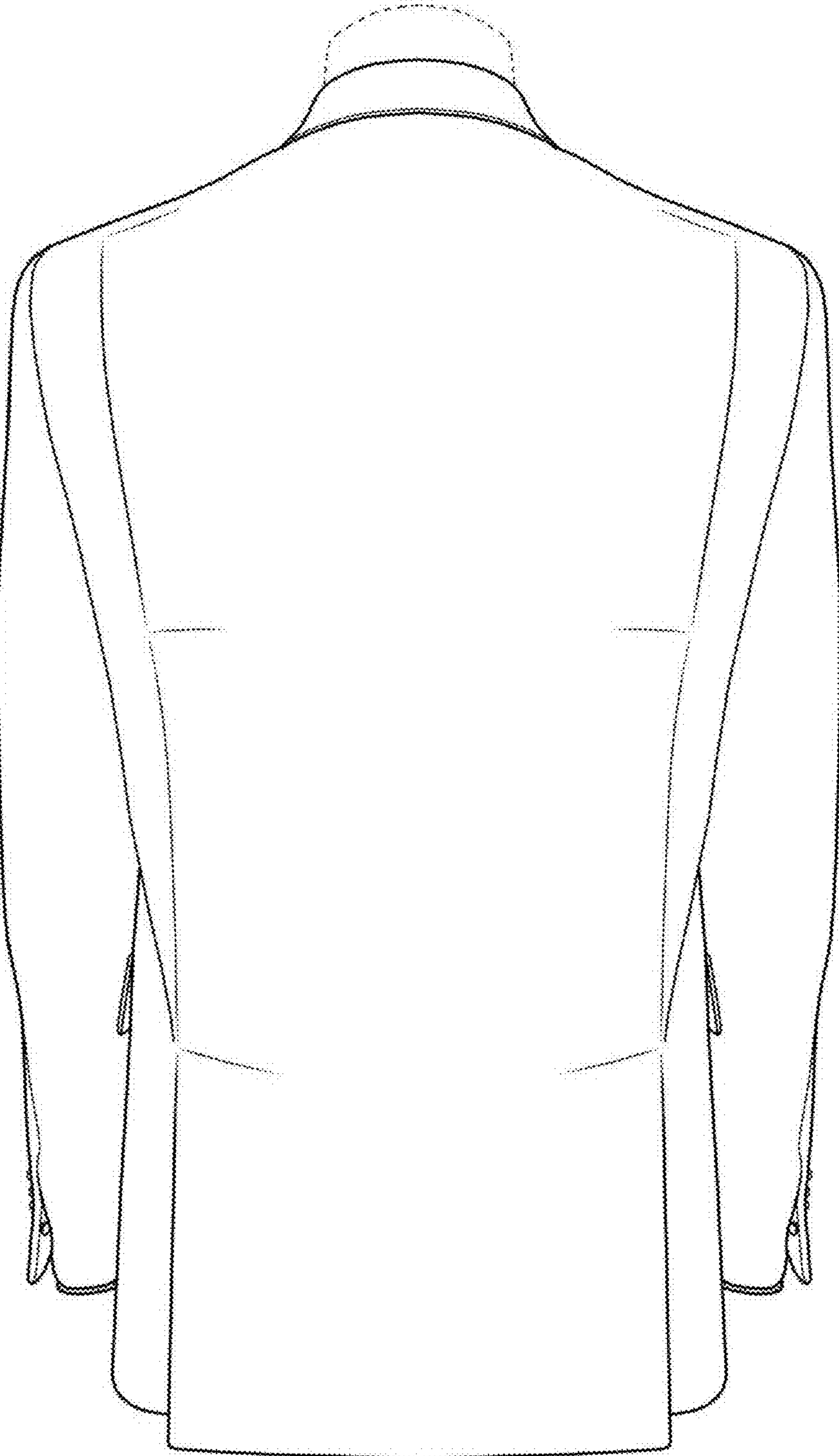

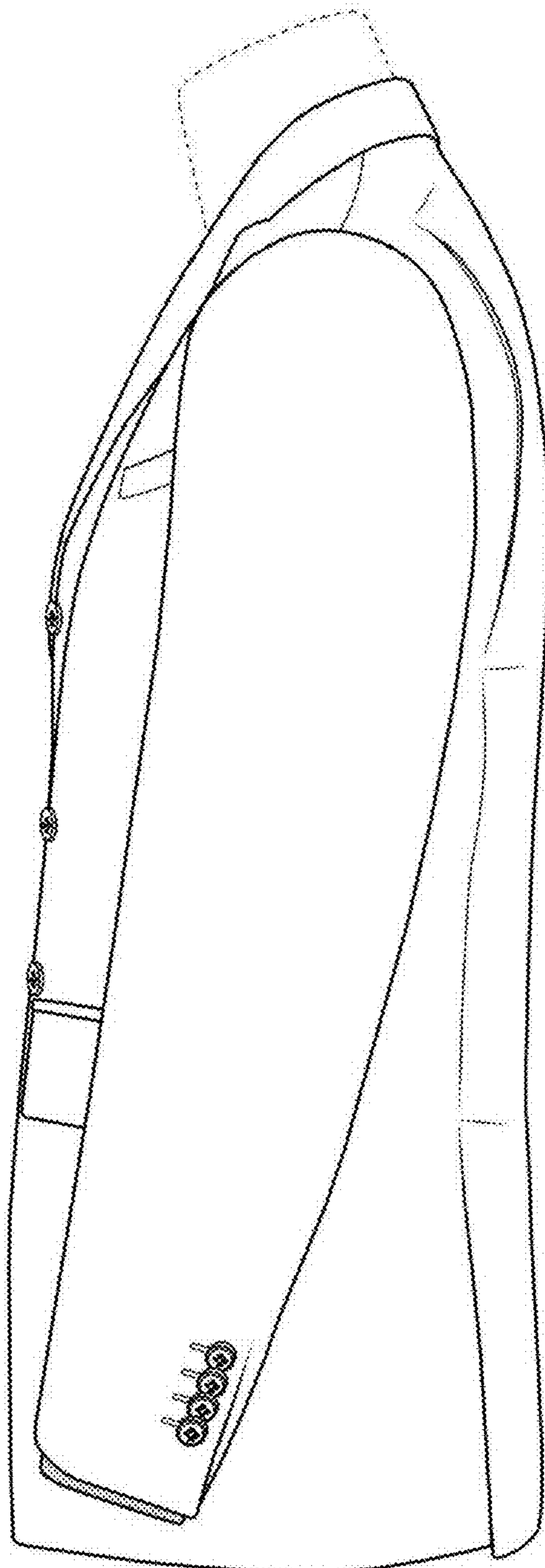

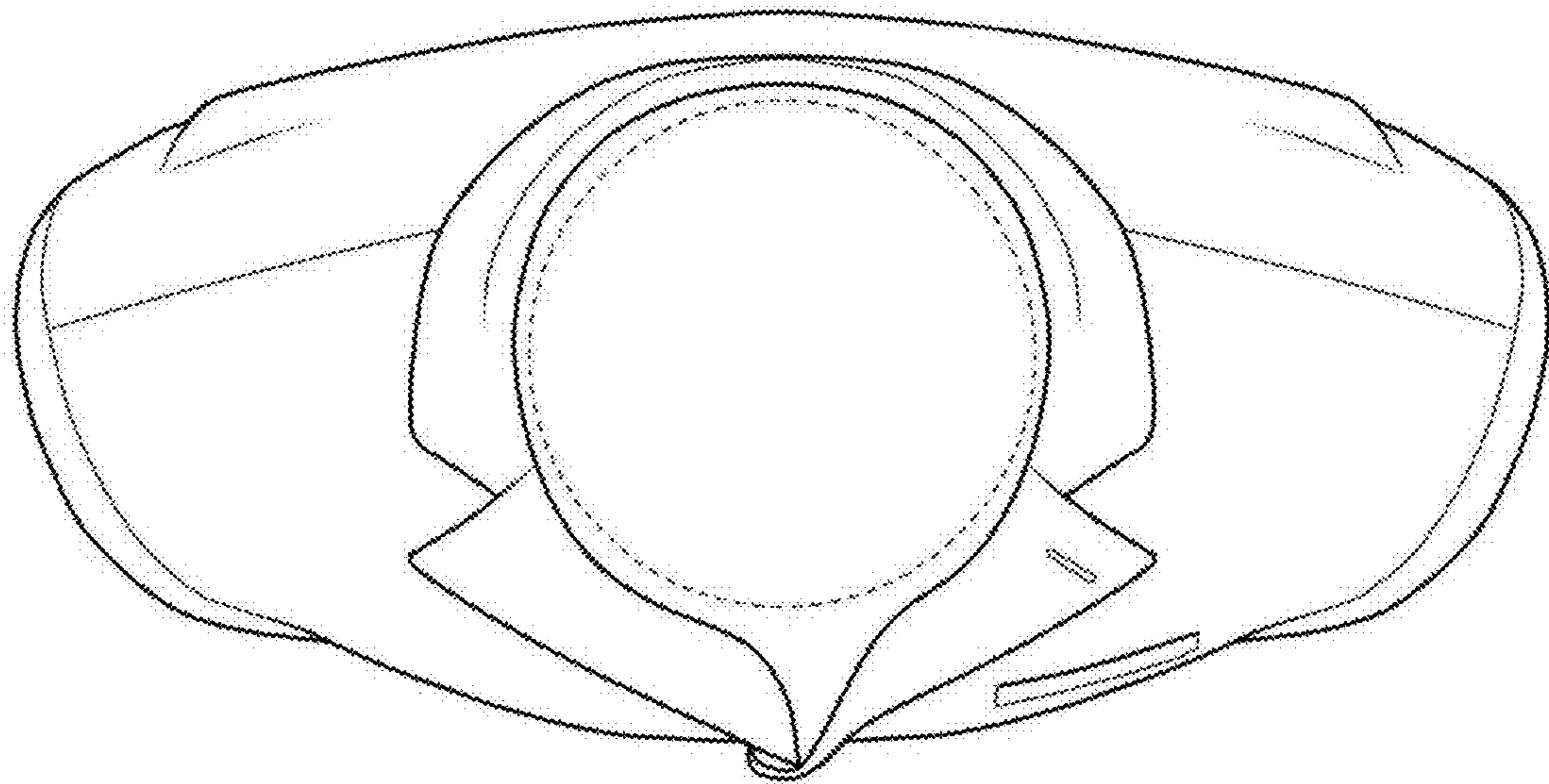
