I claim the ornamental design for a women's shoe, as shown
and described.

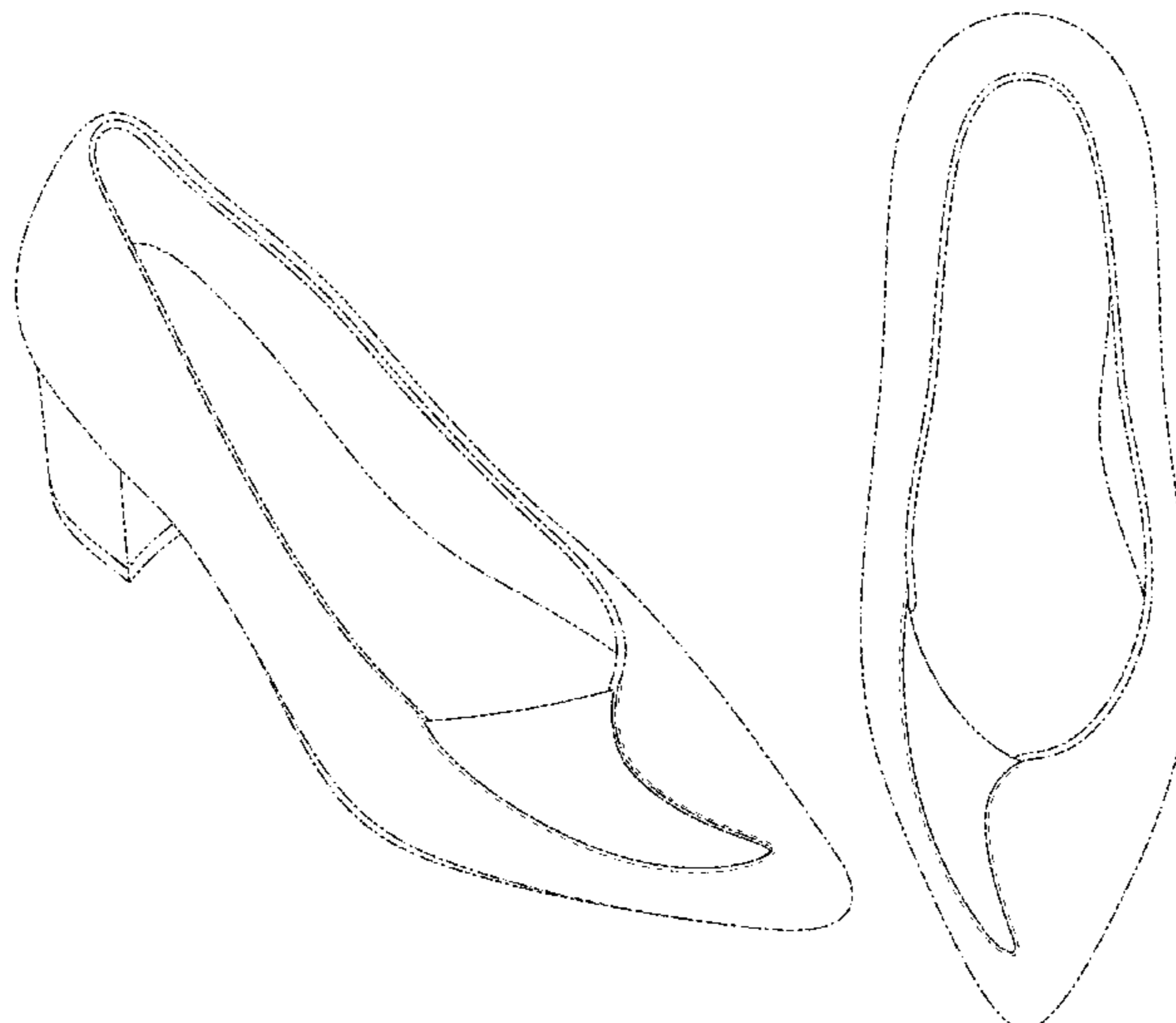
DESCRIPTION

FIG. 1 is a perspective view of a women's shoe showing my
new design;
FIG. 2 is a top view of the women's shoe of FIG. 1;
FIG. 3 is a bottom view the women's shoe of FIG. 1;
FIG. 4 is a right side view of the women's shoe of FIG. 1;
FIG. 5 is a left side view of the women's shoe of FIG. 1;
FIG. 6 is a rear view of the women's shoe of FIG. 1; and,
FIG. 7 is a front view of the women's shoe of FIG. 1.

The broken lines showing the remainder of the women's
shoe are for illustrative purposes and form no part of the
claimed design. In particular, the dash-dash broken lines in
the figure views depict stitching, which forms no part of the
claimed design.

A mirrored image version of the right side women's shoe
shown in FIGS. 1-7 for the opposite left side foot is not
shown but is claimed as a second embodiment.

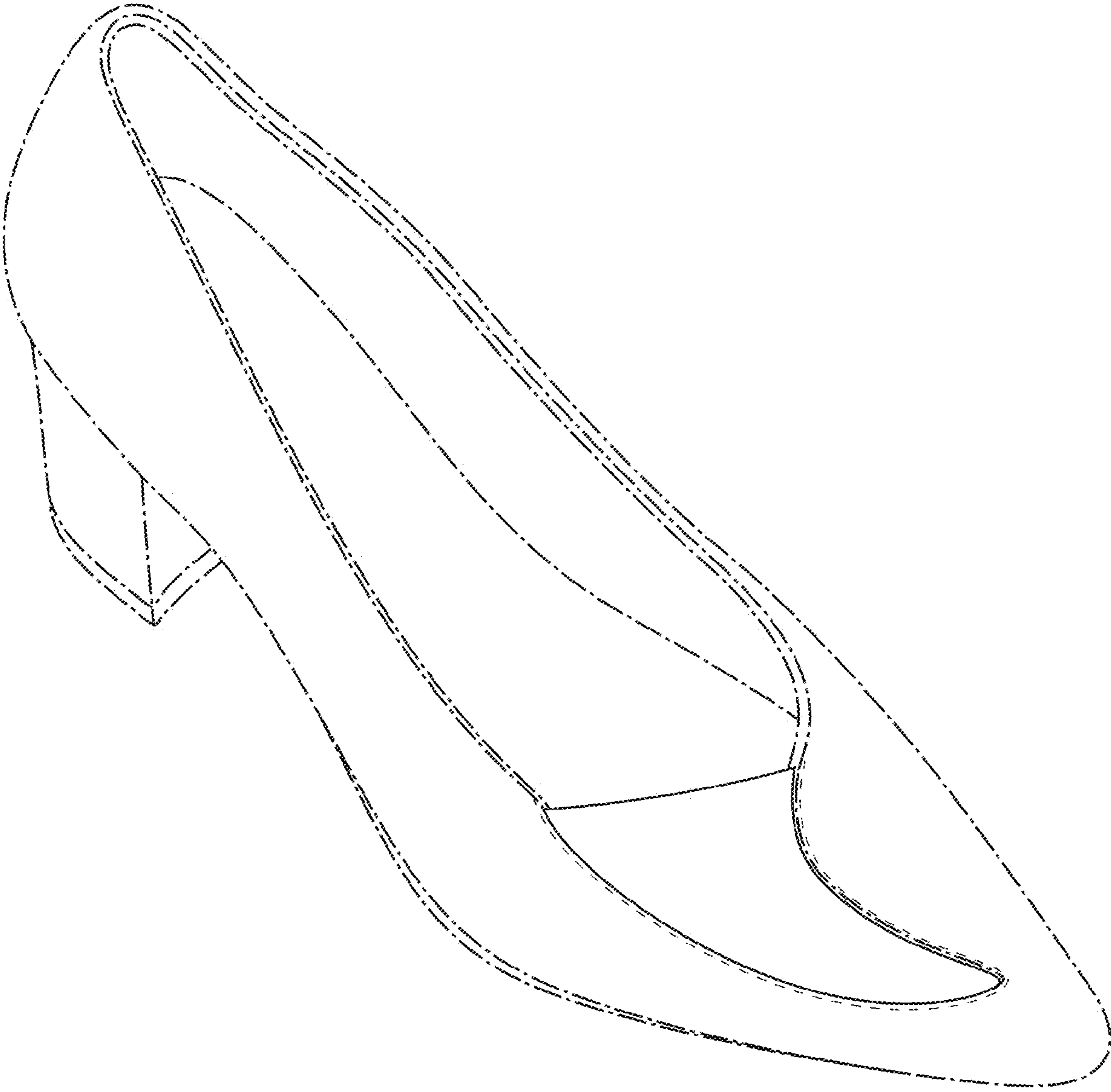

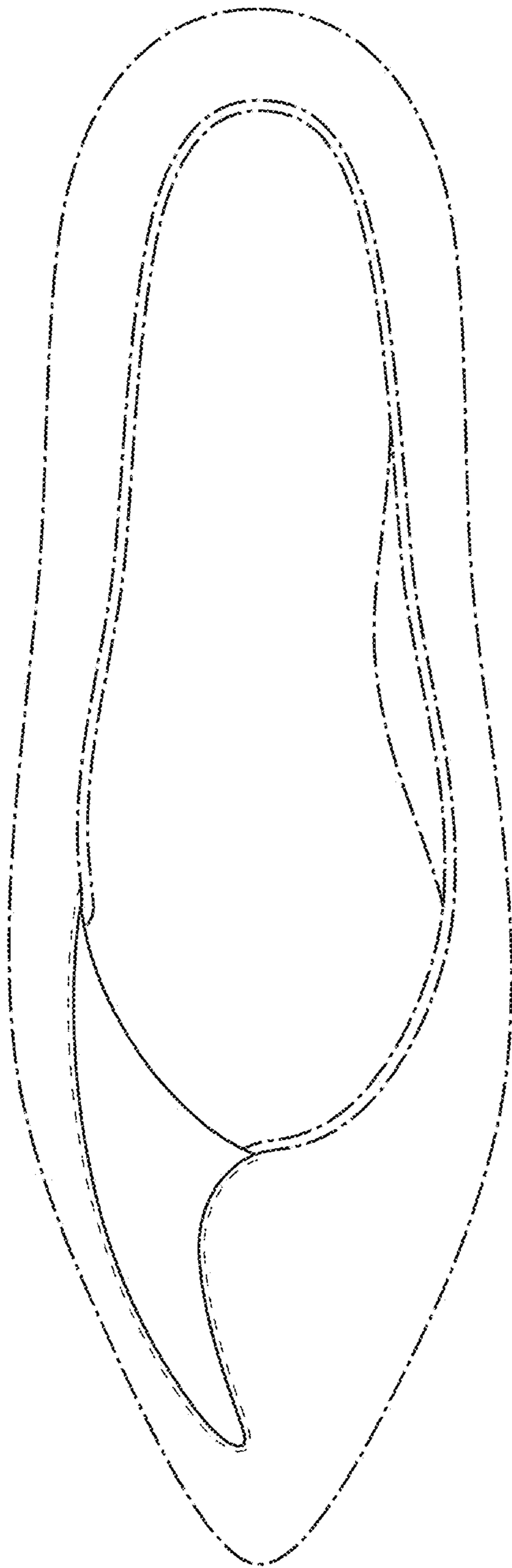

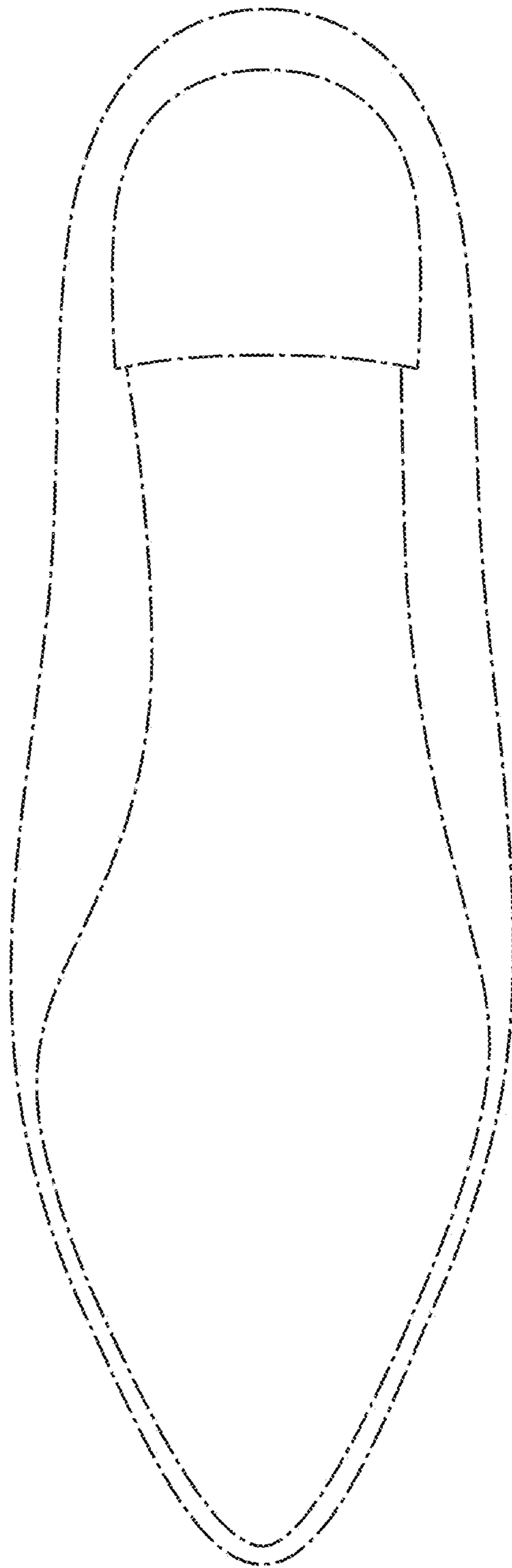

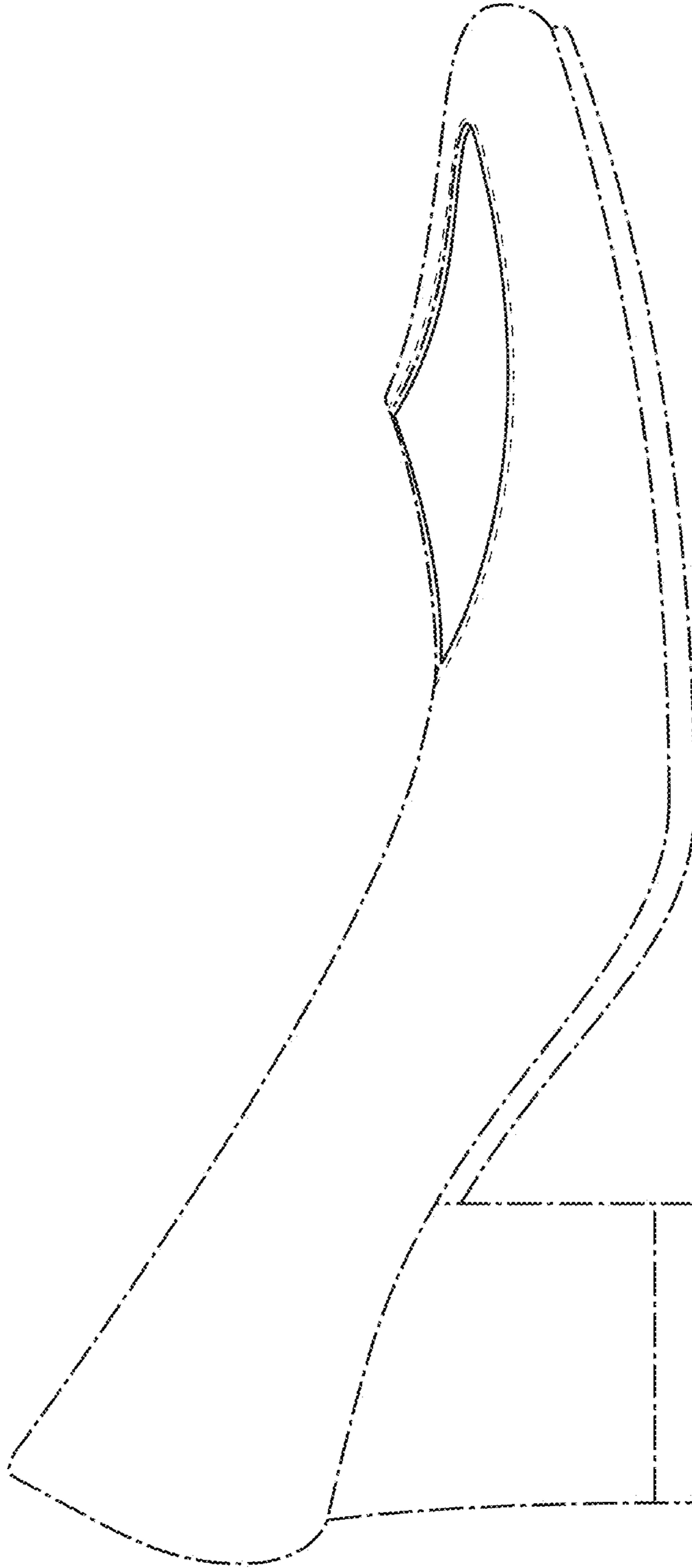

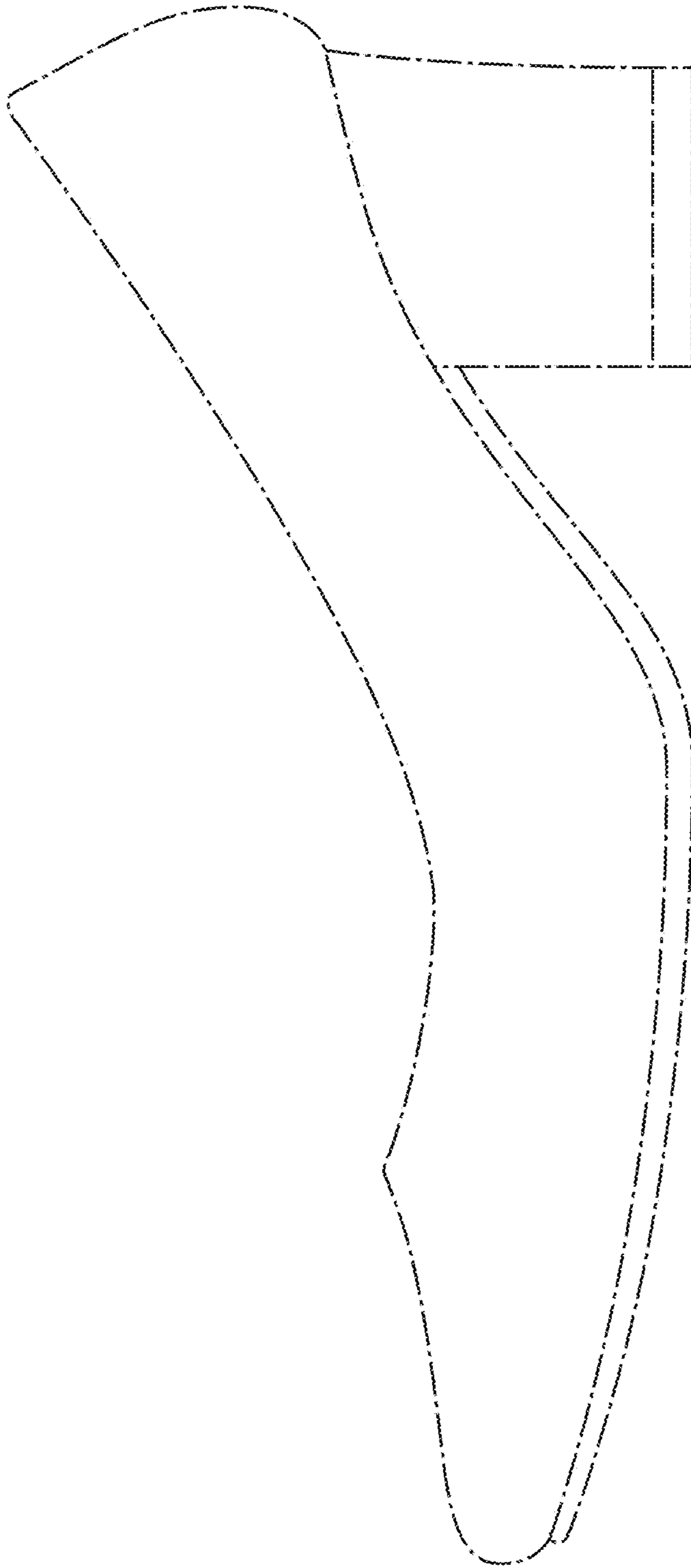

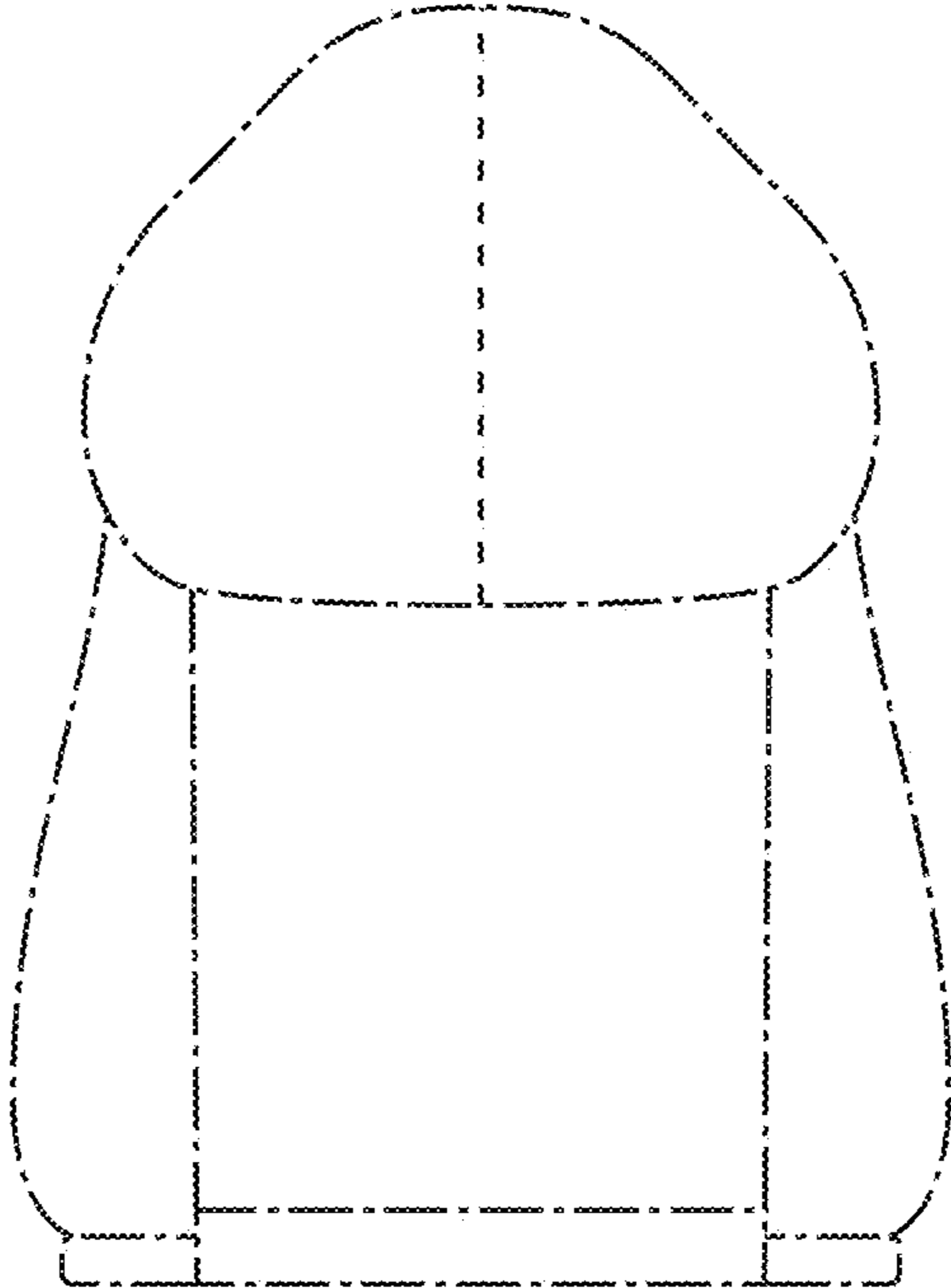

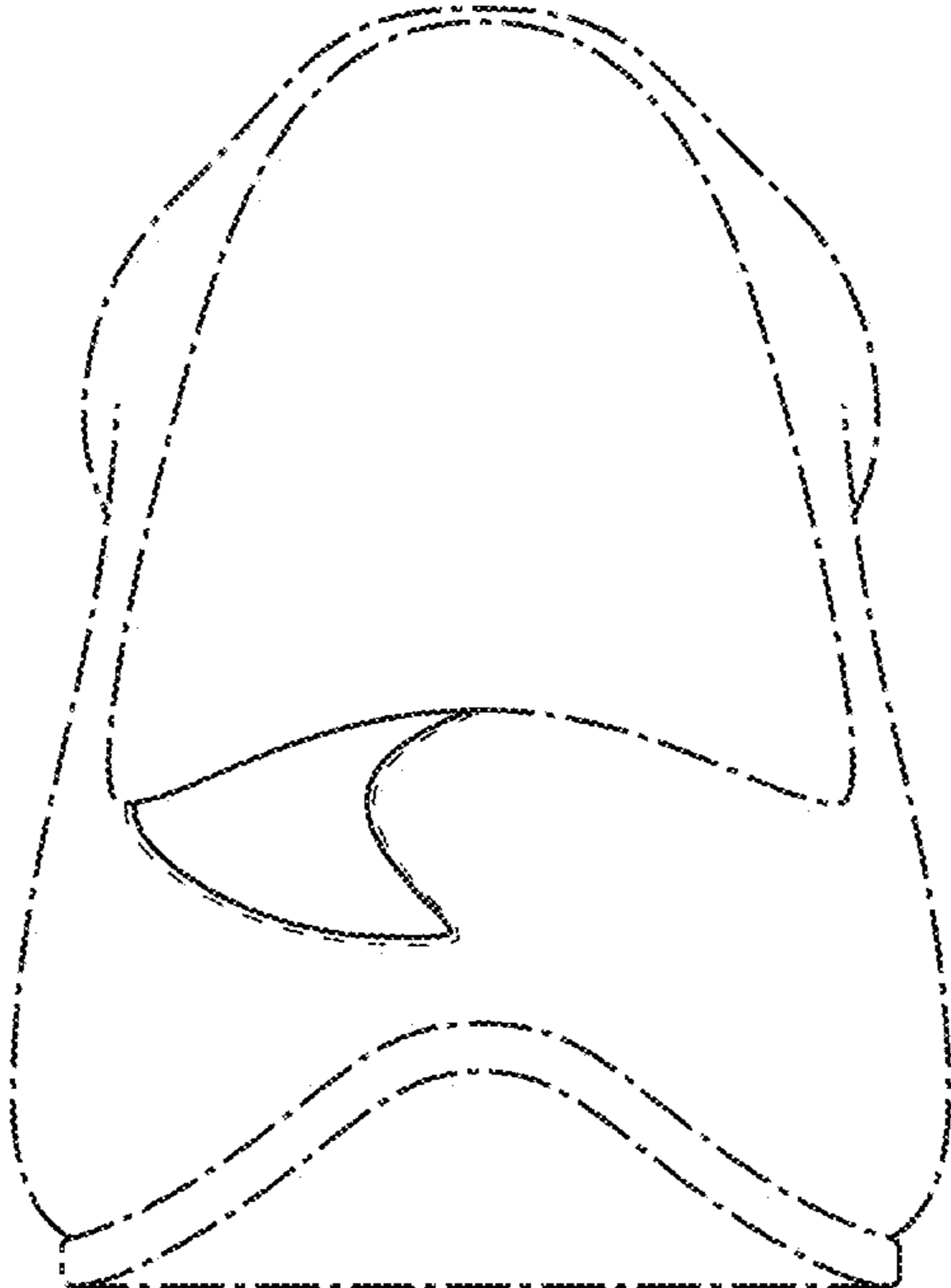
