(57) **CLAIM**

The ornamental design for crib wedge pillow set, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a crib wedge pillow set in accordance with the new design, and showing a first embodiment of the lower pad;

FIG. 2 is a front view of the upper portion of FIG. 1 thereof;

FIG. 3 is a rear view of FIG. 1 thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view of FIG. 1 thereof;

FIG. 7 is a bottom view of FIG. 1 thereof;

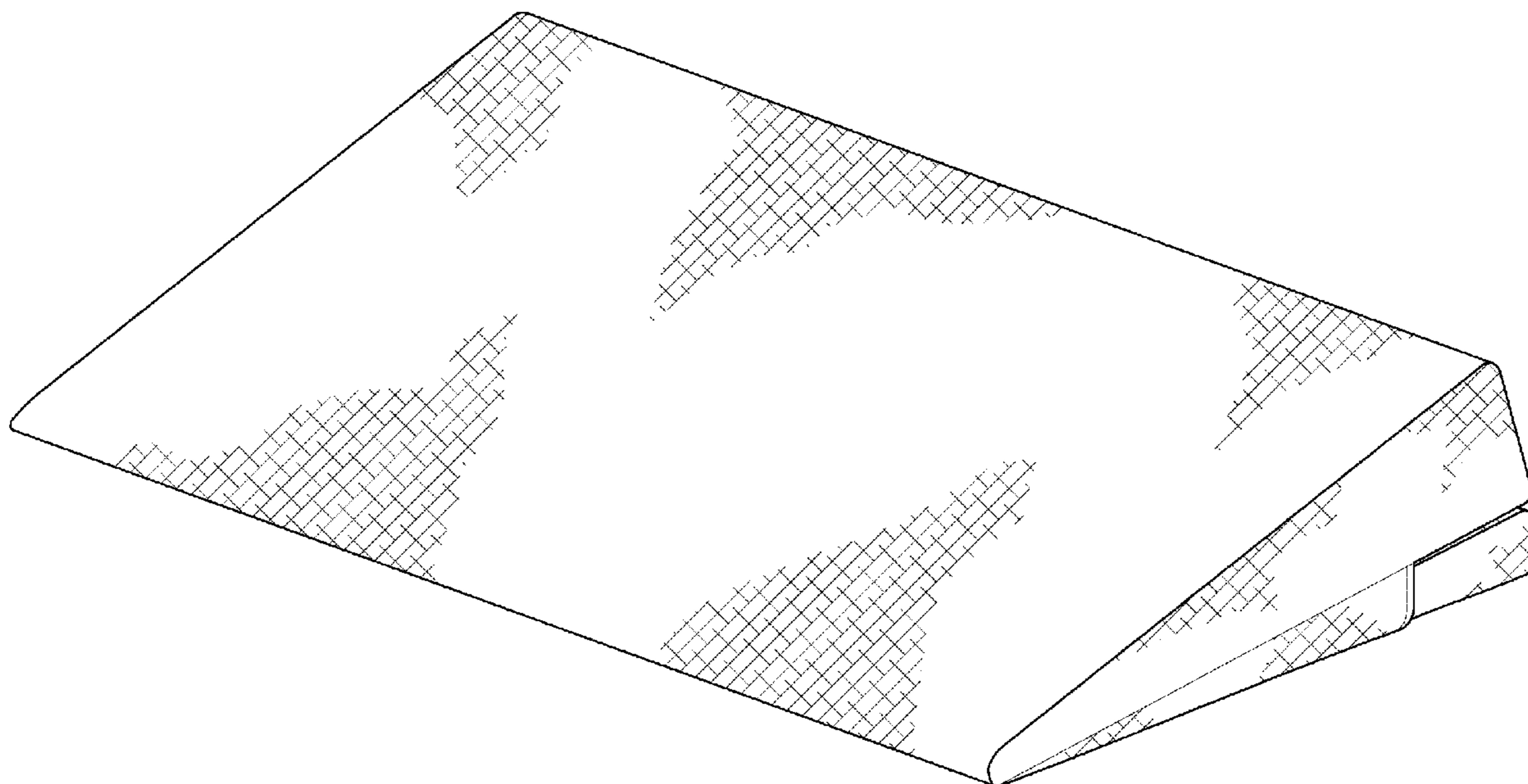
FIG. 8 is a rear perspective view of the upper portion of the crib wedge pillow set, and showing an alternate embodiment of the lower pad;

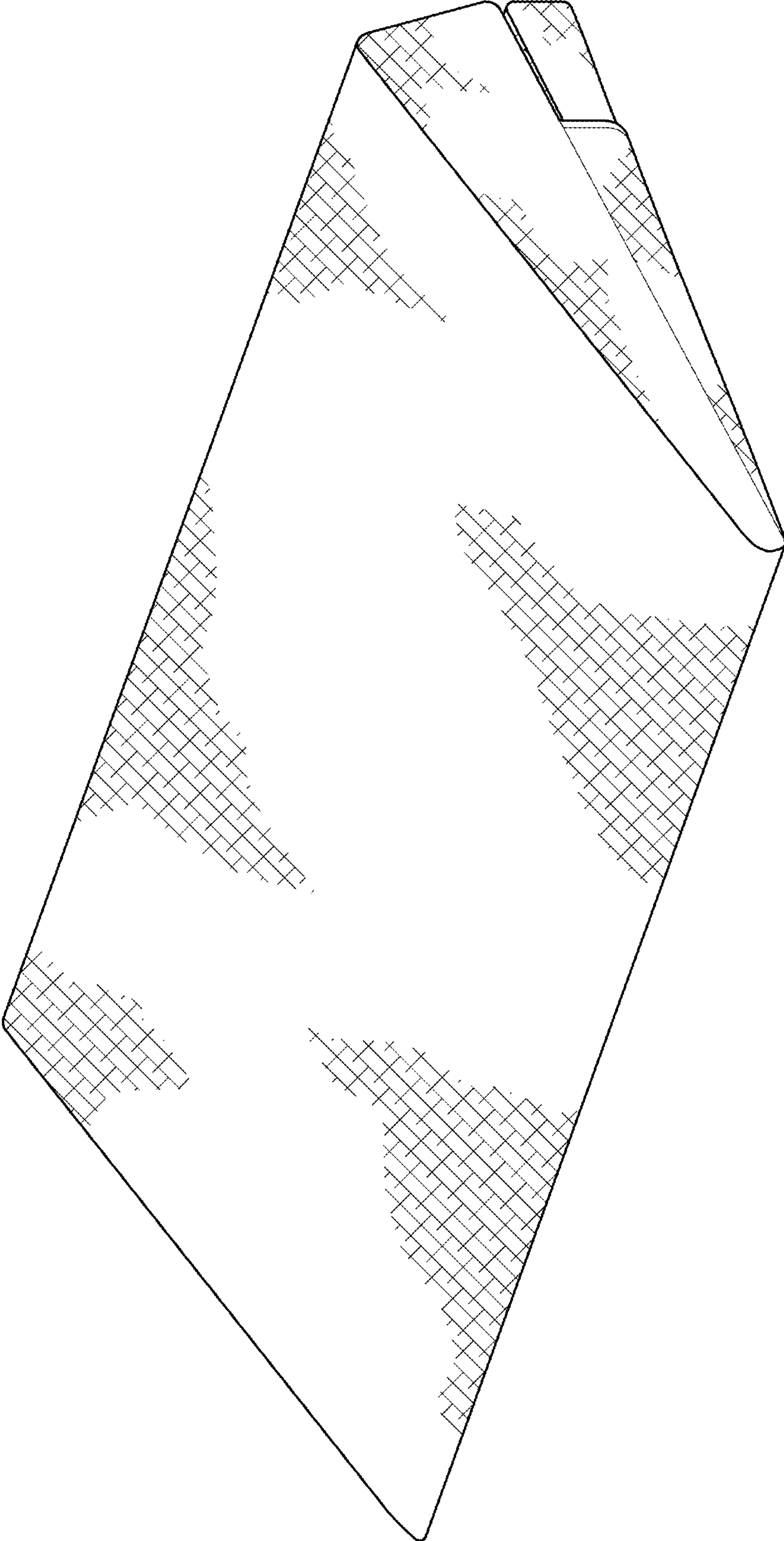

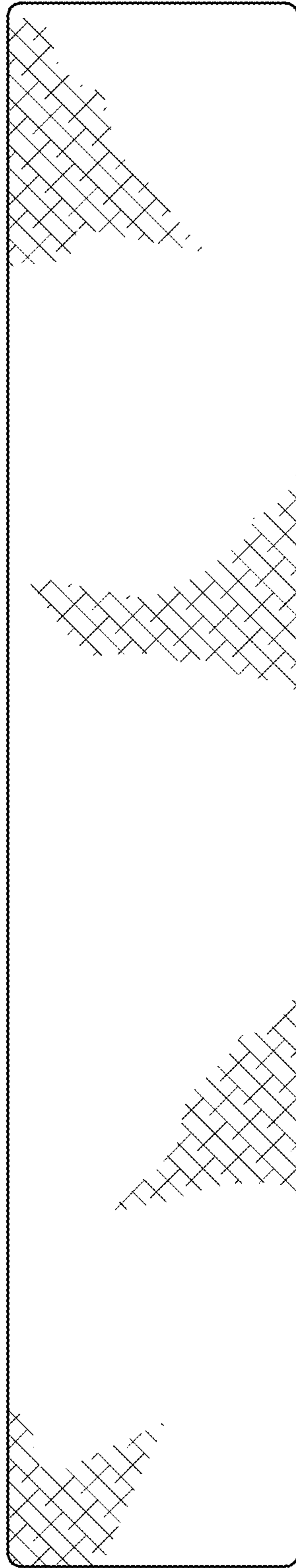

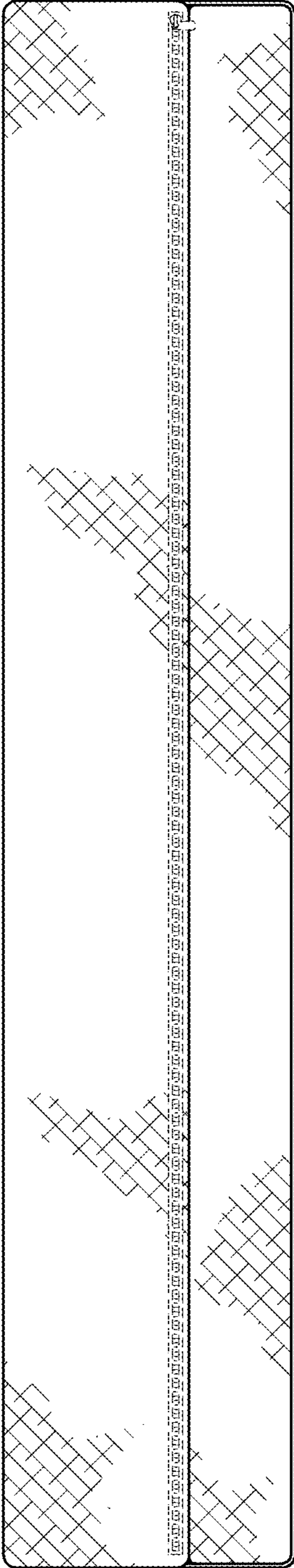

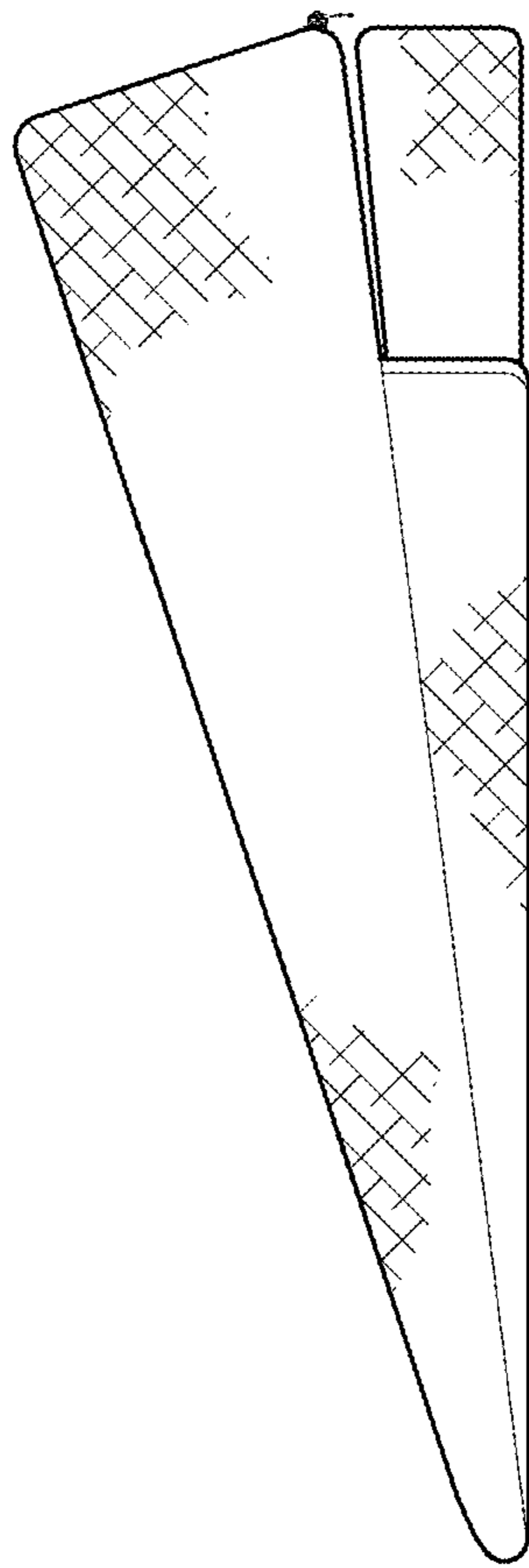

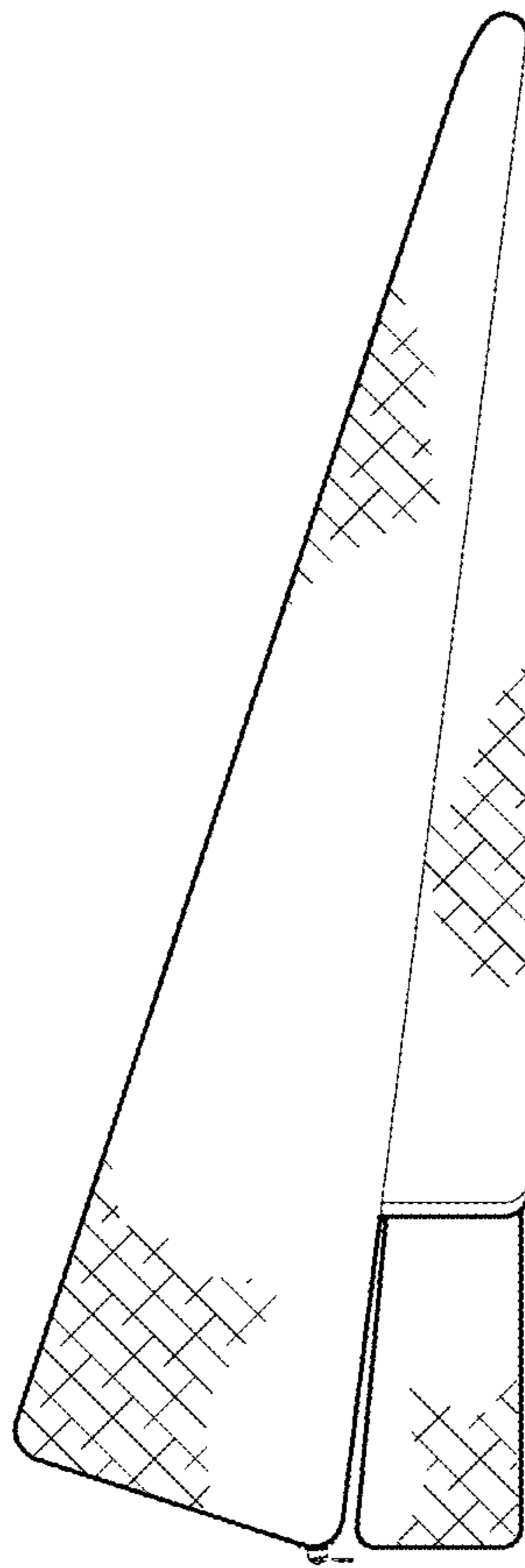

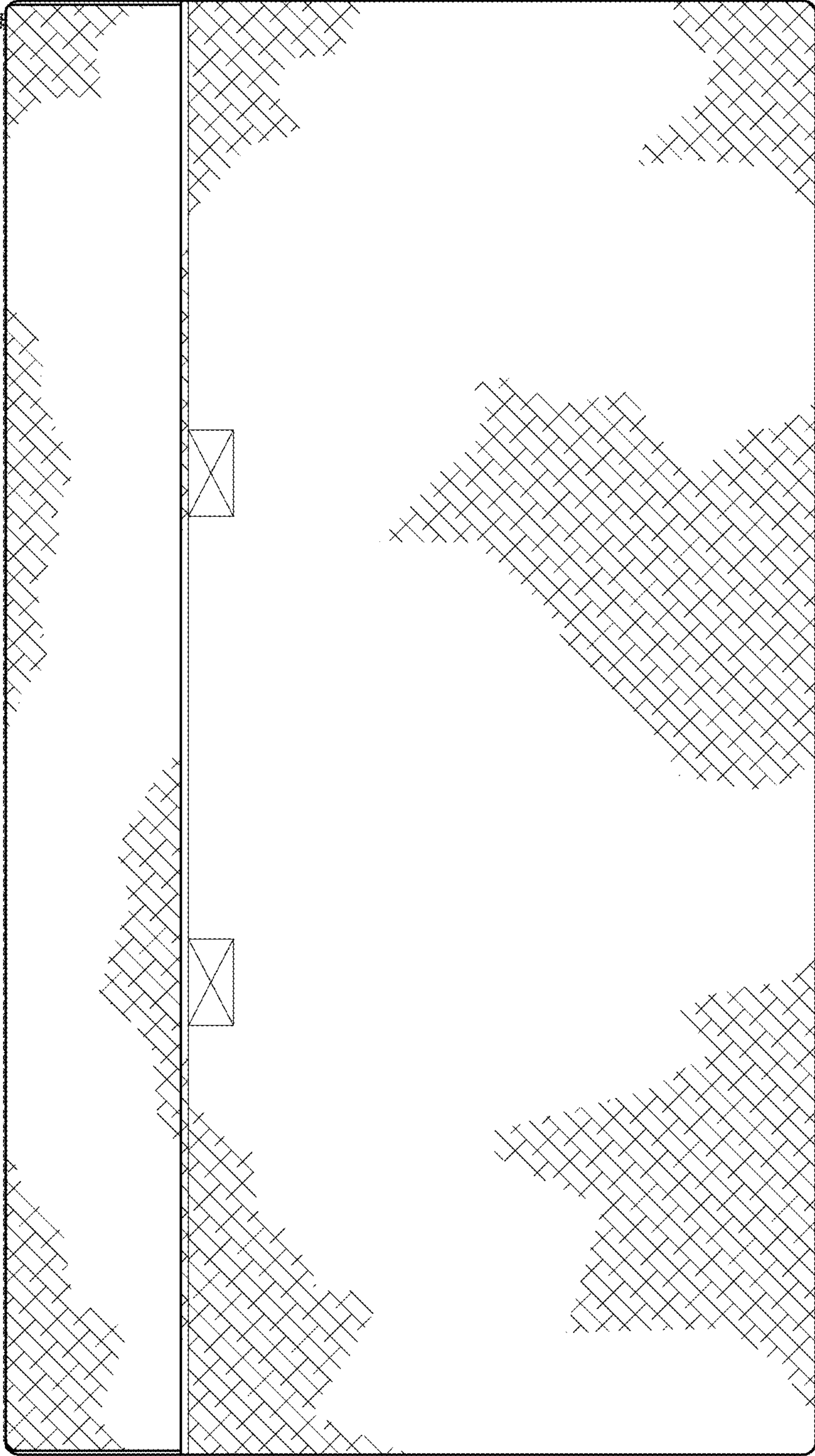

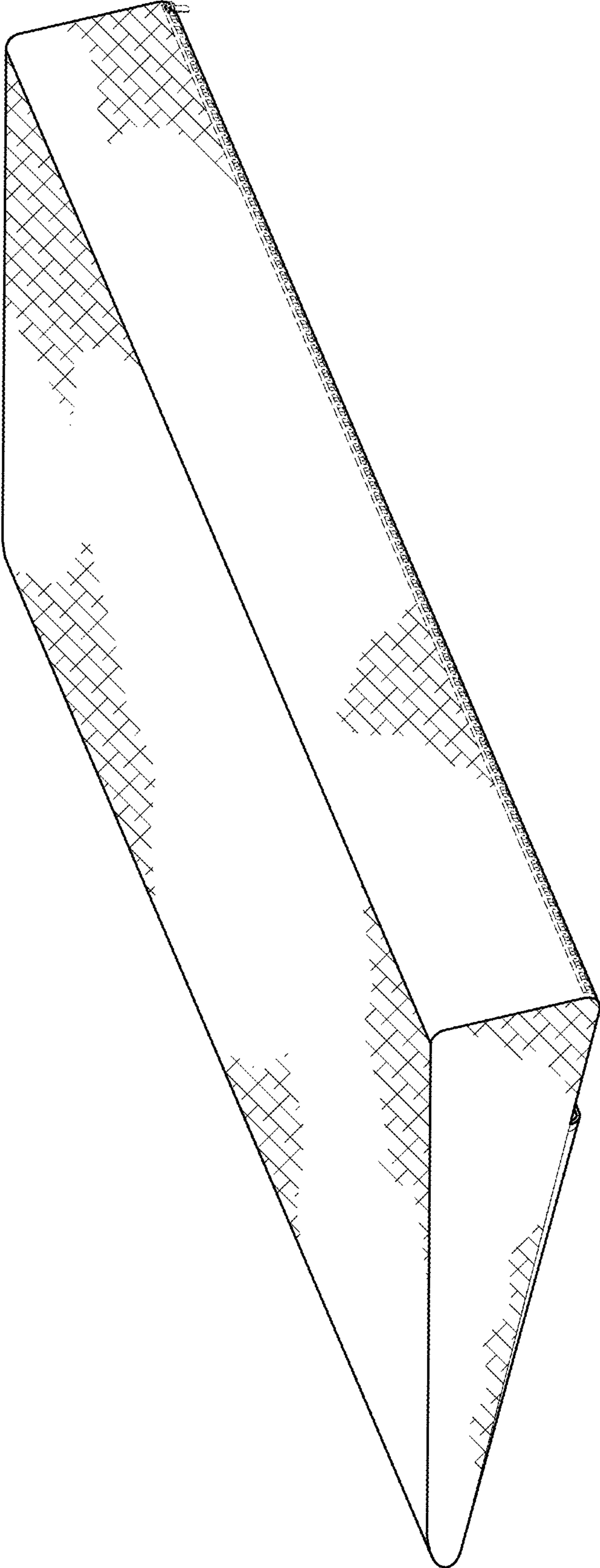

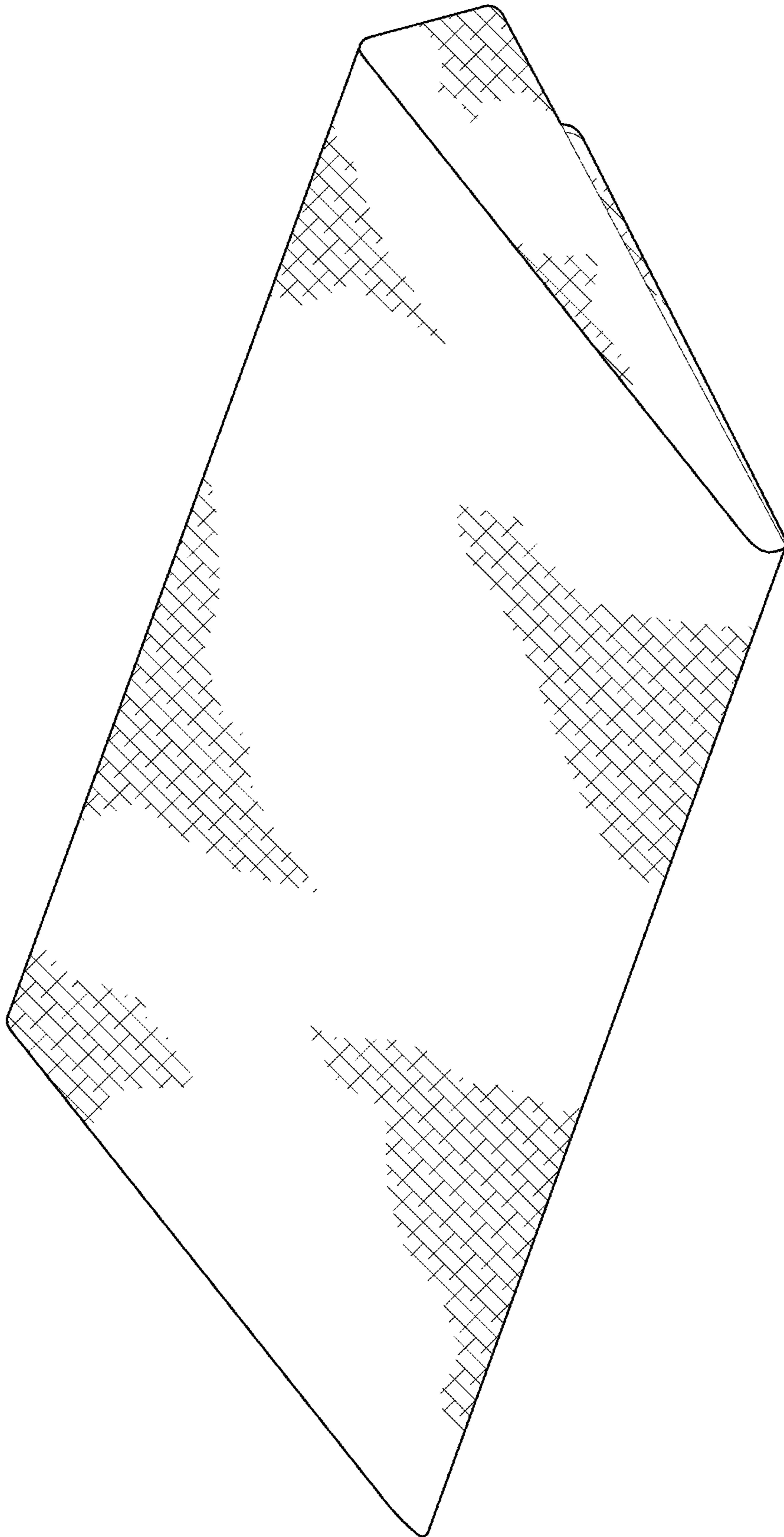

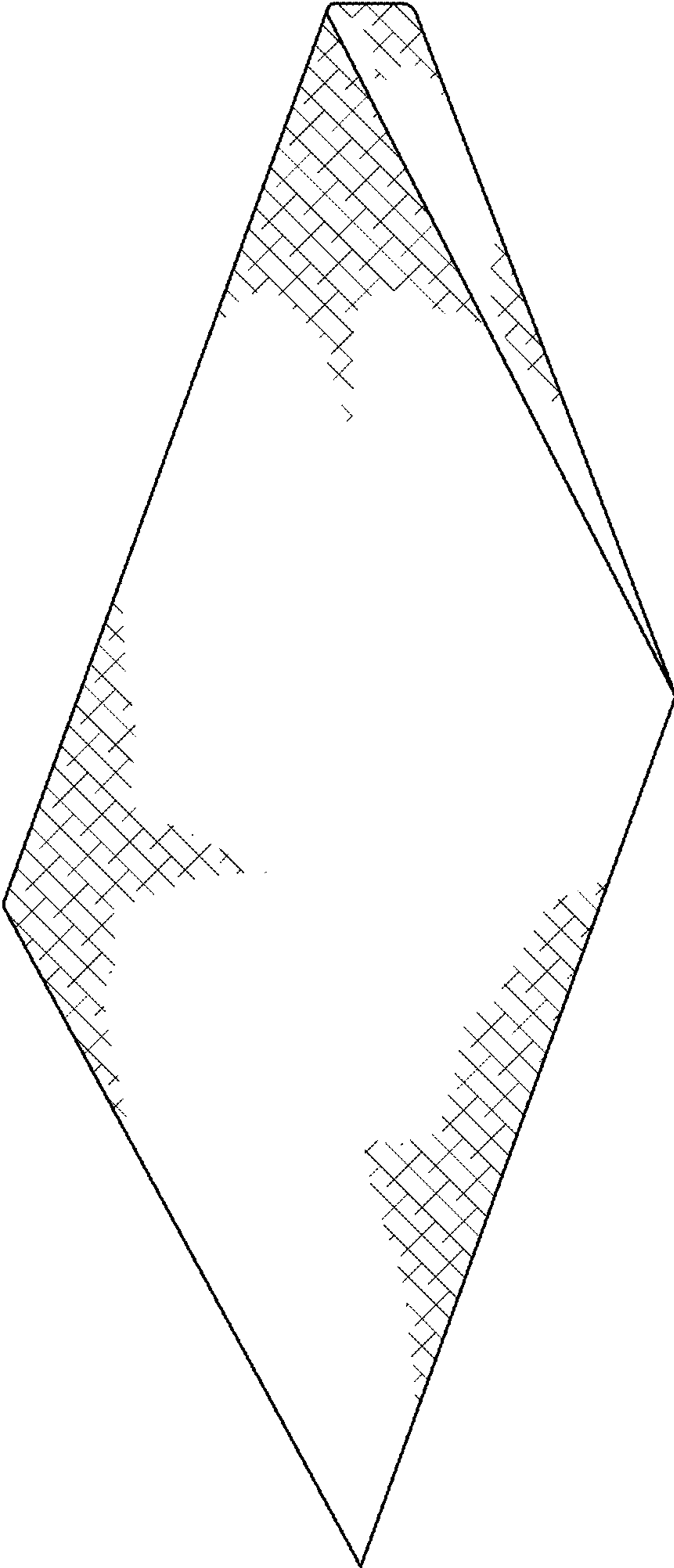
