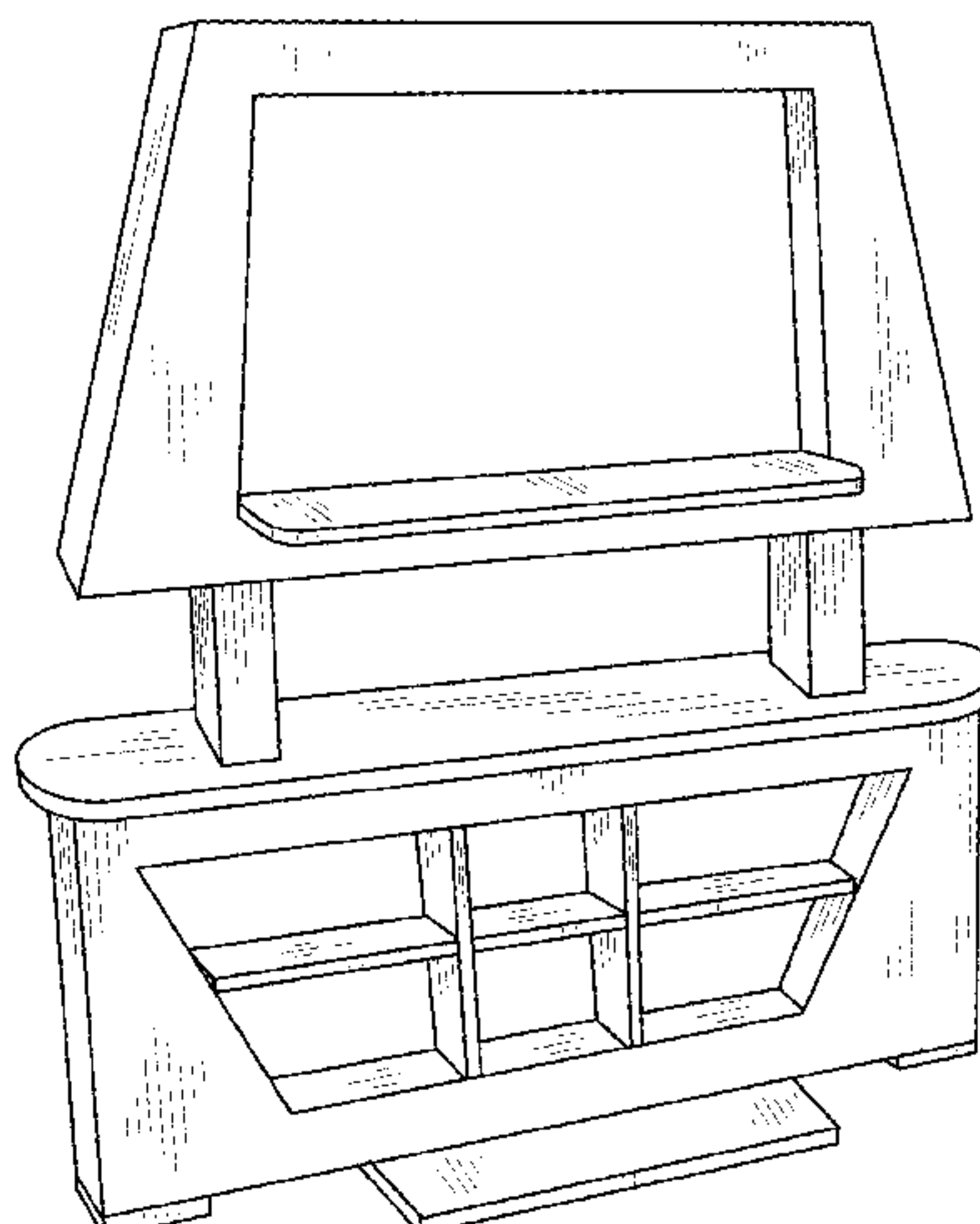


FIG. 27 is a top view of a fourth aspect of an entertainment shelf unit showing a new design; and,

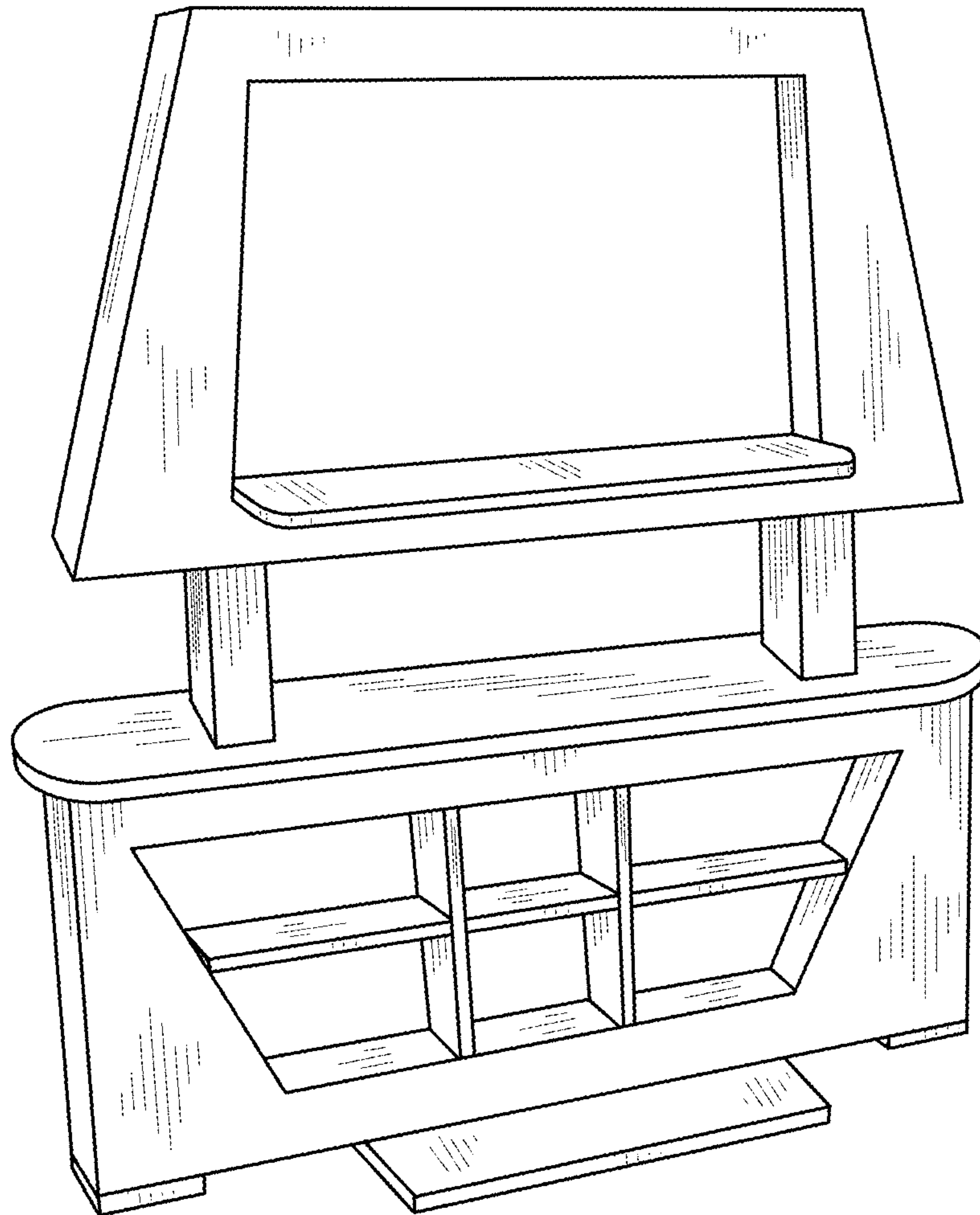

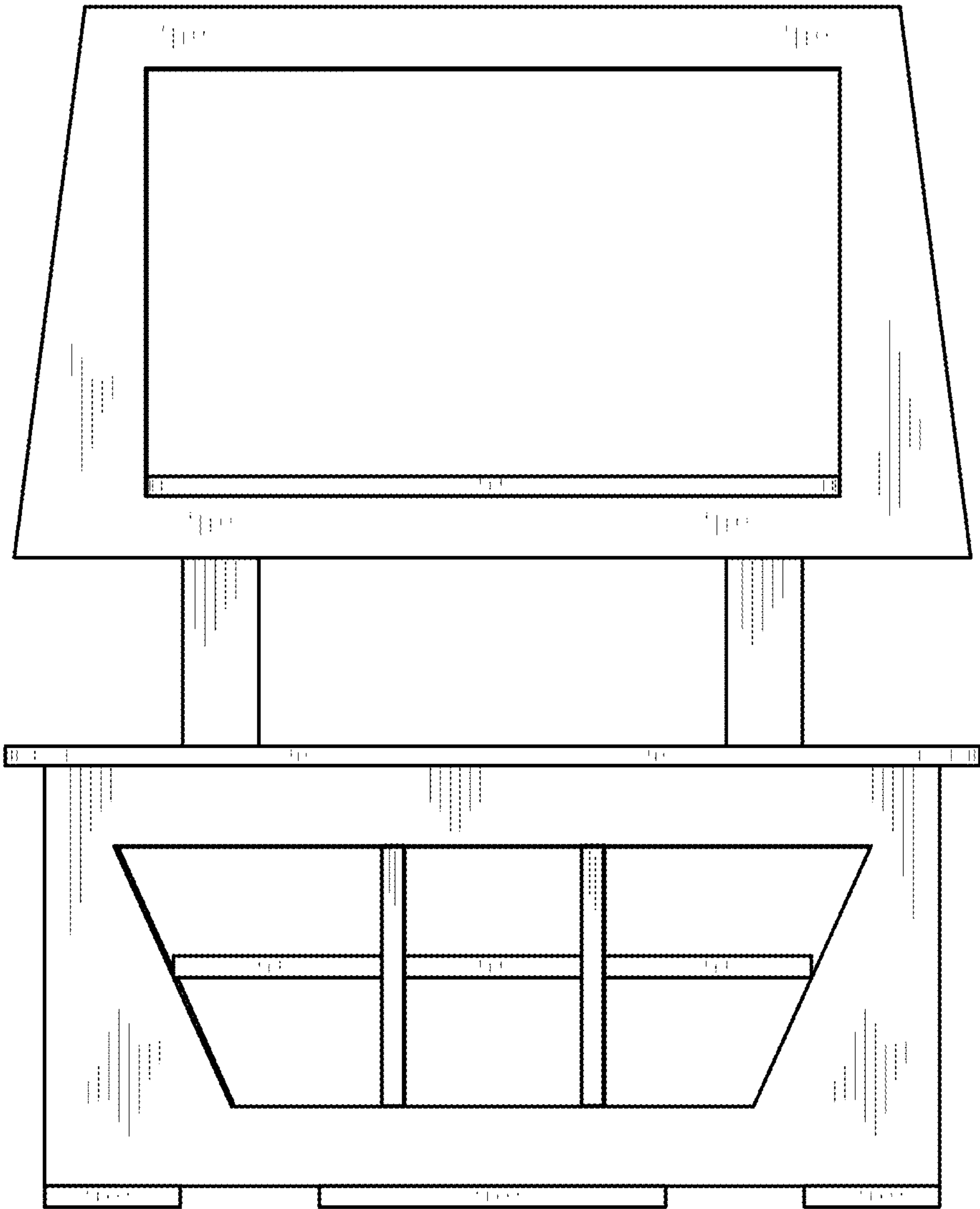

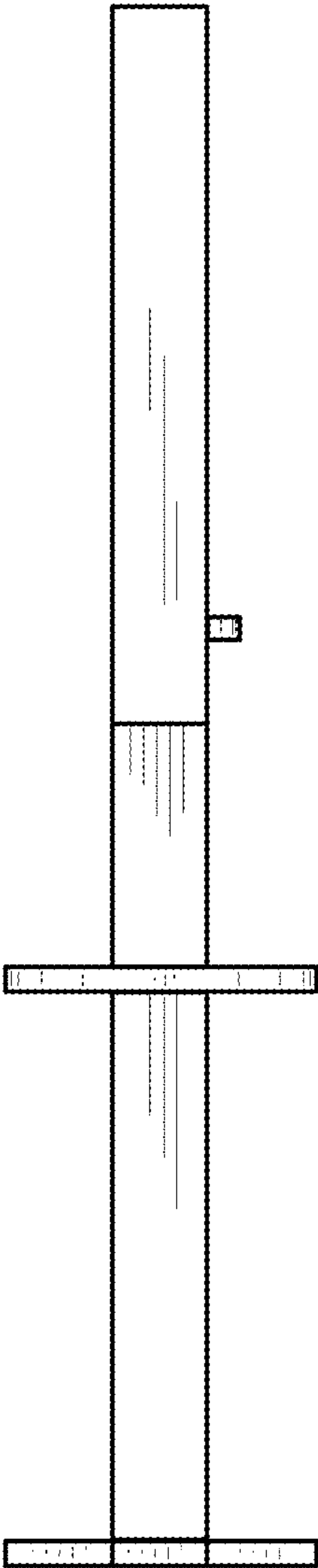

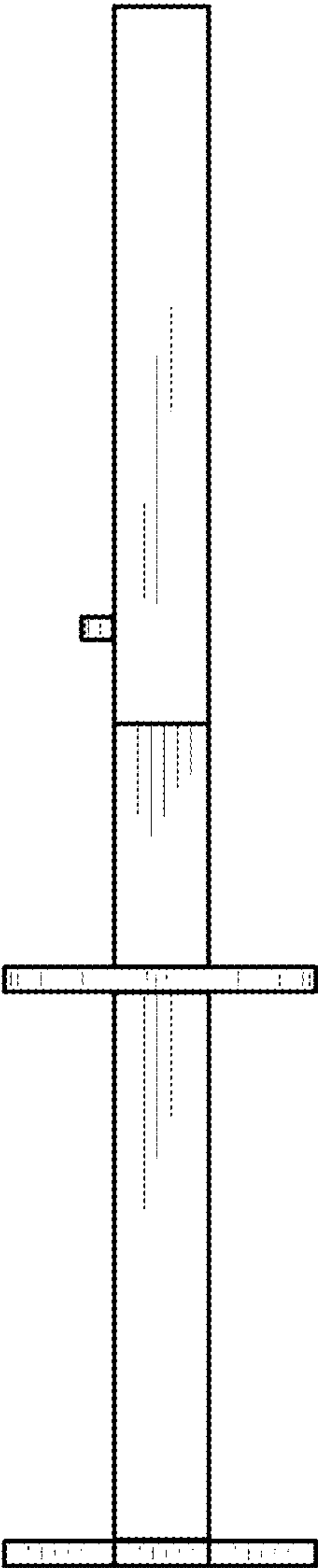

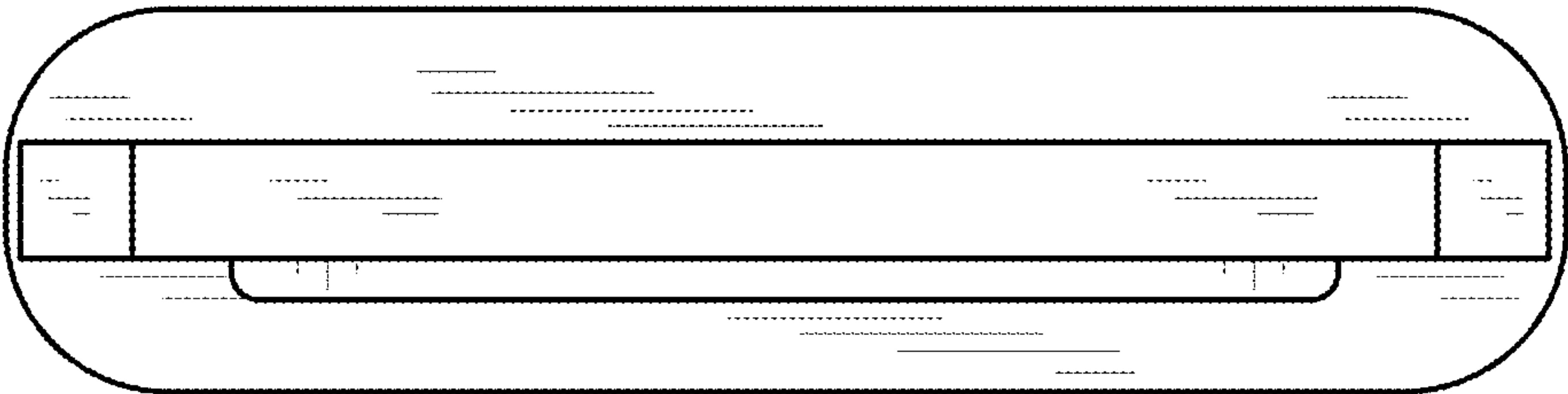

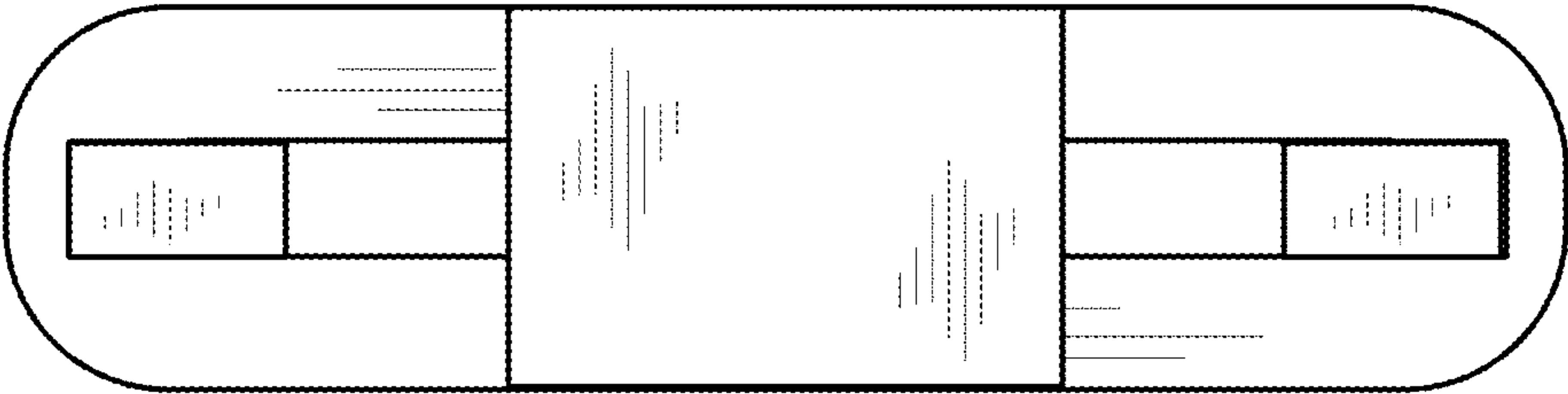

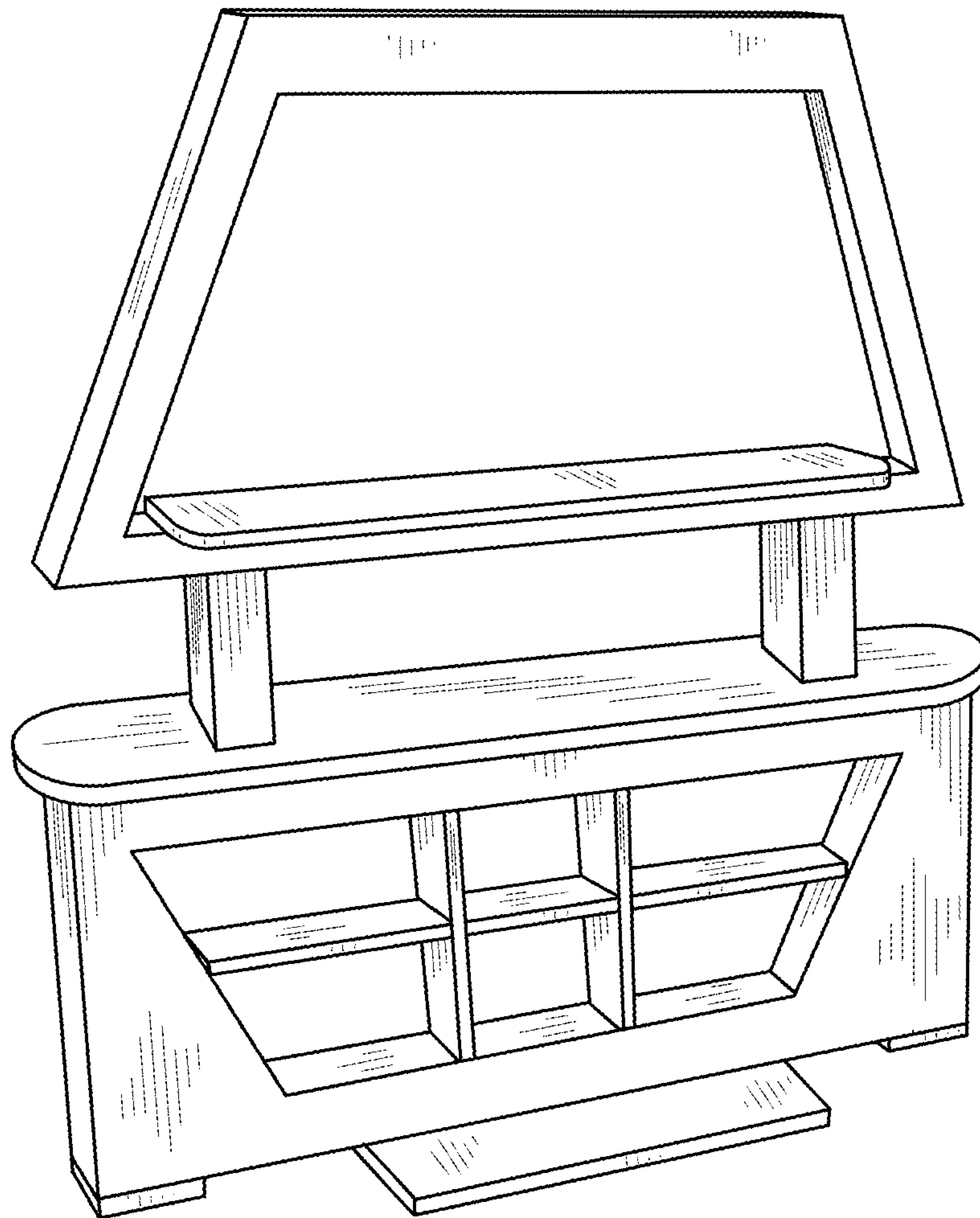

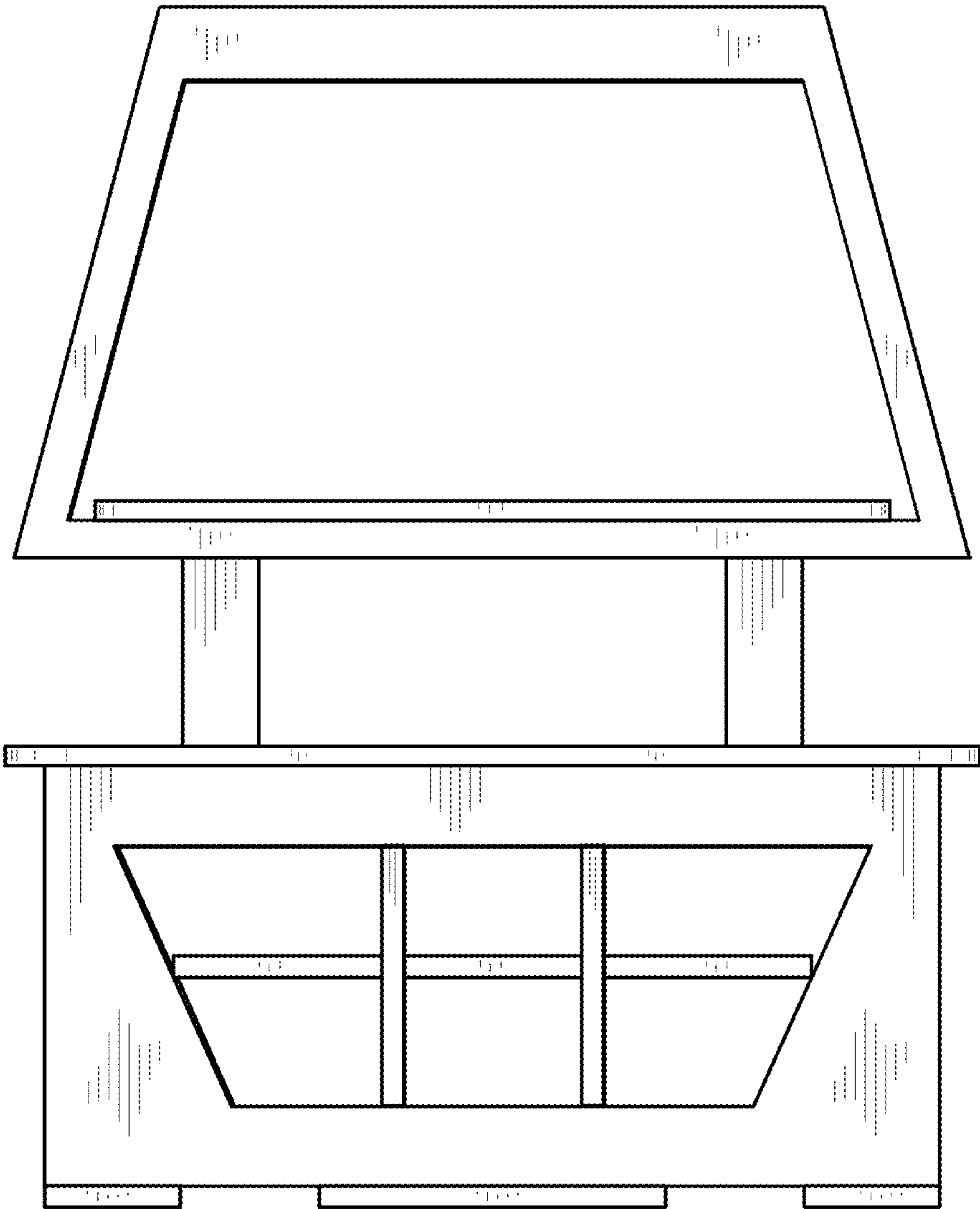

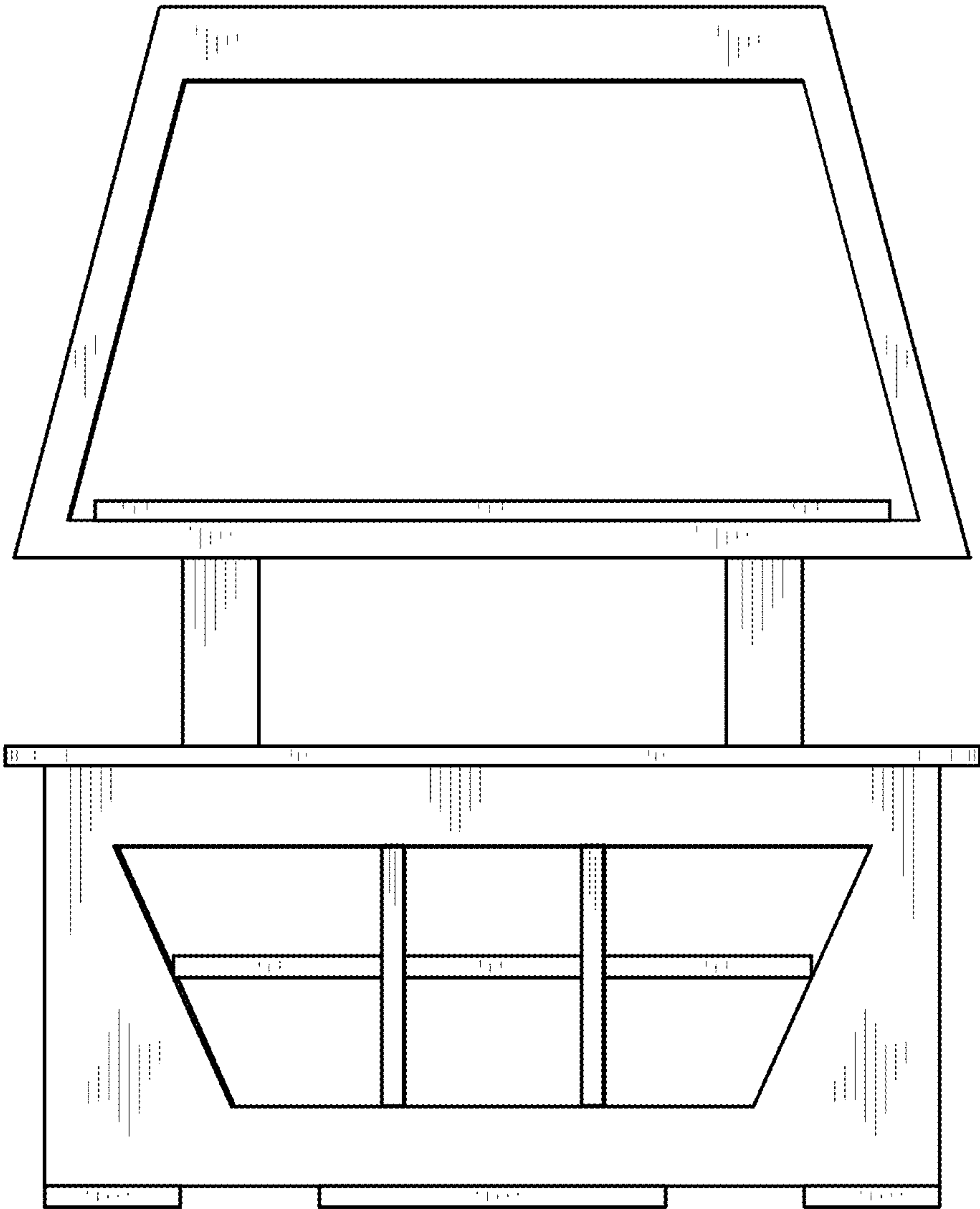

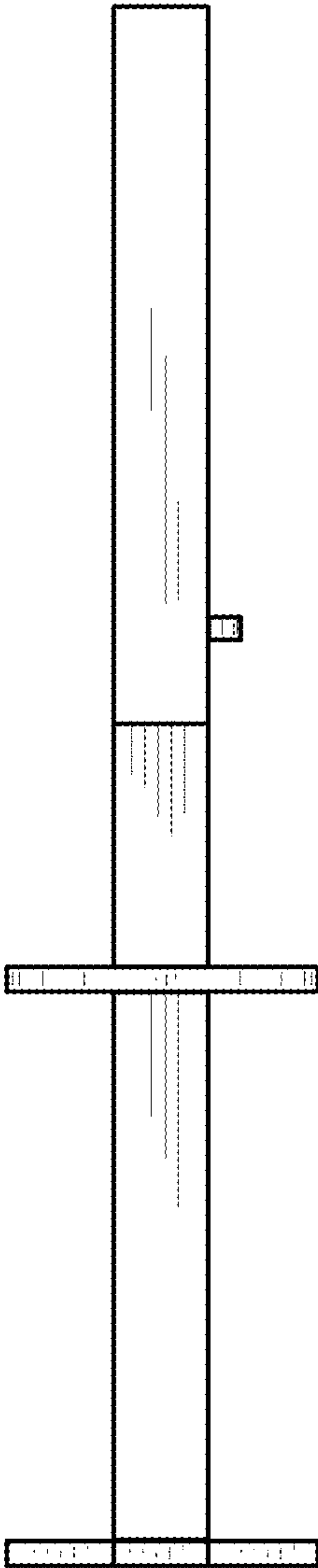

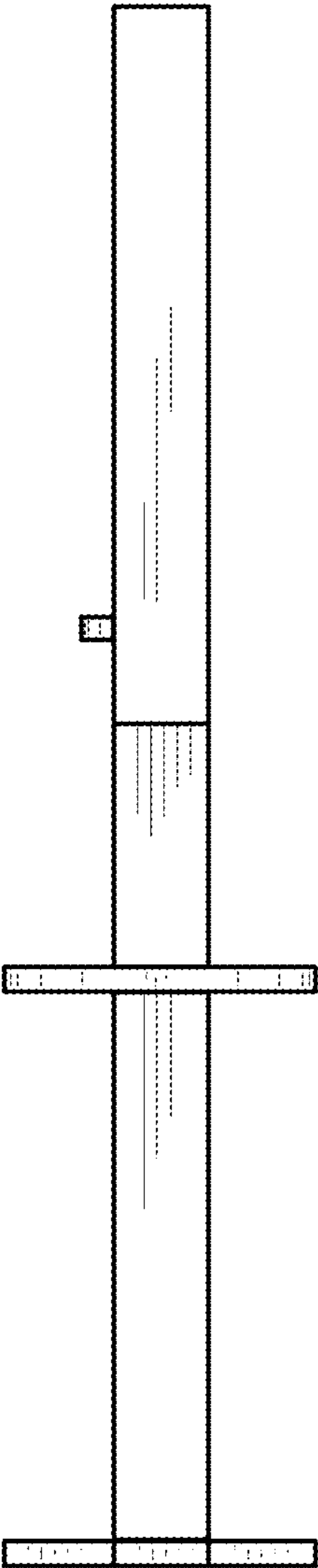

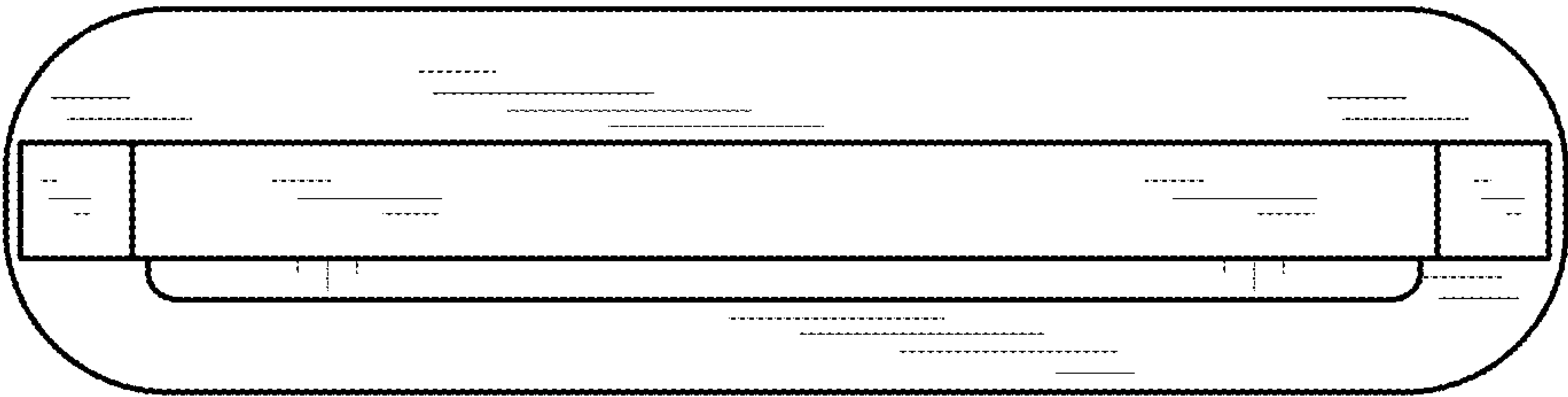

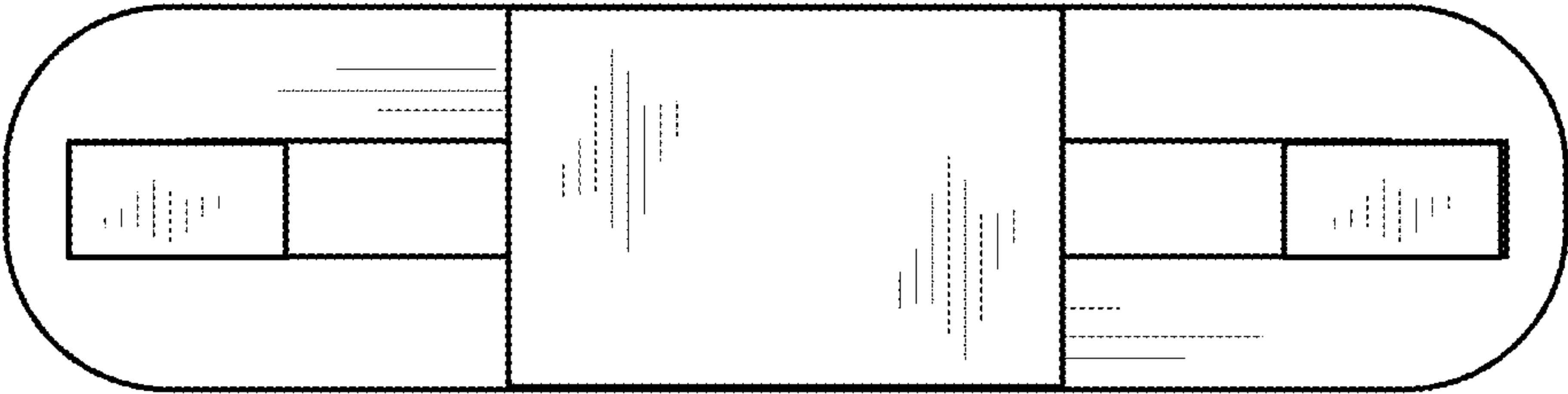

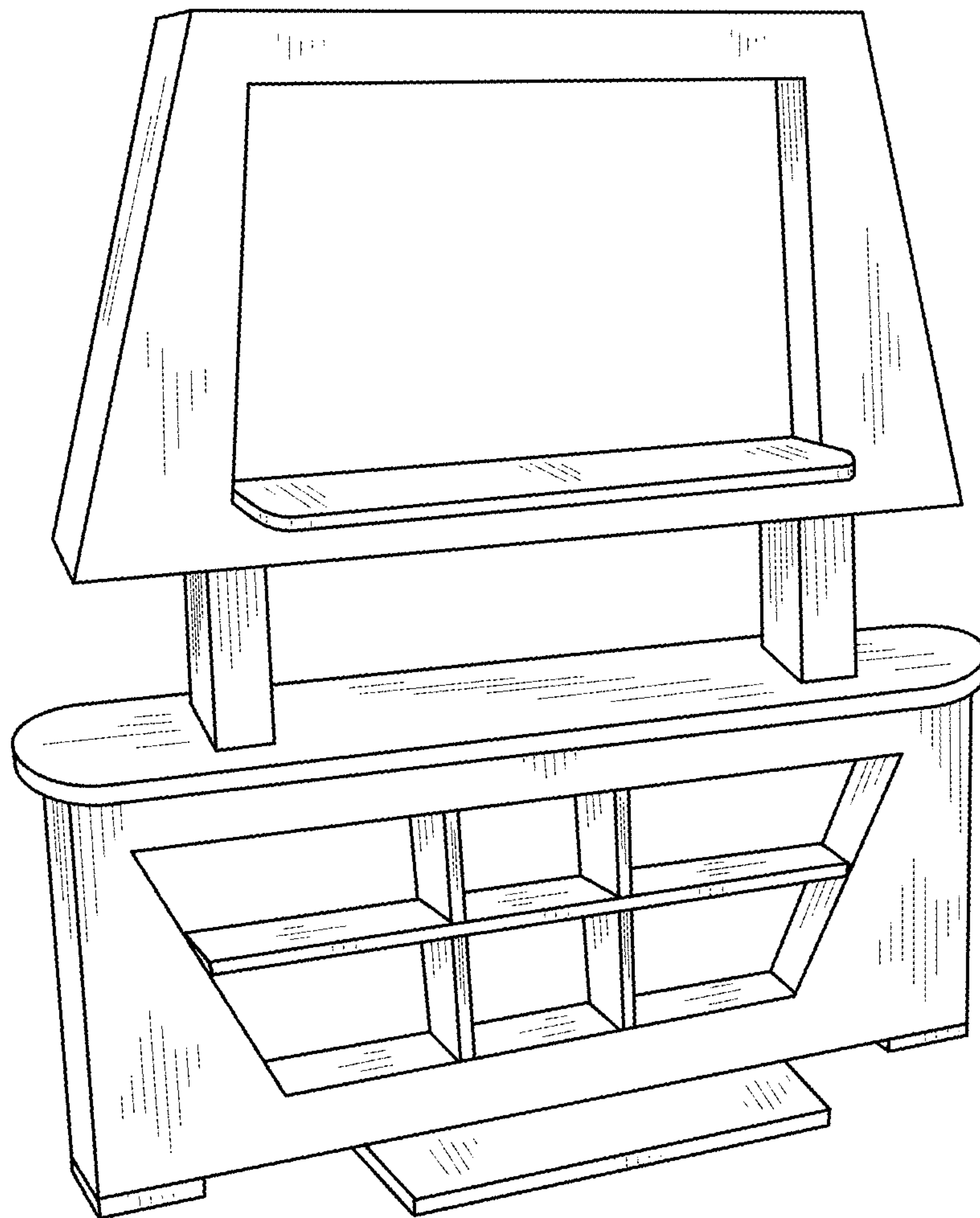

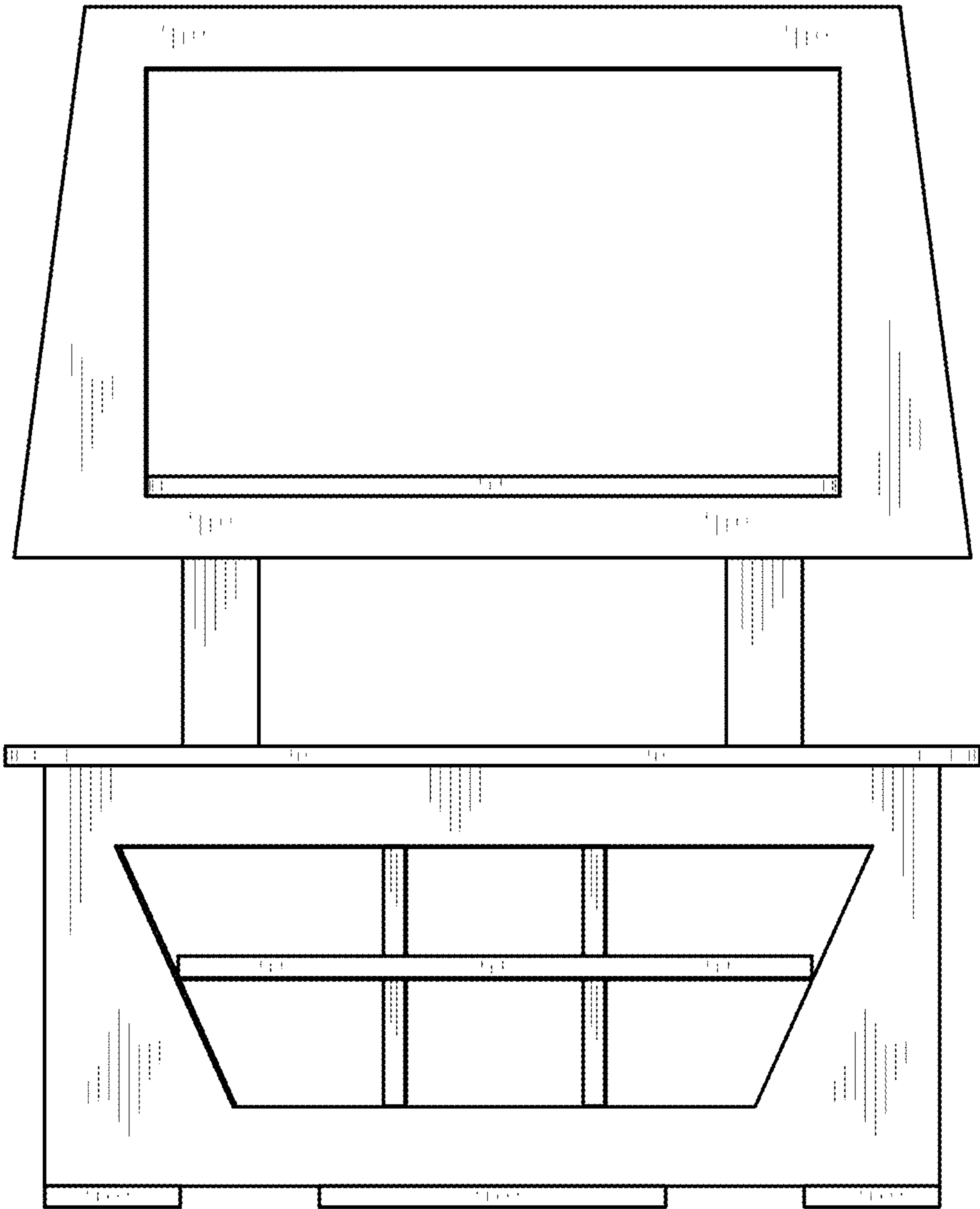

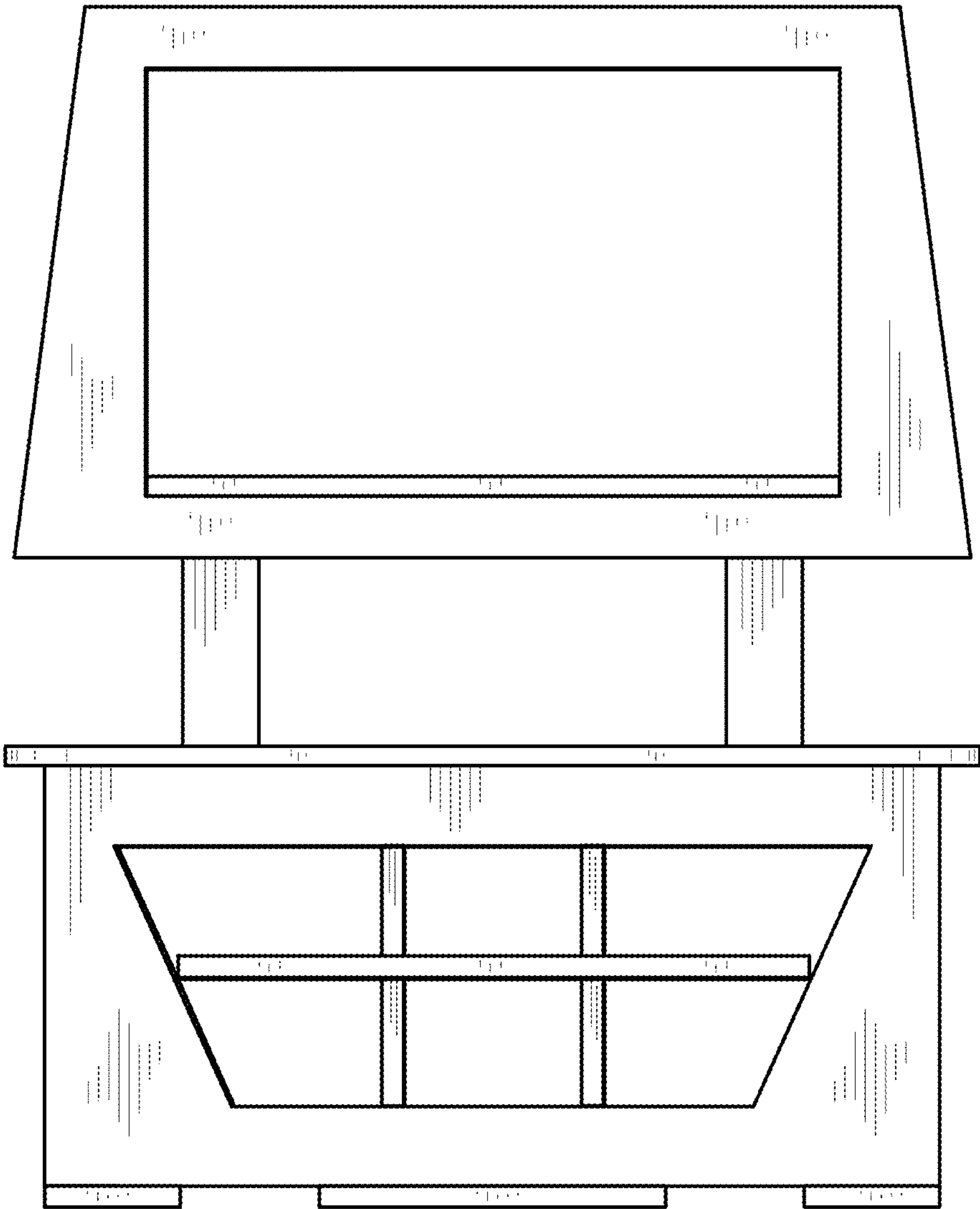

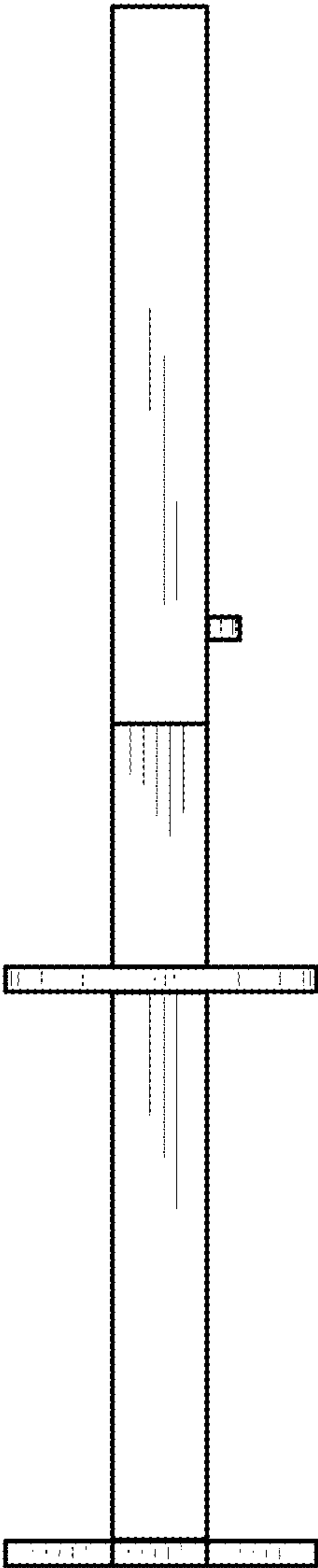

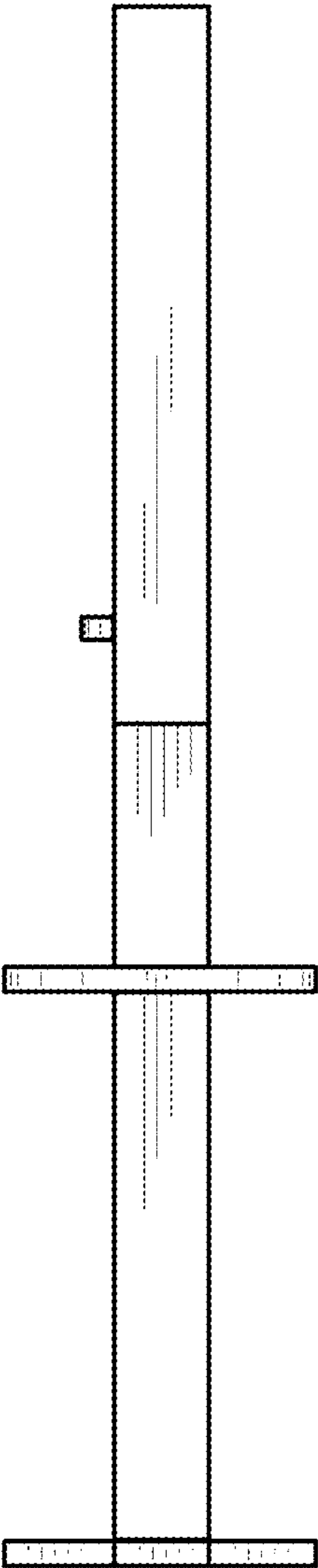

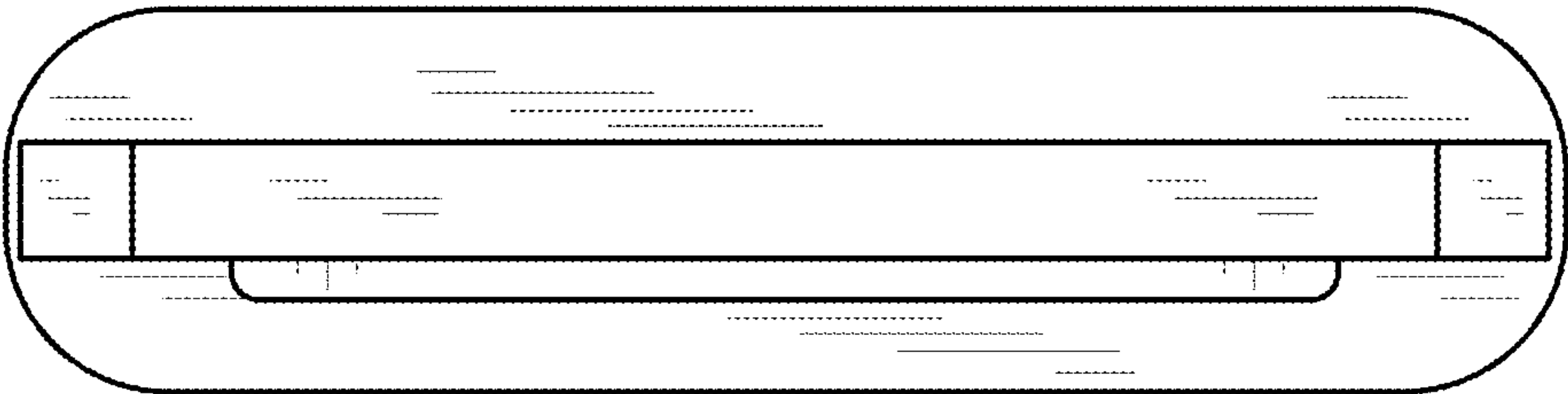

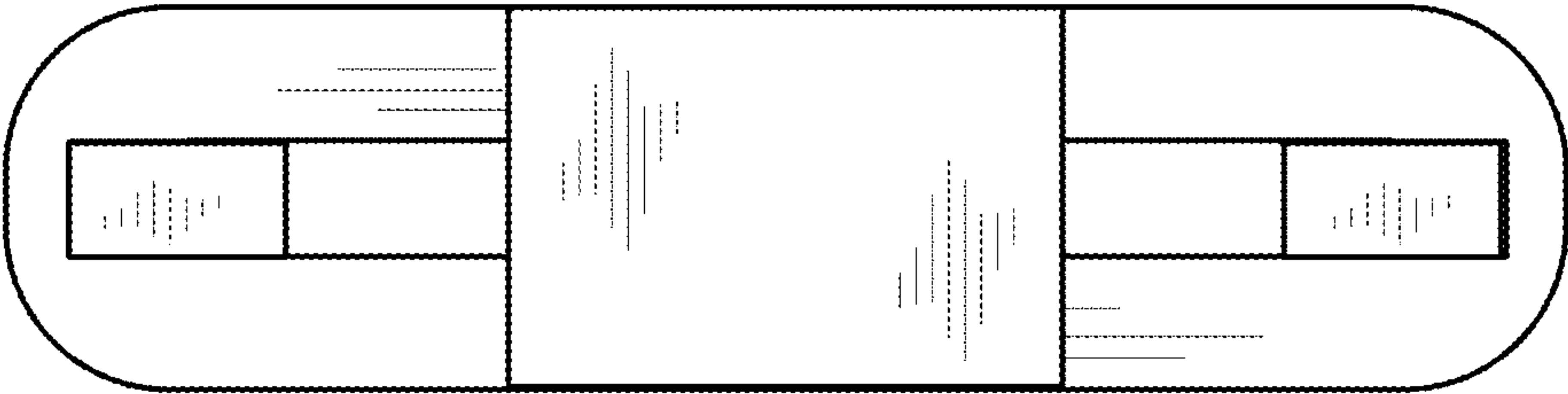

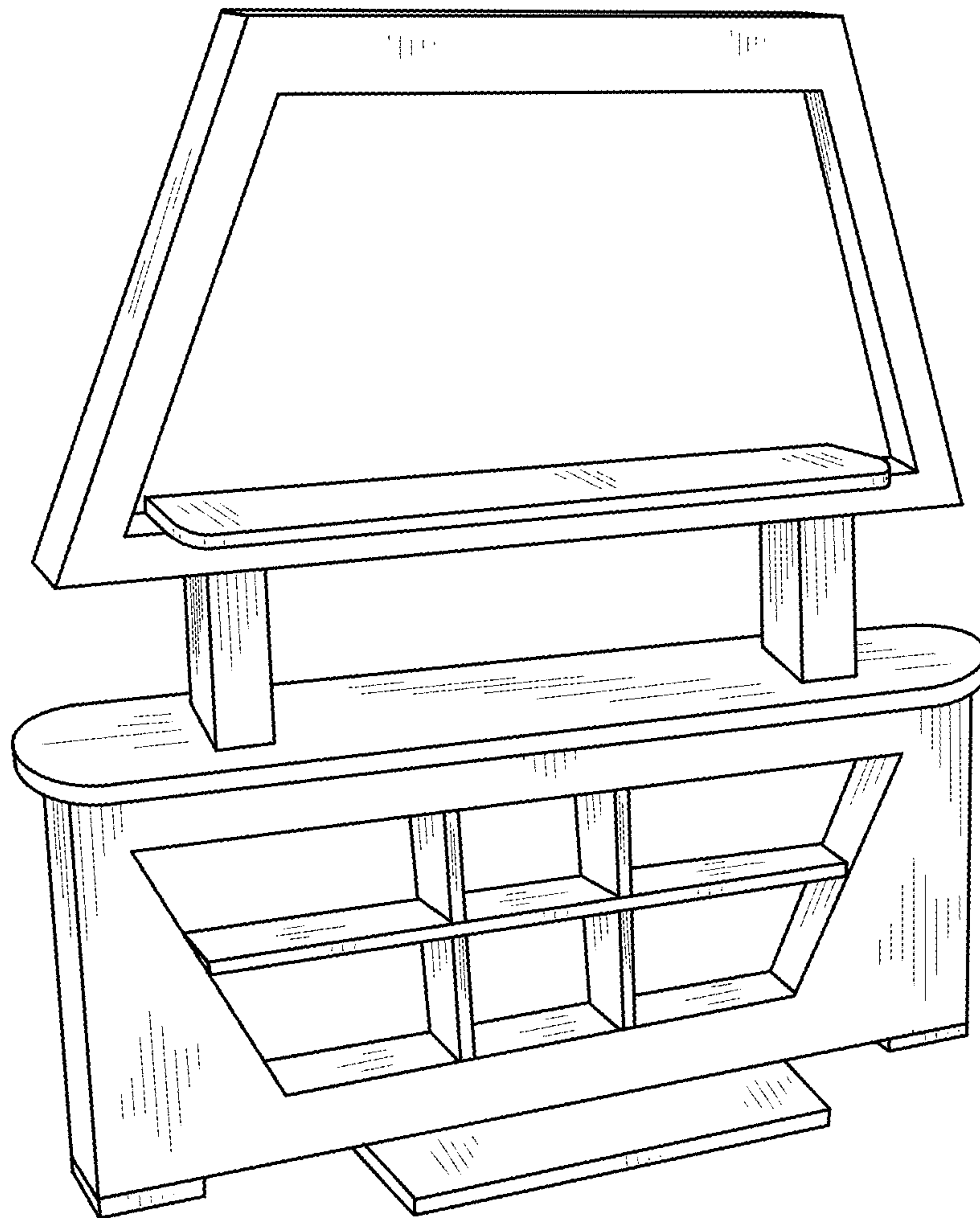

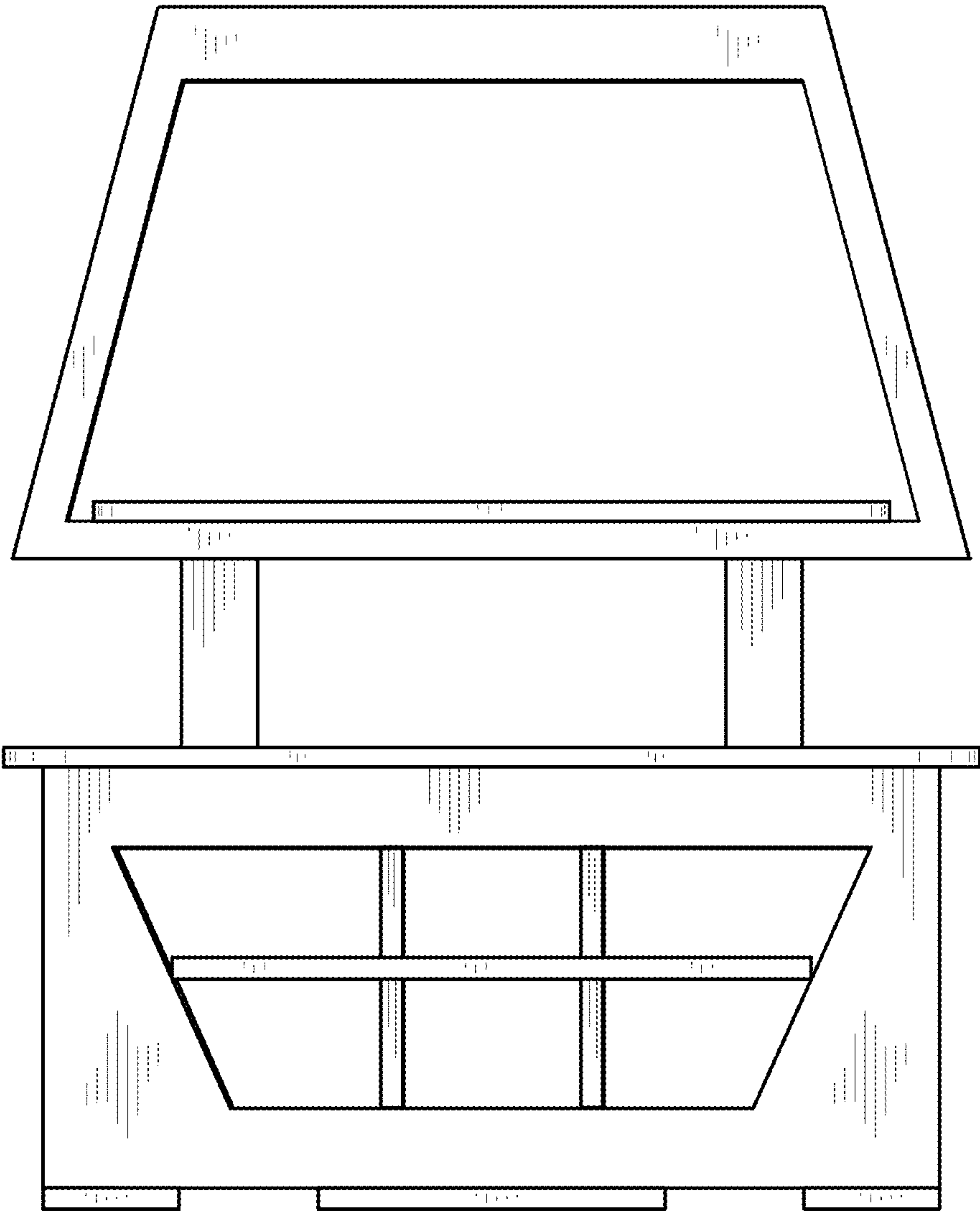

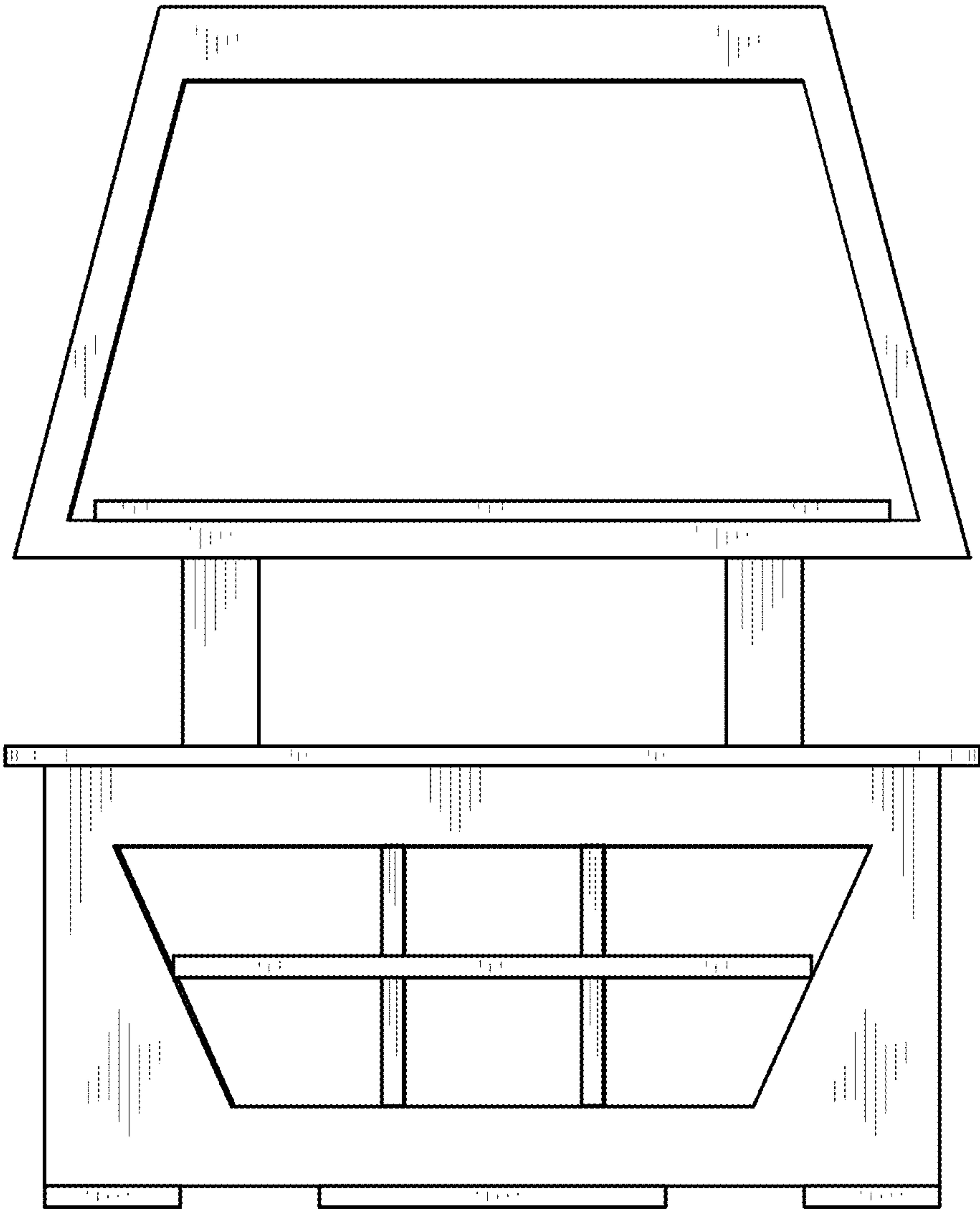

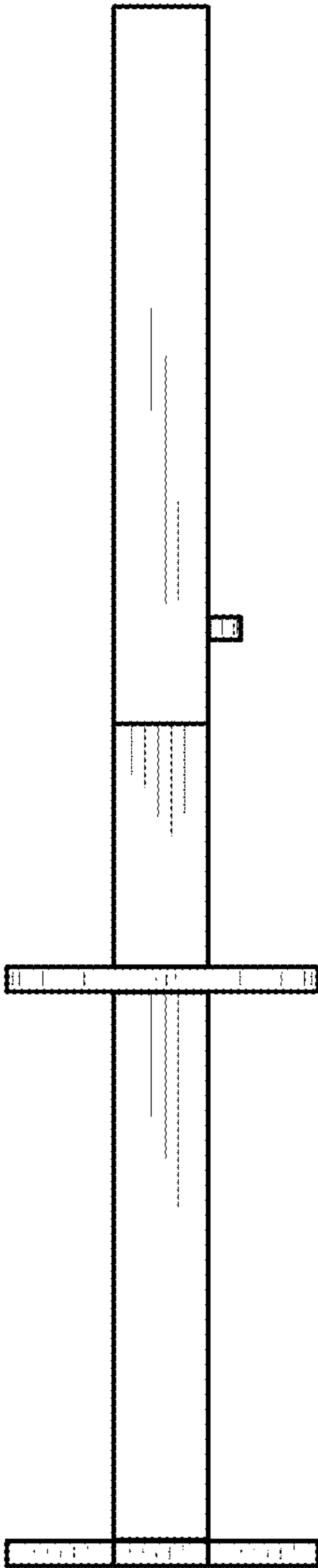

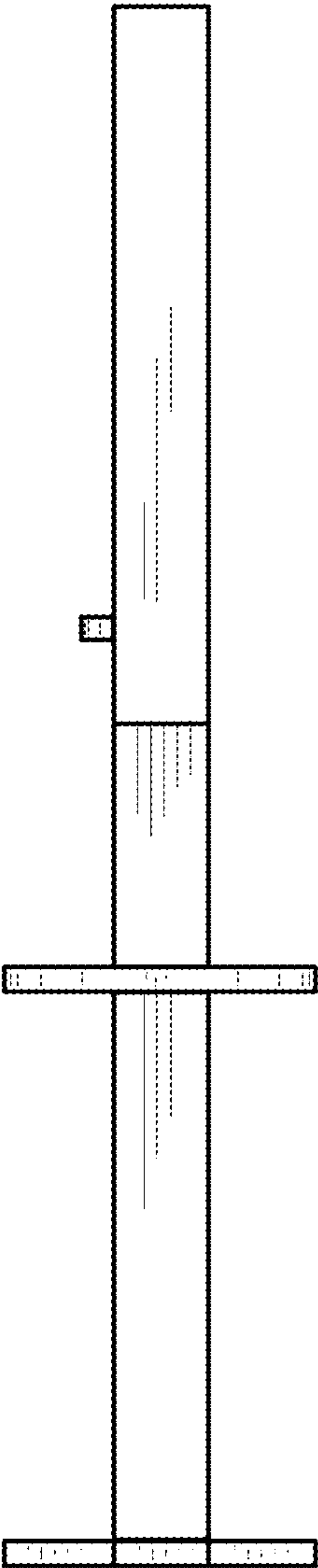

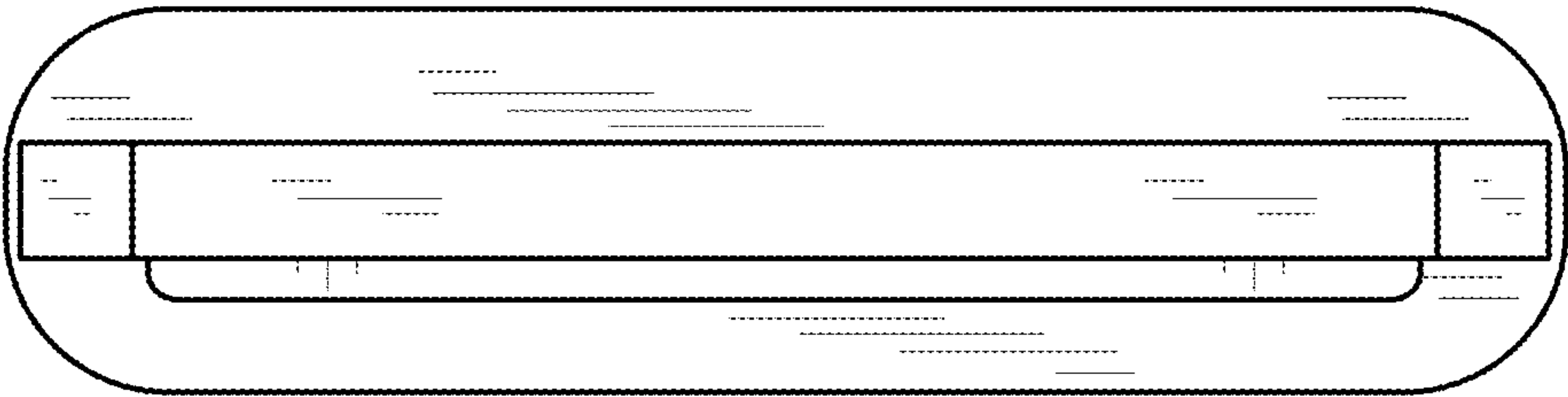

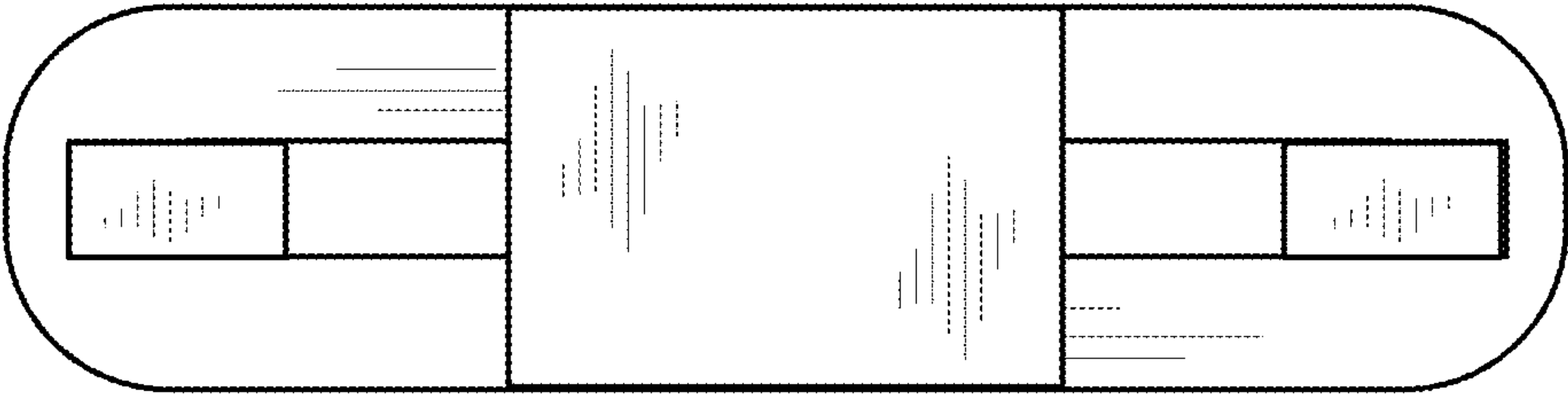
