DESCRIPTION

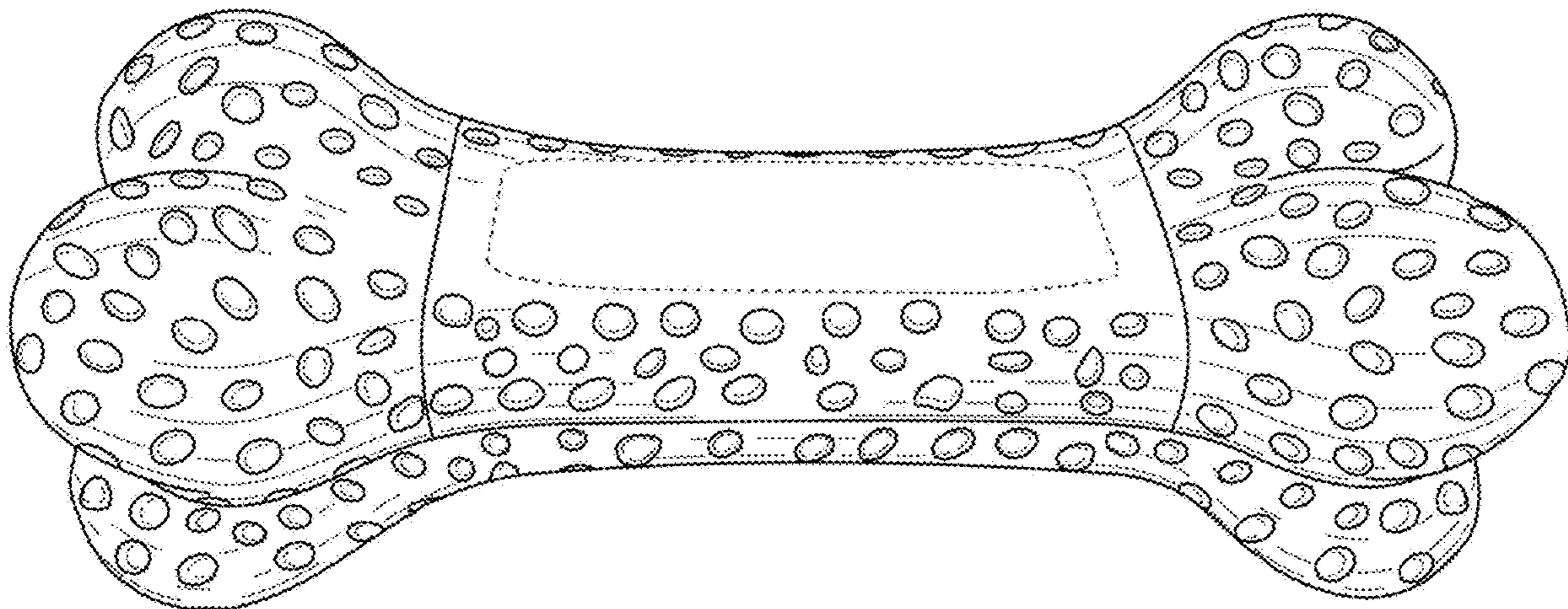
FIG. 1 is a perspective view of a container, showing our new design;

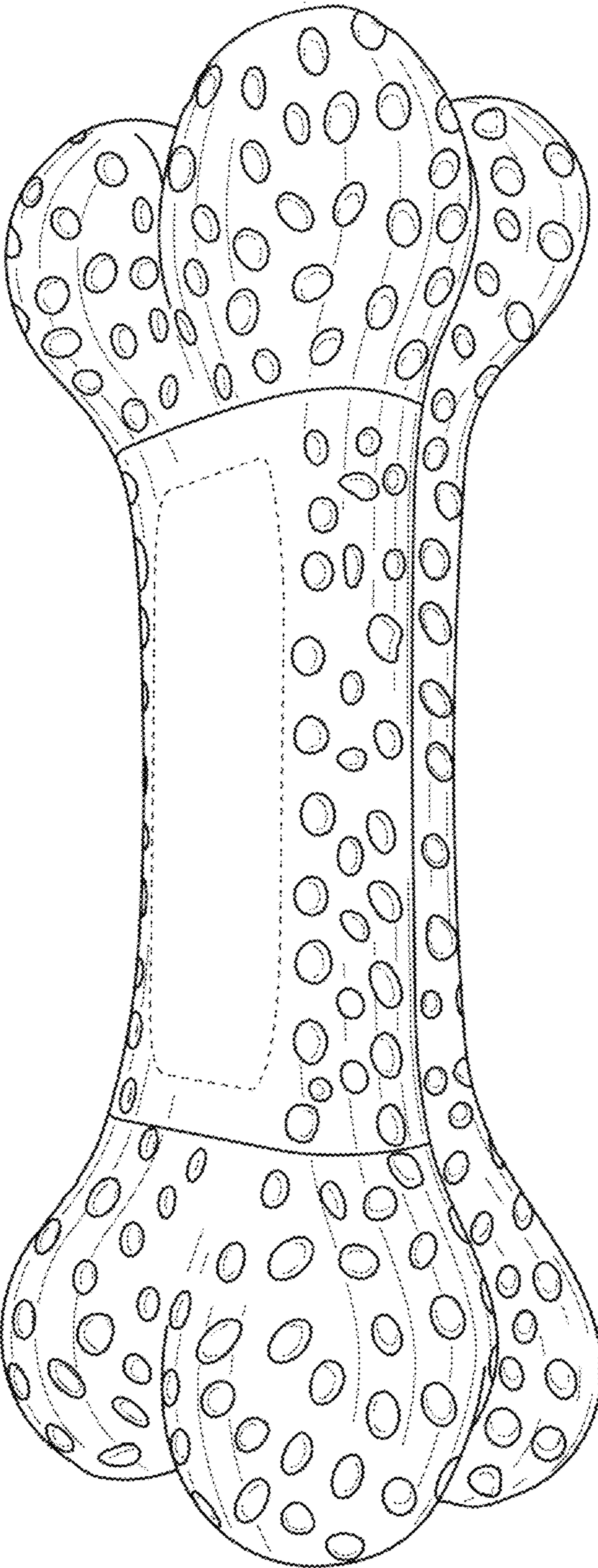

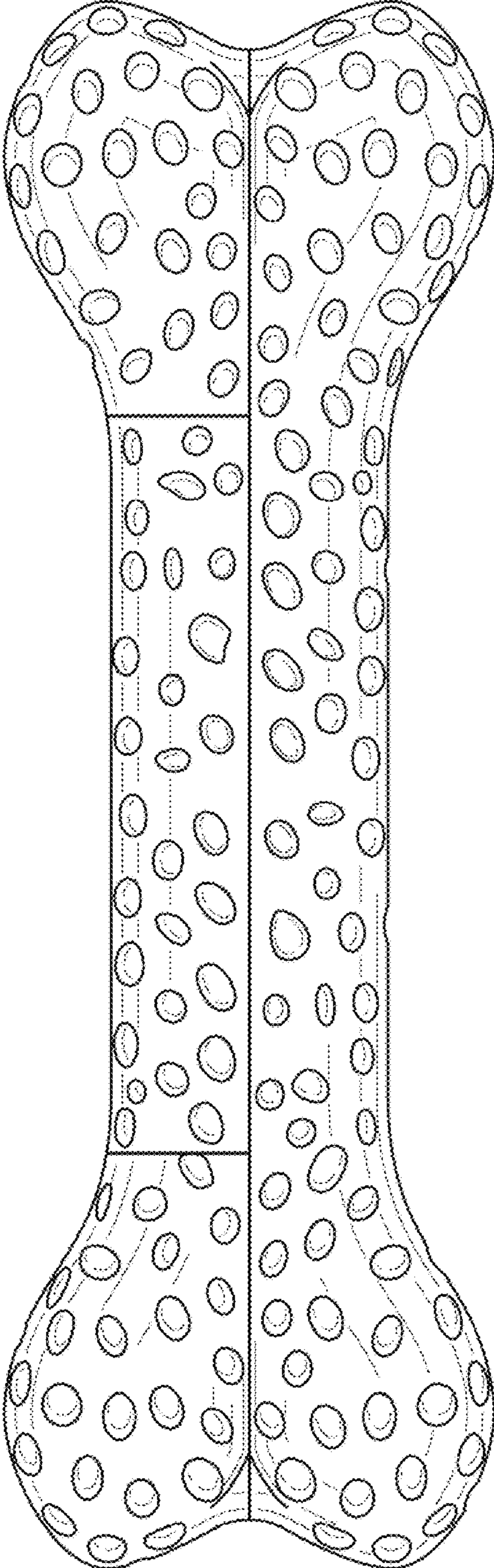

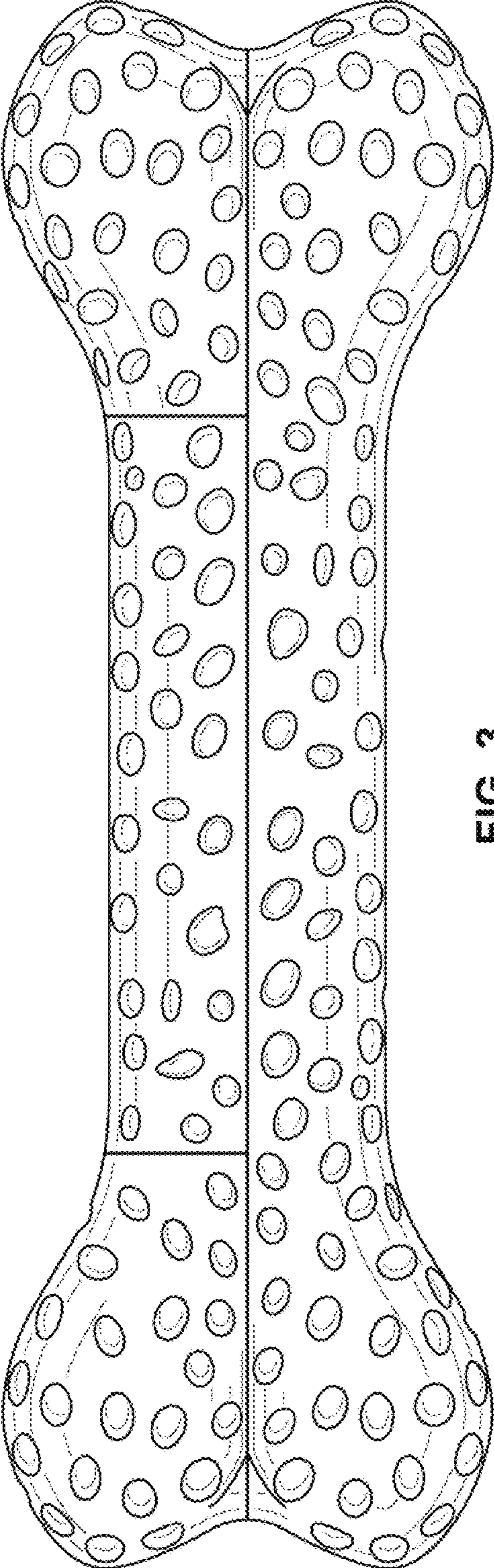

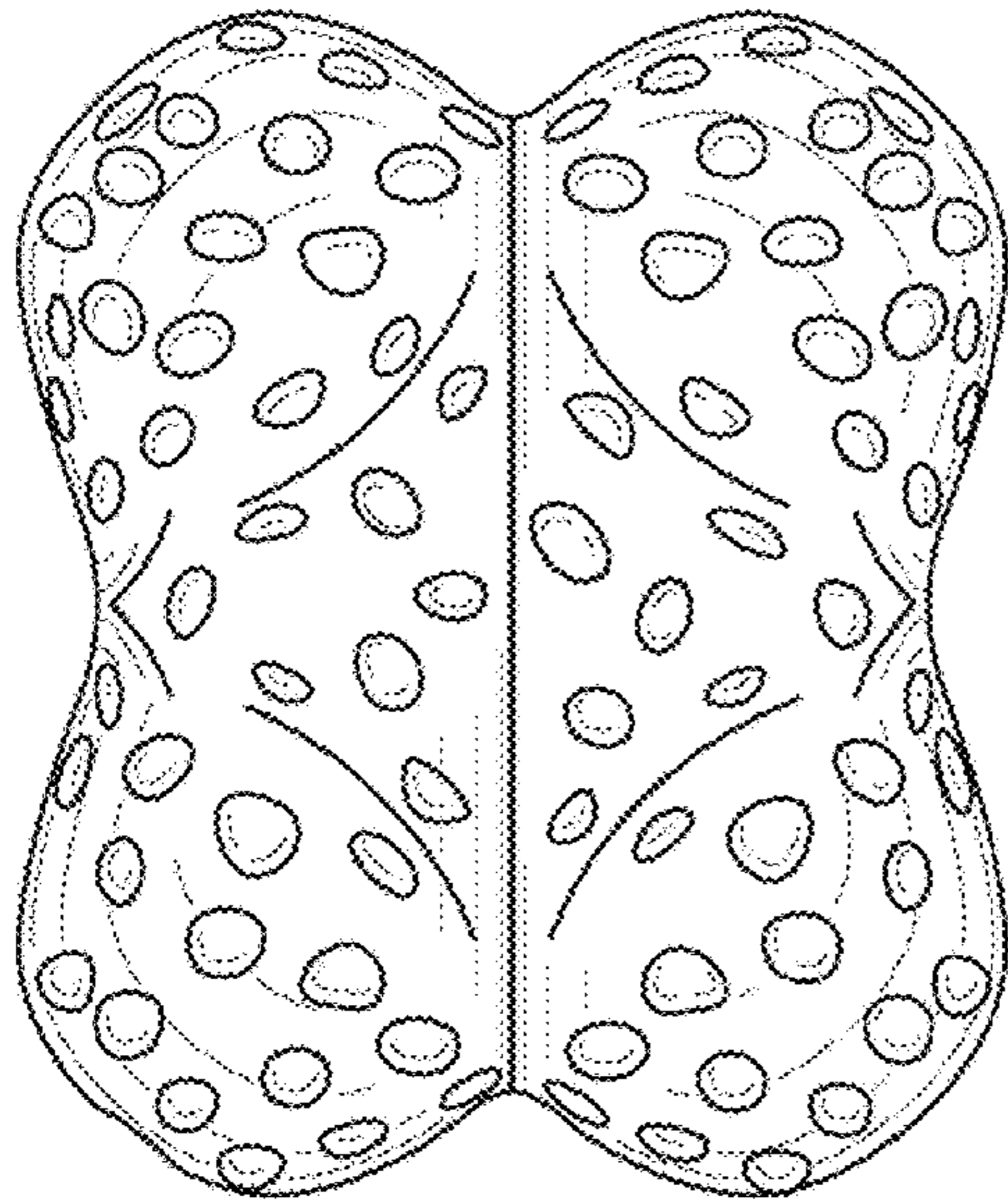

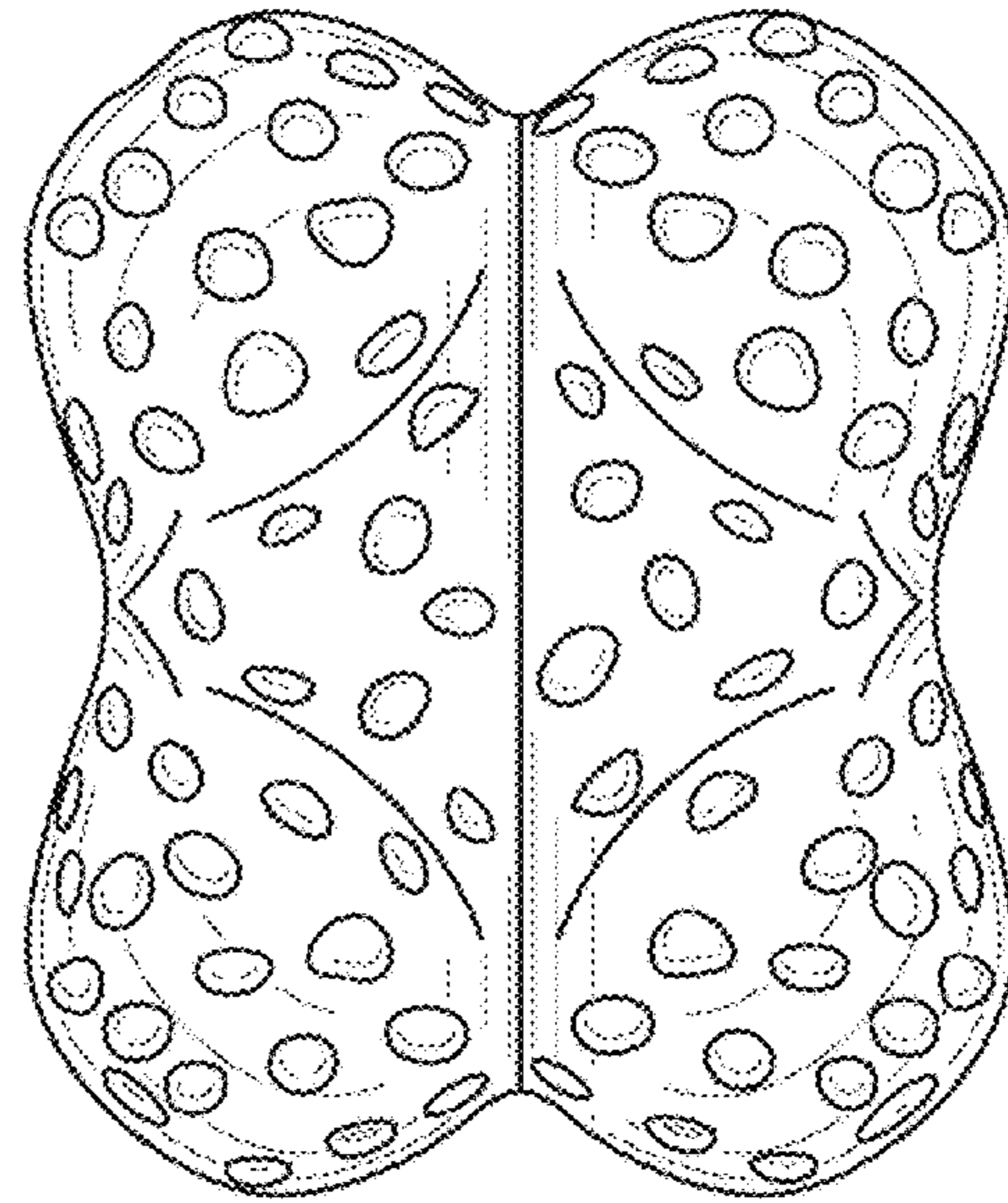

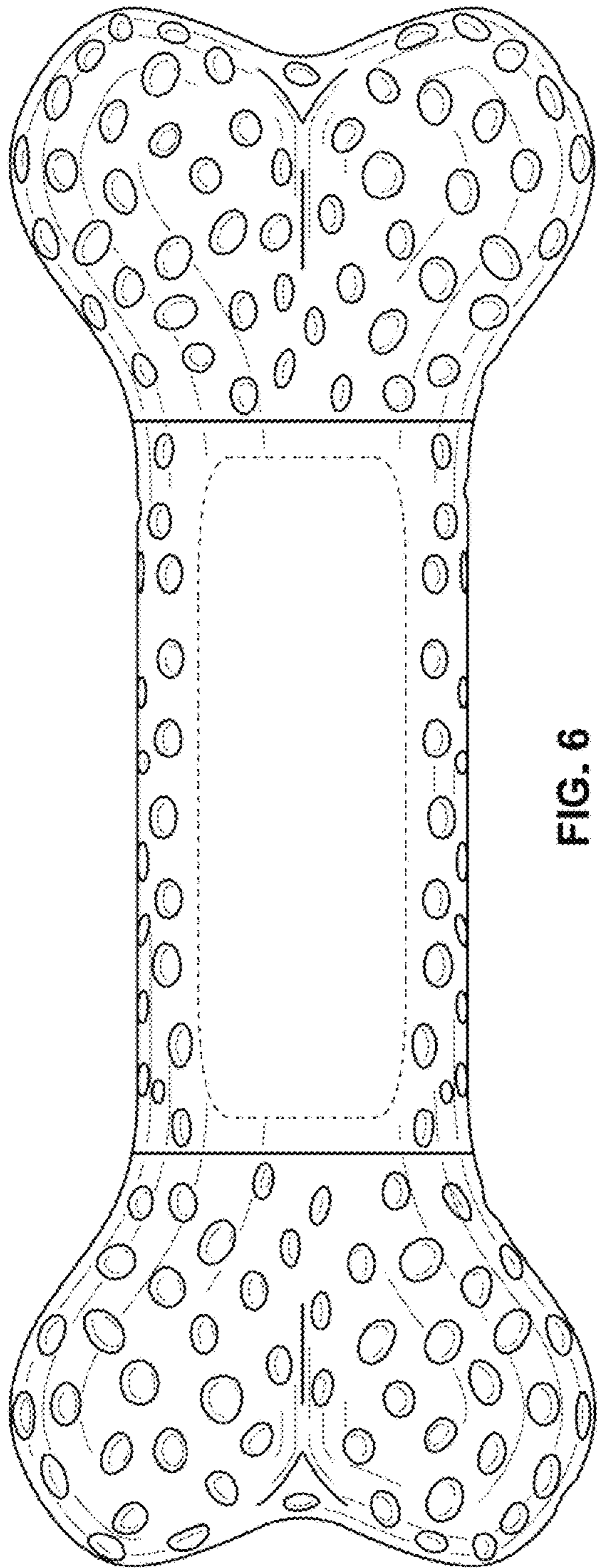

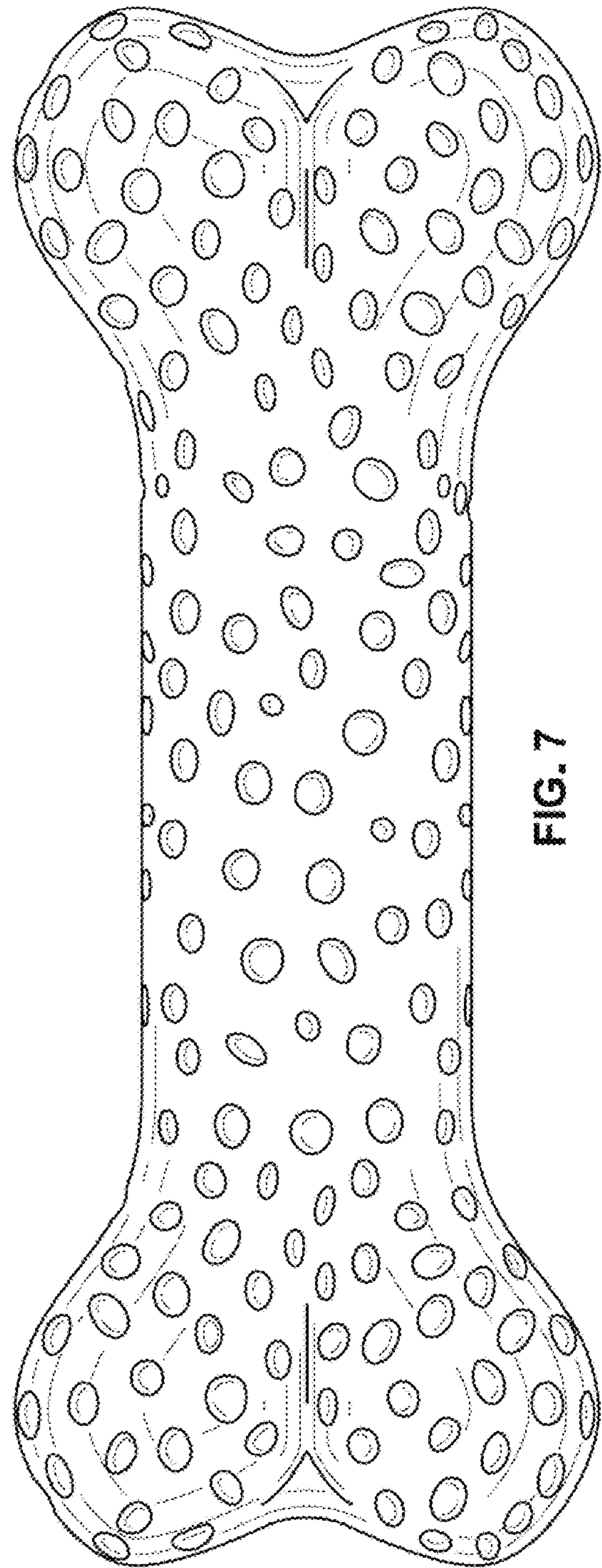

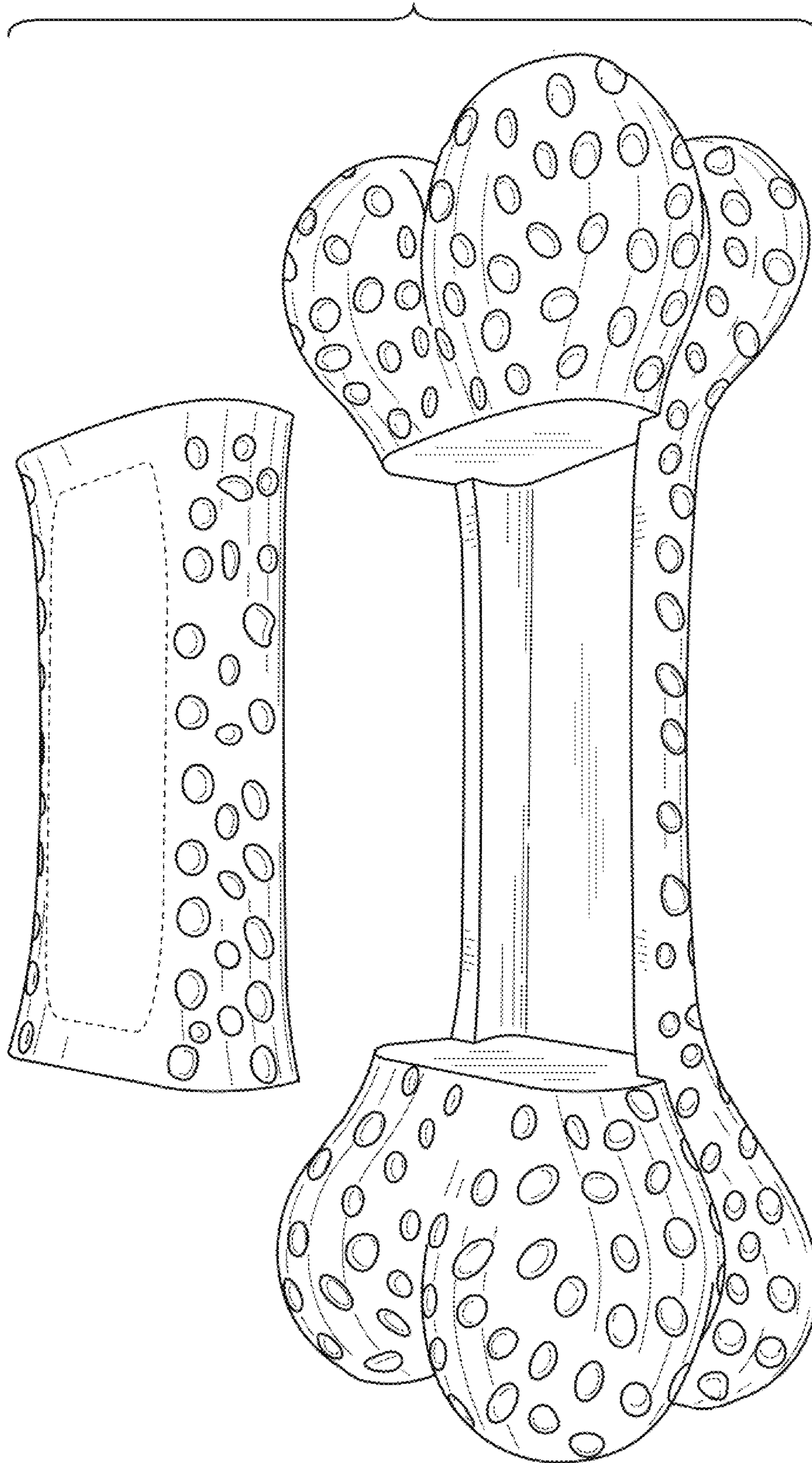
