(57) **CLAIM**

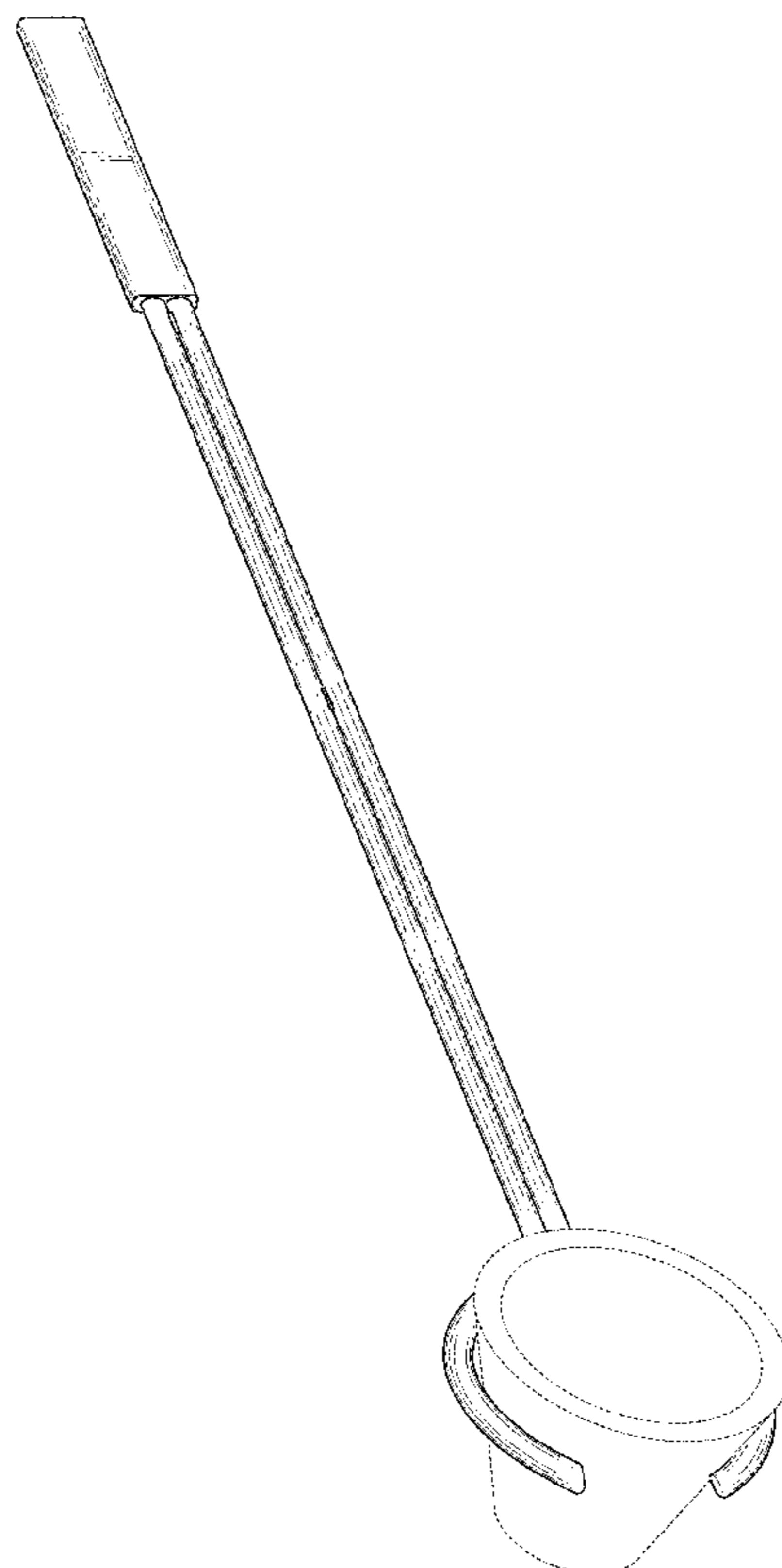
The ornamental design for a crucible holder, as shown and described.

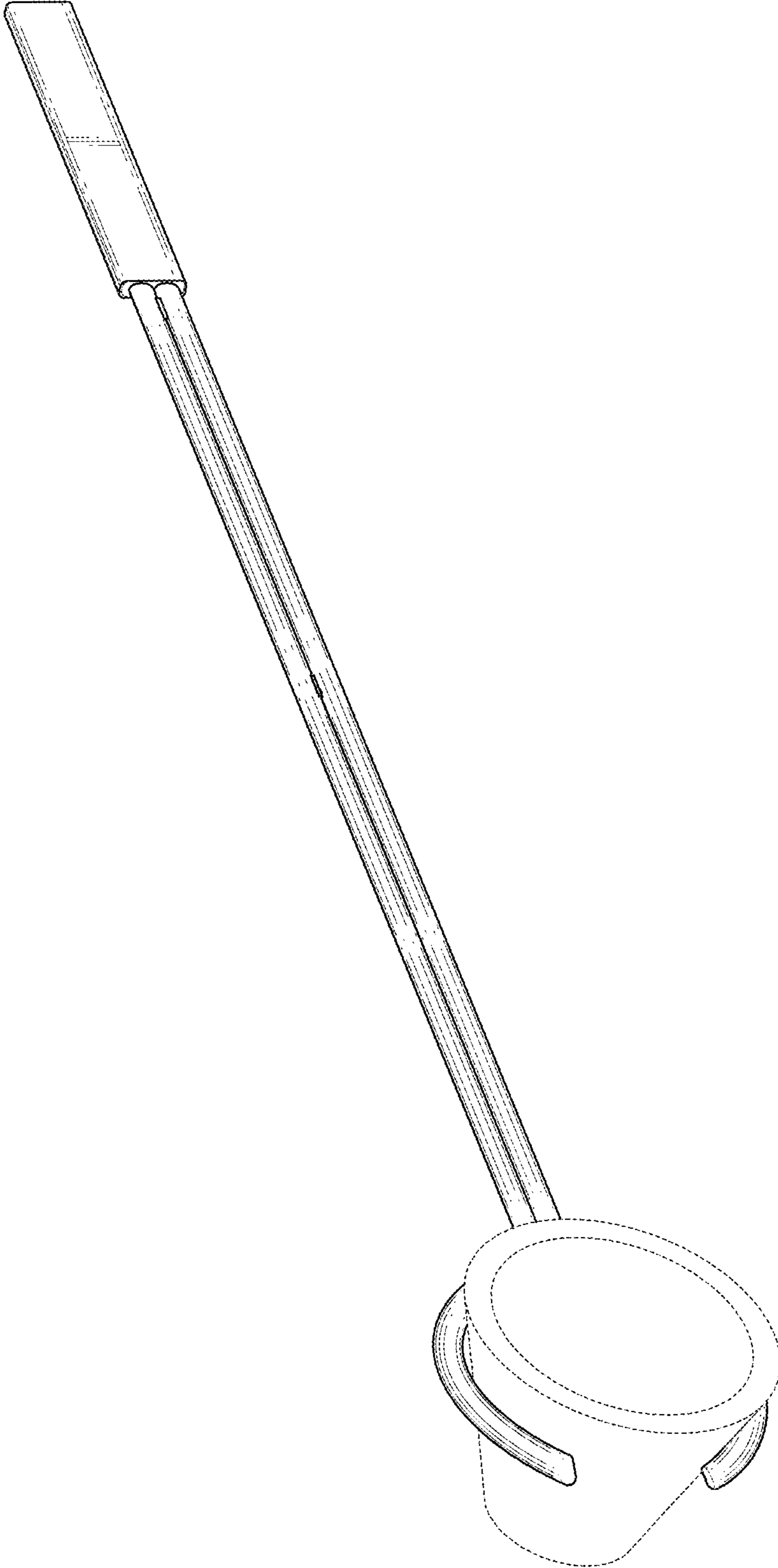

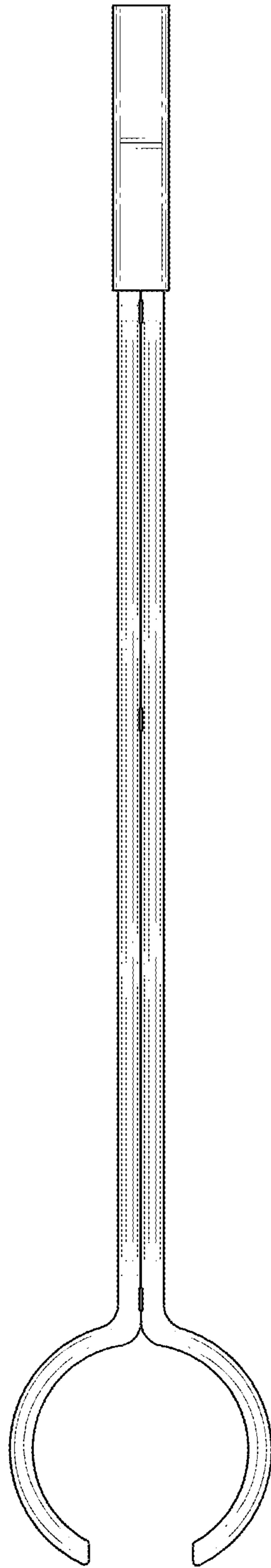

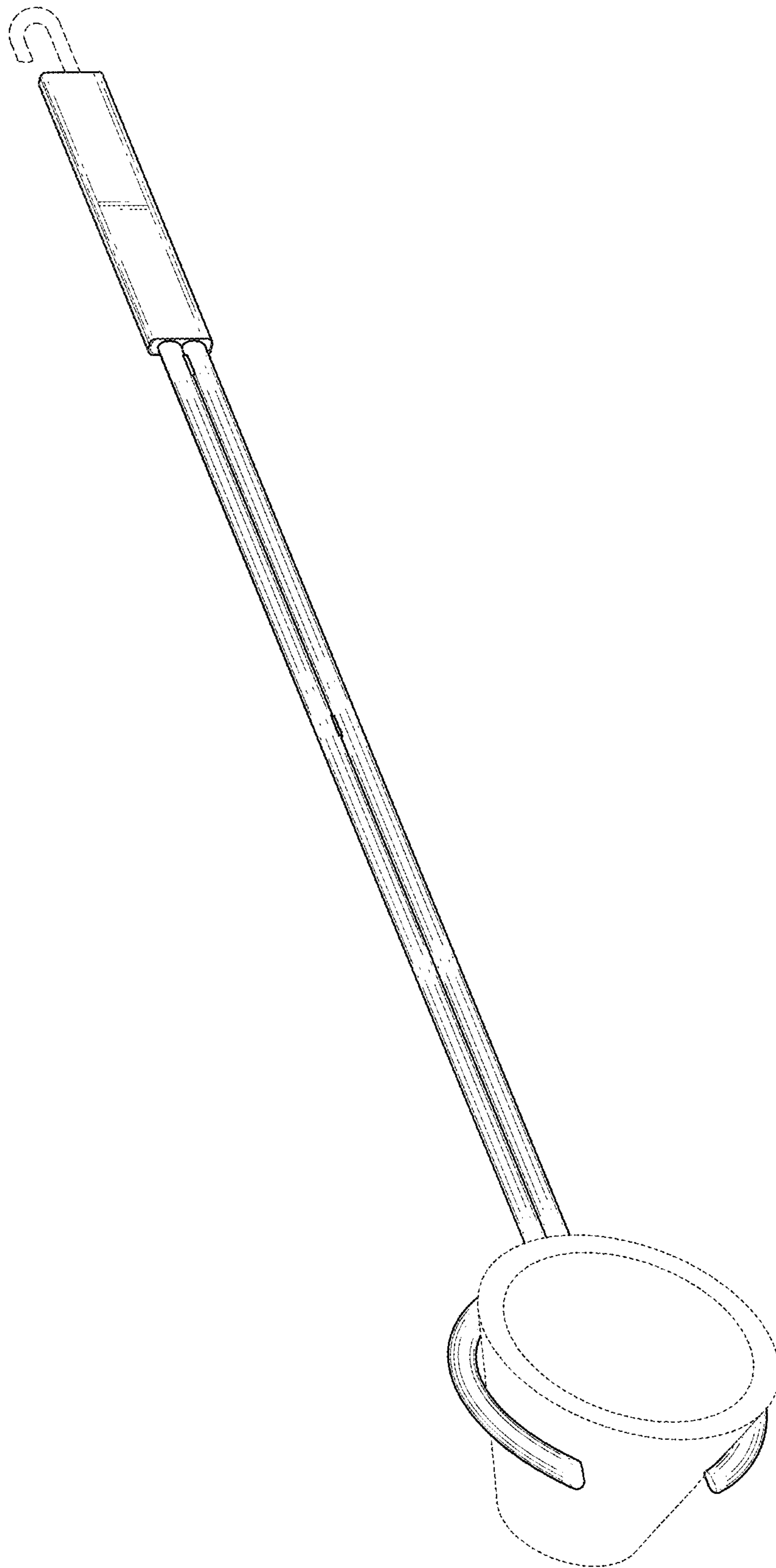
