The ornamental design for a medallion, as shown and described.

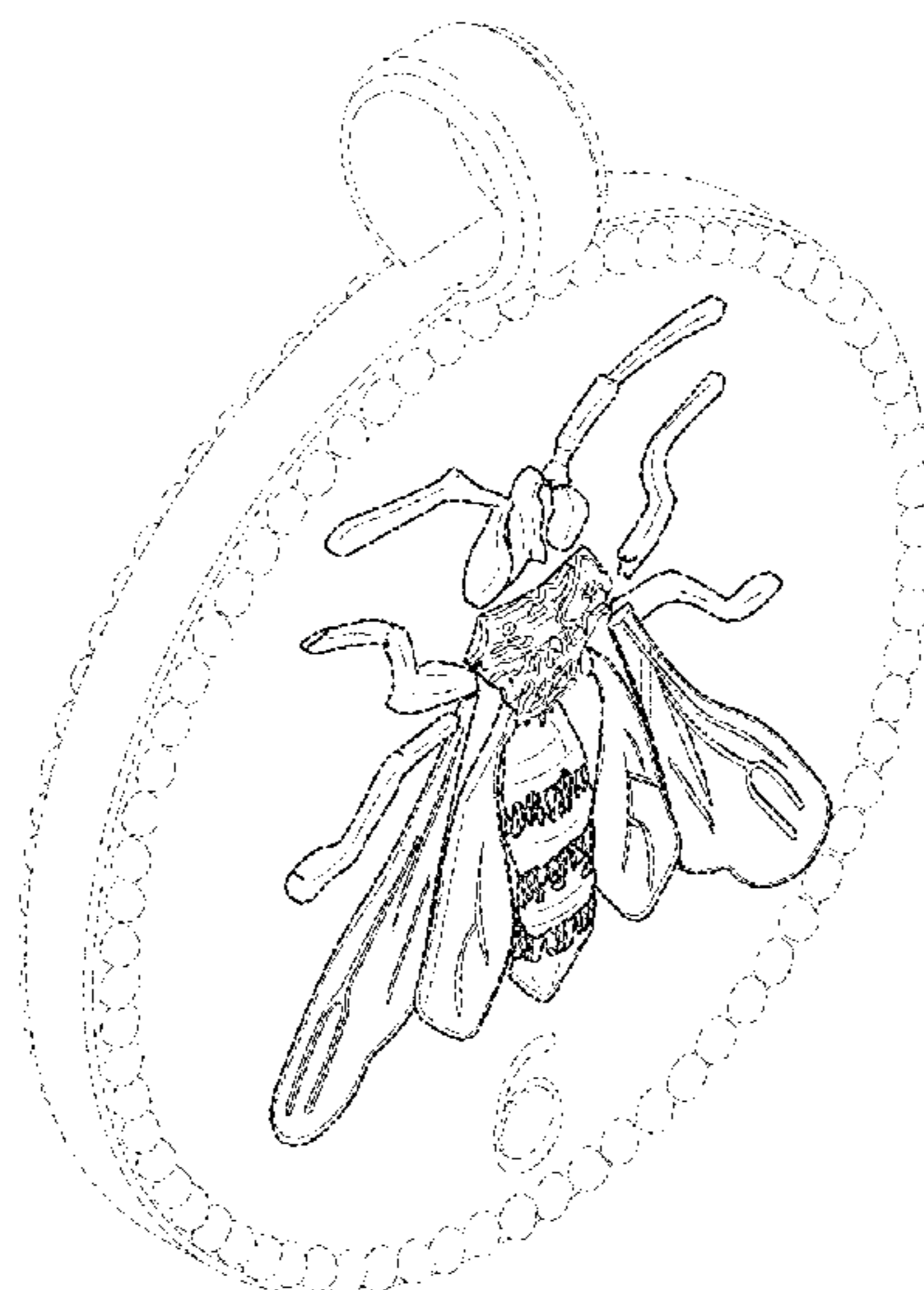
**DESCRIPTION**

FIG. 1 is a left perspective view of the front side of a medallion;  
FIG. 2 is a left perspective view of the reverse side of the medallion;  
FIG. 3 is a front plan view of the medallion; and,  
FIG. 4 is a reverse plan view of the medallion.  
The broken lines in the Figures illustrate portions of the medallion that form no part of the claimed design.

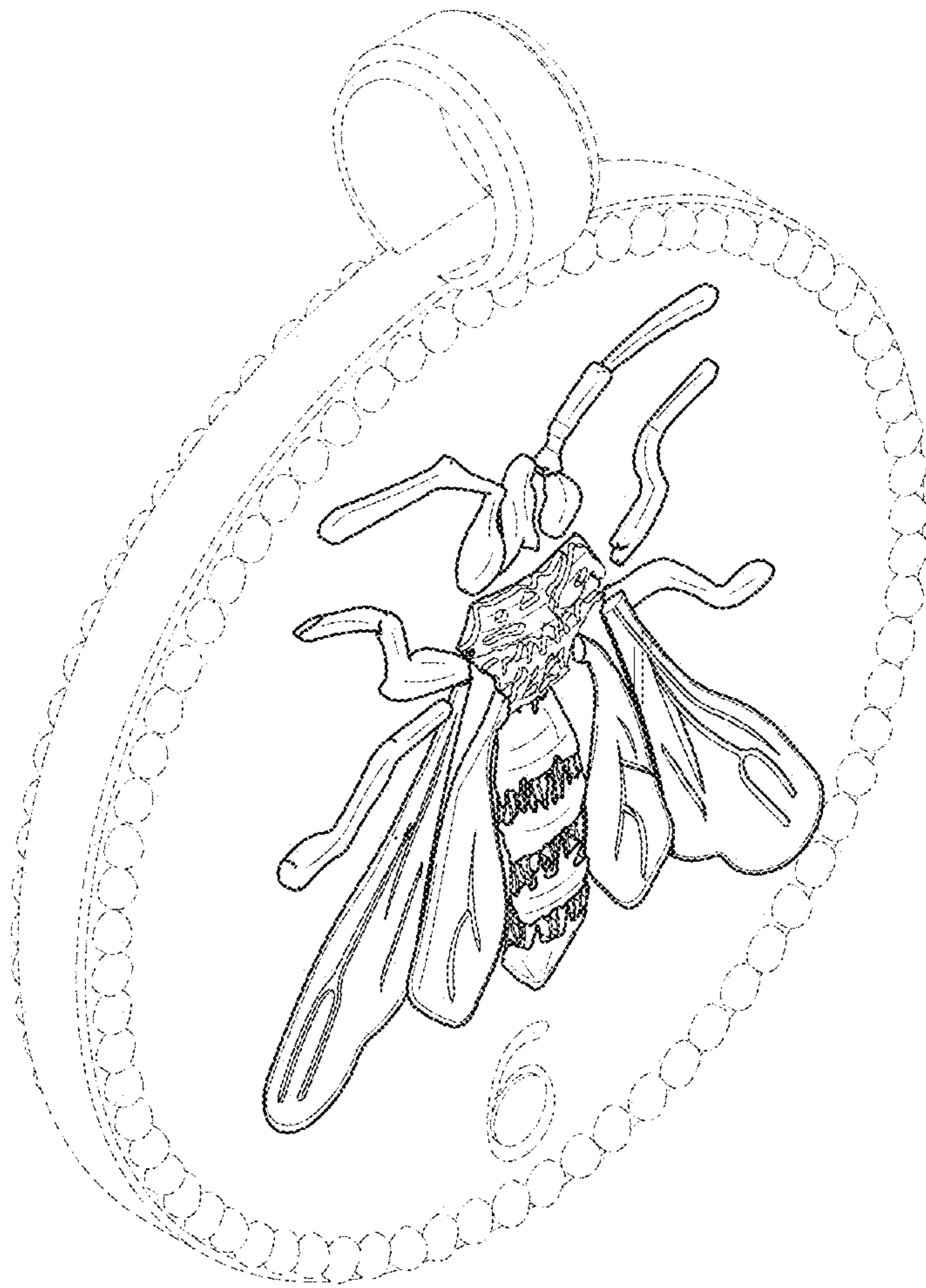

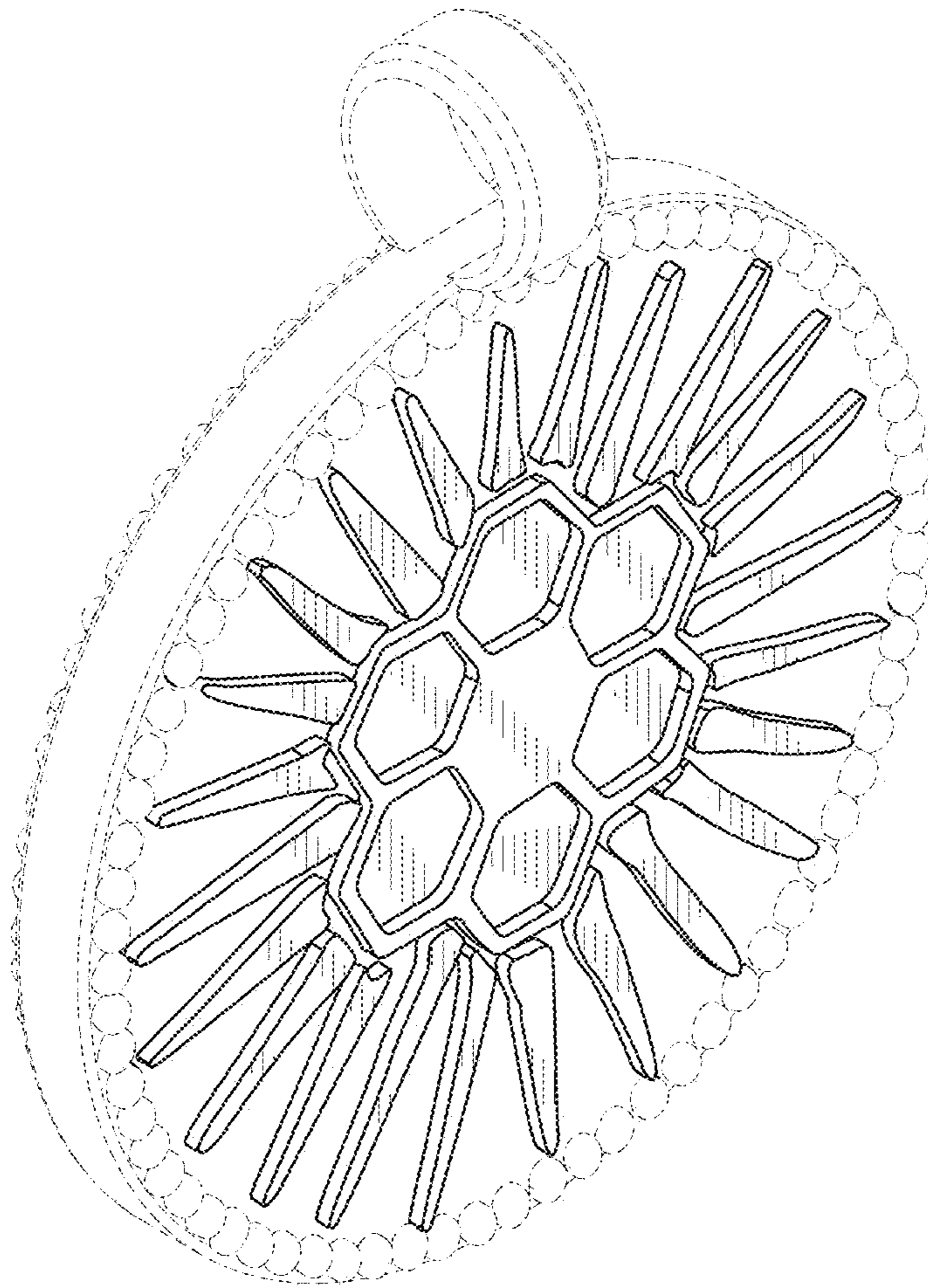

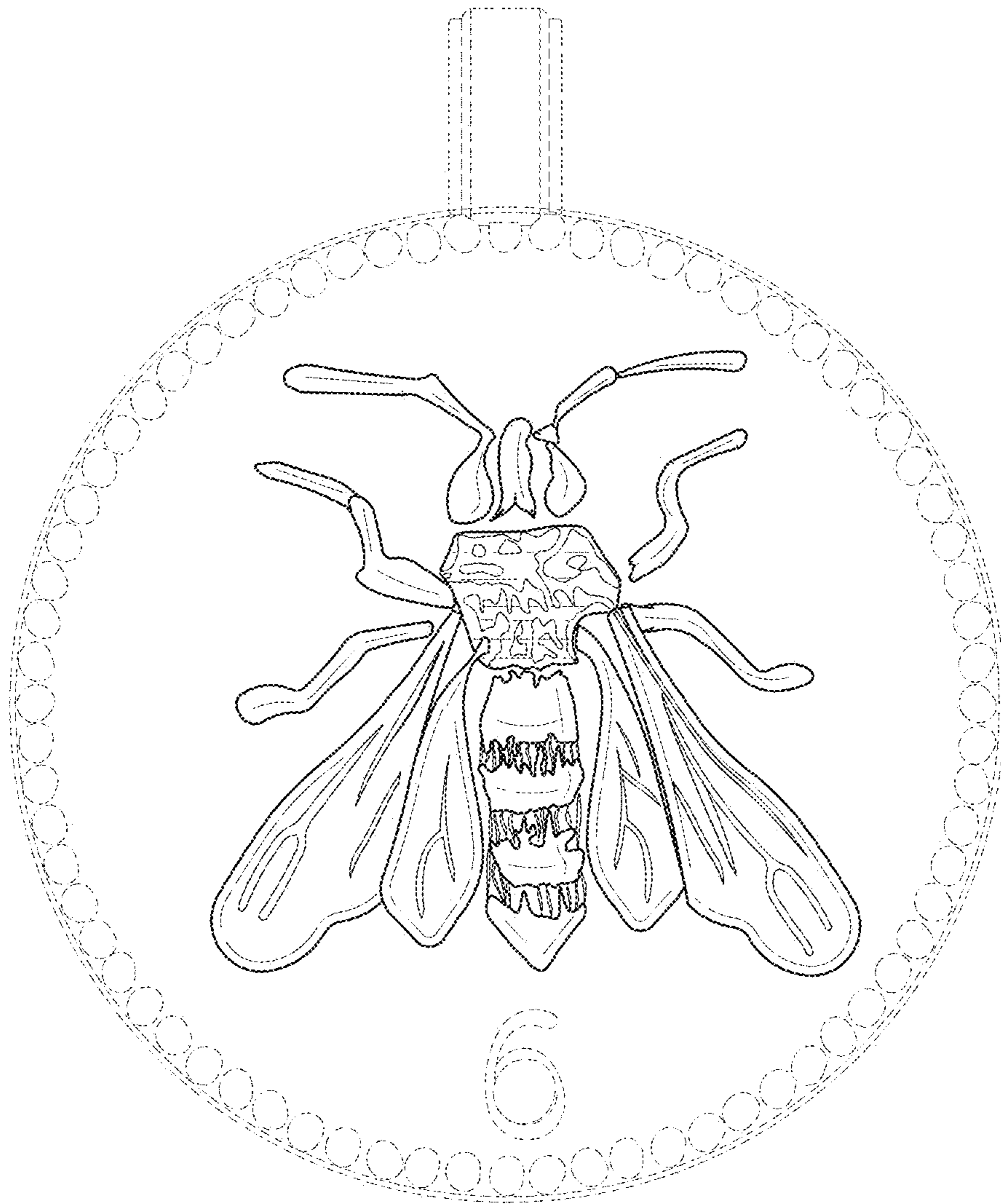

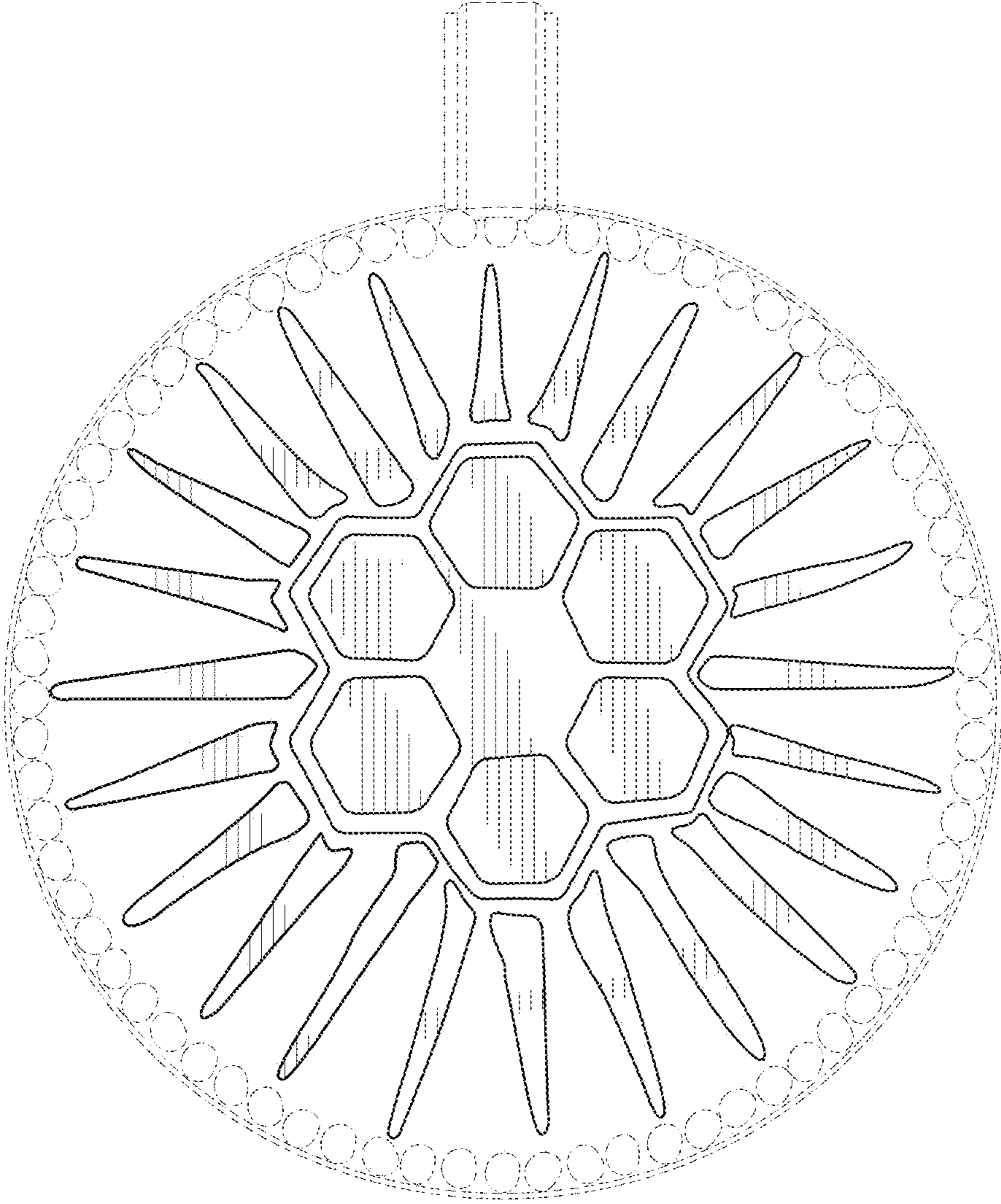
