FIG. 12 is a bottom plan view of FIG. 9.
FIG. 13 is a back elevation view of FIG. 9.

FIG. 15 is a left side elevation view of FIG. 9; and,
FIG. 16 is a right side elevation view of FIG. 9.

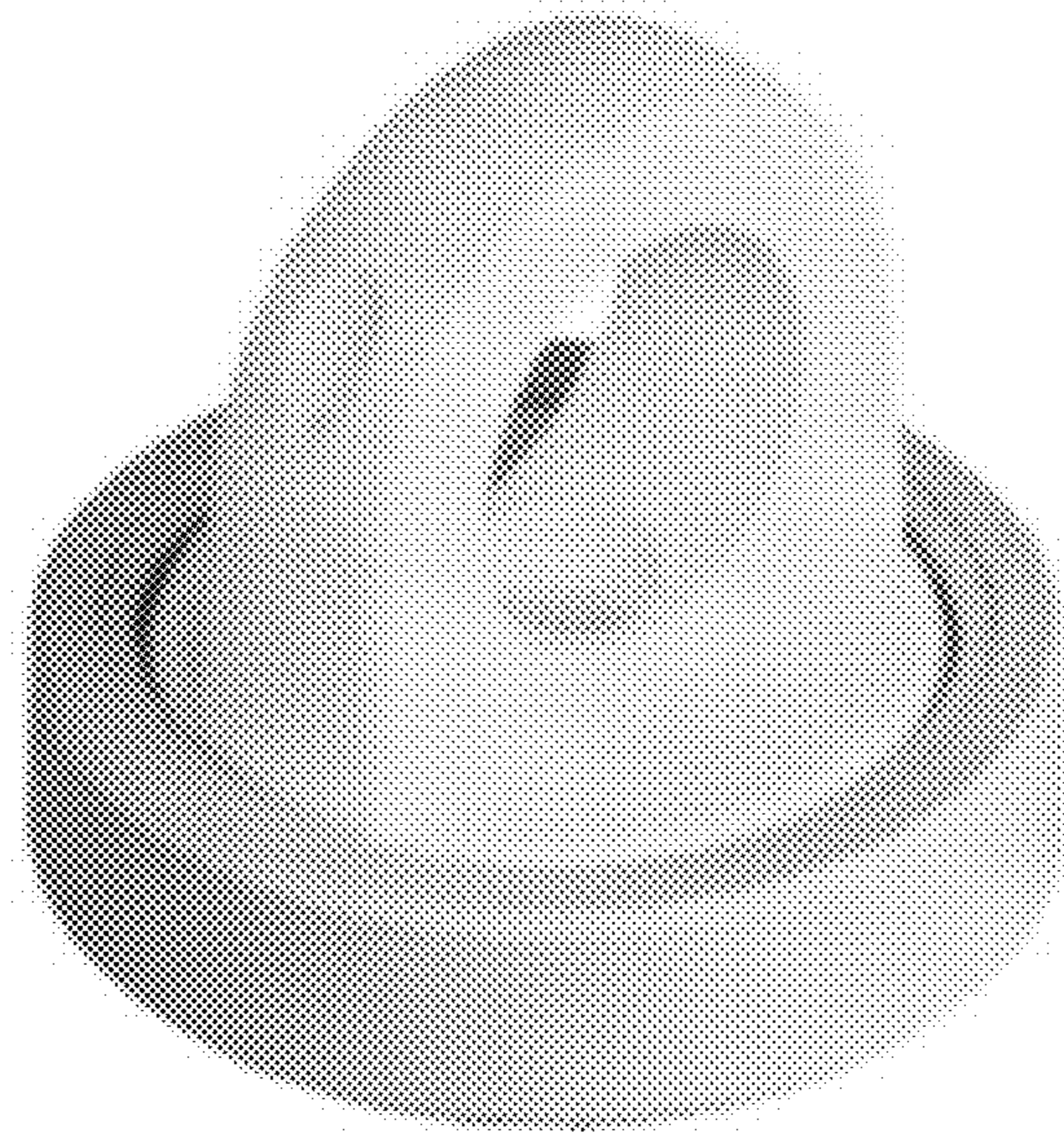

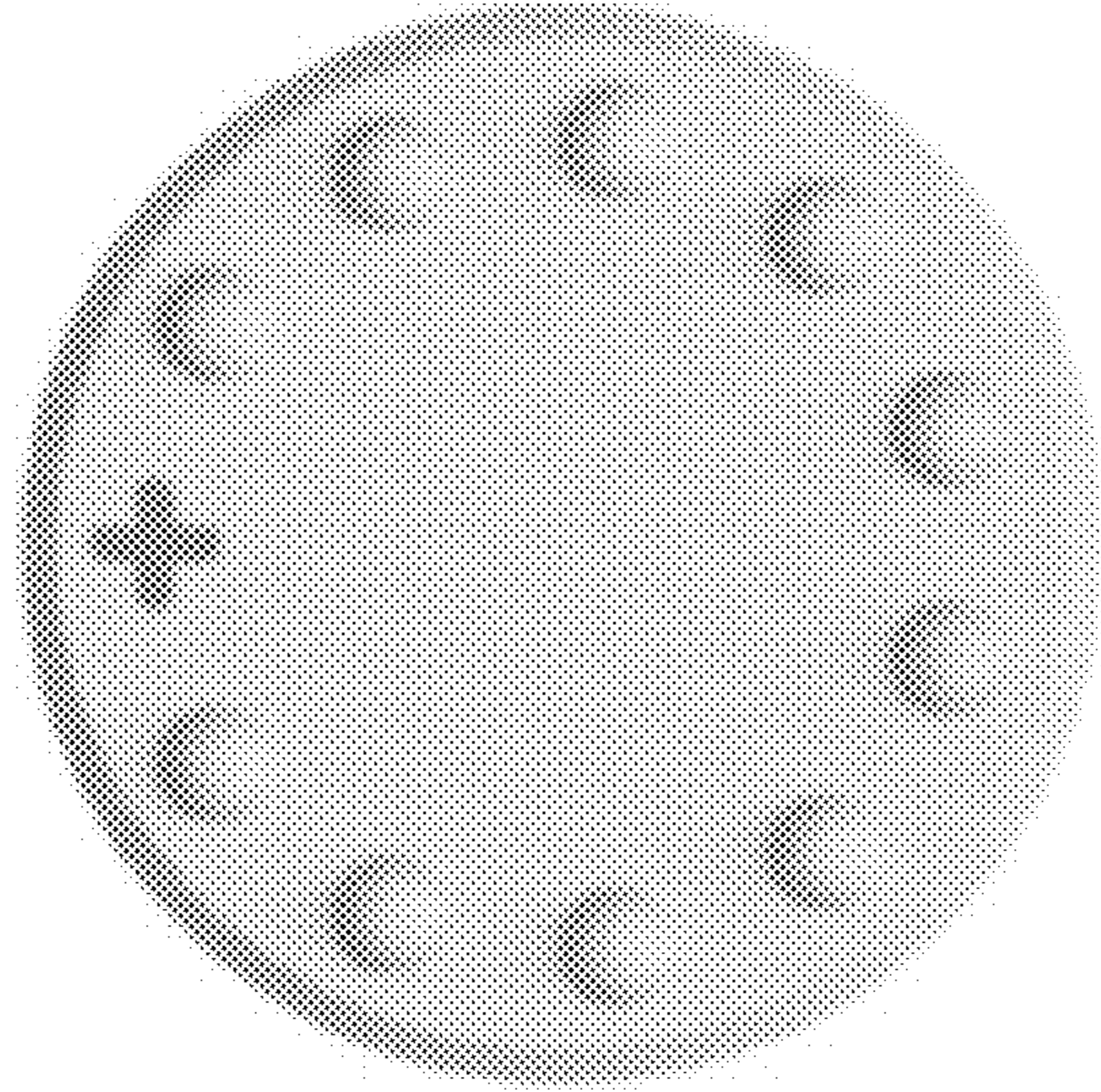

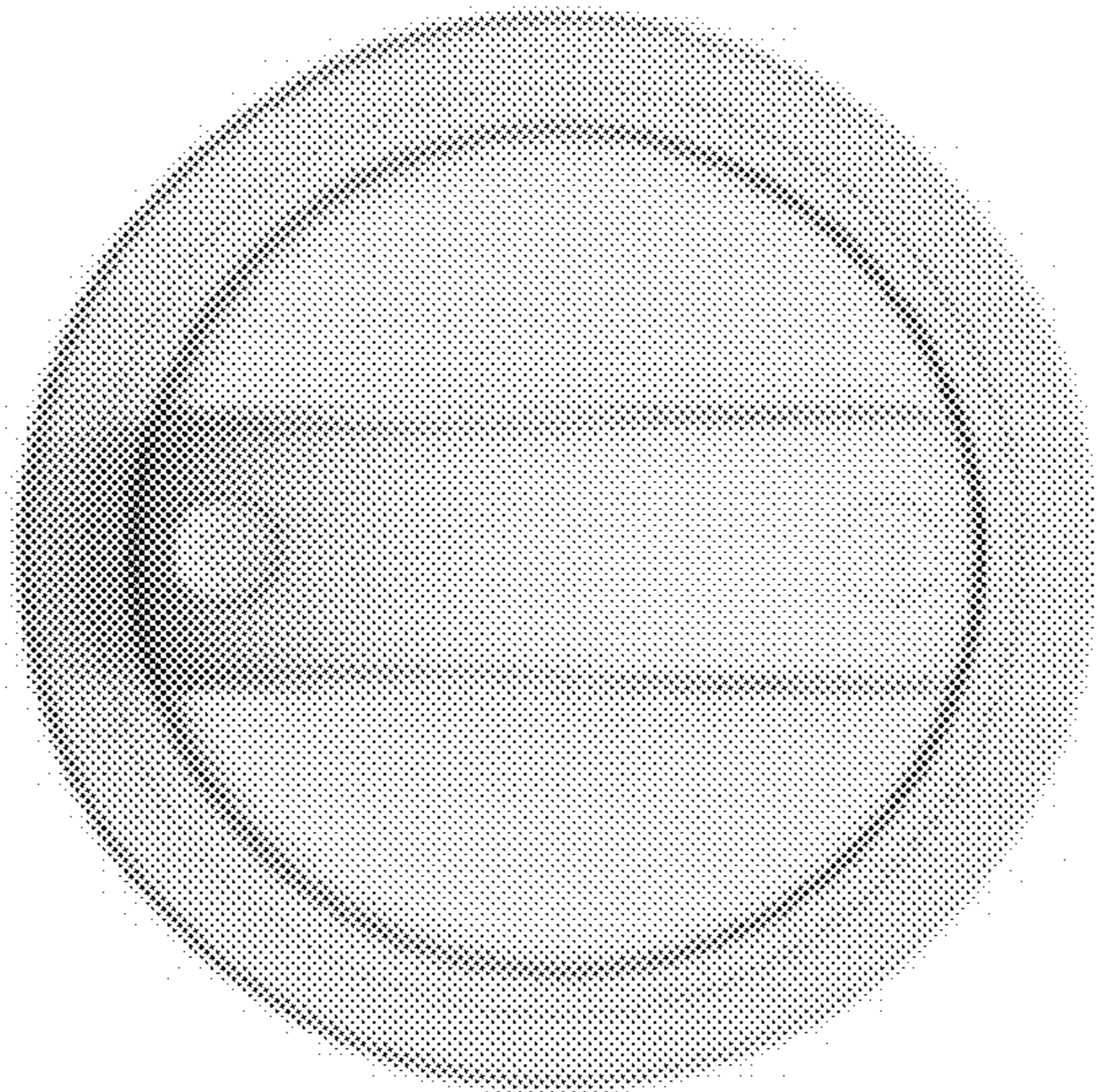

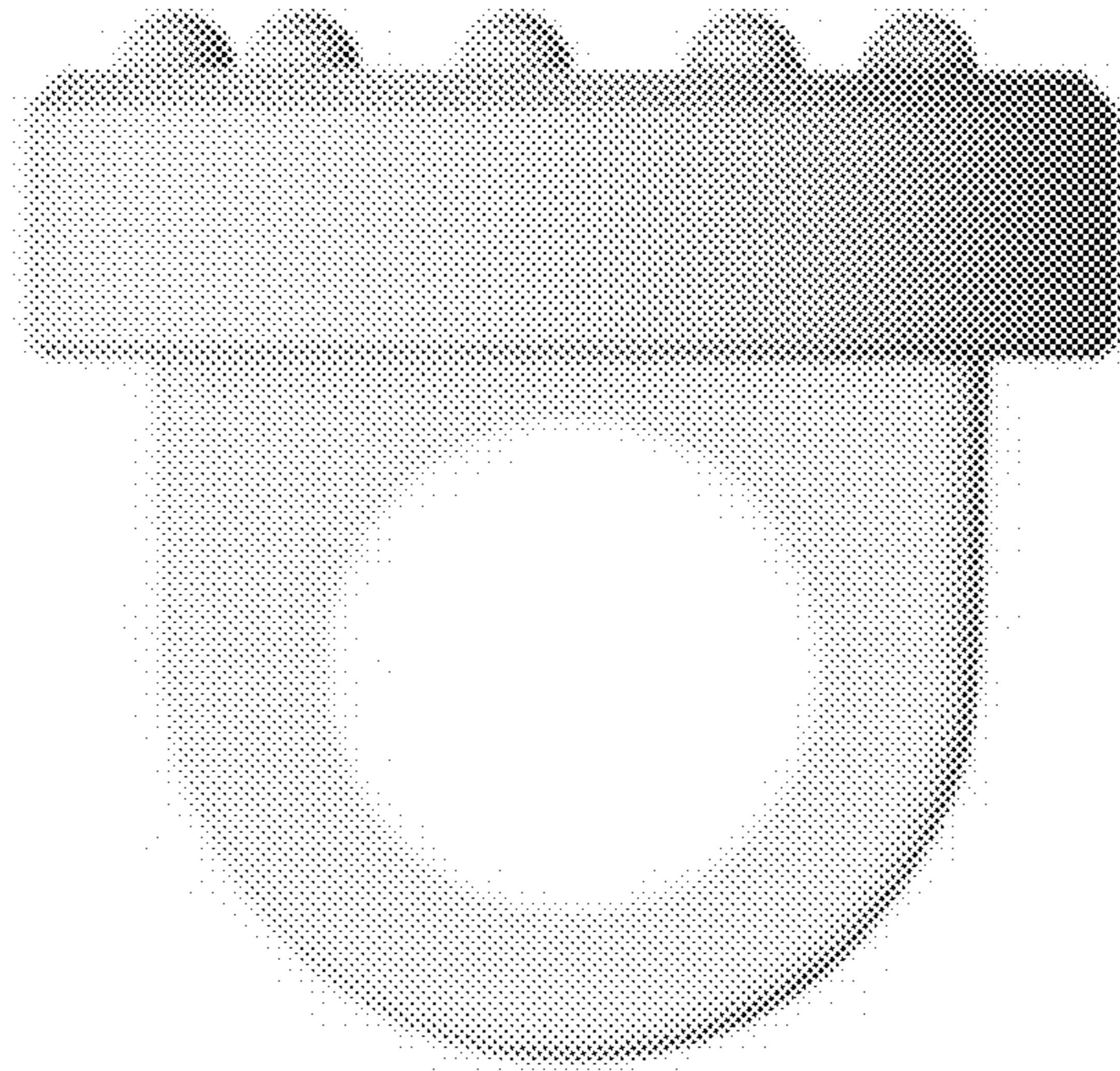

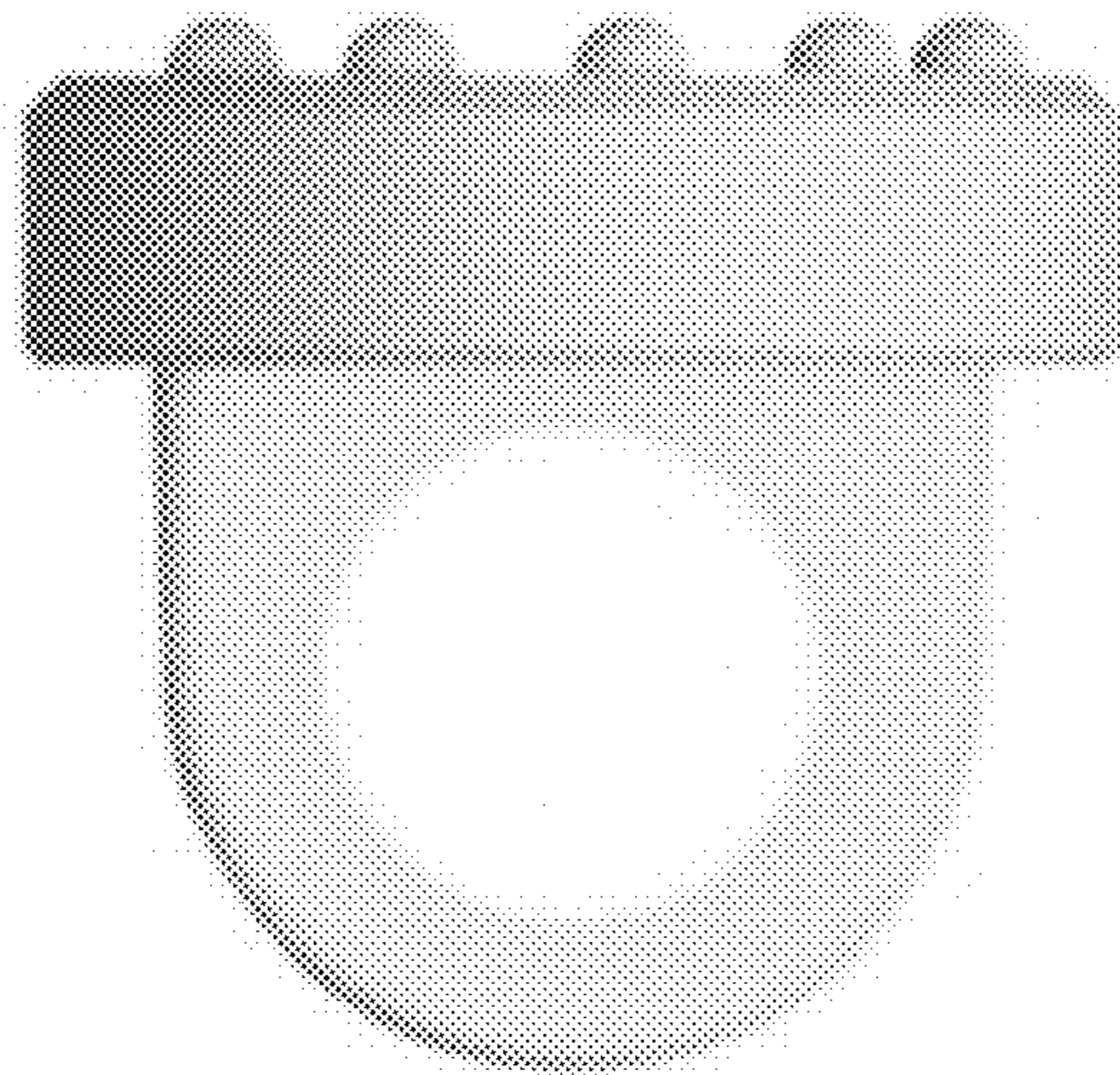

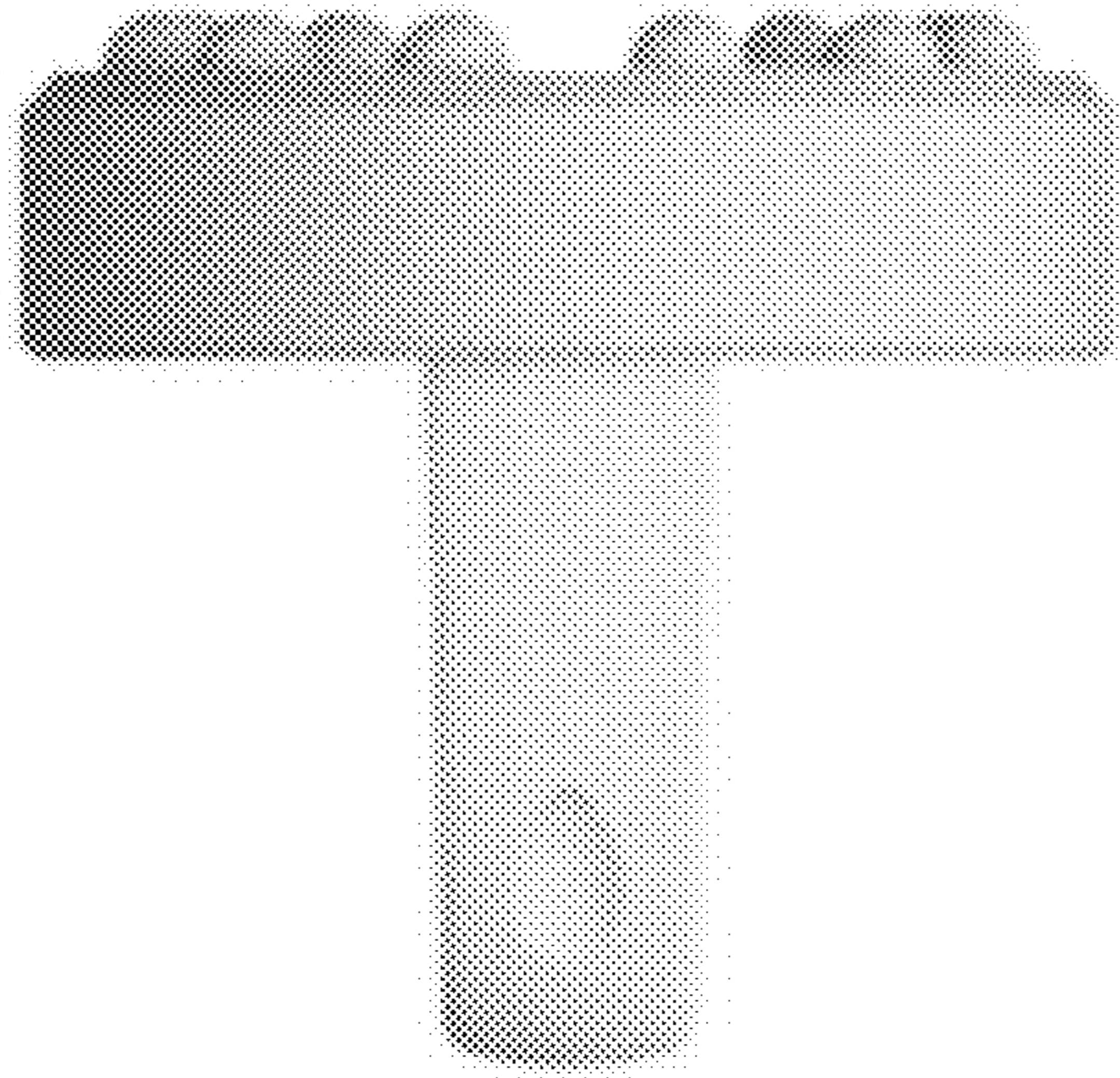

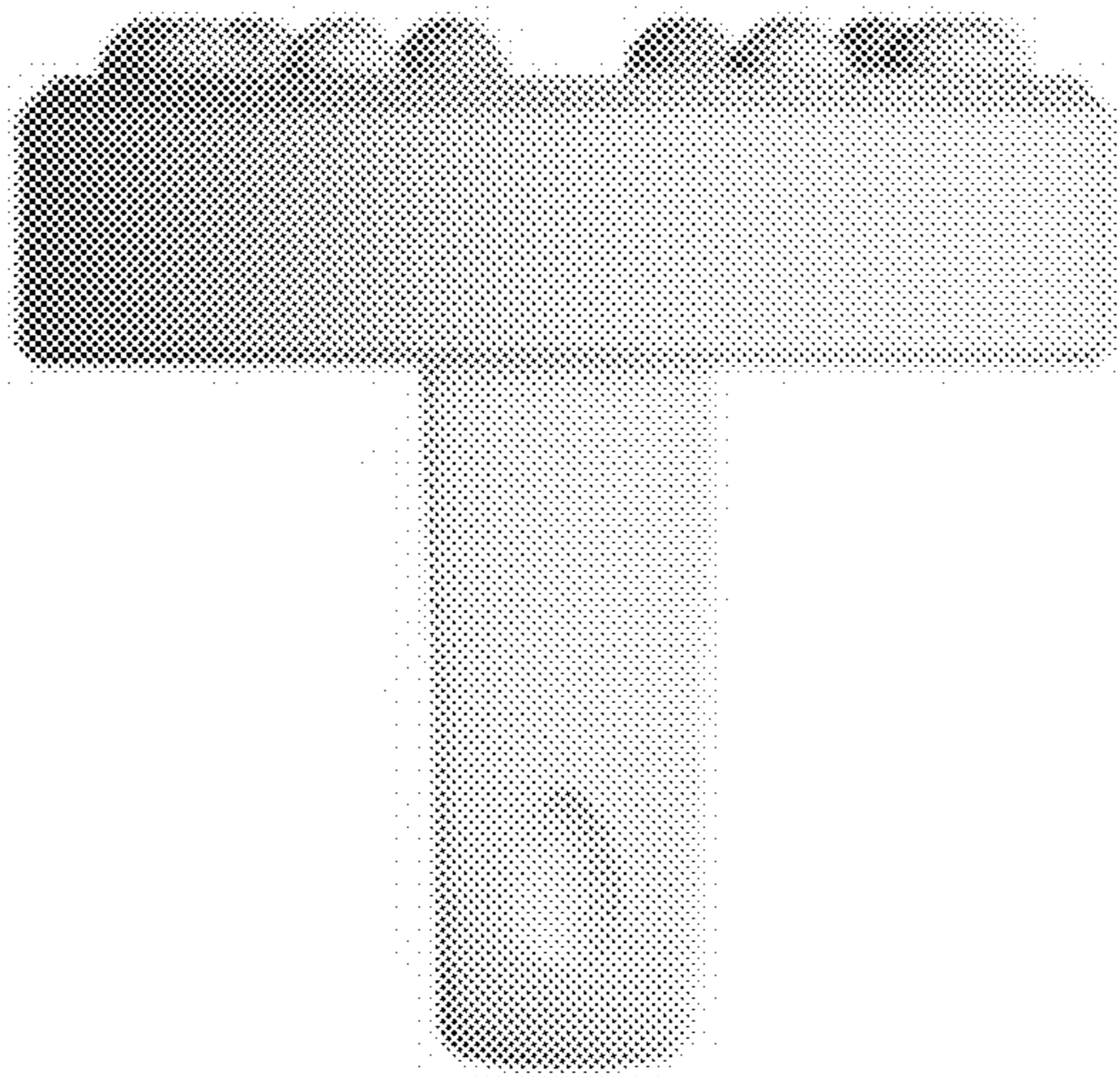

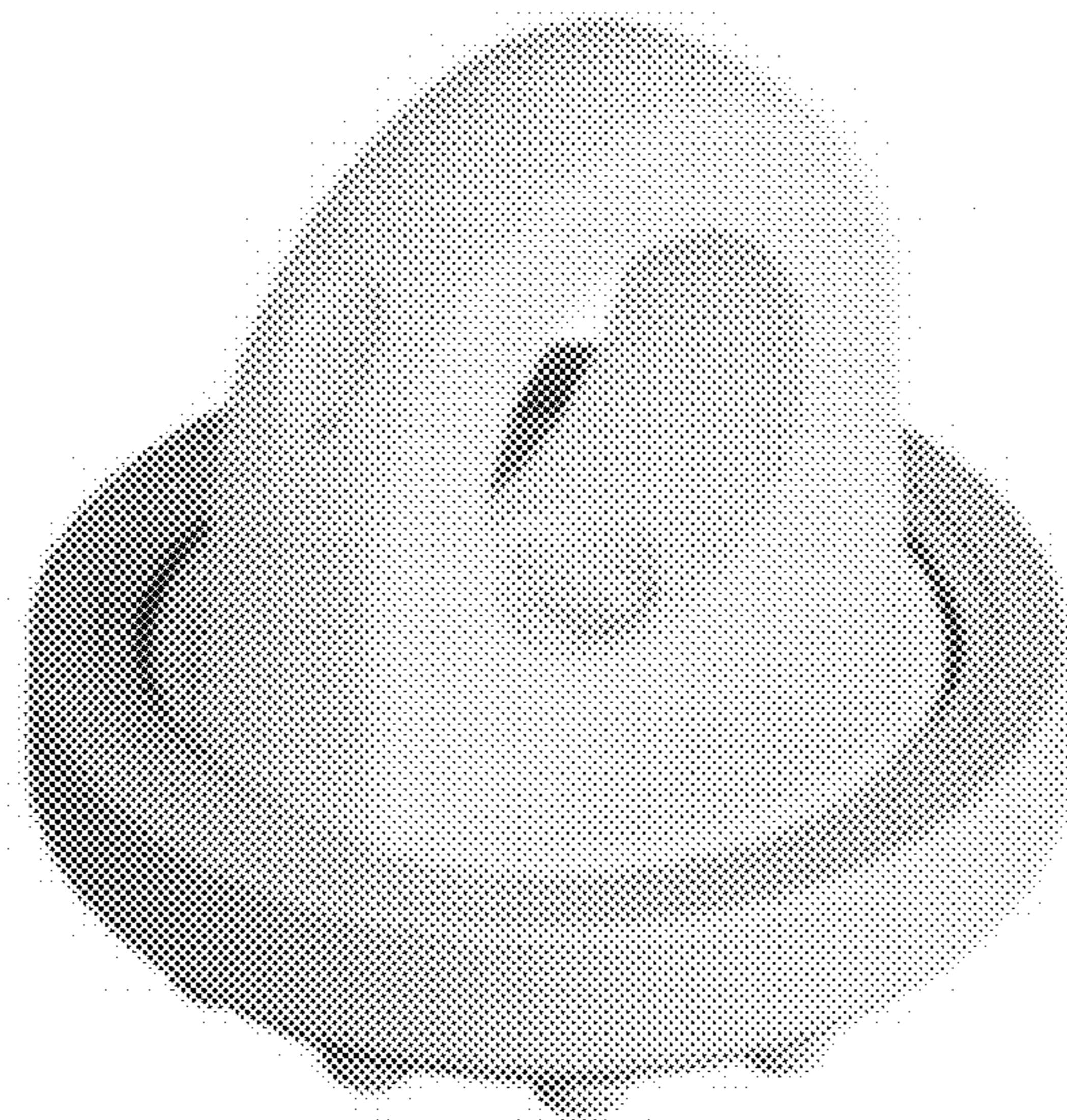

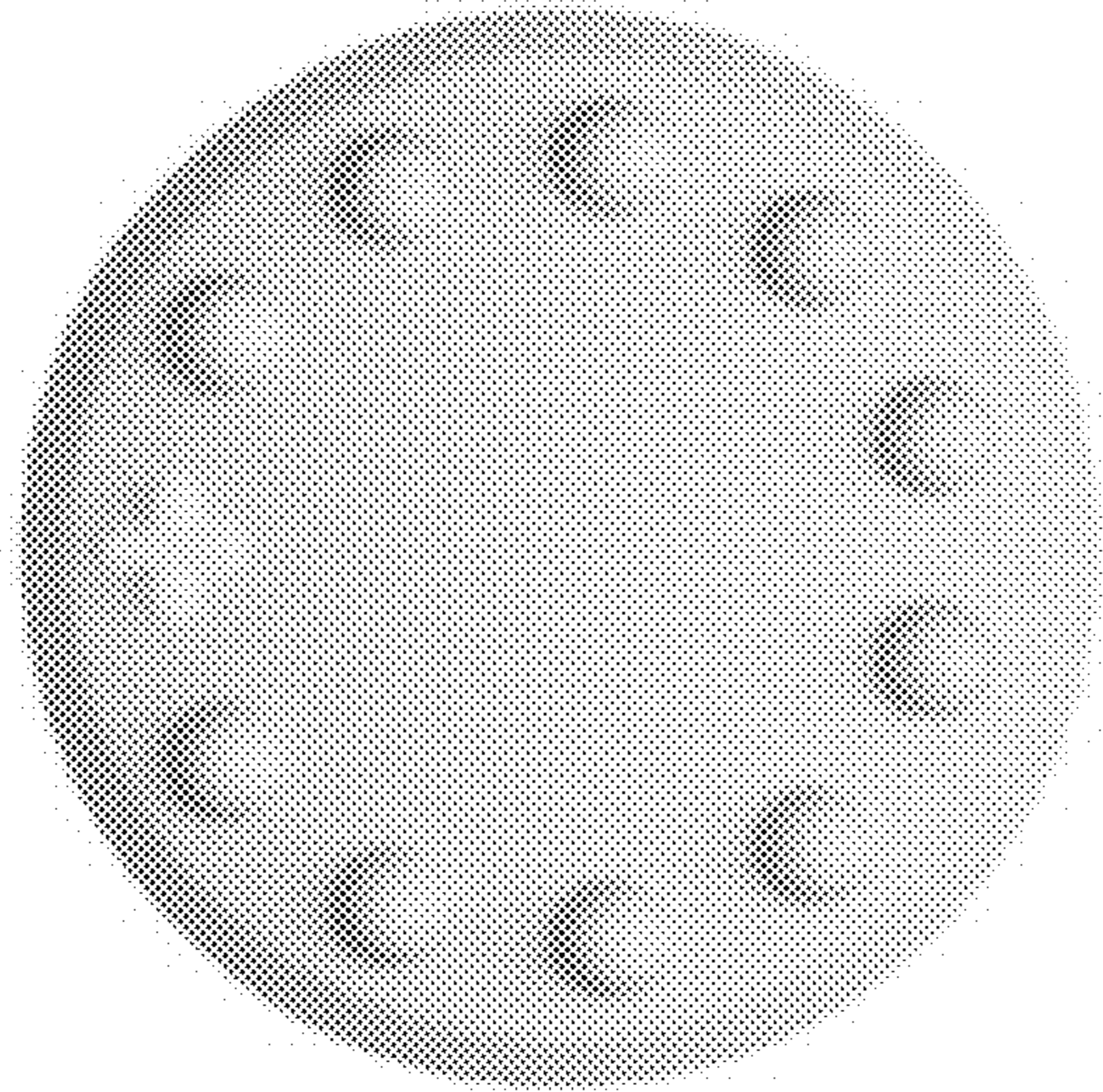

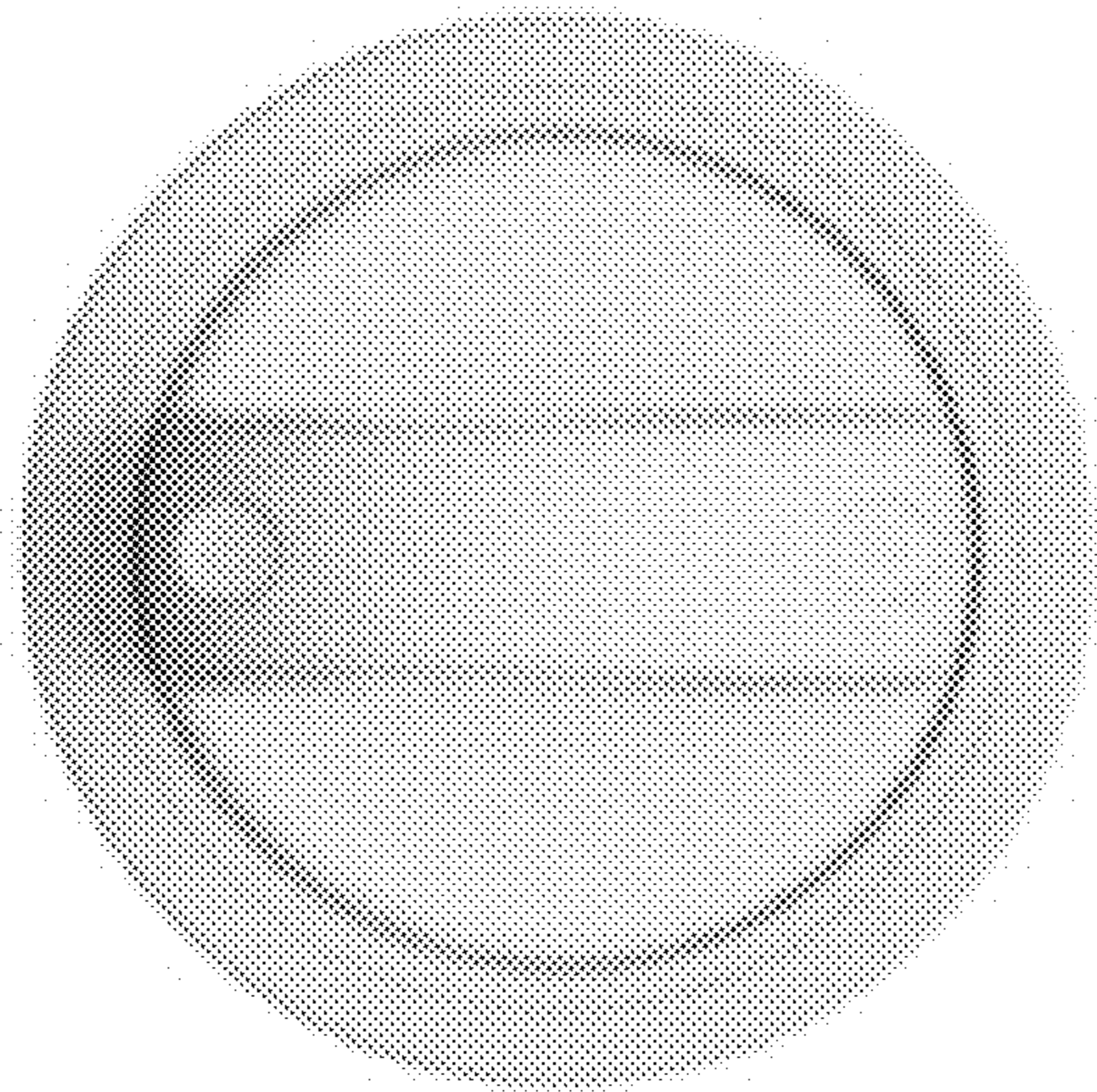

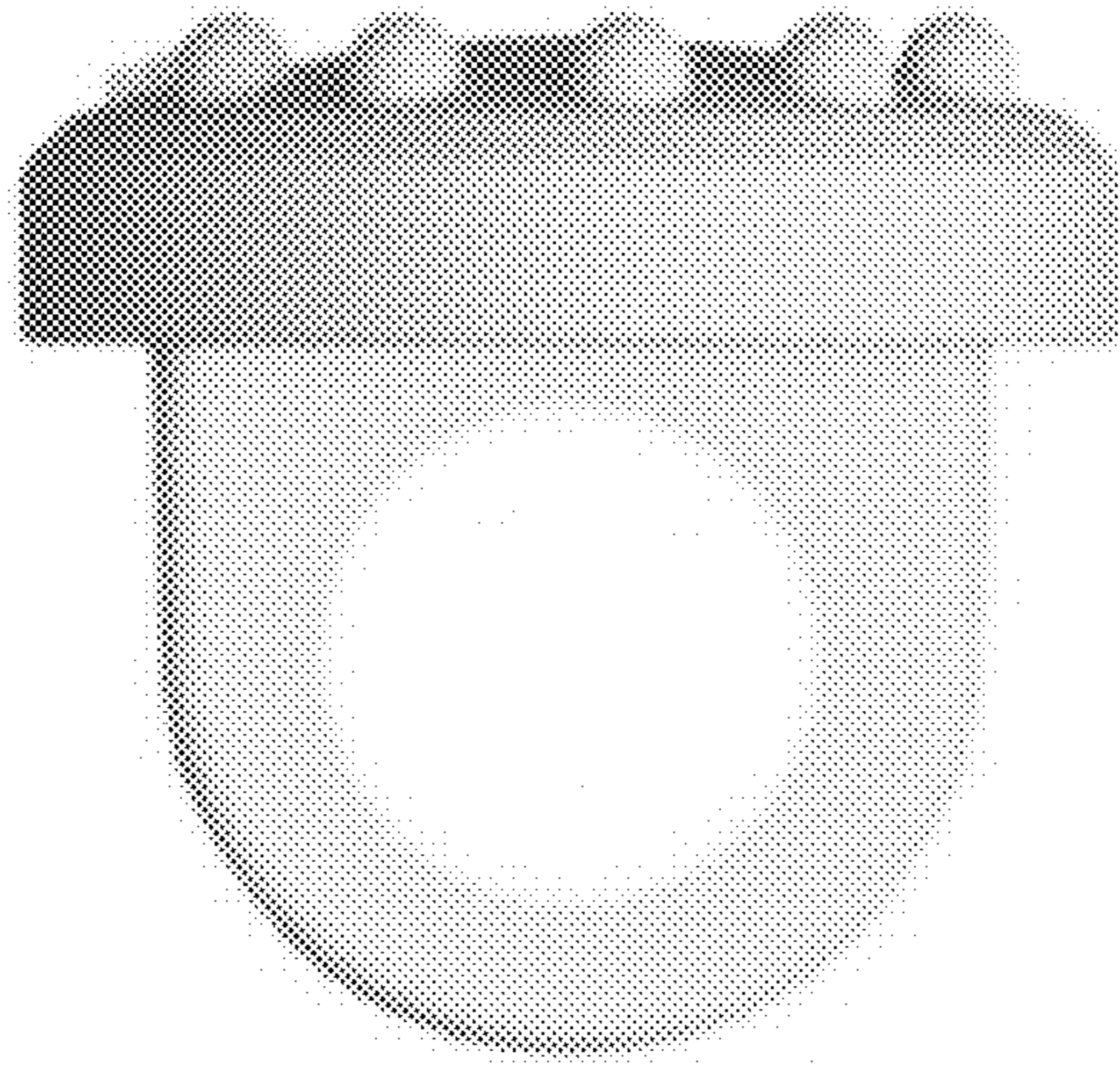

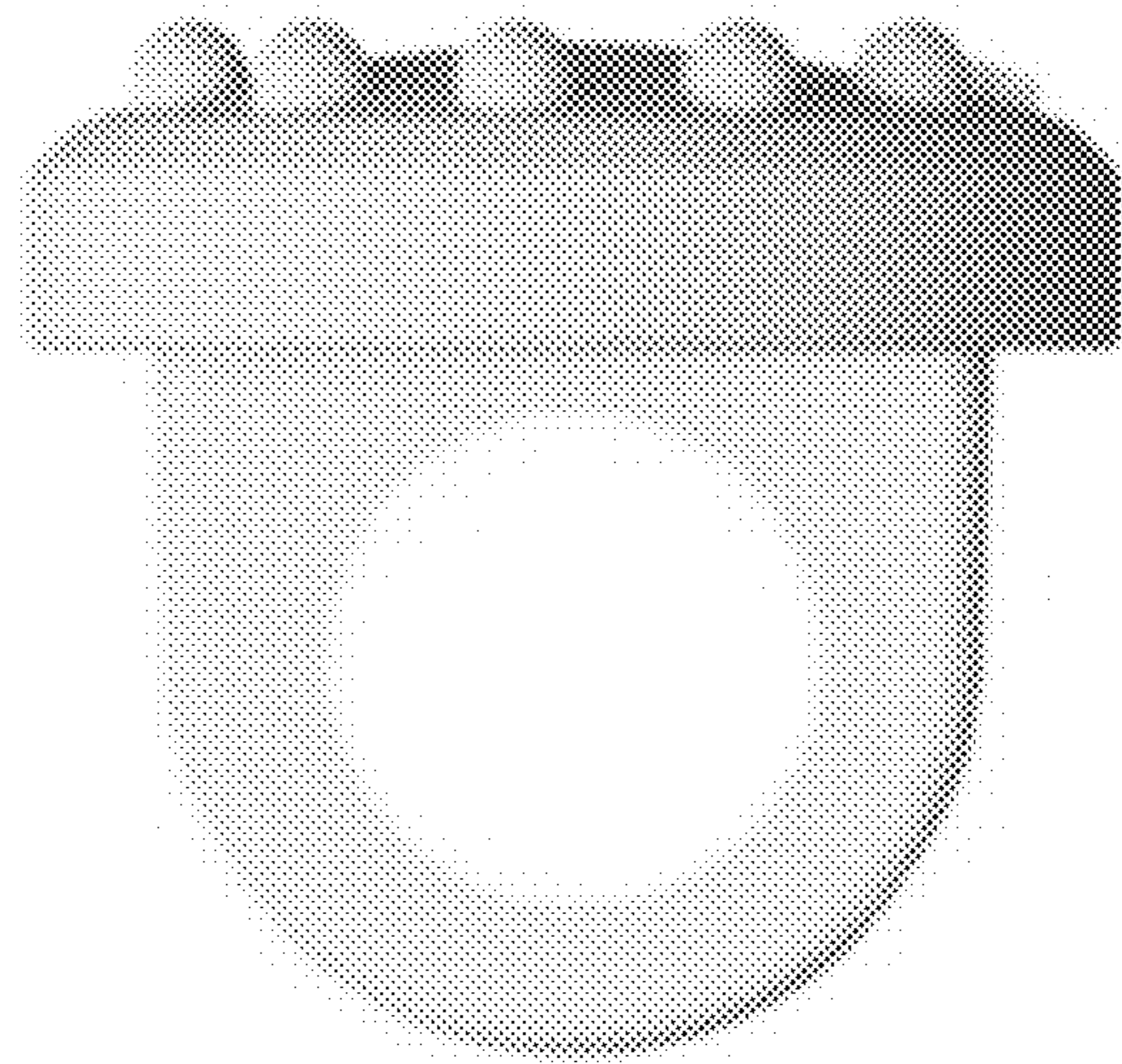

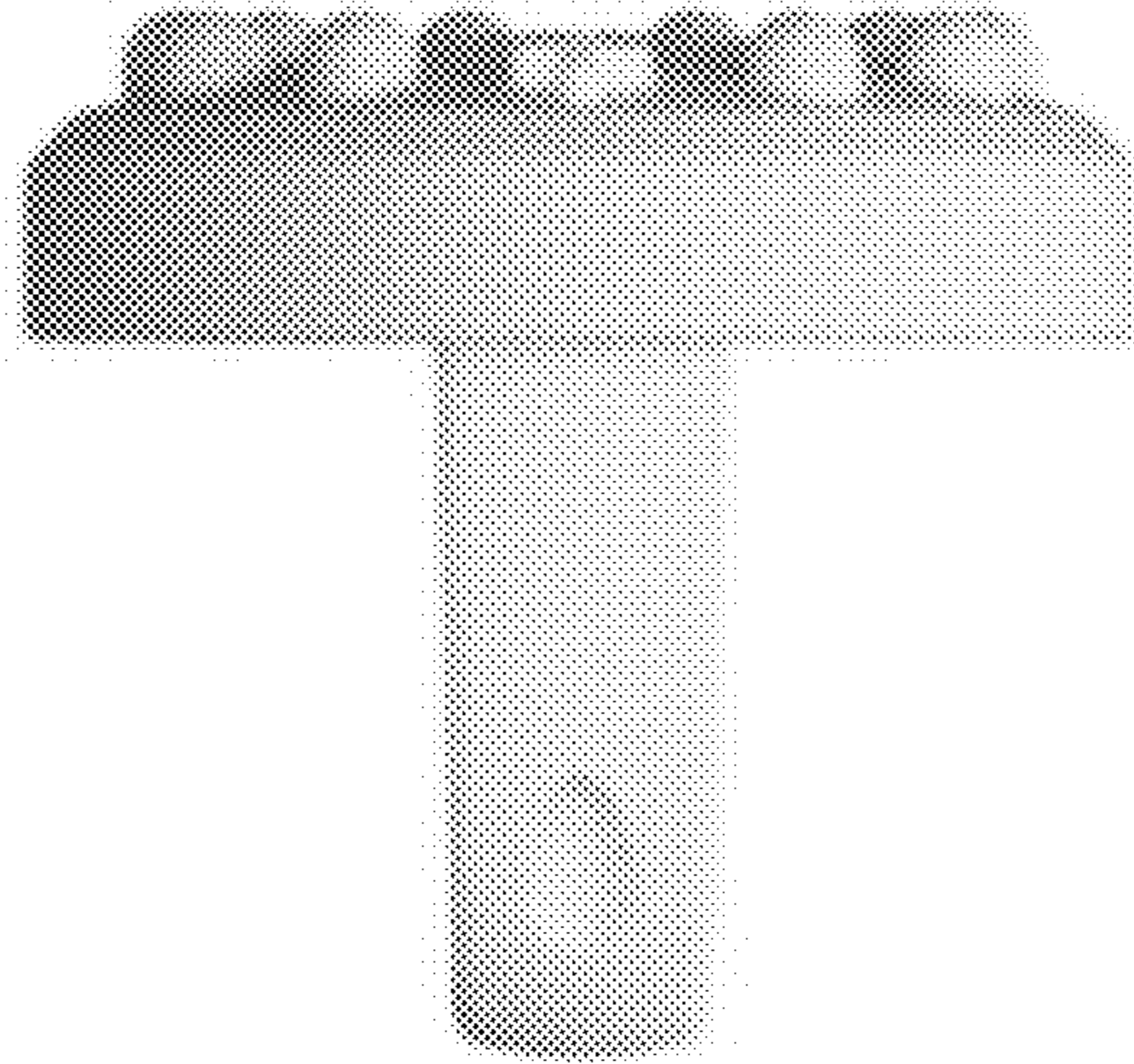

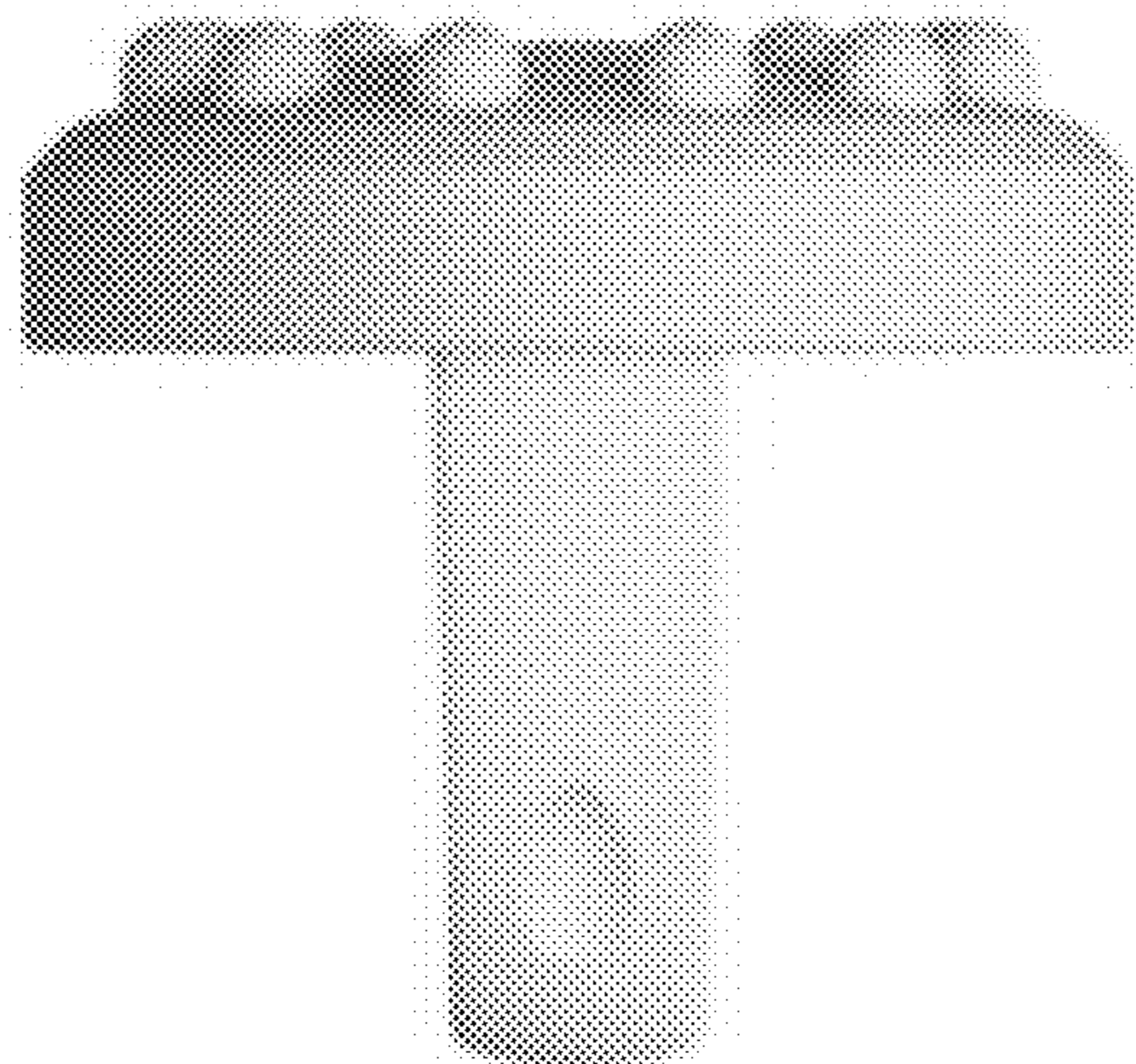
