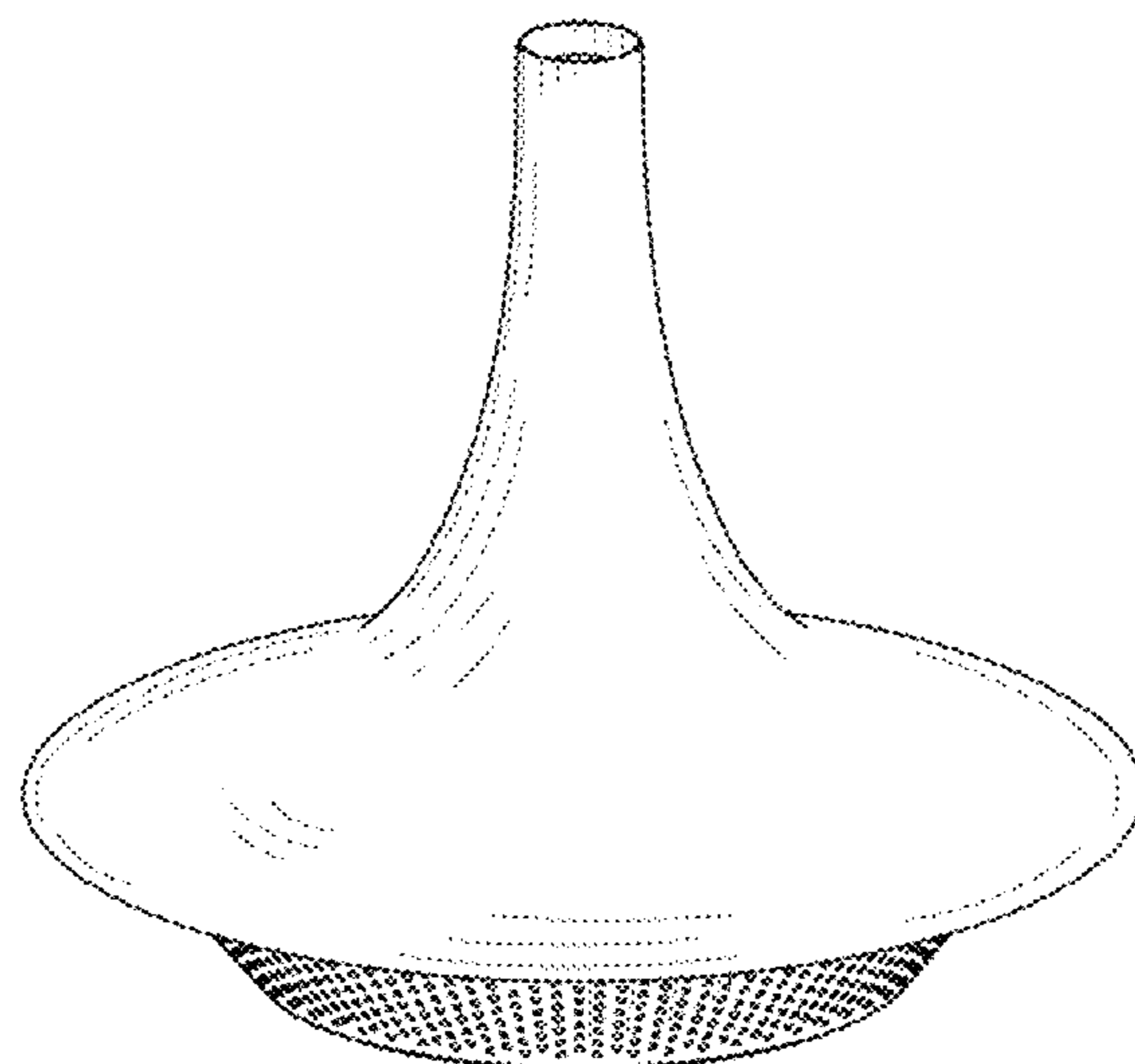
The ornamental design for a speaker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a speaker, showing our new design;

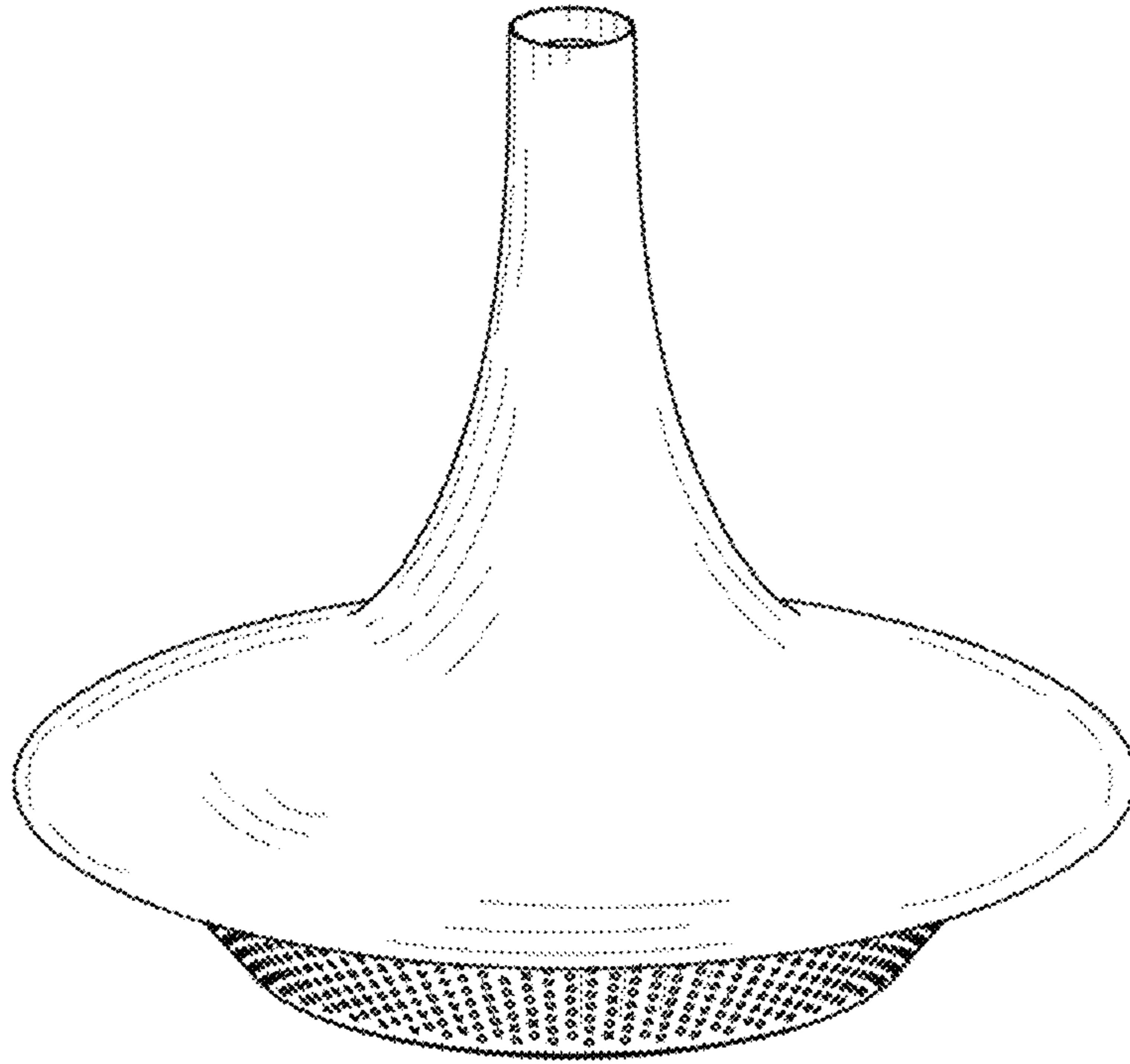

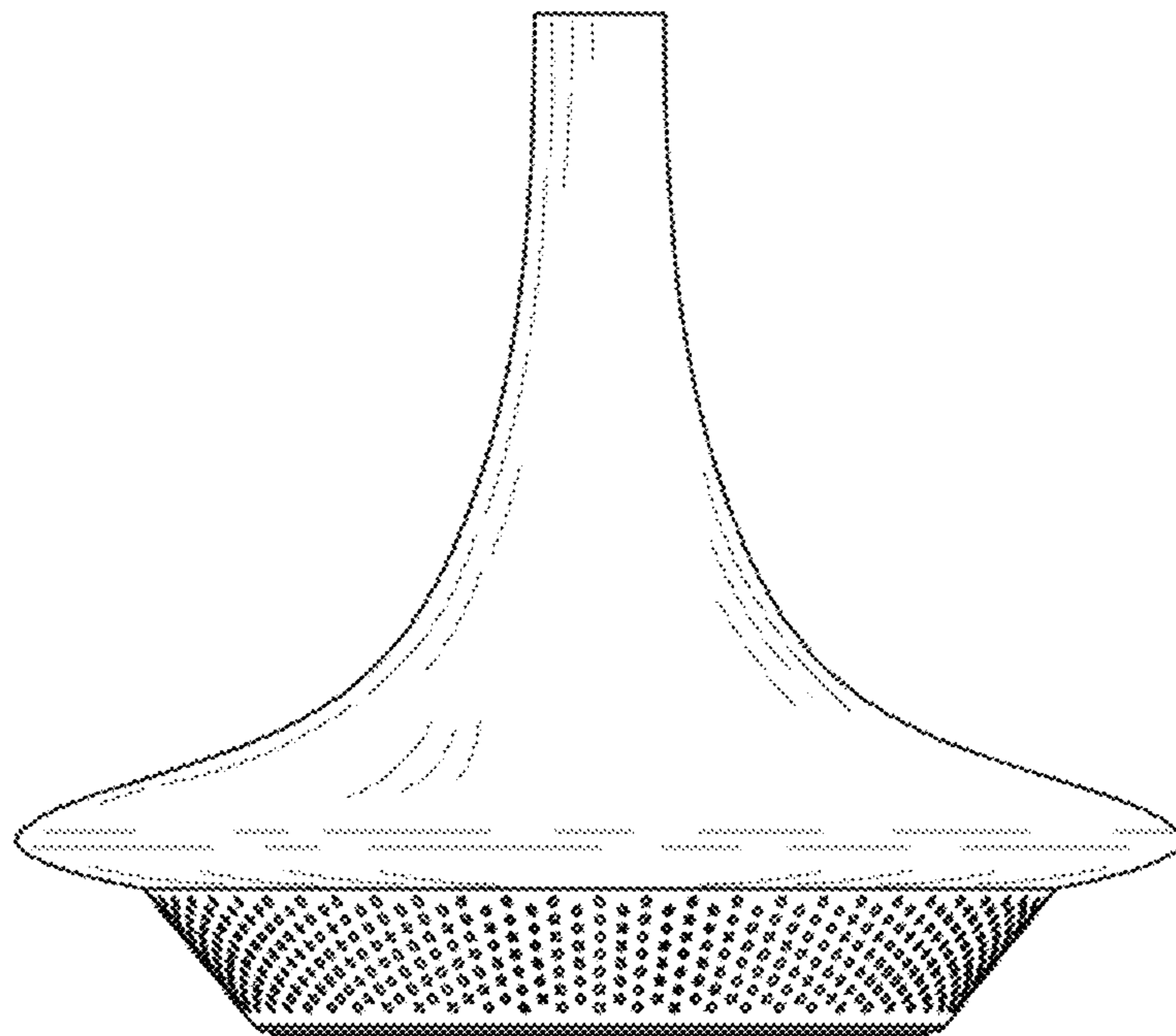

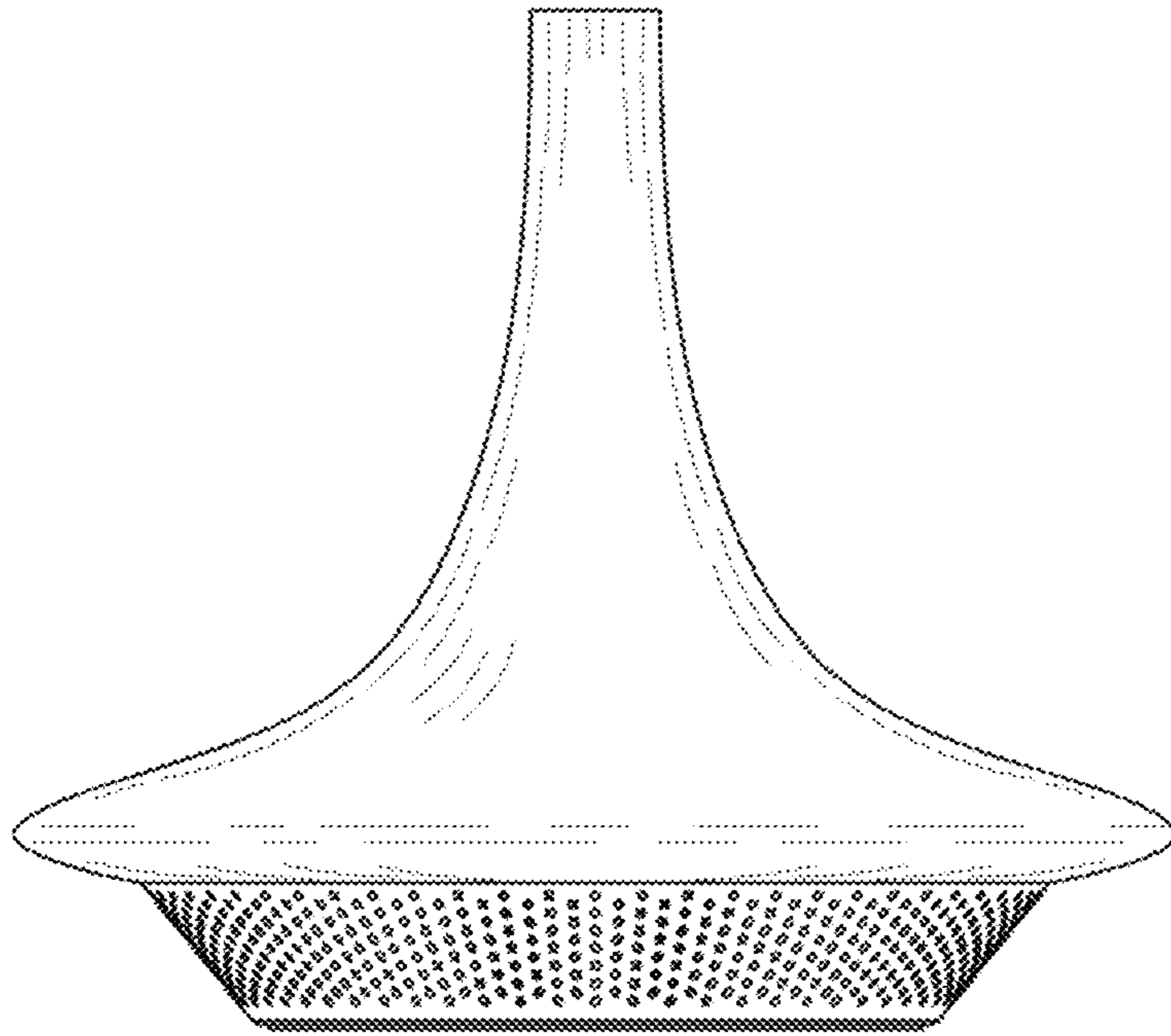

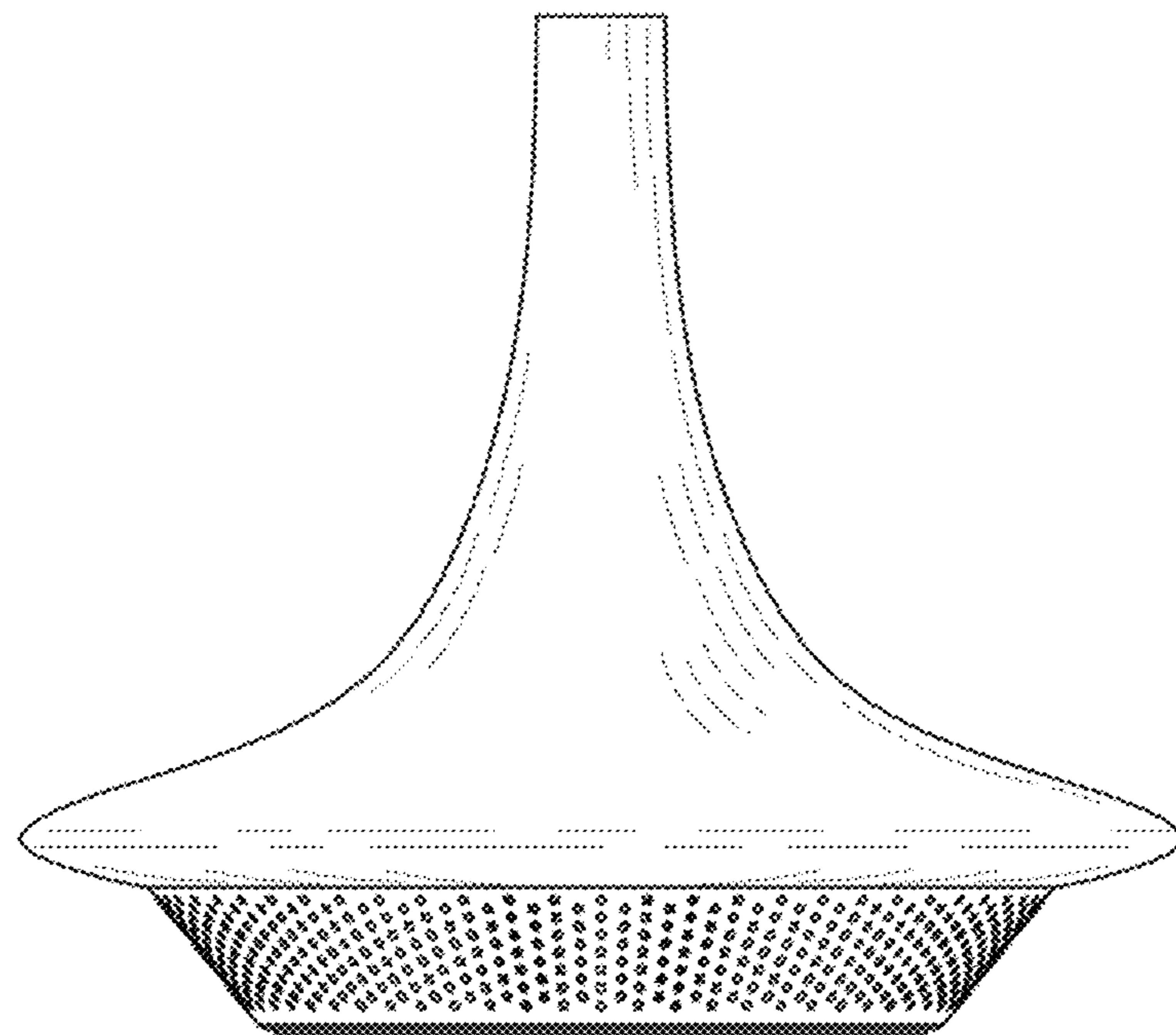

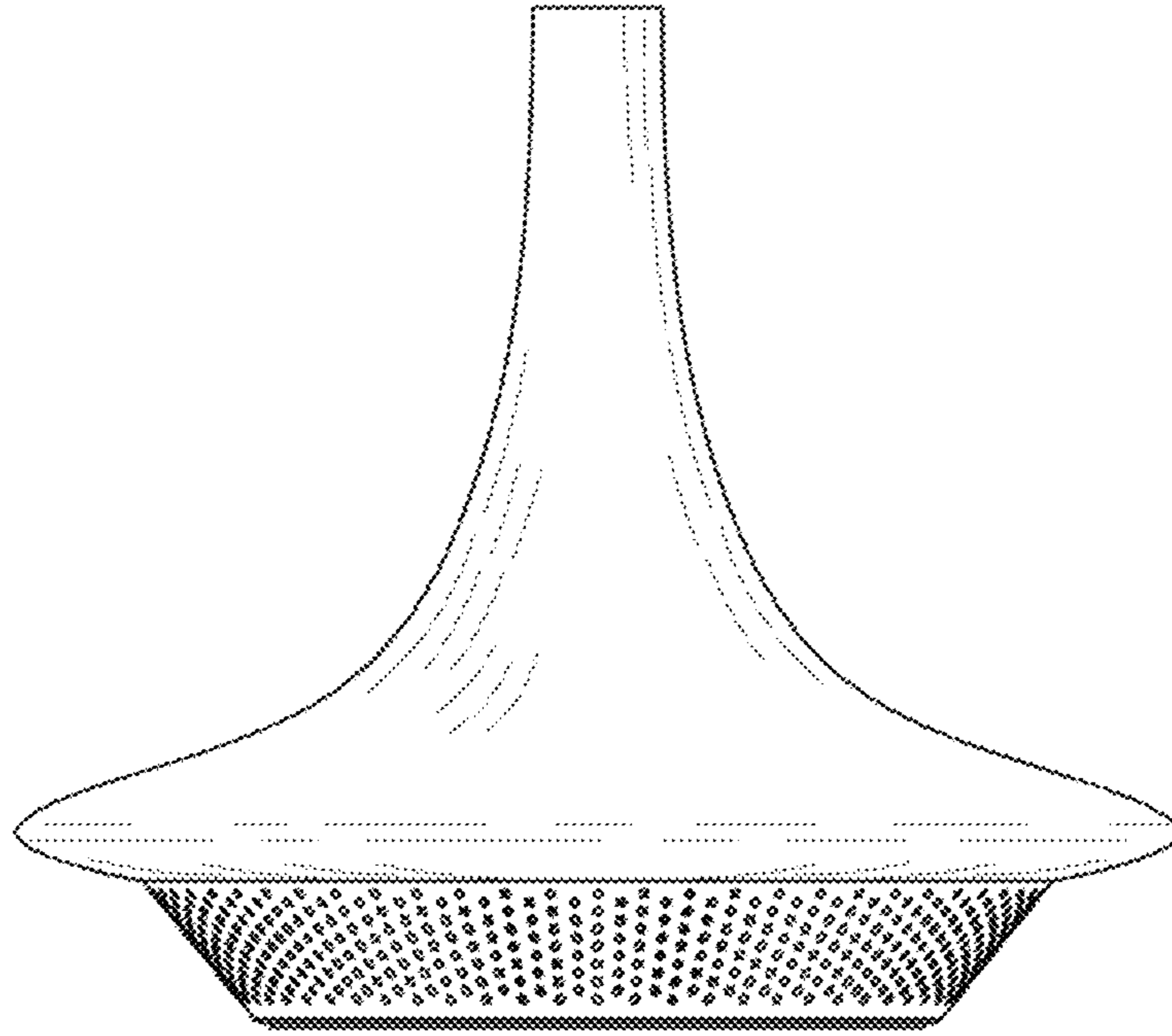

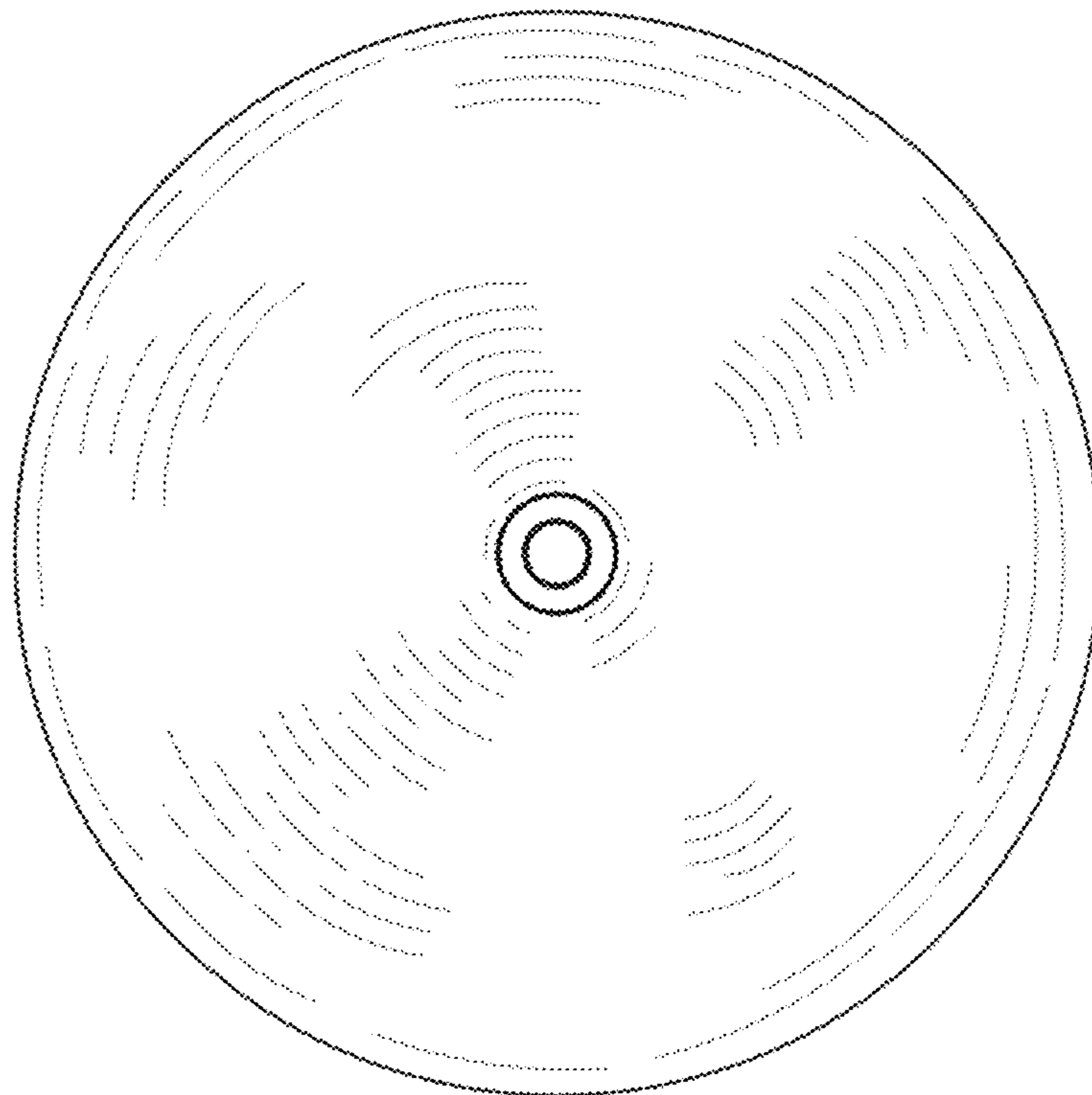

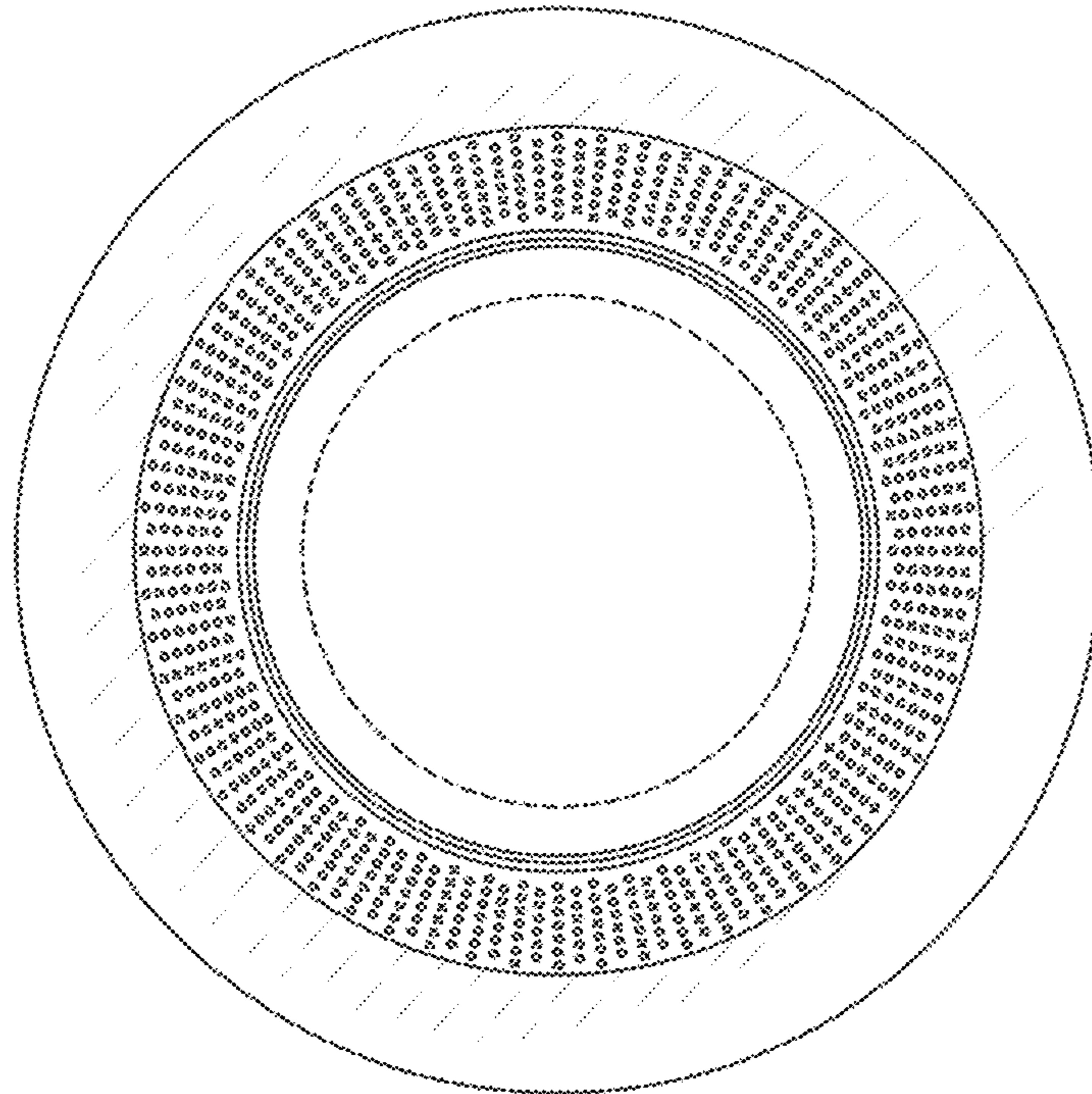
