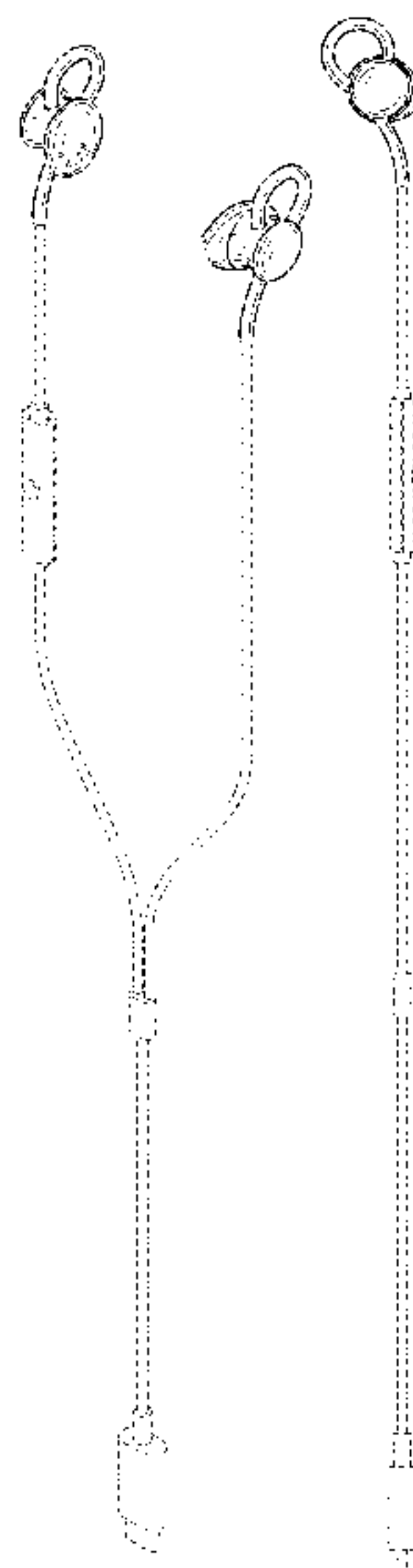
The ornamental design for an audio assembly, as shown and described.

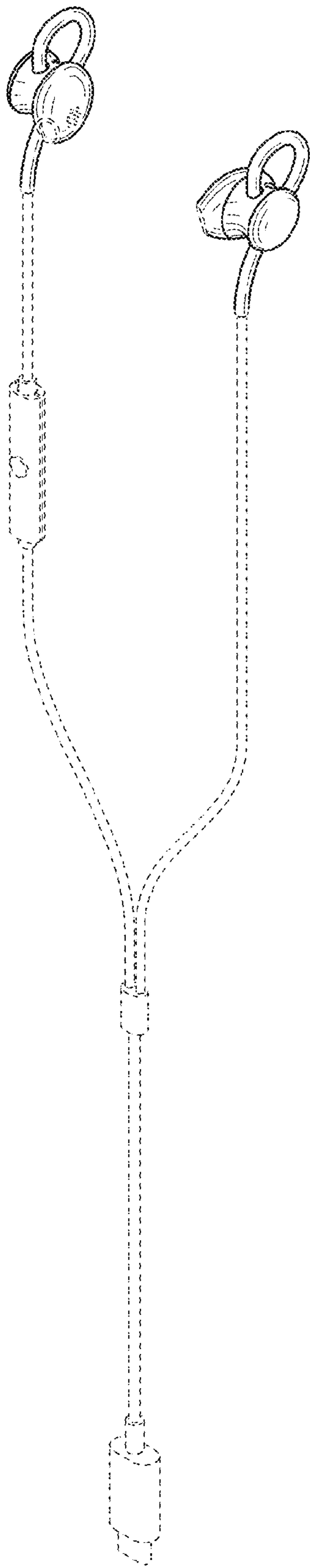

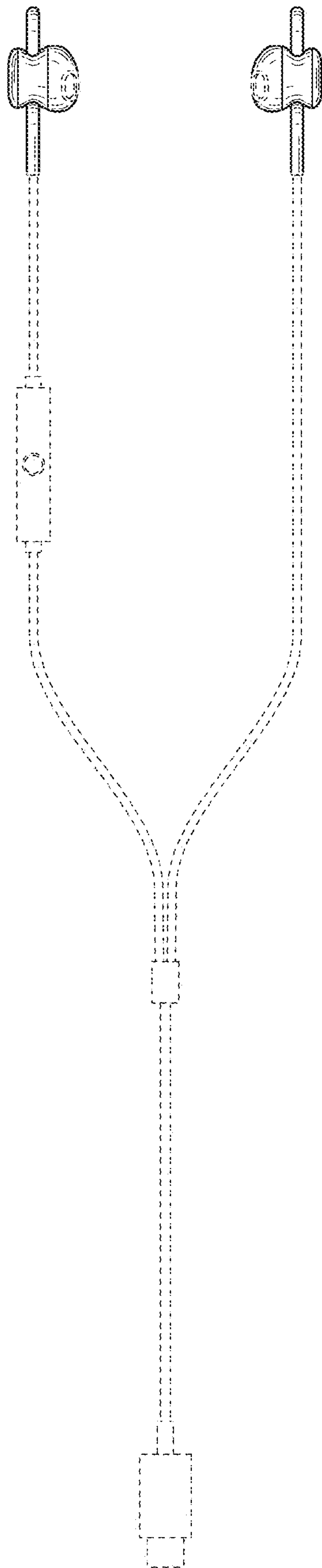

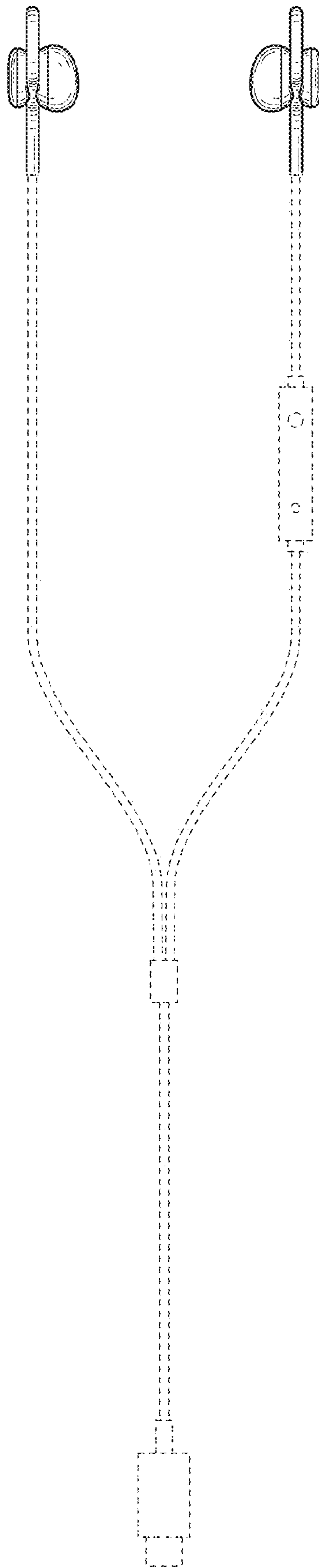

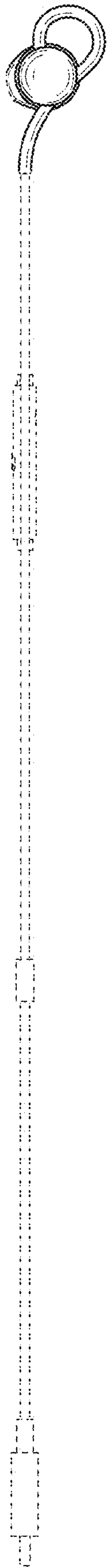

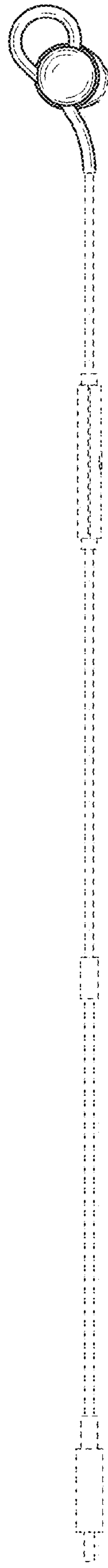

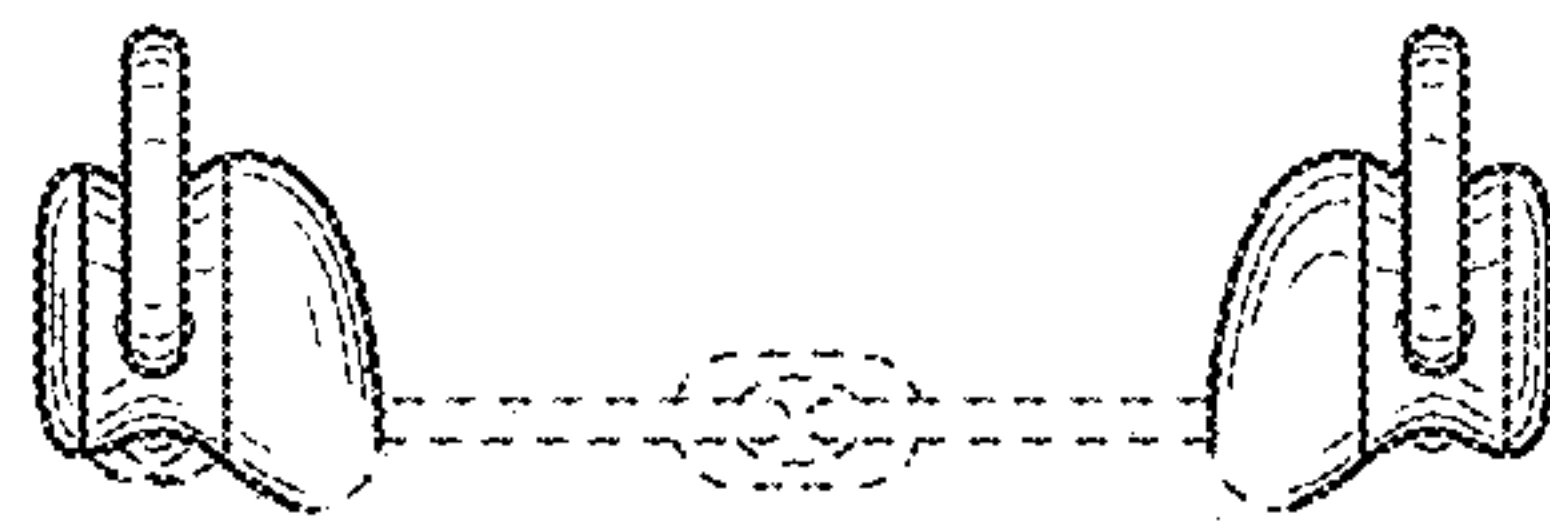

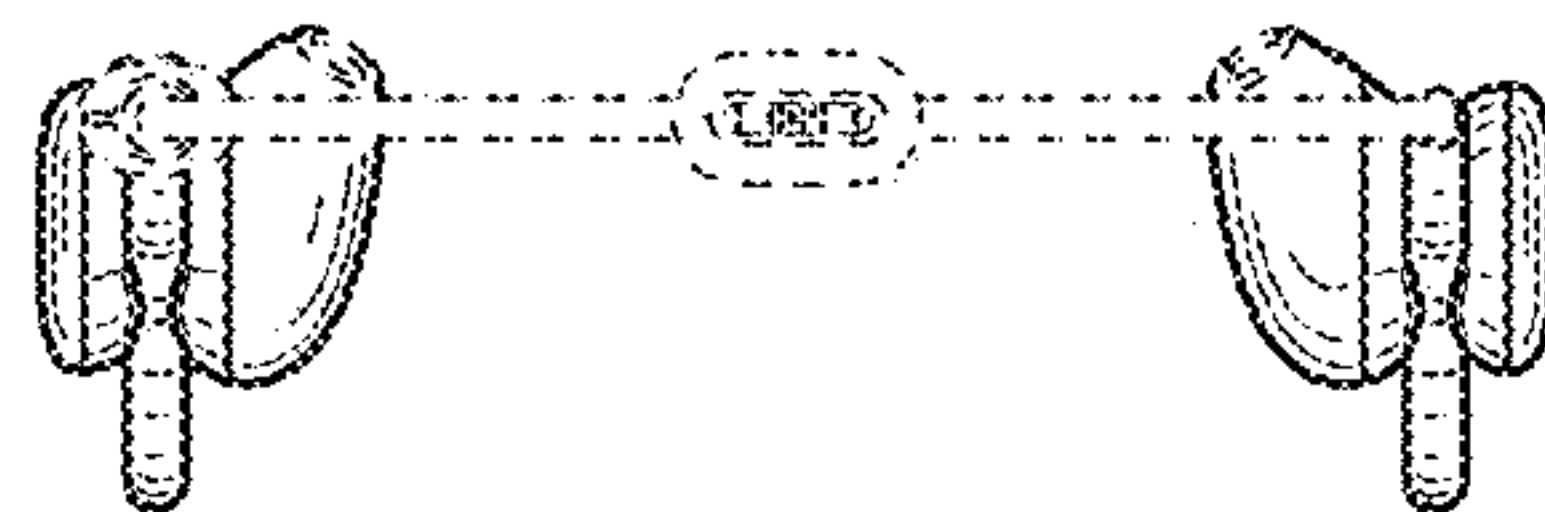
