The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design according to a first embodiment;

FIG. 2 is a front view of a display screen or portion thereof with graphical user interface showing our new design according to a second embodiment;

FIG. 4 is a front view of a display screen or portion thereof with graphical user interface showing our new design according to a fourth embodiment;

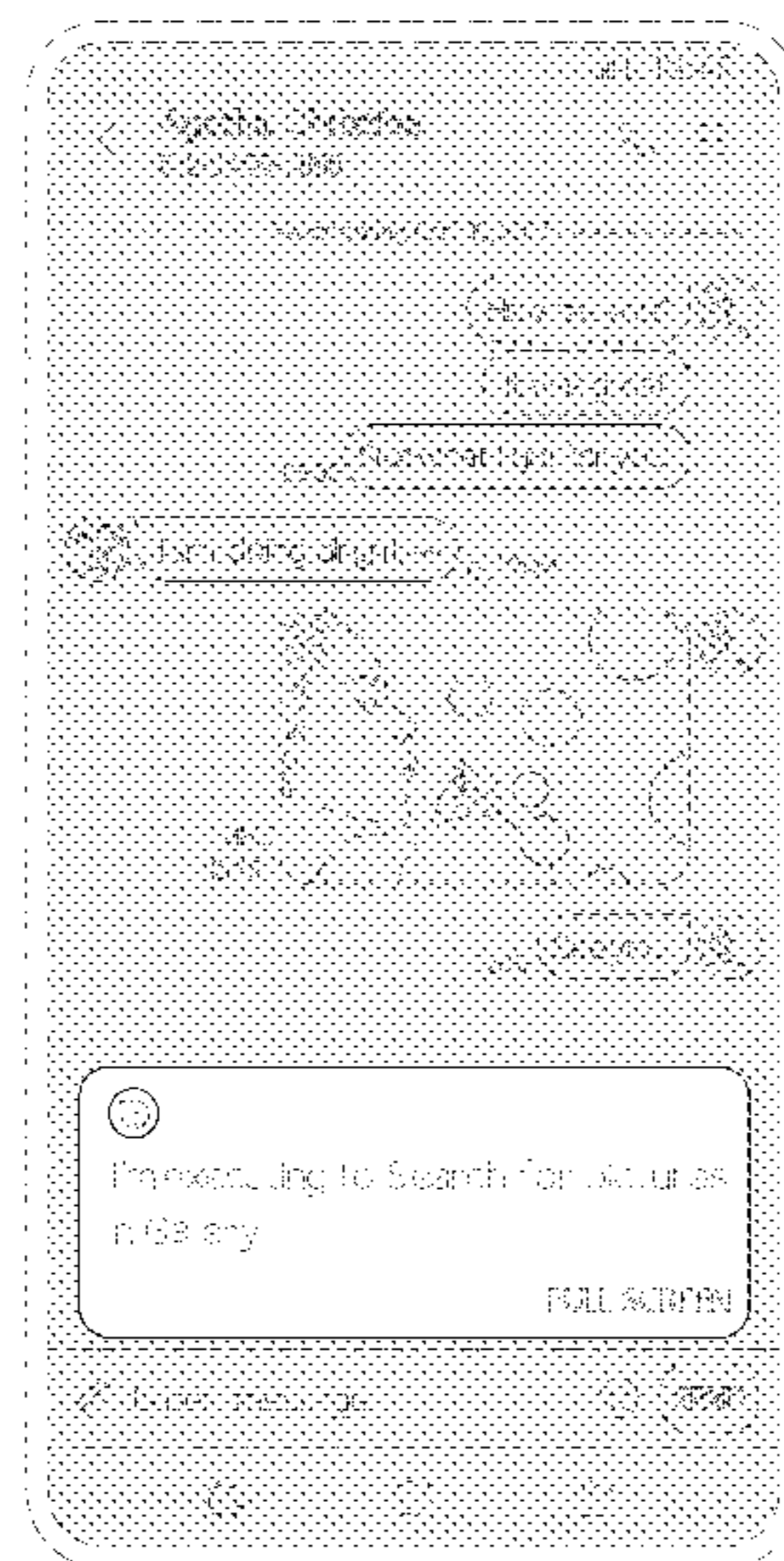
FIG. 5 is a front view of a display screen or portion thereof with graphical user interface showing our new design according to a fifth embodiment;

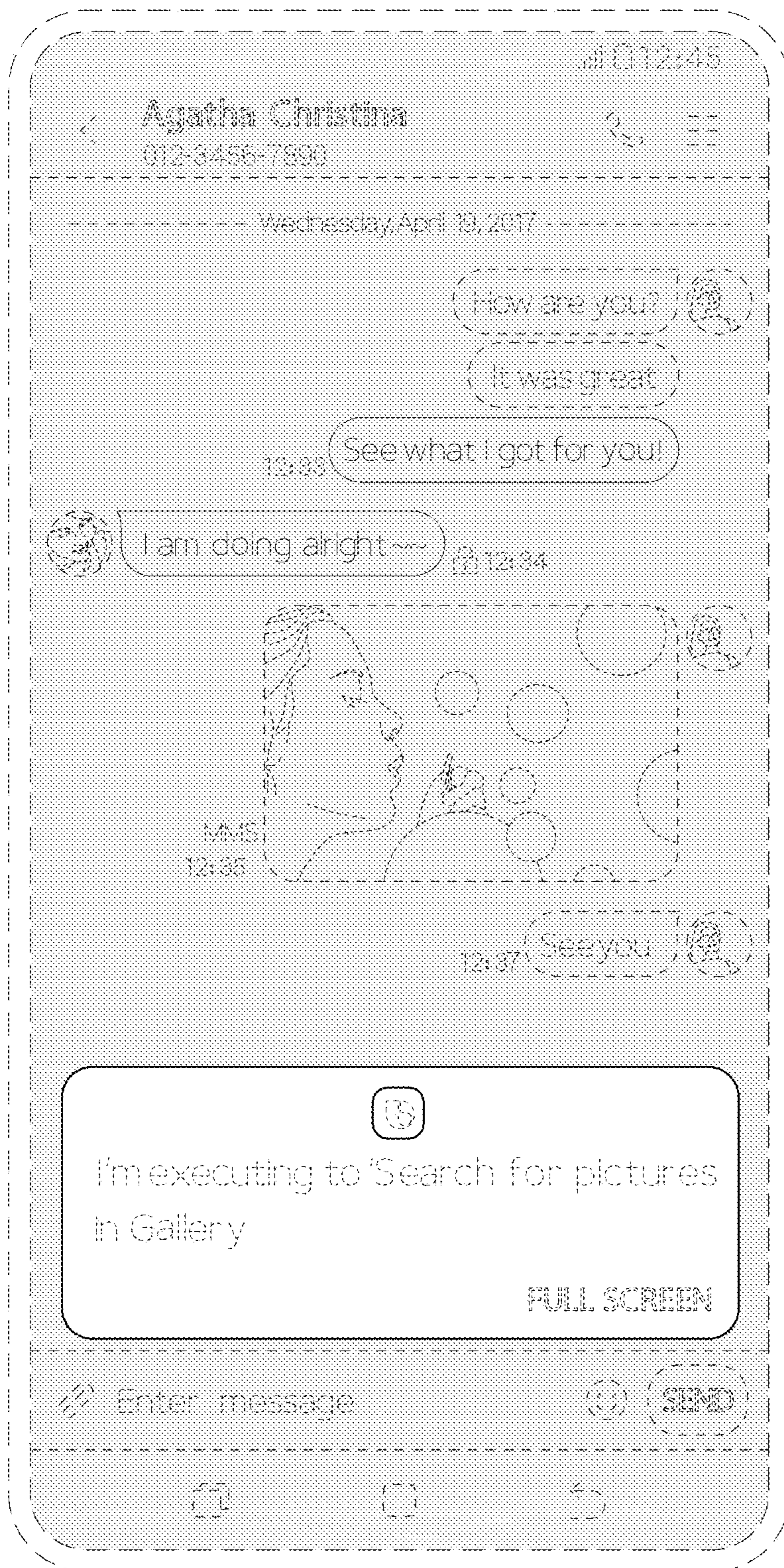
