The ornamental design for a refrigerator, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a refrigerator, showing our new design;
FIG. 2 is a front view thereof;

FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;

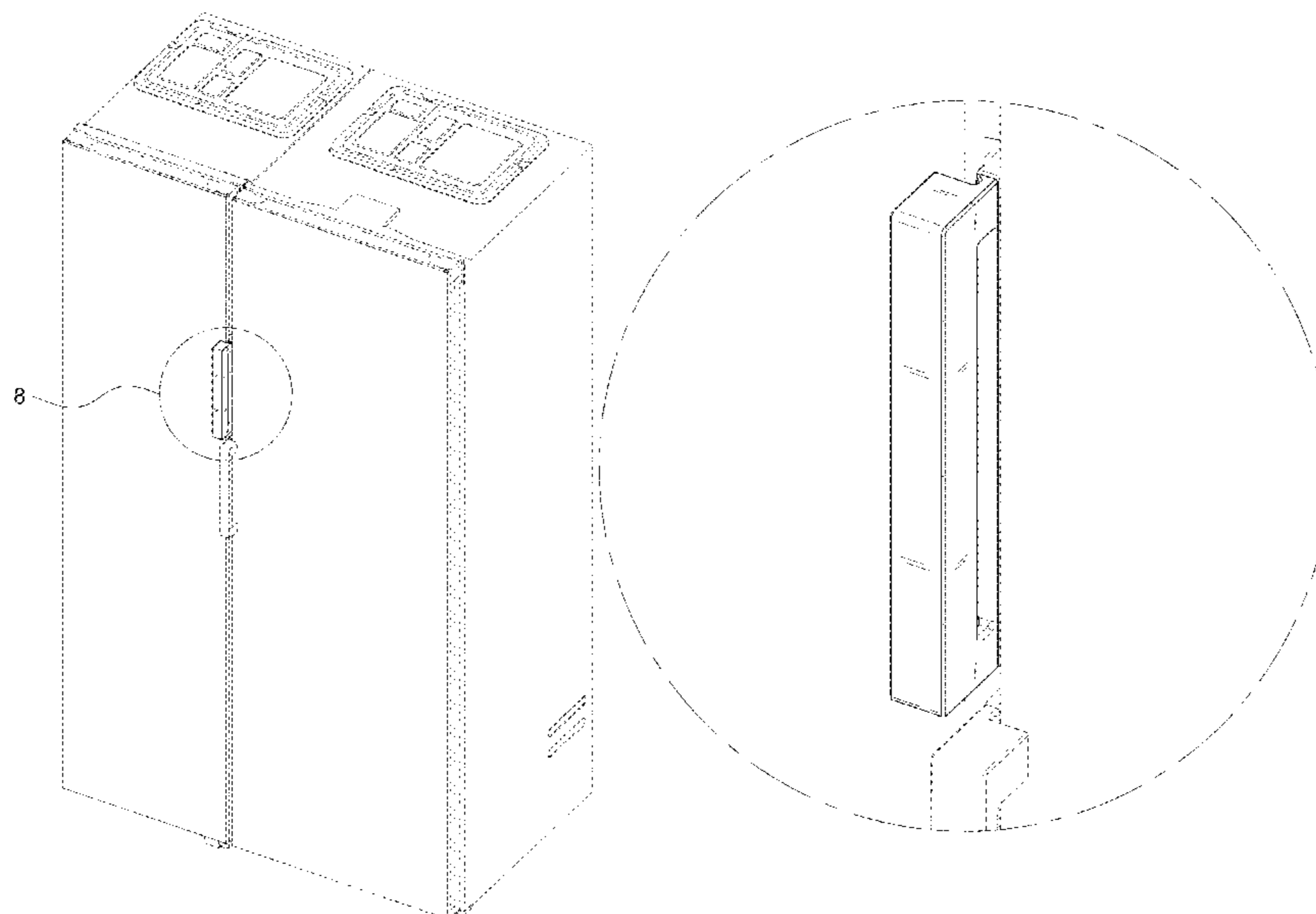

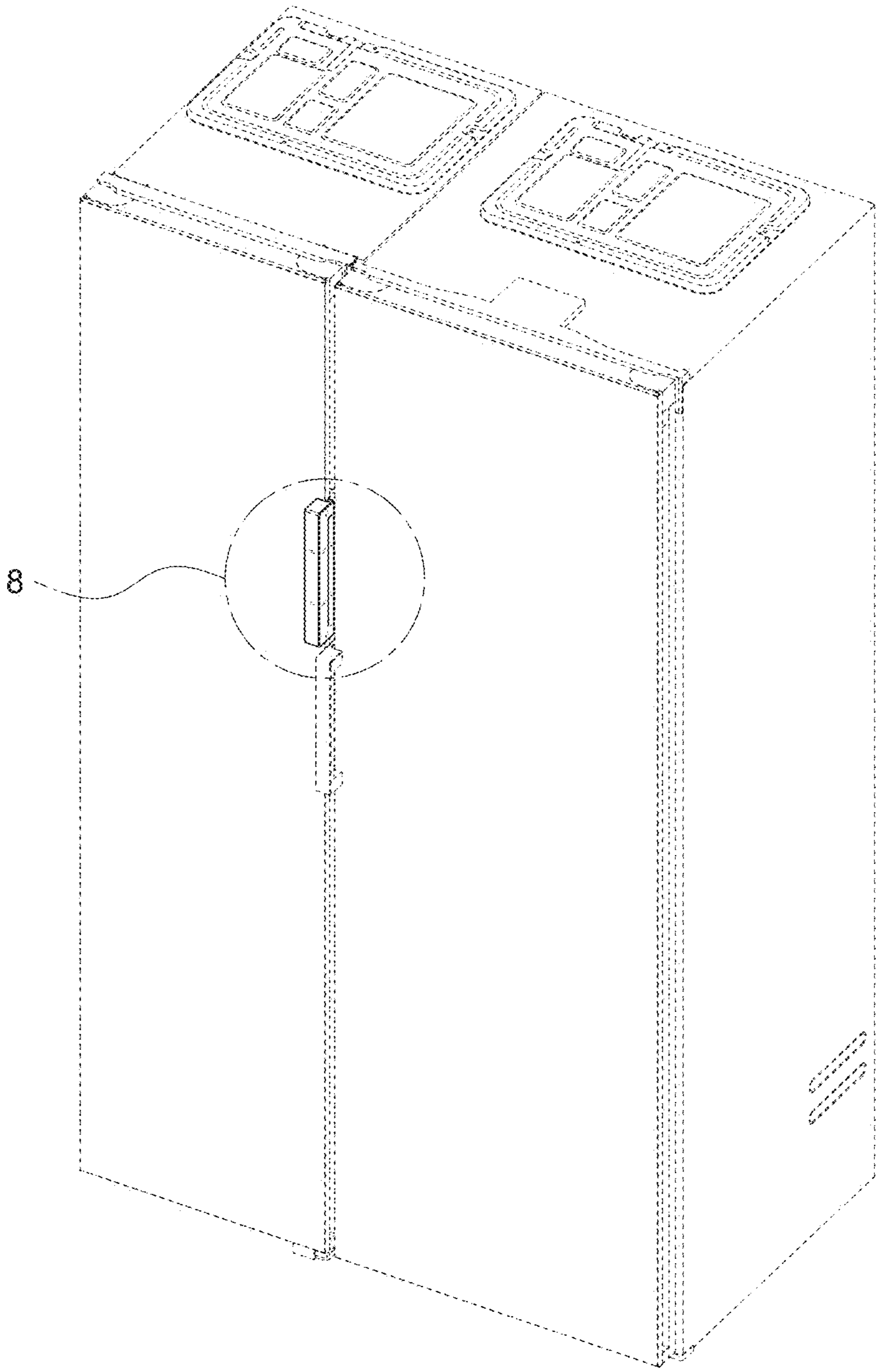

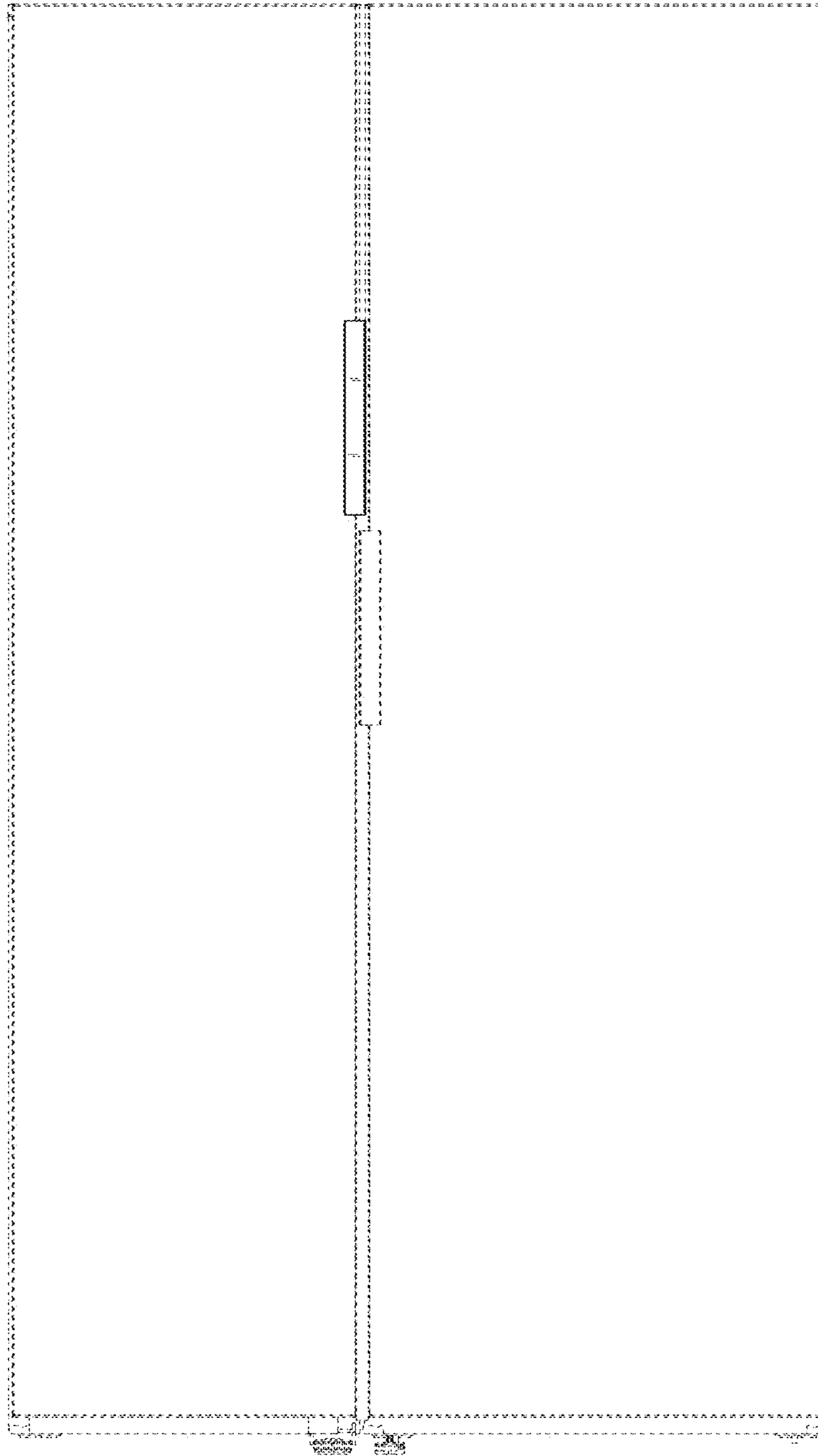

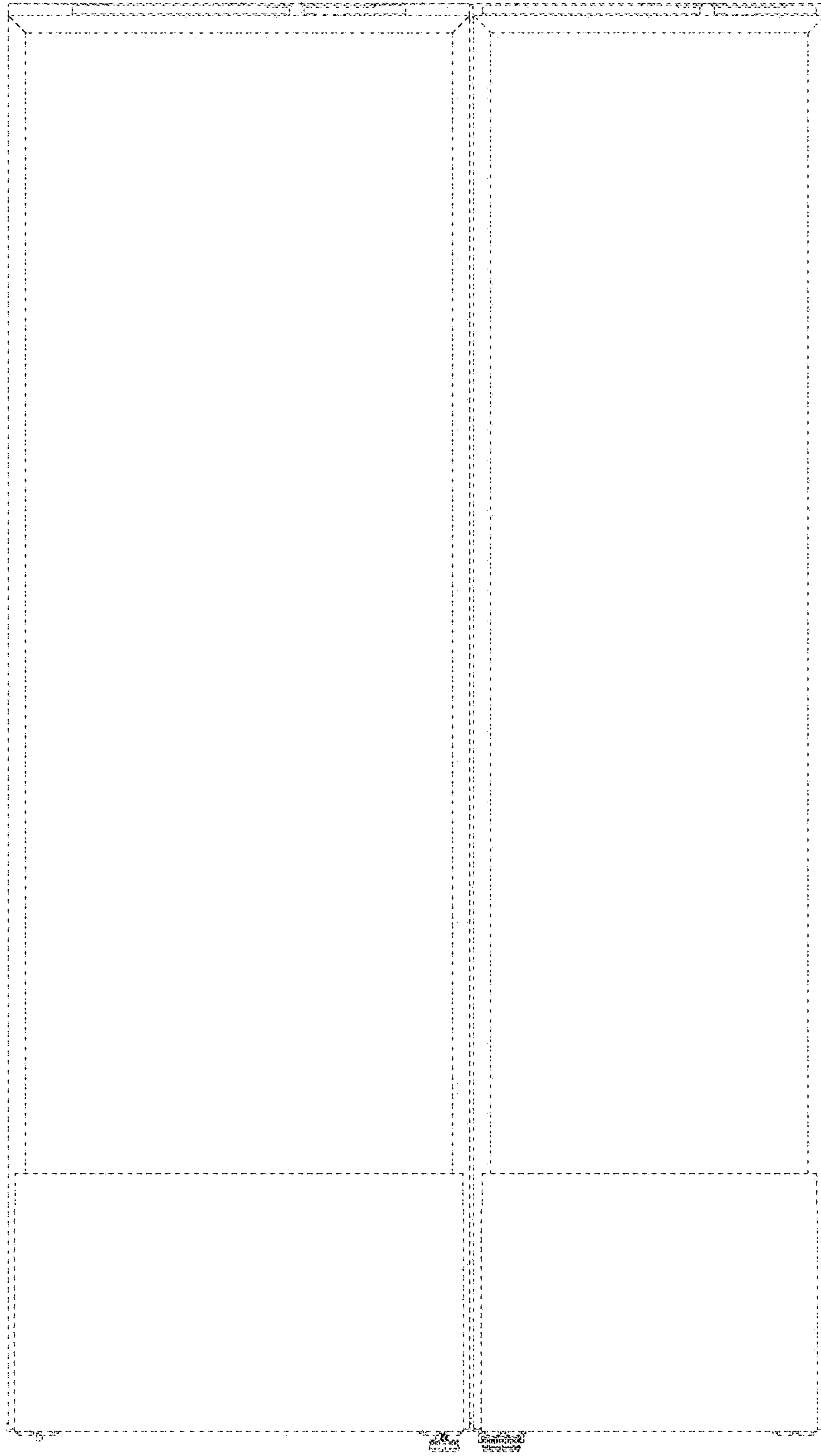

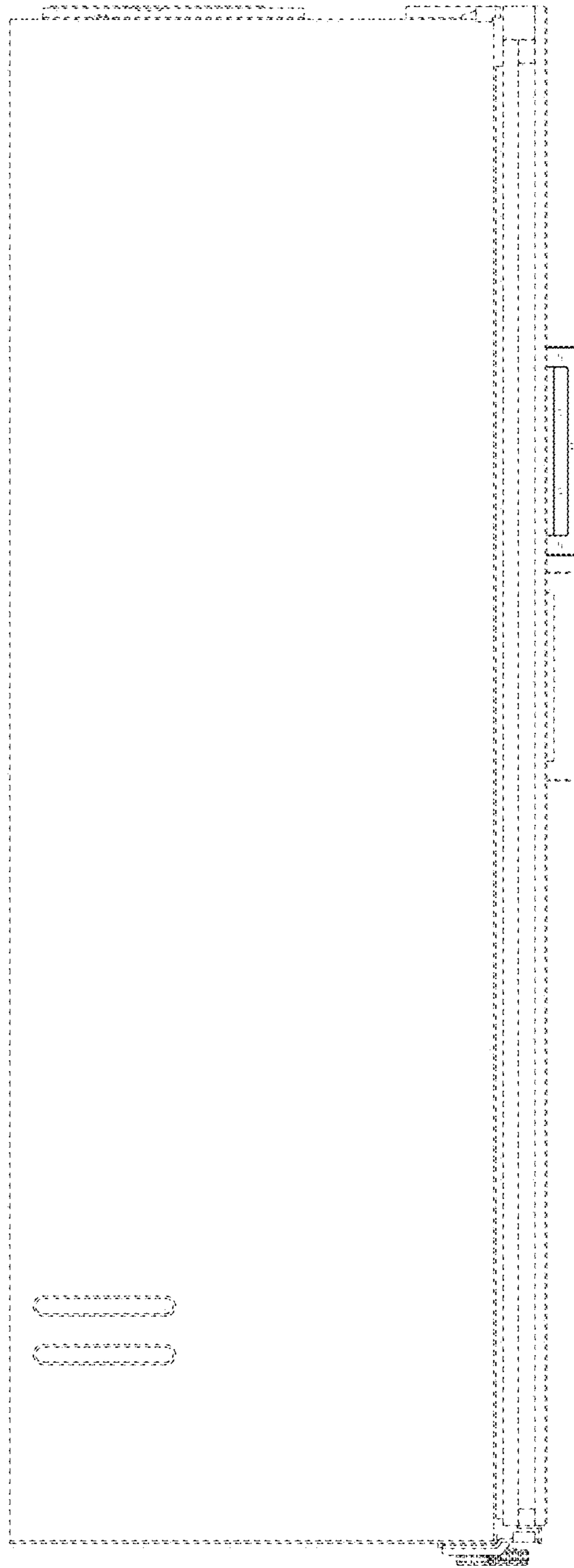

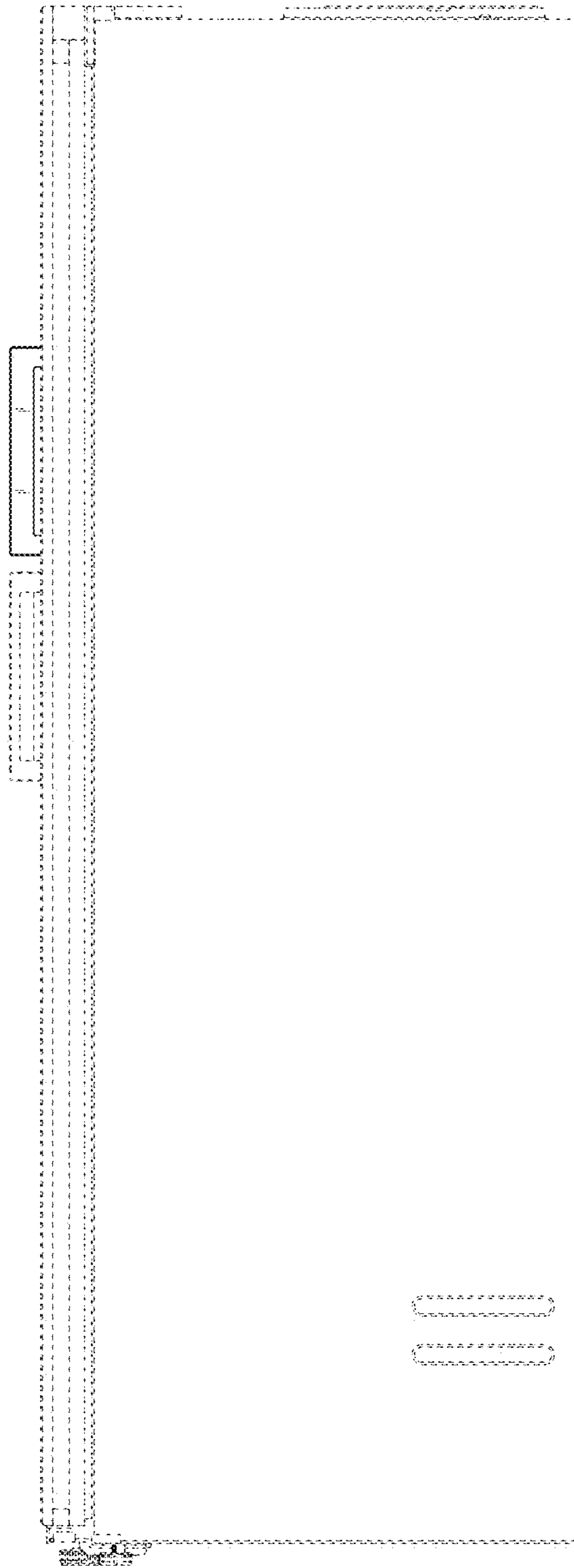

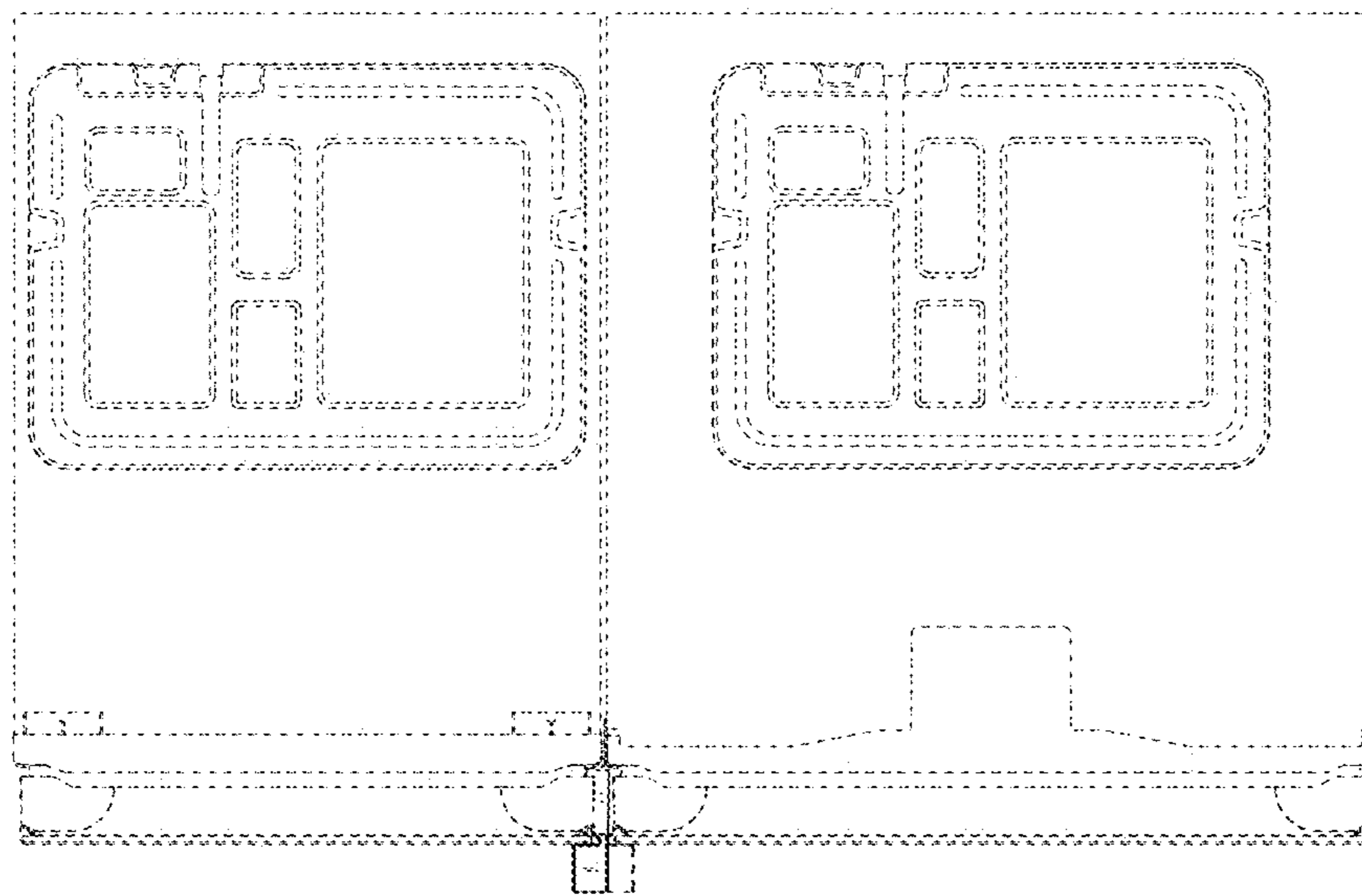

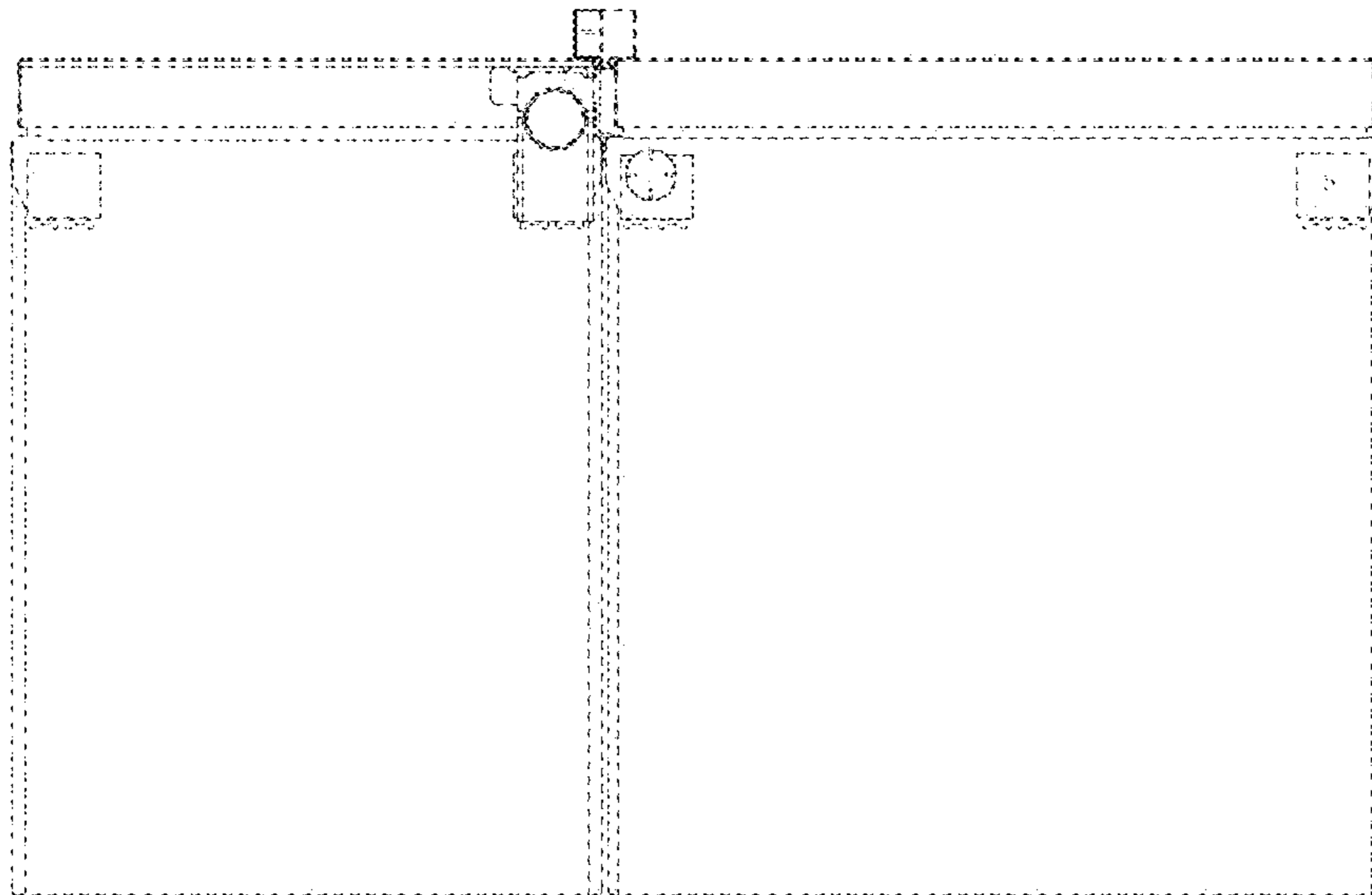
