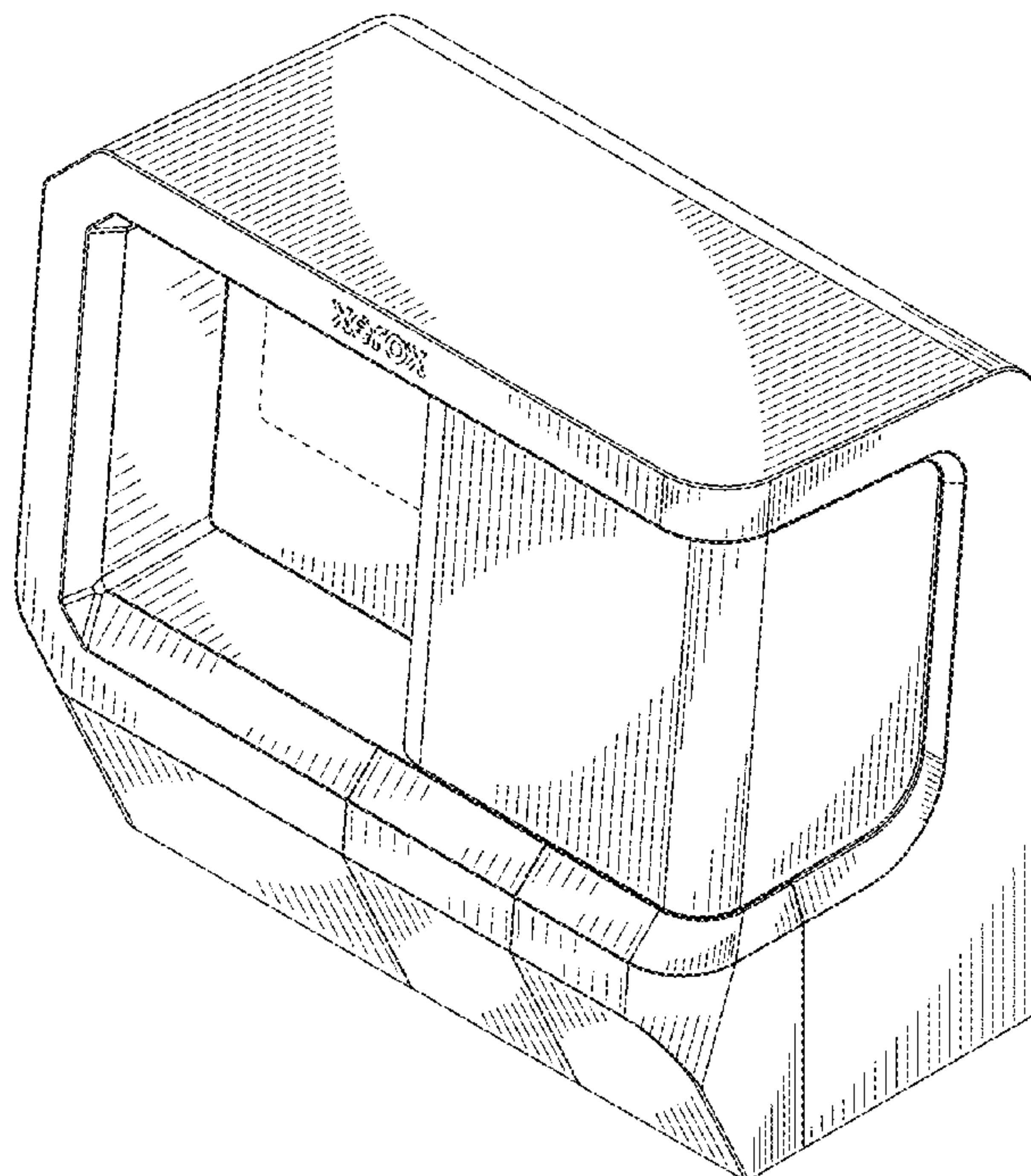
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view from the front of a 3D printer
in accordance with the present invention;

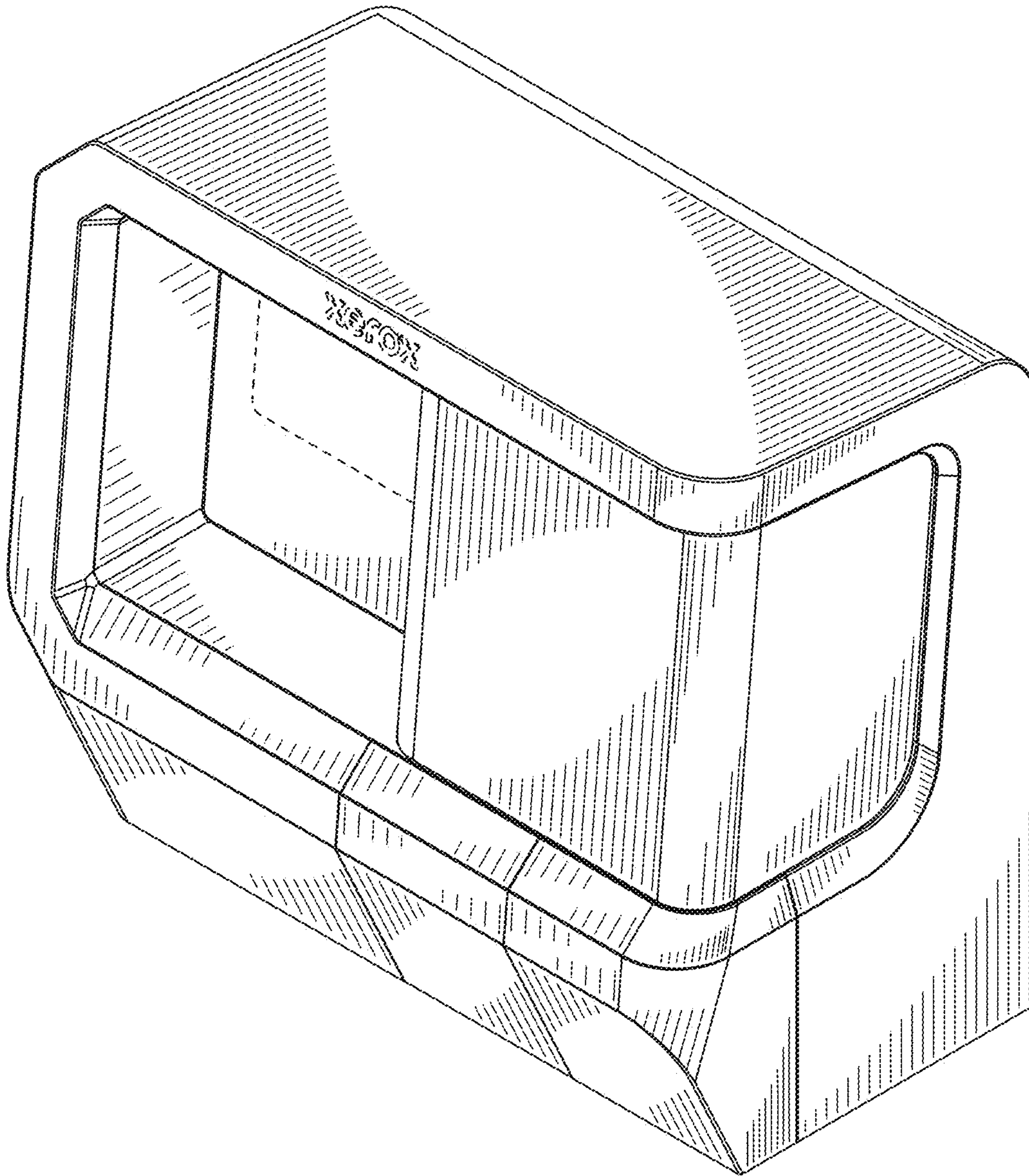

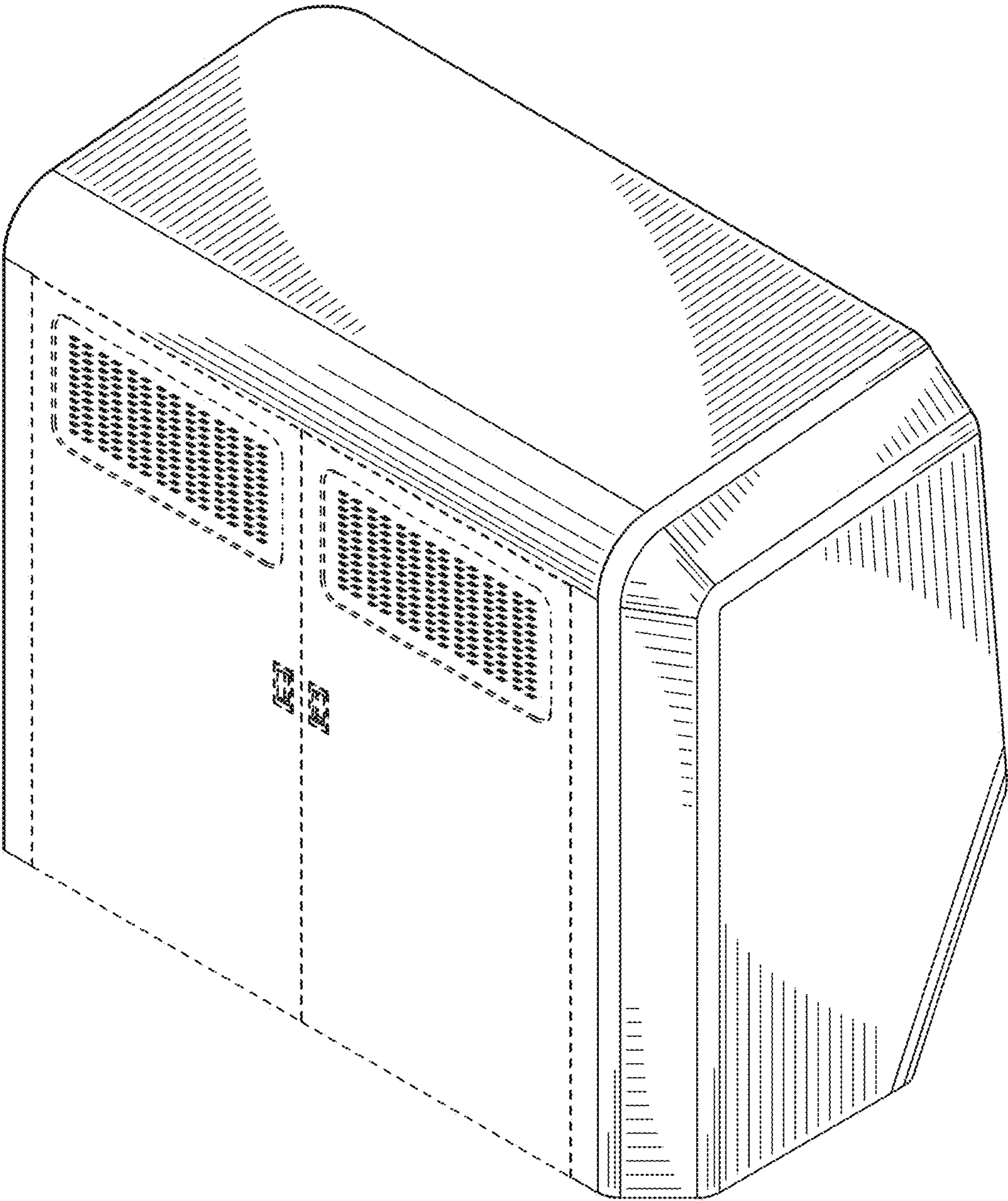

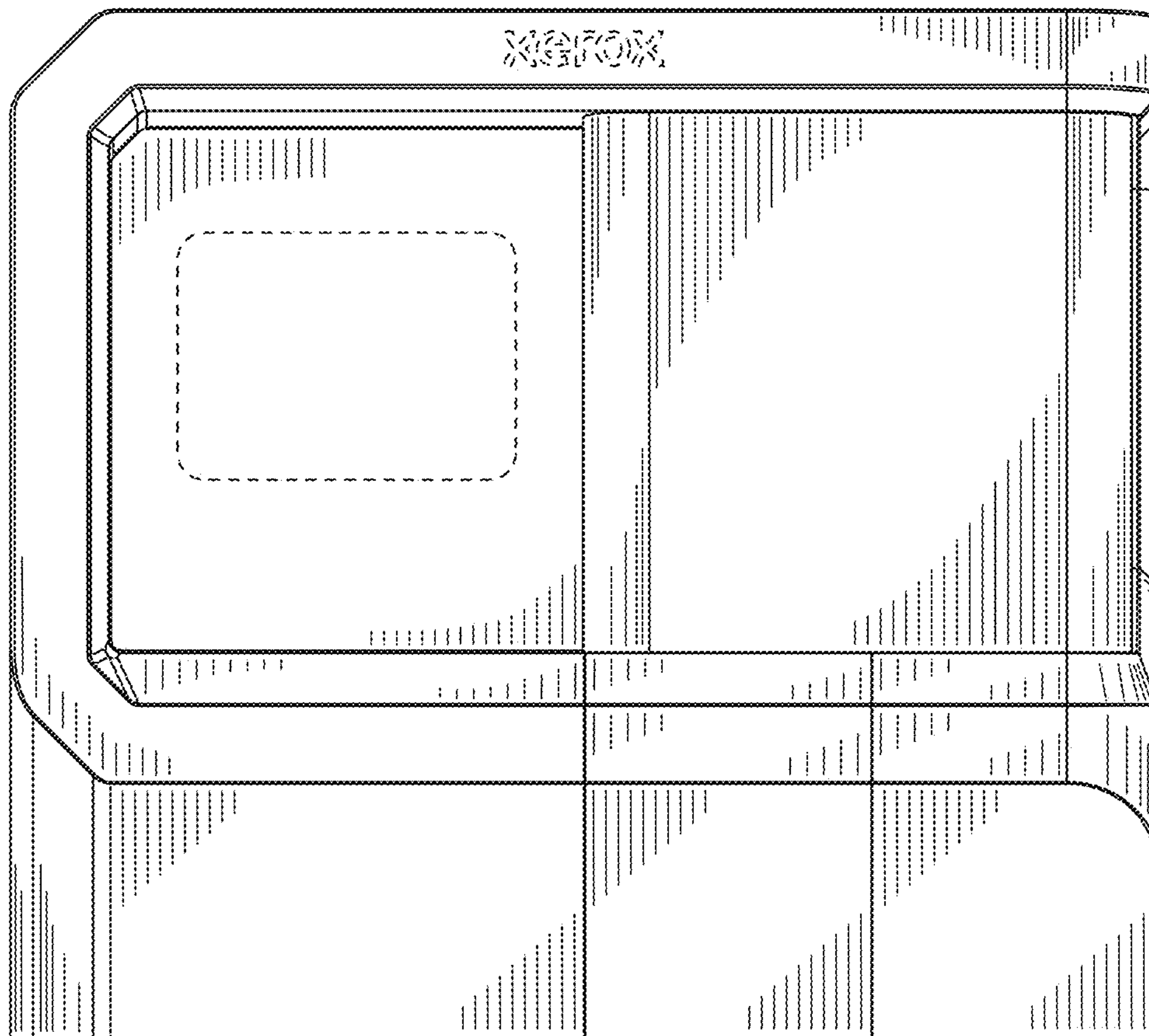

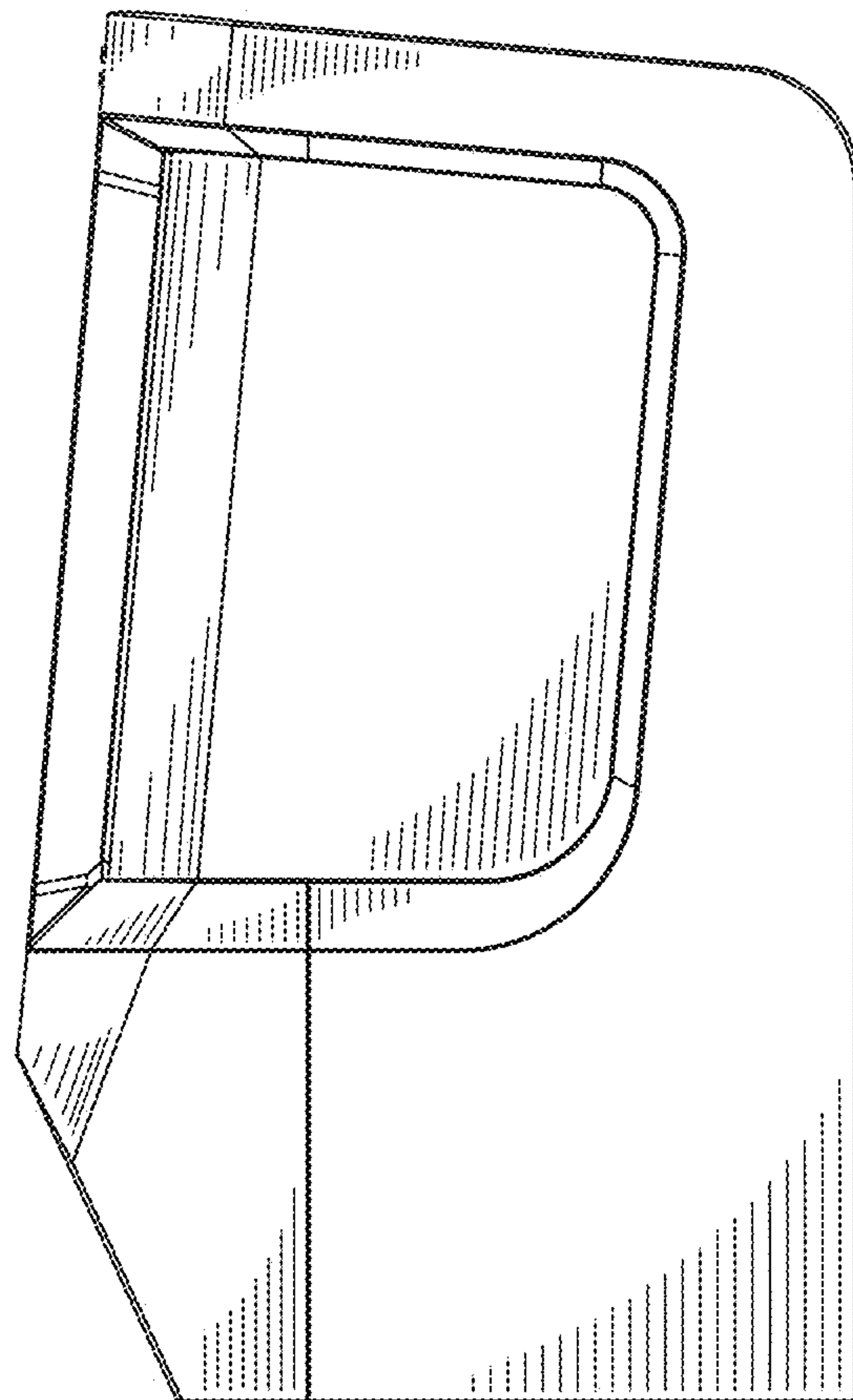

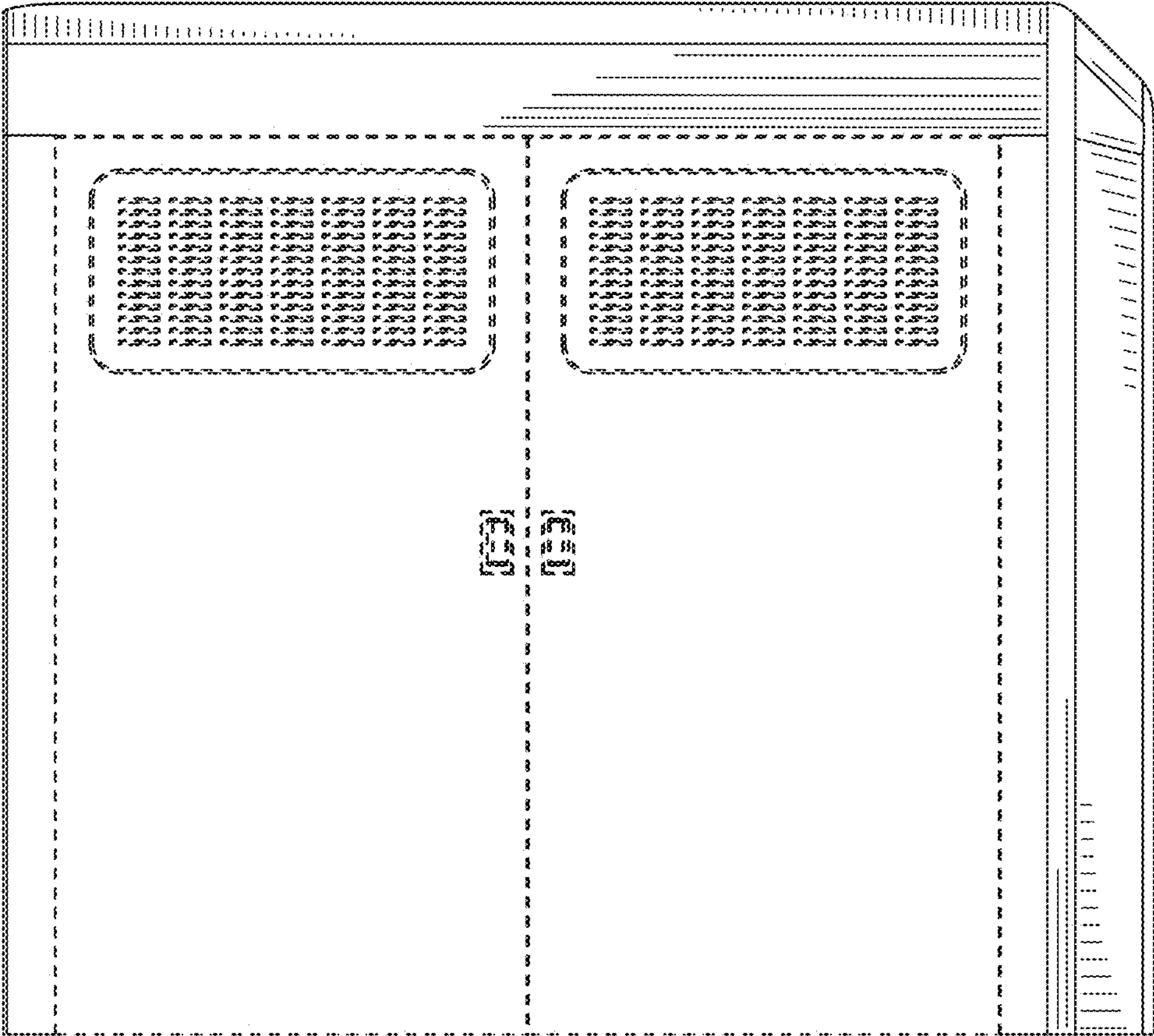

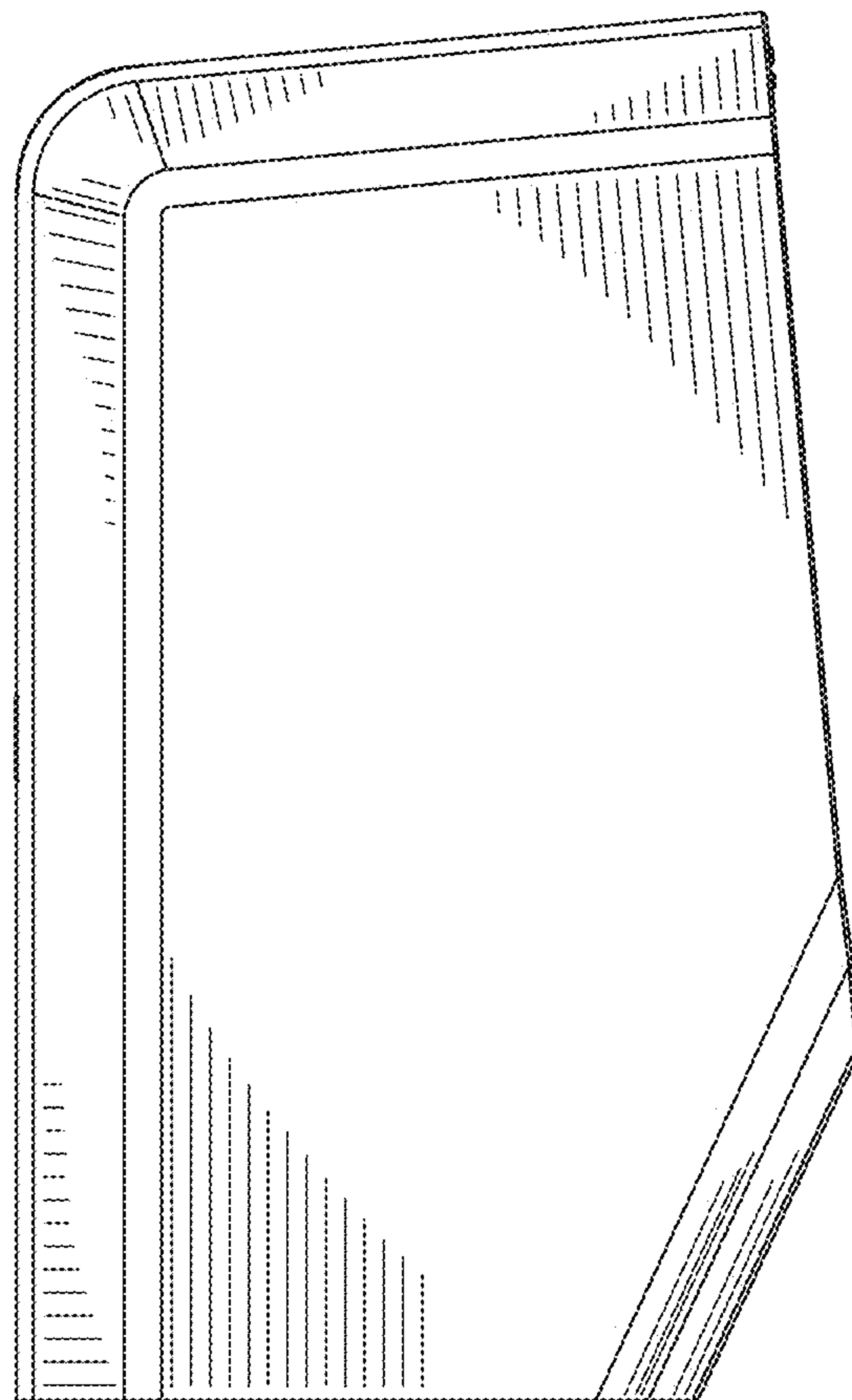

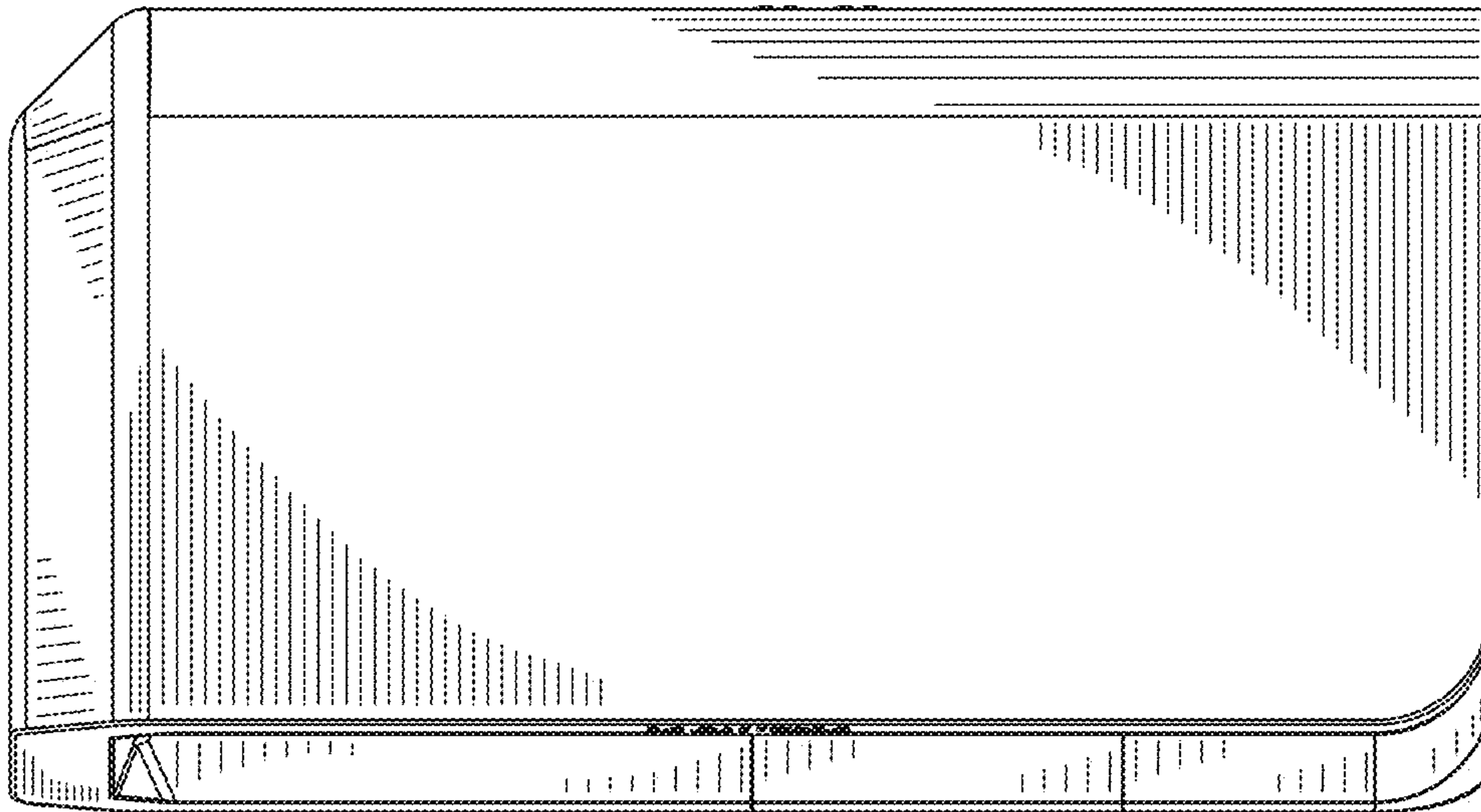

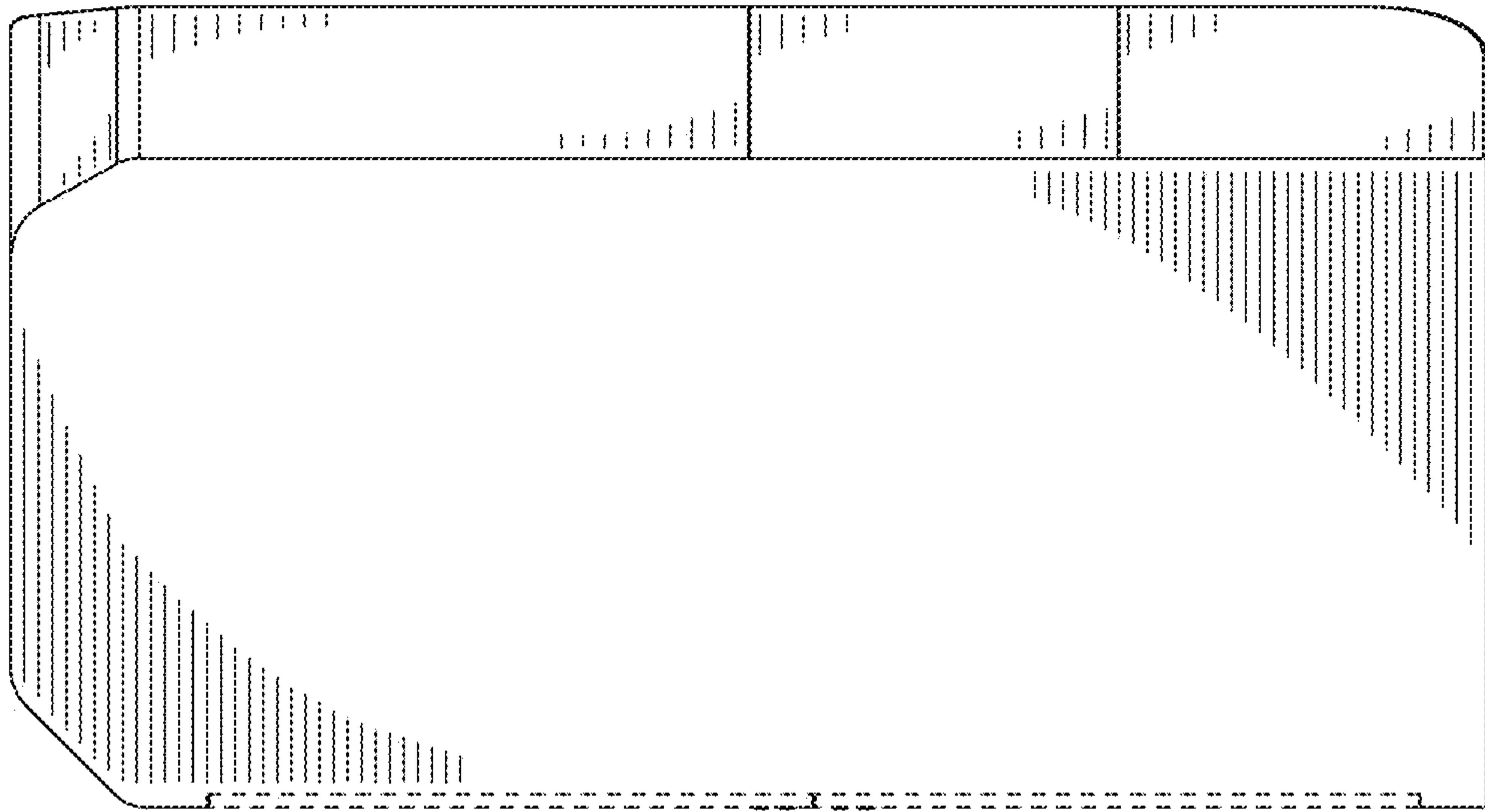
