(57) **CLAIM**

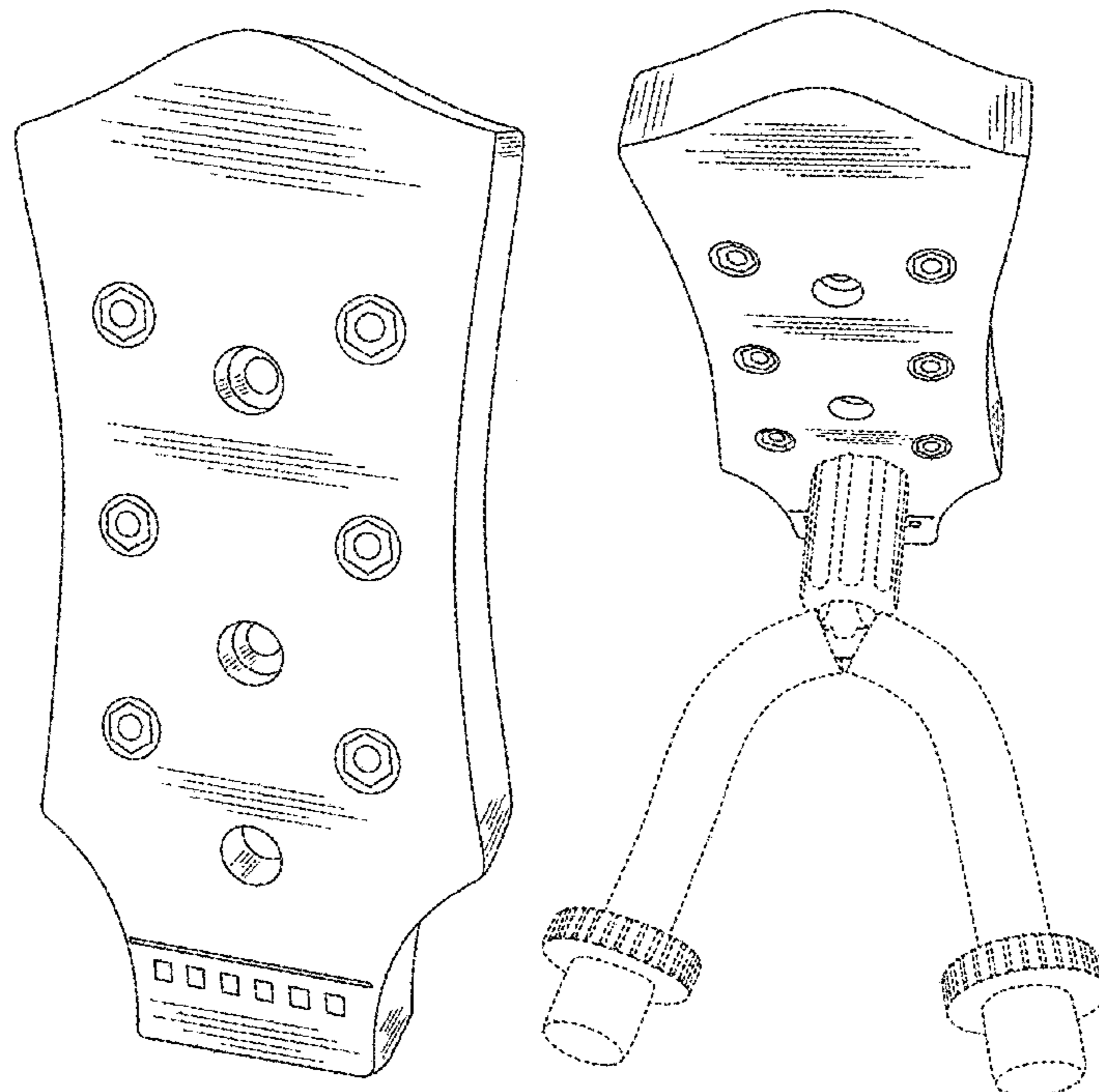
The ornamental design for a hanger base for guitar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hanger base for guitar showing my new design;

 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof;

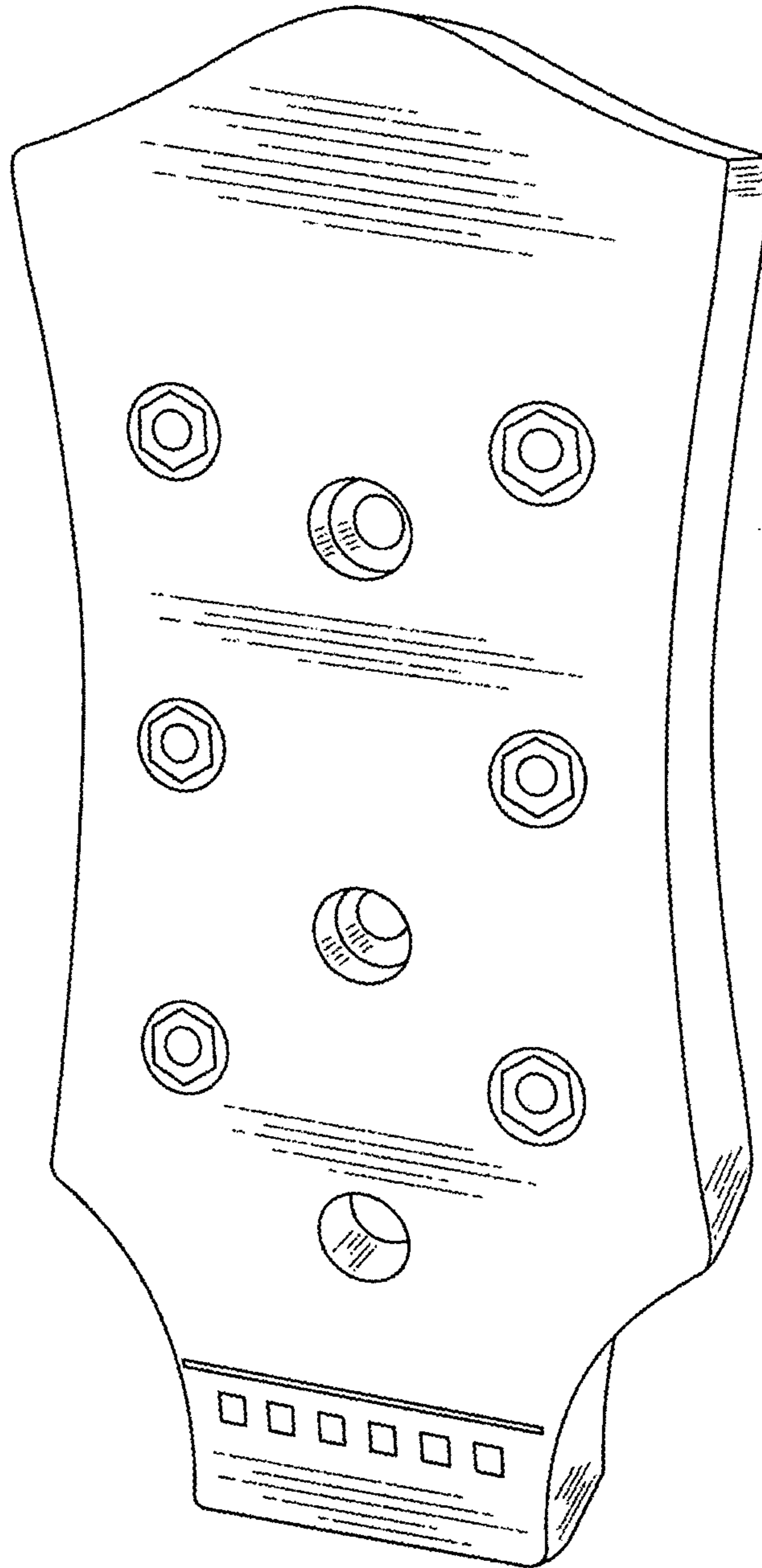

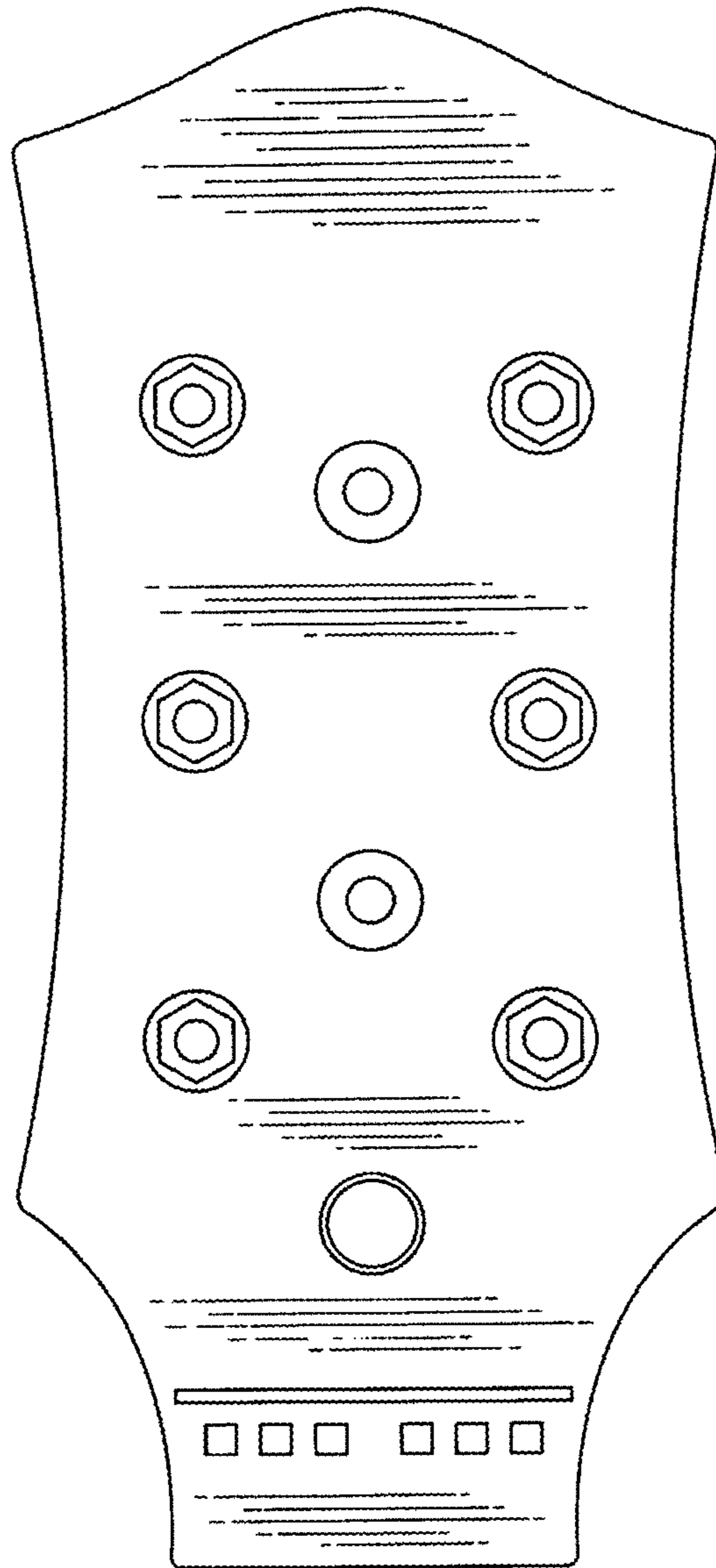

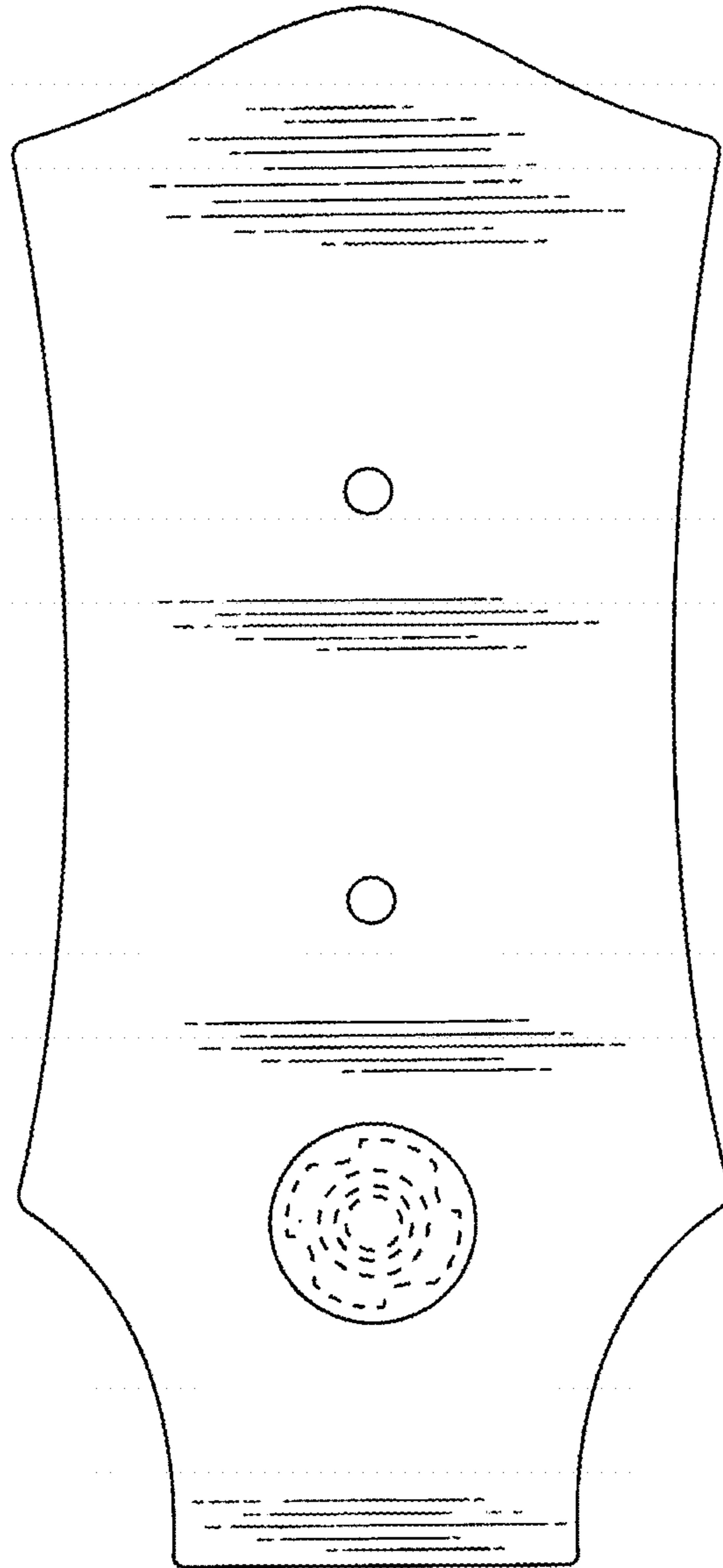

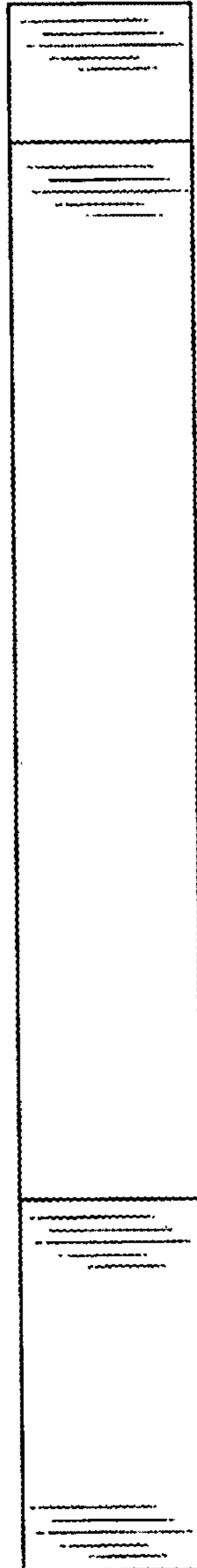

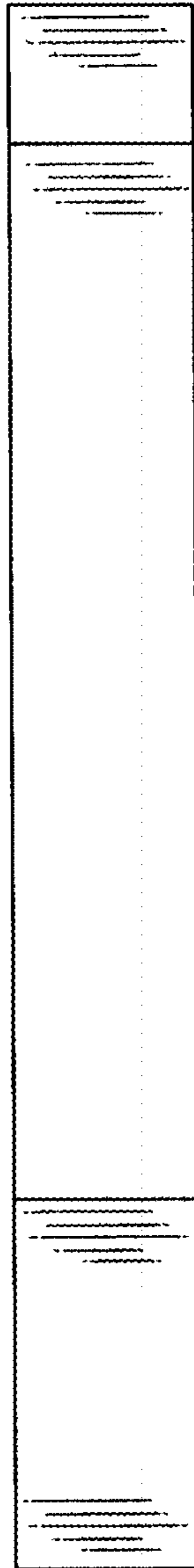

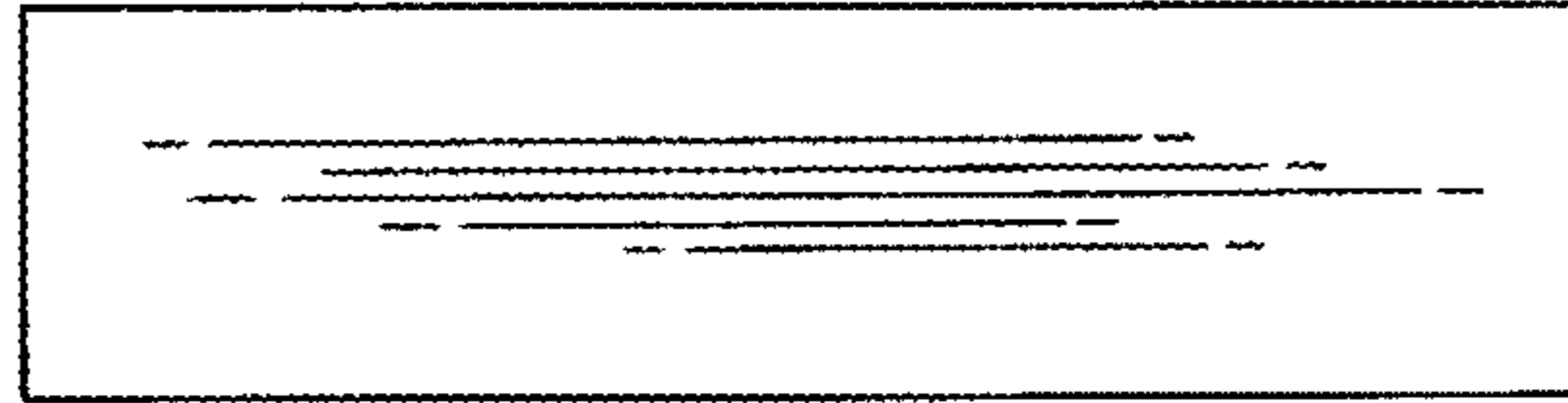

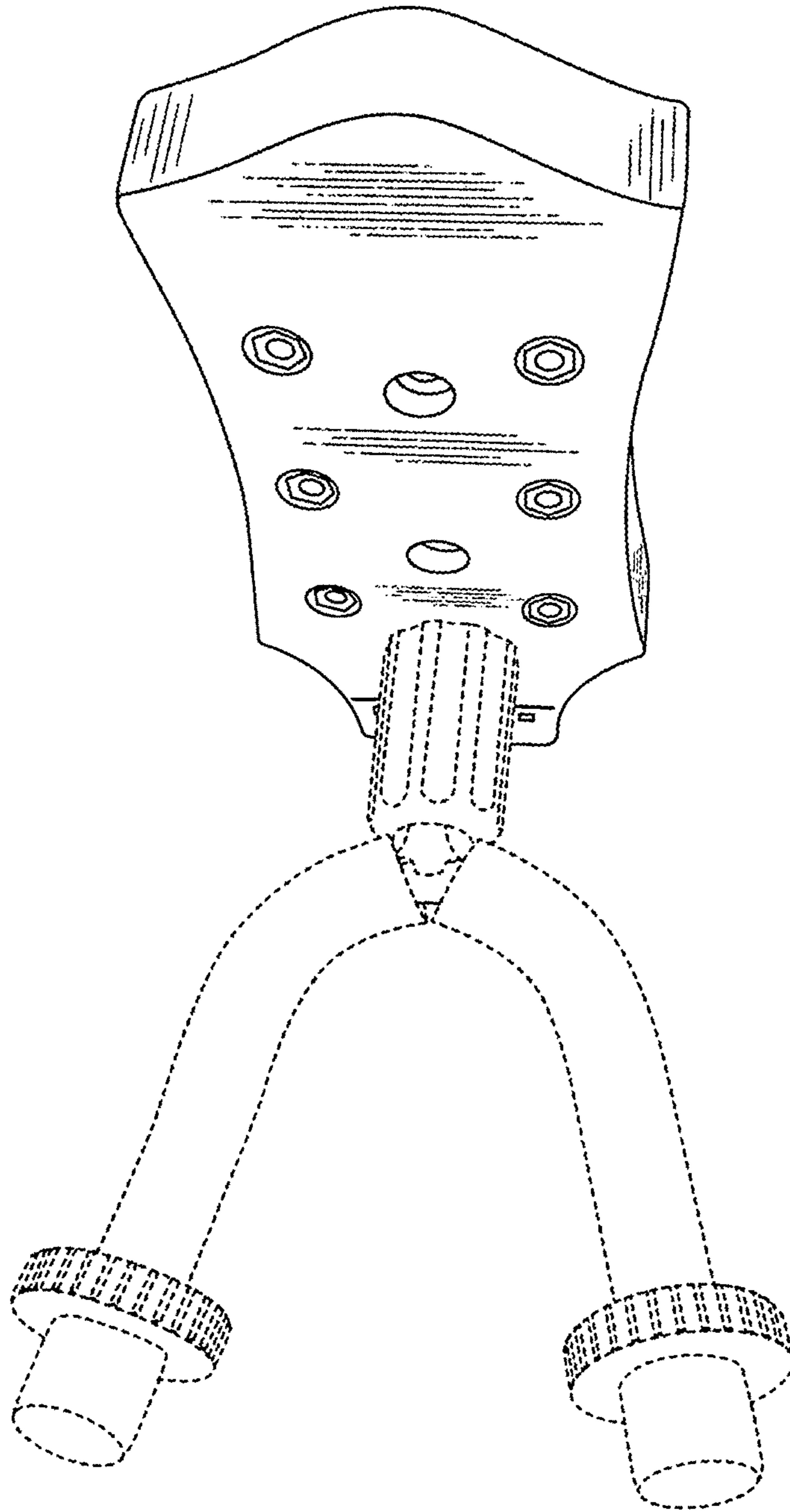
