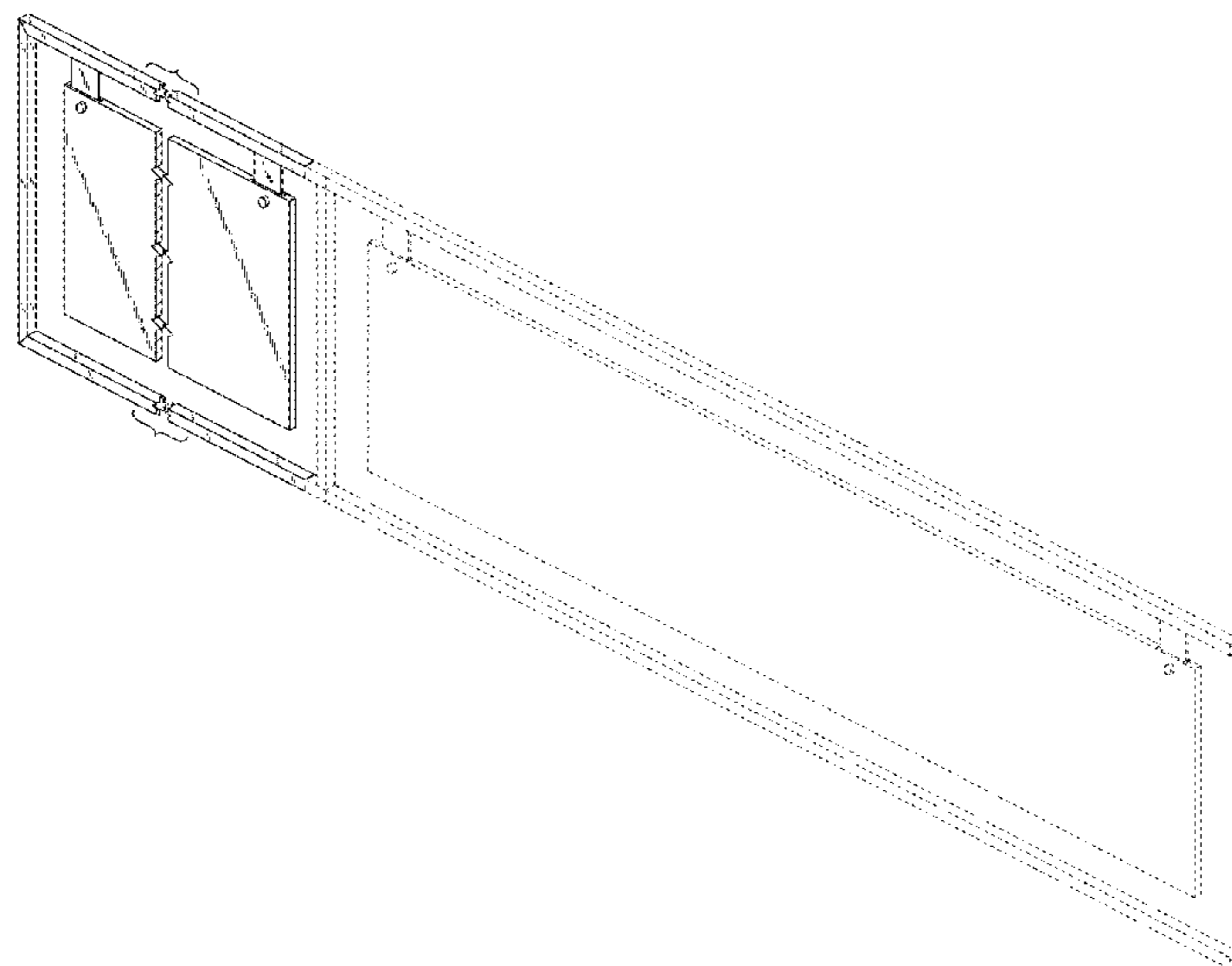
(57) **CLAIM**

The ornamental design for a display fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and front perspective view of a display fixture, showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.  
In the drawings, the broken lines depict subject matter forming no part of the claimed design. The heavy weight broken lines define the bounds of the claimed design and form no part thereof.  
The article is shown with a symbolic break in its width. The appearance of any portion of the article between the break lines forms no part of the claimed design.

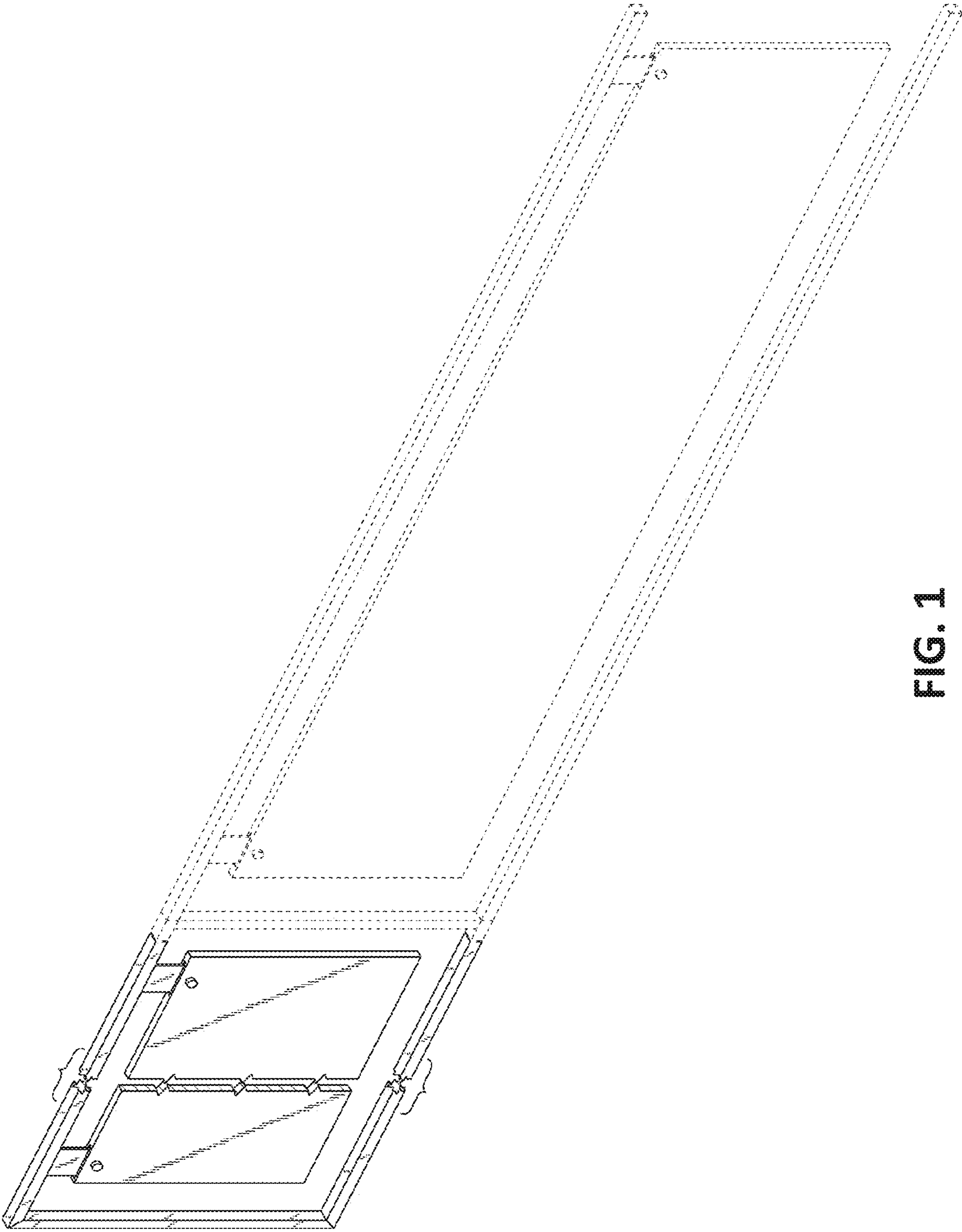

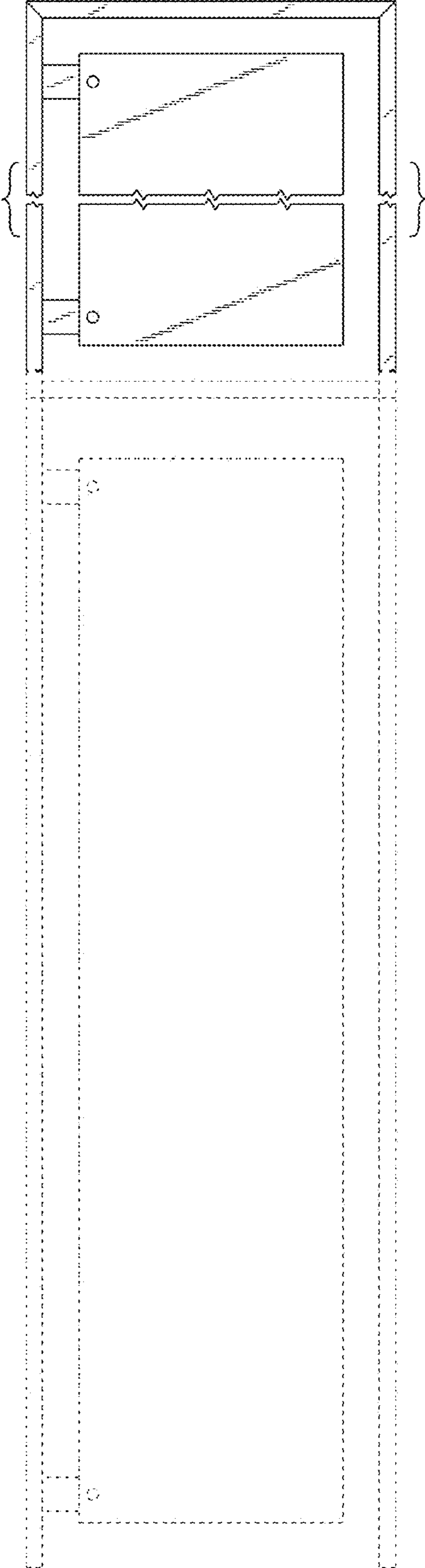

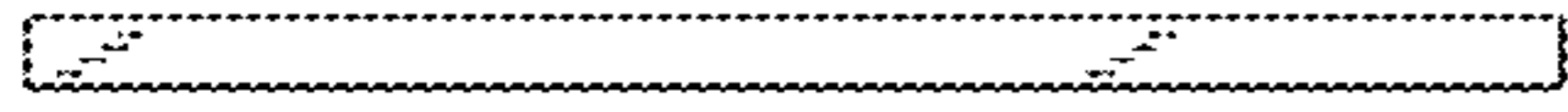

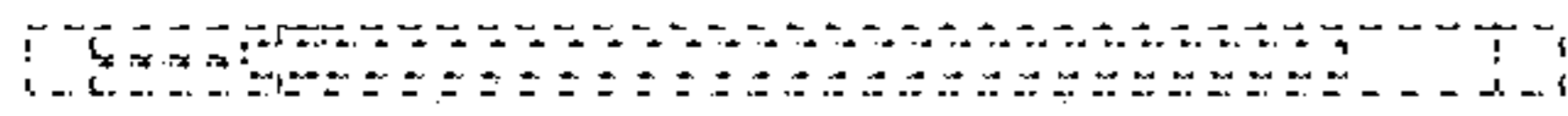

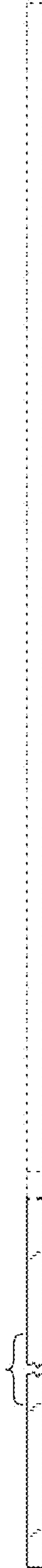

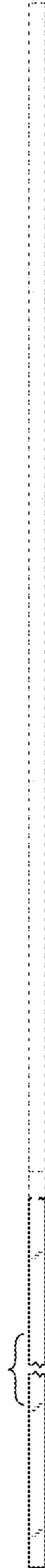
