FIG. 1 is a perspective view of electronic display screens for gaming machines.

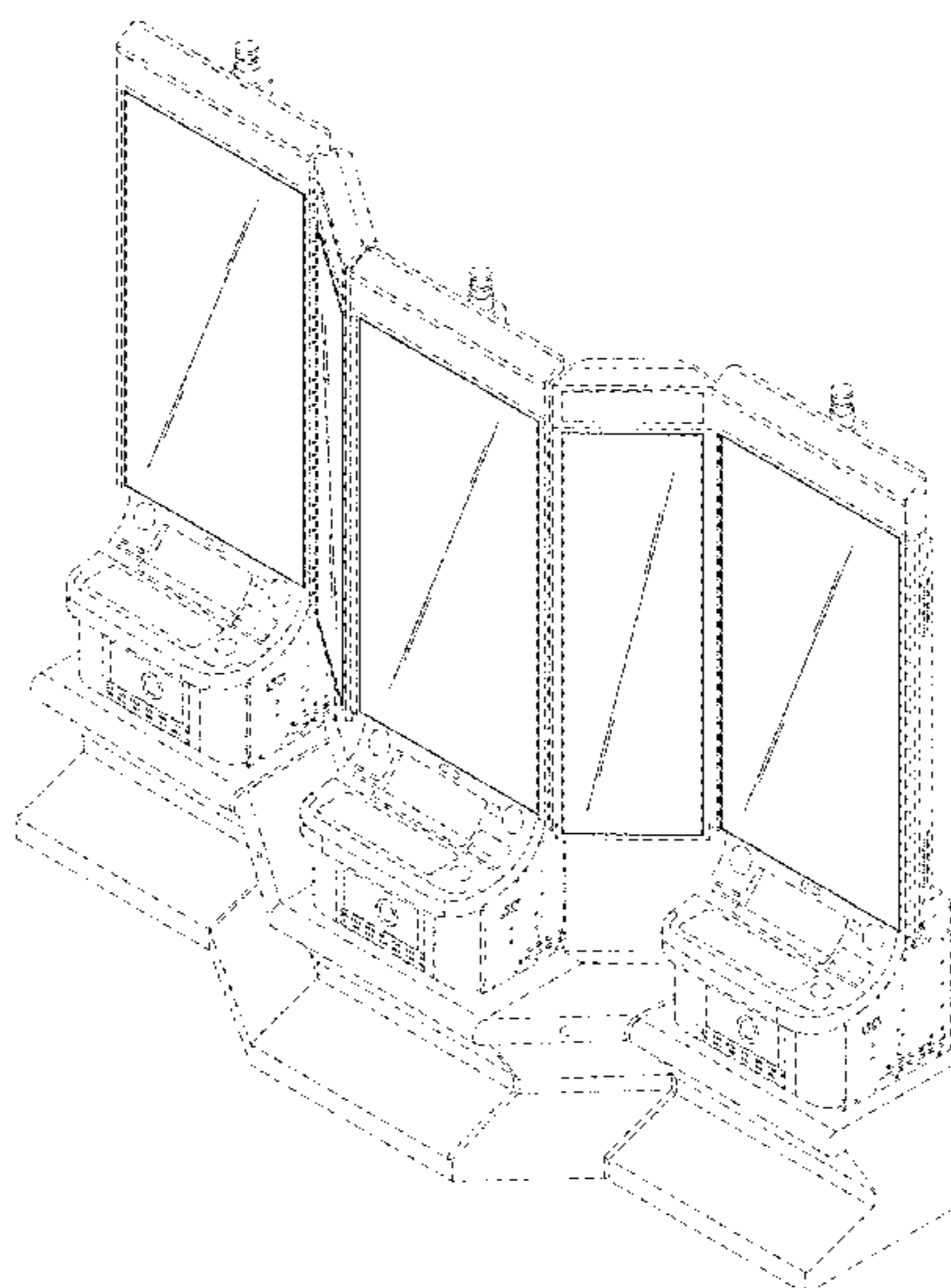
FIG. 2 is a front elevational view thereof.

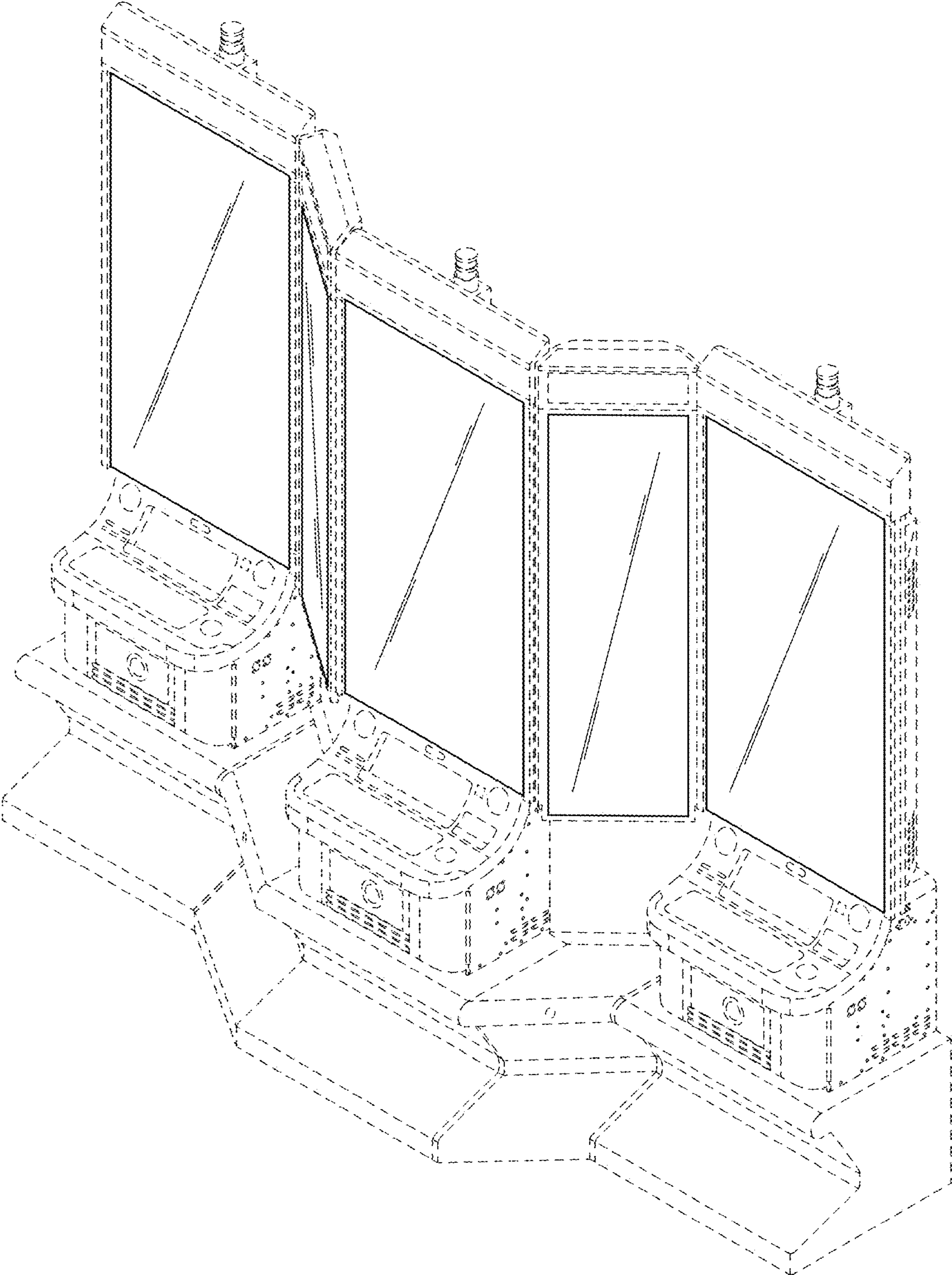

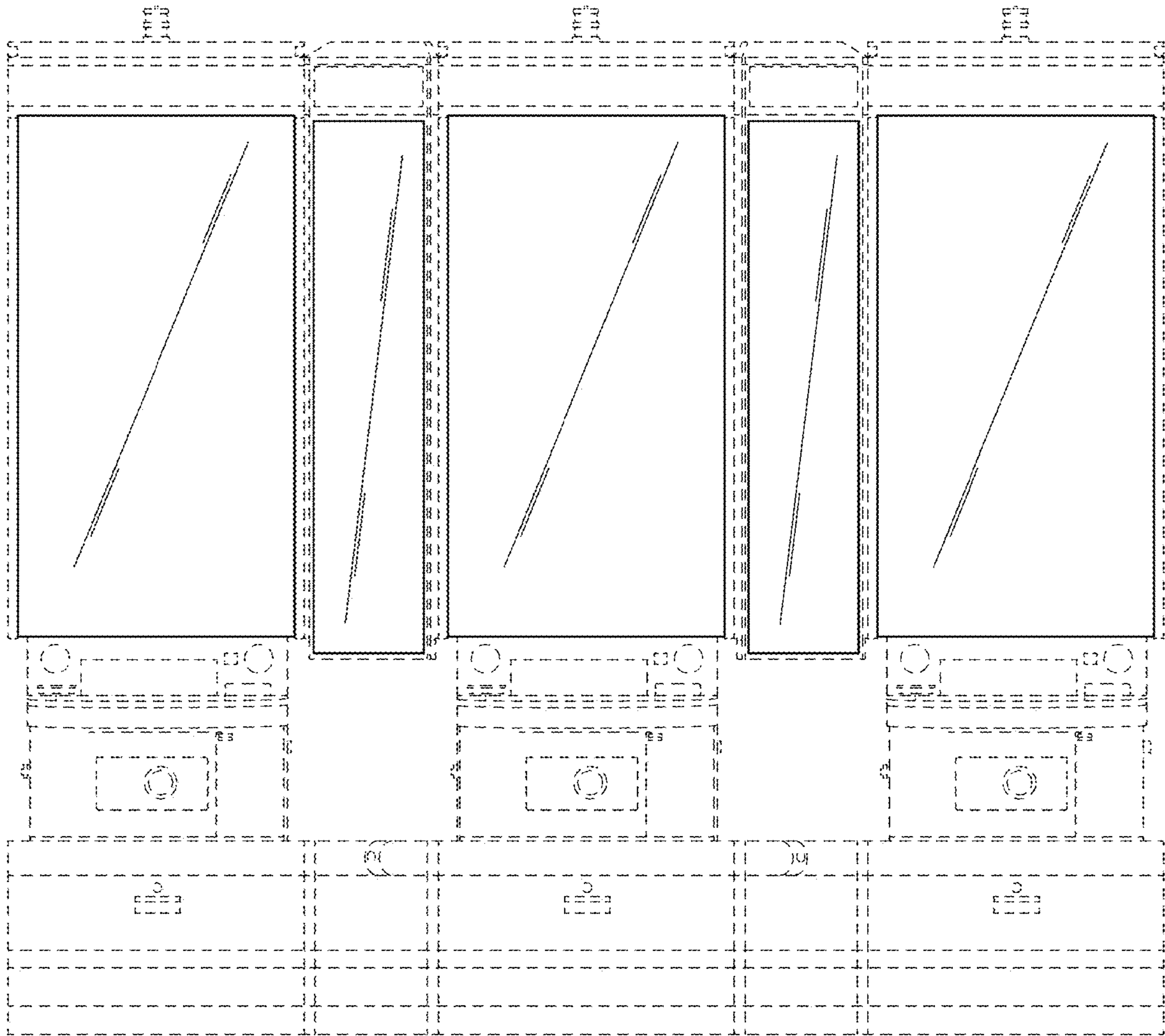

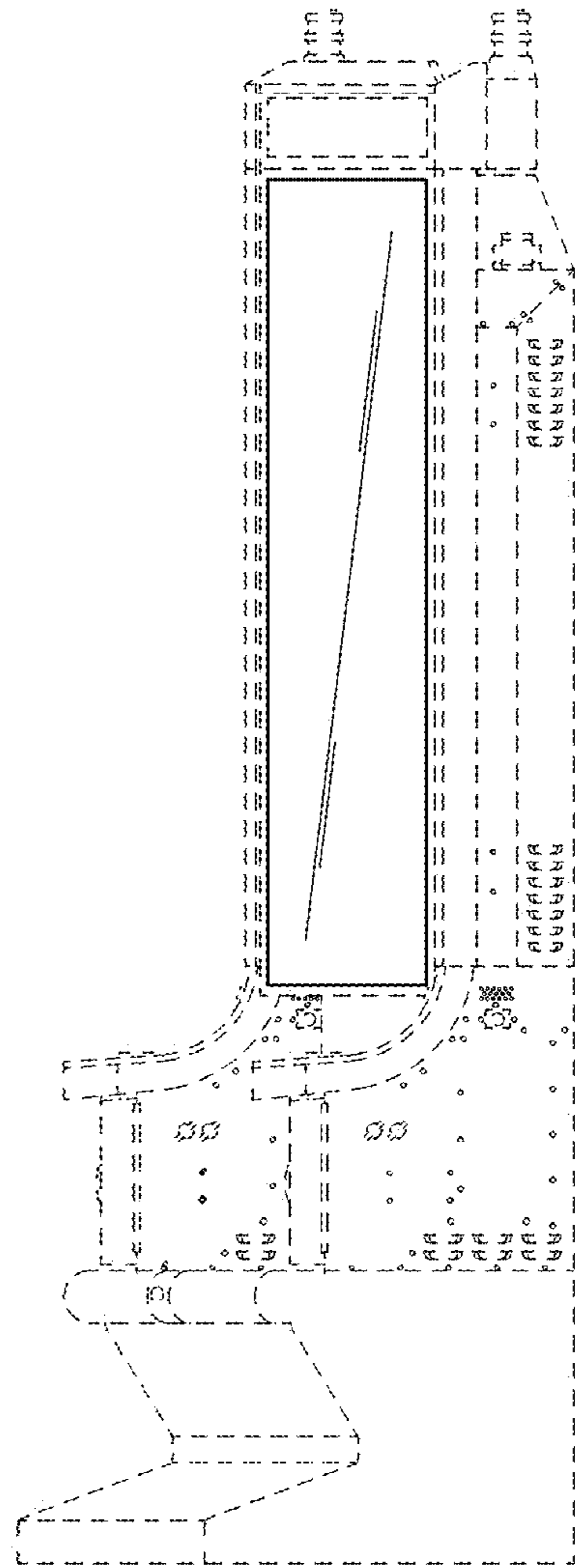

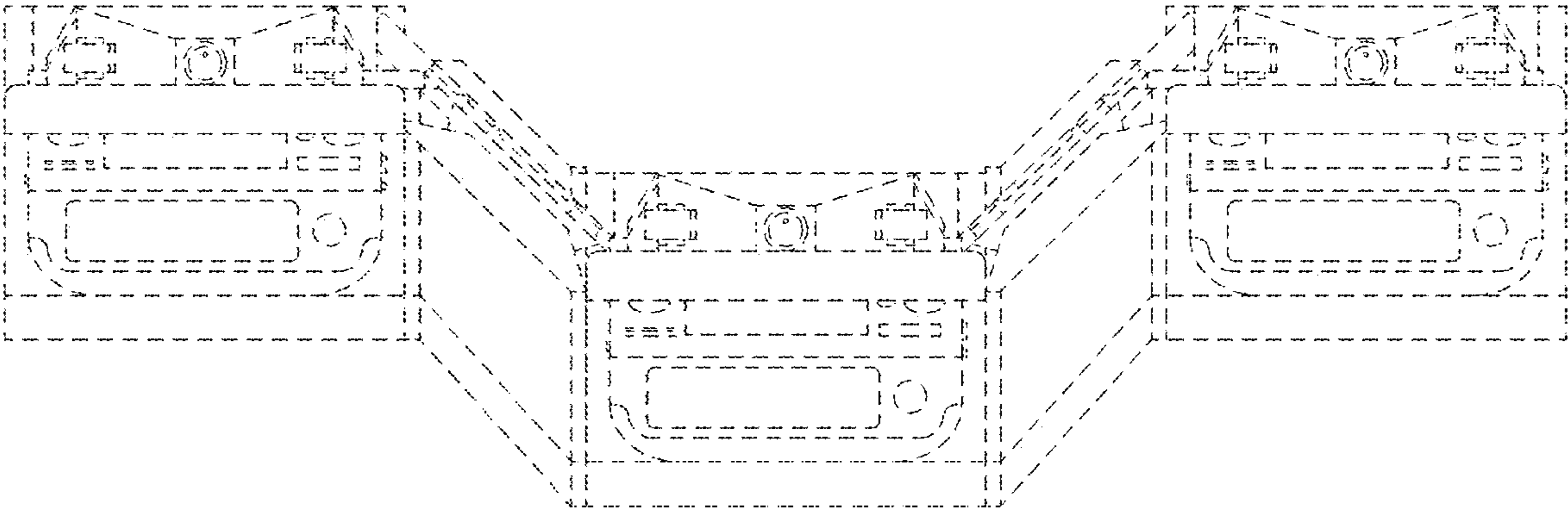
