The ornamental design for a head for golf club, as shown and described.

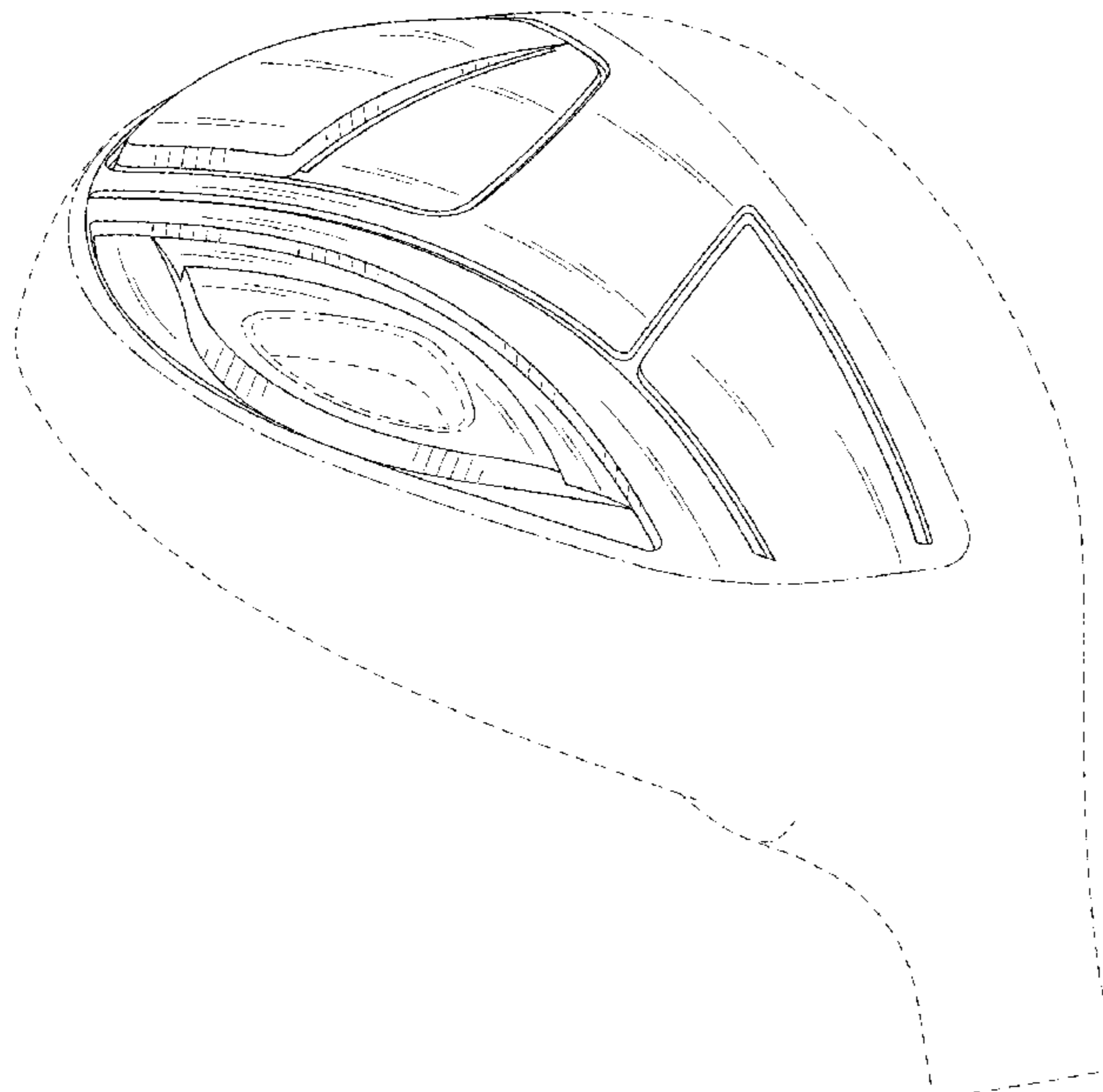
DESCRIPTION

FIG. 1 is a first perspective view of a head for golf club;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

The broken lines depict portions of the head for golf club in which the design is embodied that are not considered part of the claimed design.

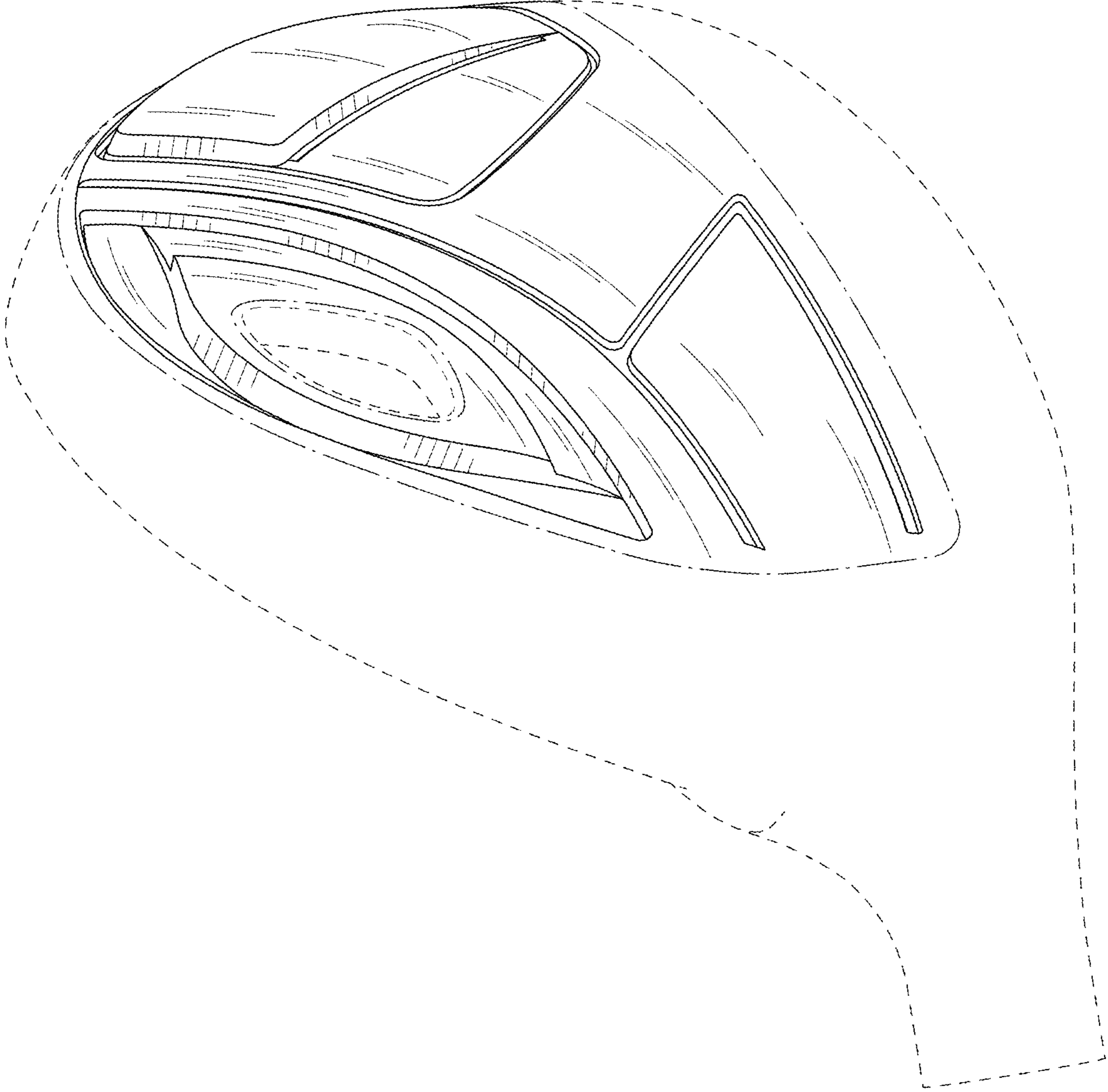

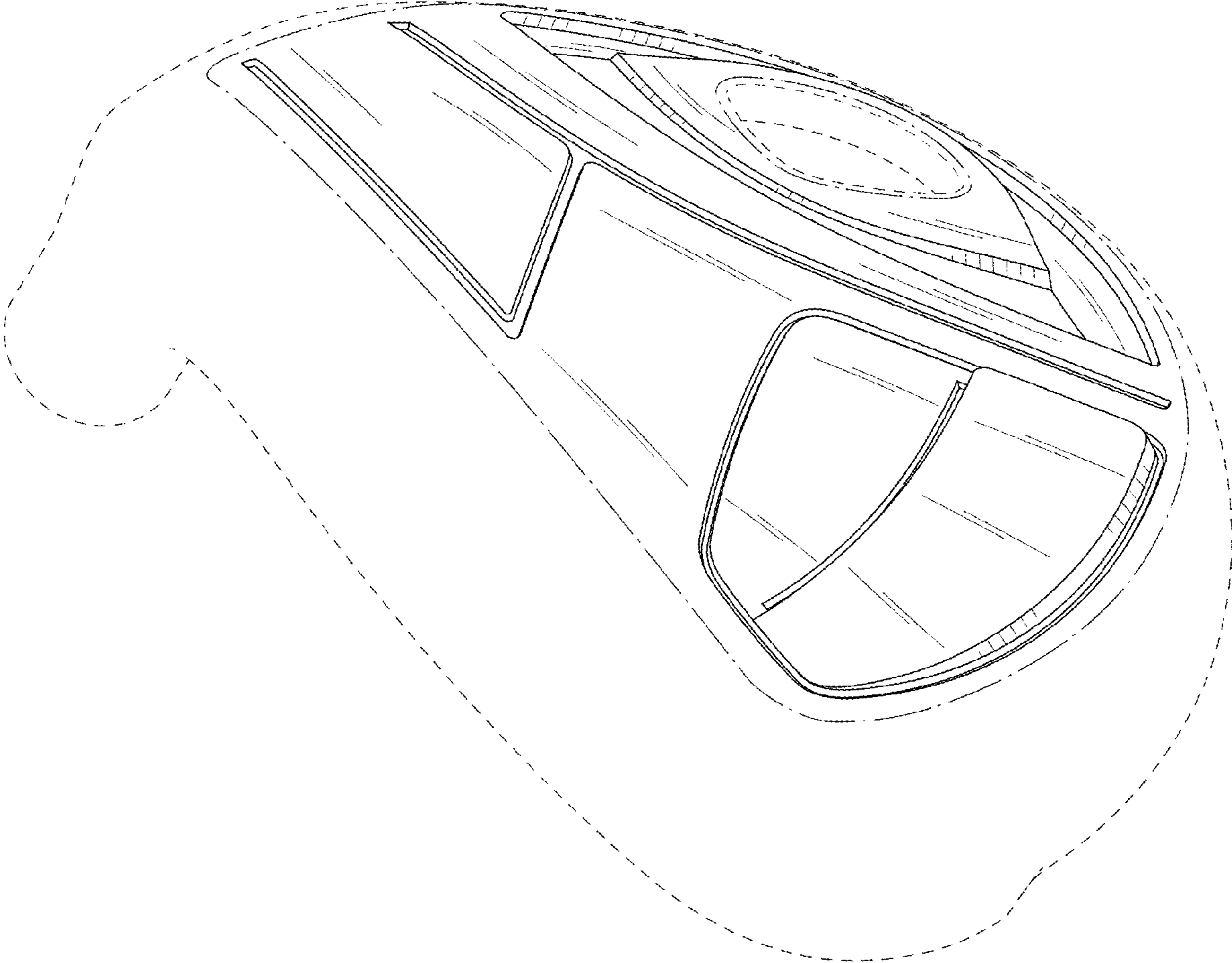

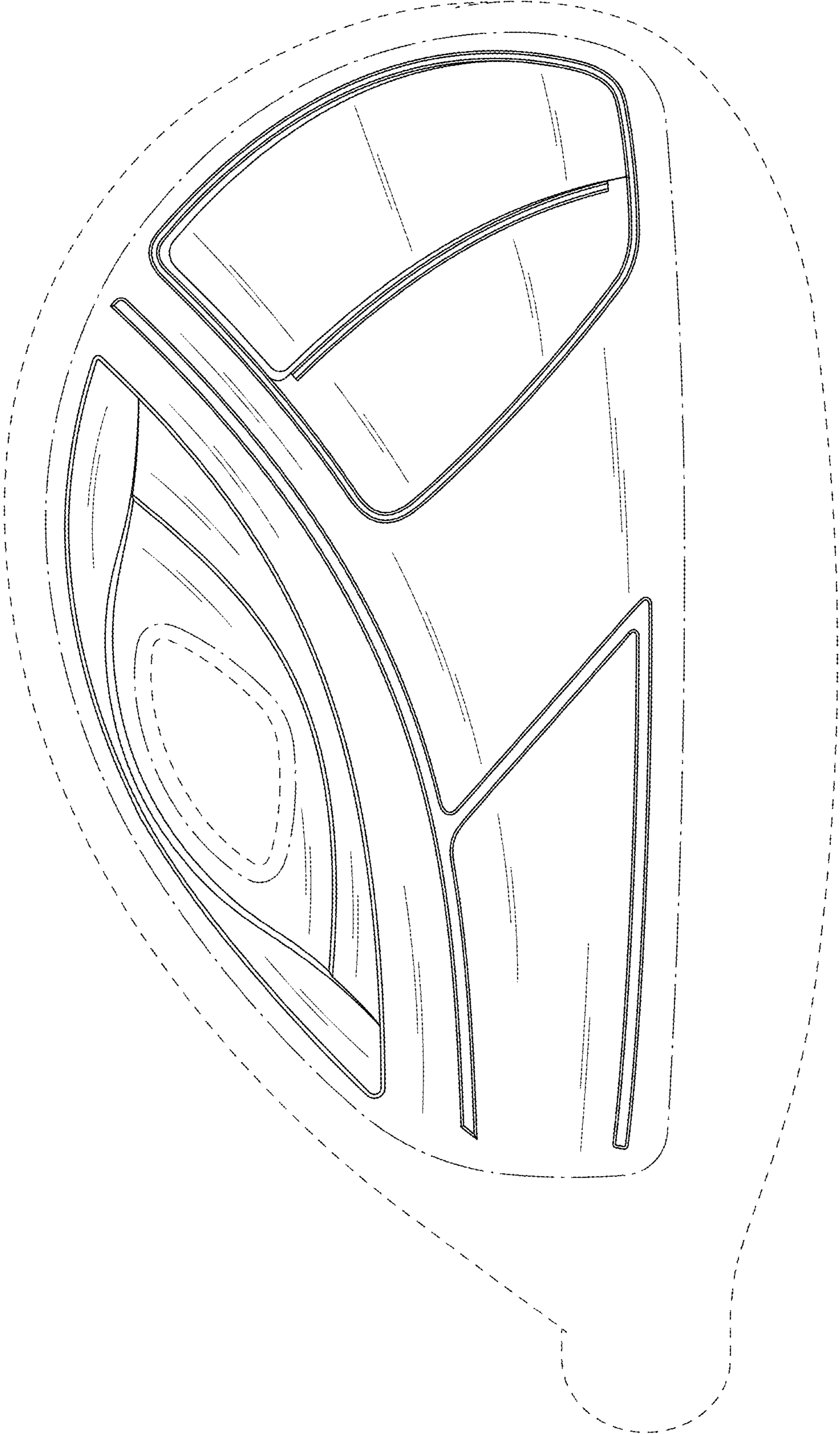

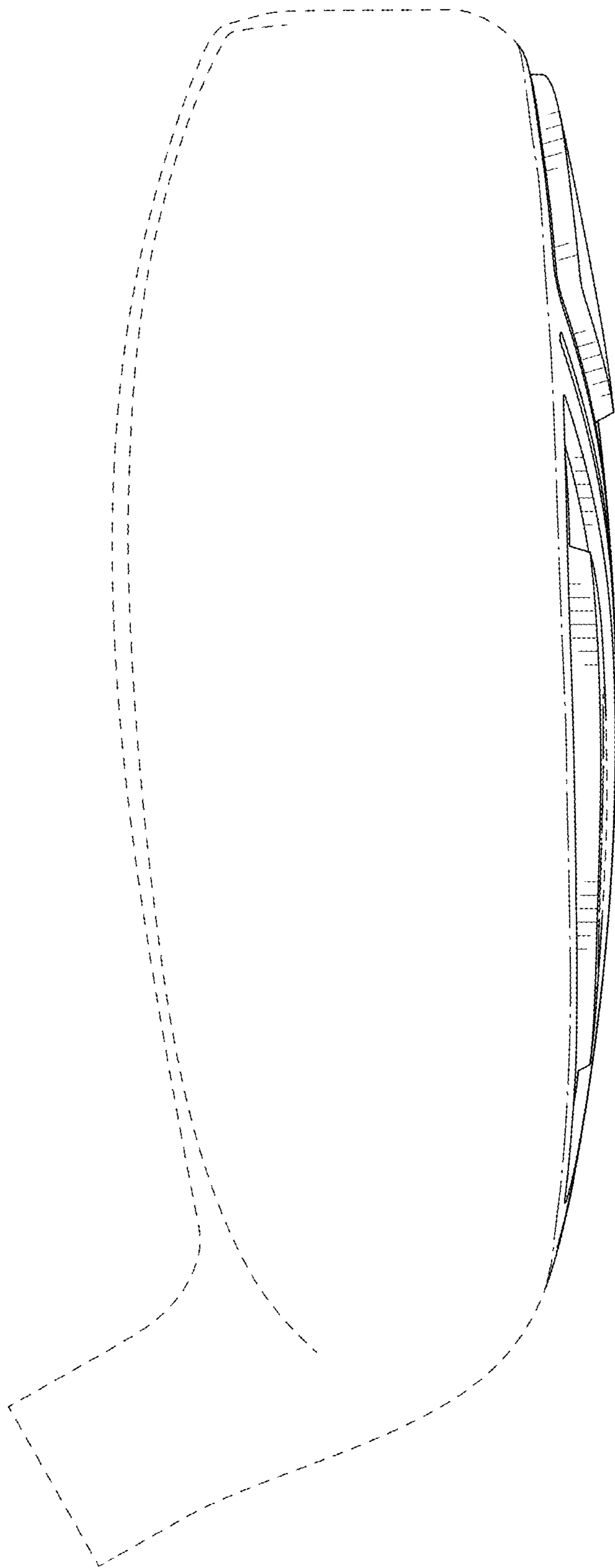

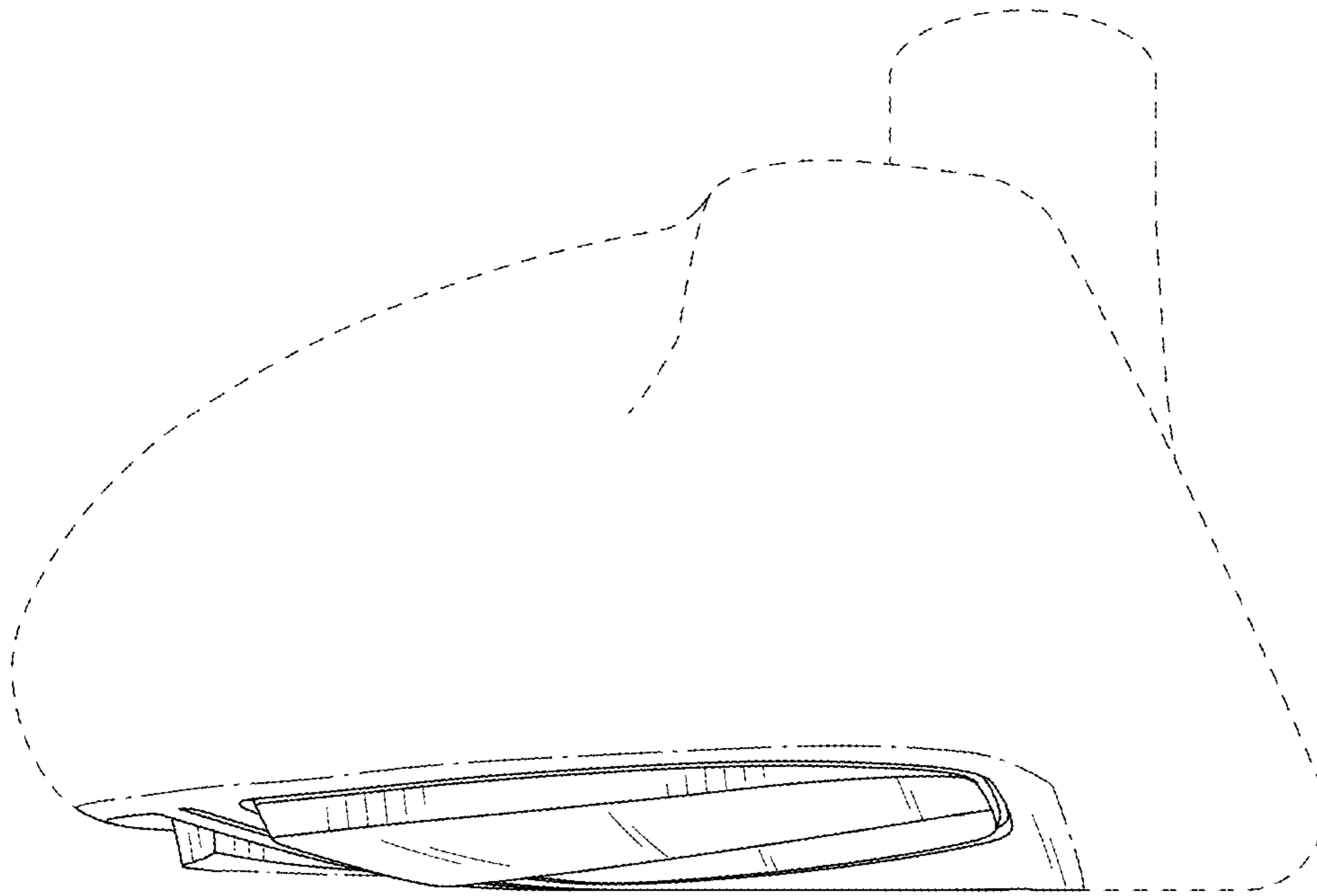

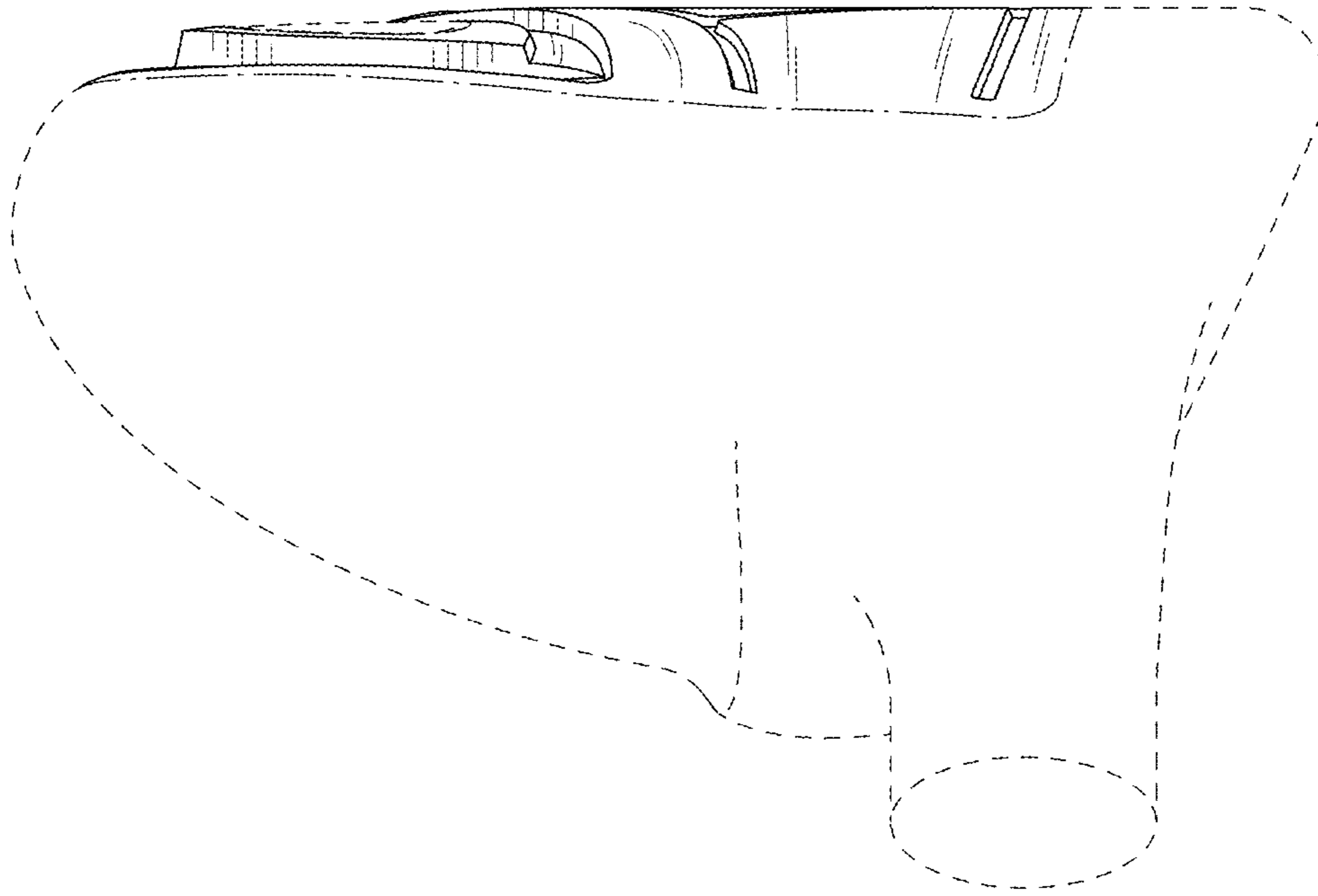
