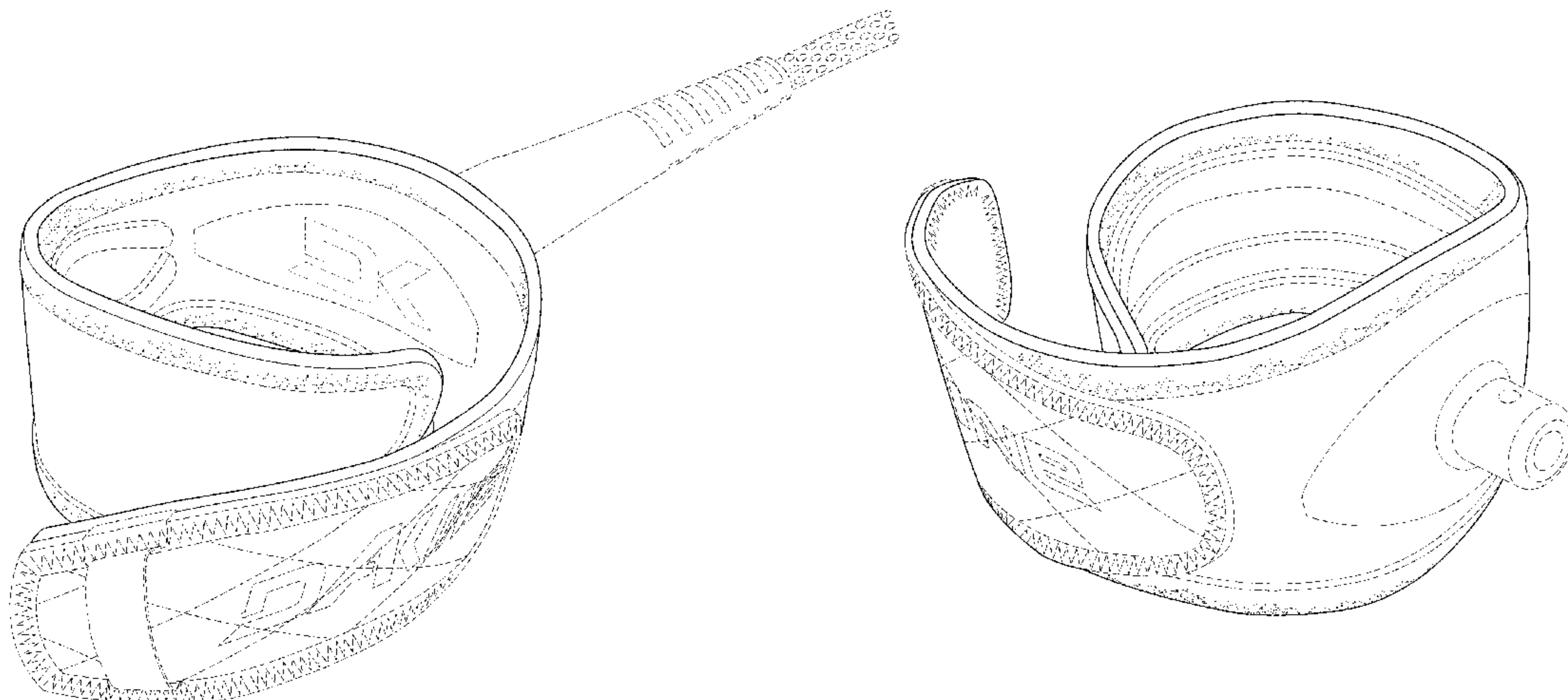


FIG. **23** is a front and right side perspective view of a cuff for surf leash in a curled configuration, showing the new design; (56)

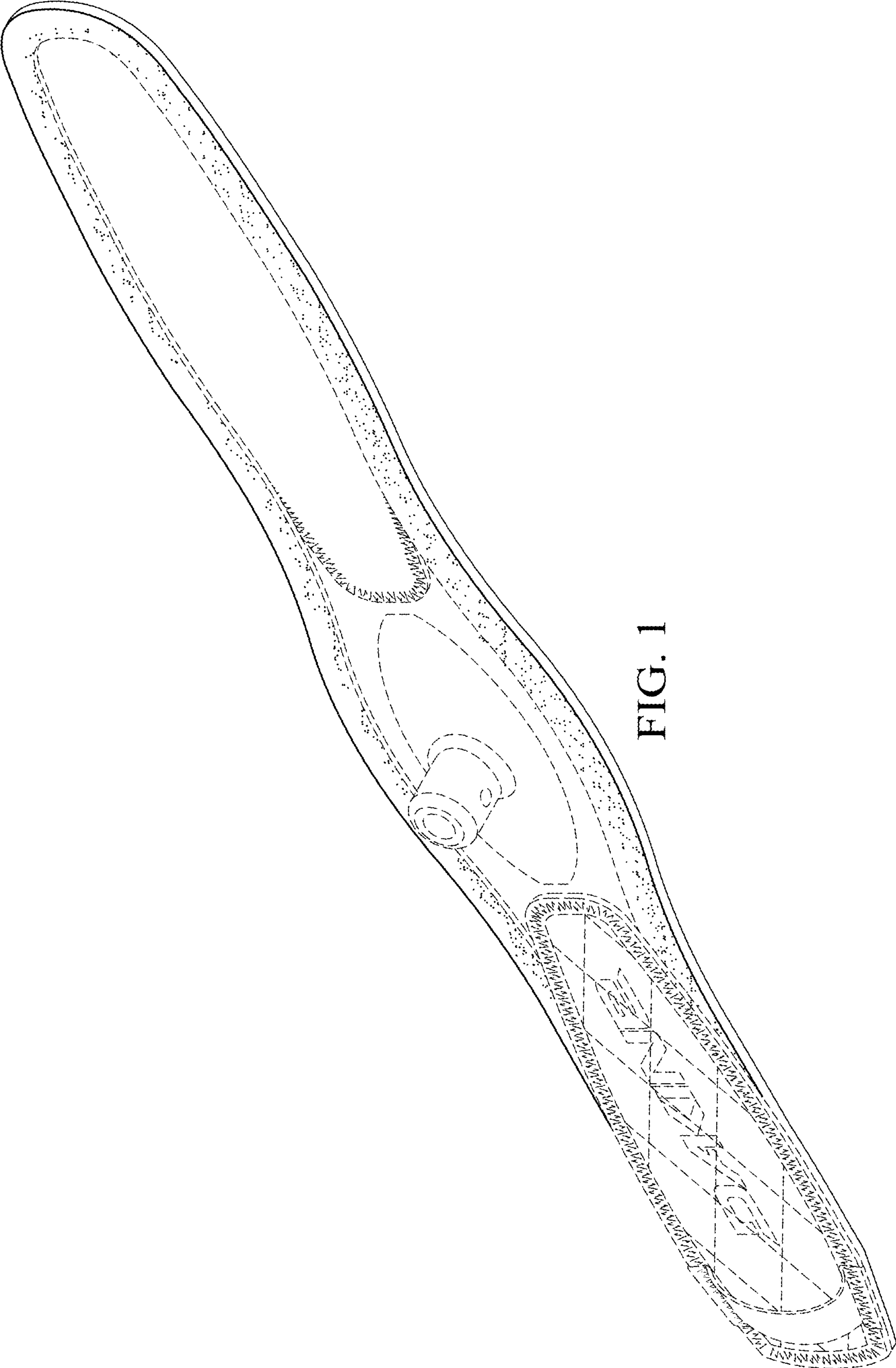

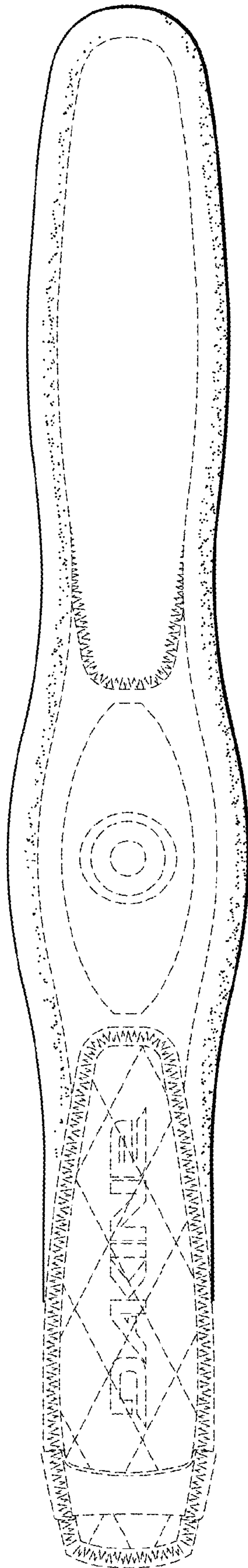

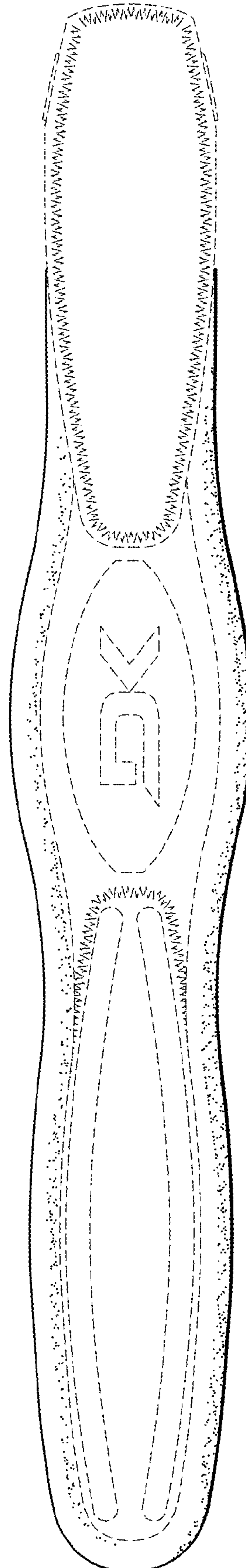

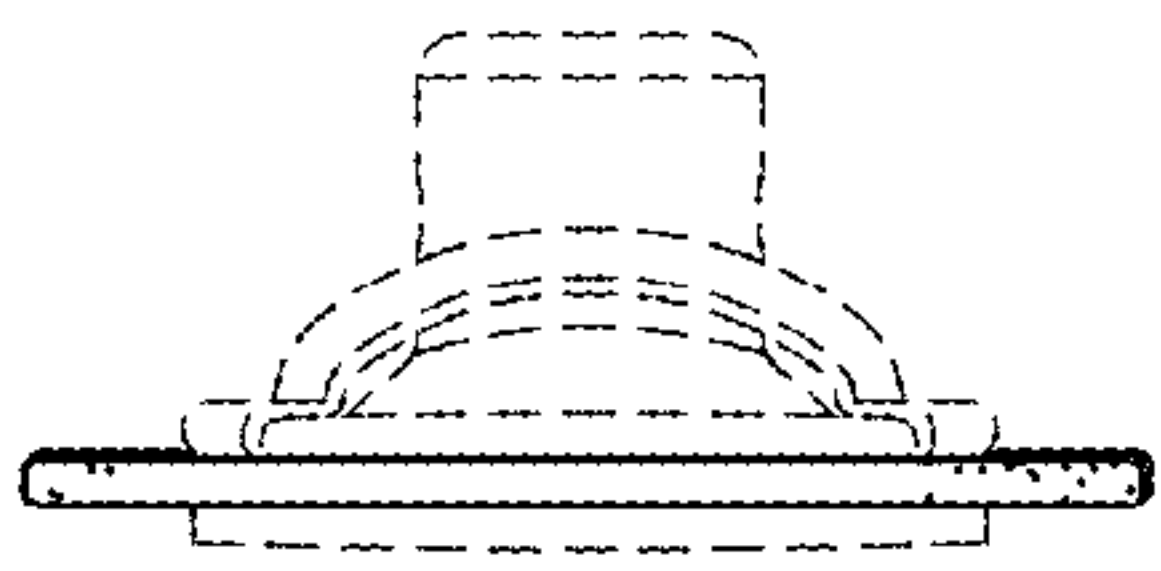

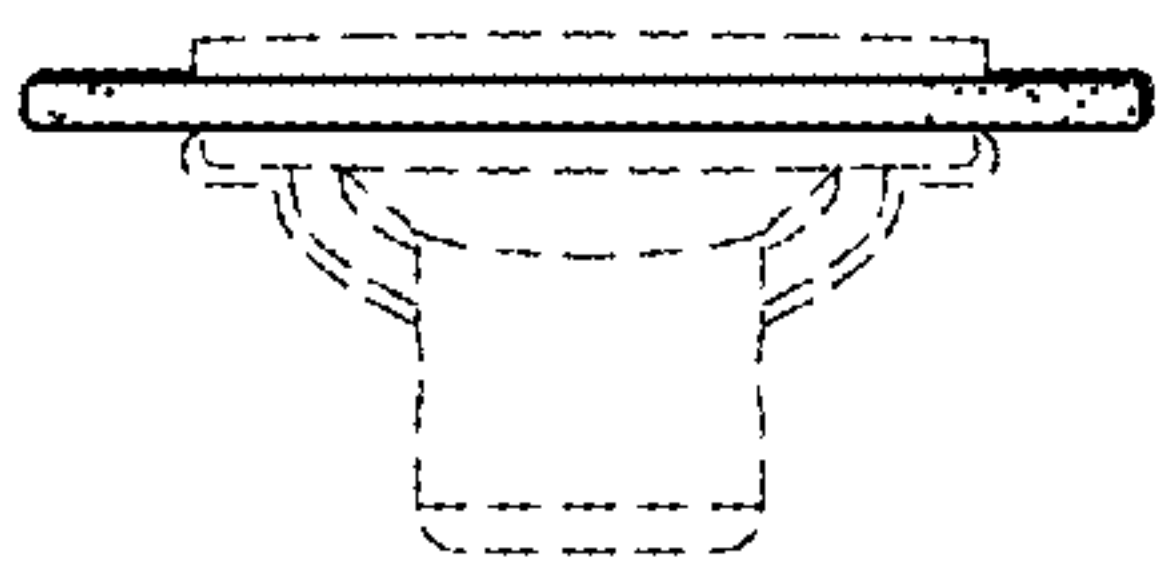

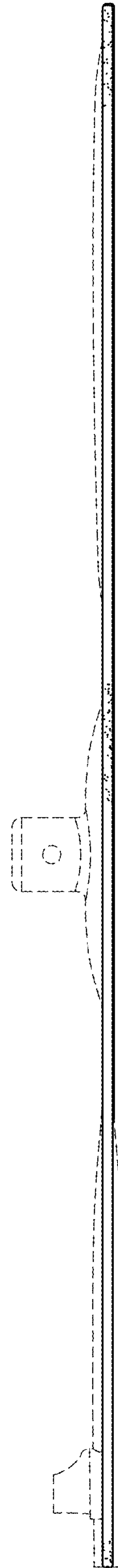

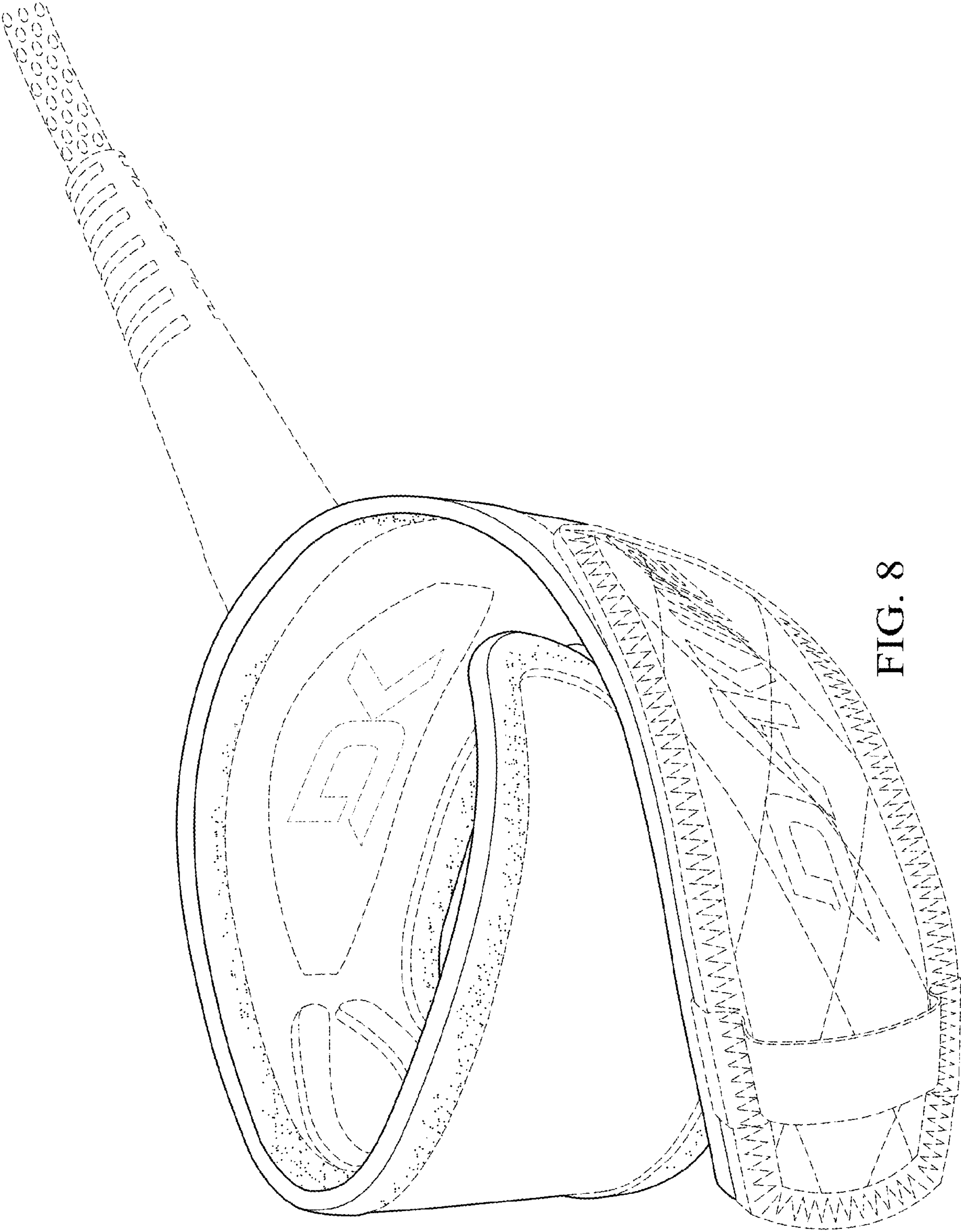

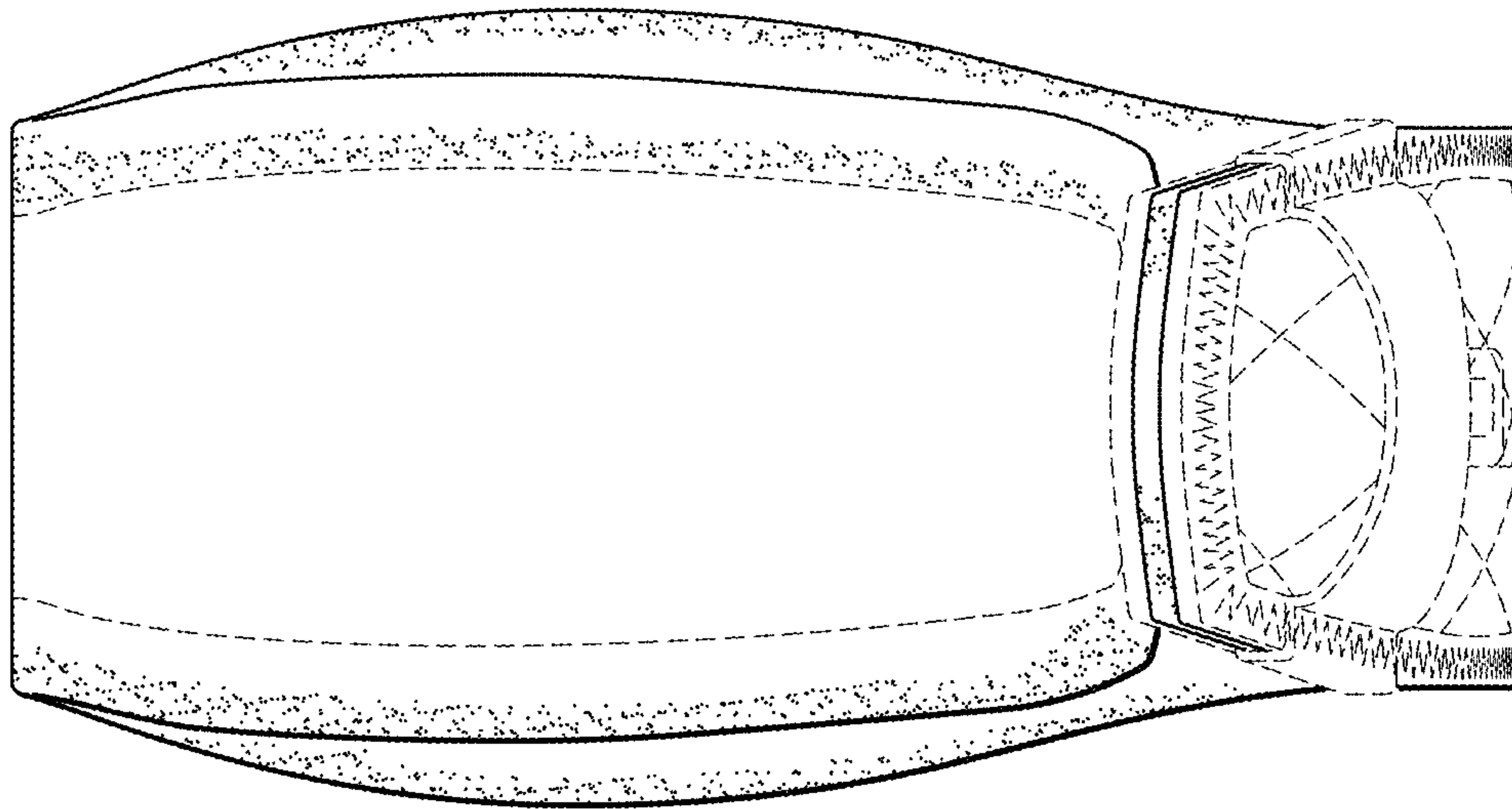

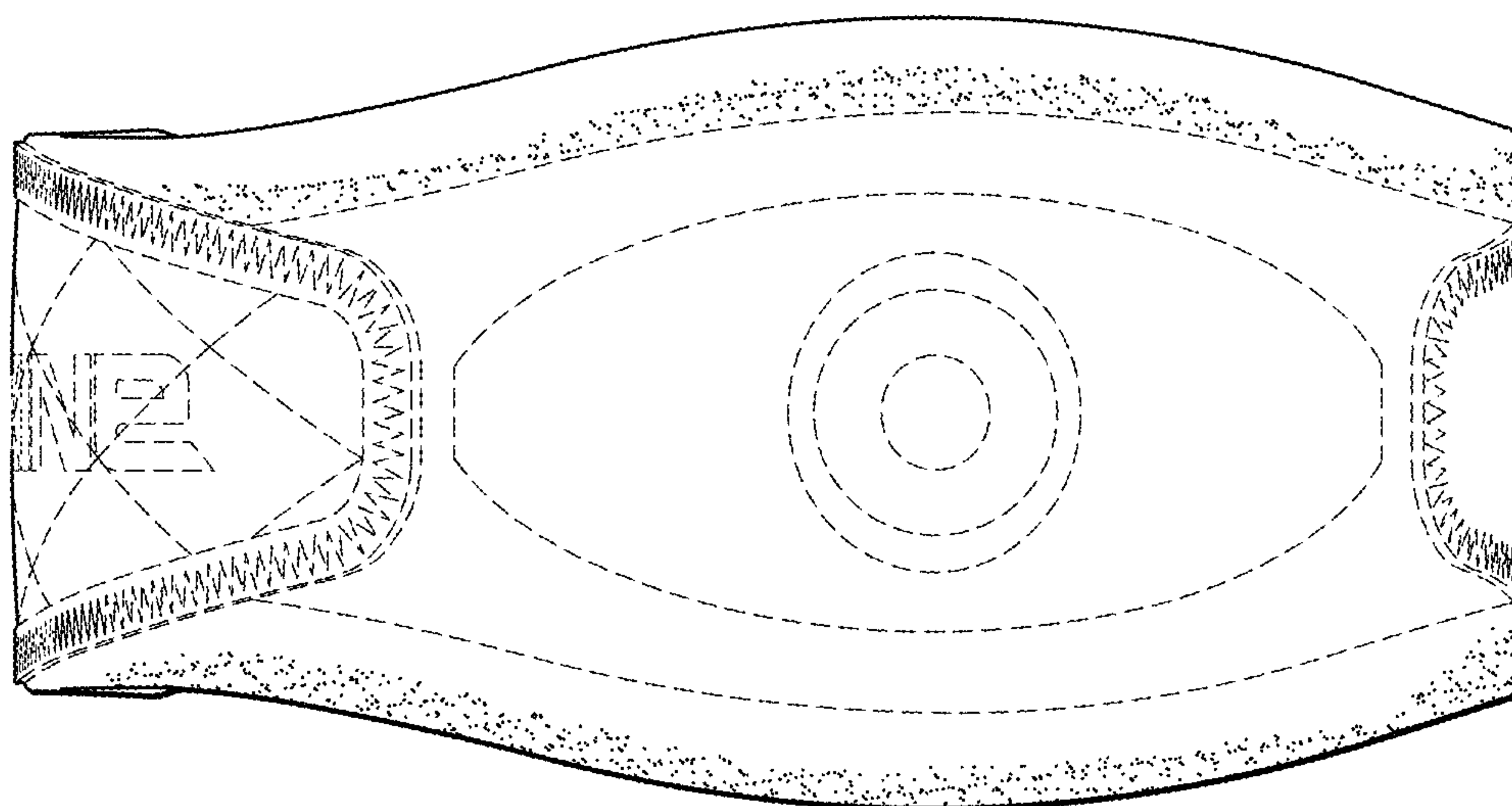

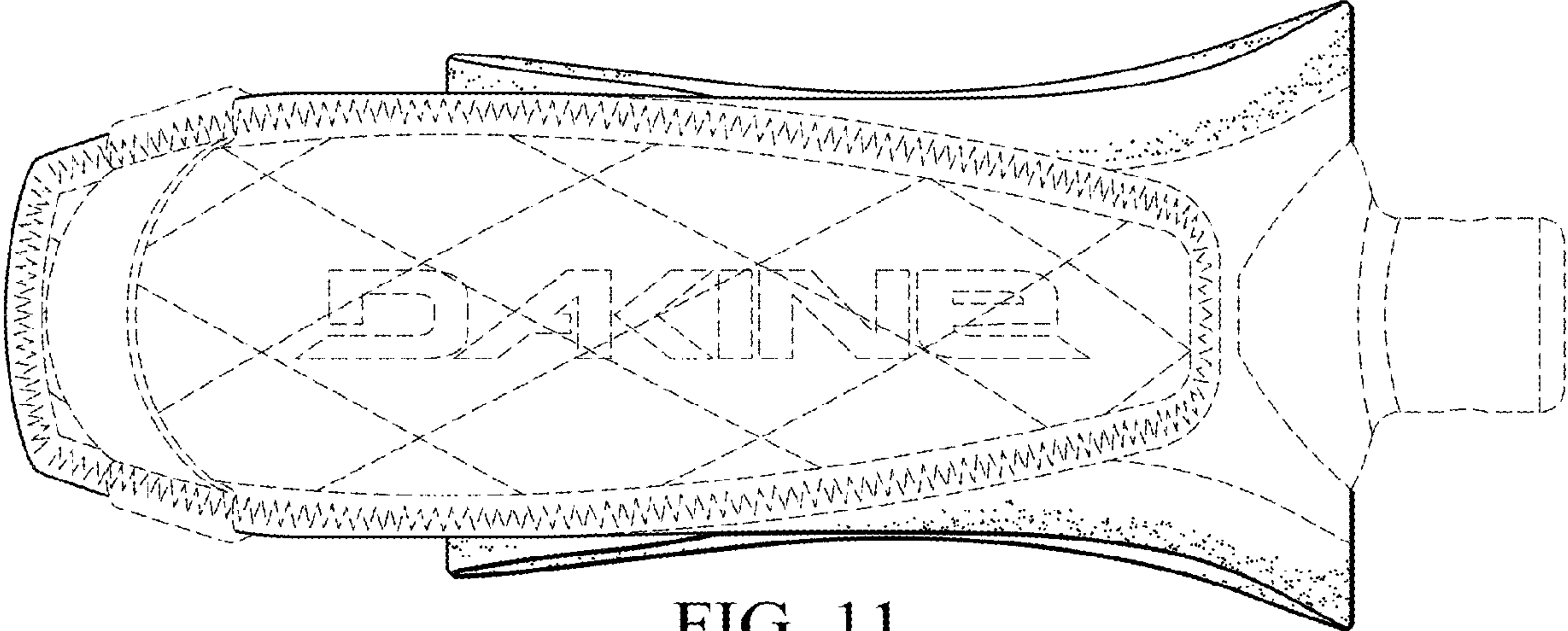

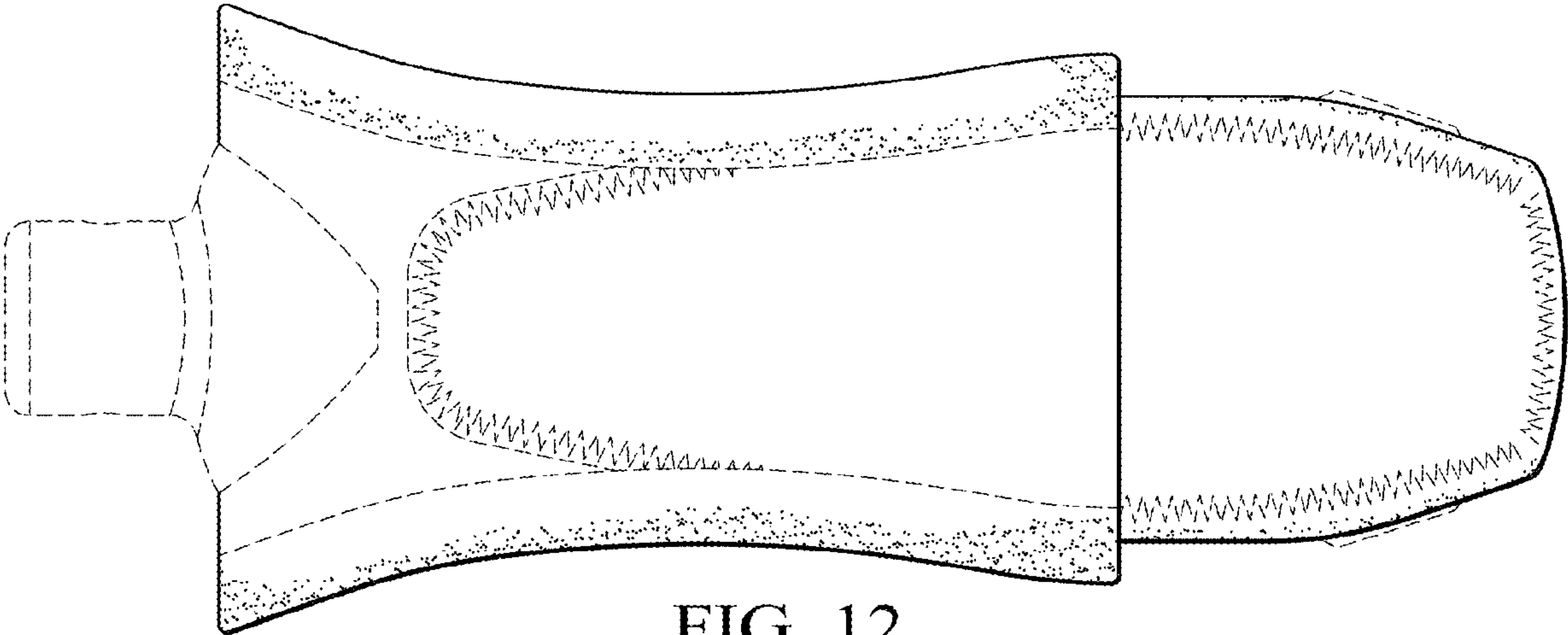

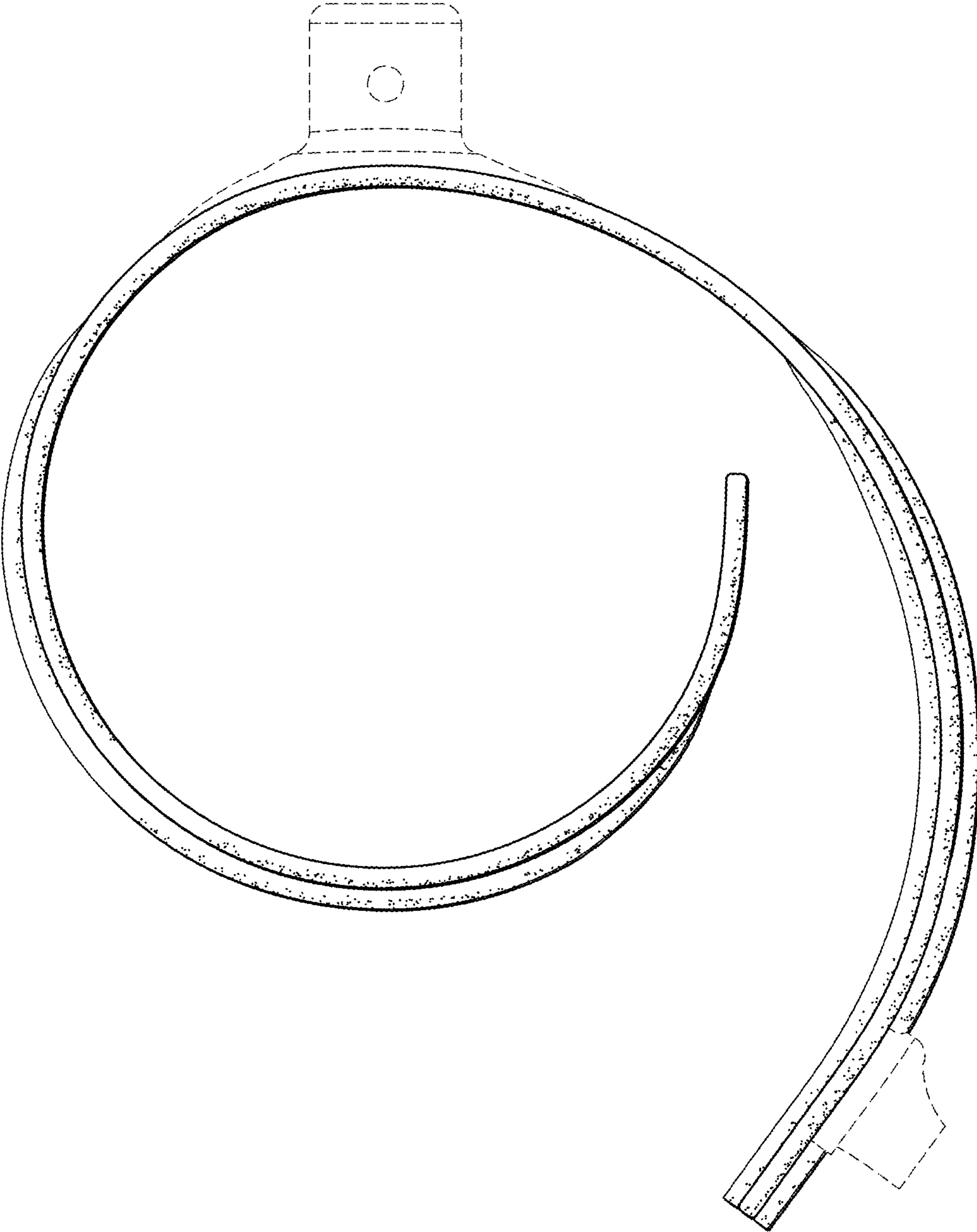

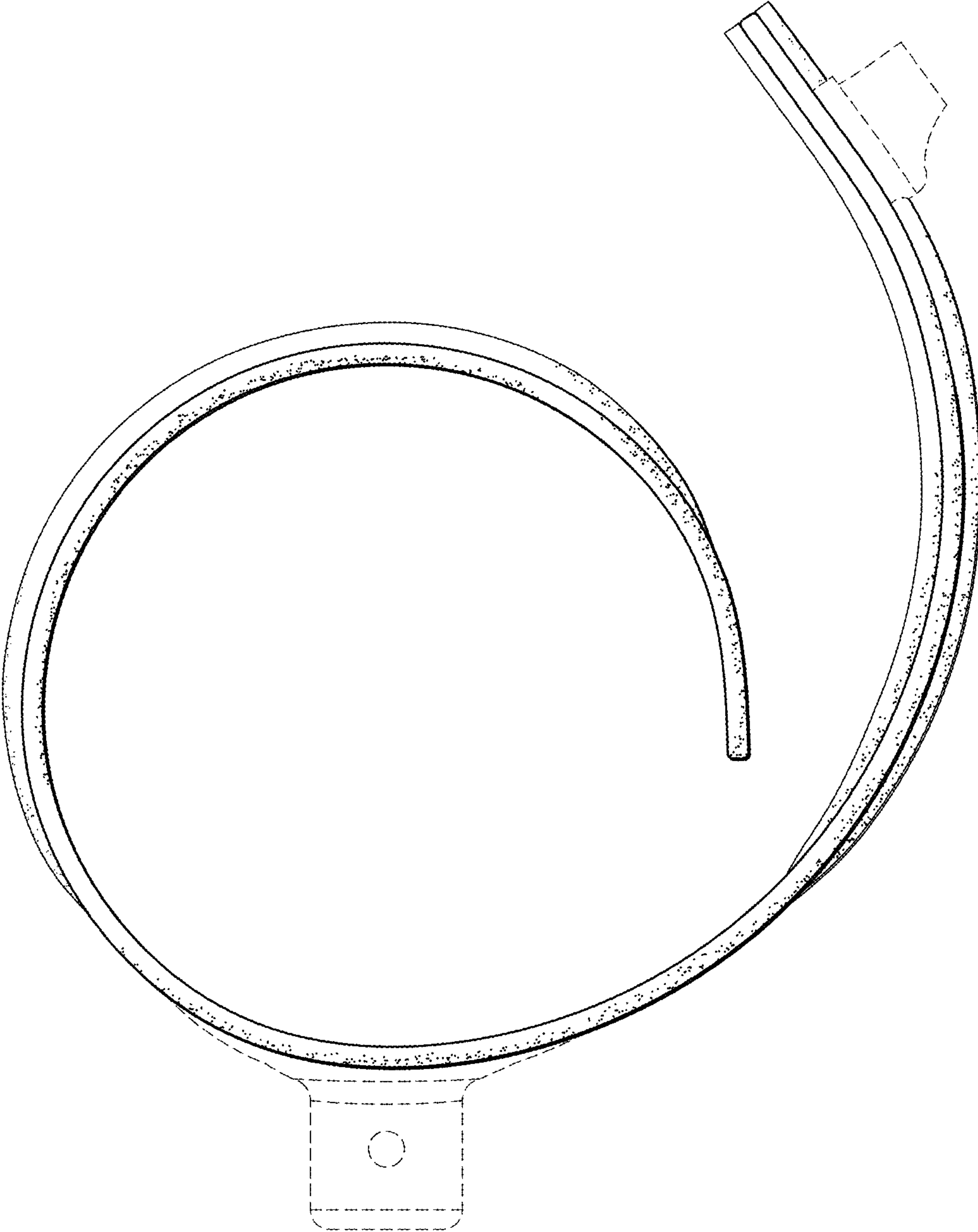

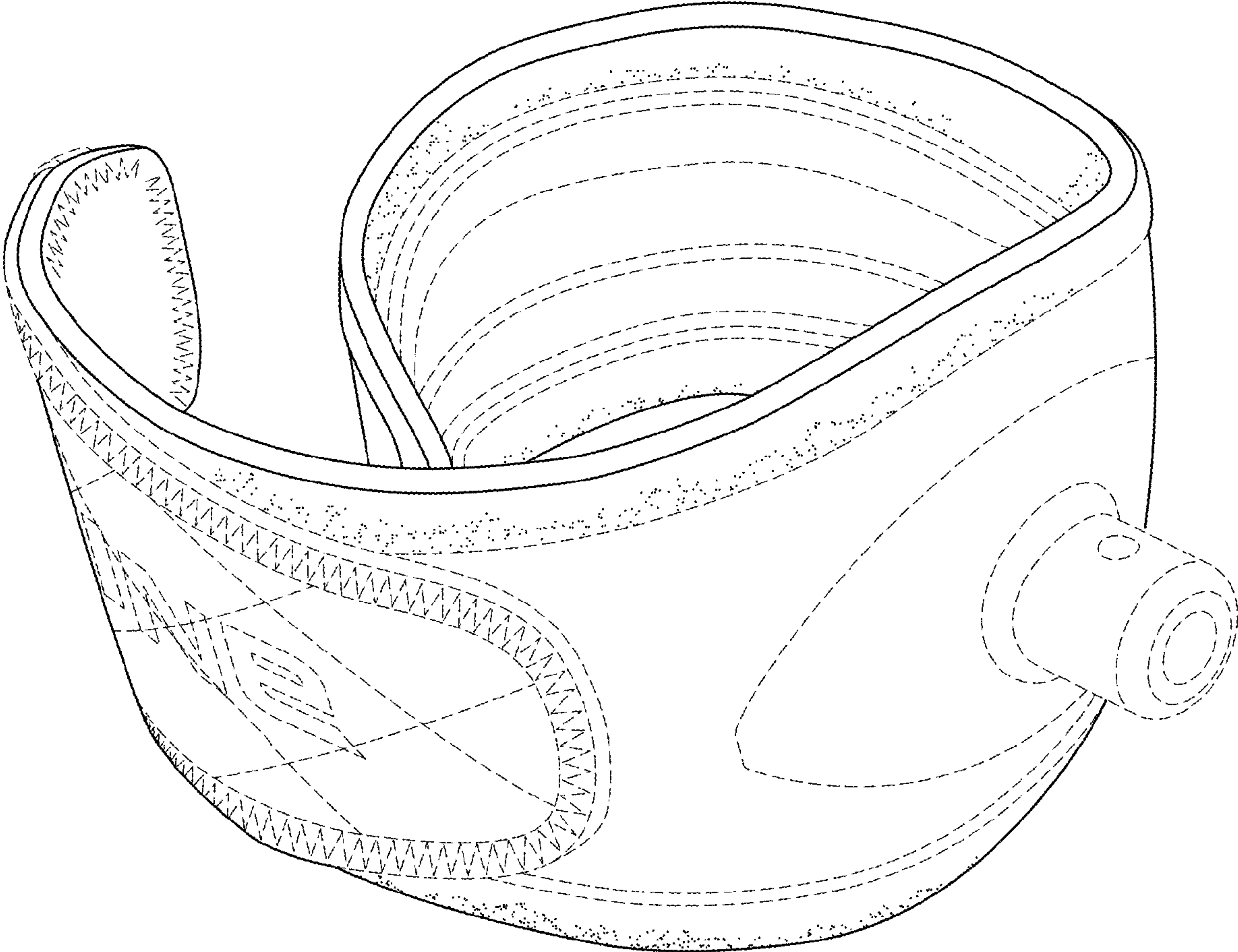

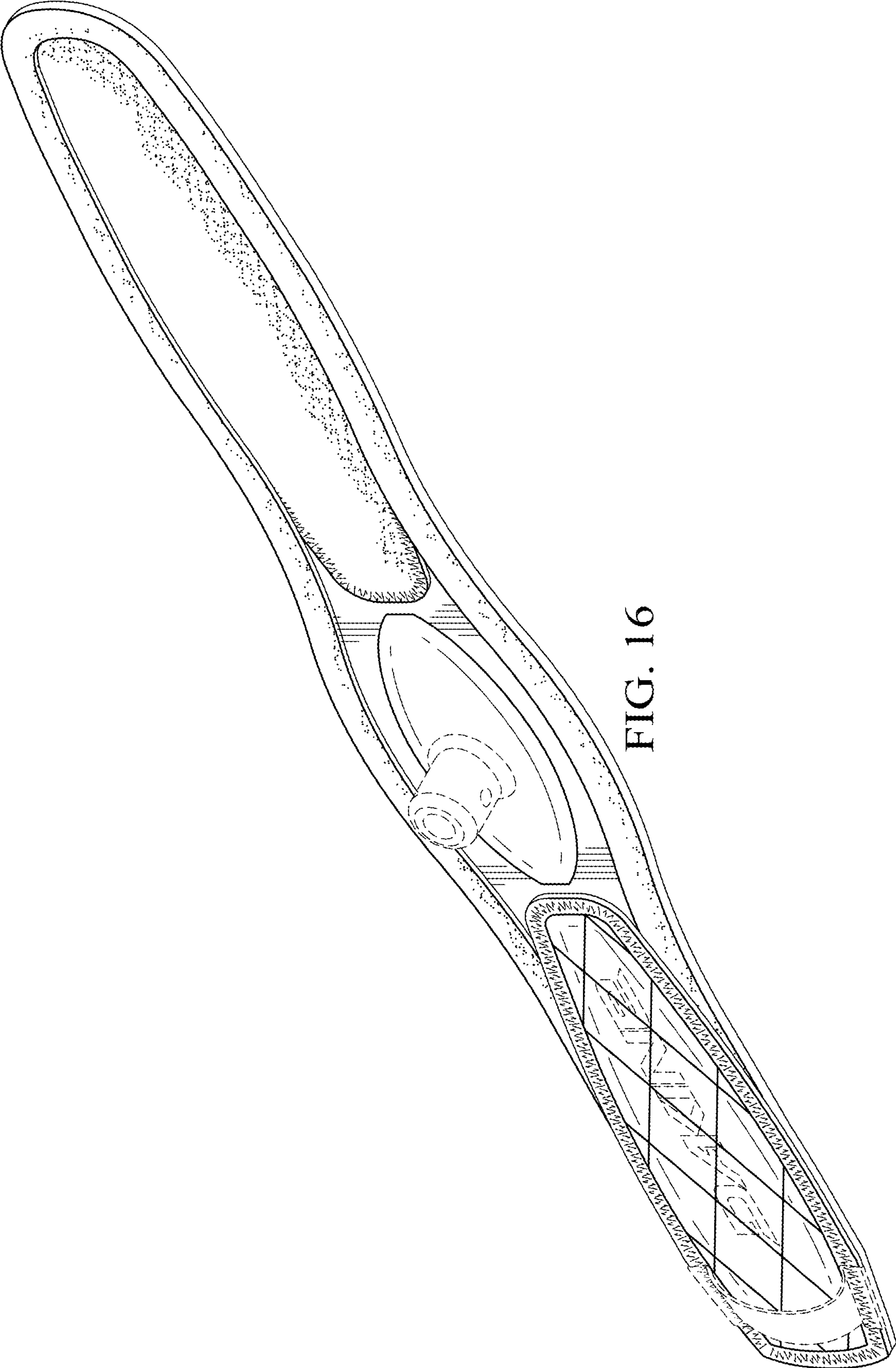

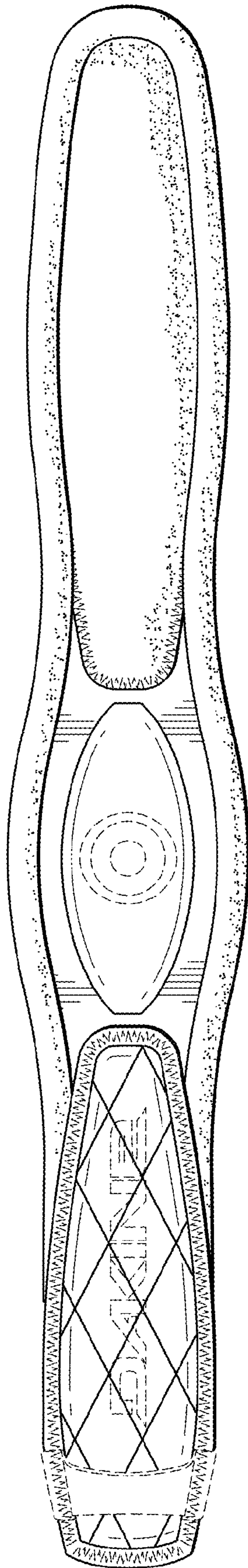

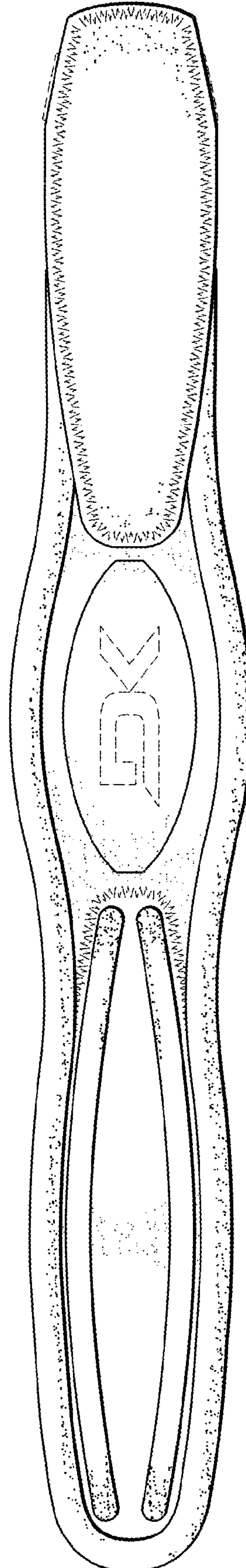

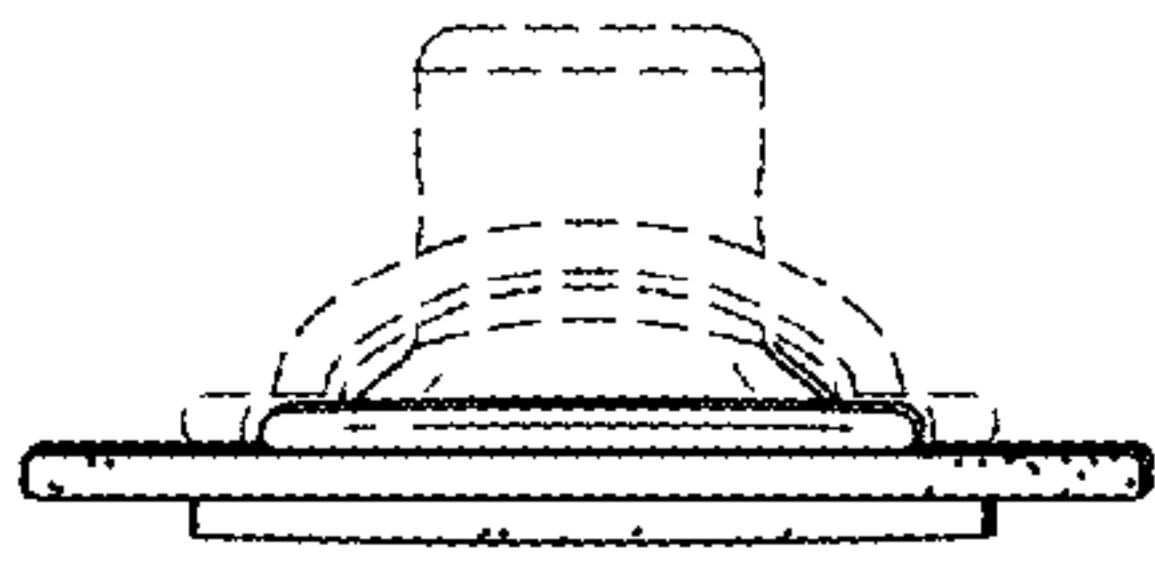

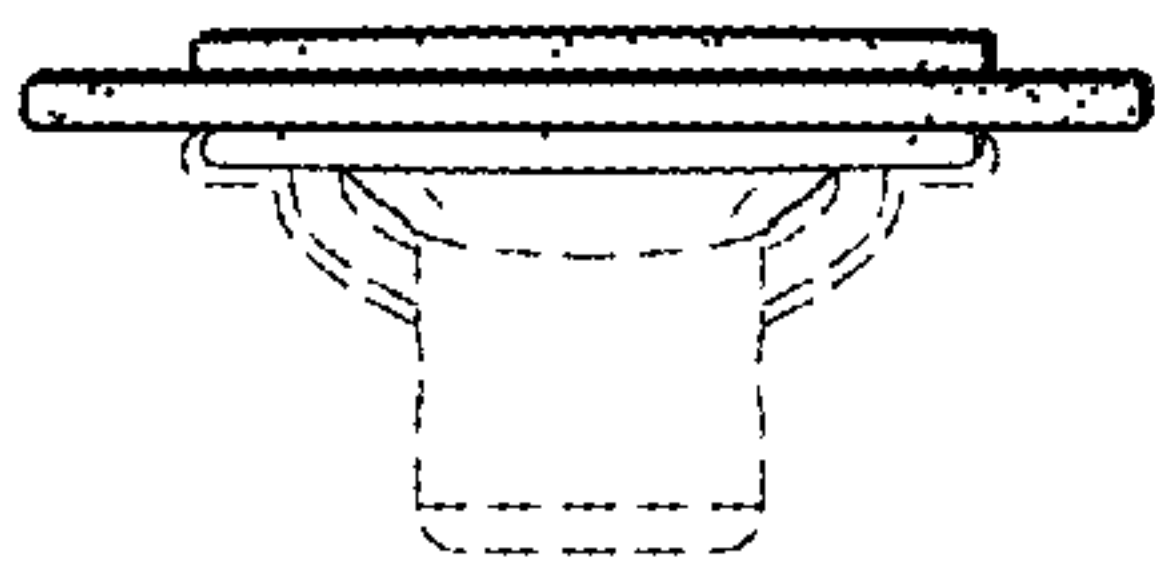

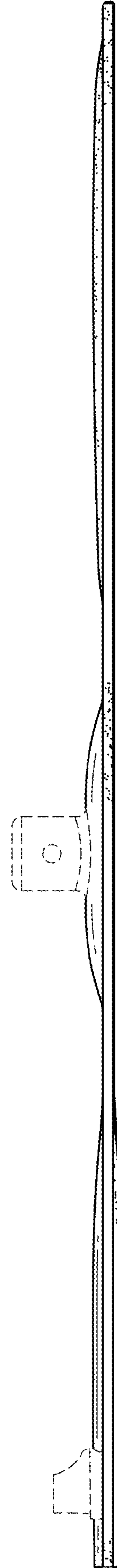

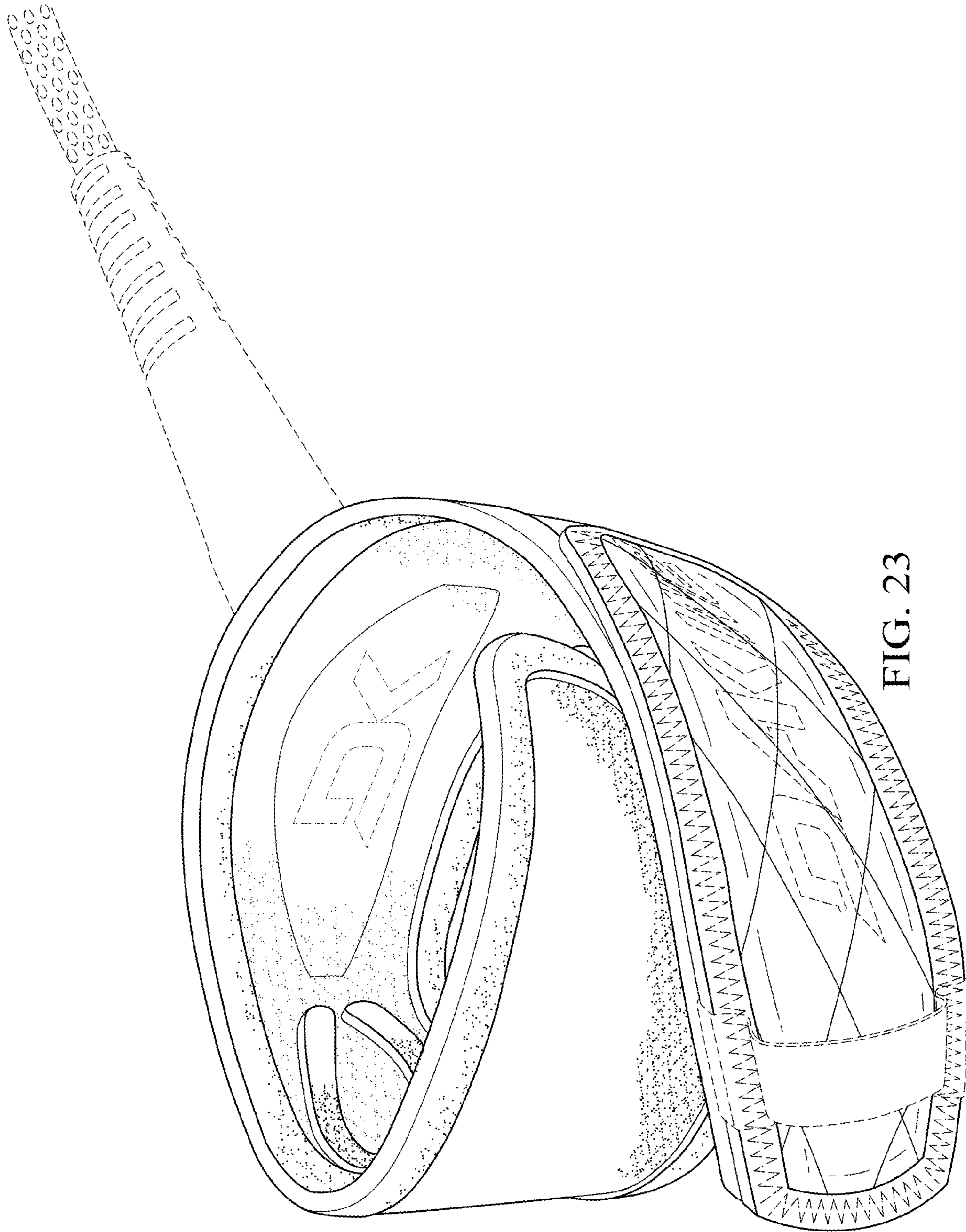

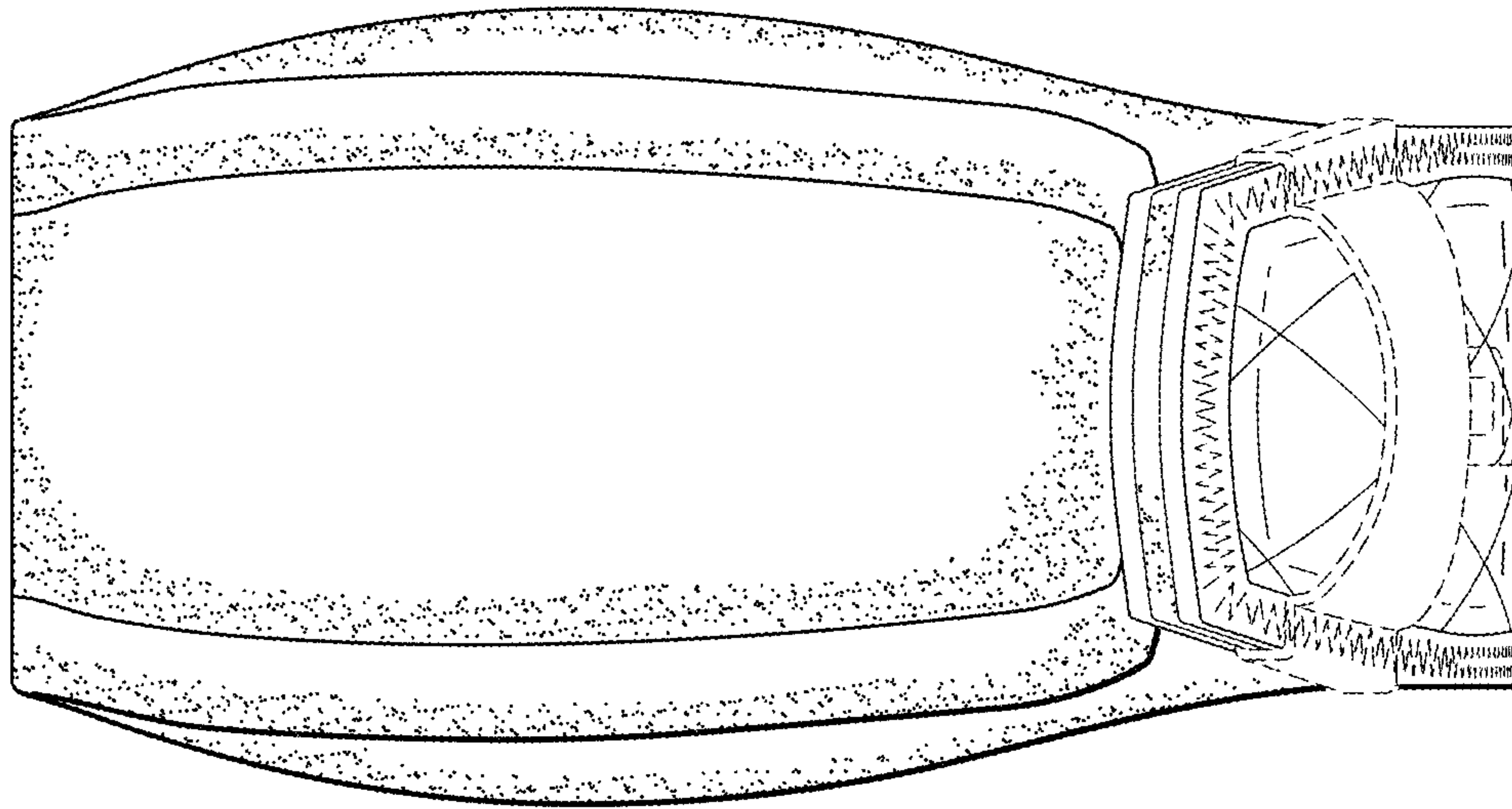

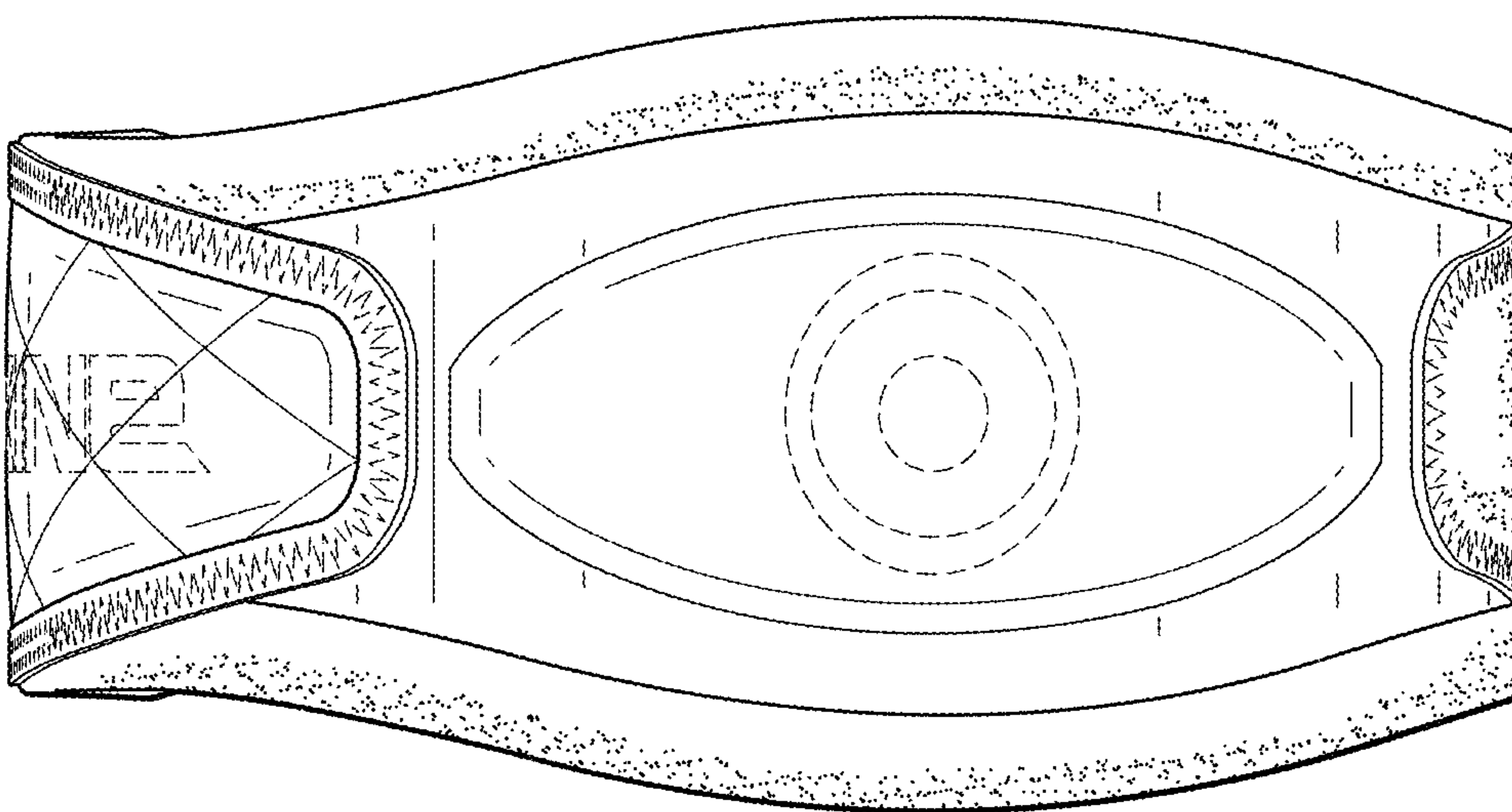

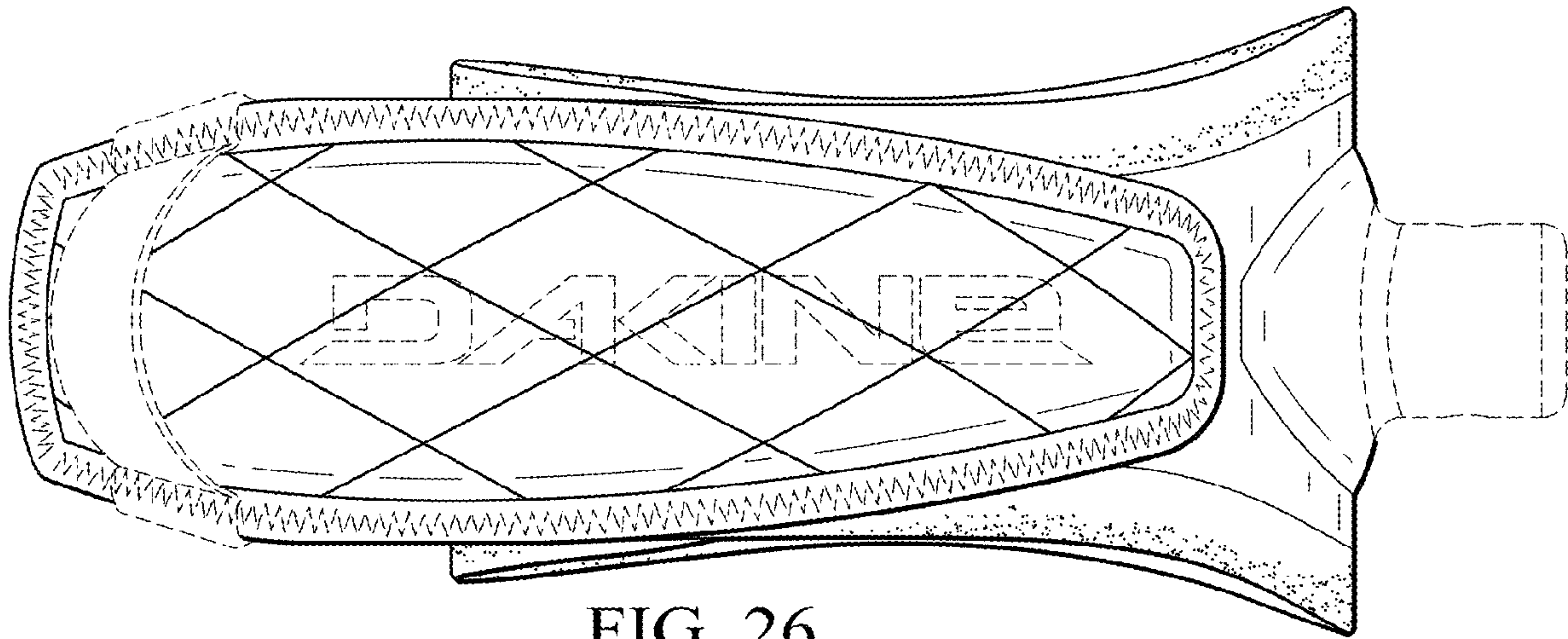

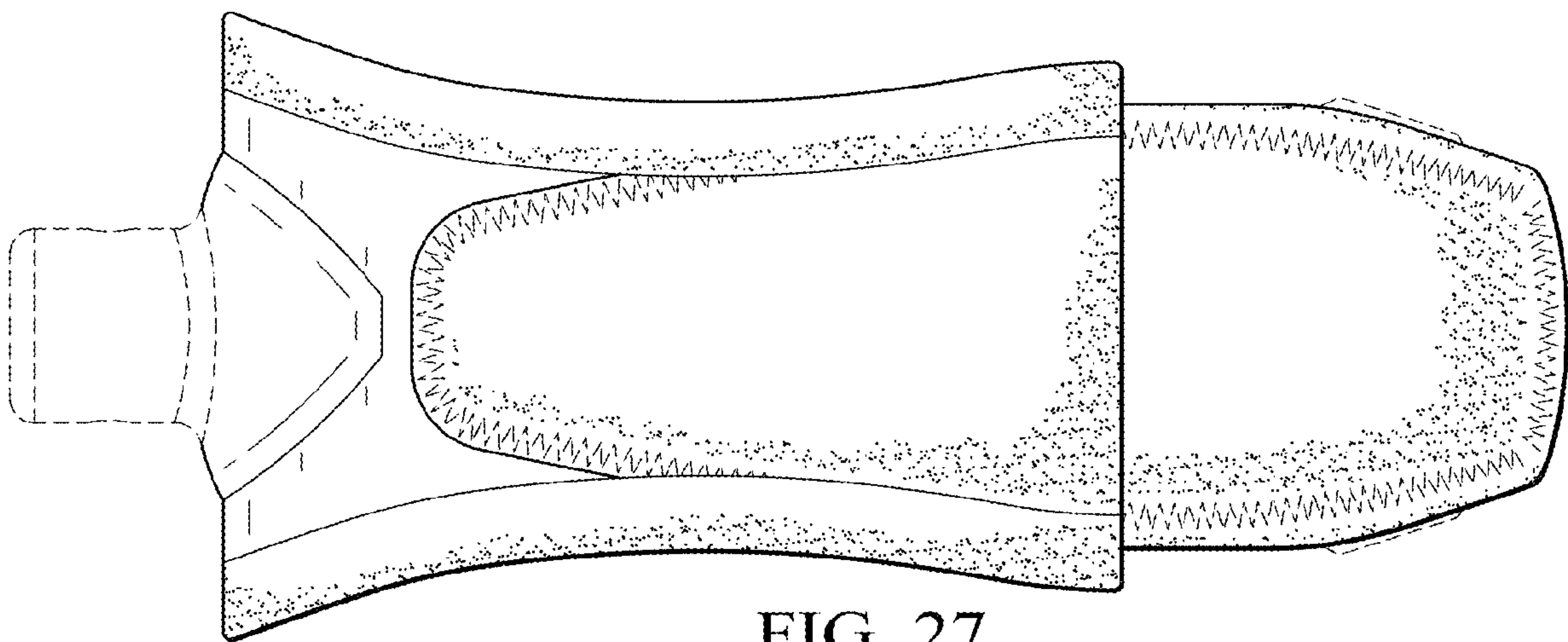

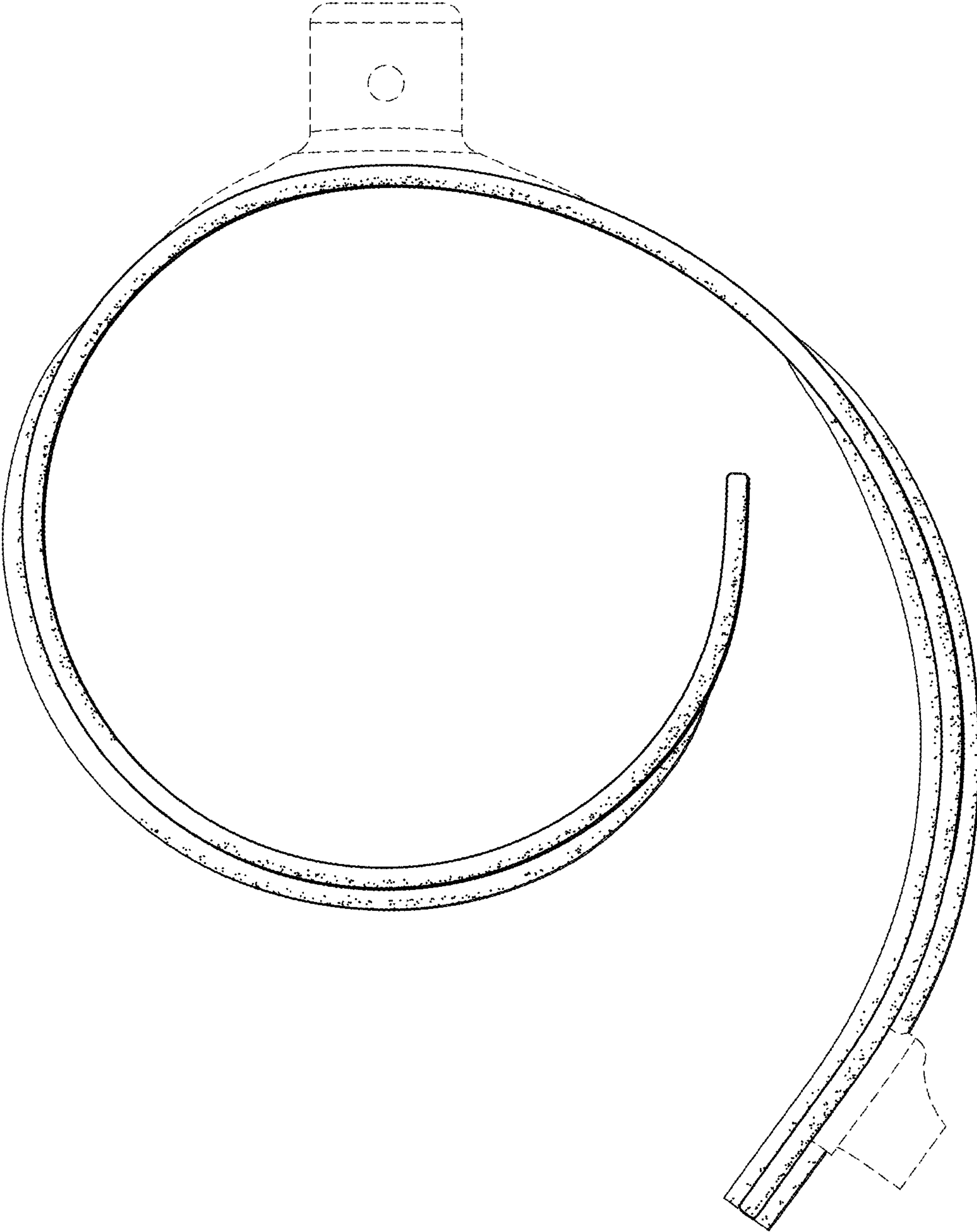

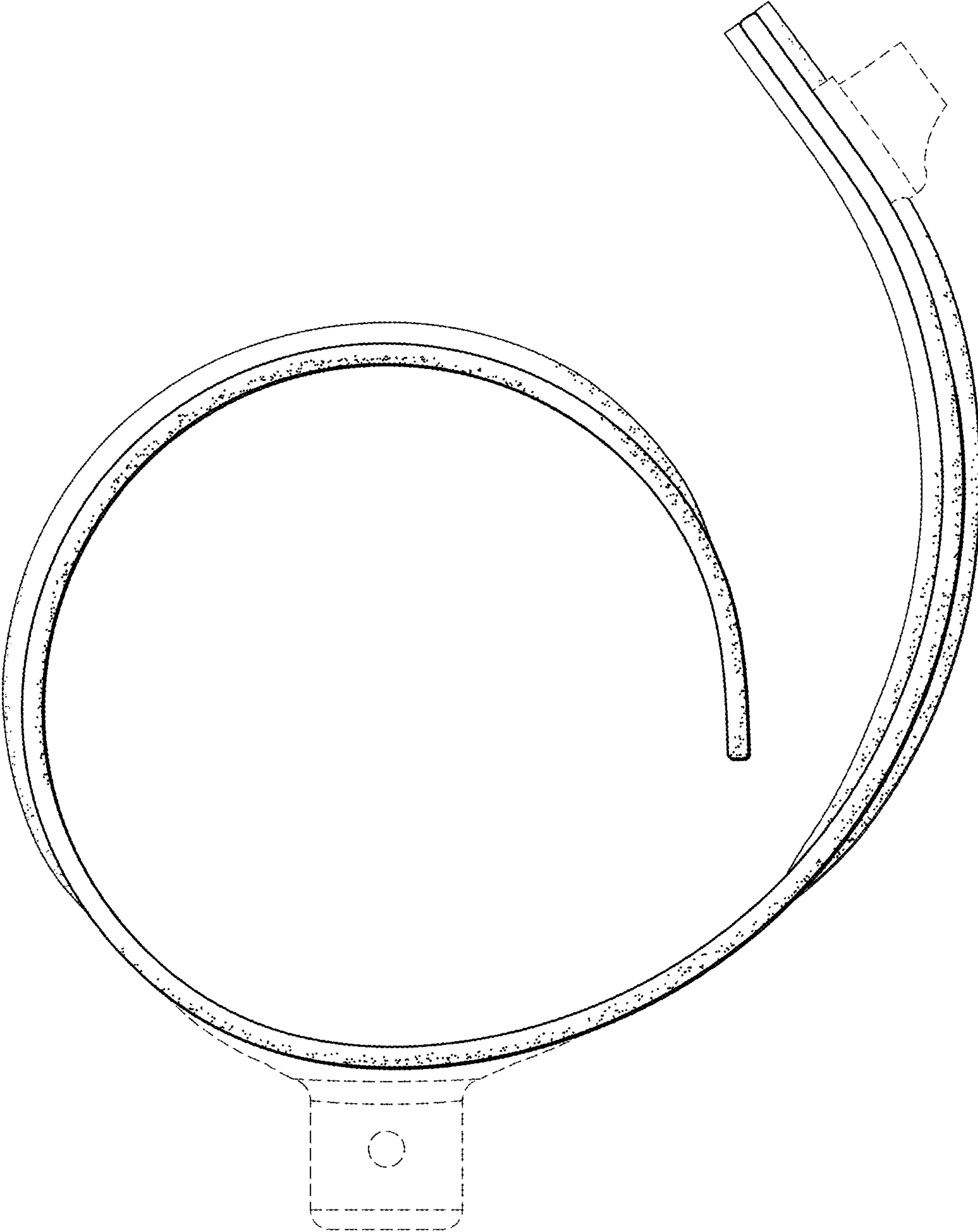

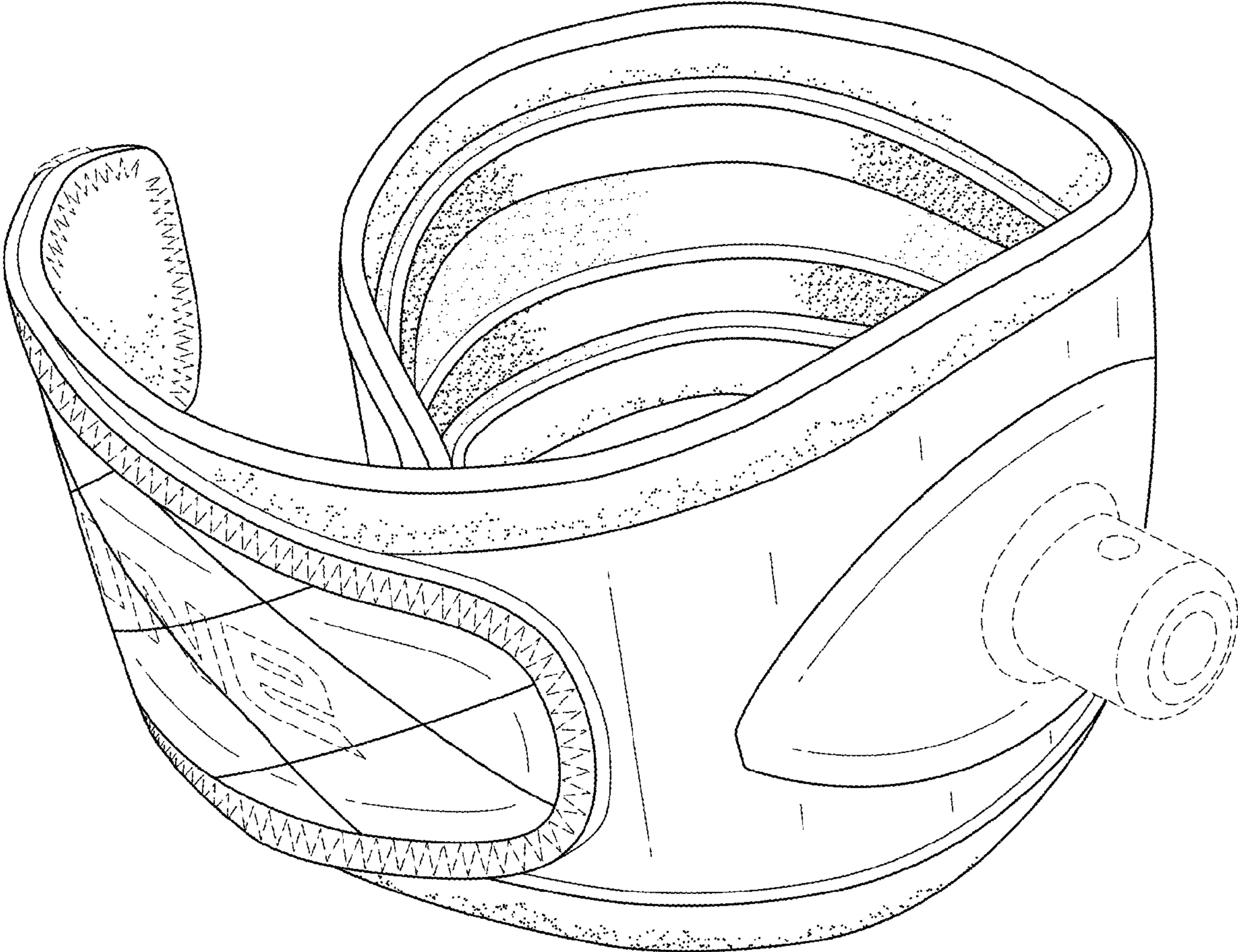
