**DESCRIPTION**

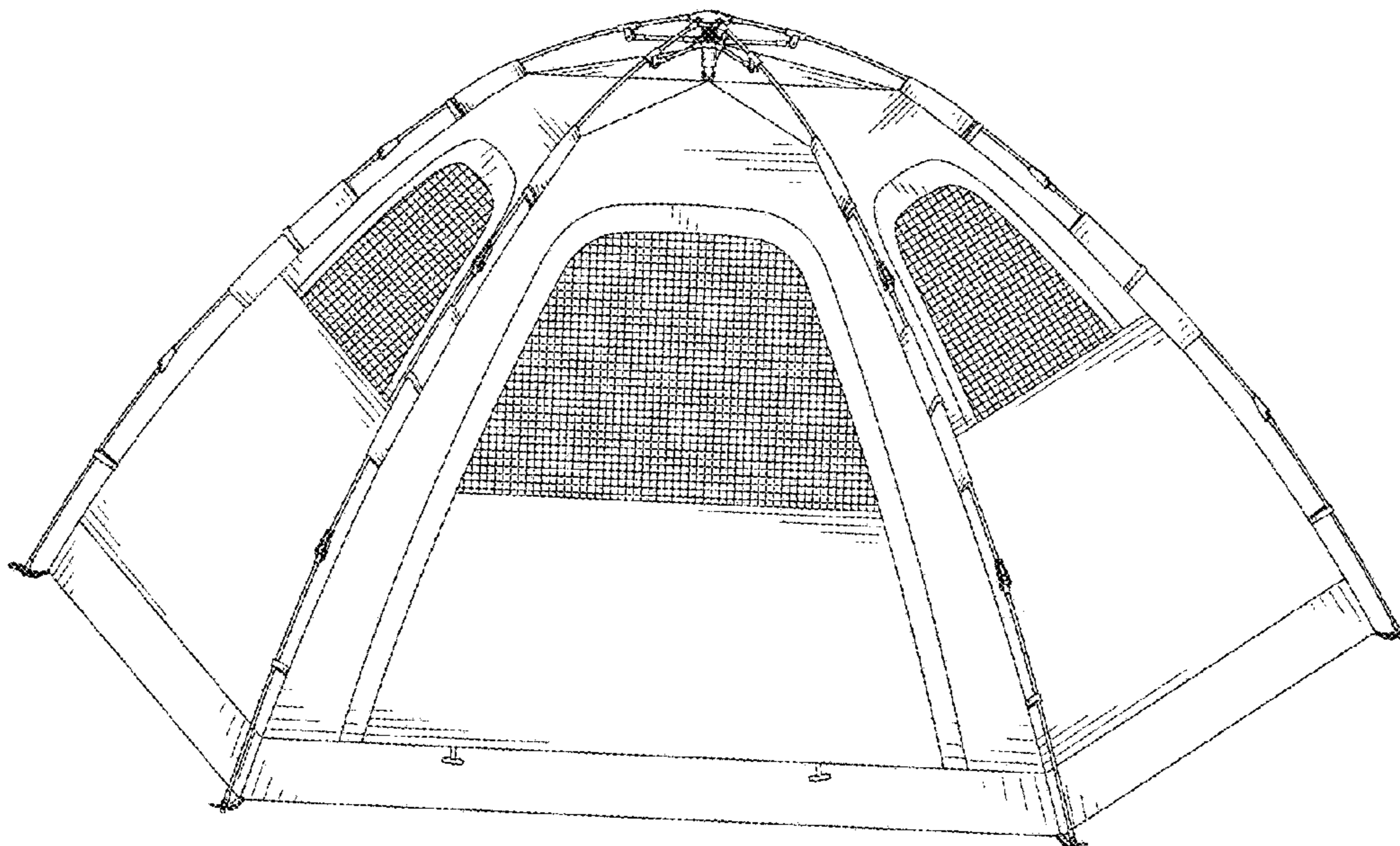
FIG. 1 is a front, right side, top perspective view of a tent showing my new design;

 FIG. 6 is a right side elevational view thereof;  
 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a bottom plan view thereof;  
 FIG. 9 is an enlarged partial view of the tent hub connector taken from the top of FIG. 2; and,  
 FIG. 10 is a front, right side, top perspective view thereof when the front flap of the tent is opened.  
 The broken lines represent the boundaries of the enlarged partial views of FIG. 9 and forms no part of the claimed design.

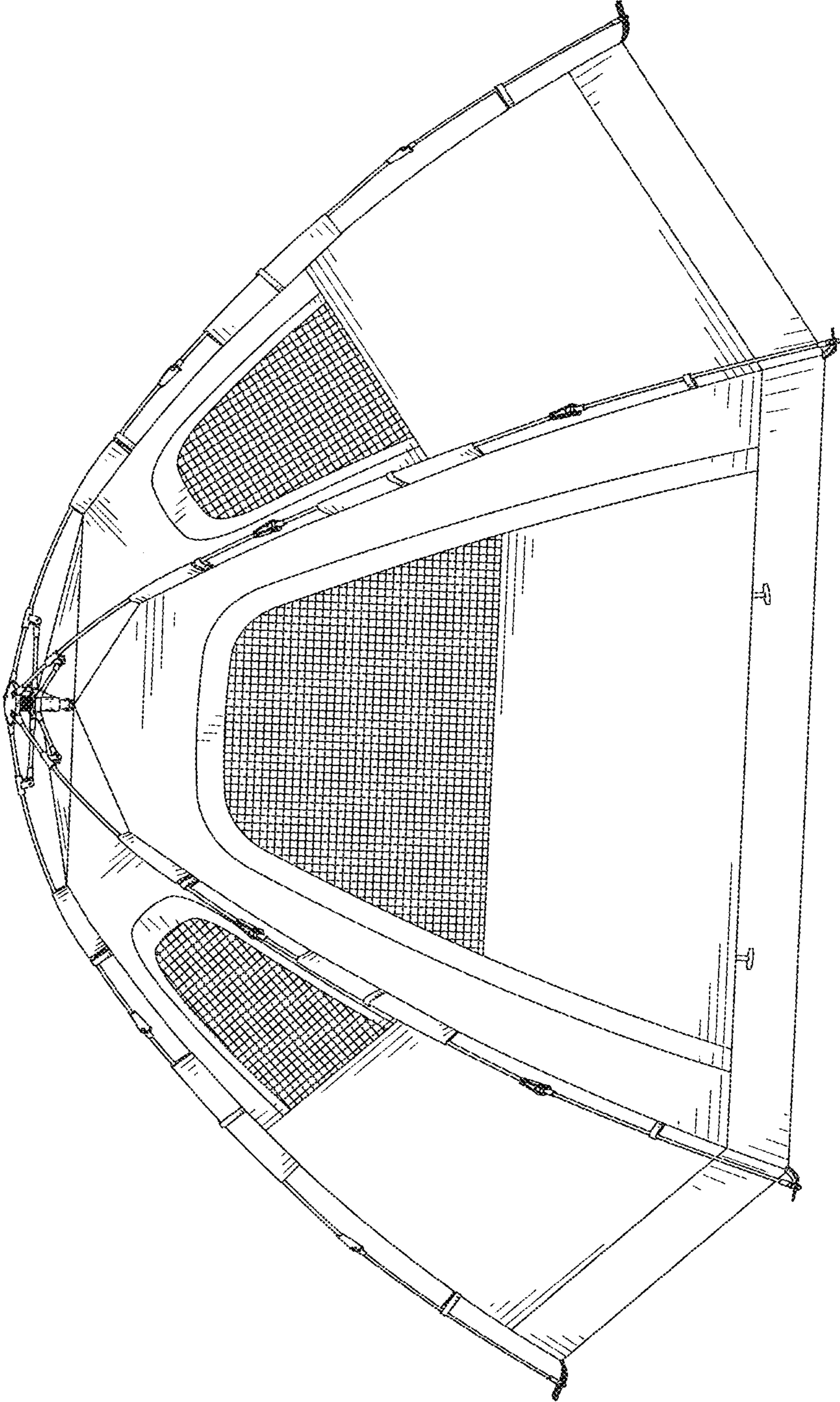

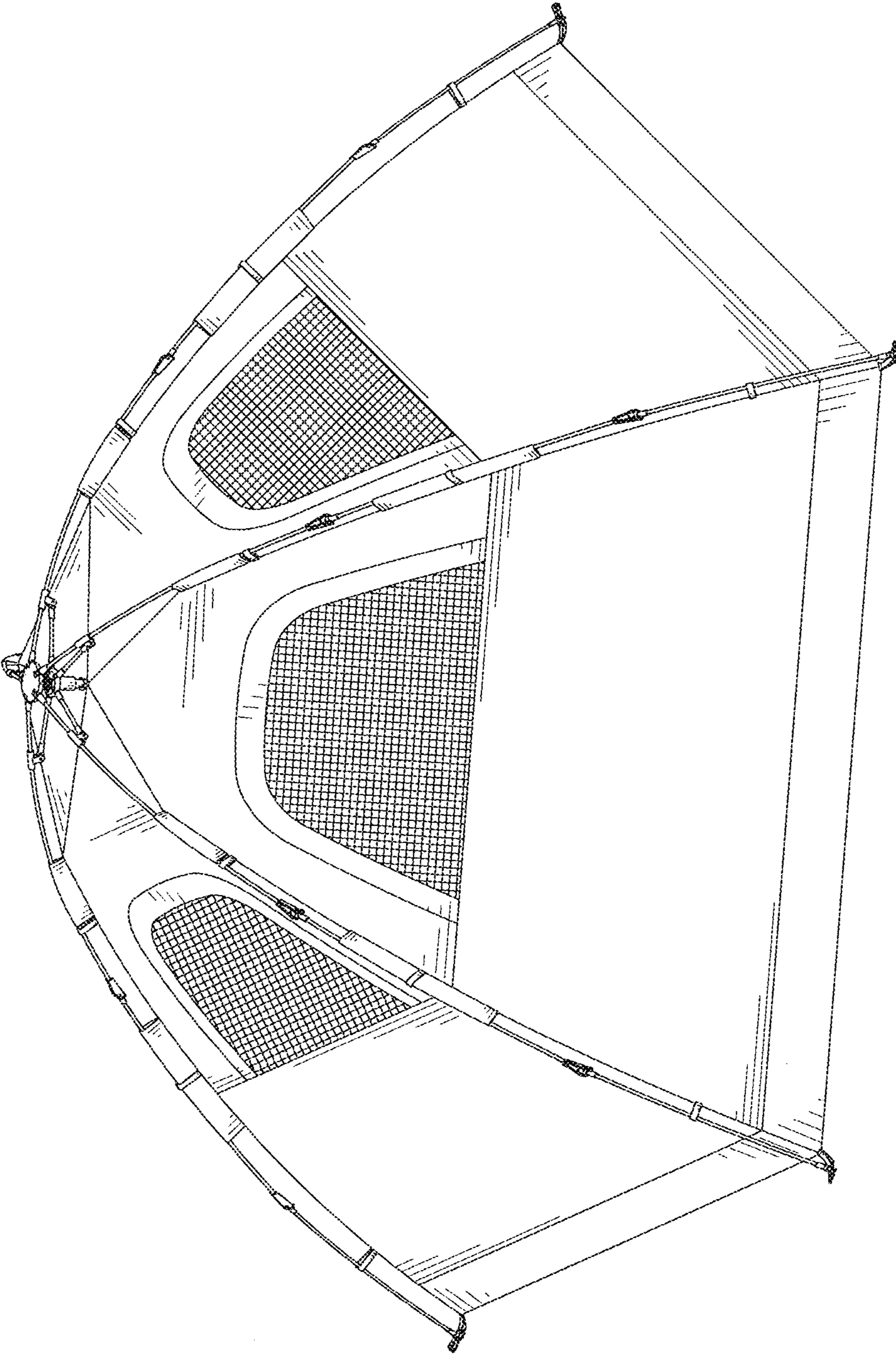

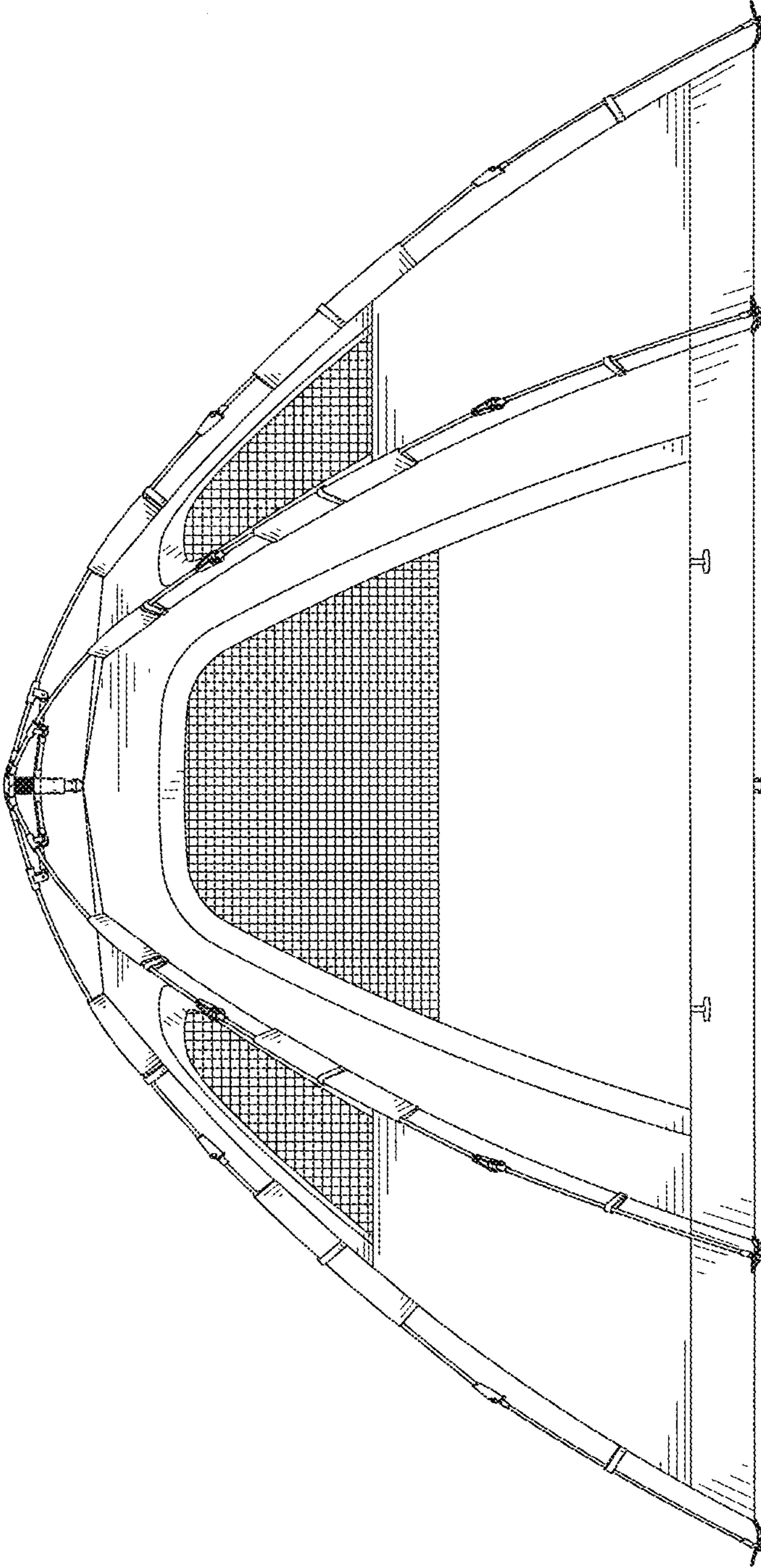

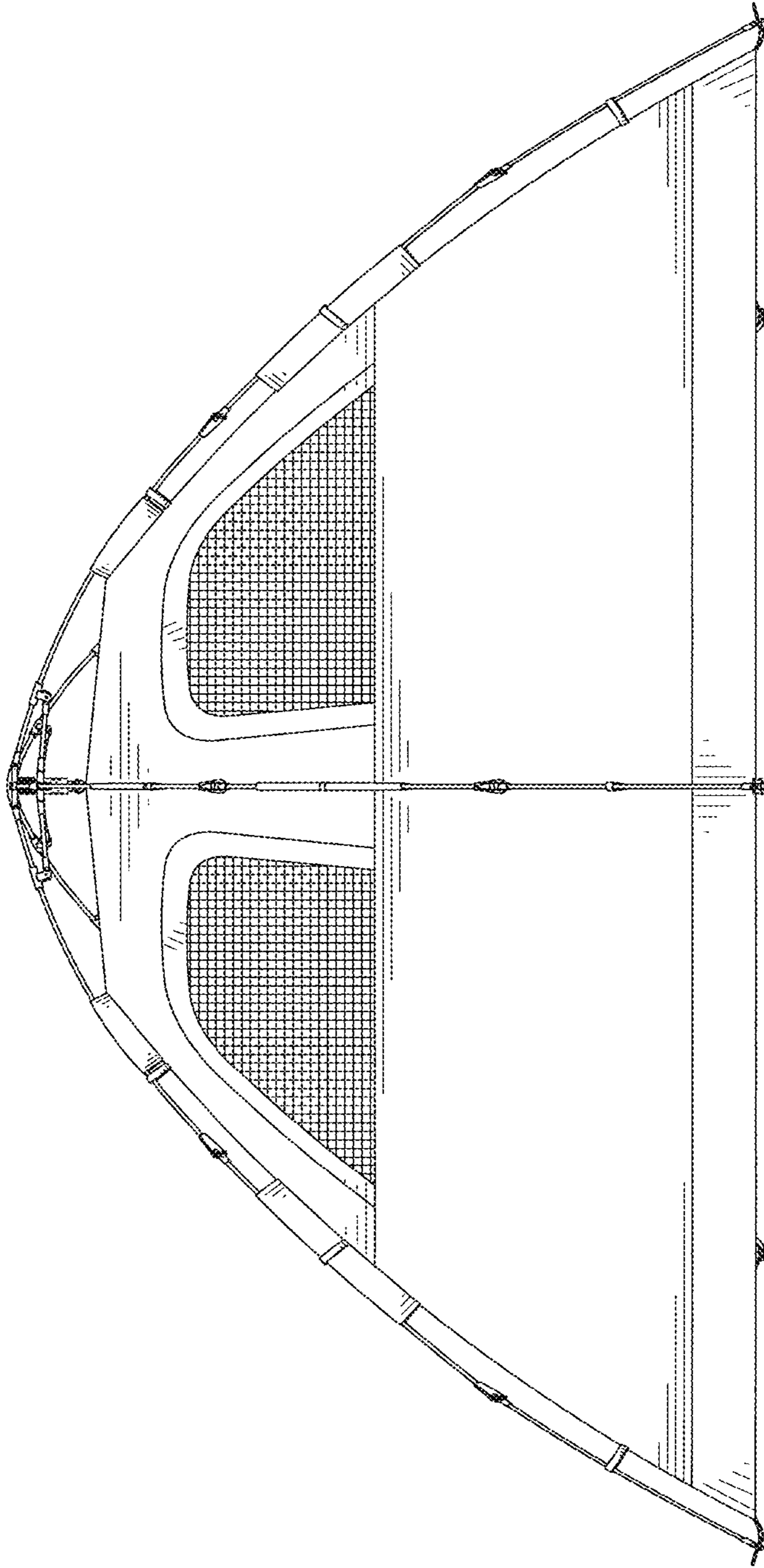

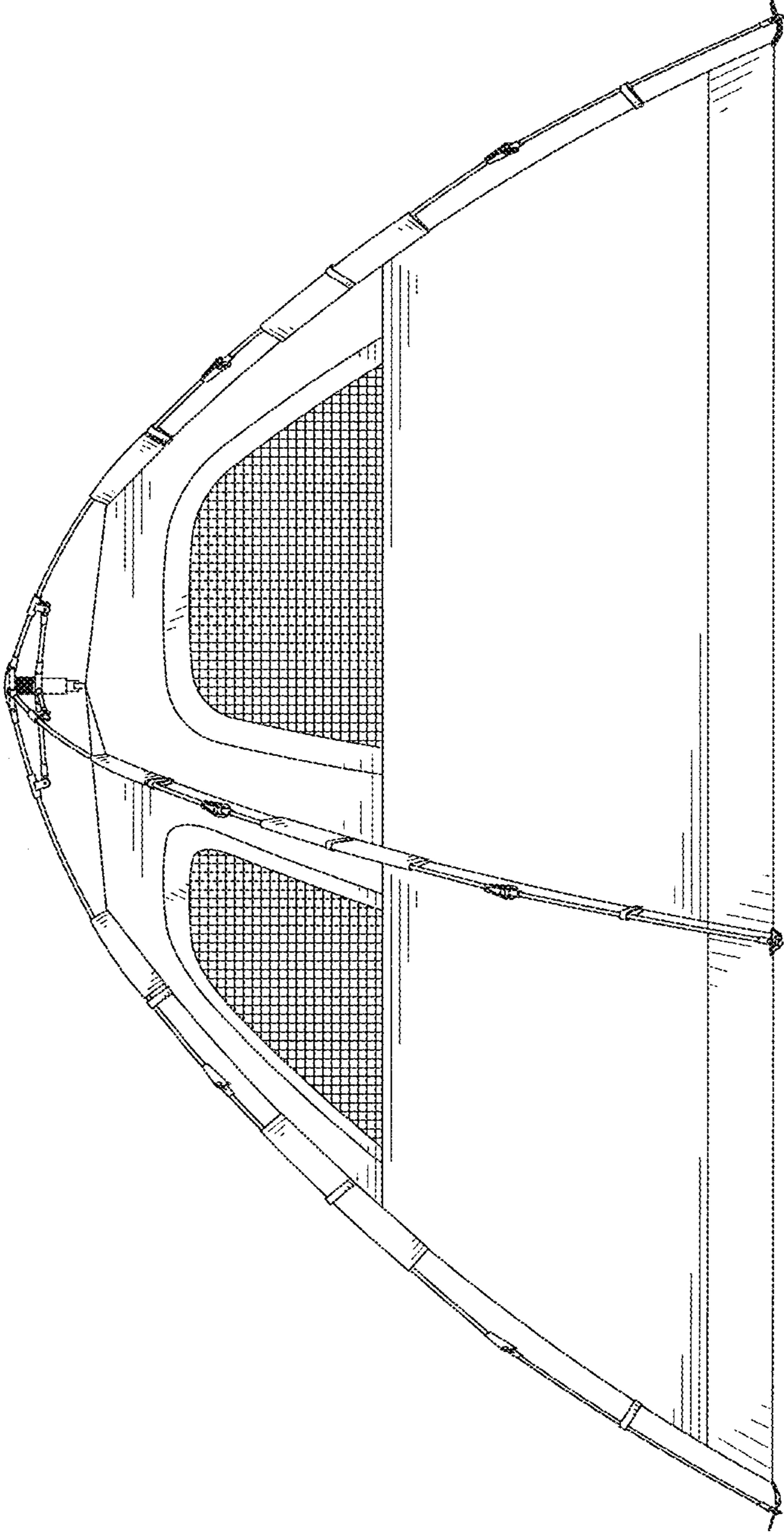

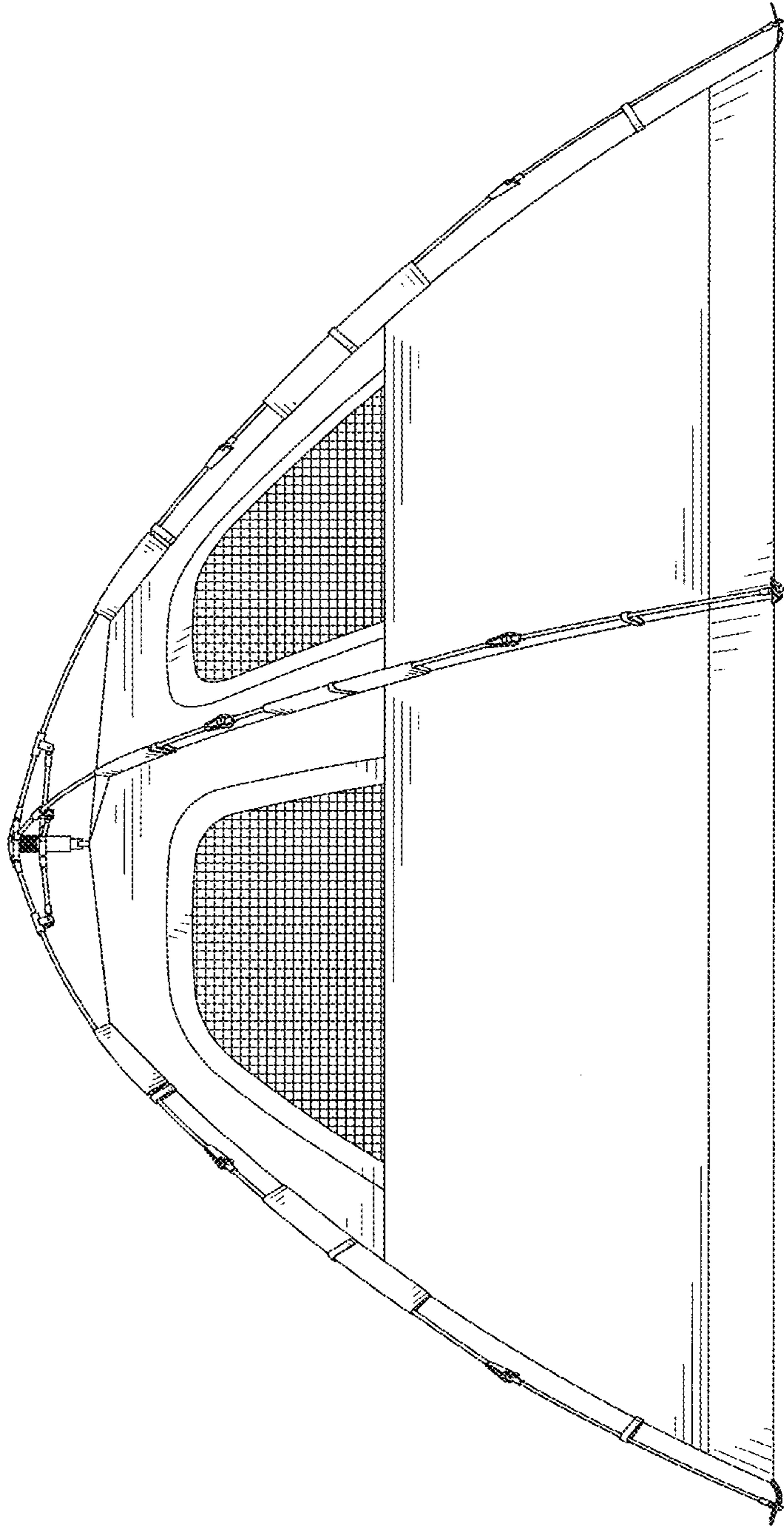

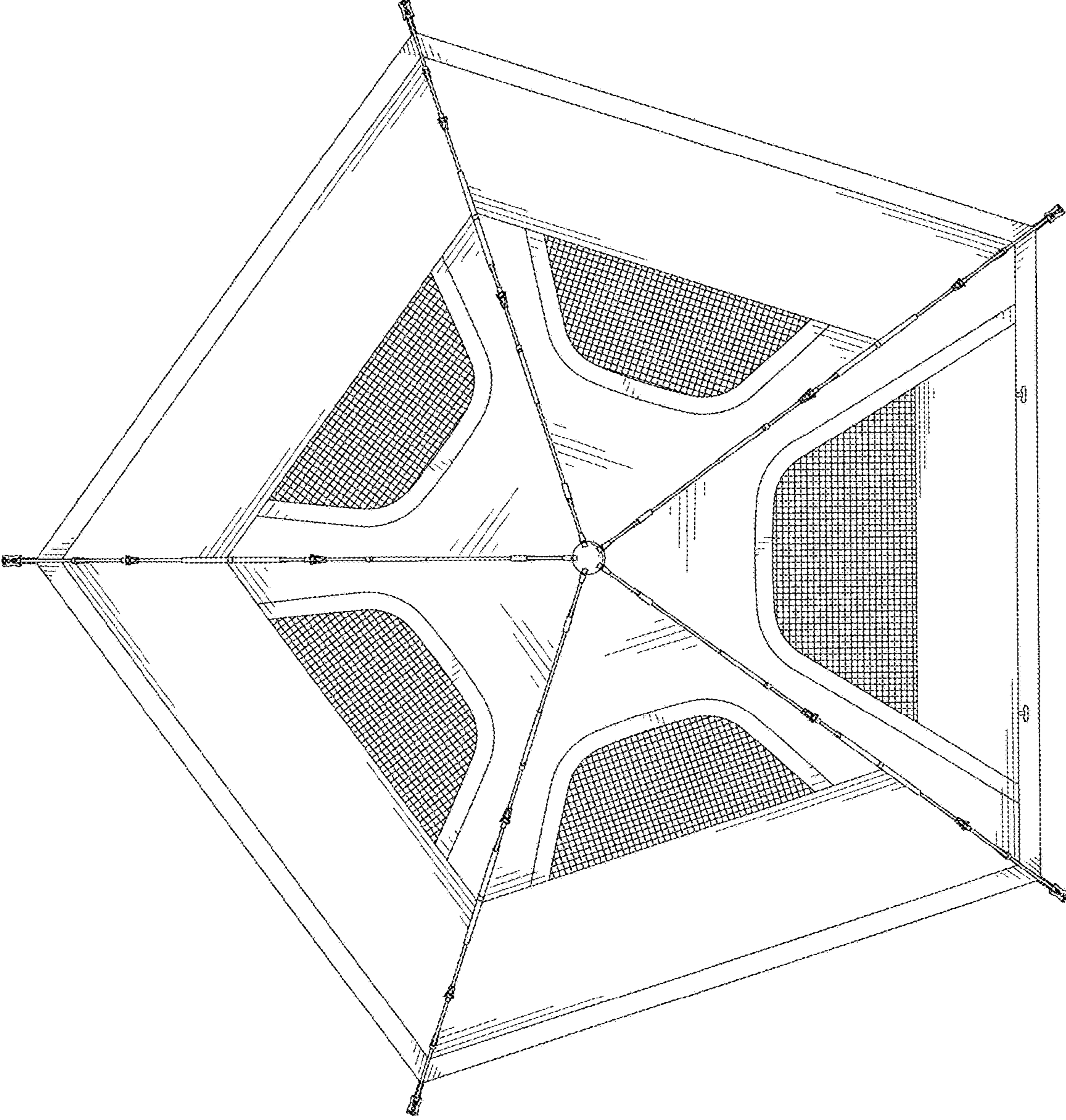

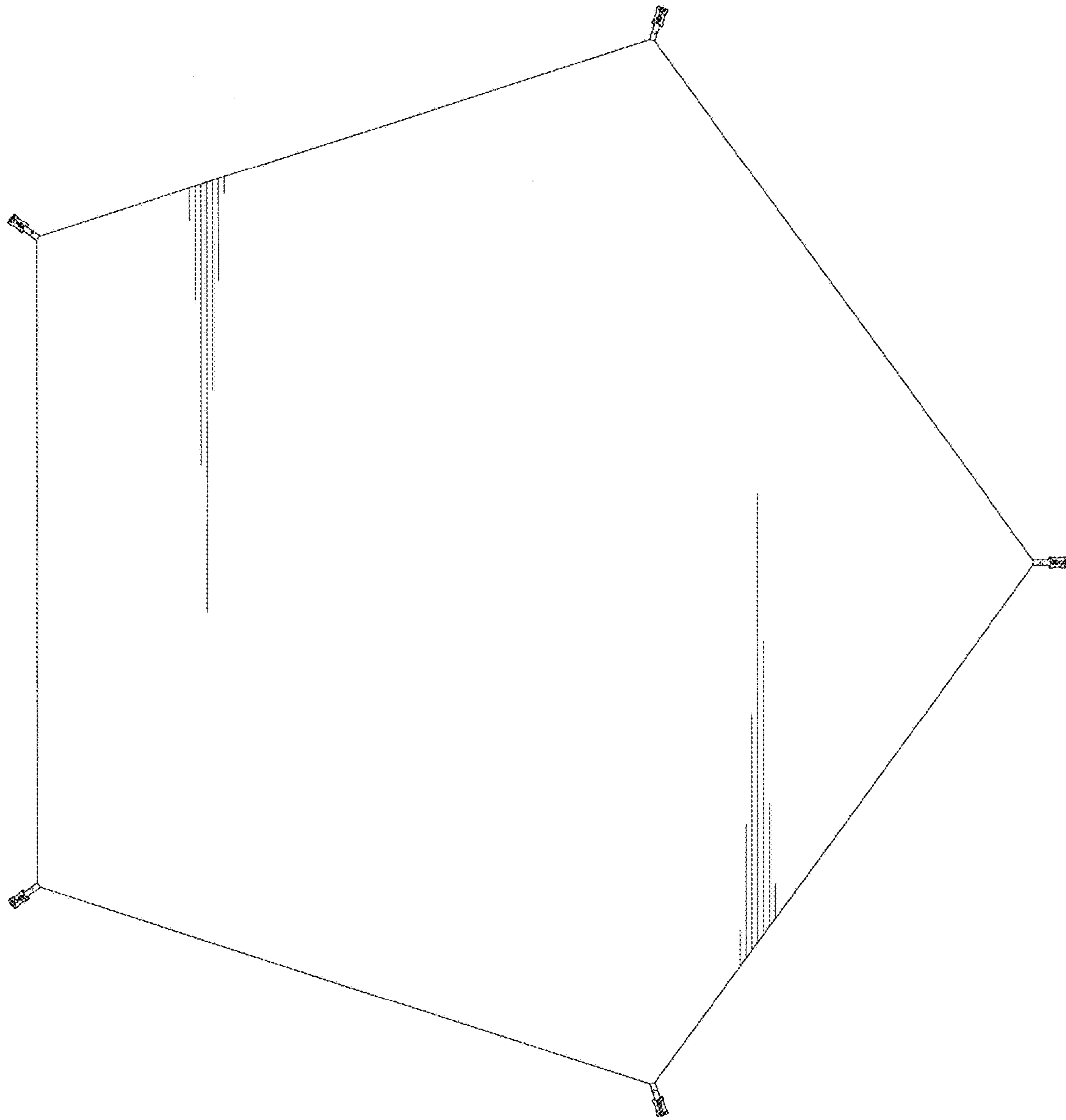

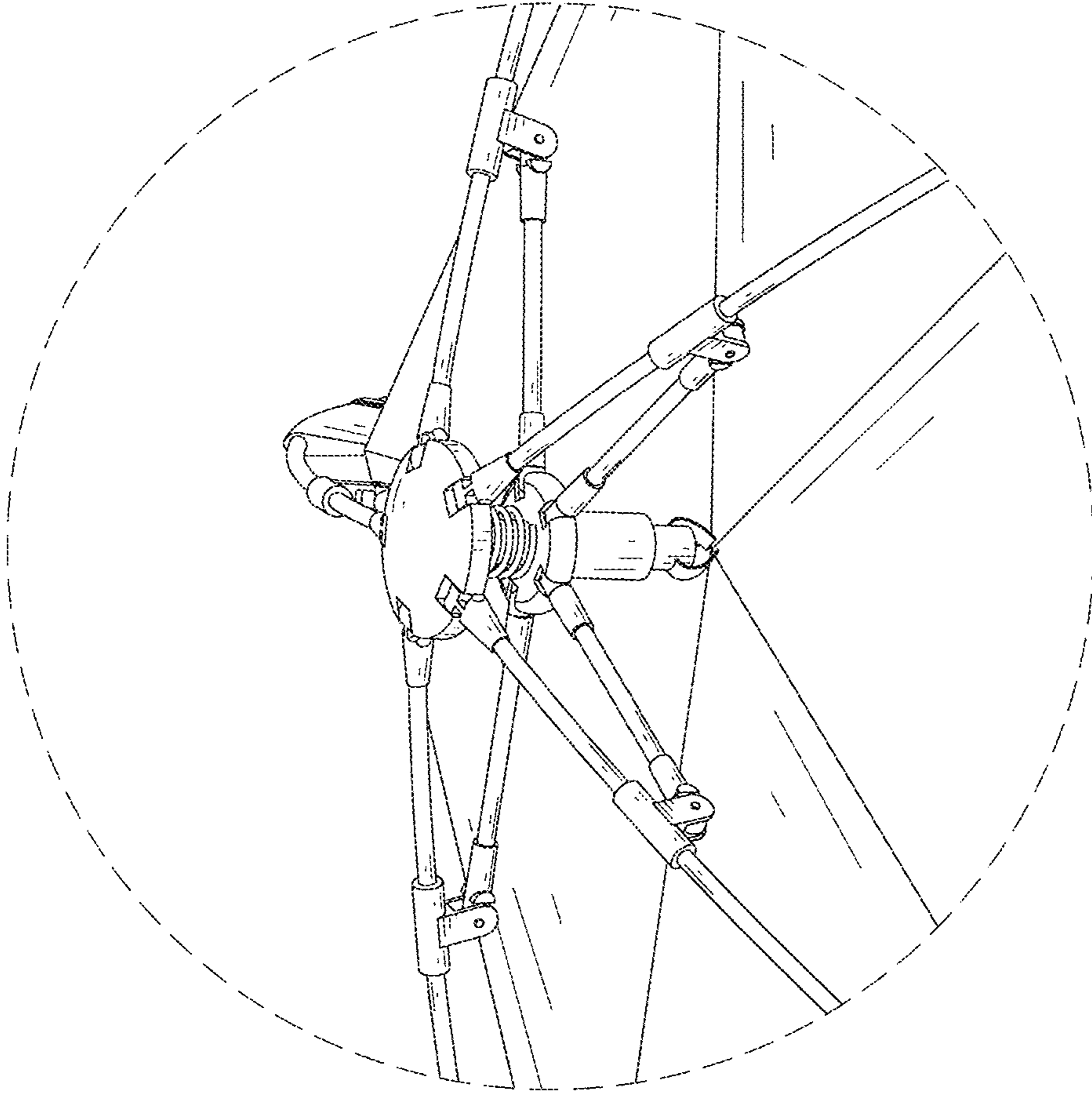

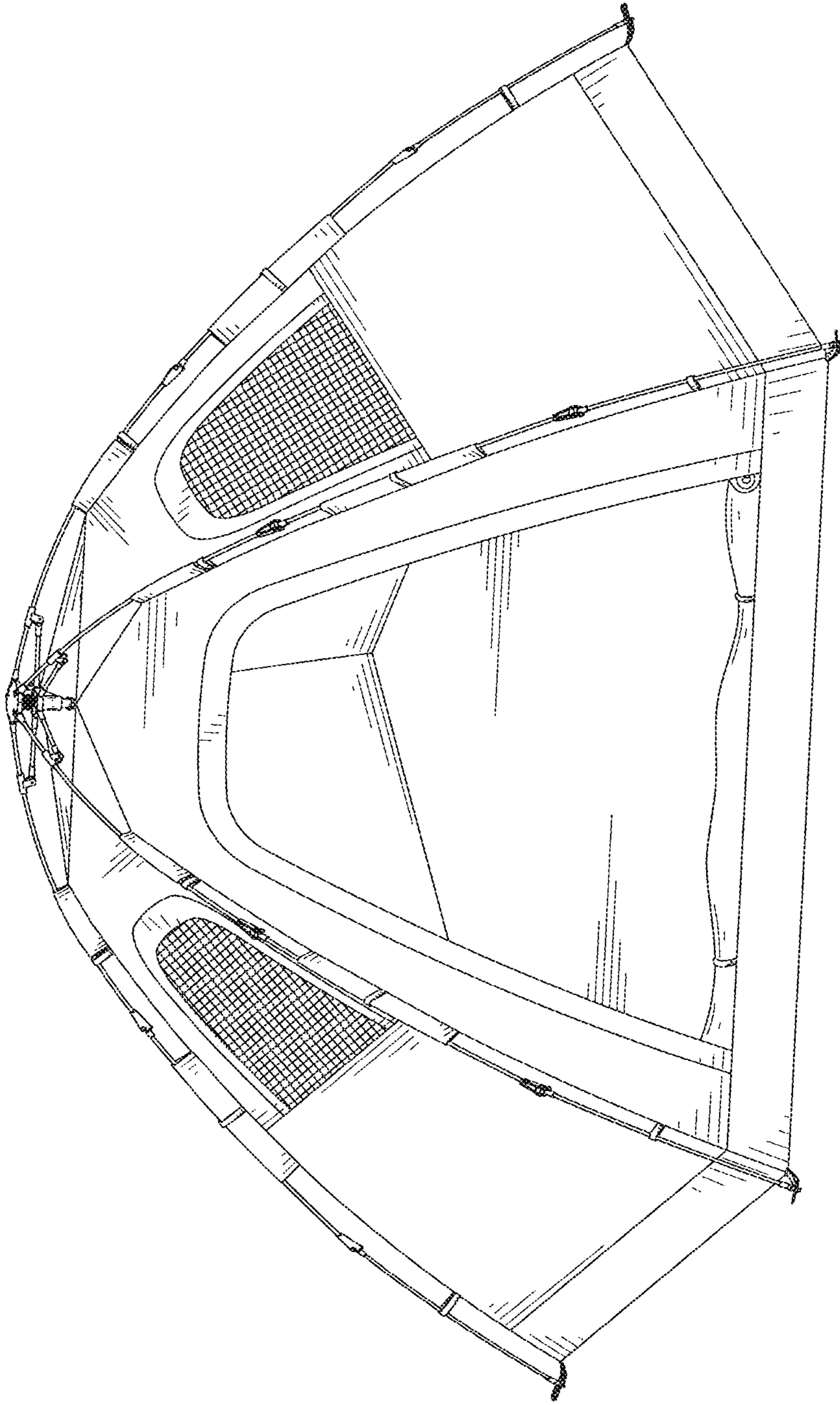
