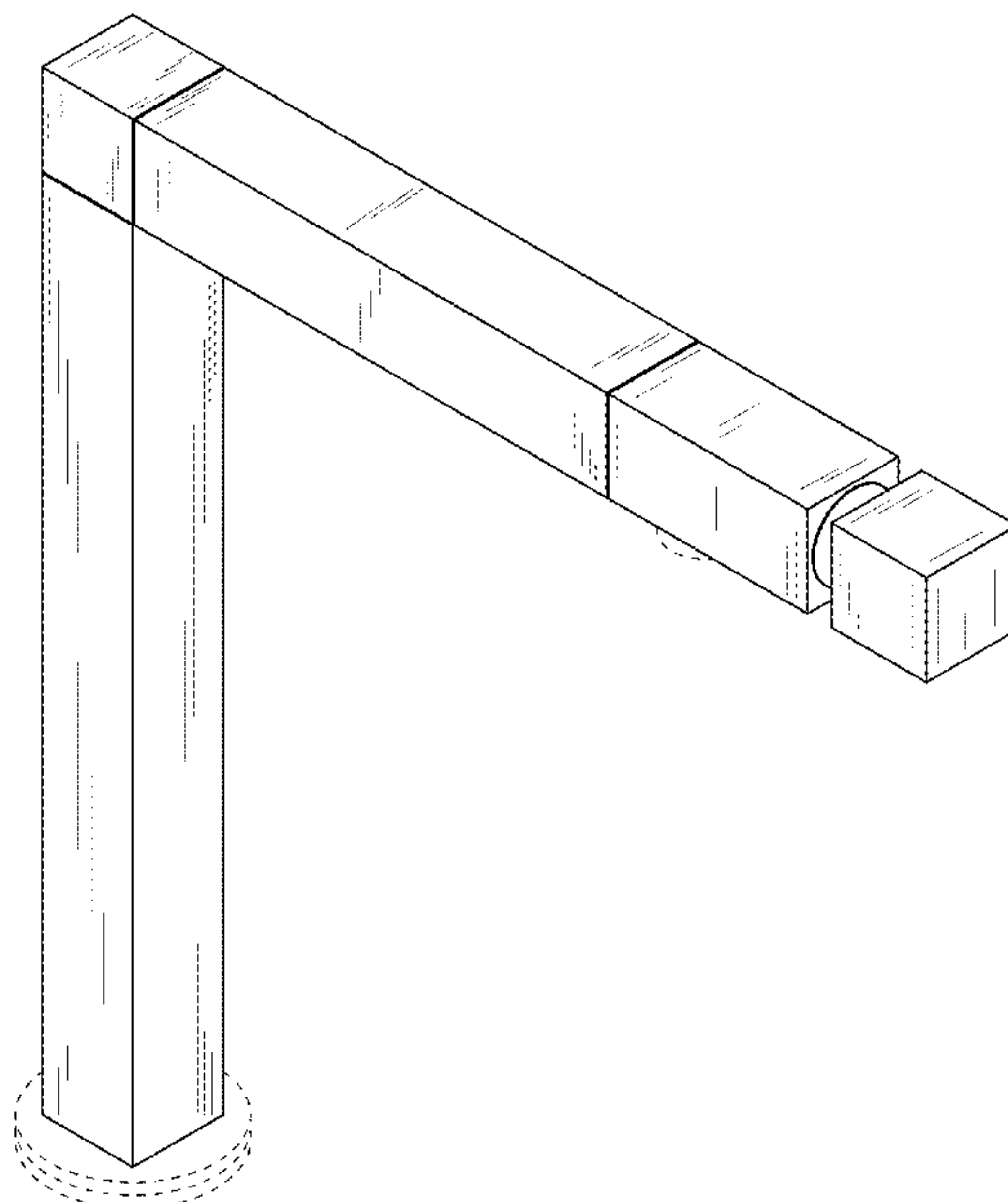
CLAIM

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a faucet incorporating my new design;

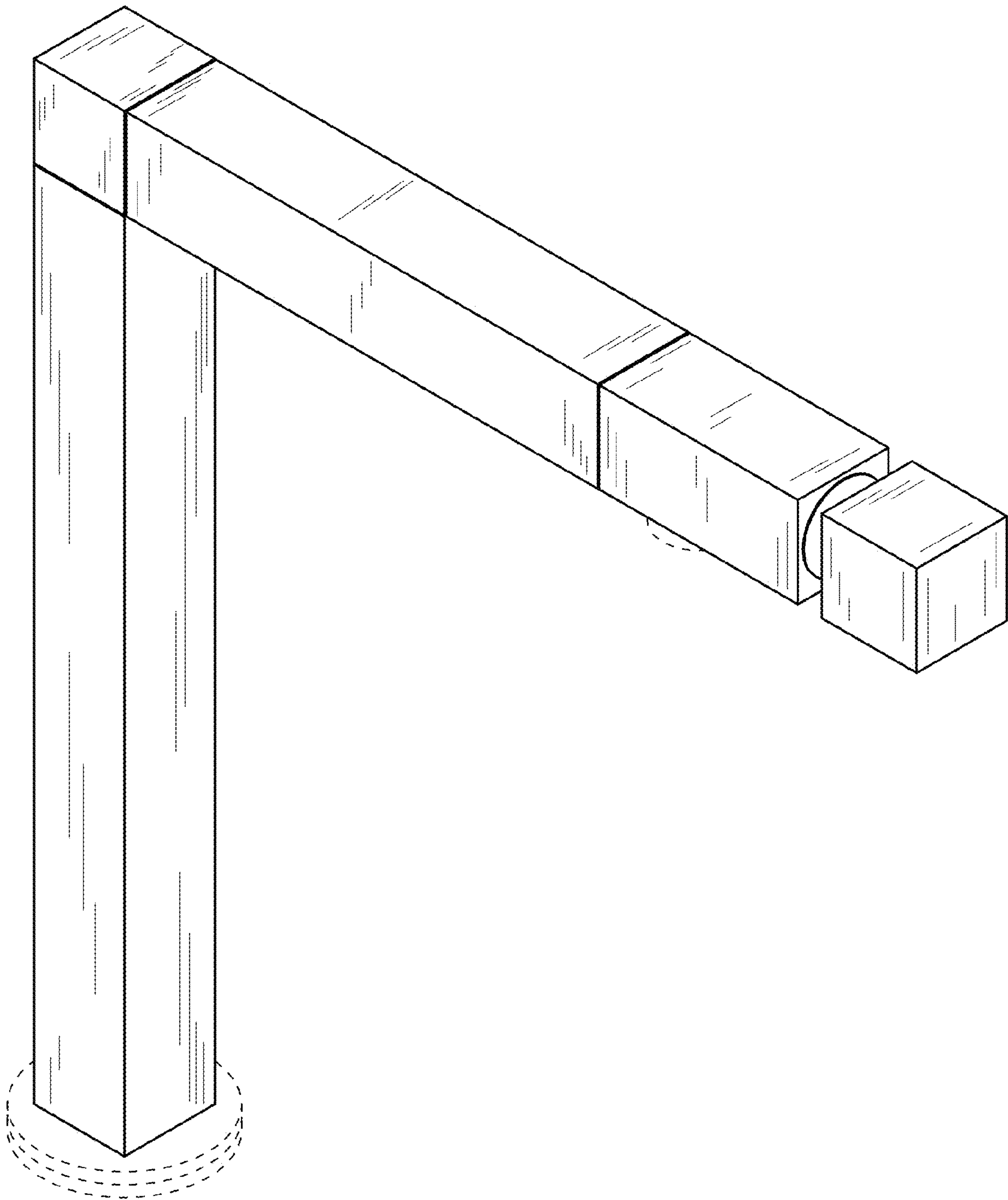

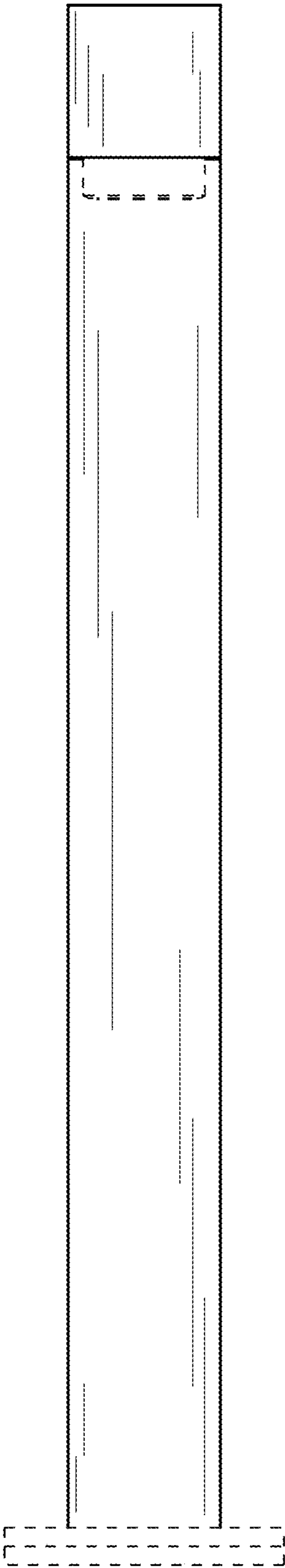

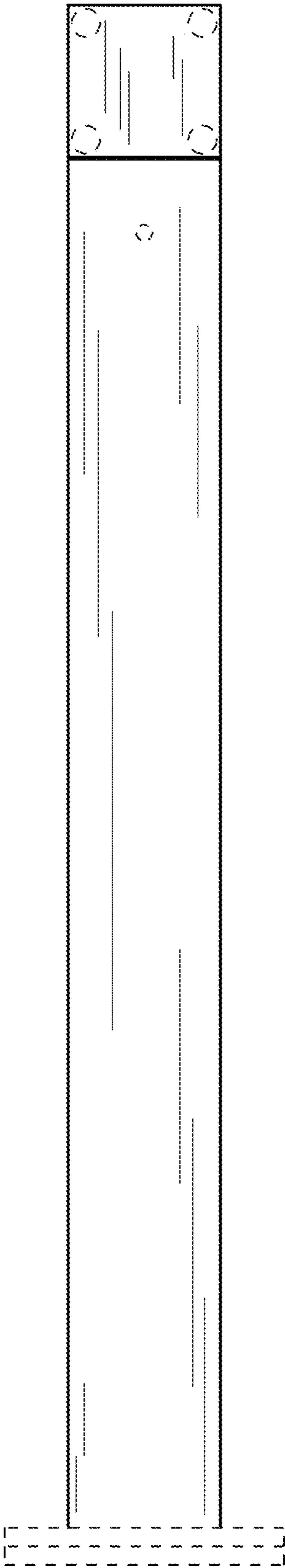

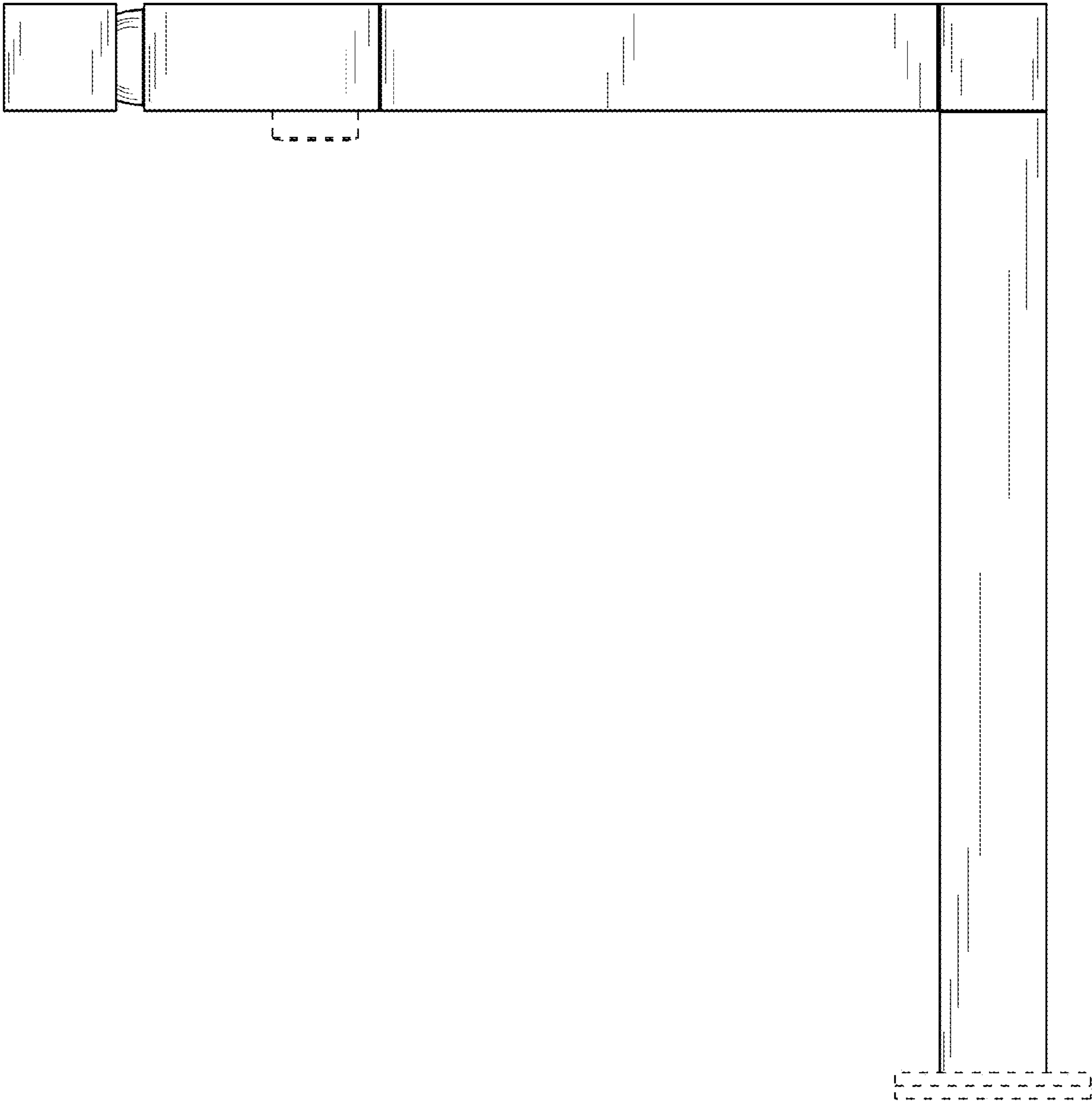

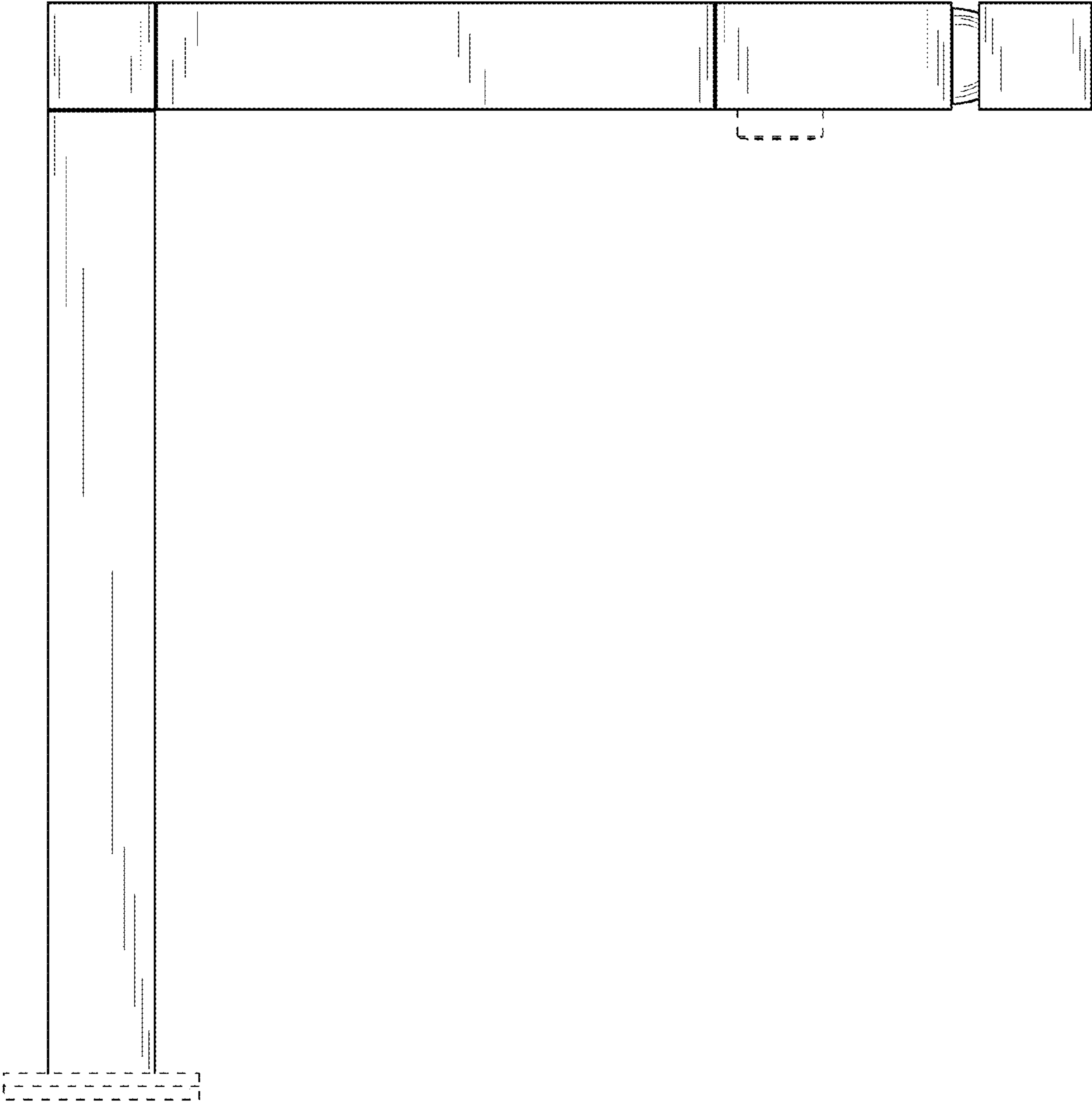

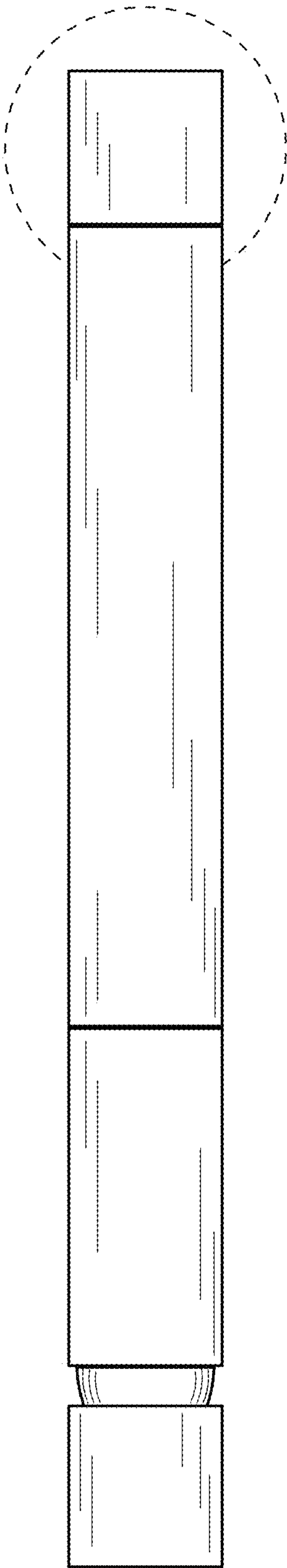

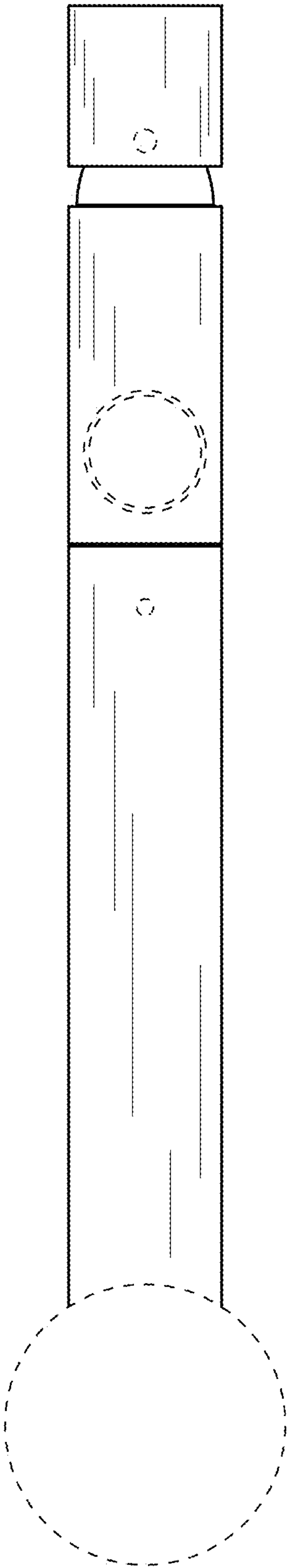
