(57) **CLAIM**

The ornamental design for a fastening member portion of a disposable diaper, as shown and described.

DESCRIPTION

1 is a rear view of a fastening member portion of a disposable diaper, showing our new design;

2 is a rear view of a second embodiment of a fastening member portion of a disposable diaper;

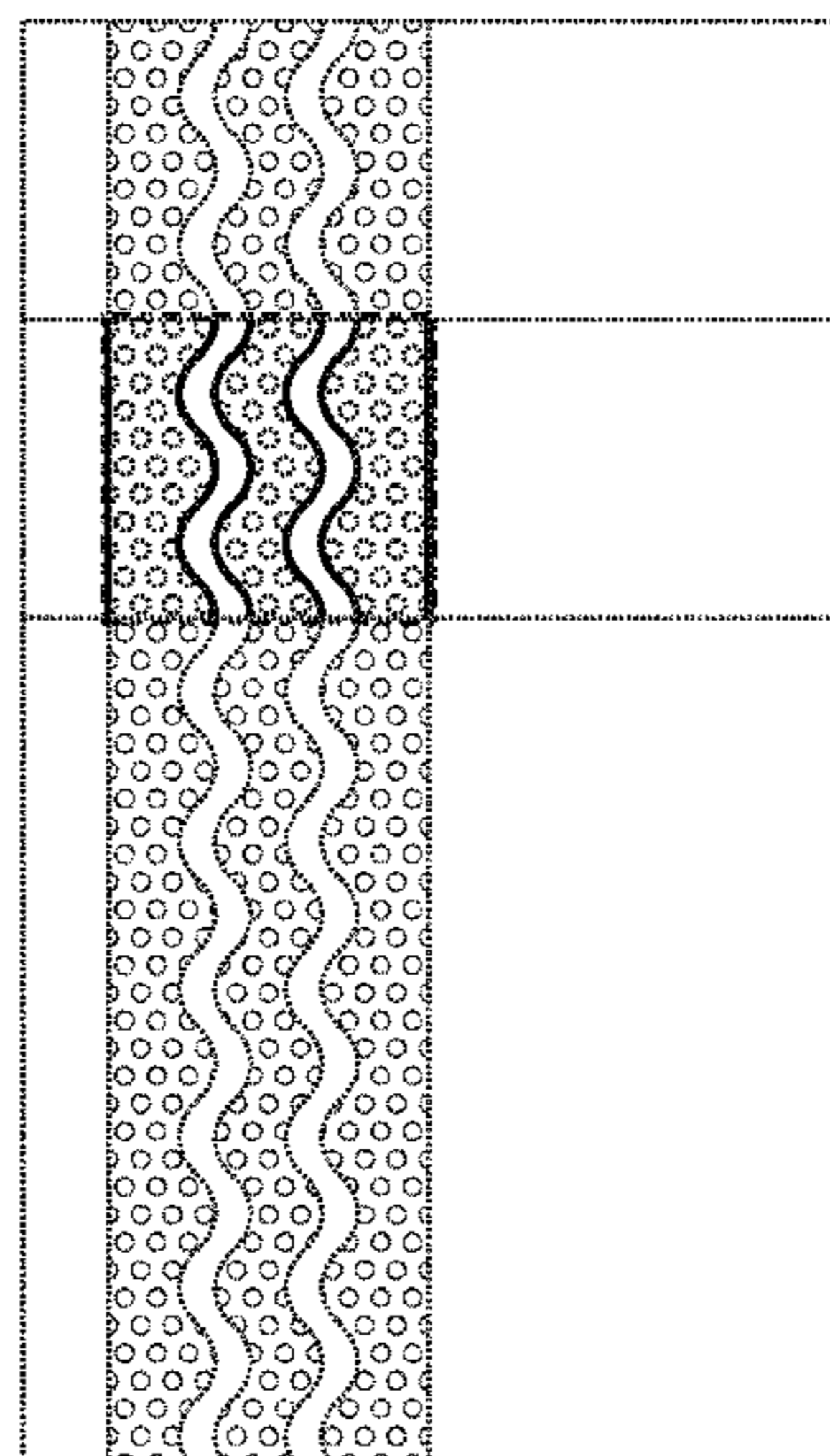
3 is a rear view of a third embodiment of a fastening member portion of a disposable diaper; and

4 is a rear view of a fastening member portion of a disposable diaper.

The dash dot dot dash broken line depicts the claim boundary and forms no part thereof. The dotted pattern inside of the claim boundary depicts any pattern resulting from fastening elements. All other dashed lines depict portions of a fastening member portion of a disposable diaper and form no part of the claim.

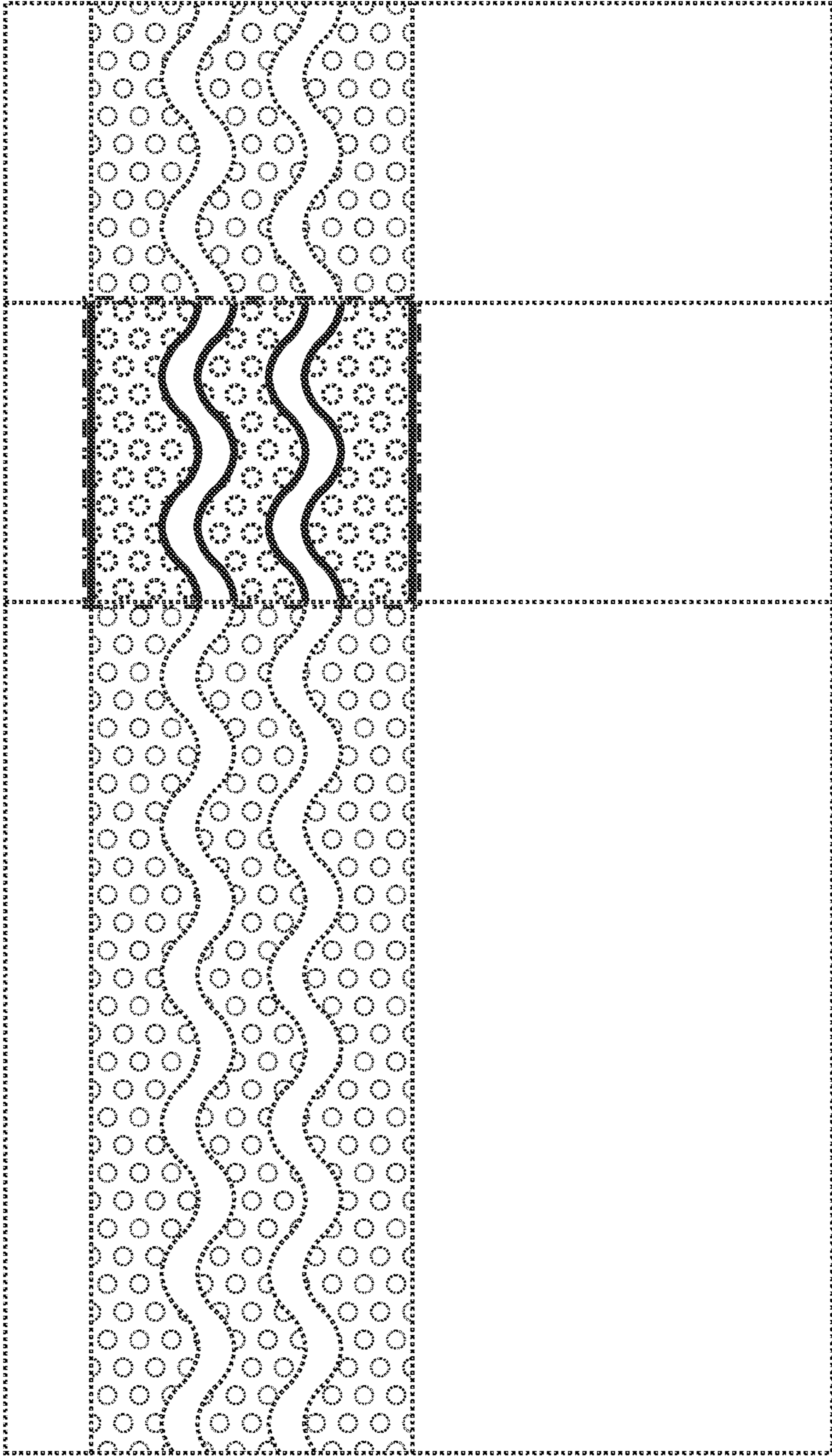

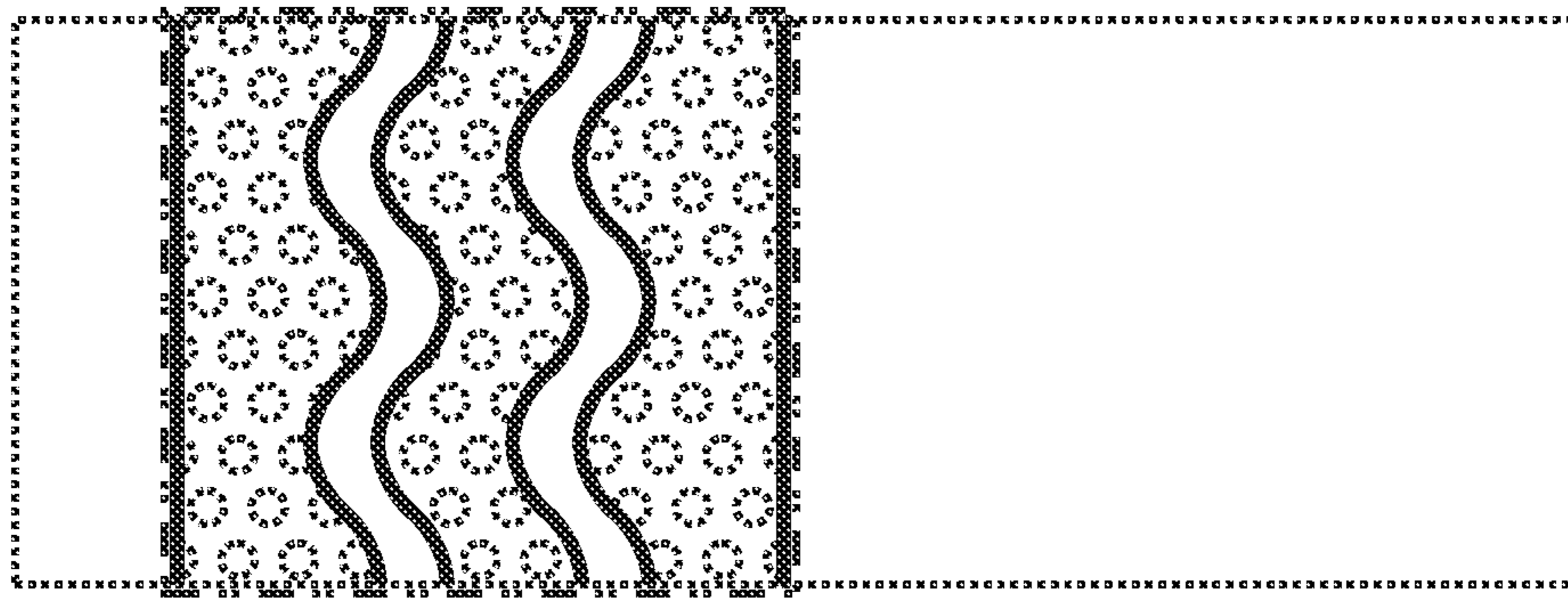

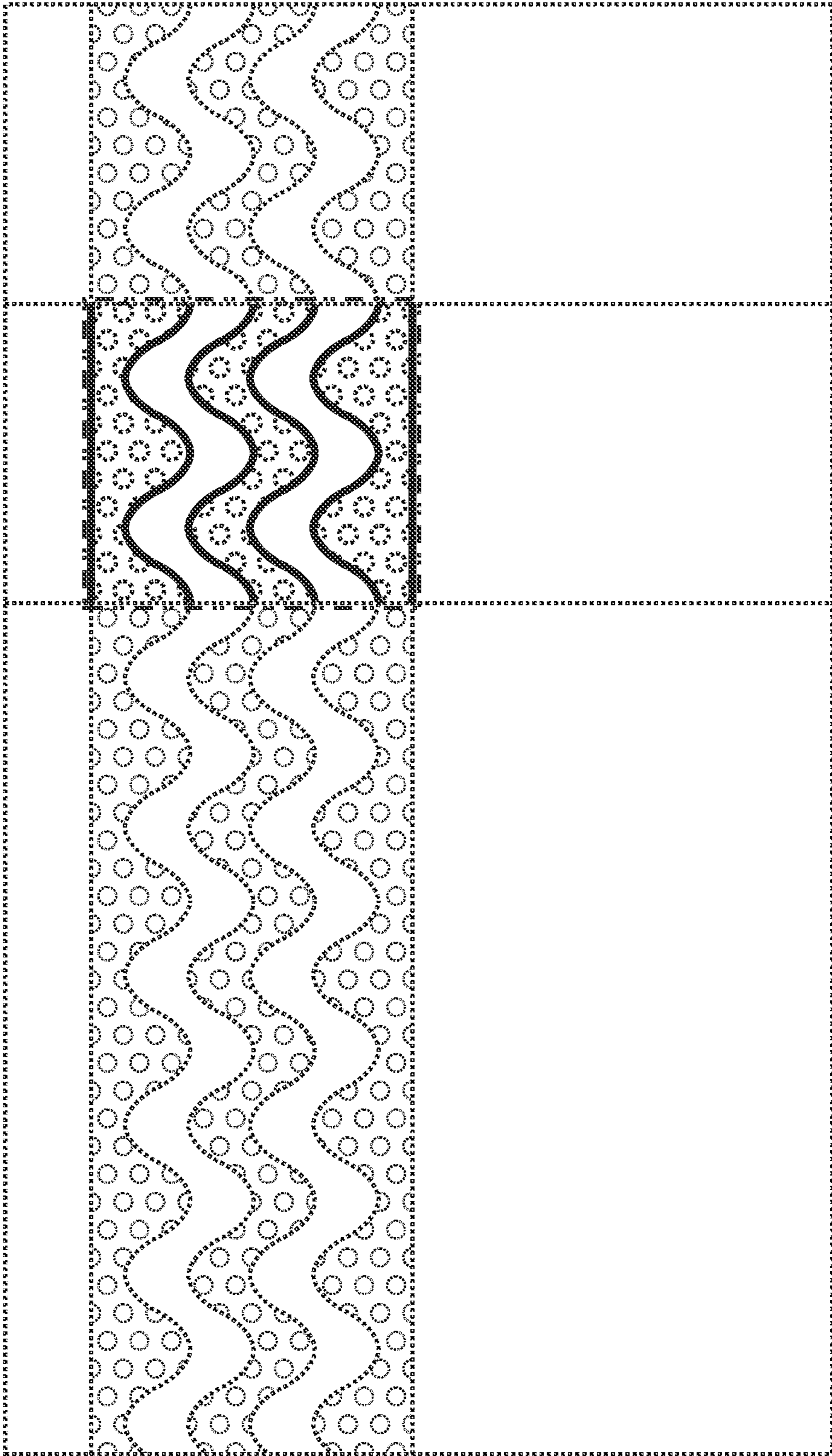
