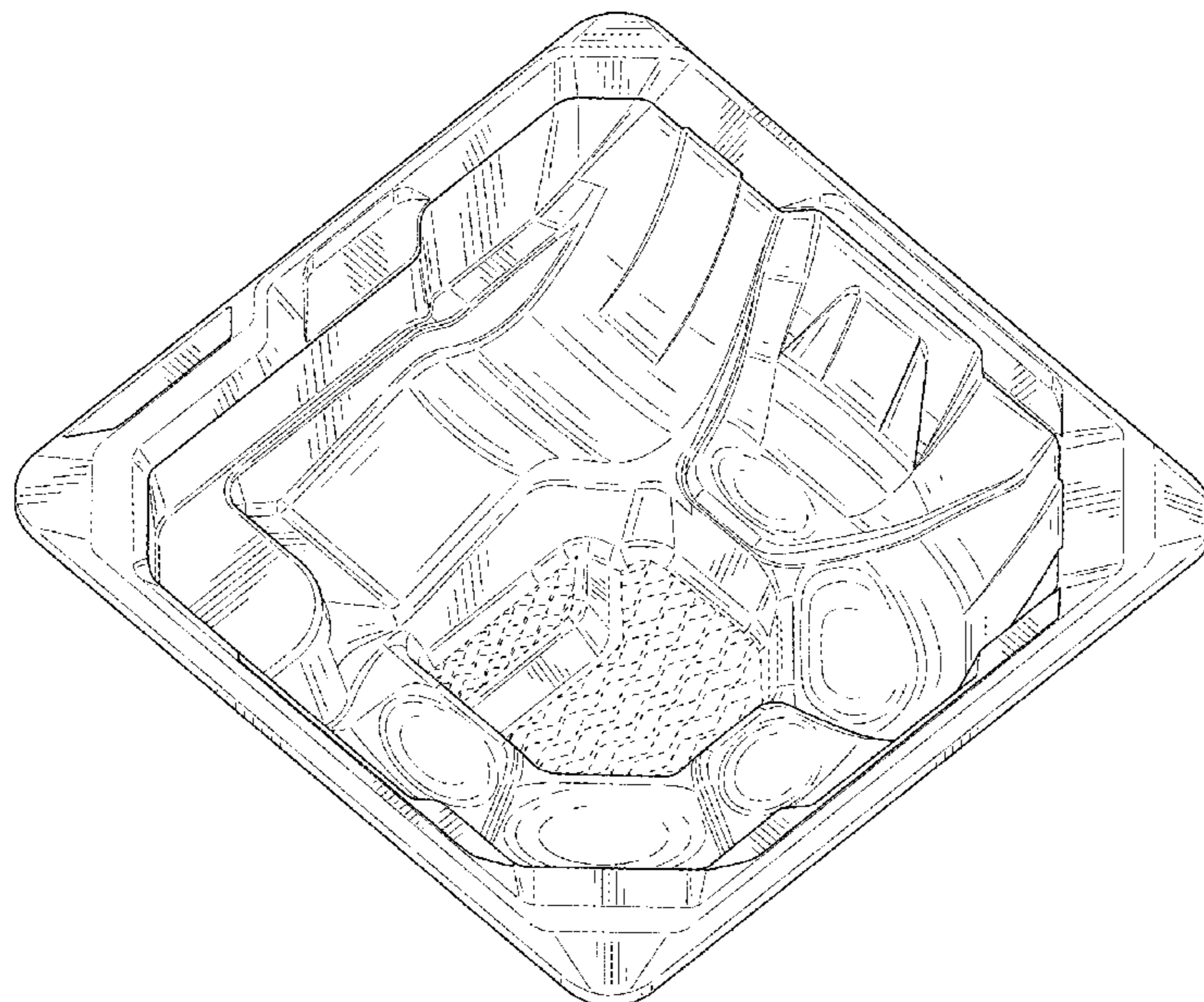
FIG. 9 is a cross-sectional view thereof, taken in the direction of line 9-9 of FIG. 3.

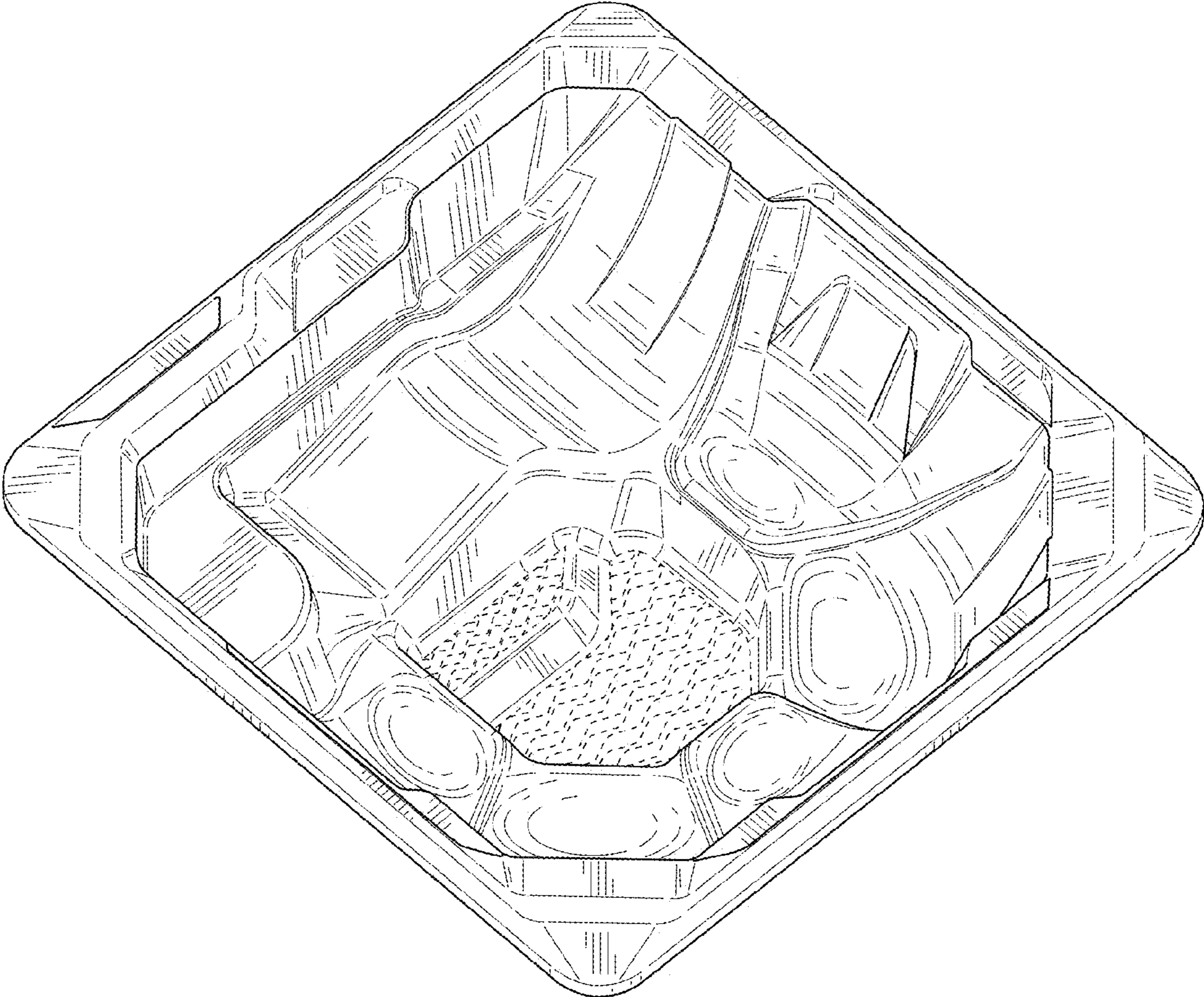

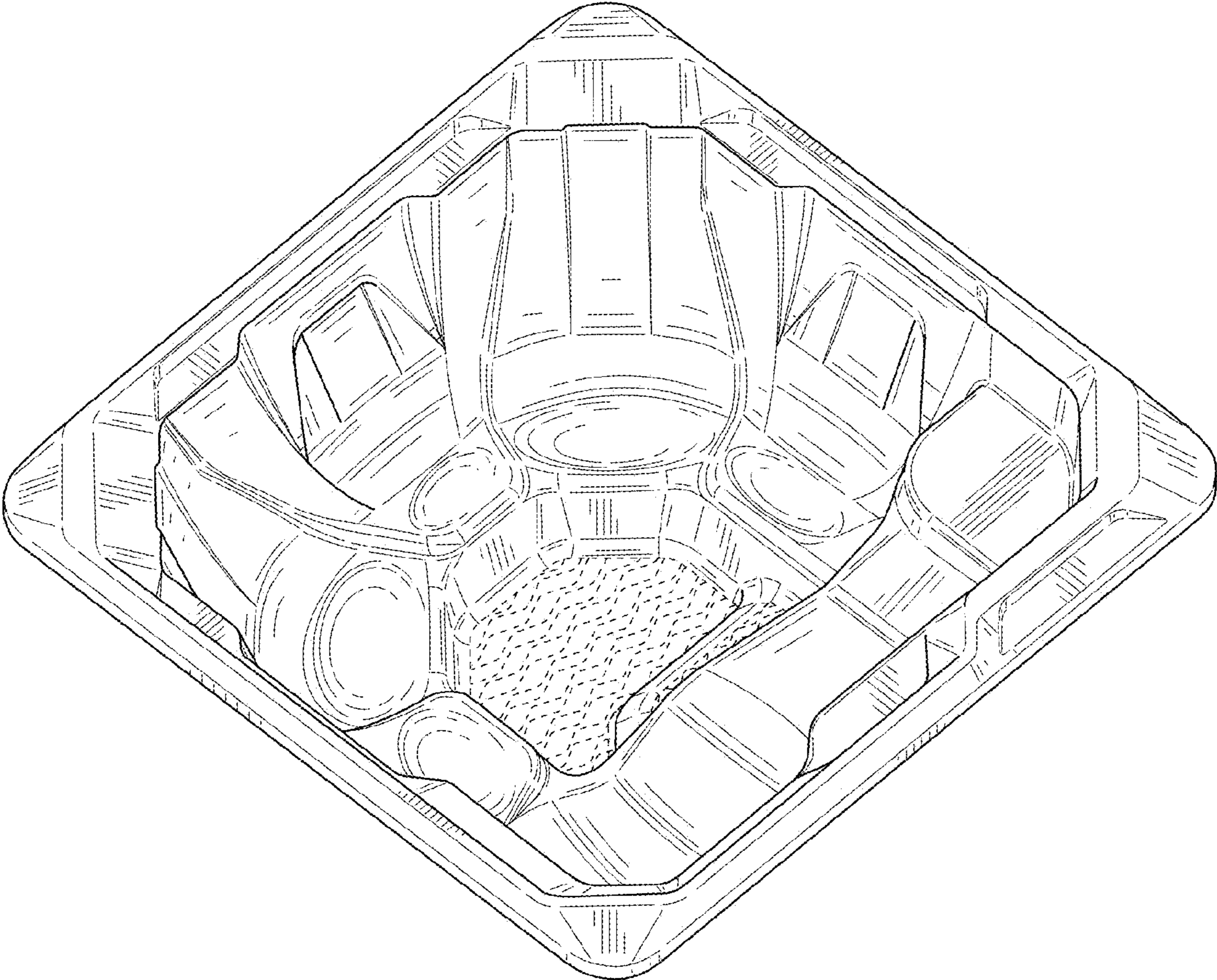

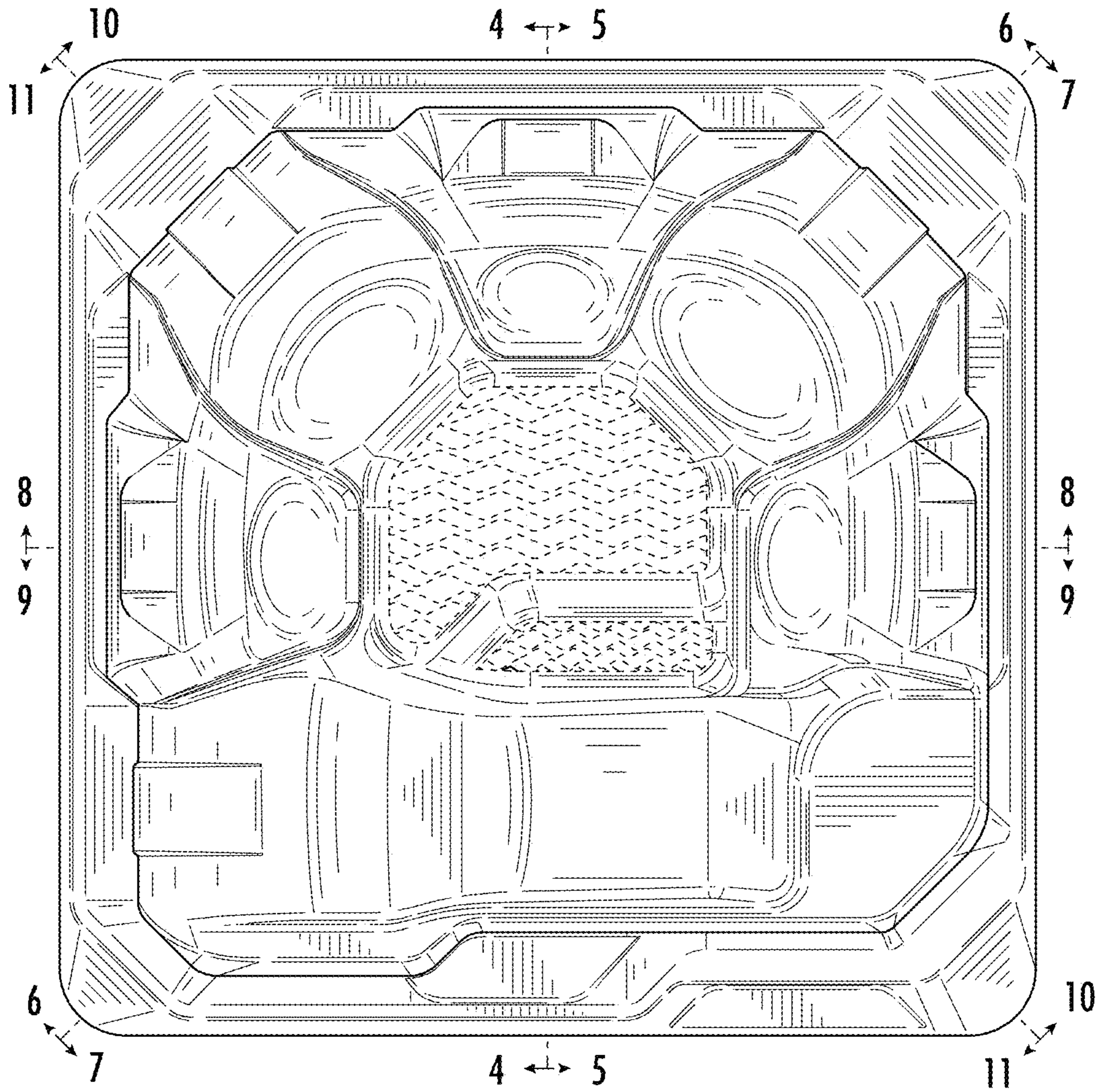

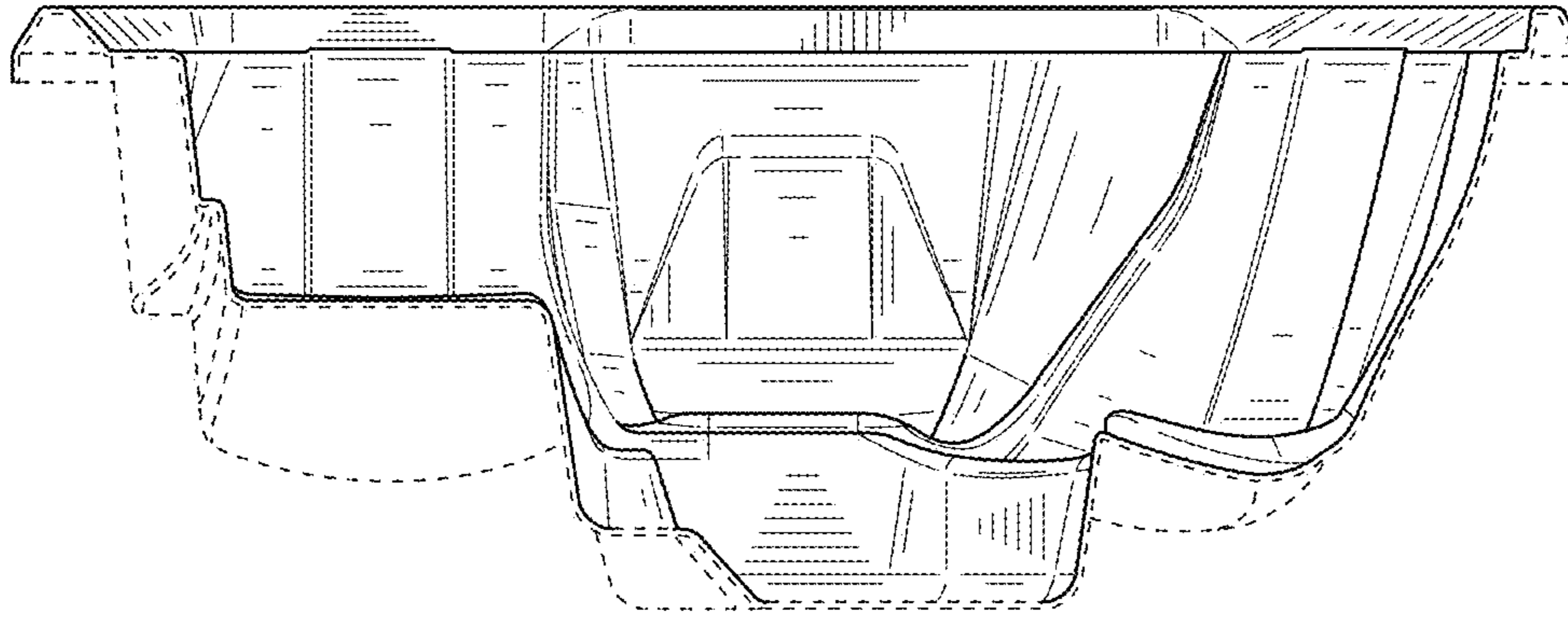

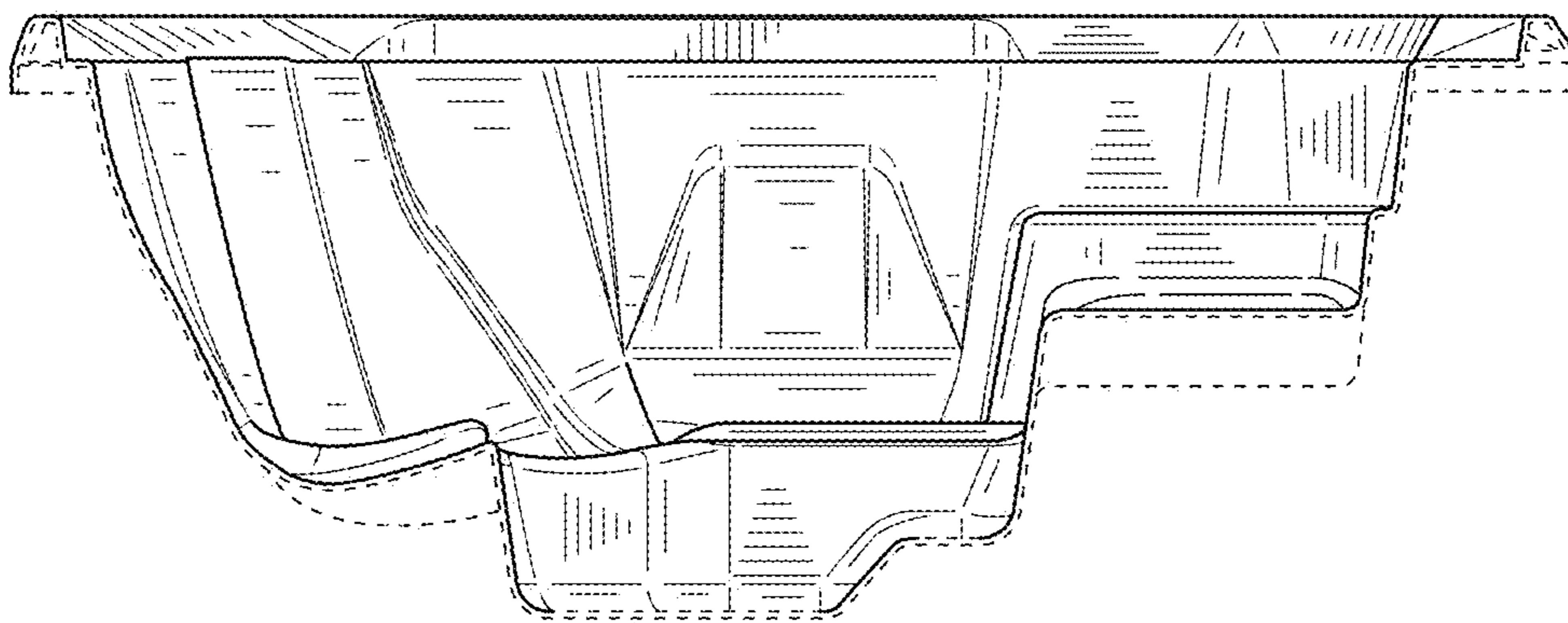

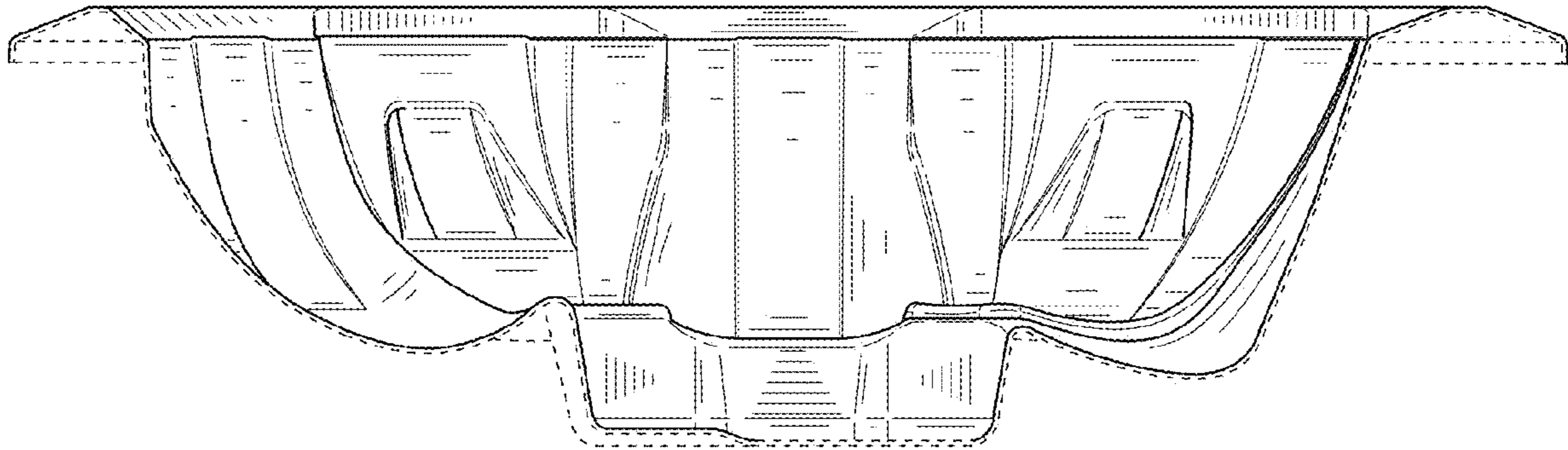

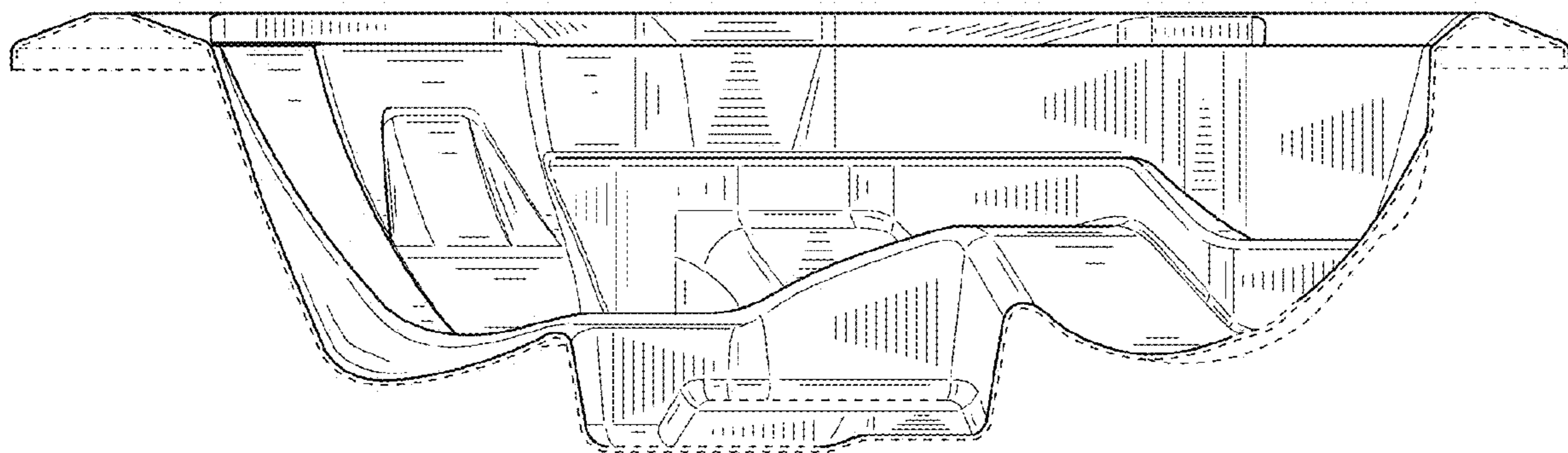

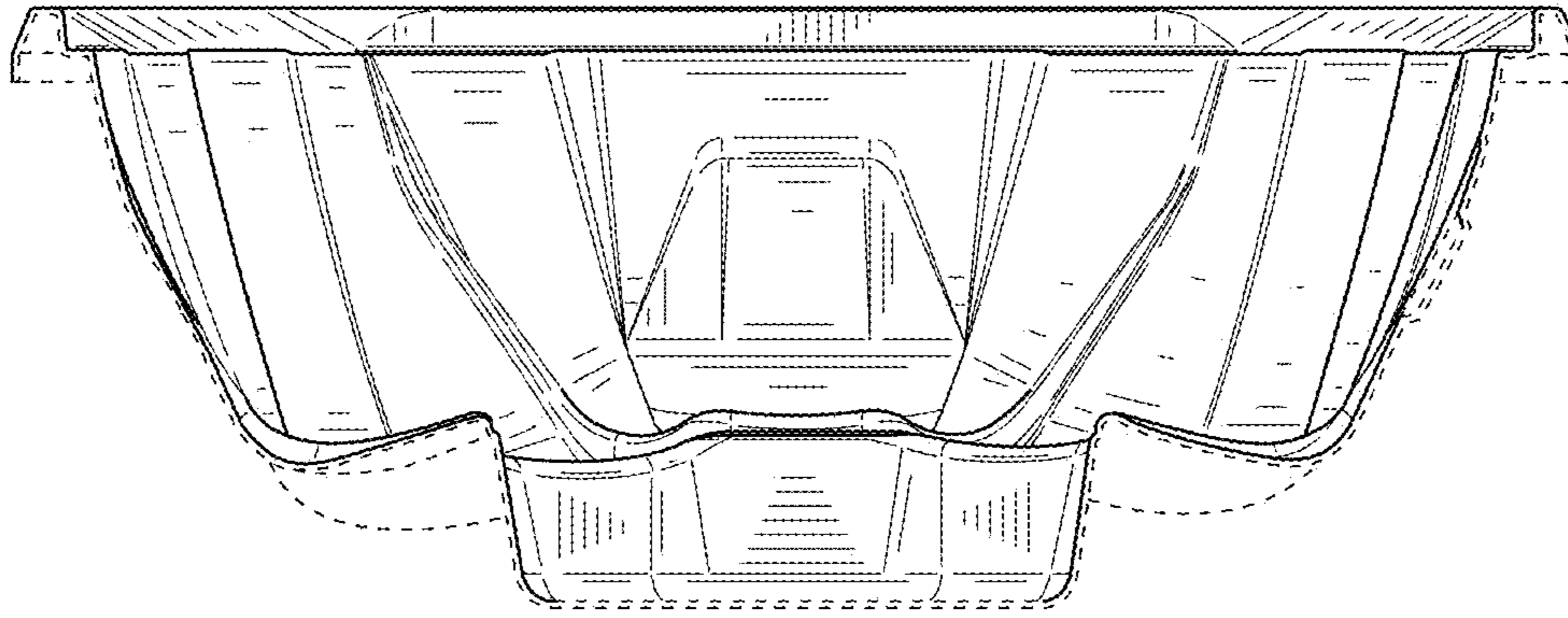

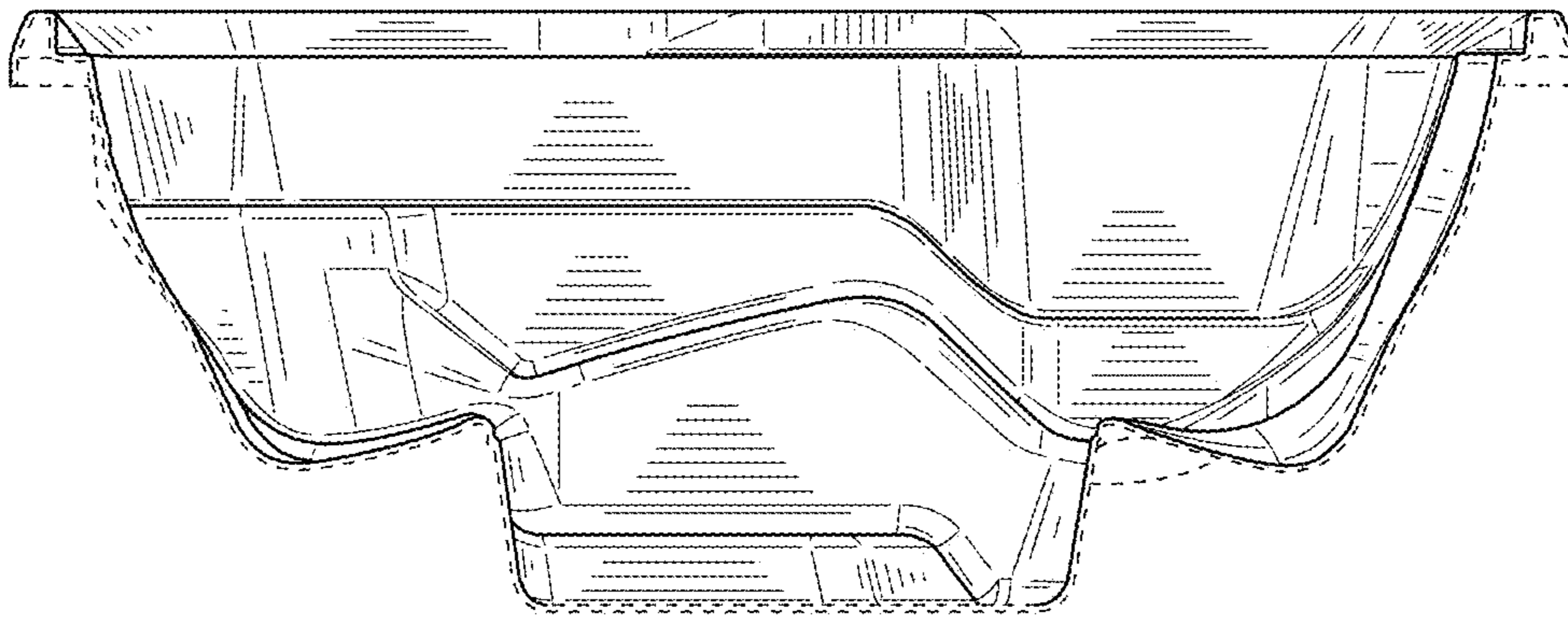

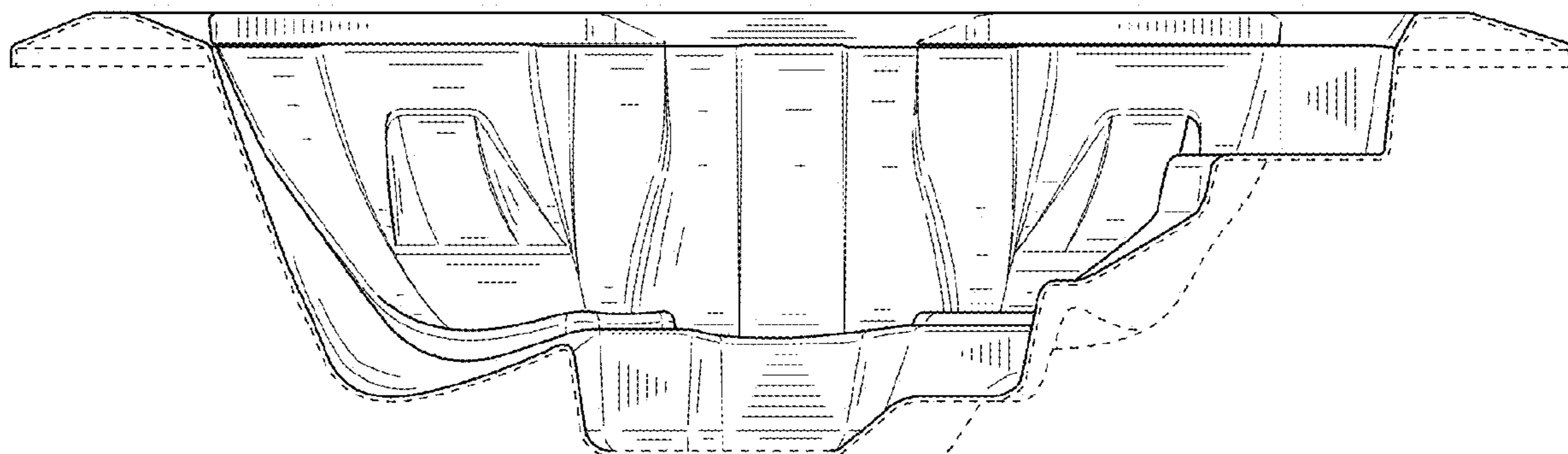

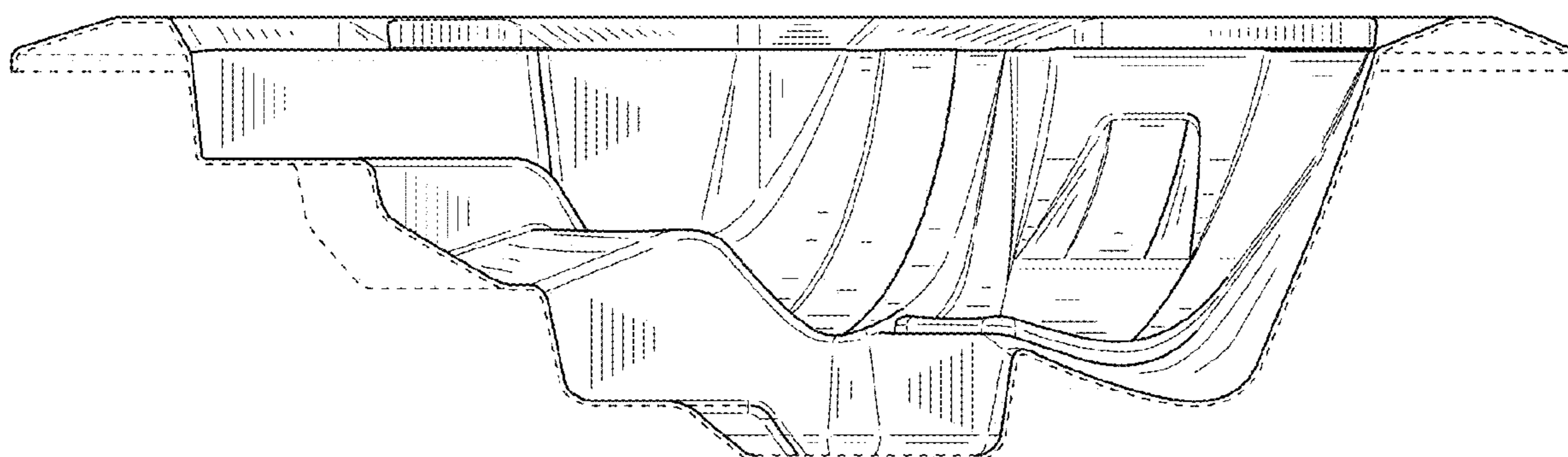
