FIG. 10 is cross-sectional view thereof, taken in the direction of line 10-10 of FIG. 2.

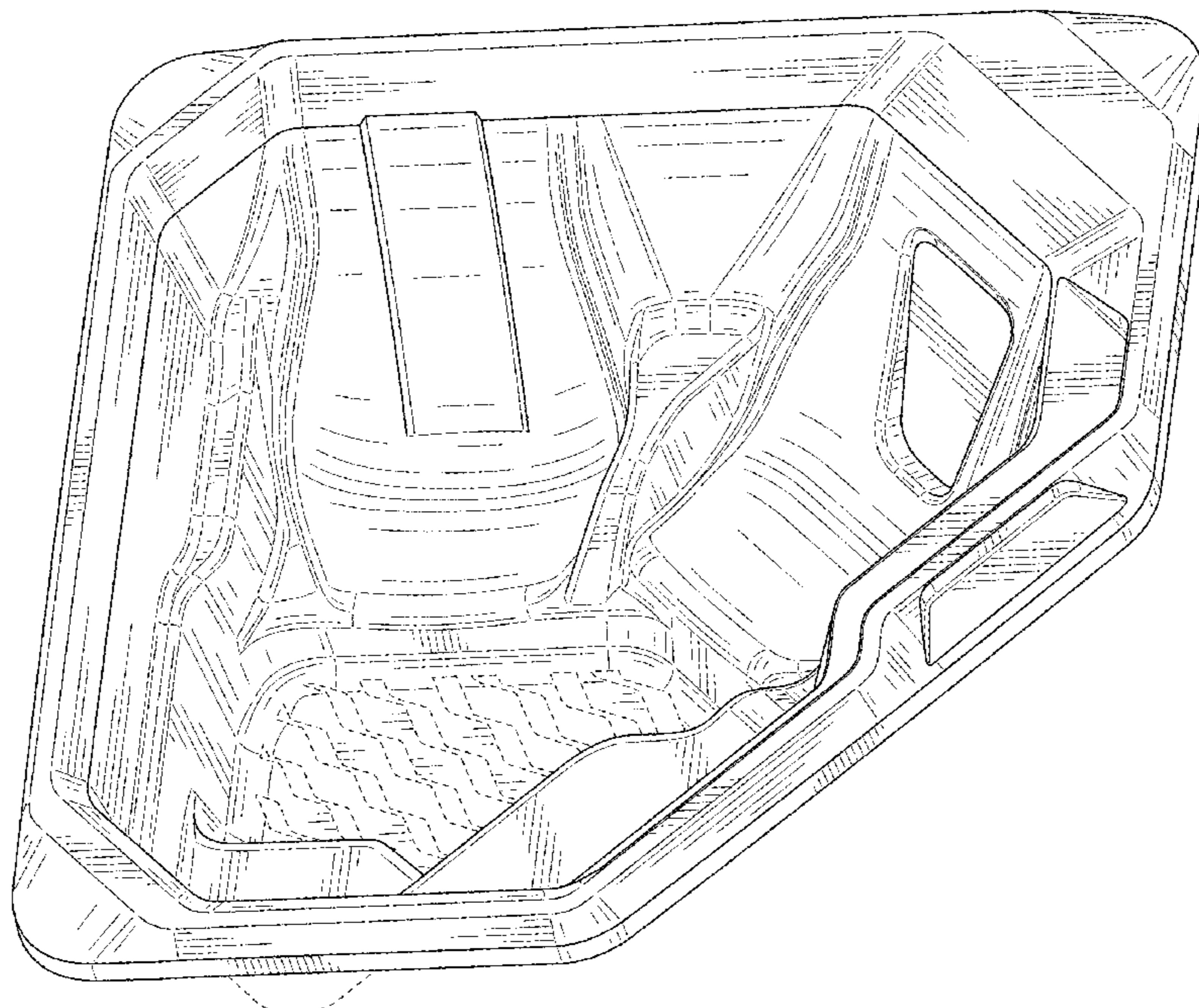

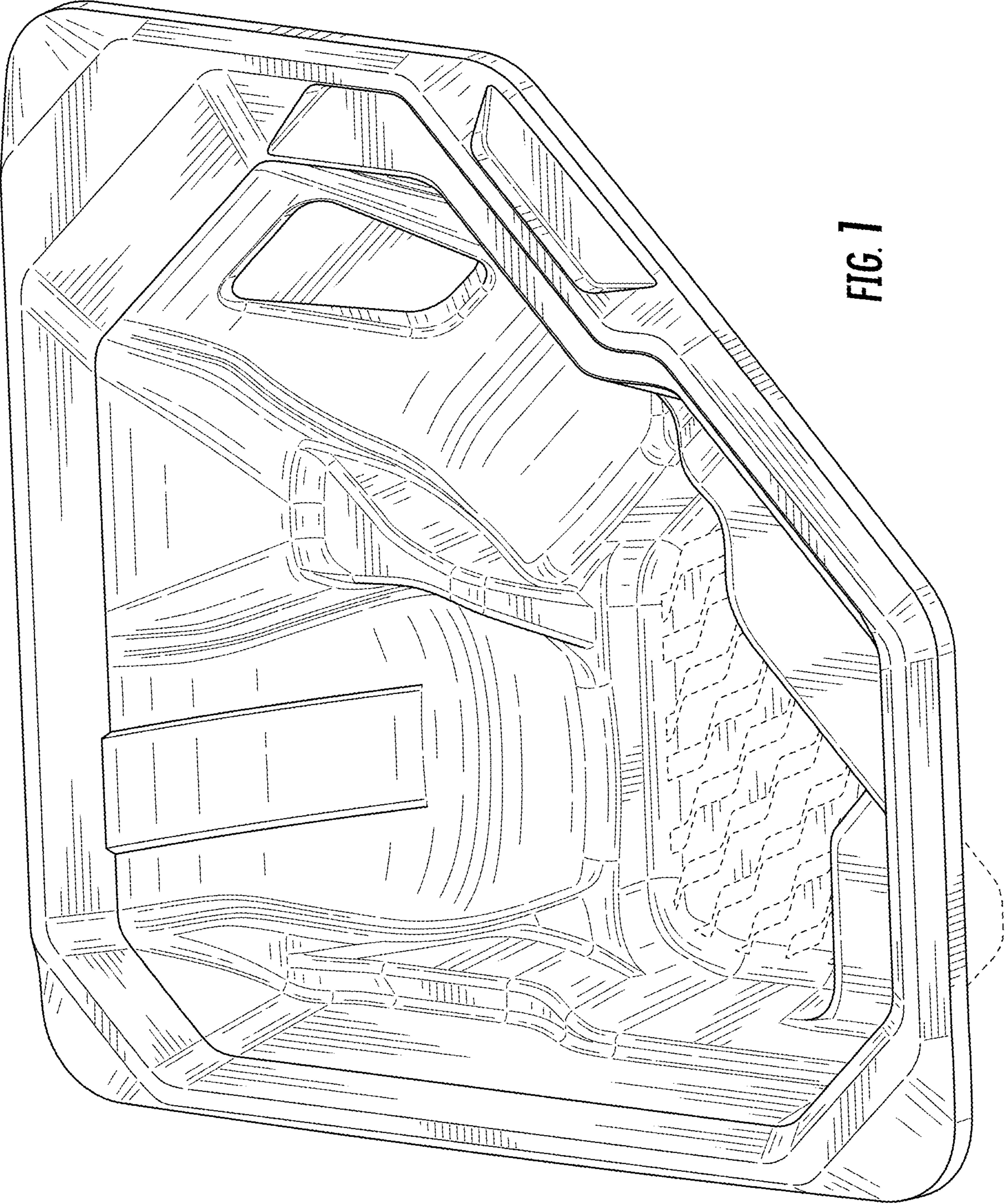

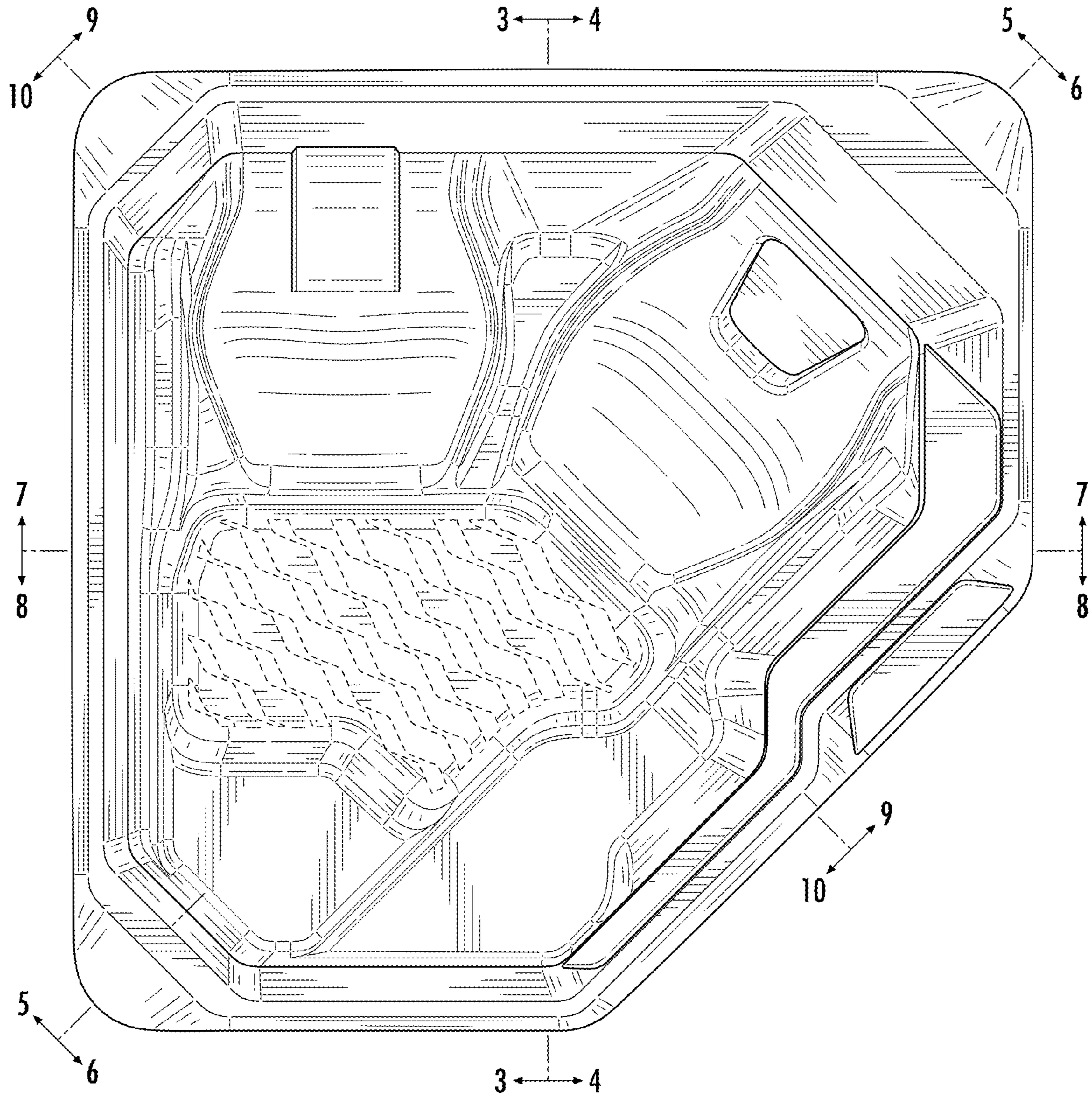

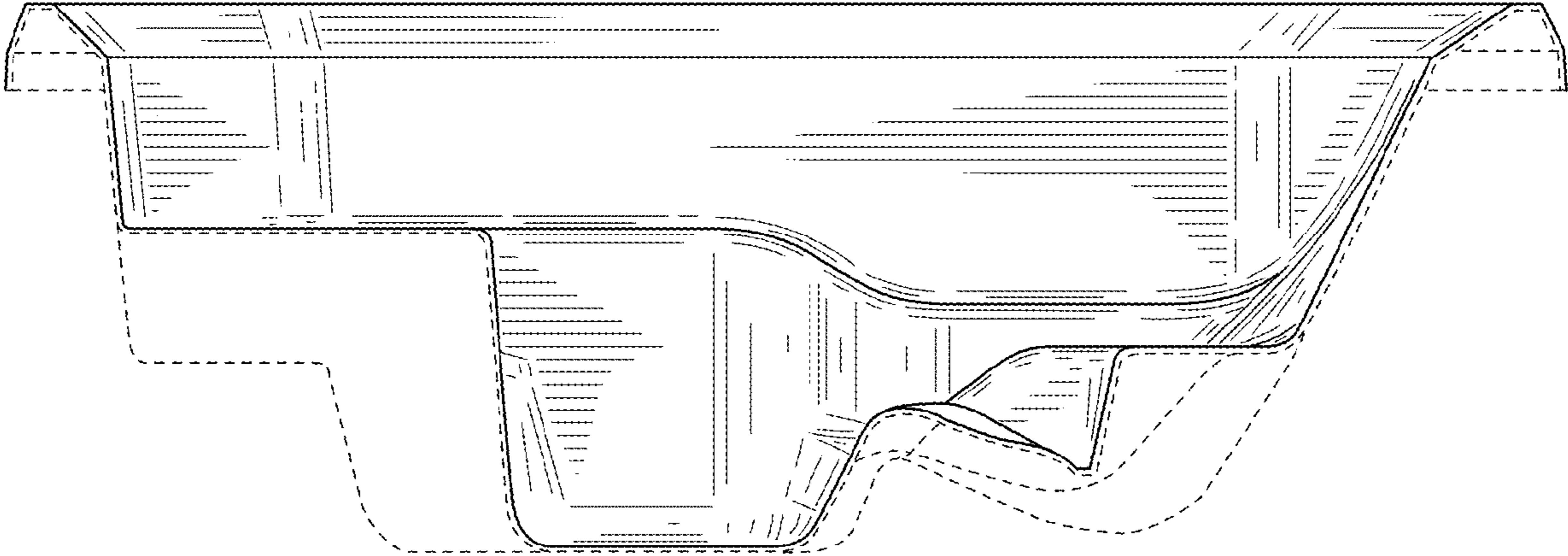

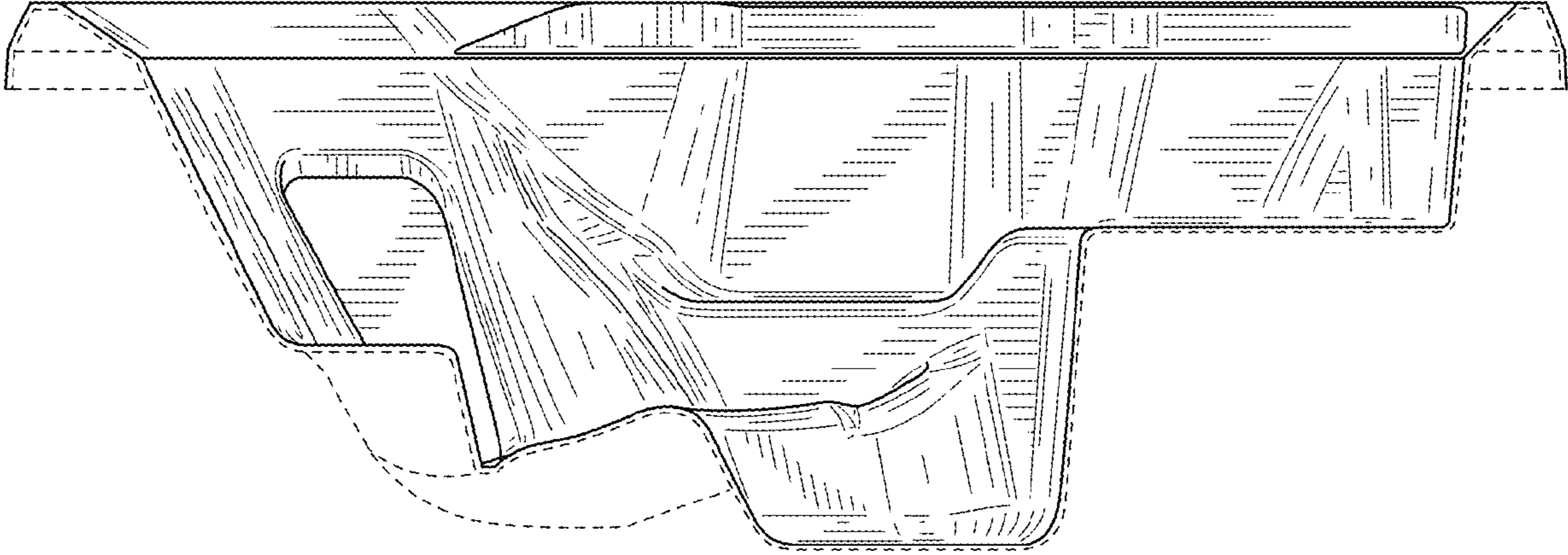

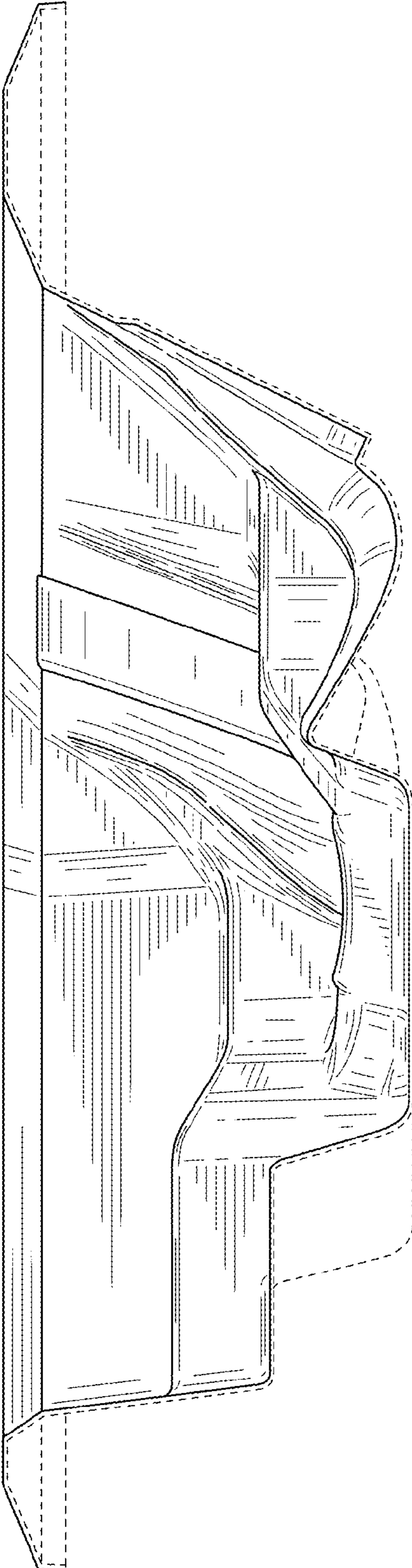

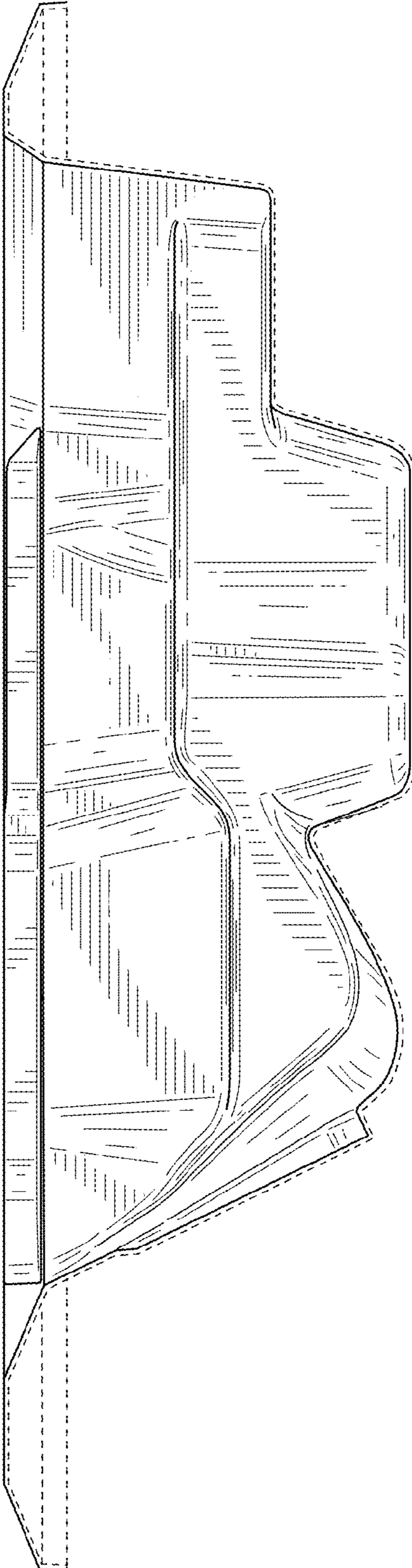

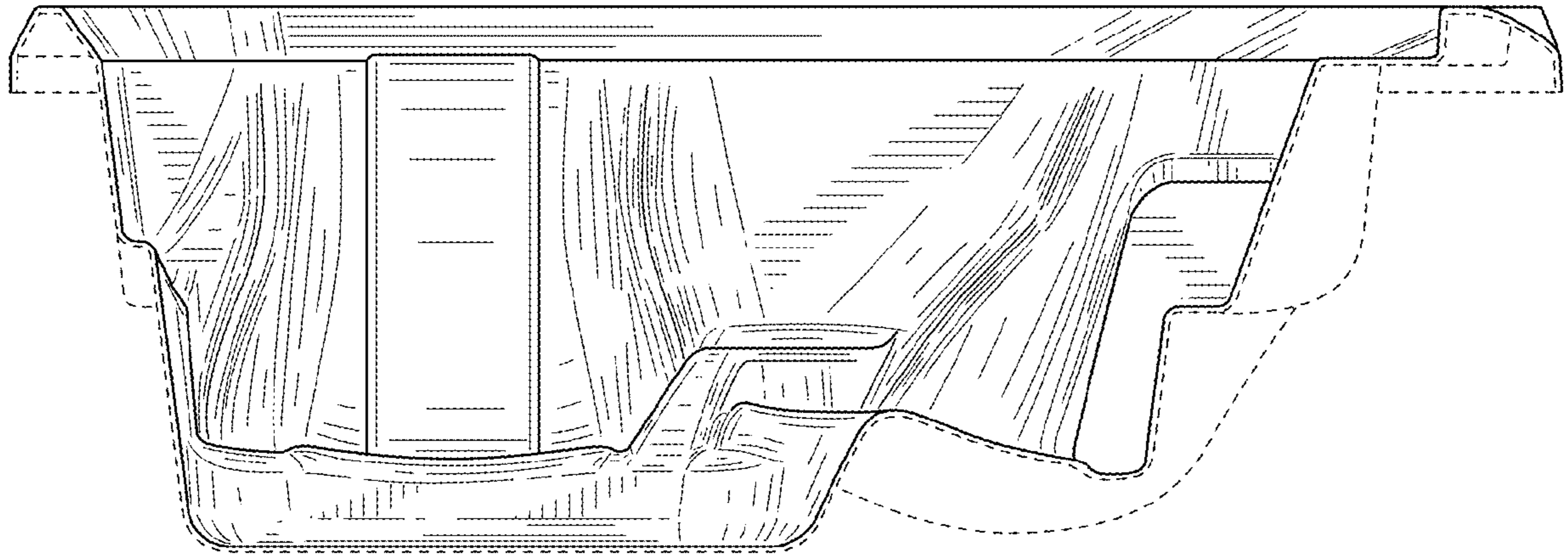

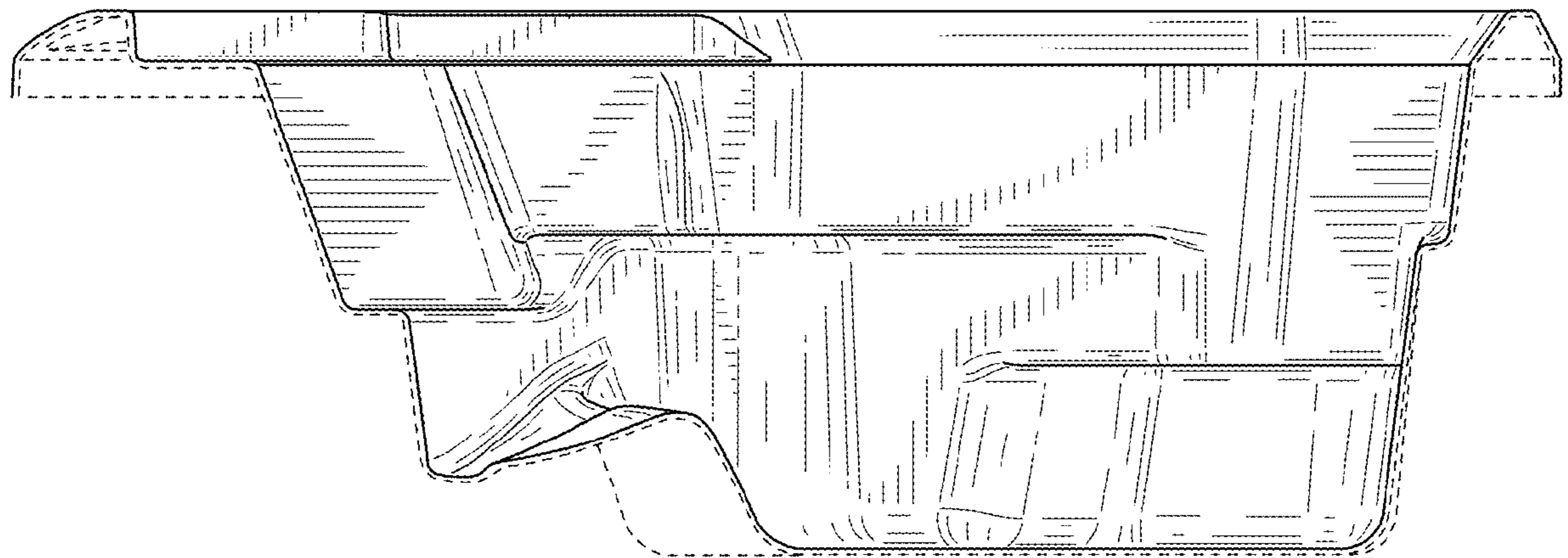

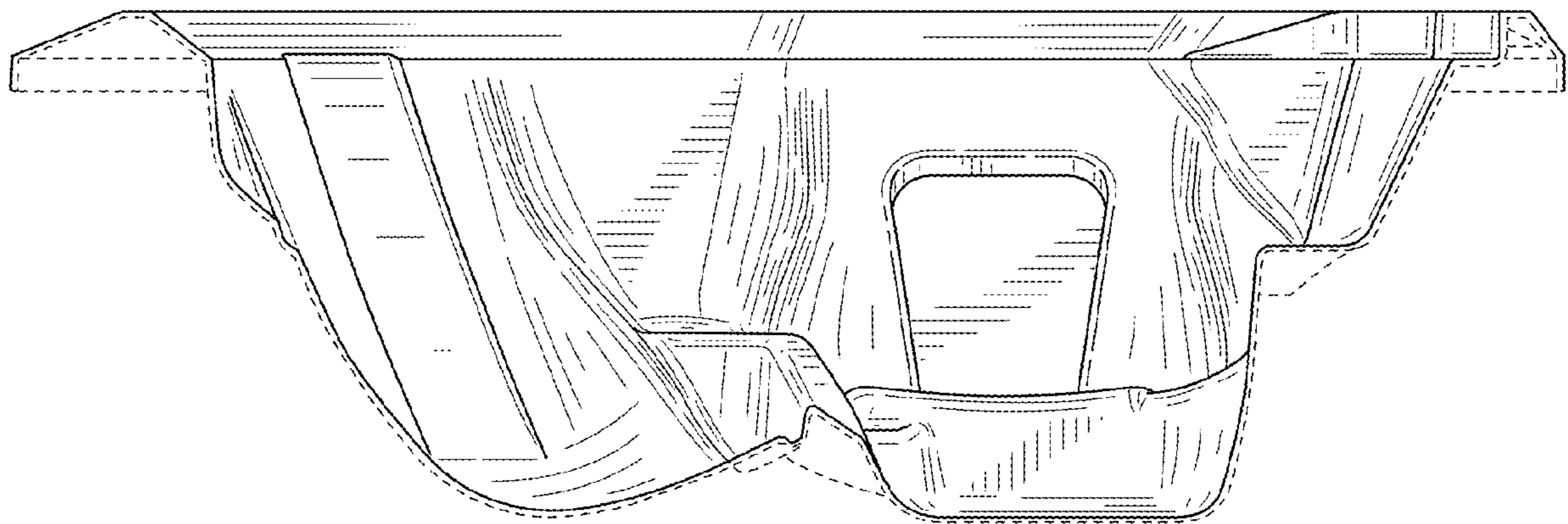

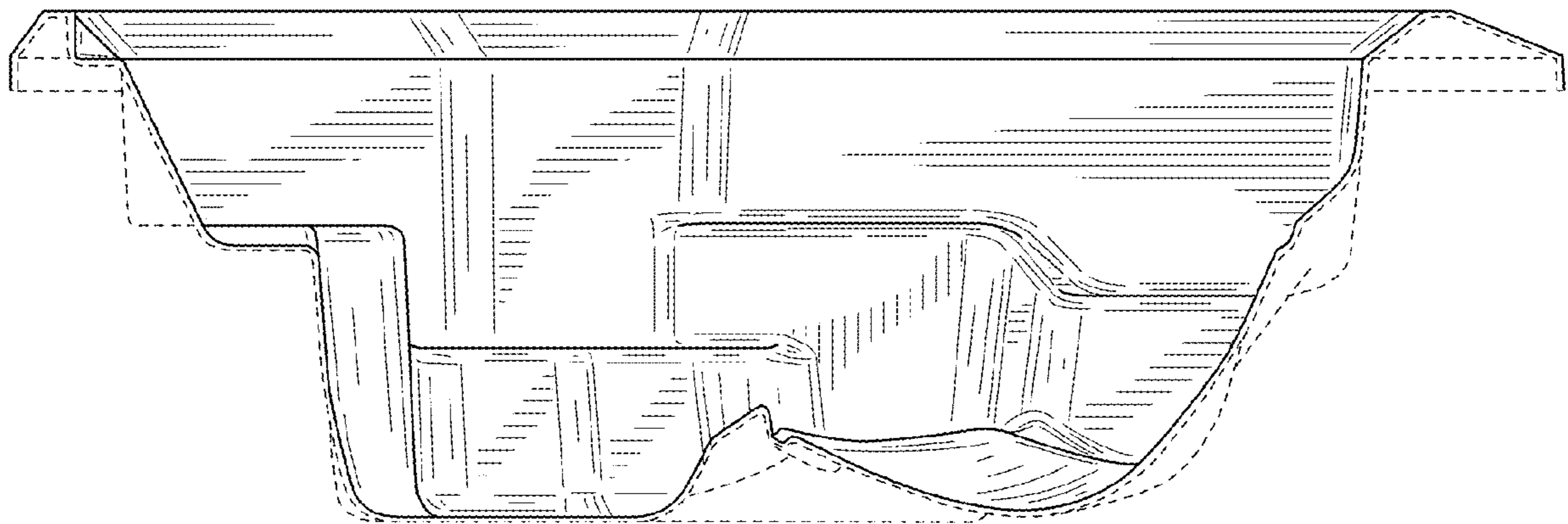
