(57) **CLAIM**

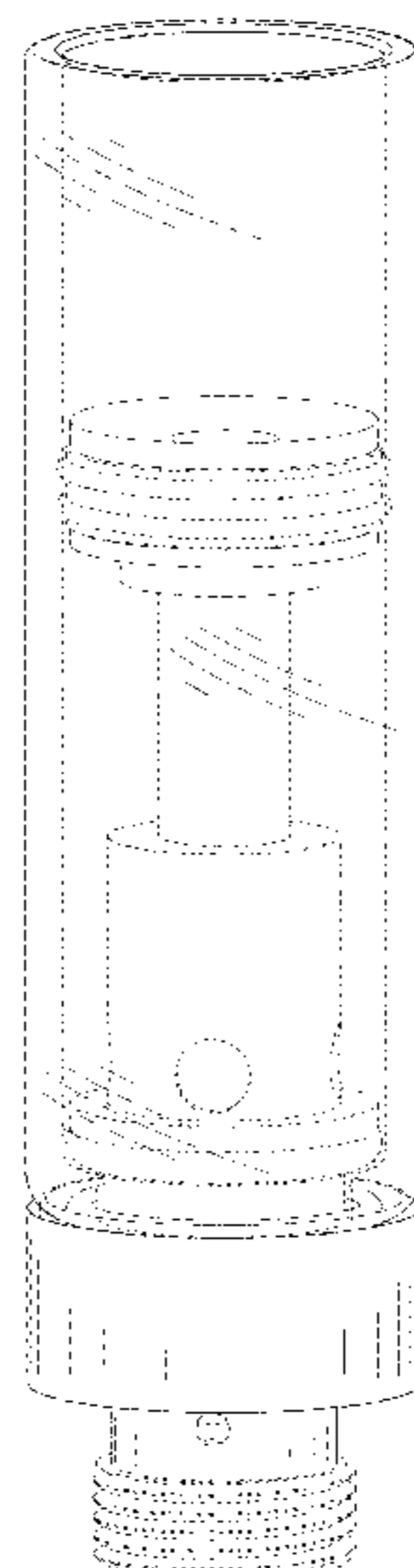
The ornamental design for an electronic atomizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an electronic atomizer showing my new design;  
FIG. 2 is another perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.

The broken lines in the drawings depict portions of the electronic atomizer that form no part of the claimed design. Oblique lines on the surfaces of the electronic atomizer indicate that those surfaces are transparent.

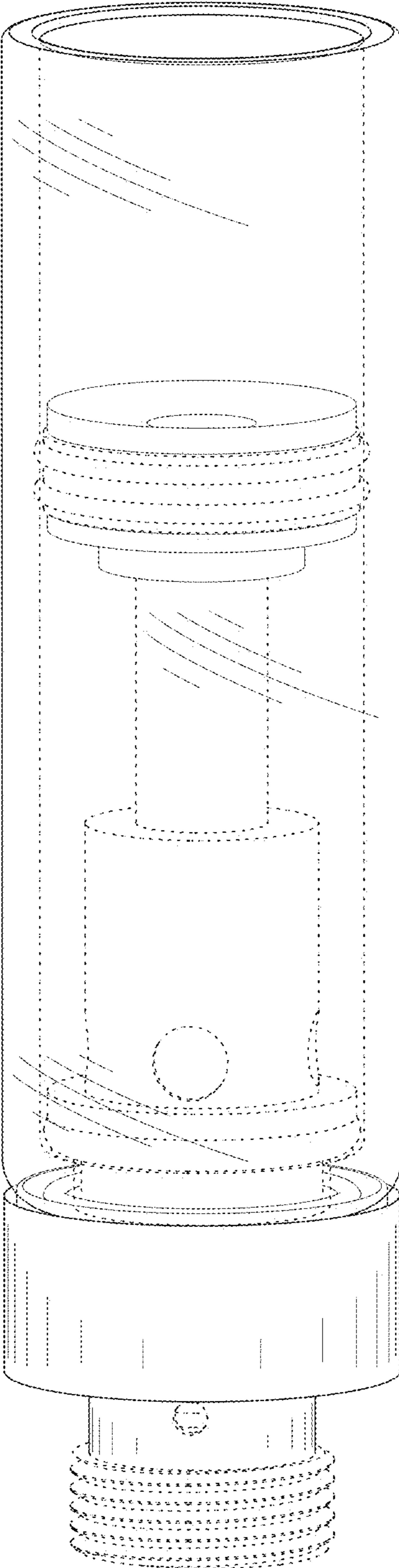

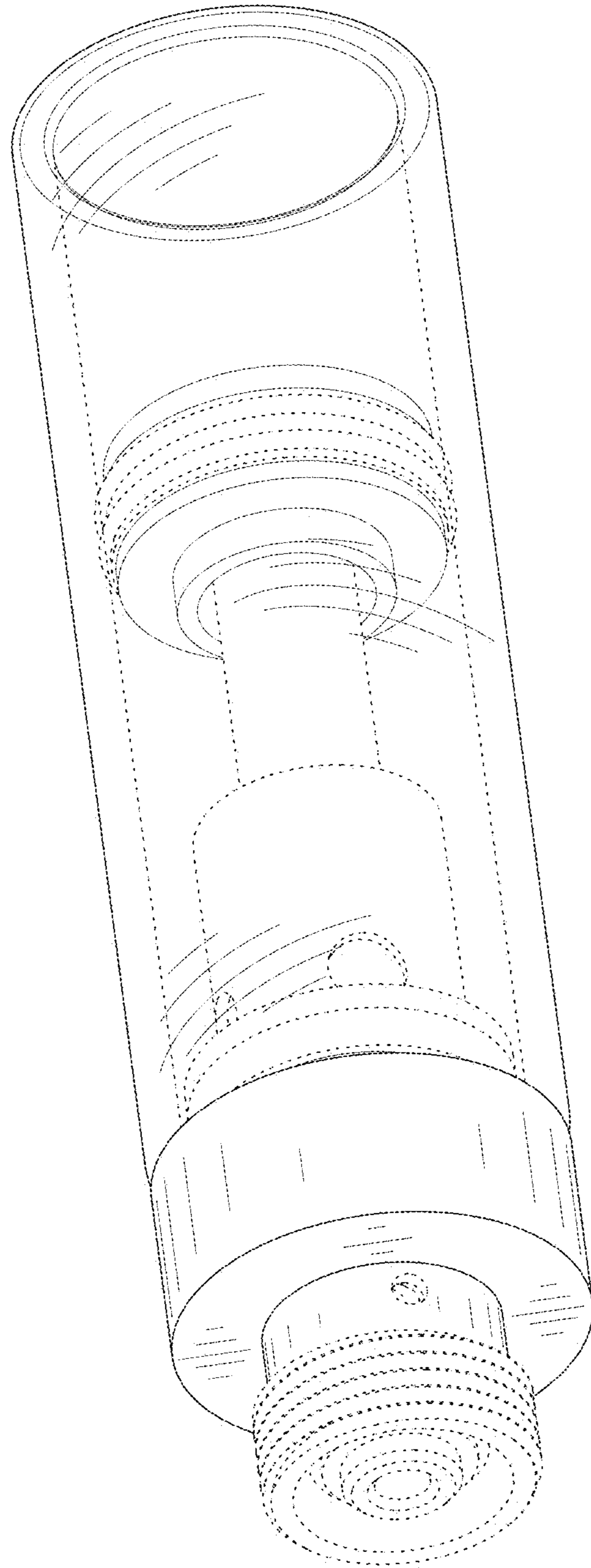

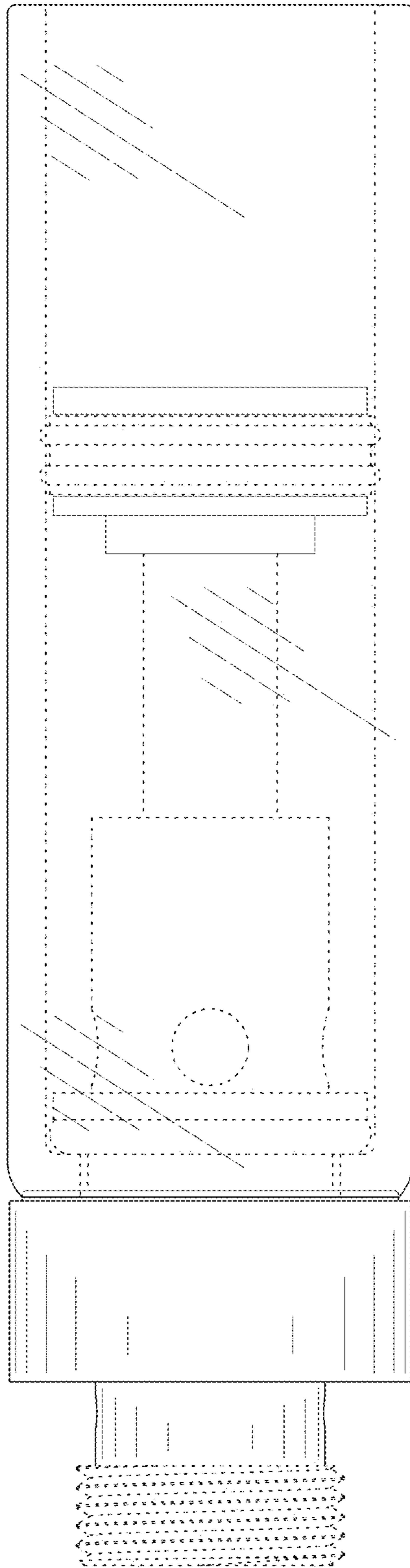

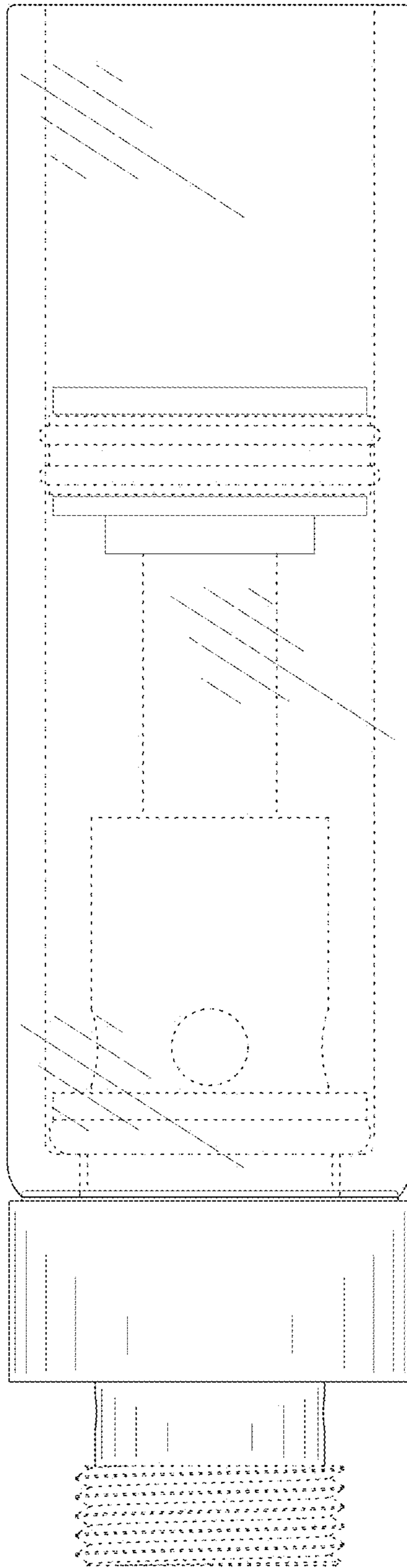

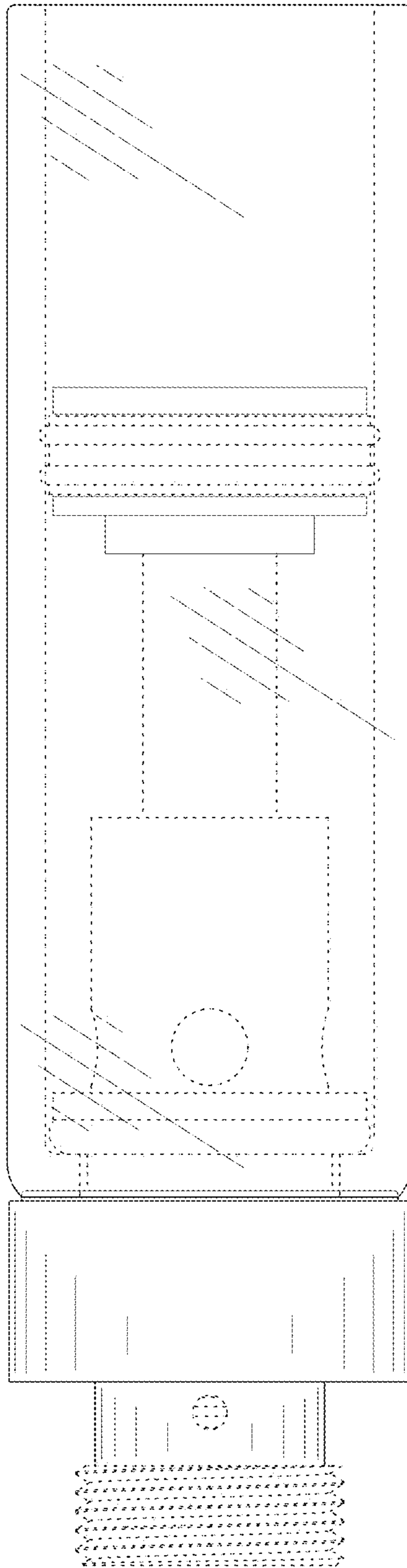

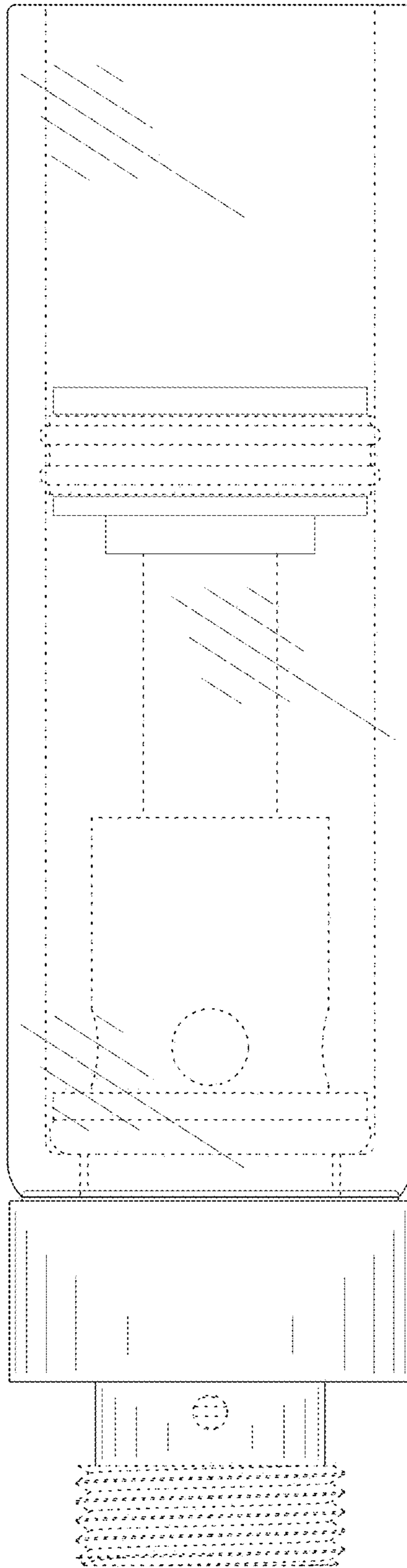

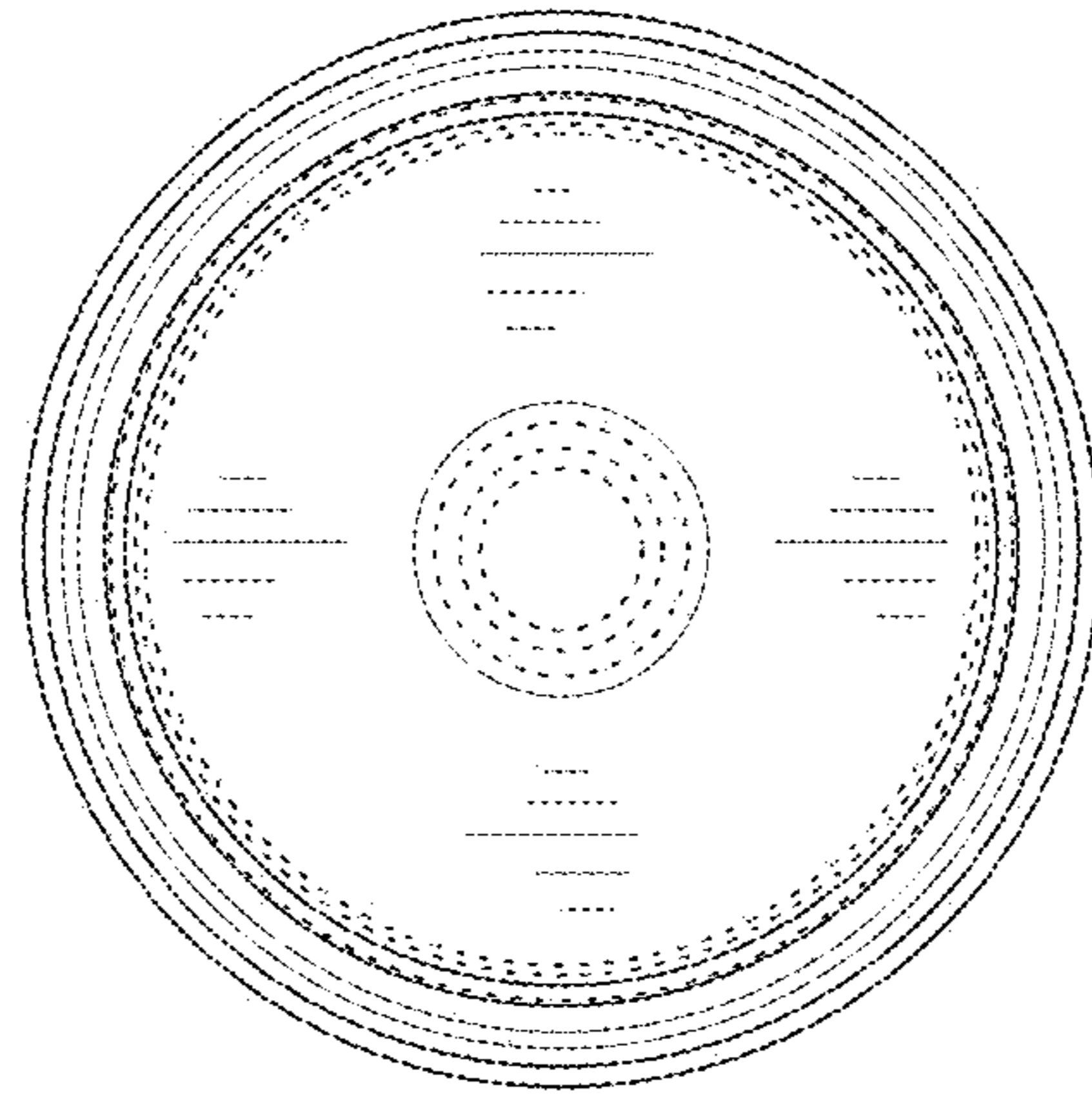

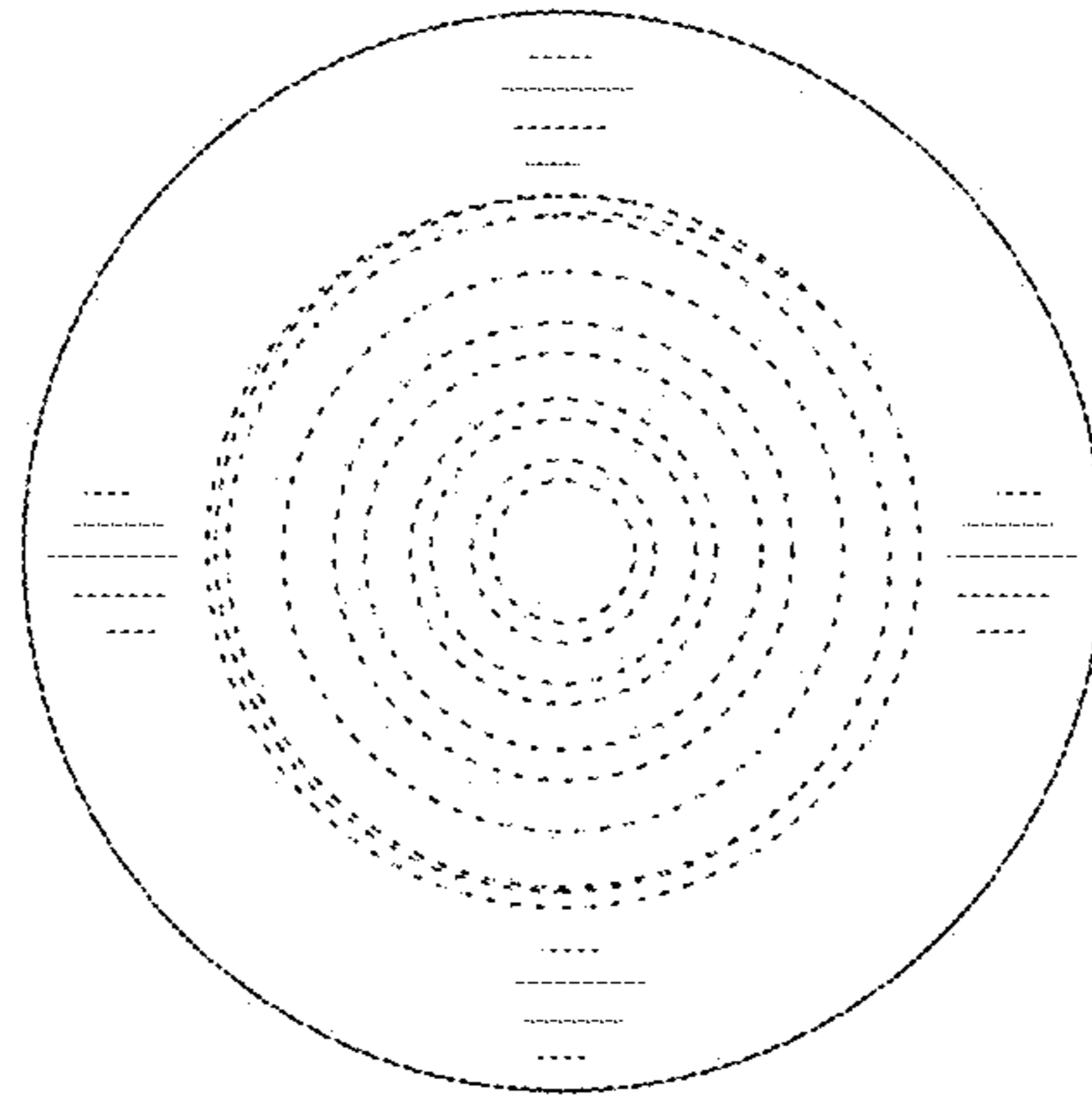
