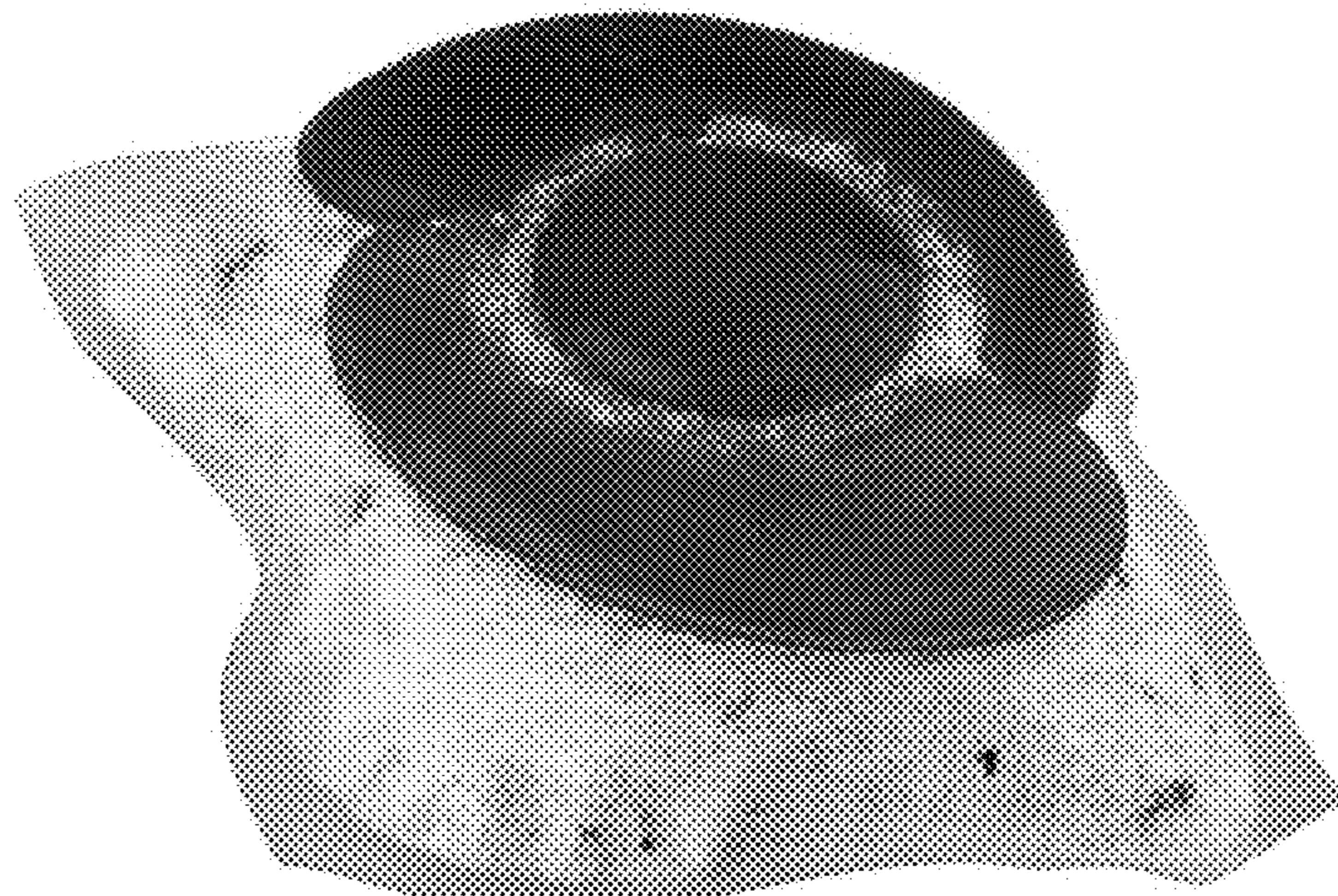
The ornamental design for a pouch, as shown and described.

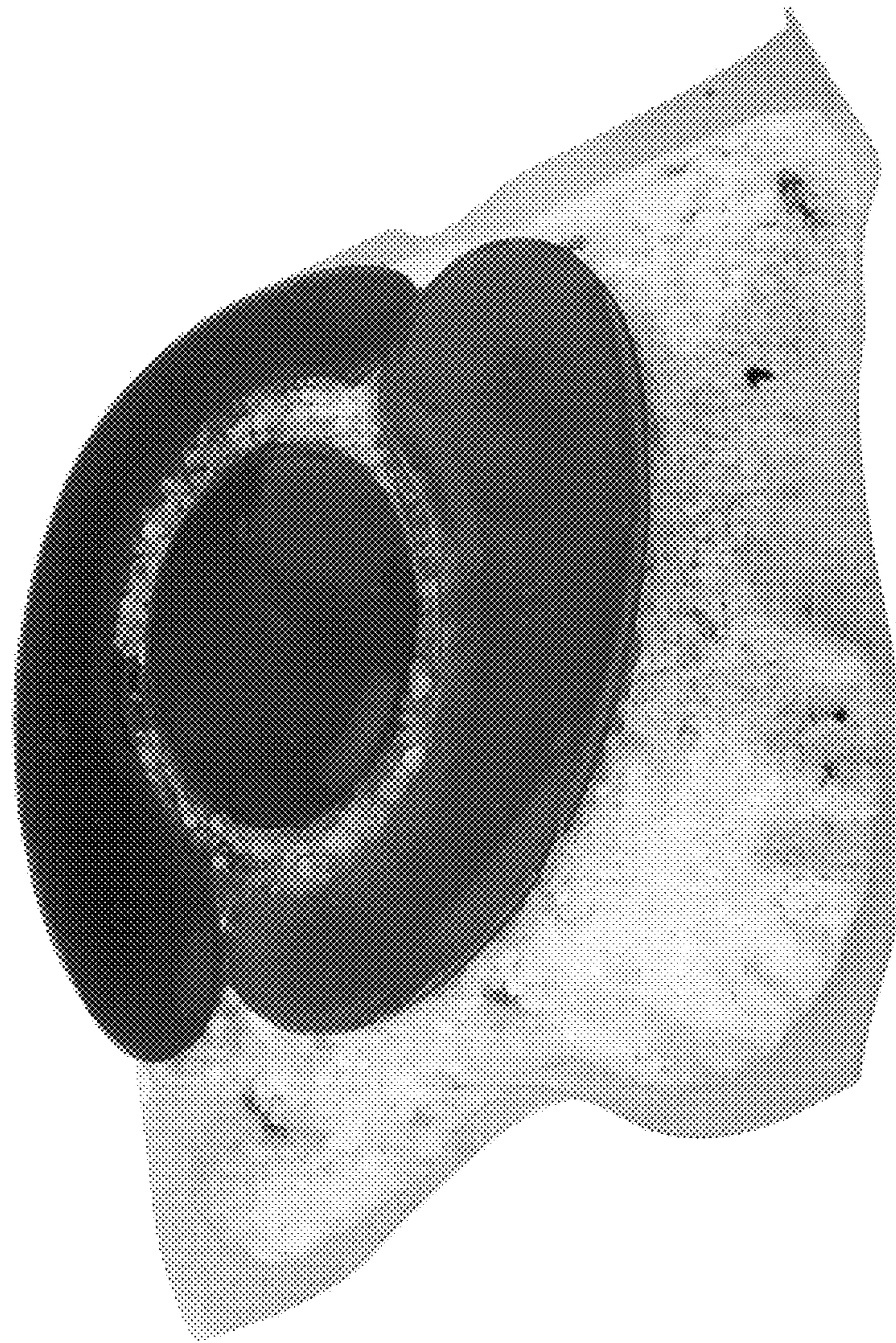

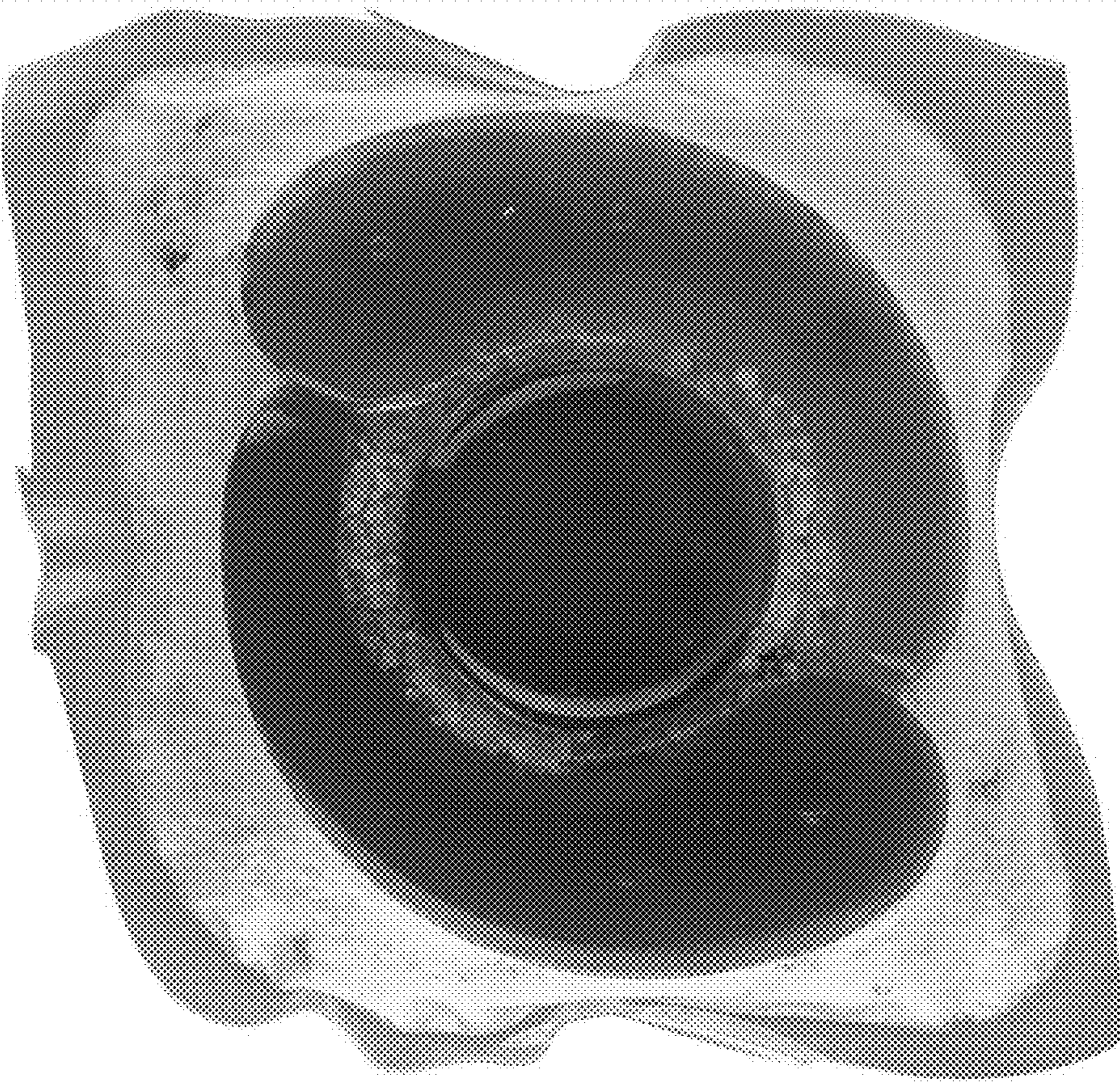

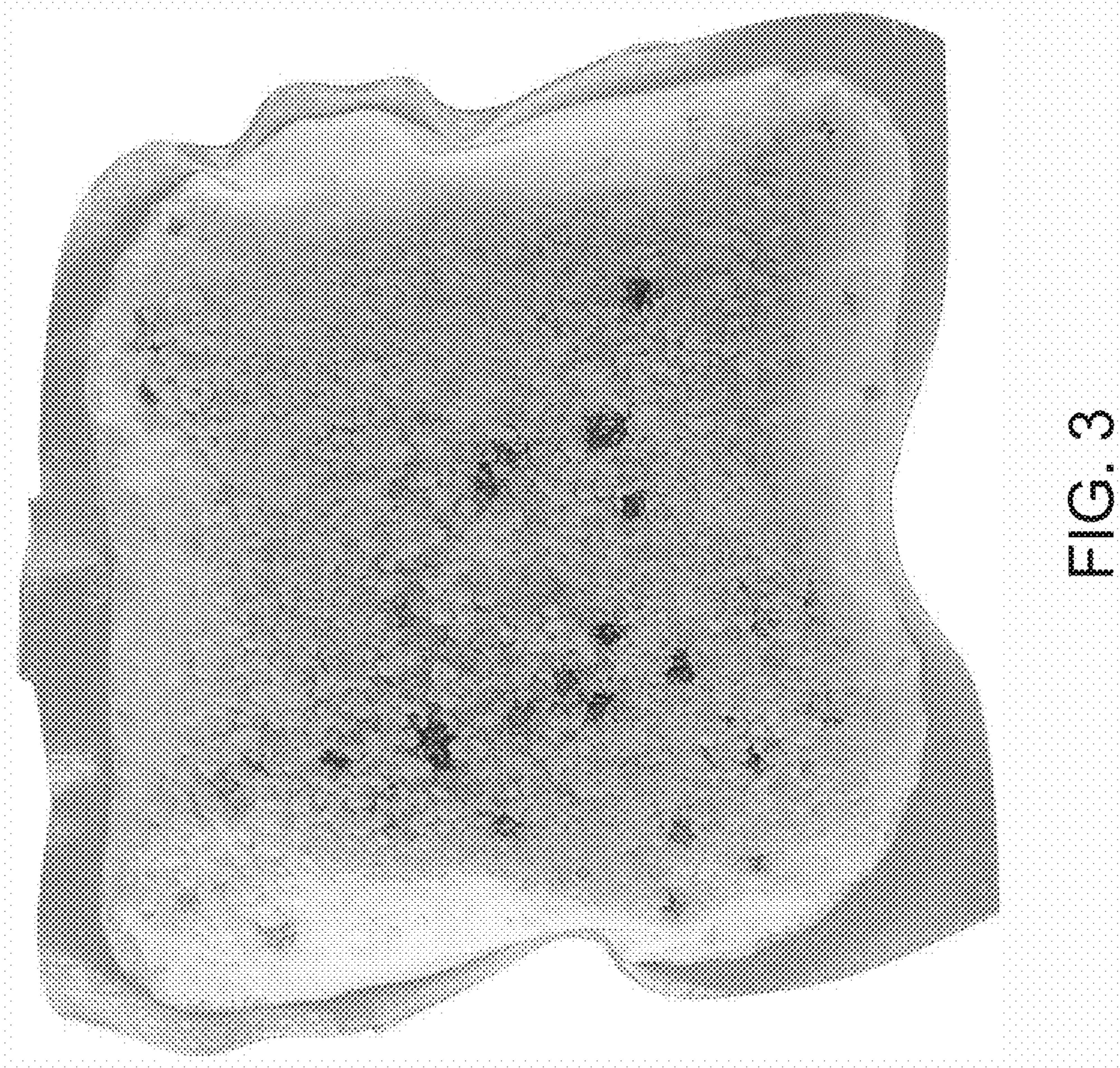

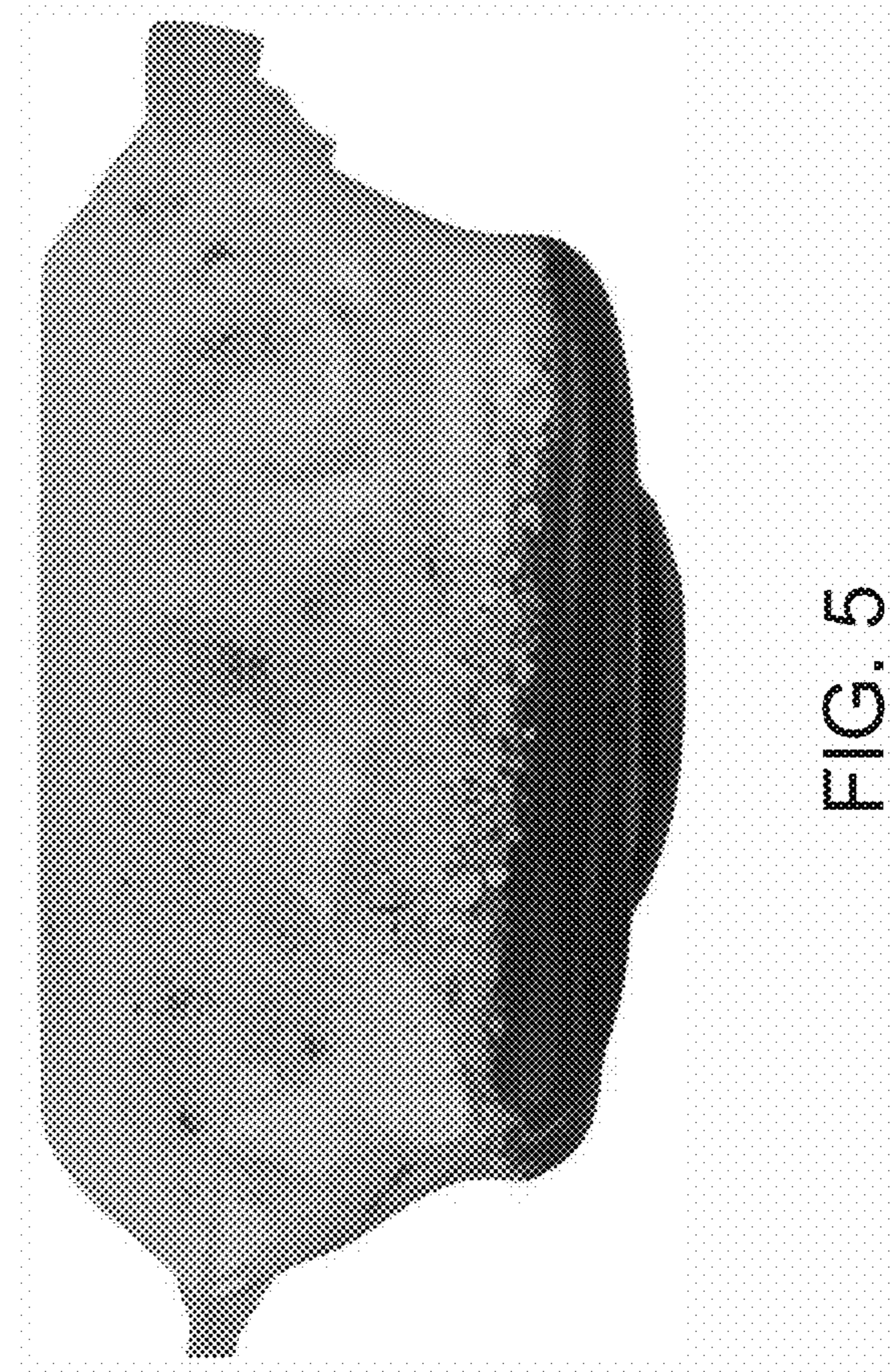

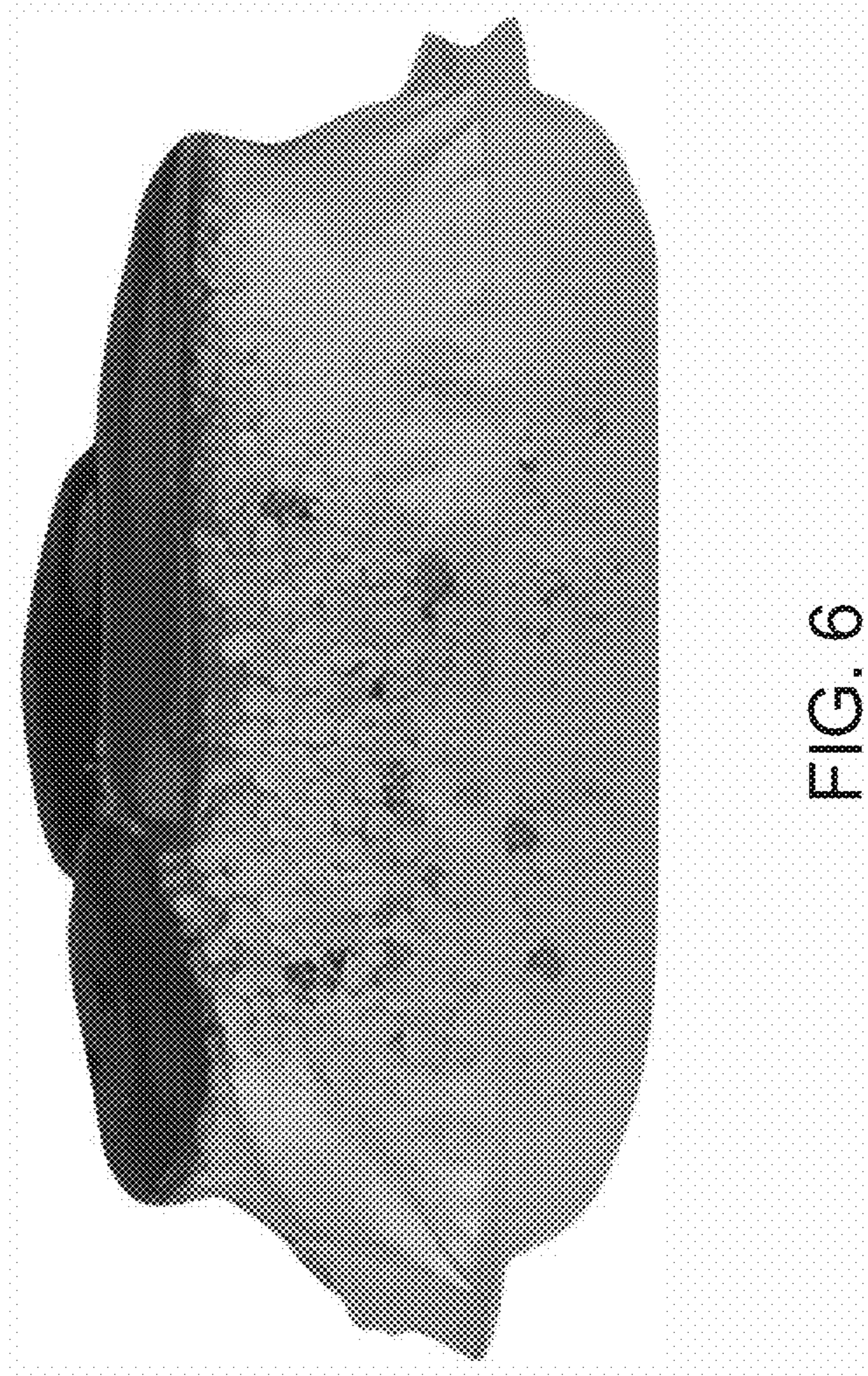

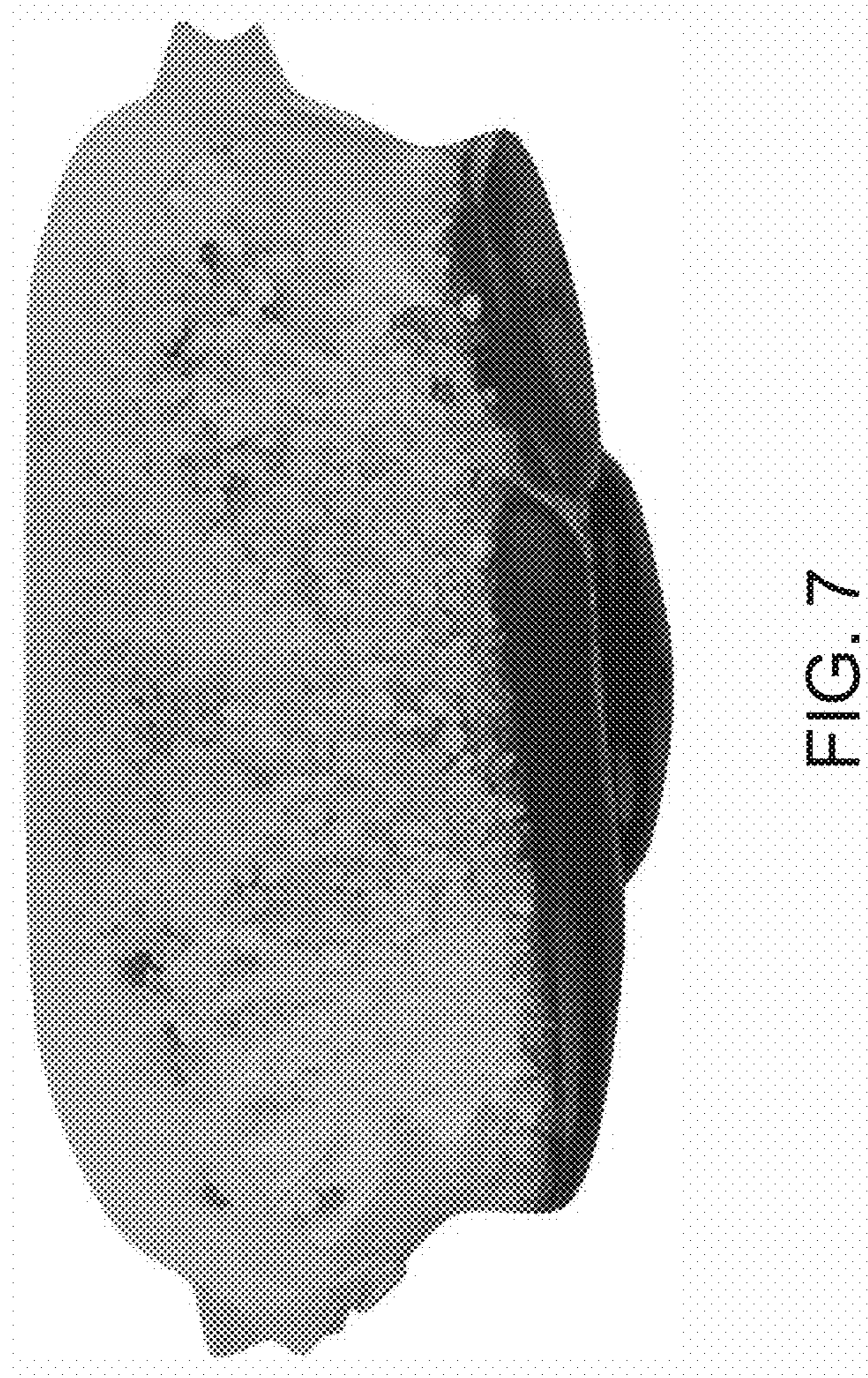

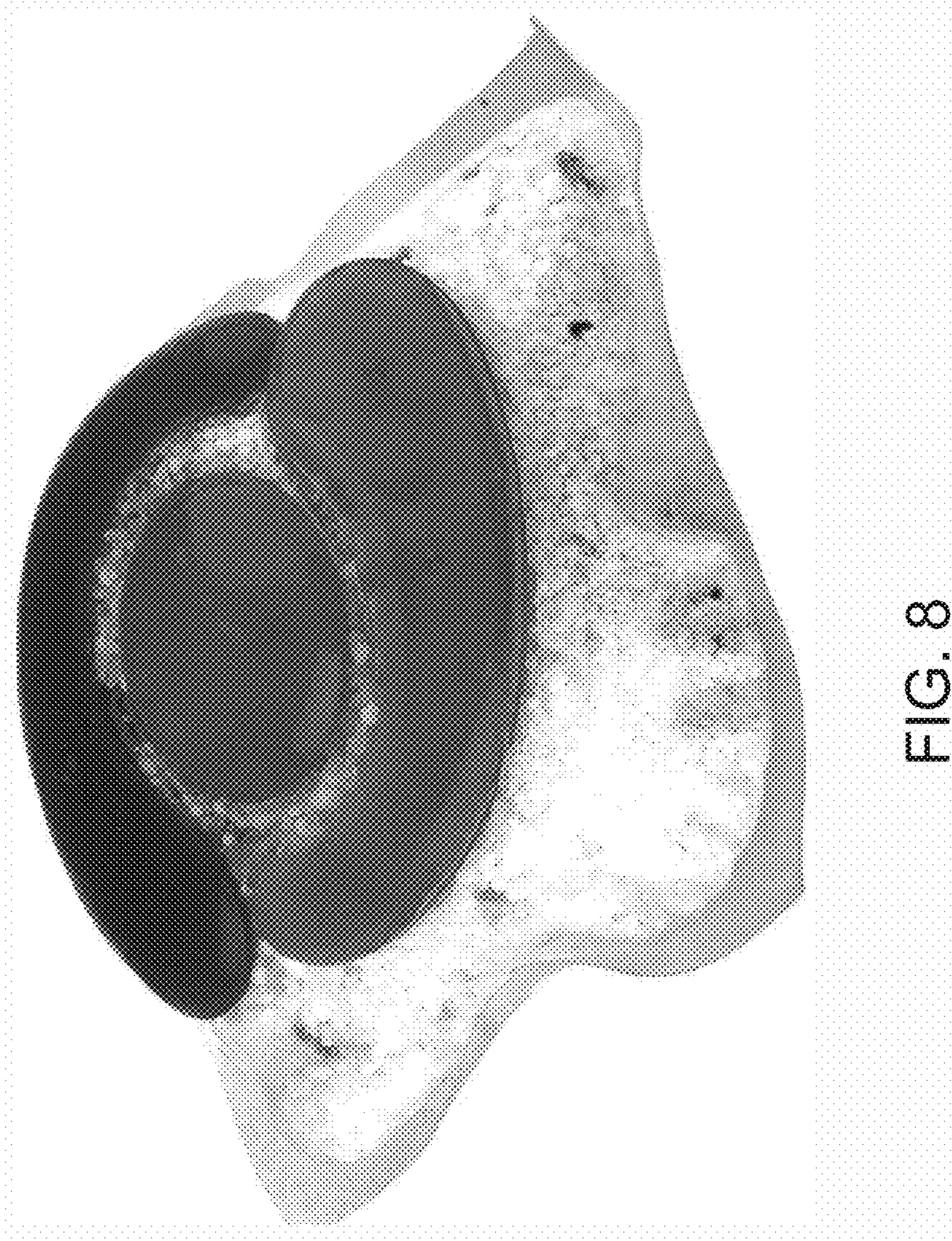

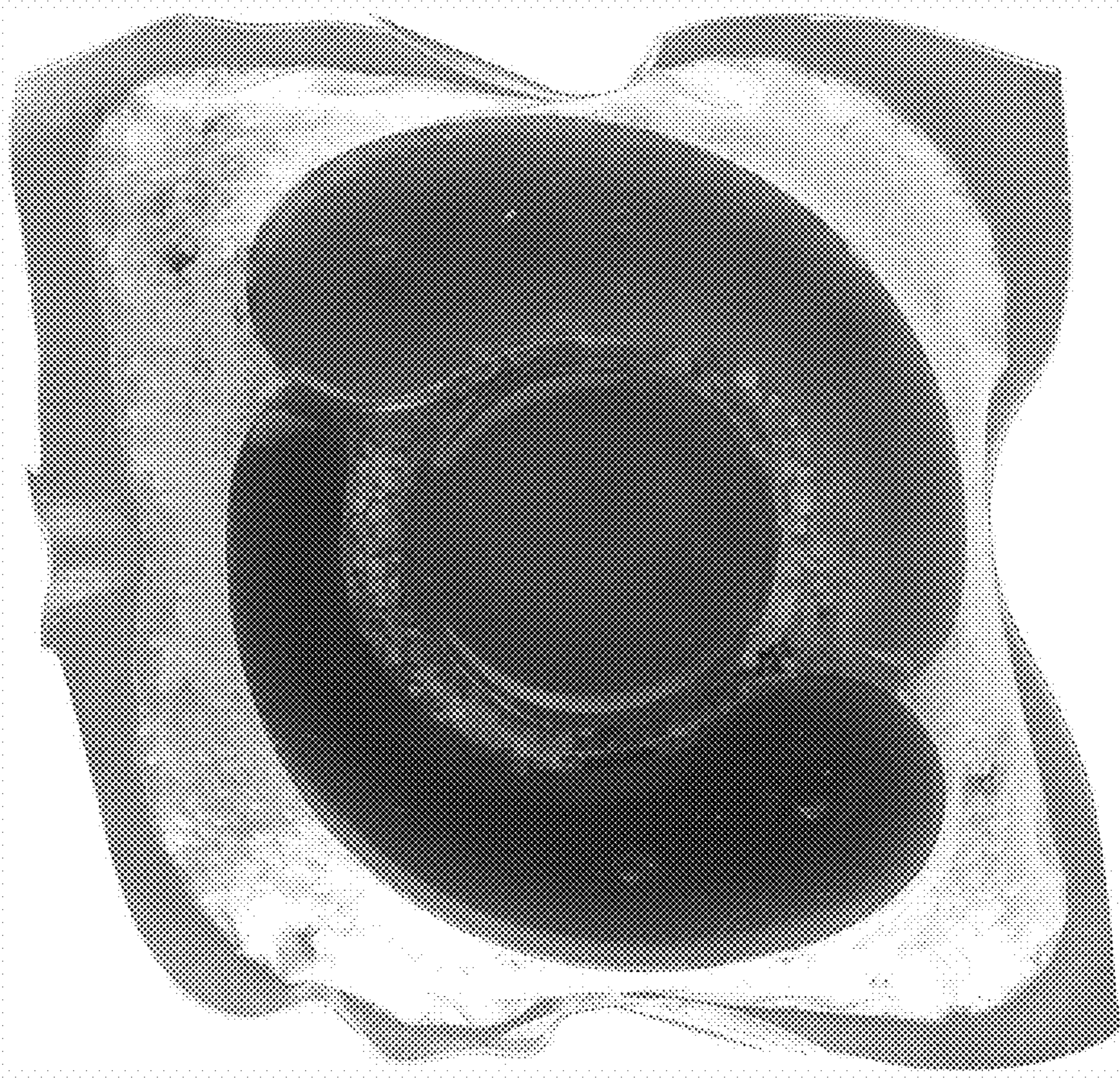

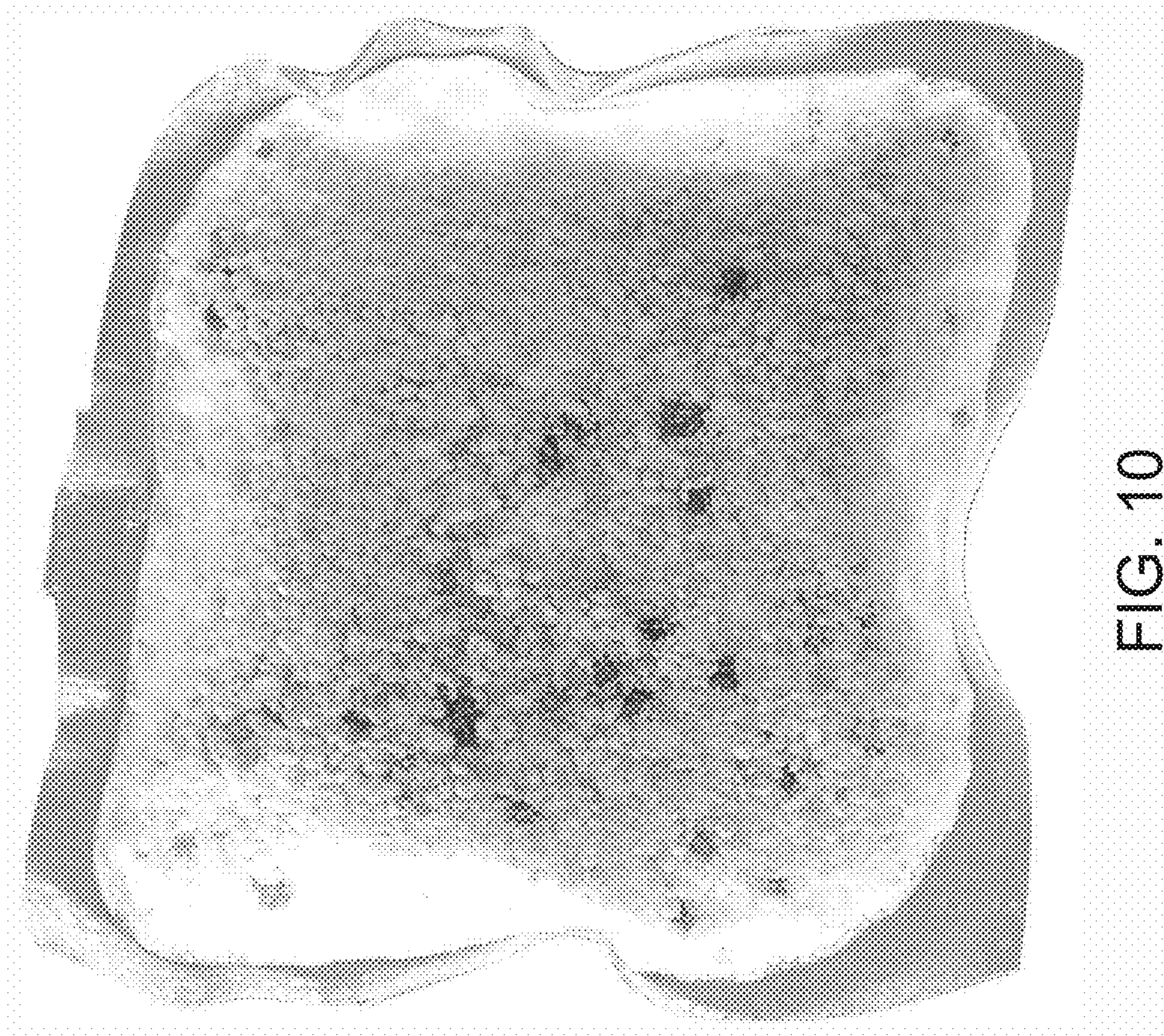
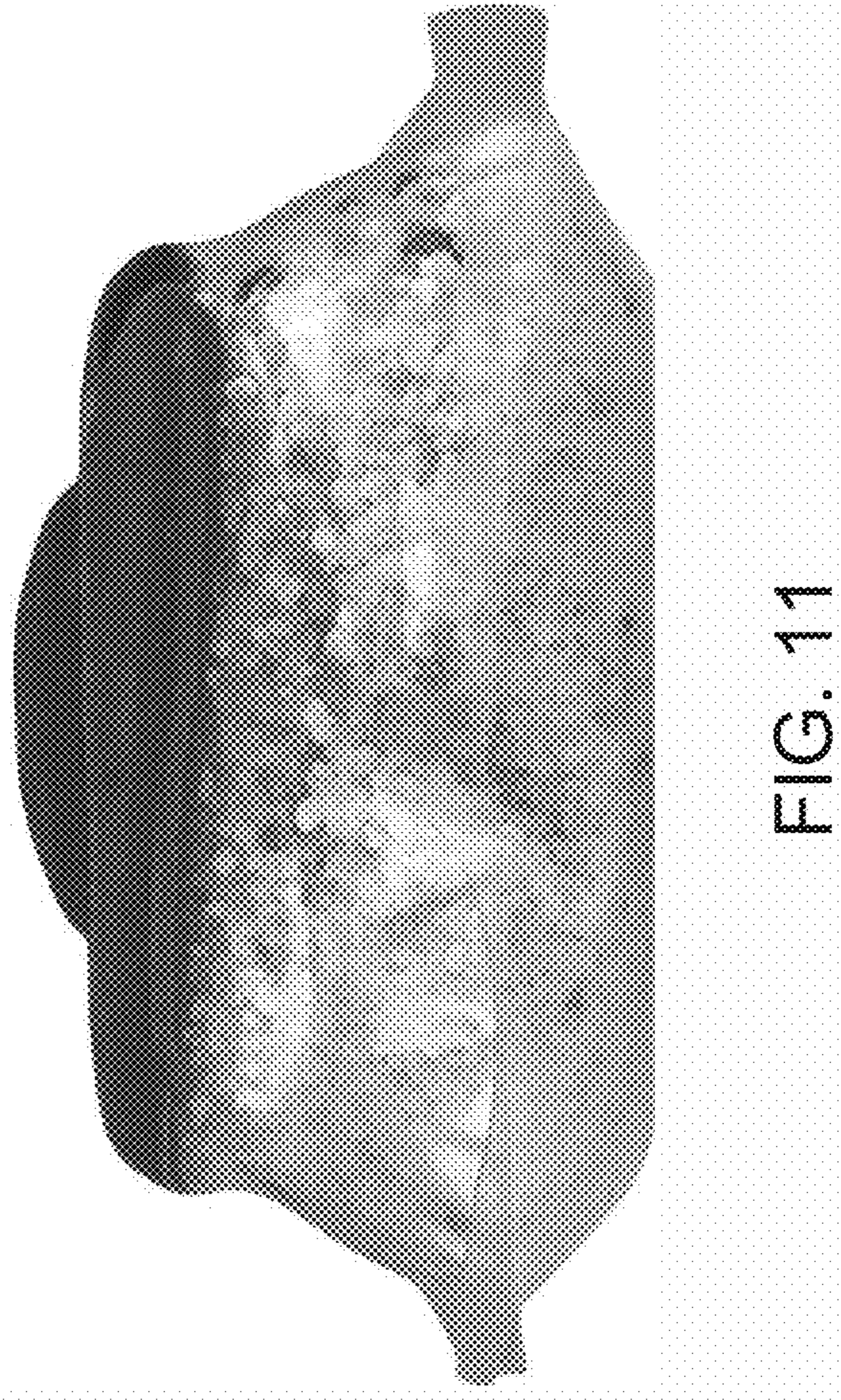

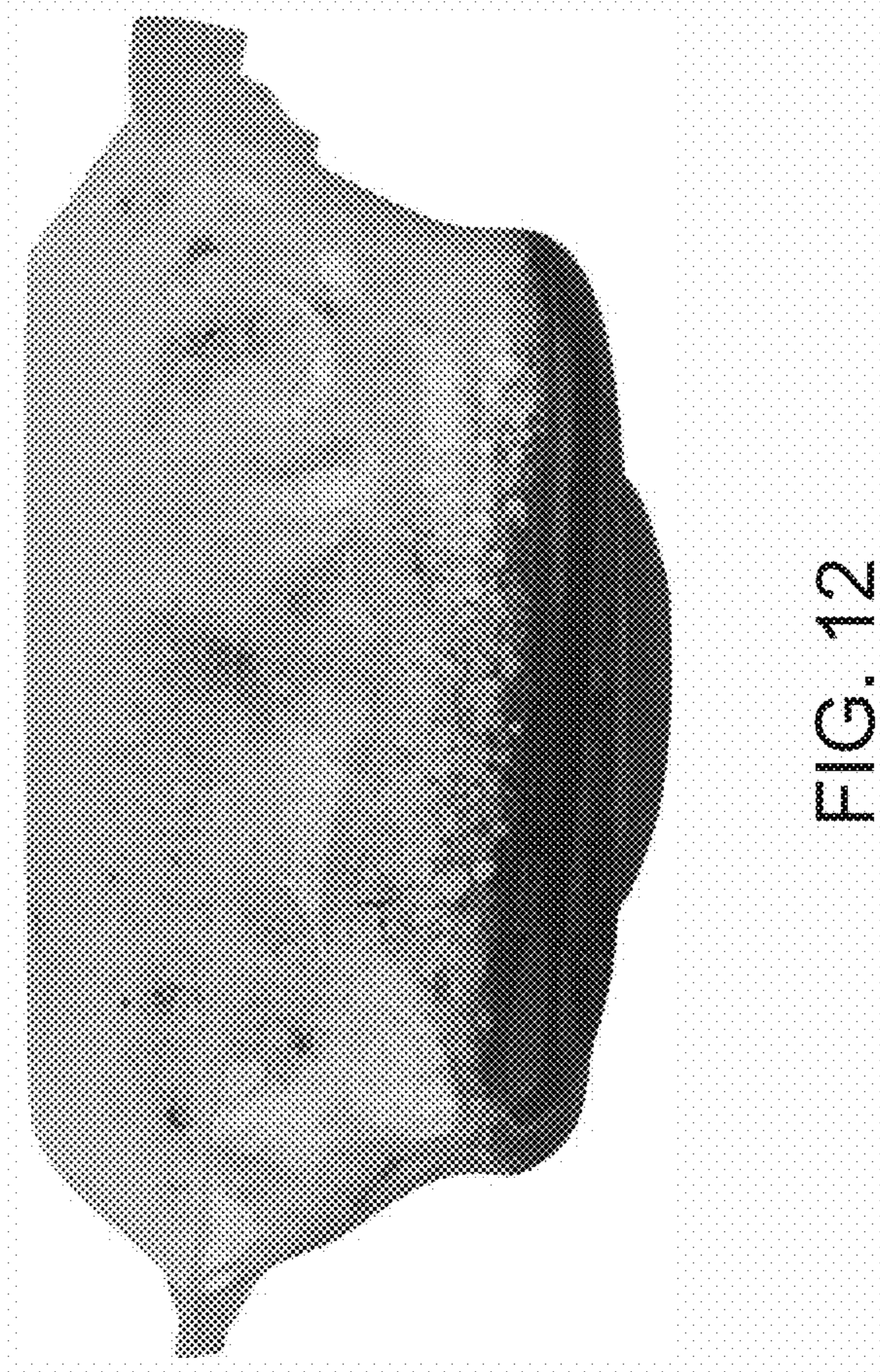

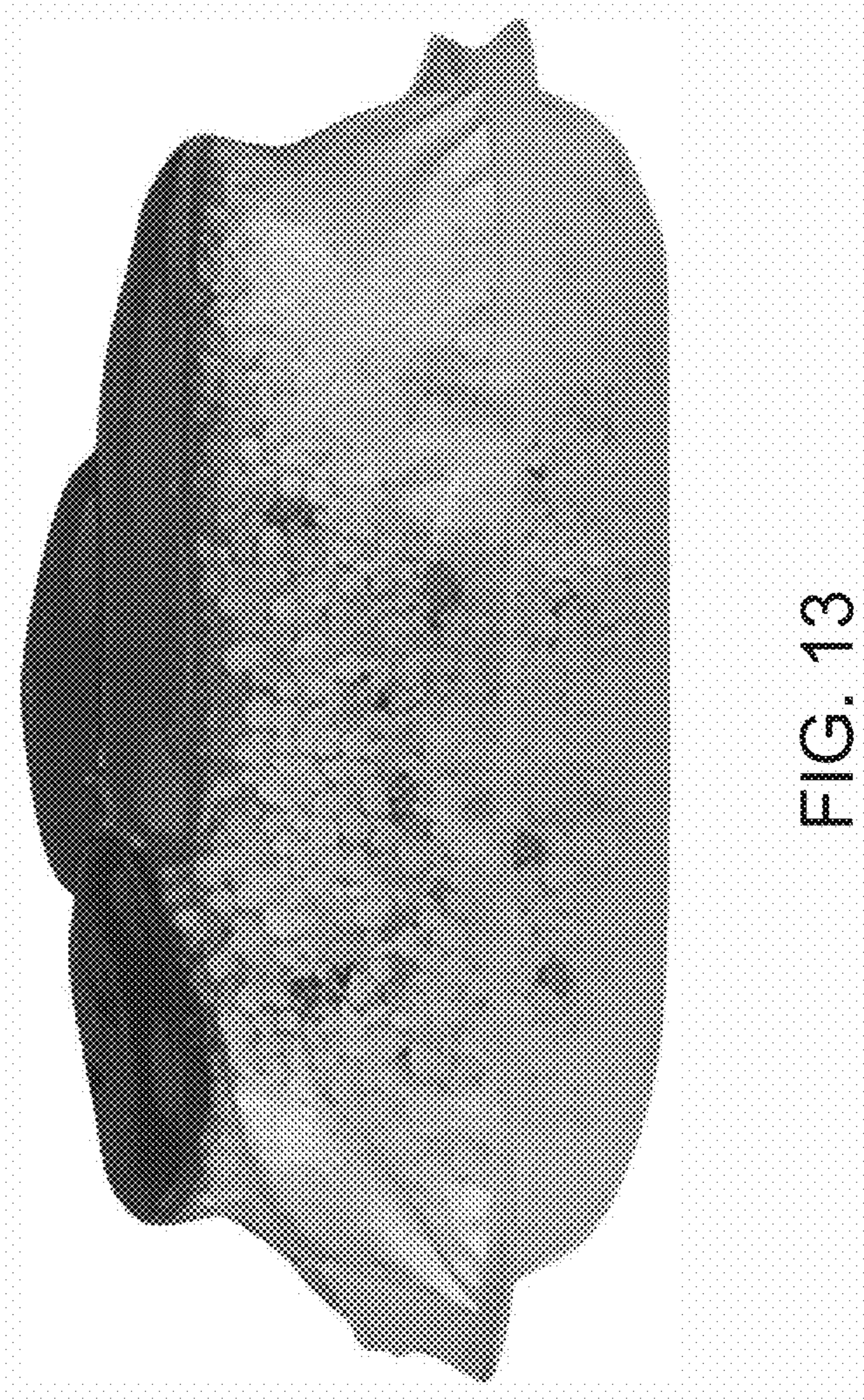

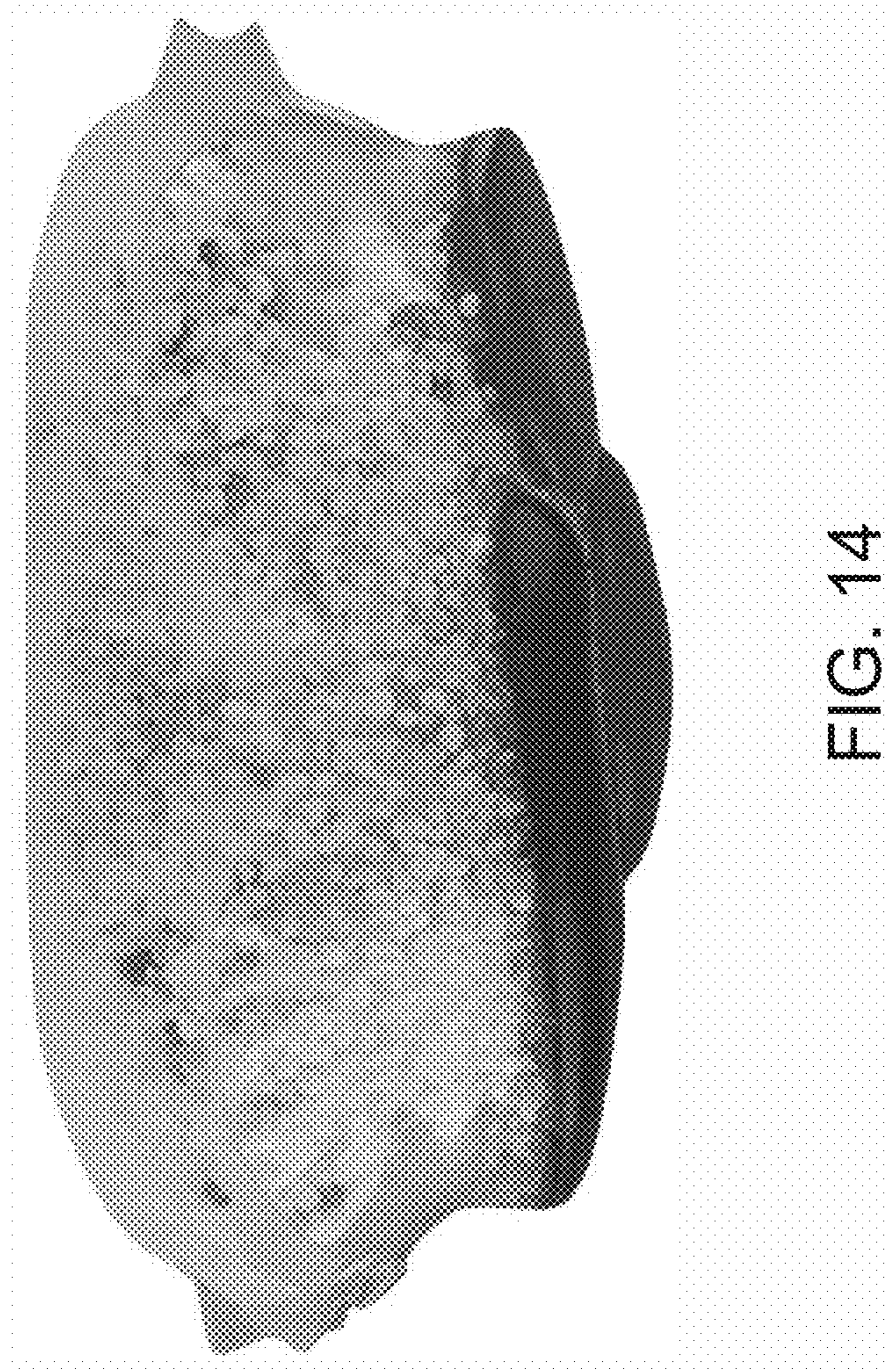

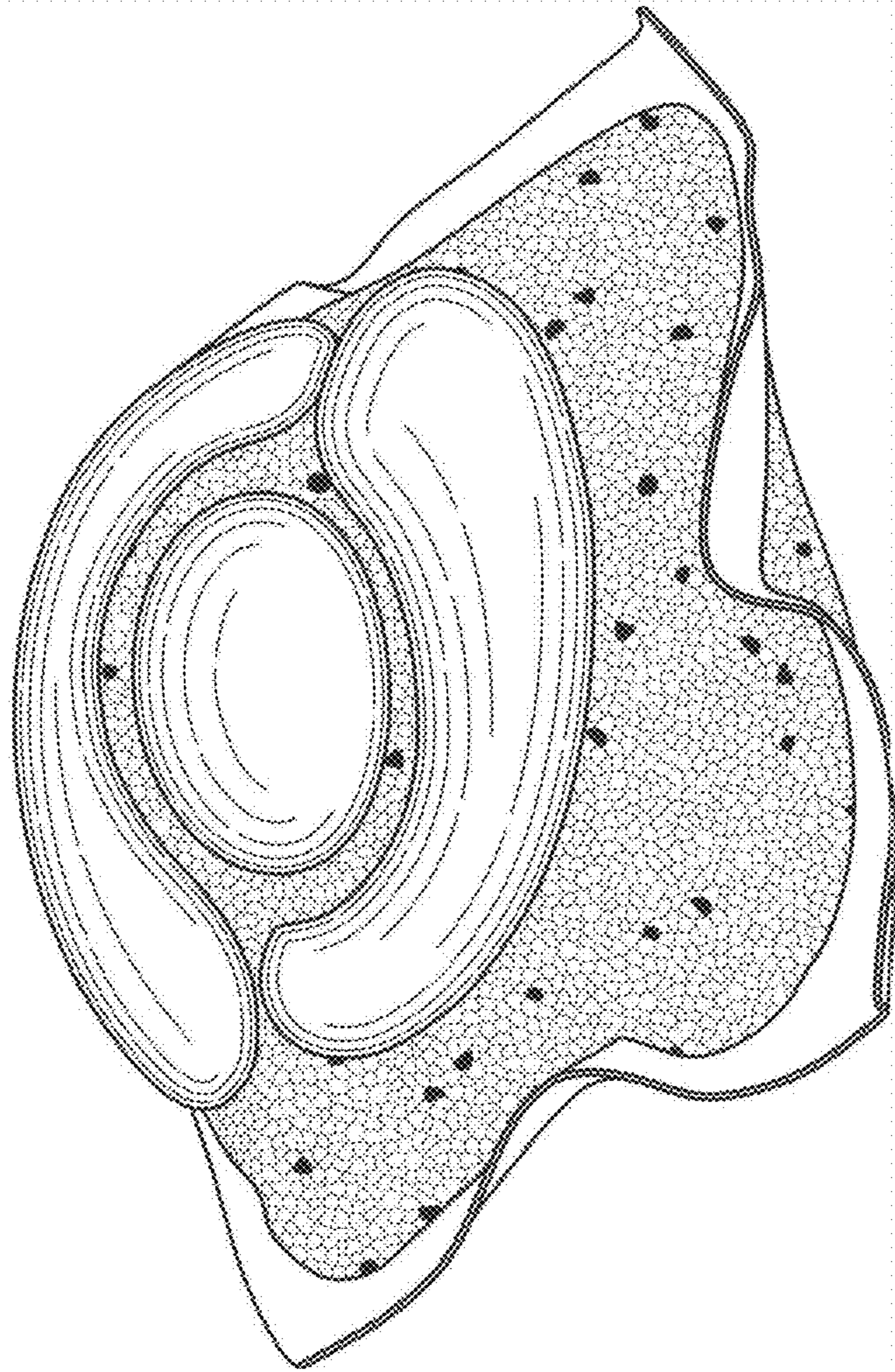

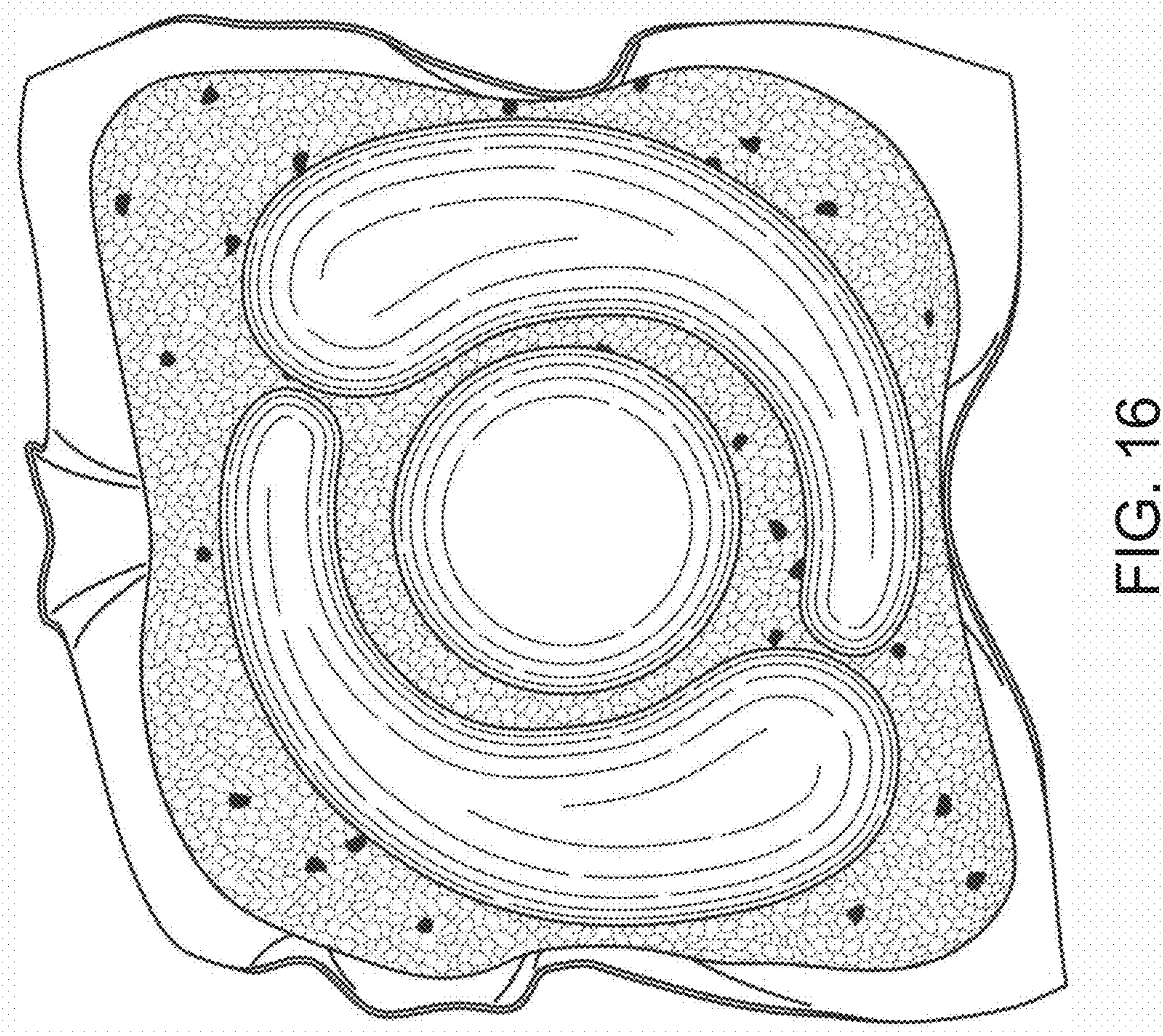

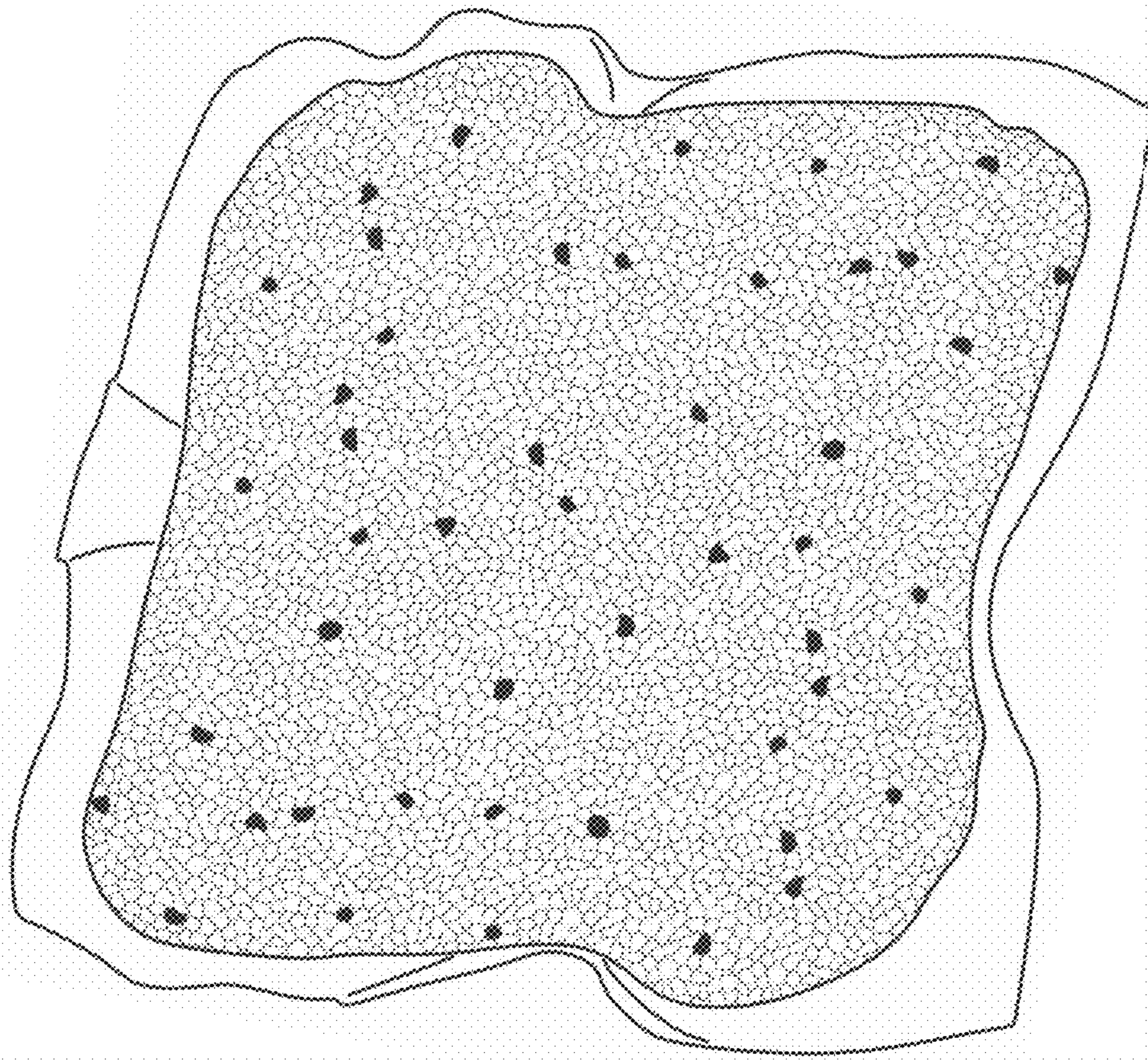

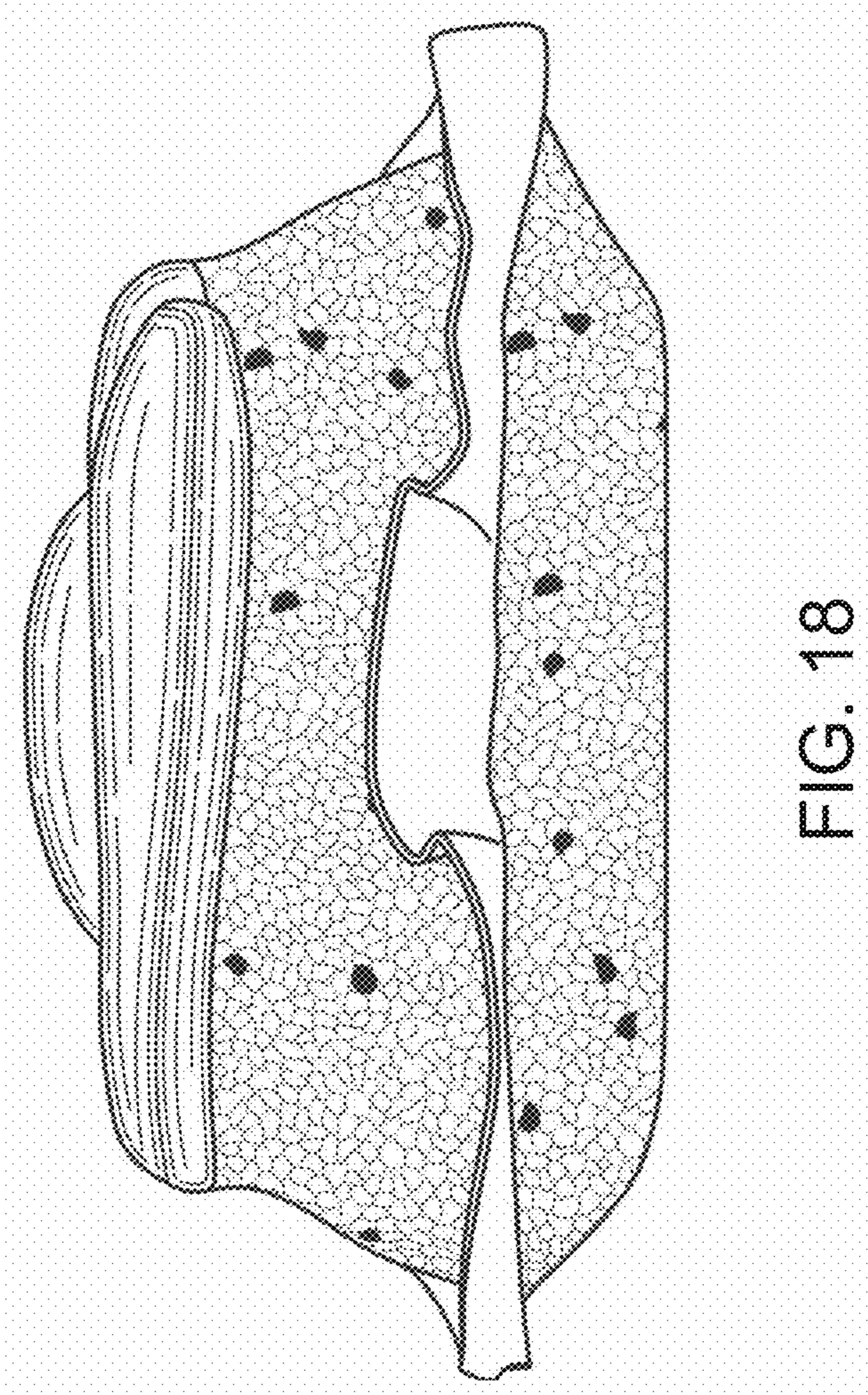

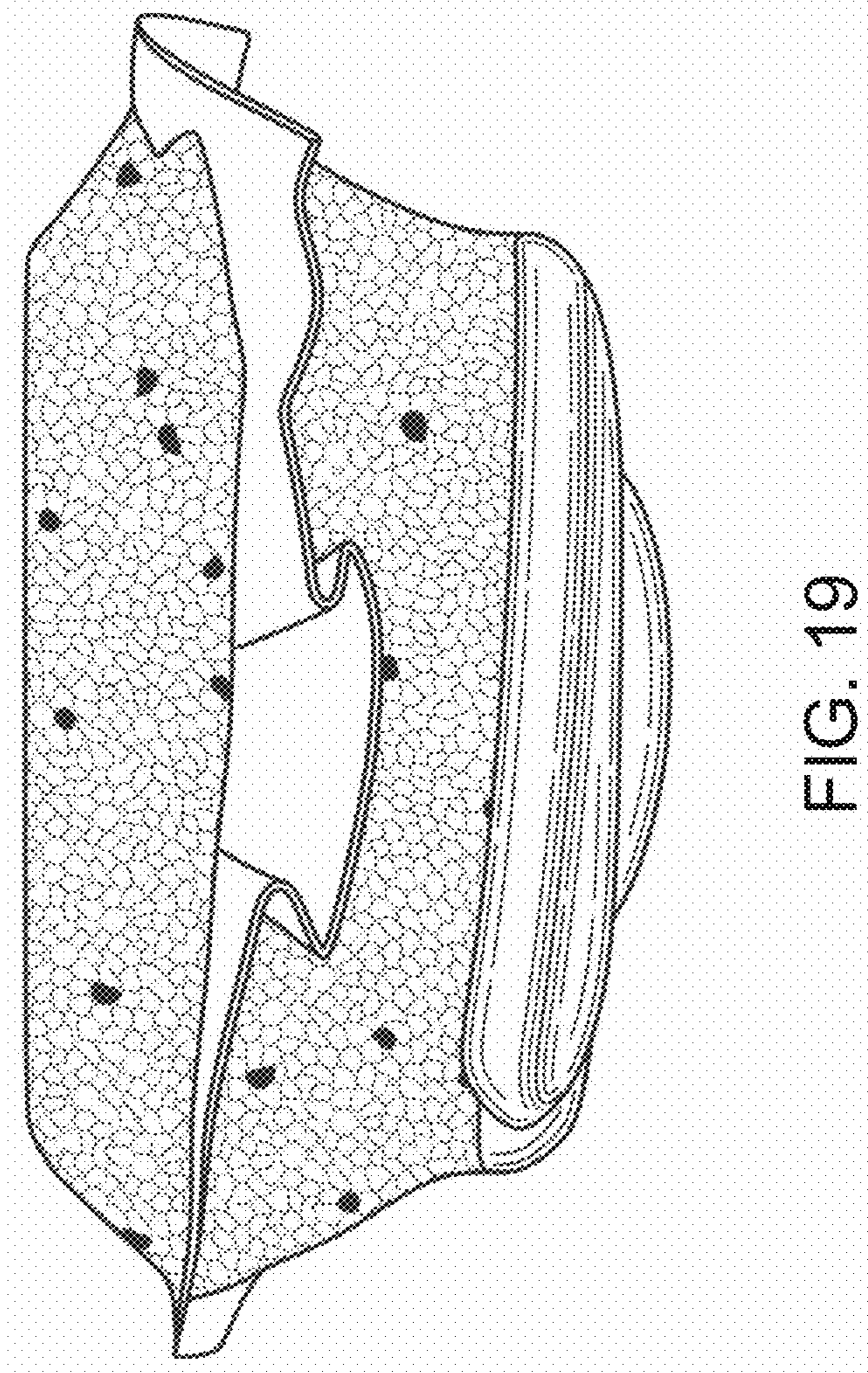

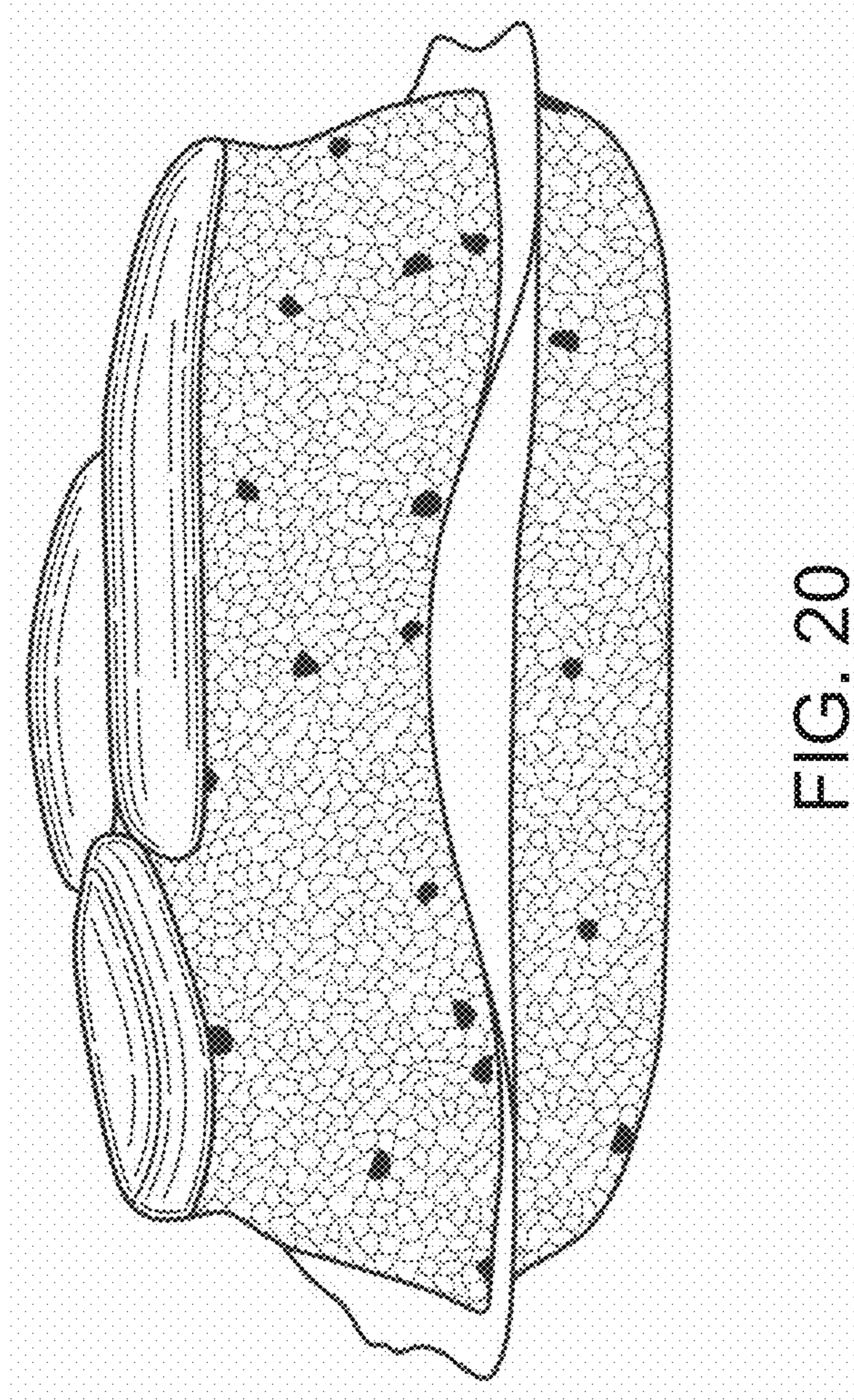

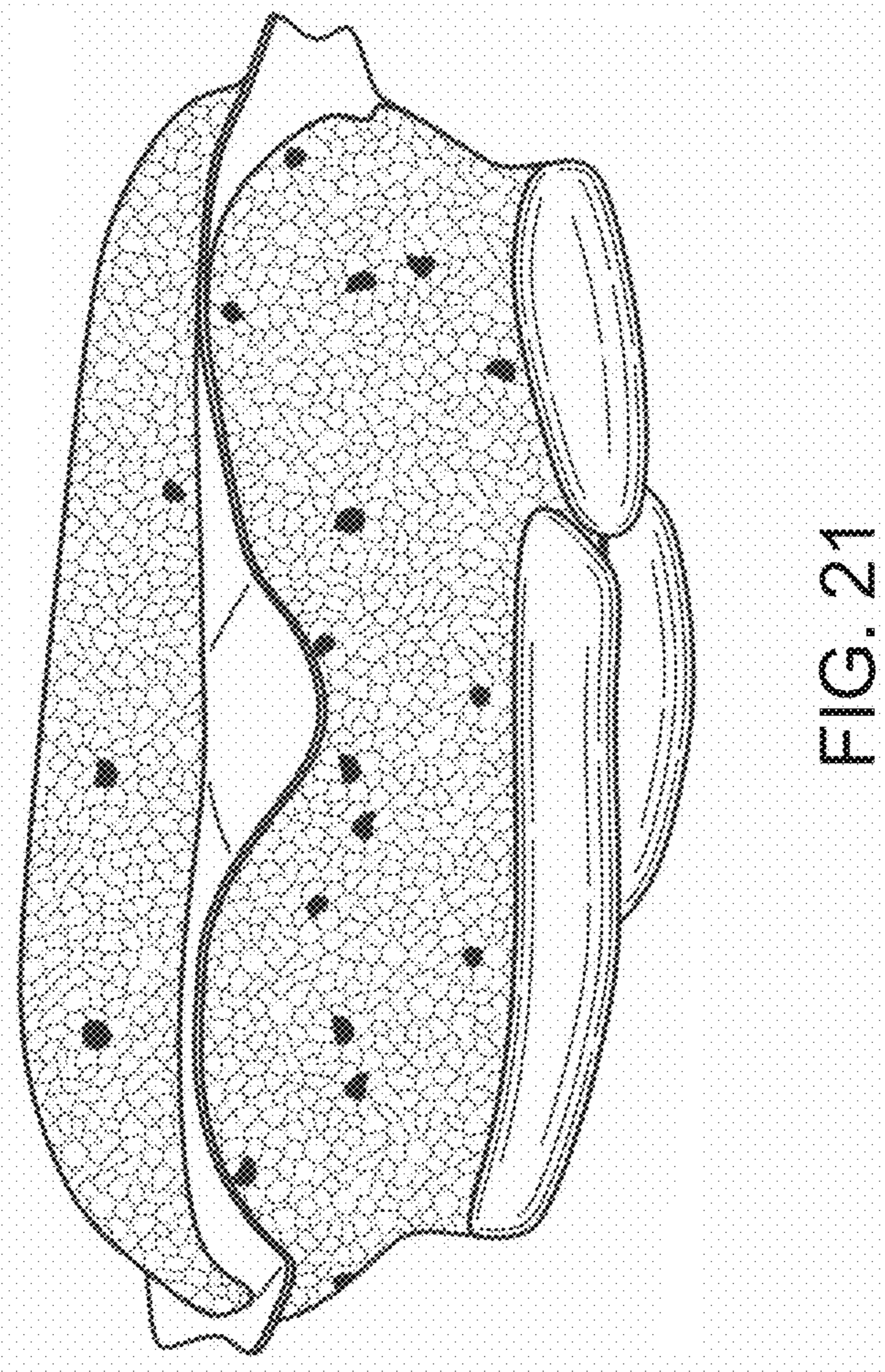
