(57) **CLAIM**

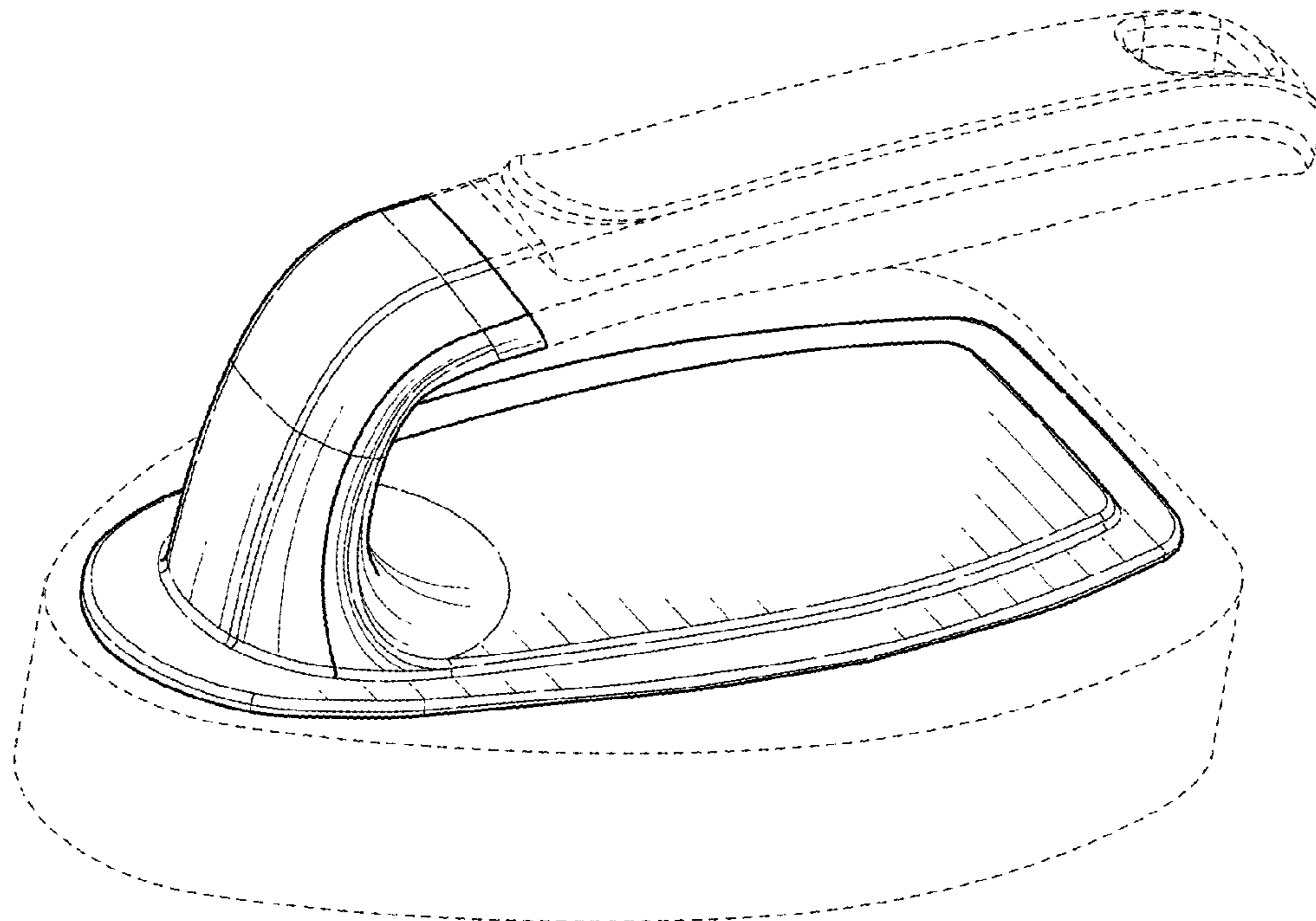
The ornamental design for a refillable cleaning tool, as shown and described.

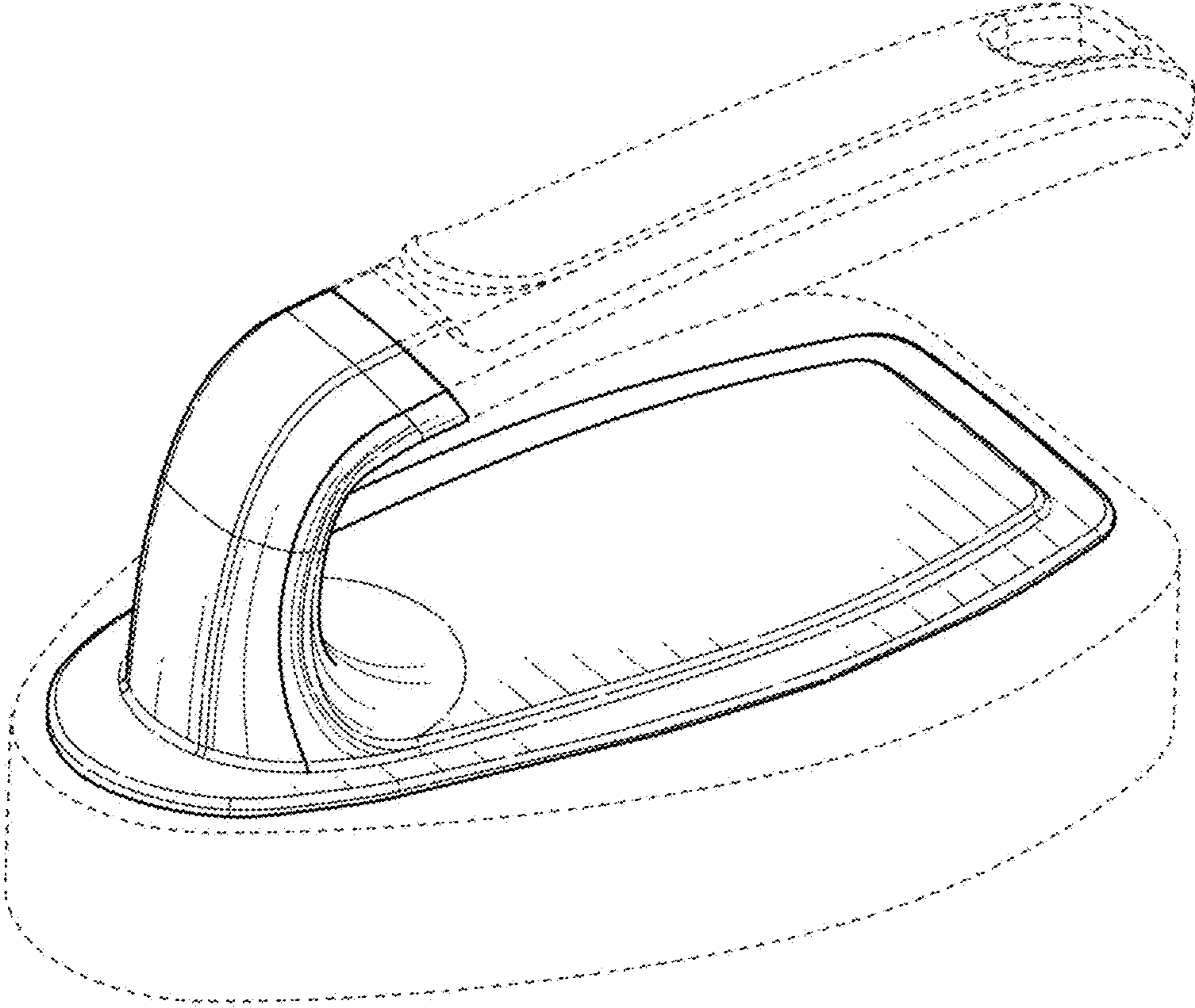

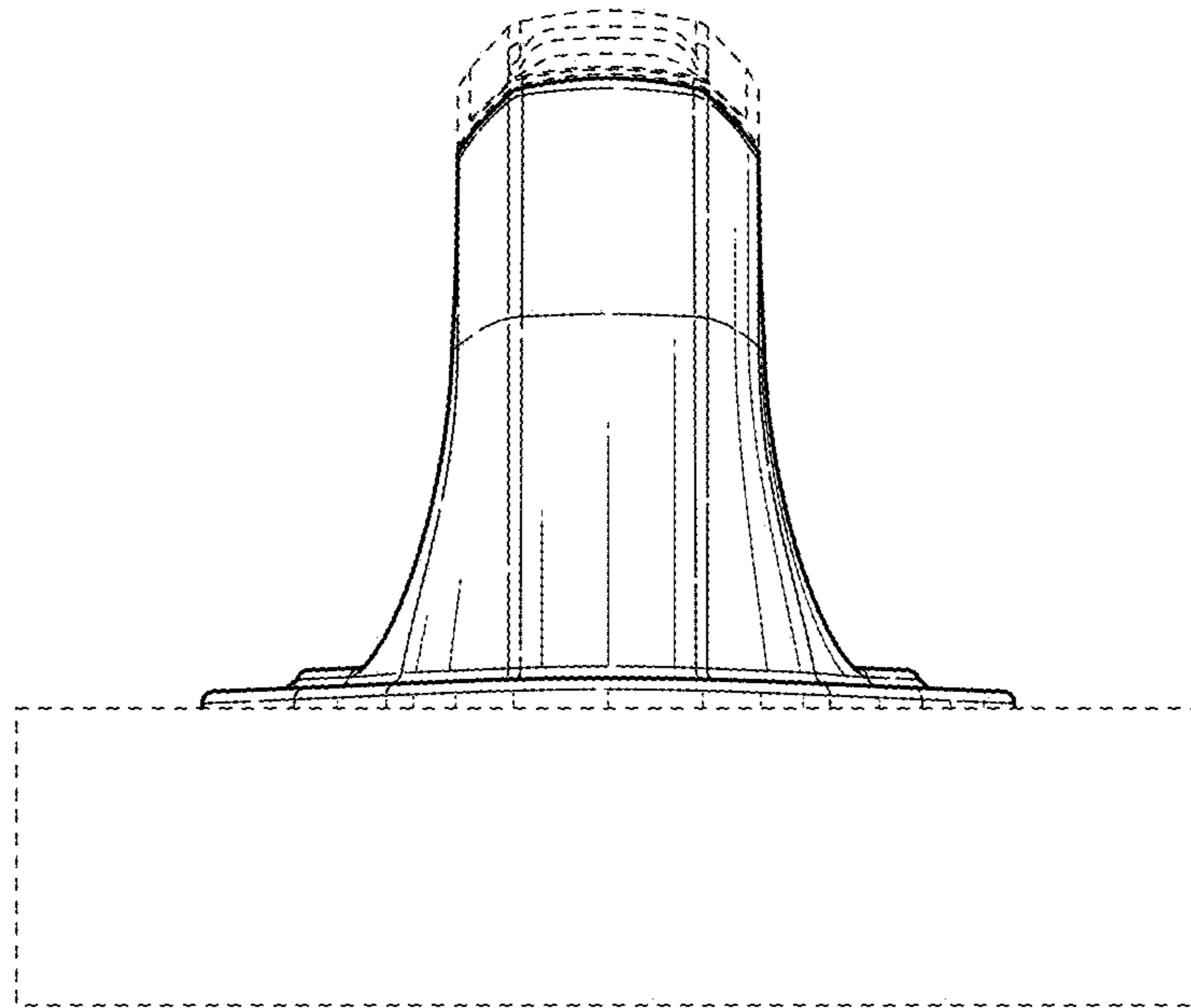

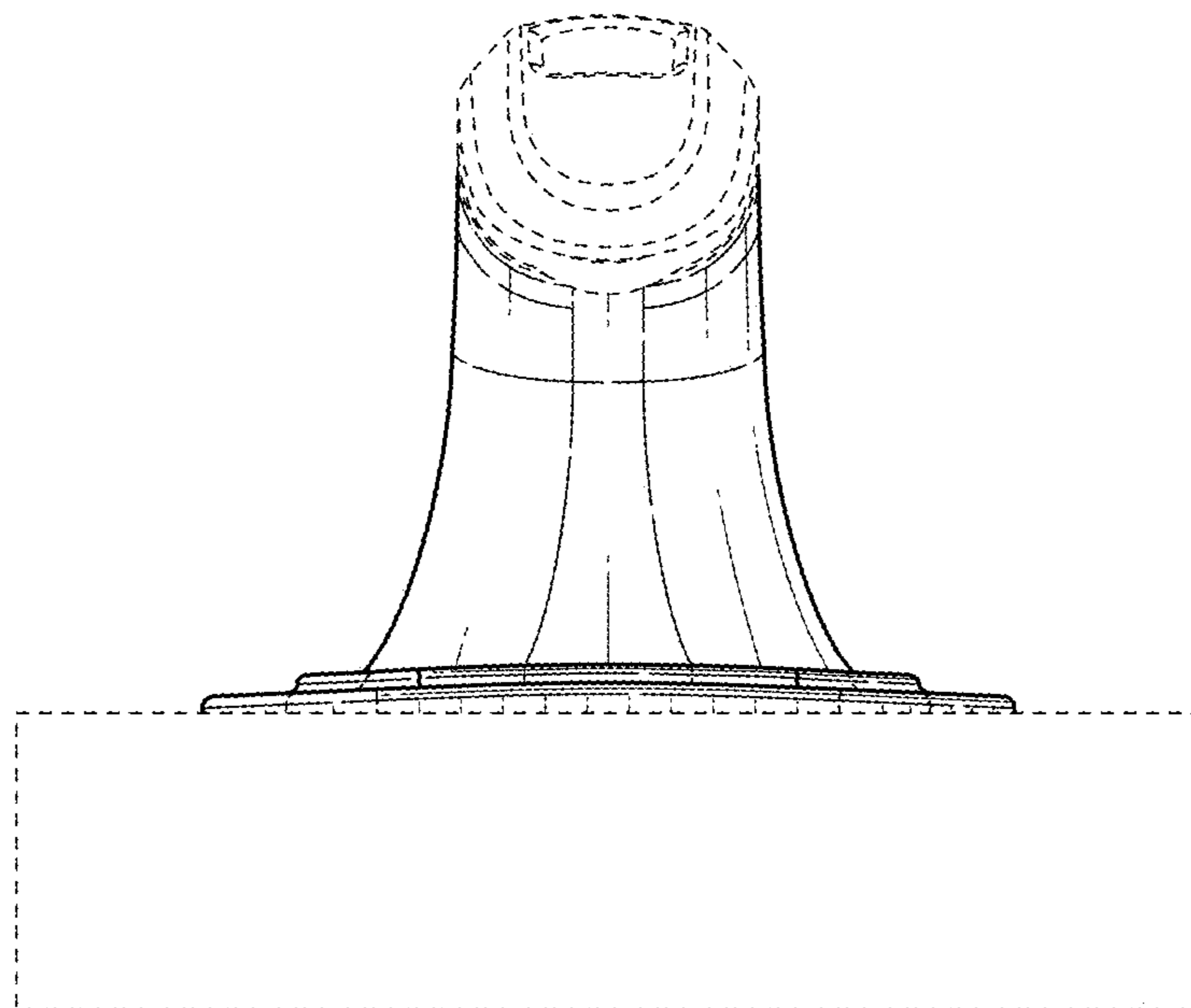

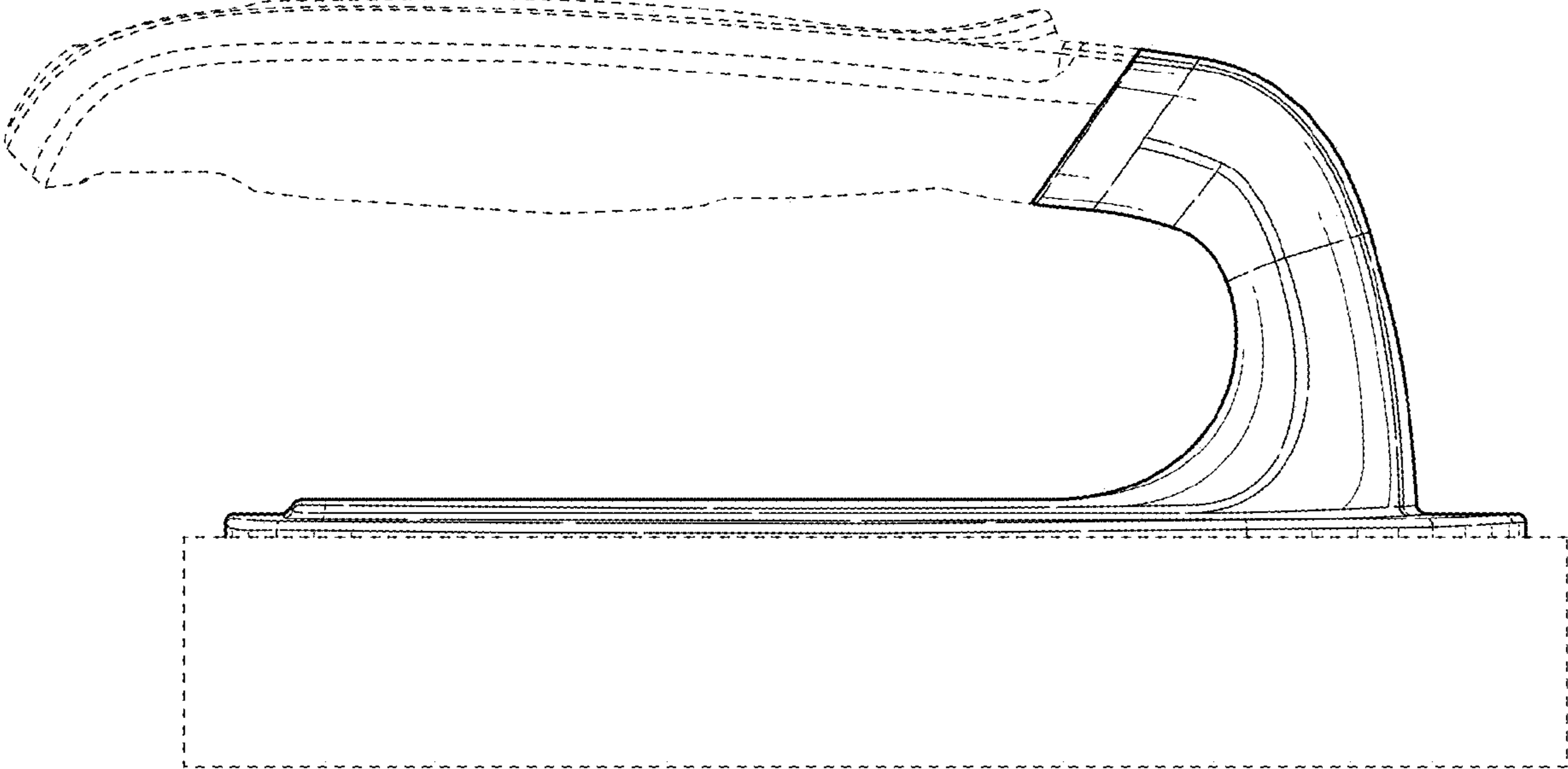

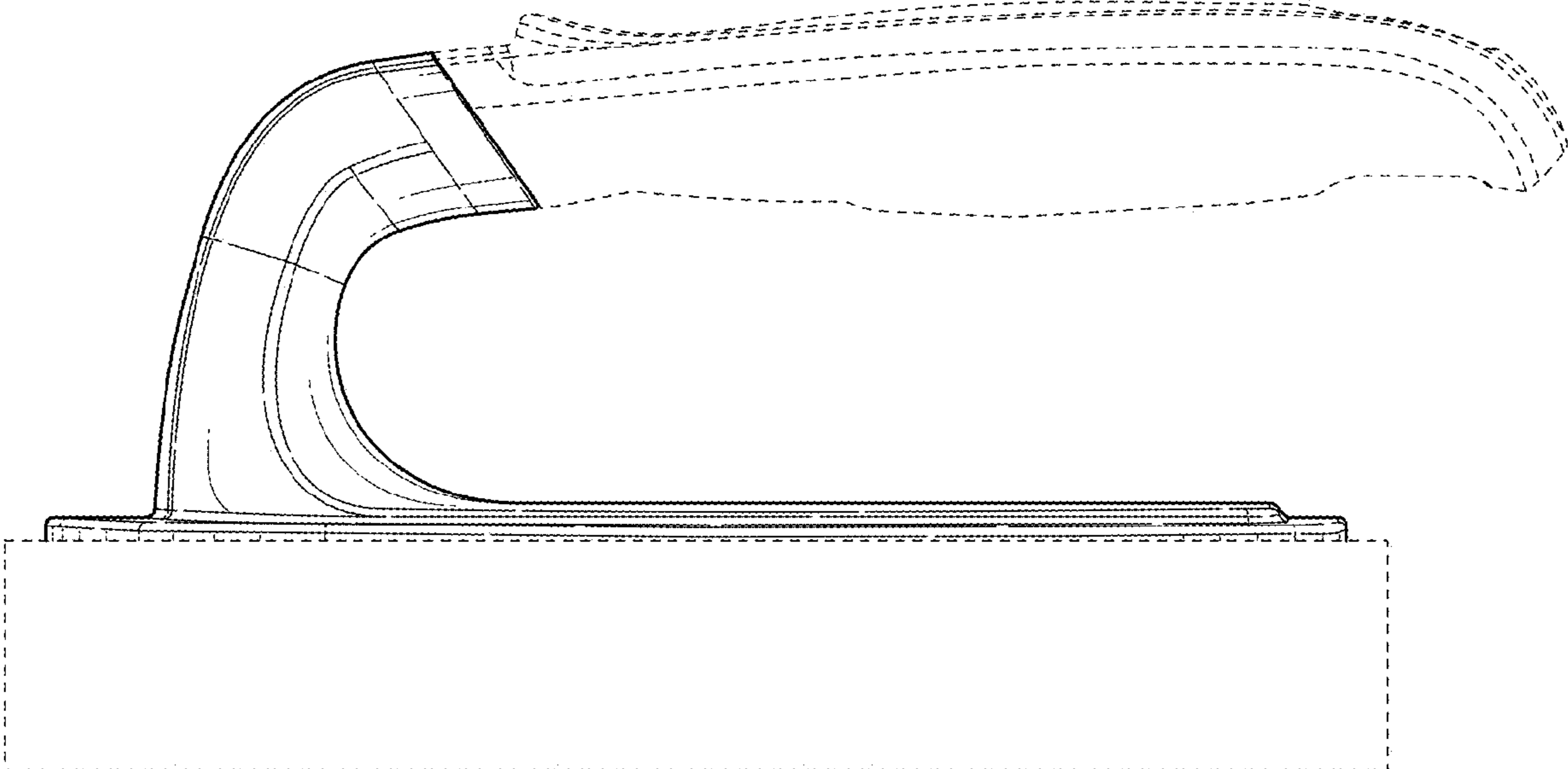

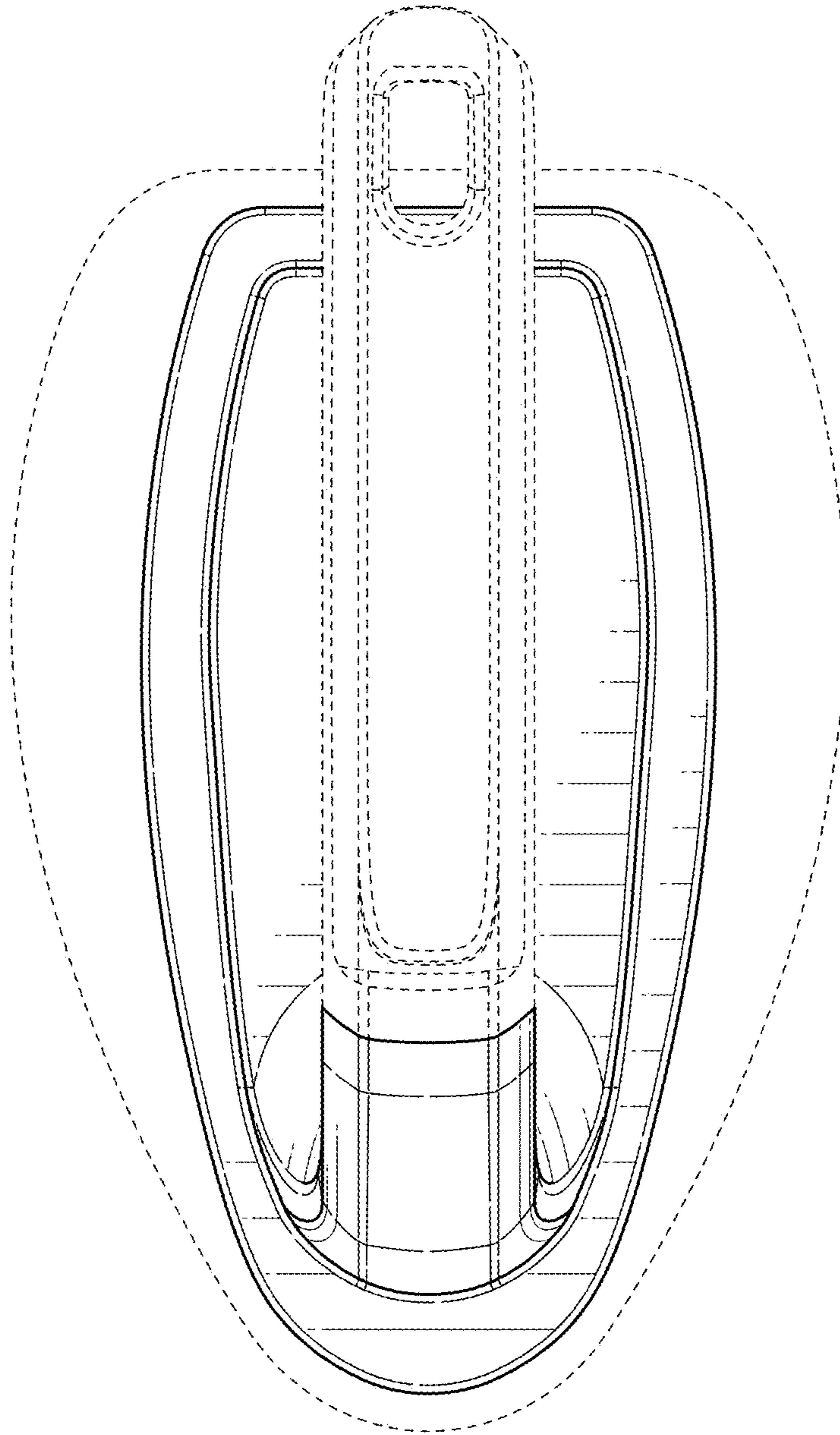

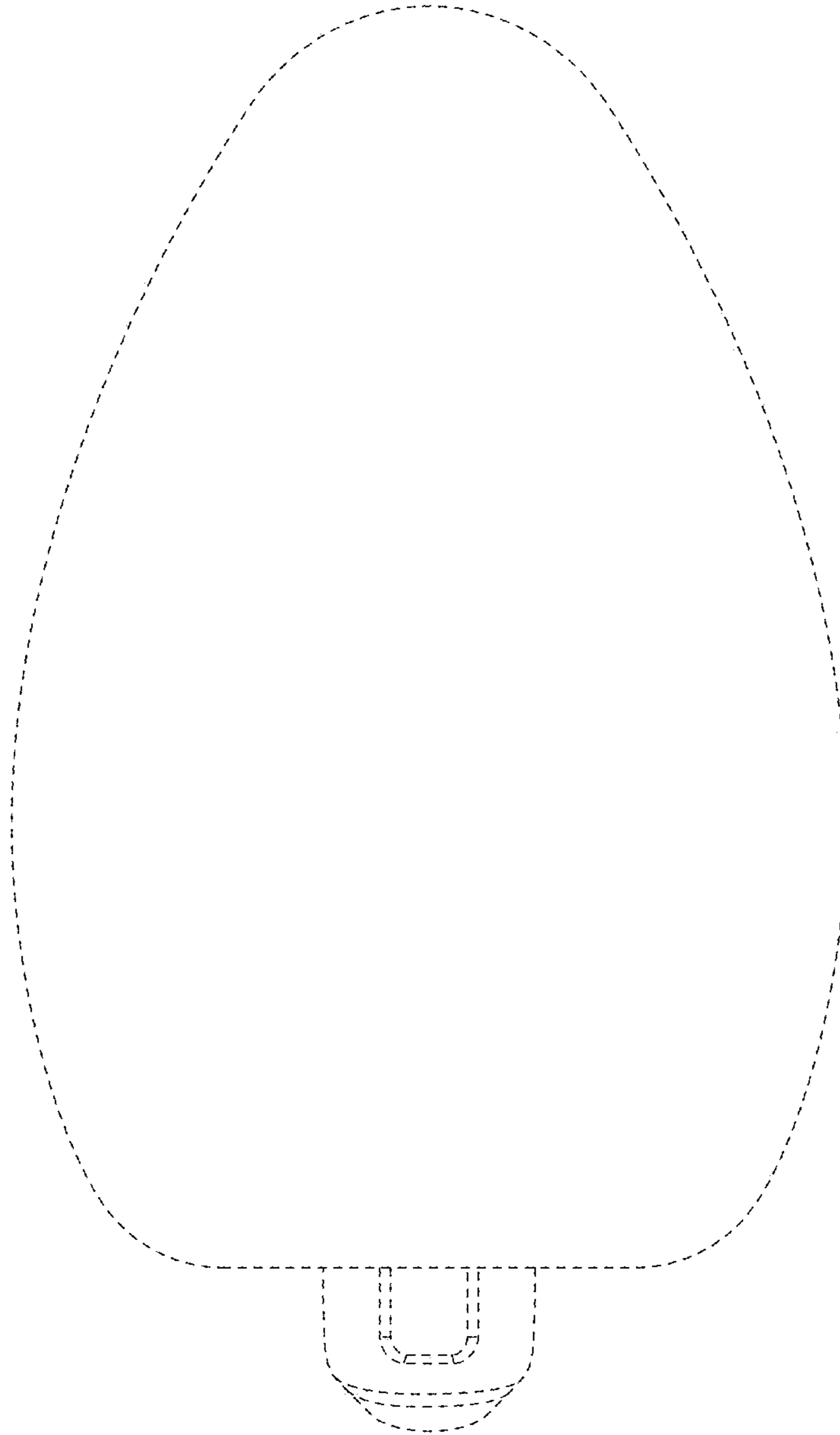
