1. Vest

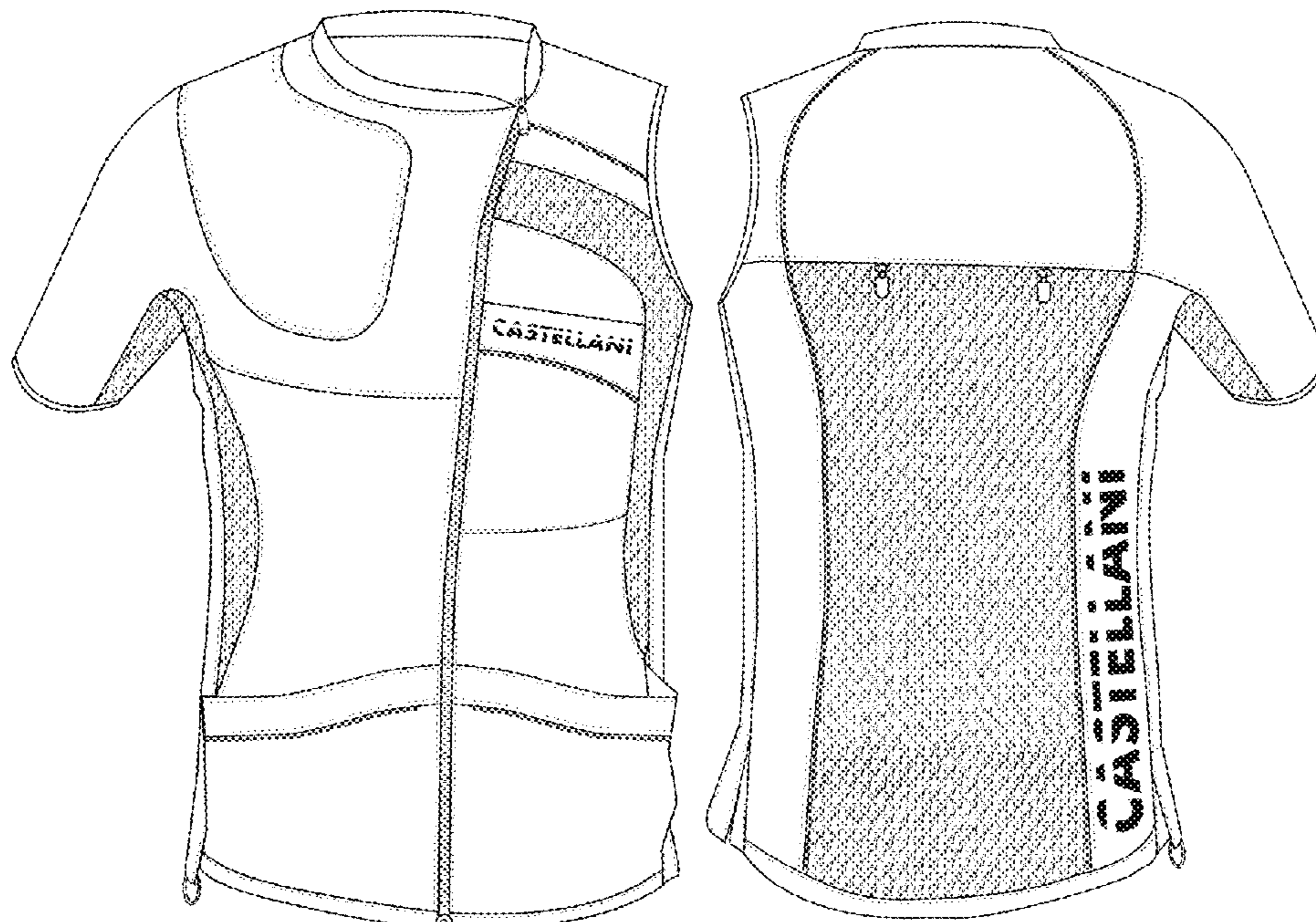
1.1 : Front view;

1.2 : Rear view.

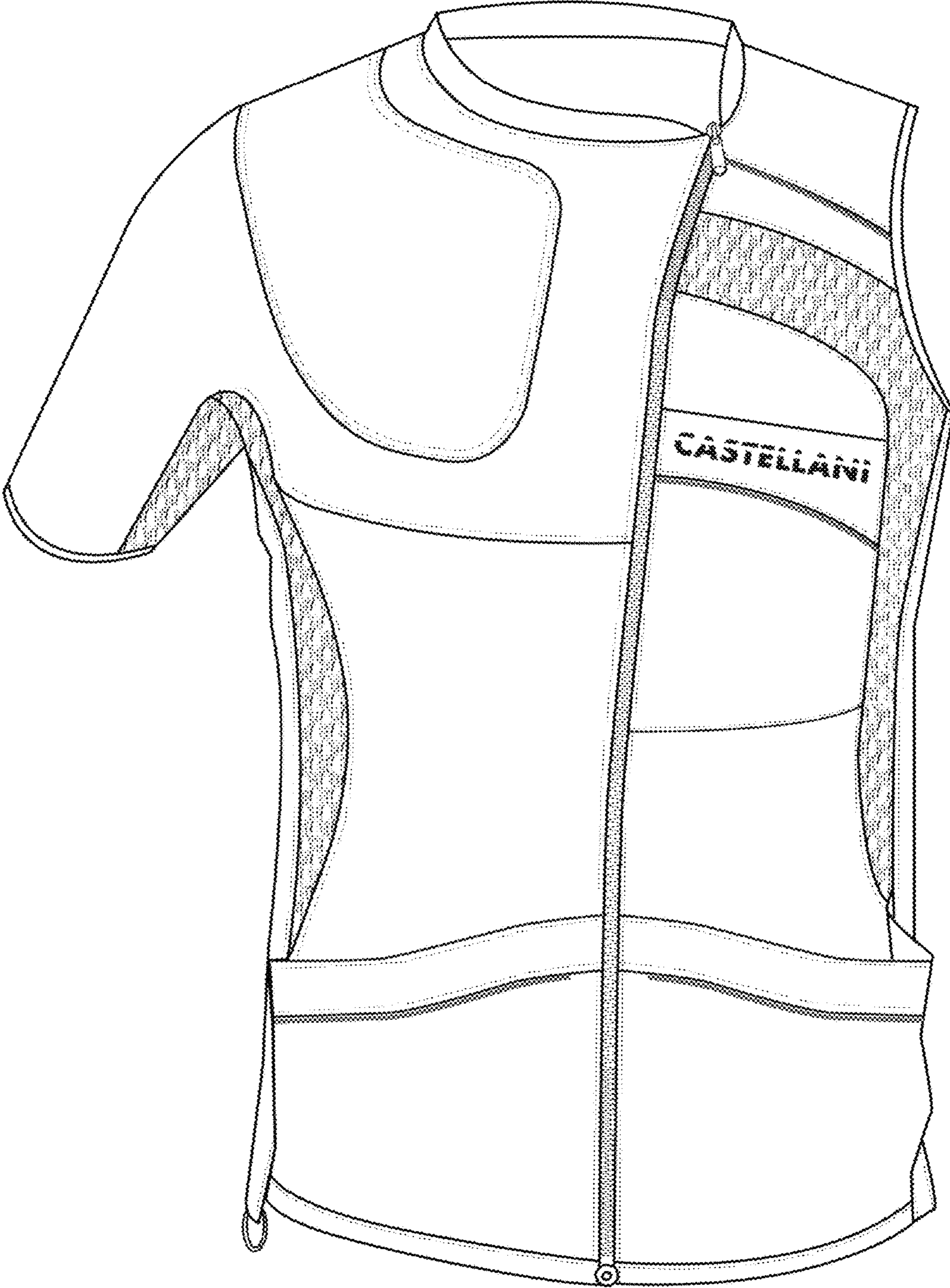
The design is an asymmetrical vest with a short sleeve on the side; the front has a curved zipper from the bottom to the side of the crew neck.
