The ornamental design for a hands-free hair dryer system, as shown and described.

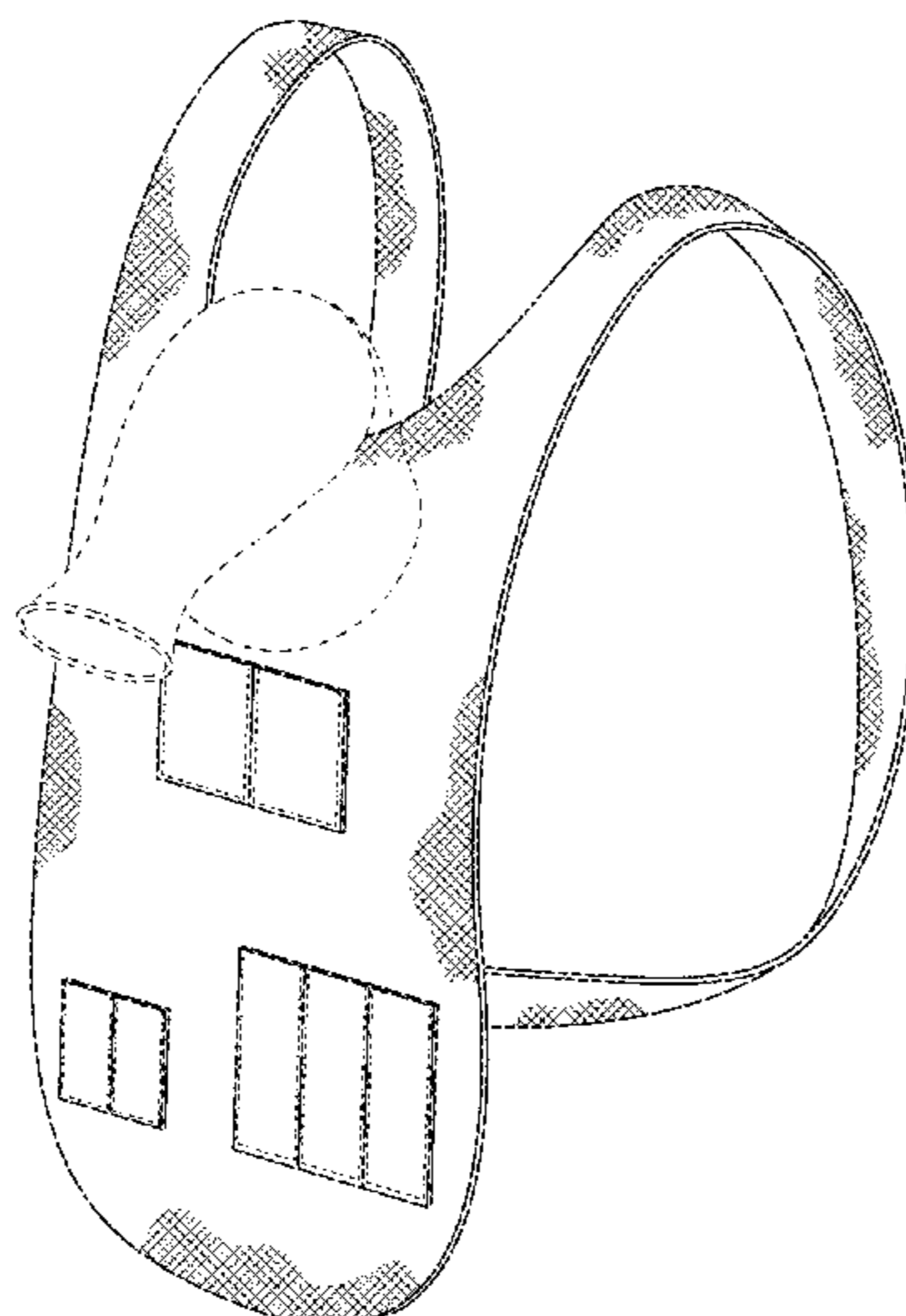
DESCRIPTION

FIG. 1 is an isometric view of a hands-free hair dryer system showing my new design;

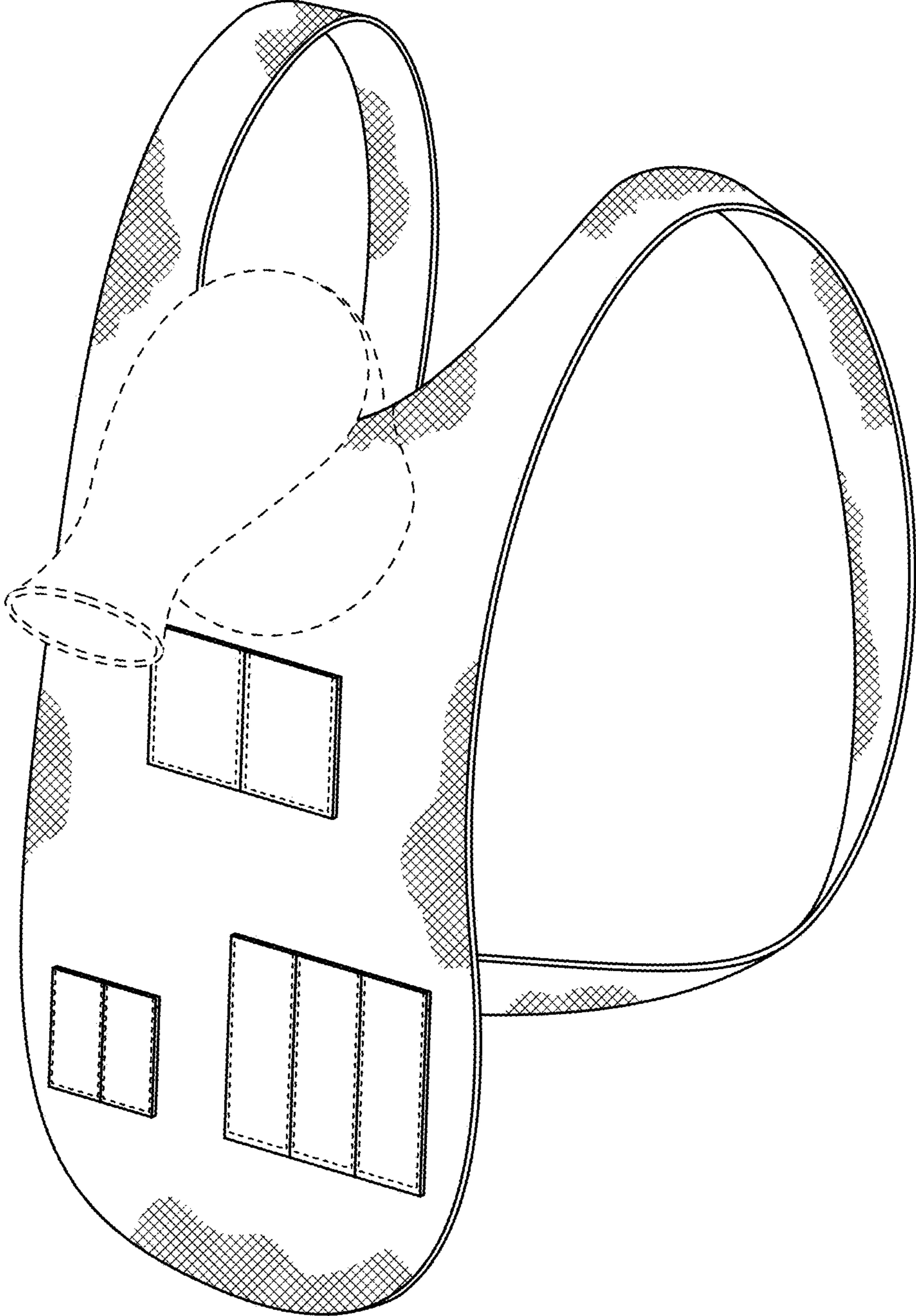

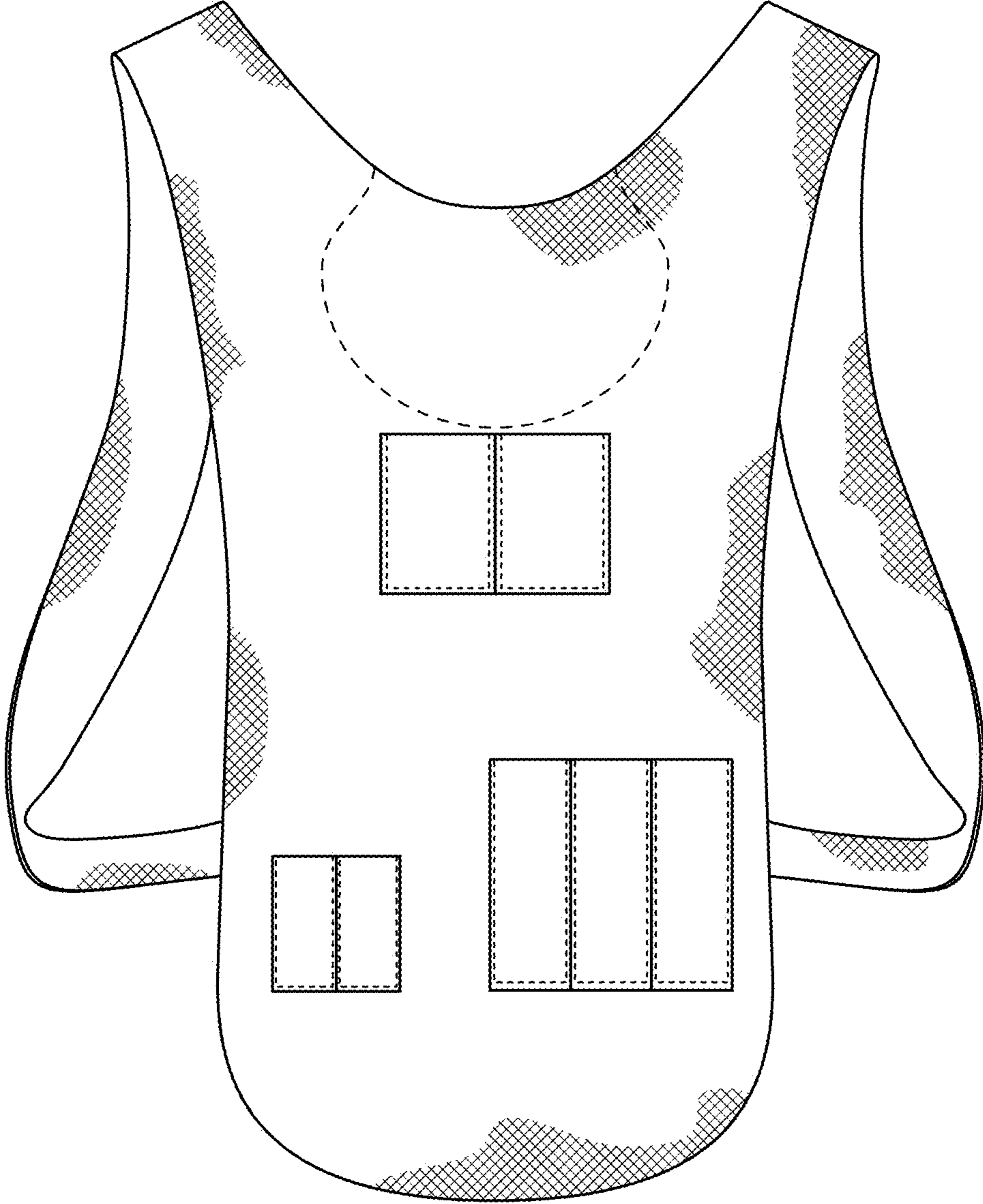

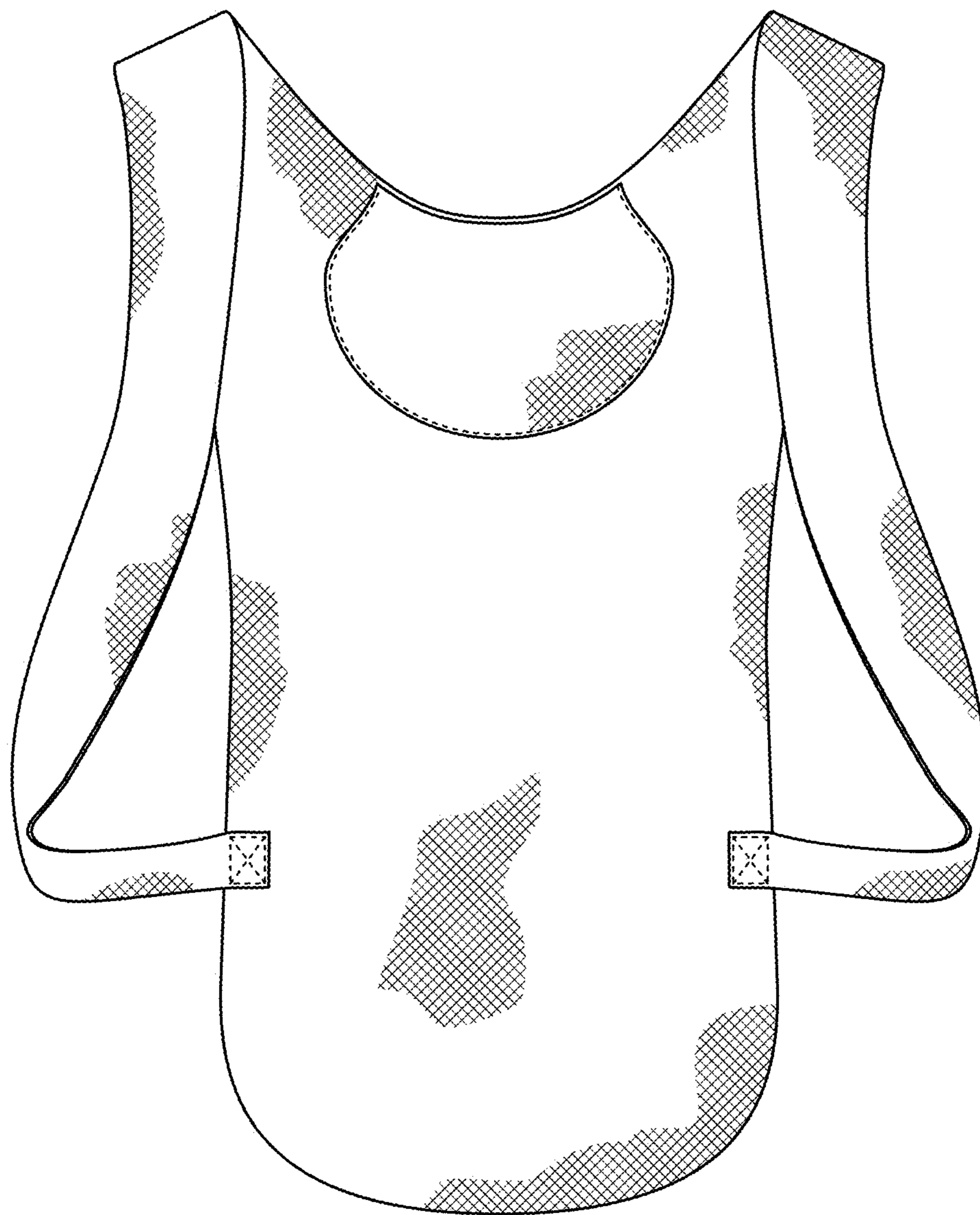

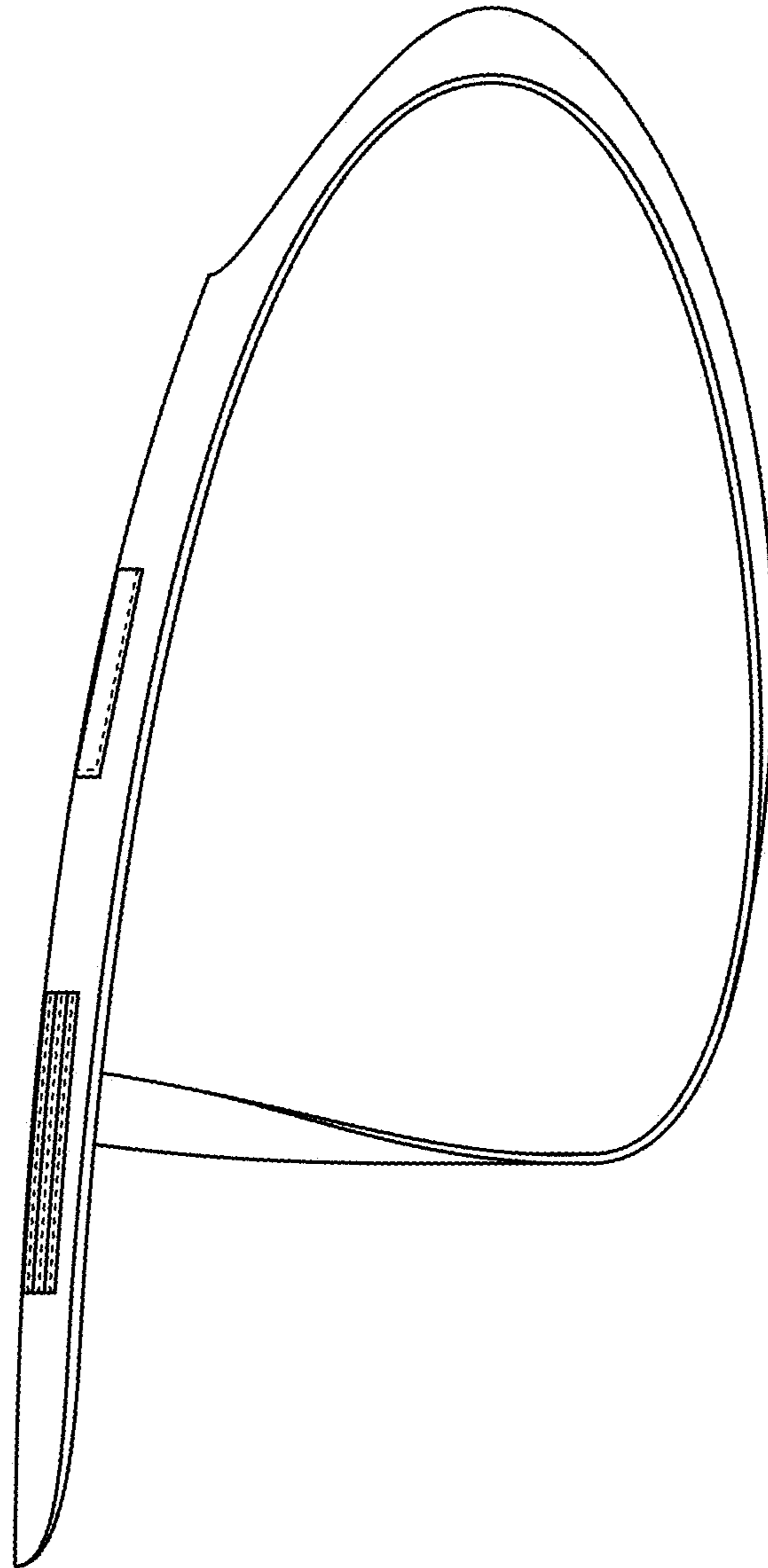

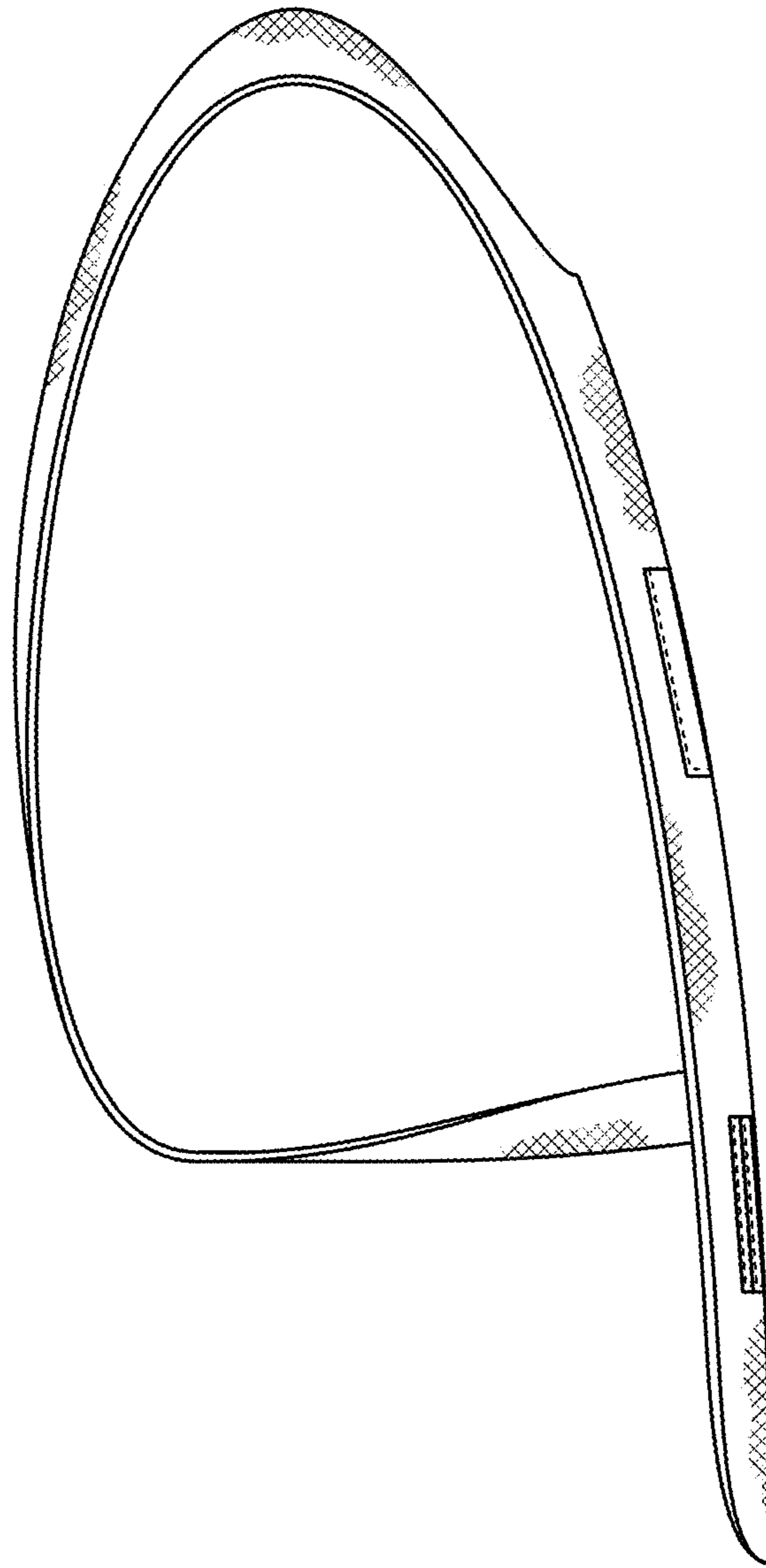

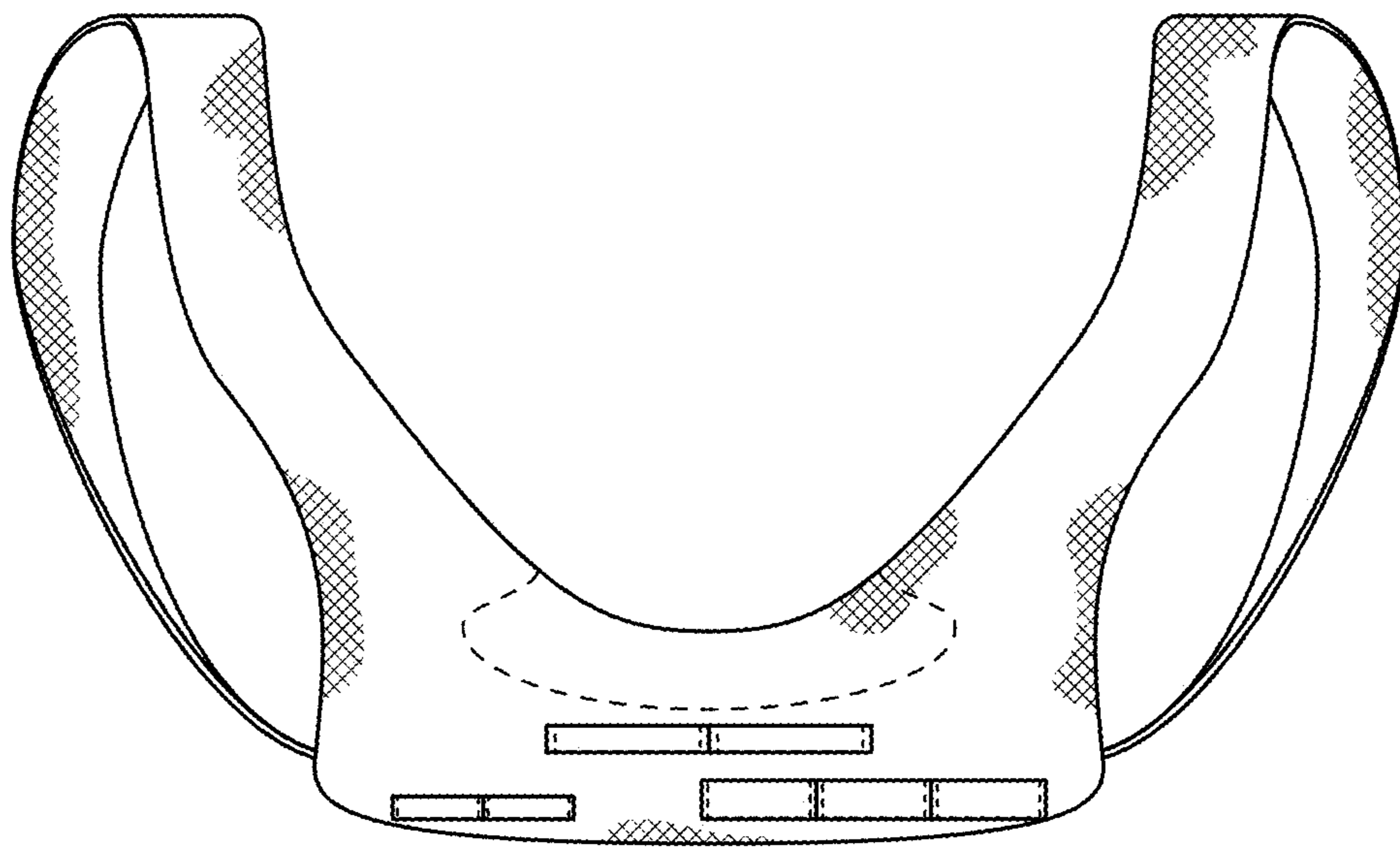

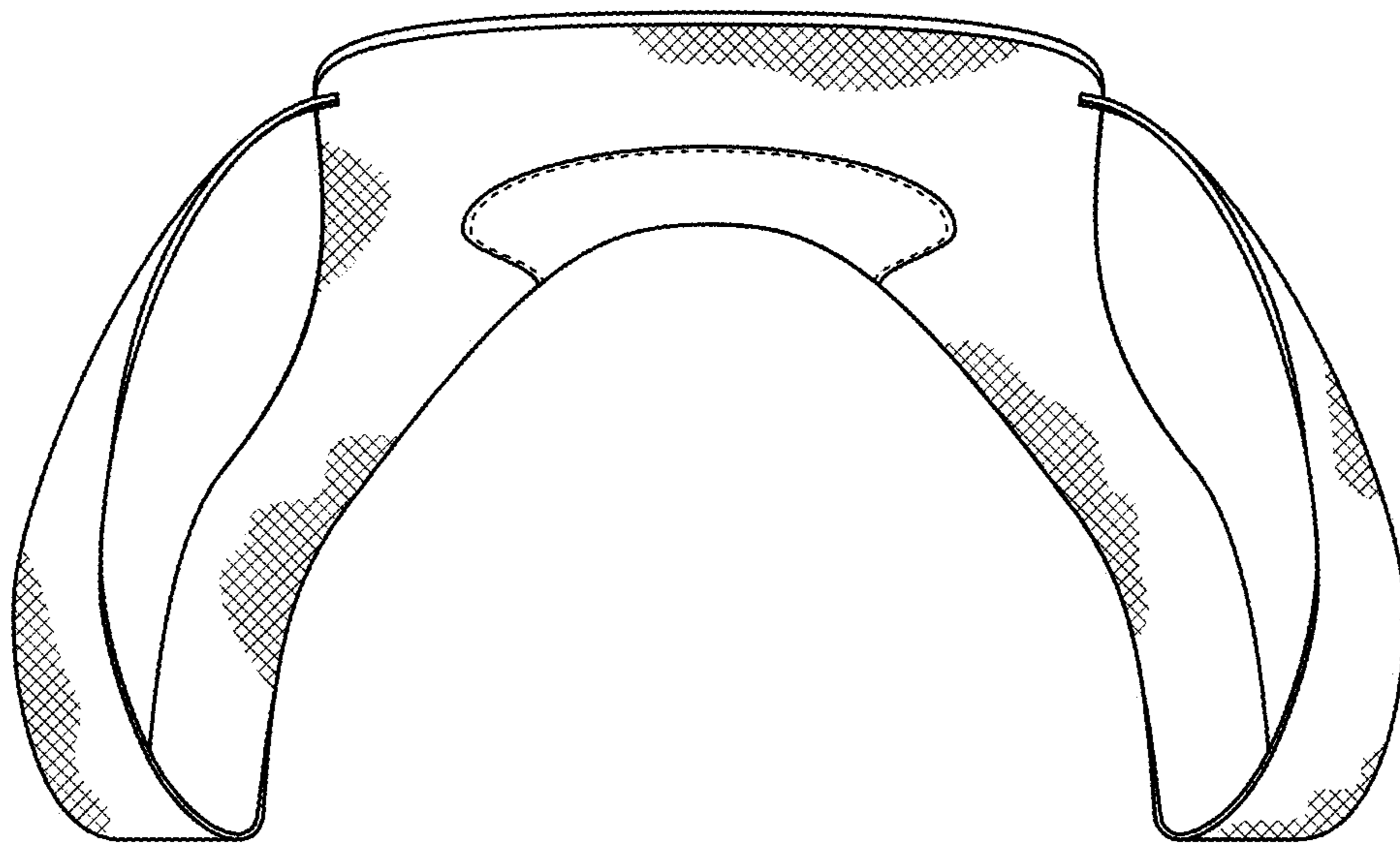
