(57) **CLAIM**

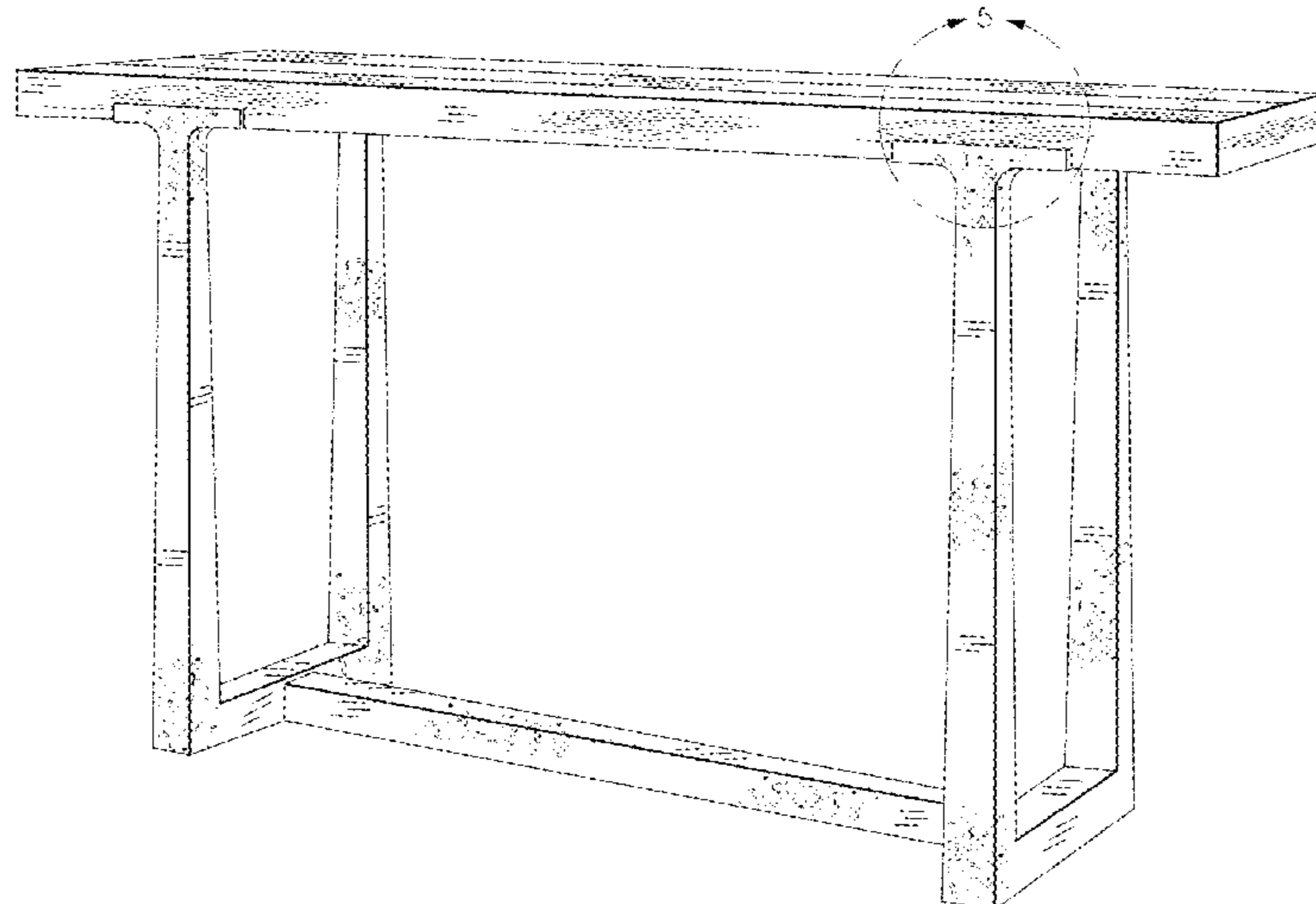
The ornamental design for a console, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a console showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevation view thereof, the rear being a mirror image; FIG. 4 is a right side elevation view thereof, the sides being mirror images of one another; FIG. 5 is an enlarged fragment of a portion of the console shown in in FIG. 1 and labelled 5; FIG. 6 is a perspective view of a second embodiment of a console showing our new design; FIG. 7 is a top plan view thereof; FIG. 8 is a front elevation view thereof, the rear being a mirror image; FIG. 9 is a right side elevation view thereof, the sides being mirror images of one another; and, FIG. 10 is an enlarged fragment of a portion of the console shown in FIG. 6 and labelled 10.

The fragmentary showing of wood grain in FIGS. 1-4 and 6-9 and shown in detail in FIGS. 5 and 10 is understood to be repeated throughout the surfaces shown. The fragmentary showing of the surface pattern on the legs and base of the console shows a contrasting appearance from the wood grain on the table top and is understood to be repeated throughout the surfaces shown. The second embodiment is shown with a symbolic break in length in FIGS. 6-8, and those portions of the article between the break lines form no part of the claimed design.

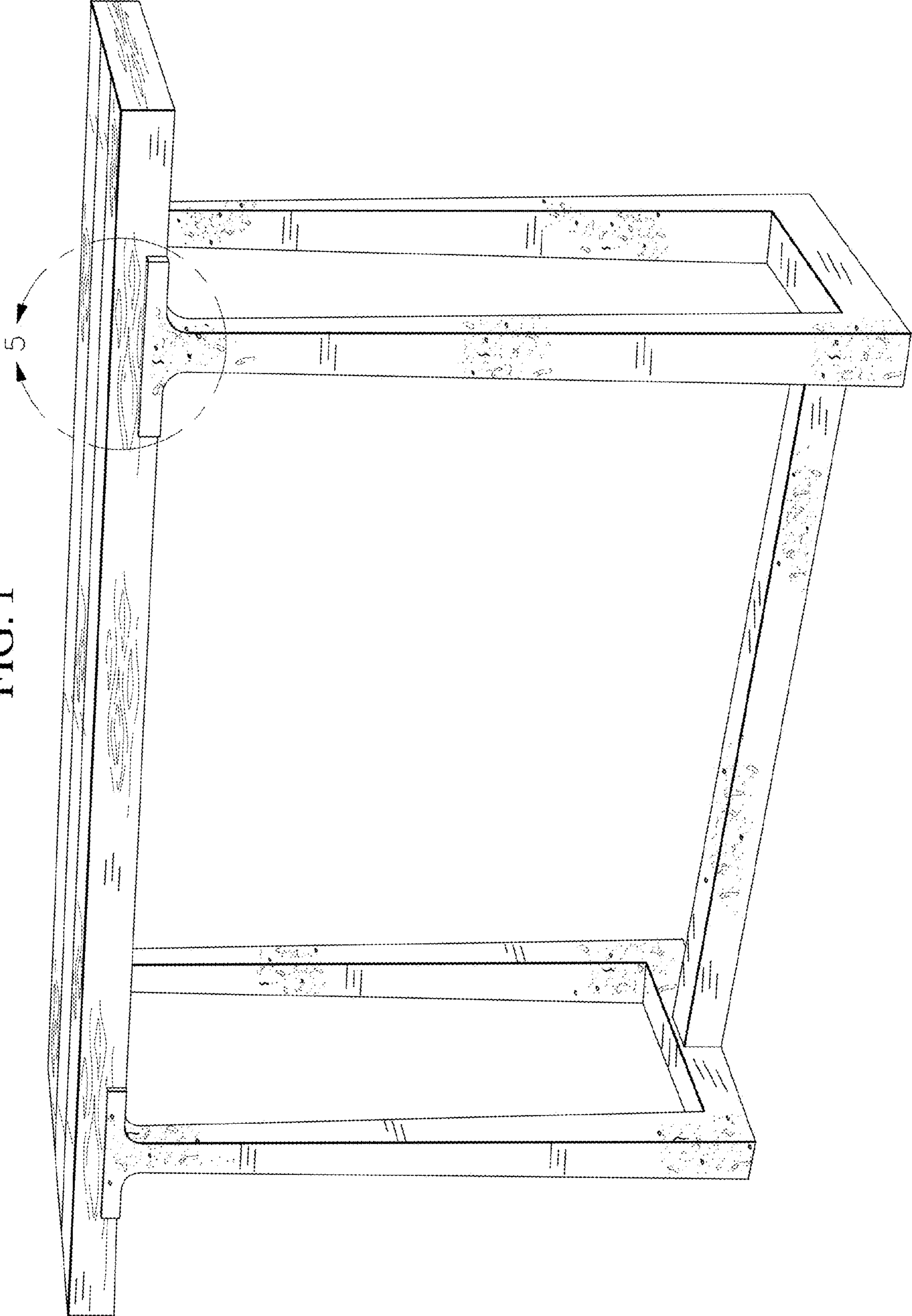

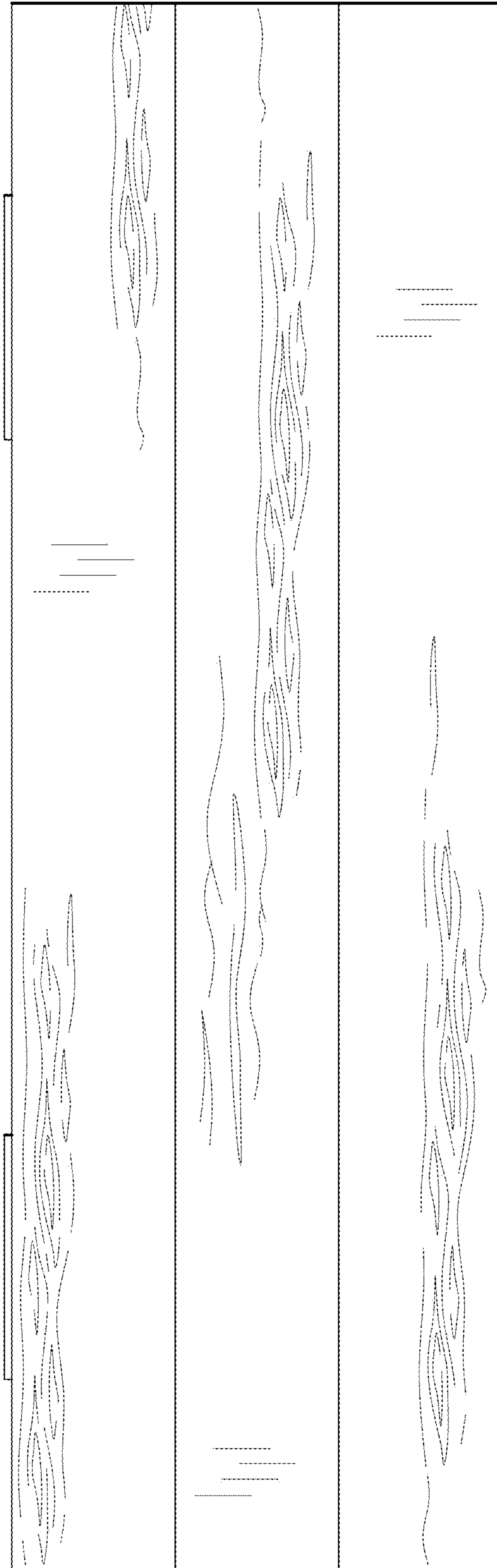

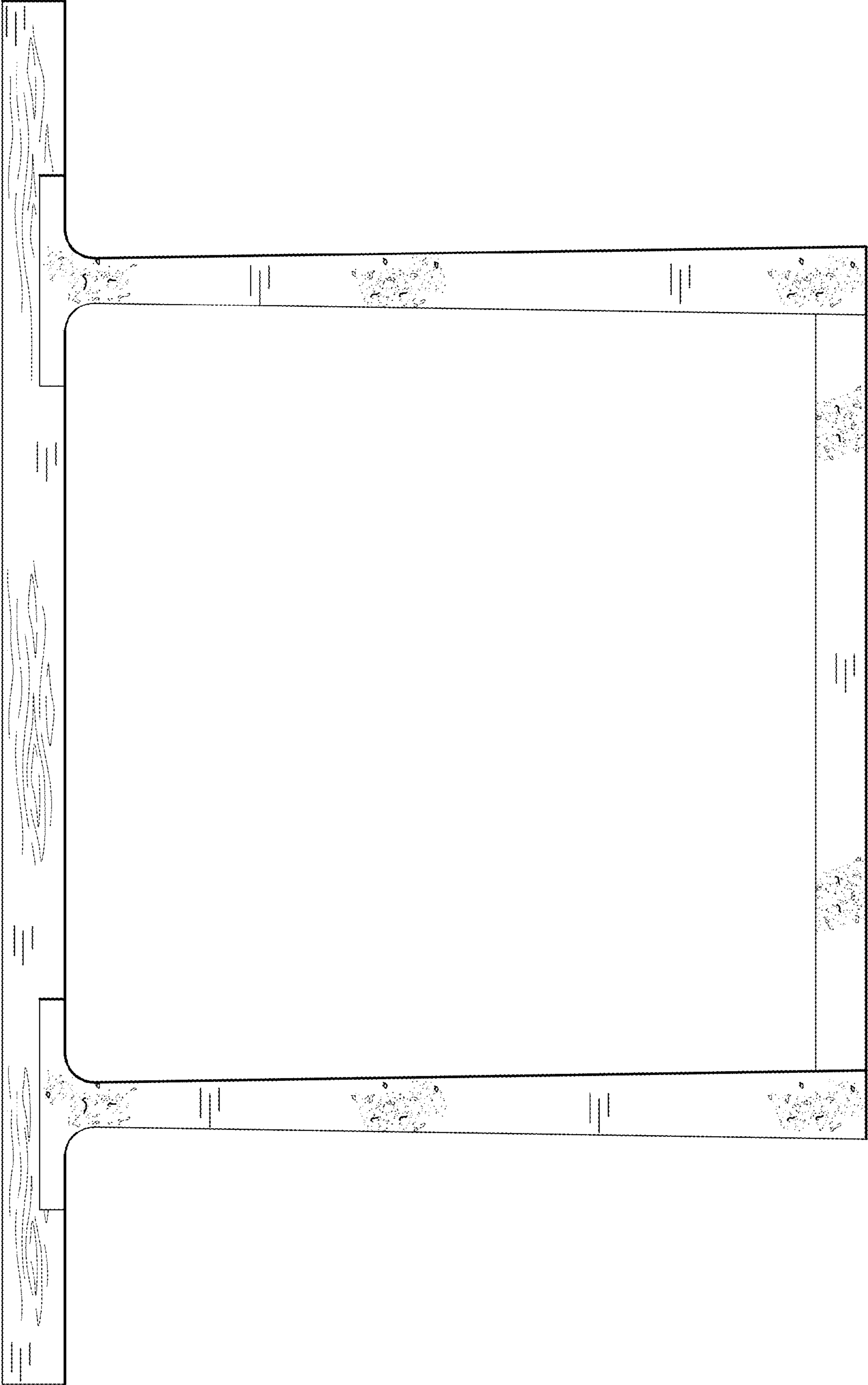
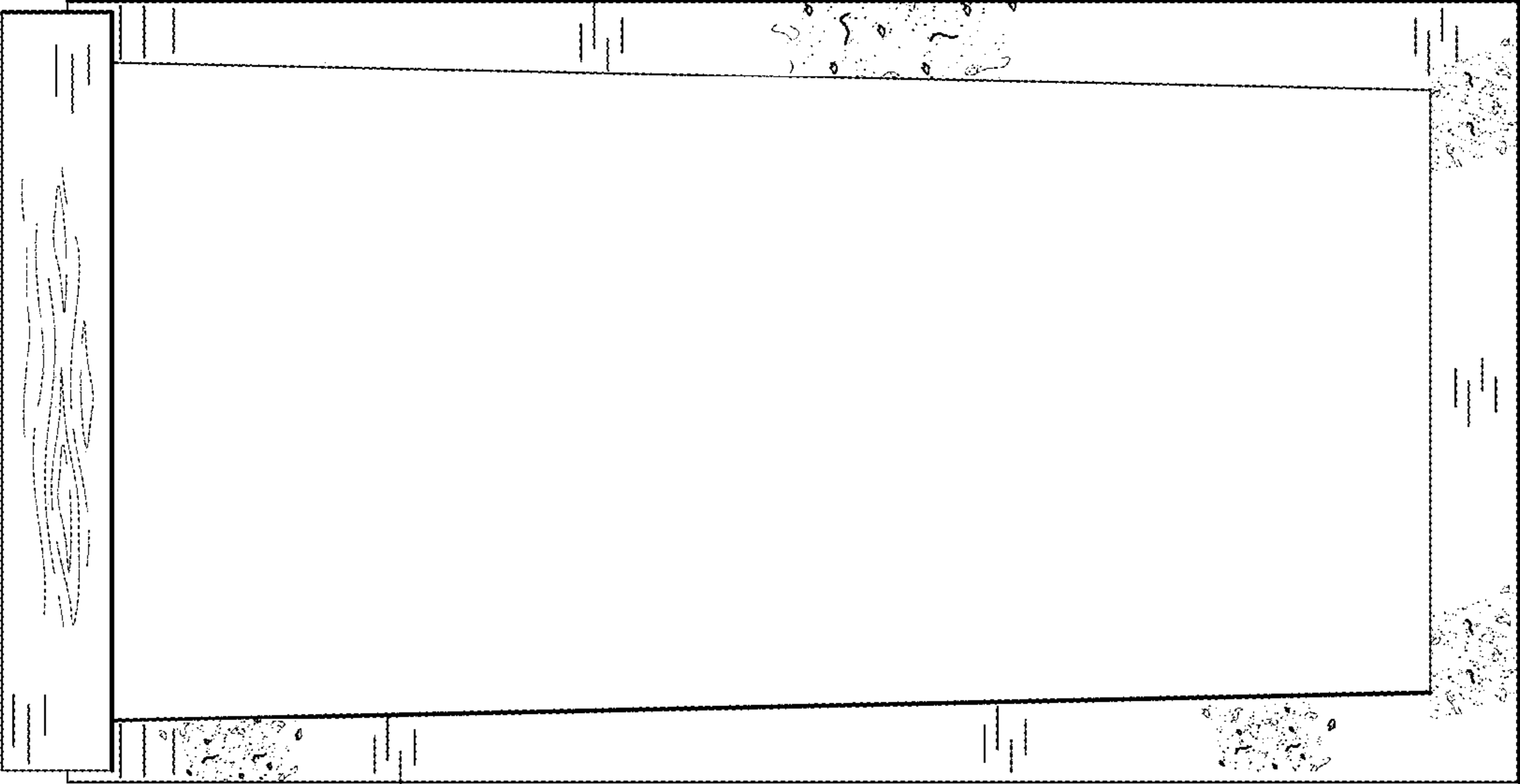

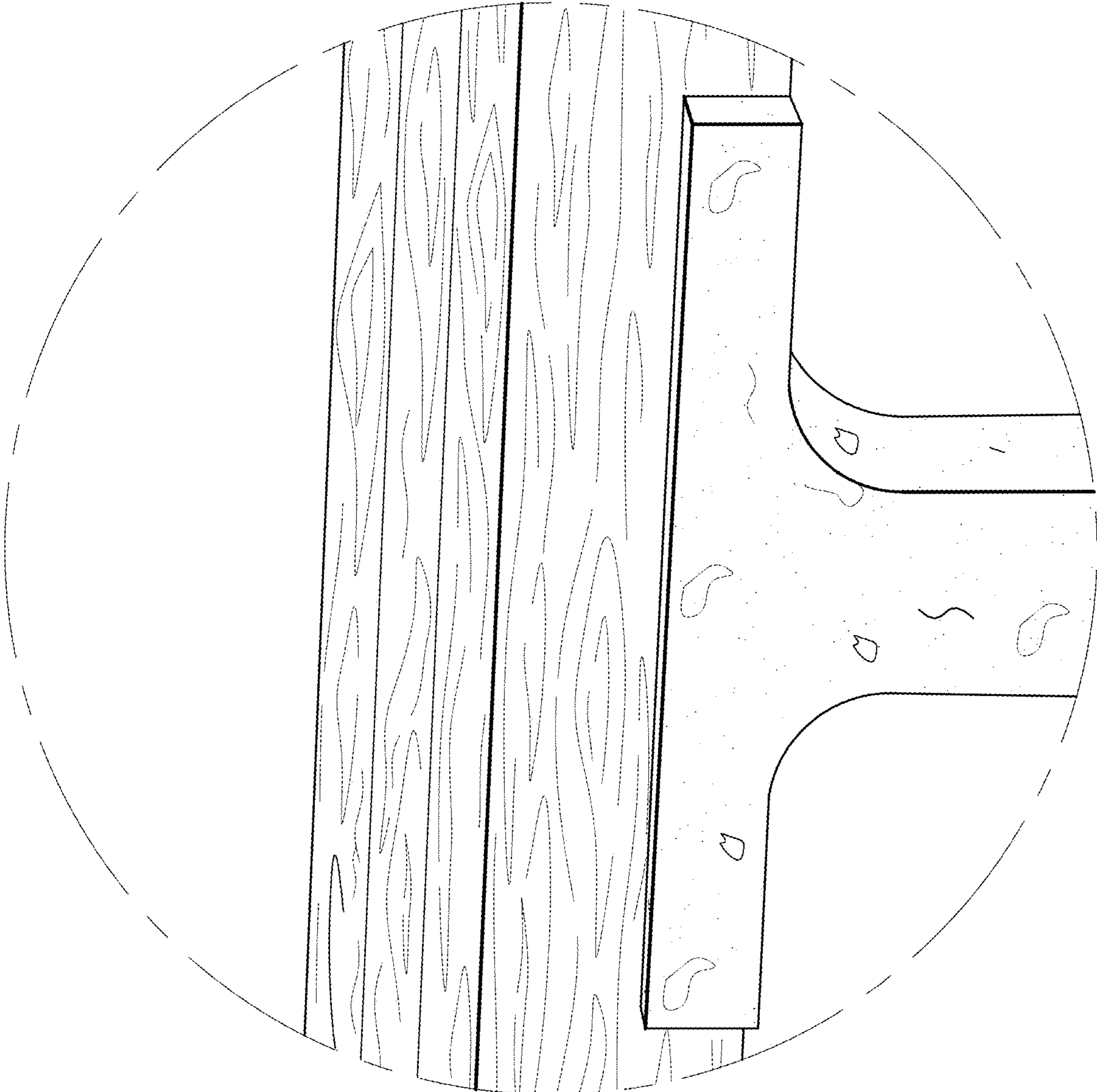

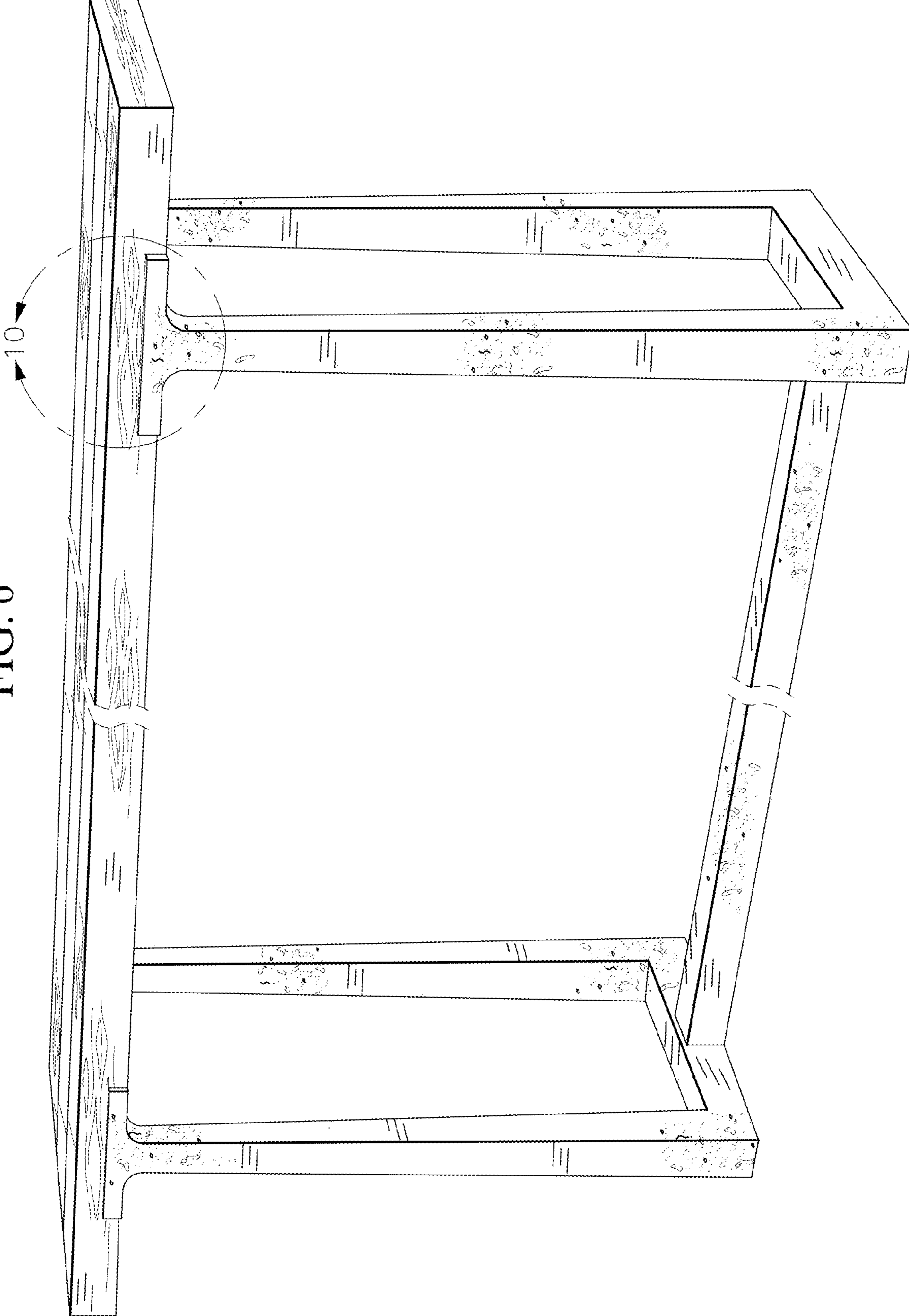

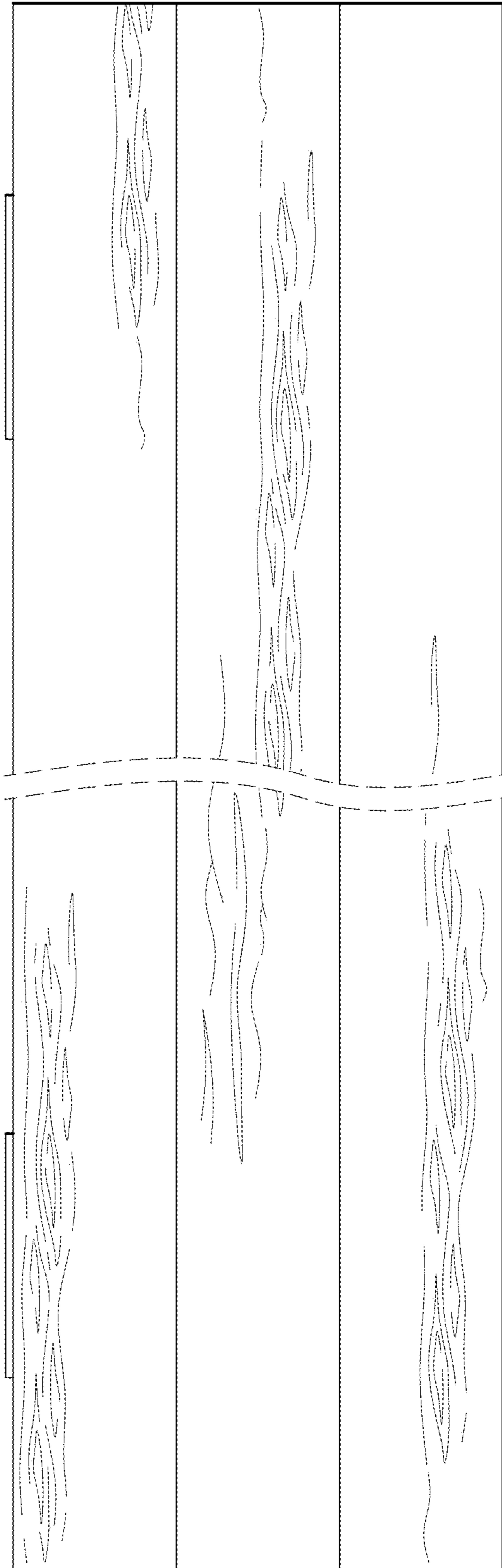

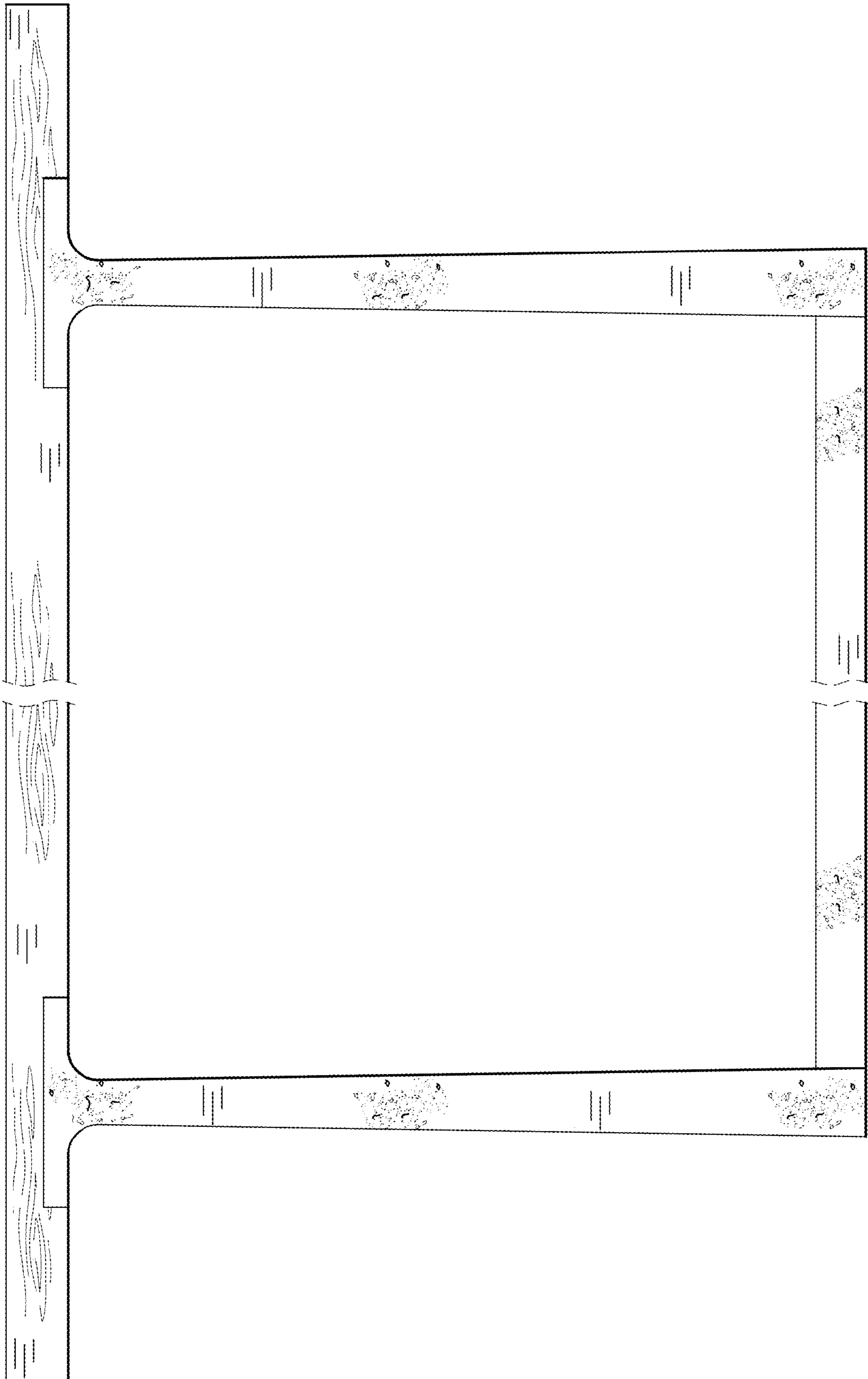
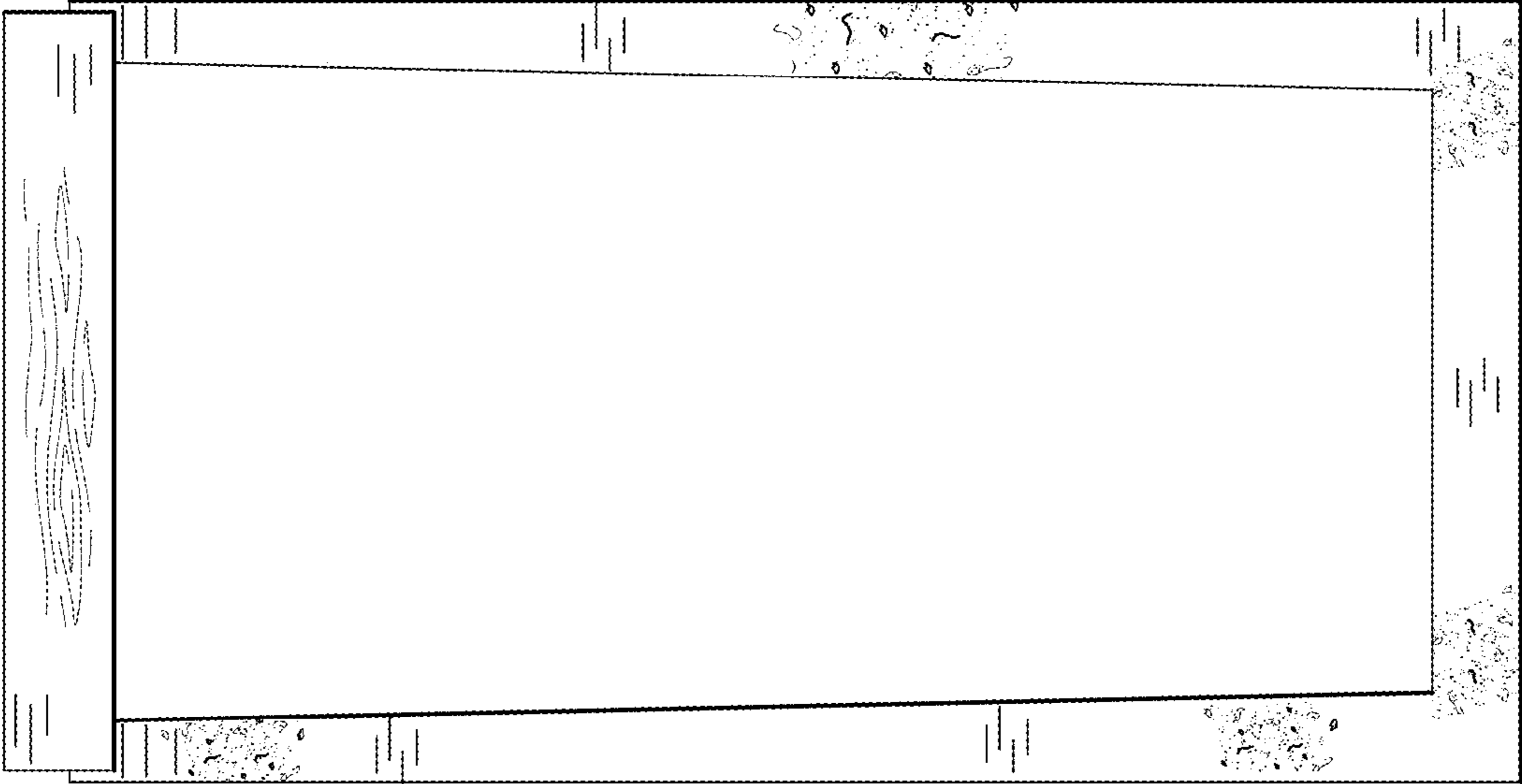

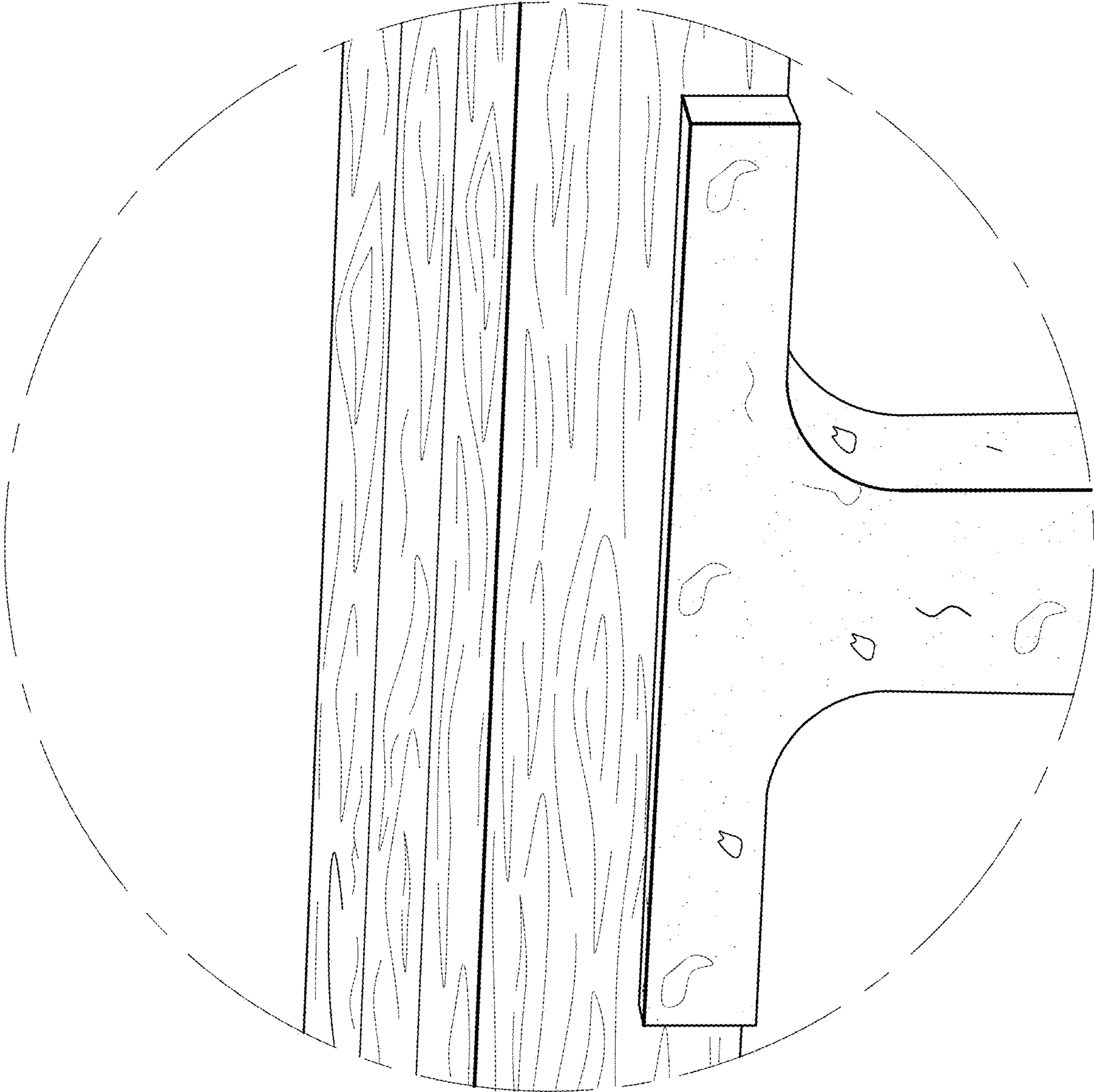
