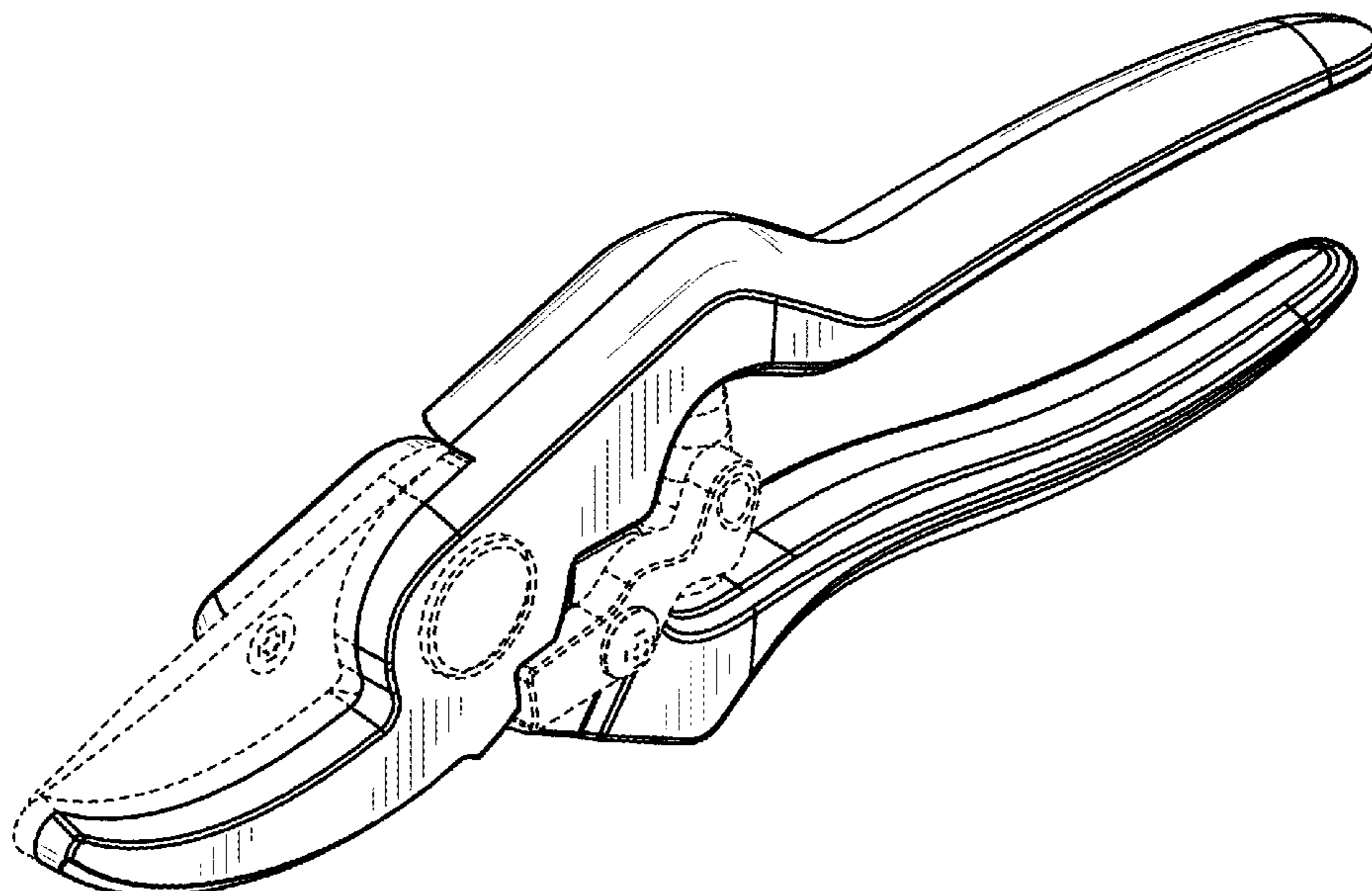
(57) **CLAIM**

The ornamental design for a pruner, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of our pruner according to our new design;
FIG. 2 is a left, side view thereof;
FIG. 3 is a right, side view thereof;
FIG. 4 is a bottom-left rear perspective view thereof;
FIG. 5 is a bottom-left front perspective view thereof;
FIG. 6 is a top-left rear perspective view thereof;
FIG. 7 is a top-left front perspective view thereof;
FIG. 8 is a front view thereof;
FIG. 9 is a bottom plan view thereof; and,
FIG. 10 is a rear view thereof.
The broken lines in the drawings illustrate portions of the pruner and form no part of the claimed design.
Conventional shading is illustrated for purposes of highlighting the line drawings, but forms no part of the claimed design.

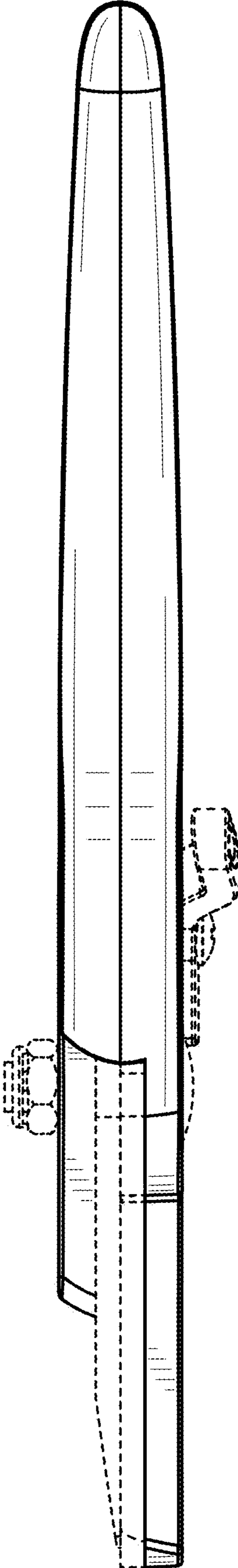

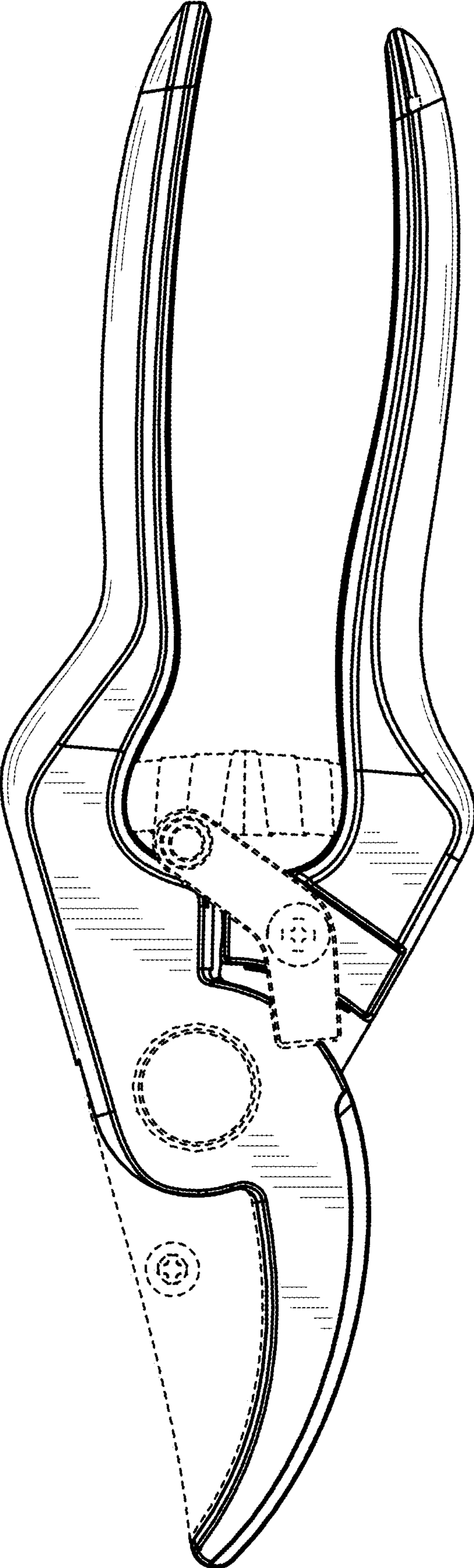

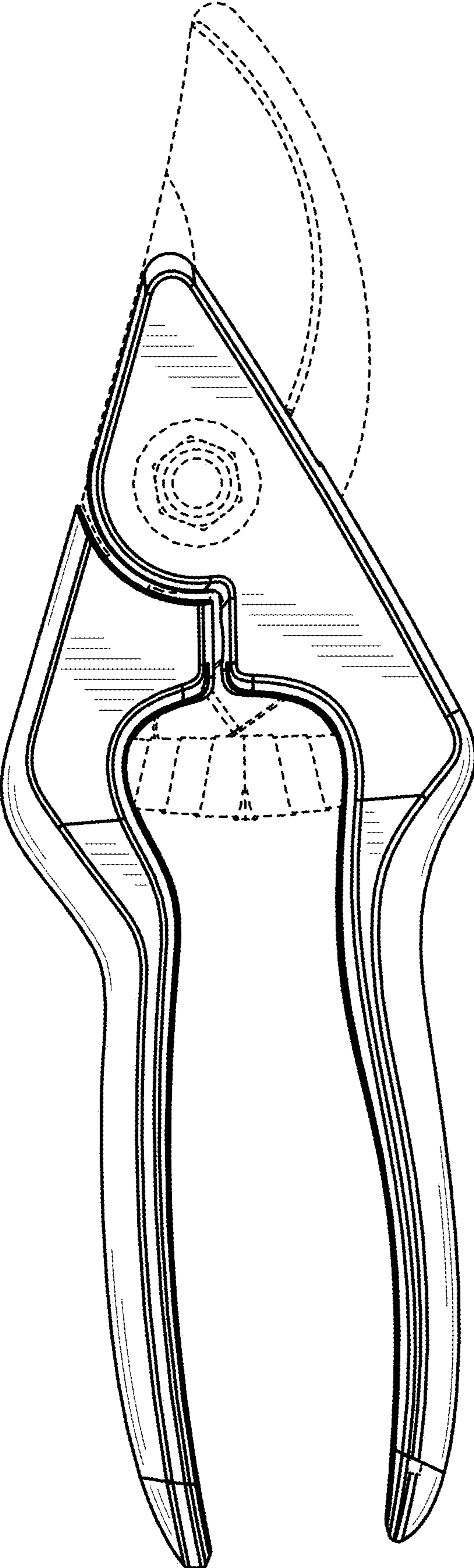

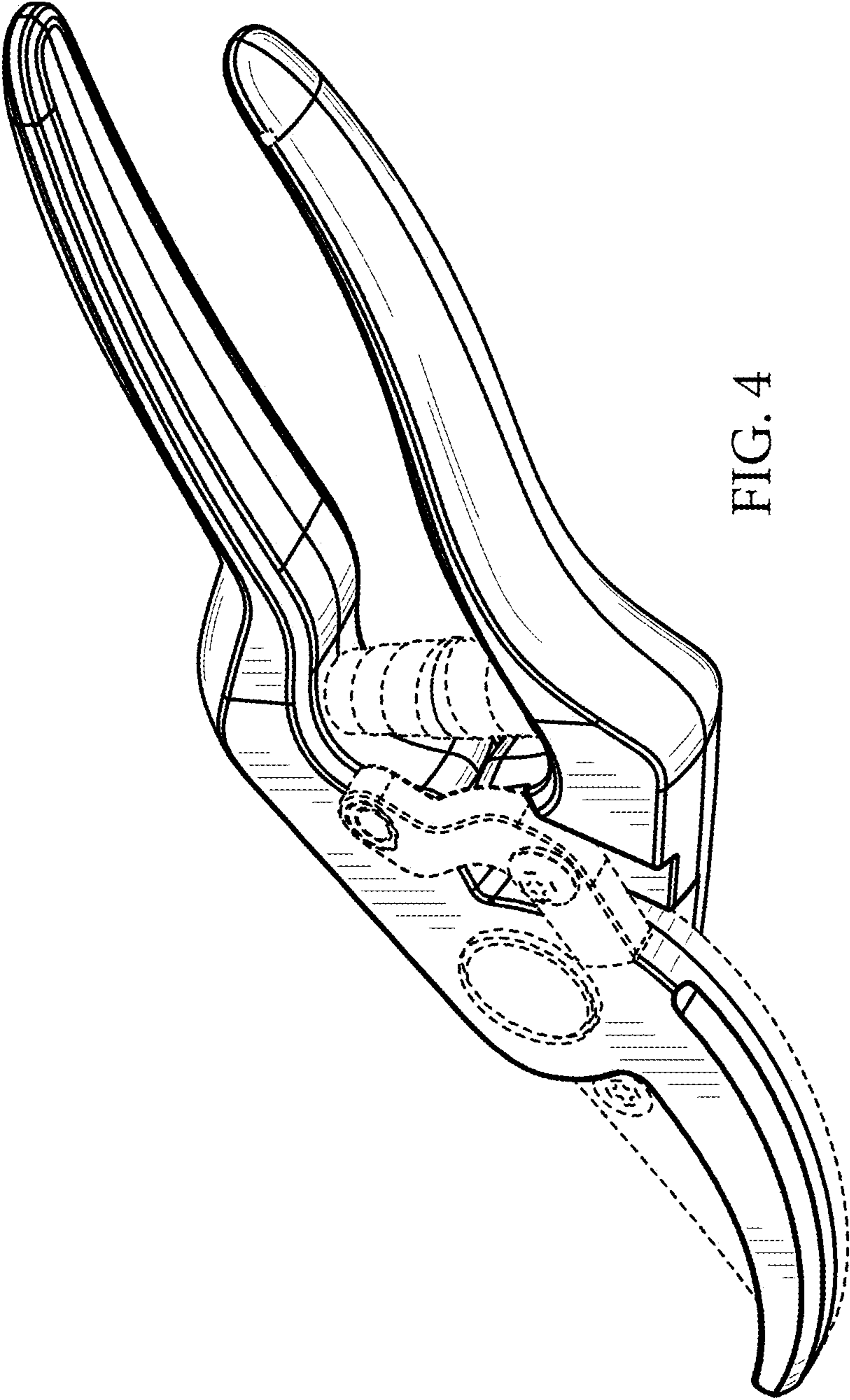

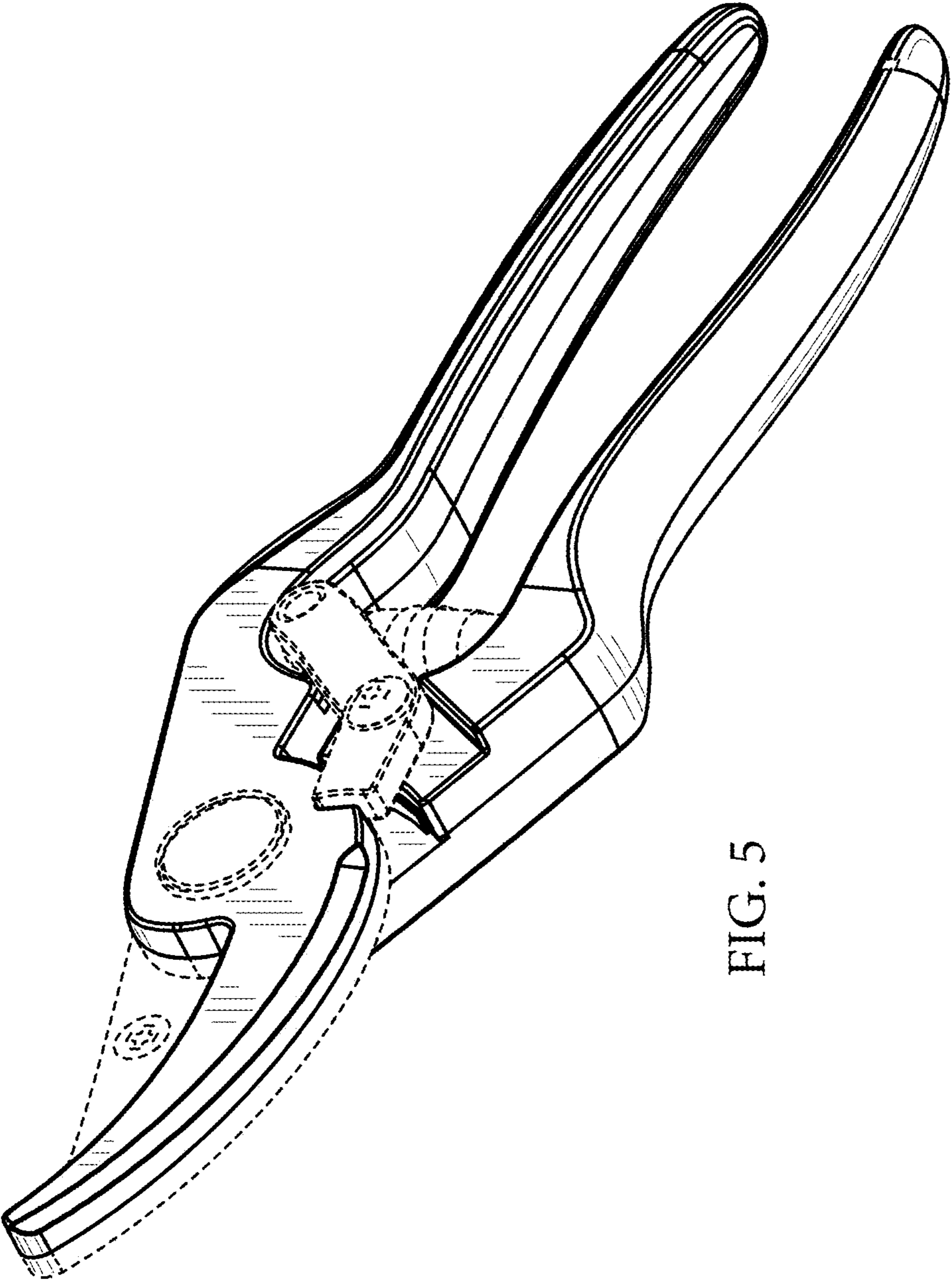

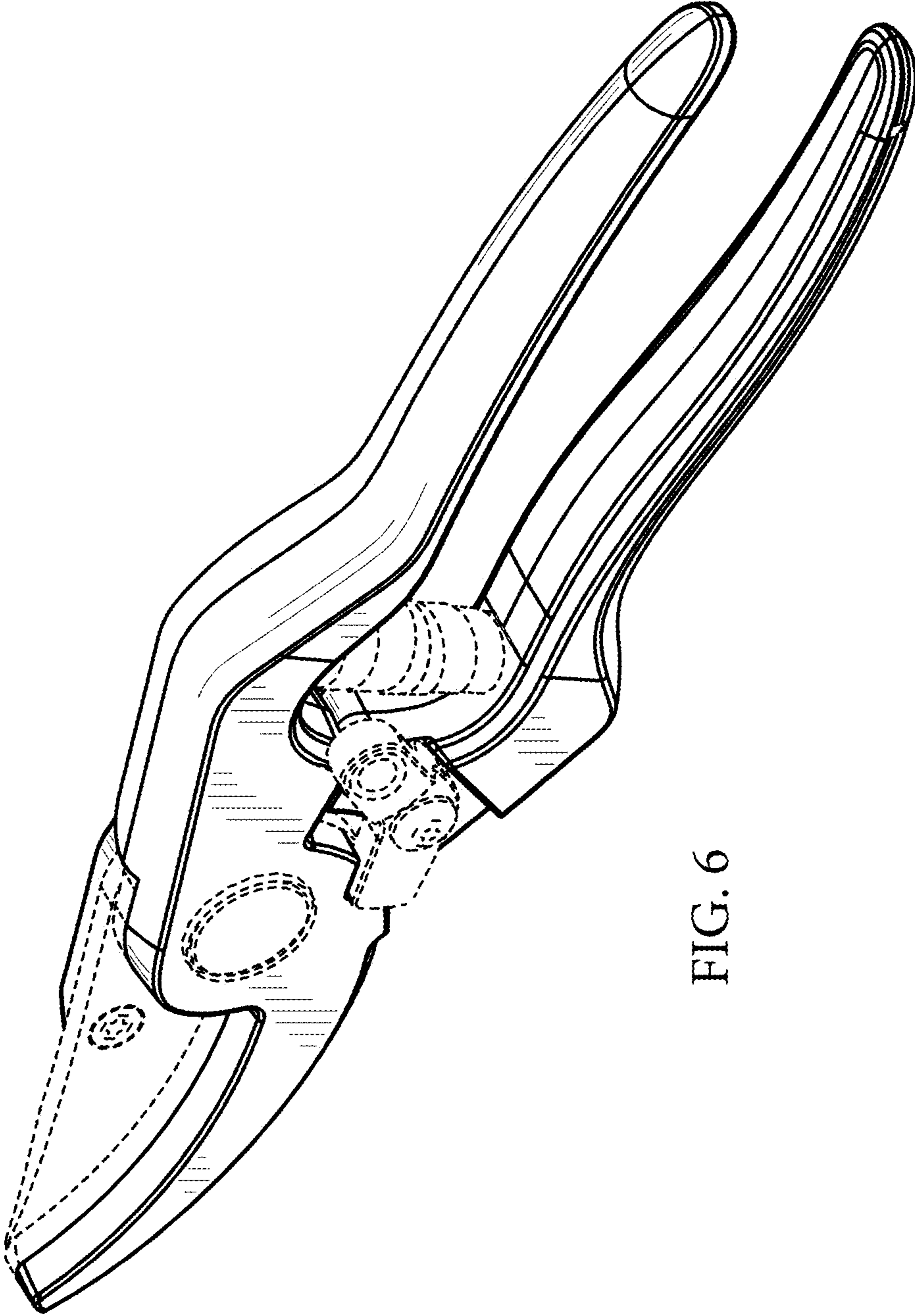

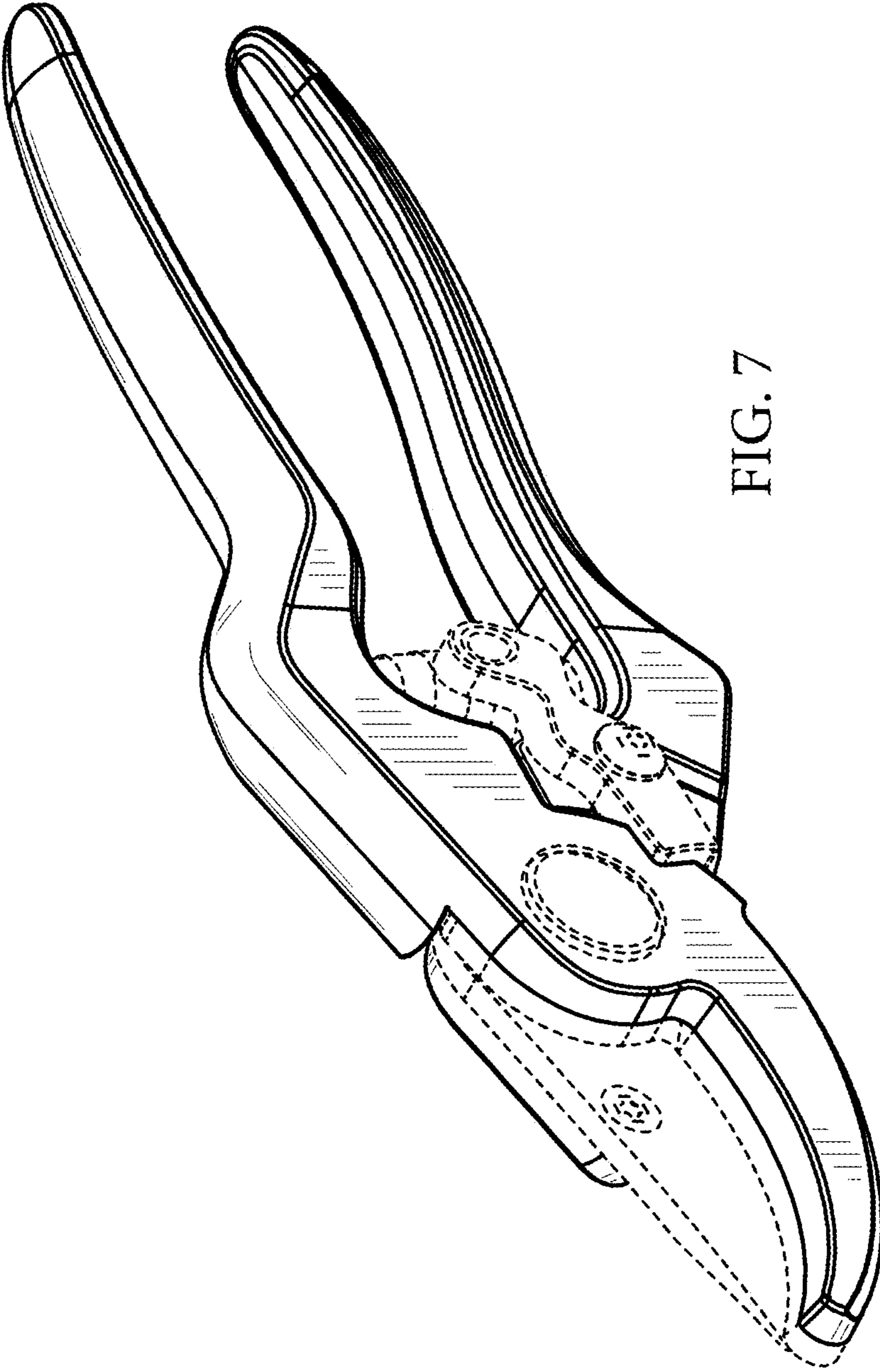

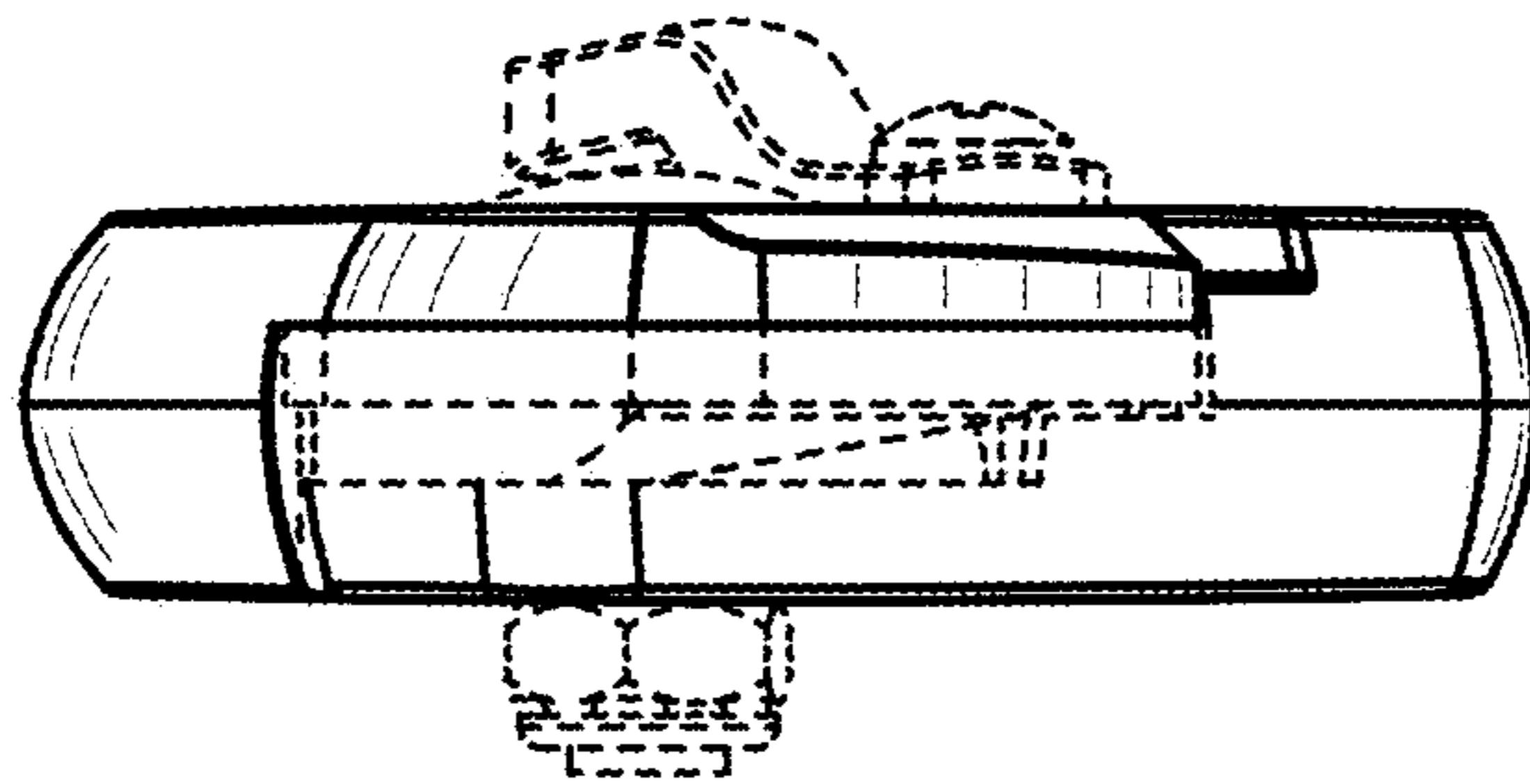

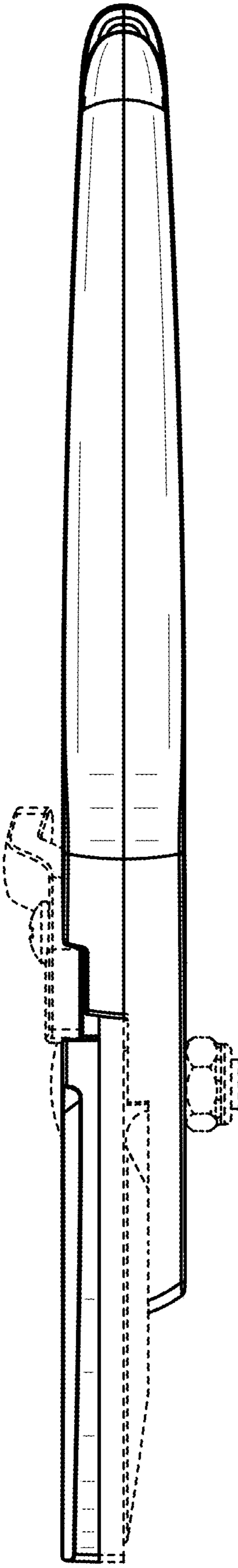

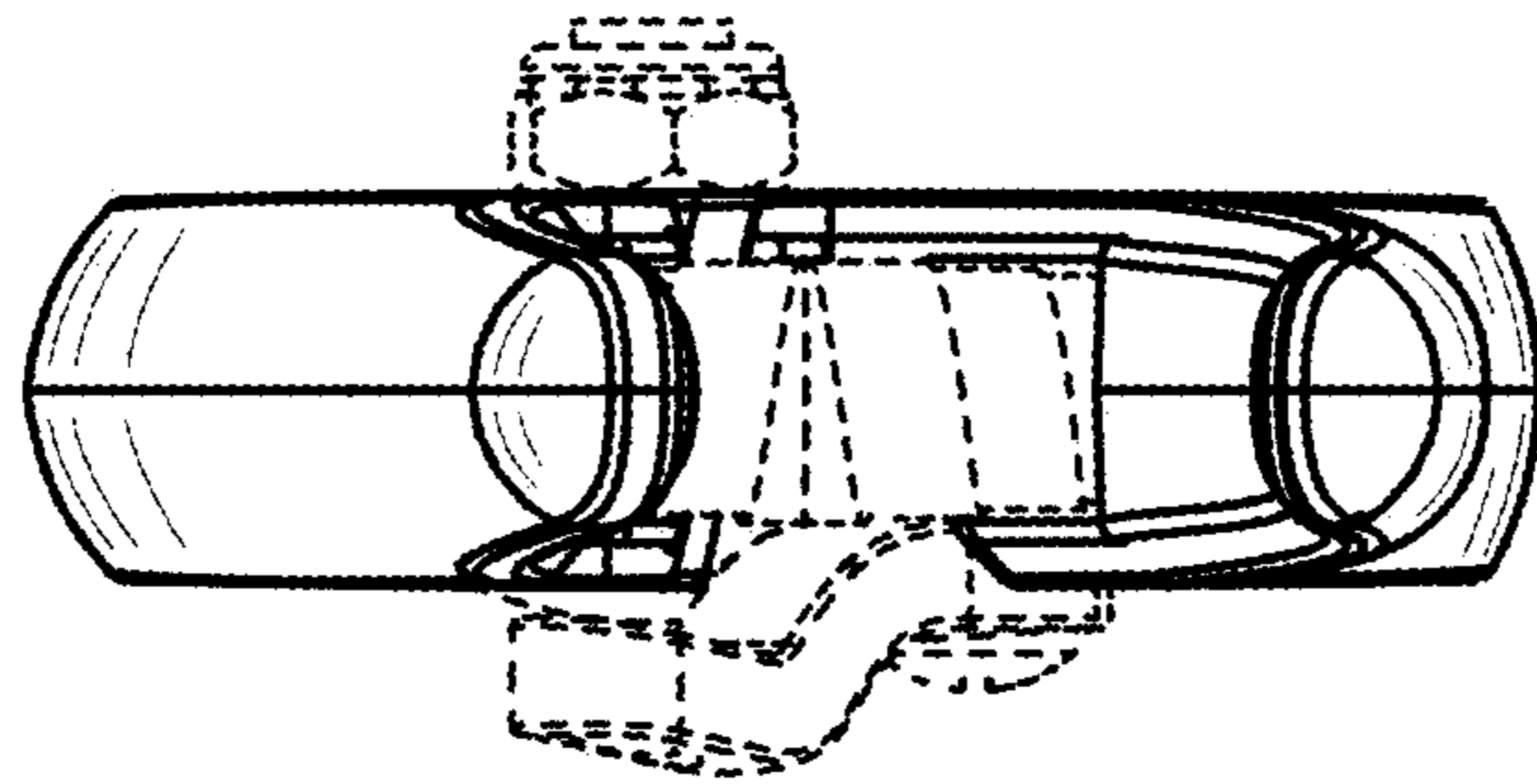
