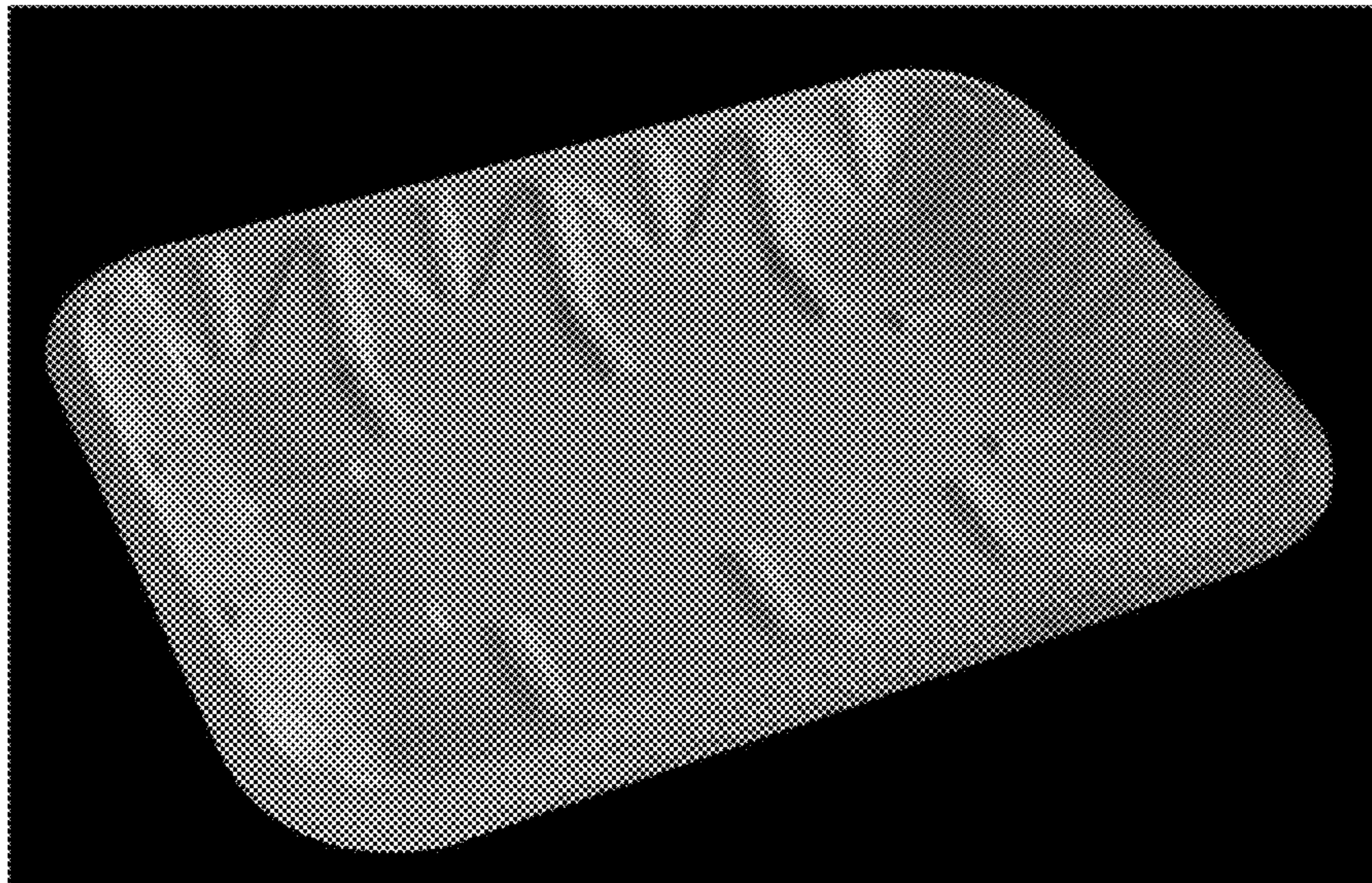

The ornamental design for a food containing plate, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view showing a food containing plate according to my new design;
FIG. 2 is a front elevational view thereof, the opposite side being a mirror image;
FIG. 3 is a side elevational view thereof, the opposite side being a mirror image; and,
FIG. 4 is a top plan view thereof.
For clarity, the food containing plate is shown within a black background environment that forms no part of the claimed design.

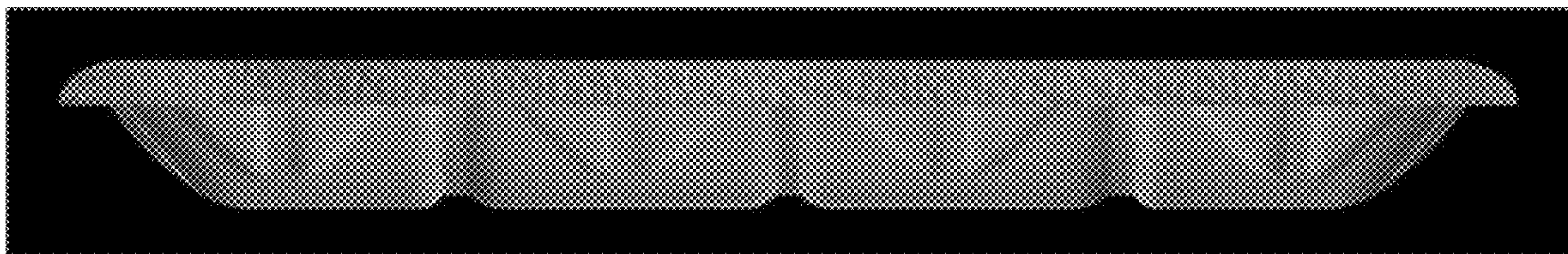

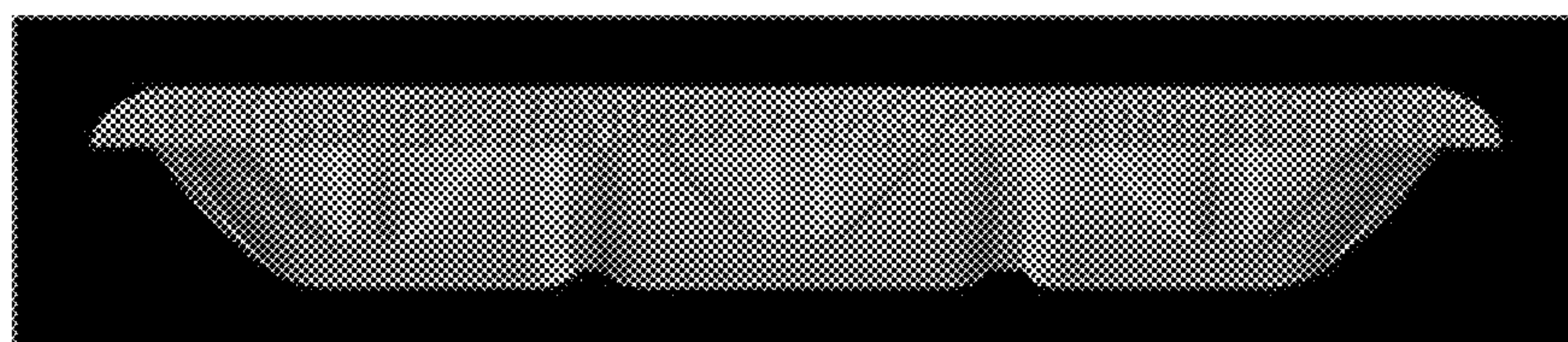
