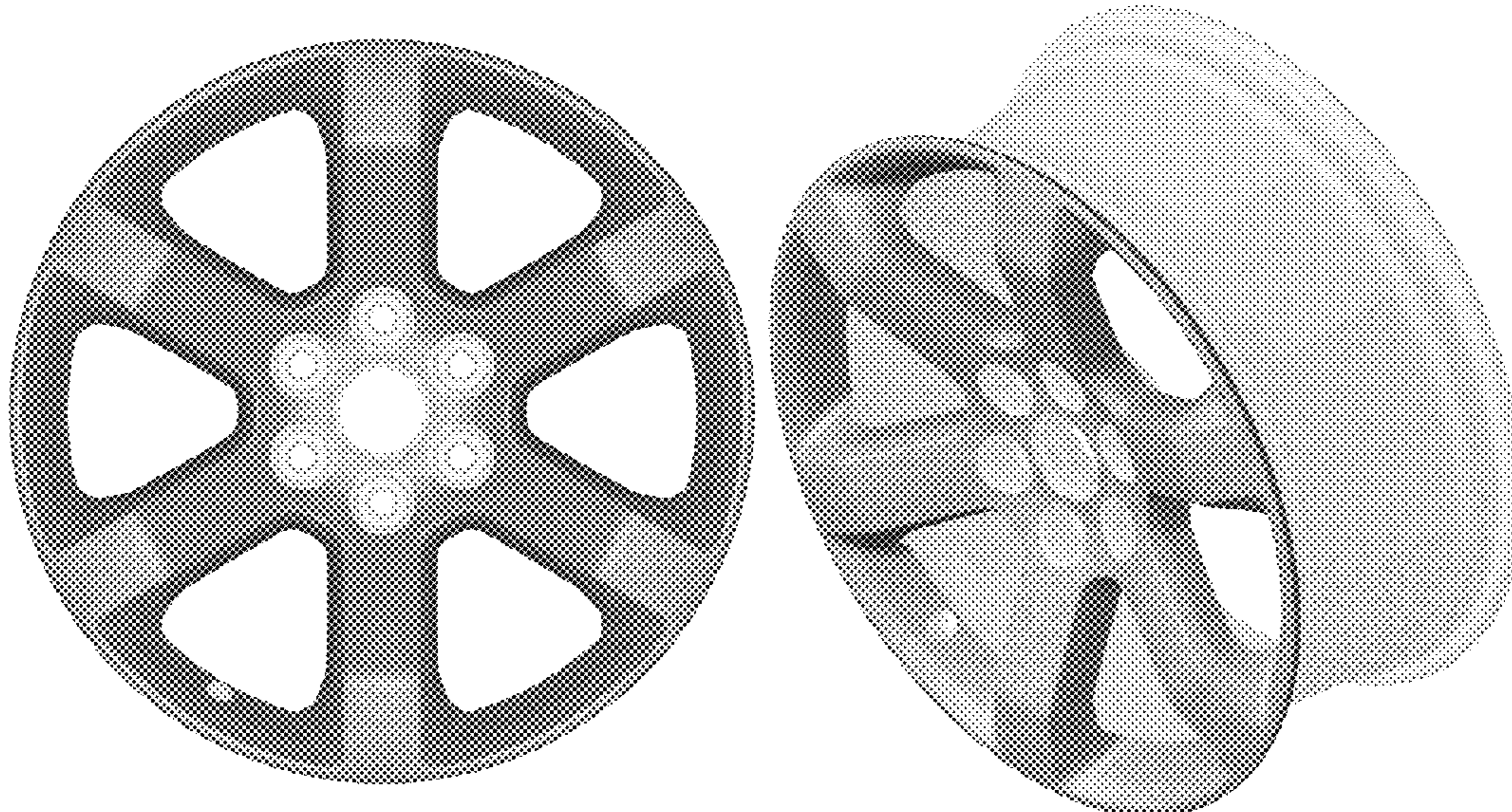
(57) **CLAIM**

The ornamental design for a vehicle wheel, as shown and described.

DESCRIPTION

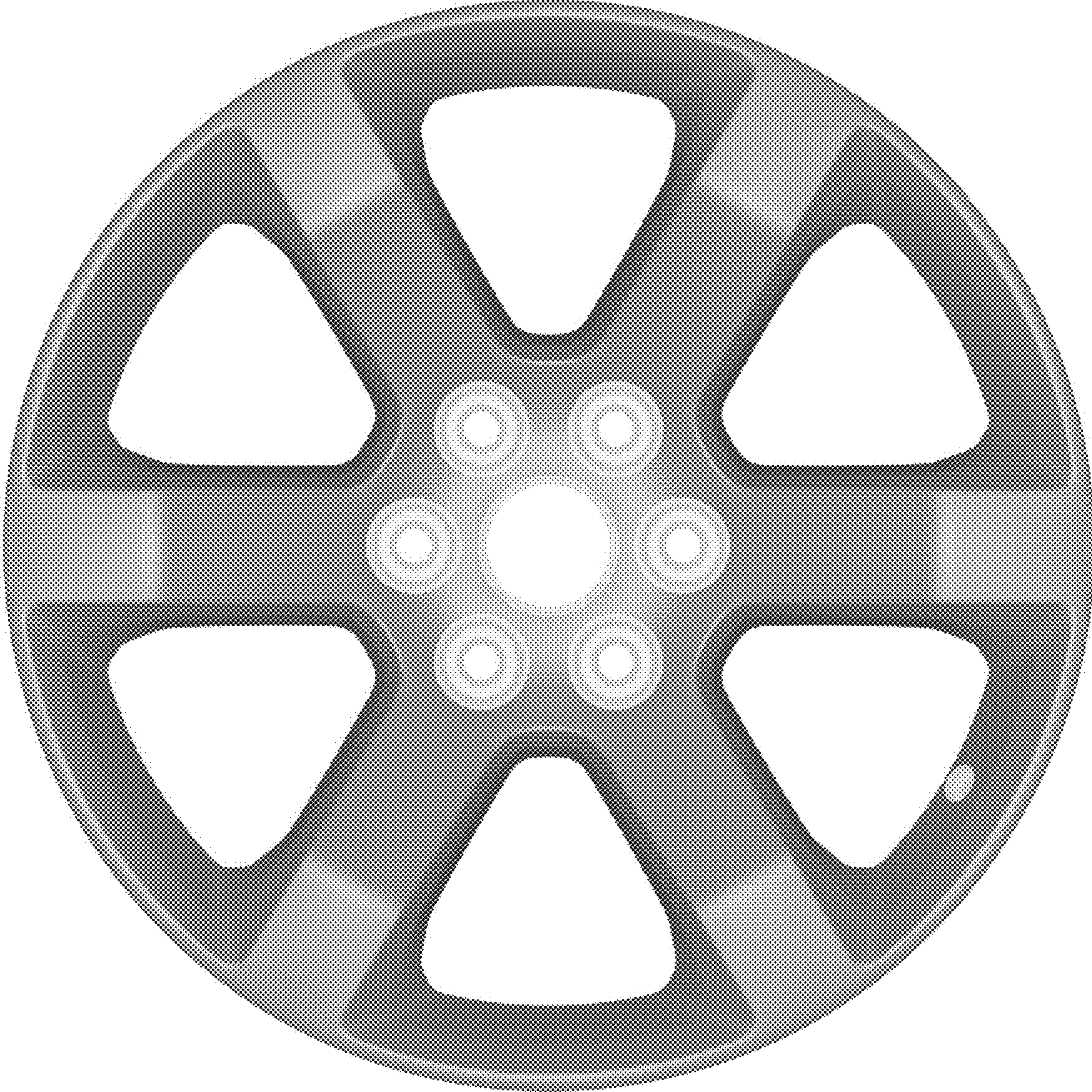

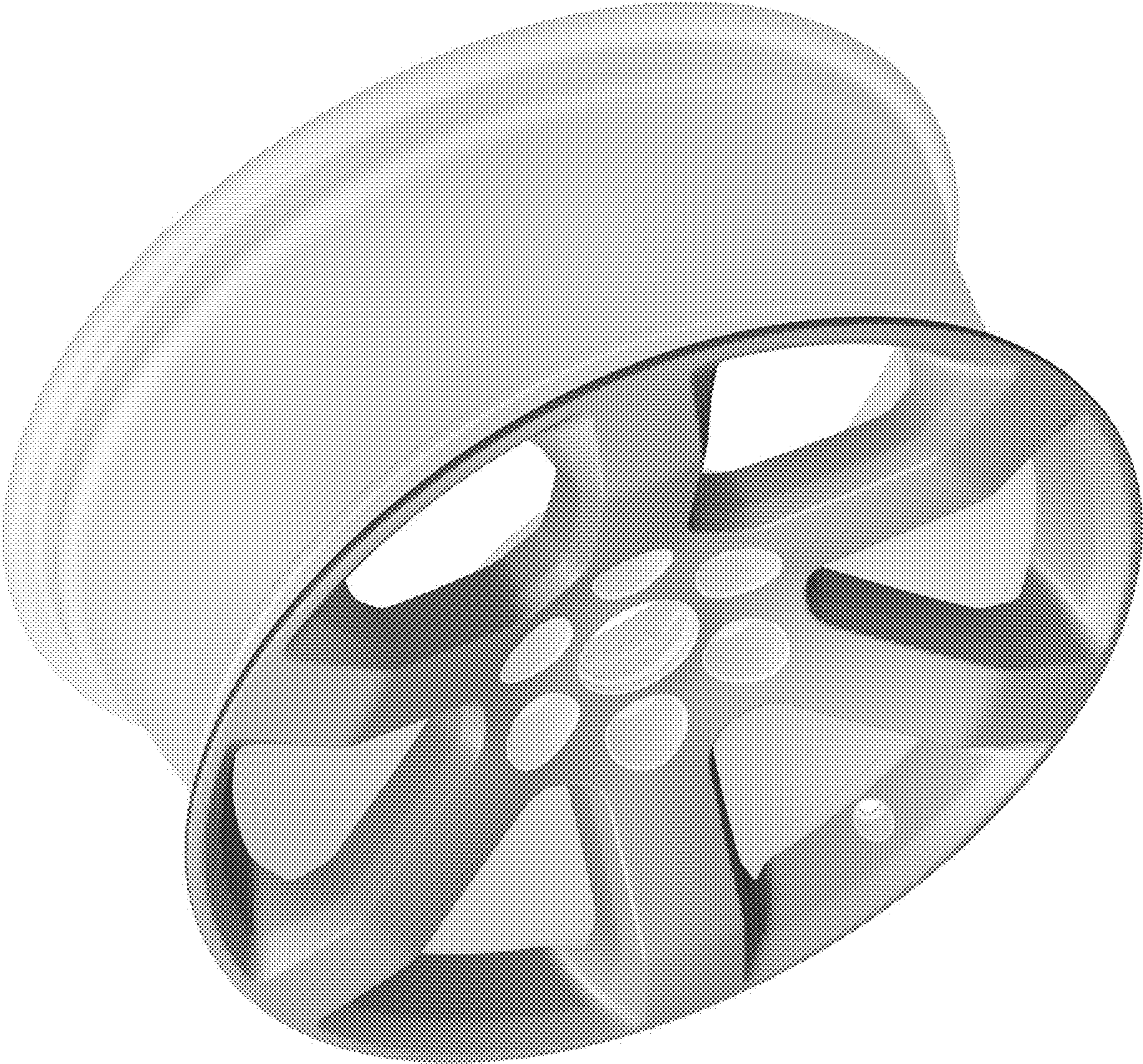
