DESCRIPTION

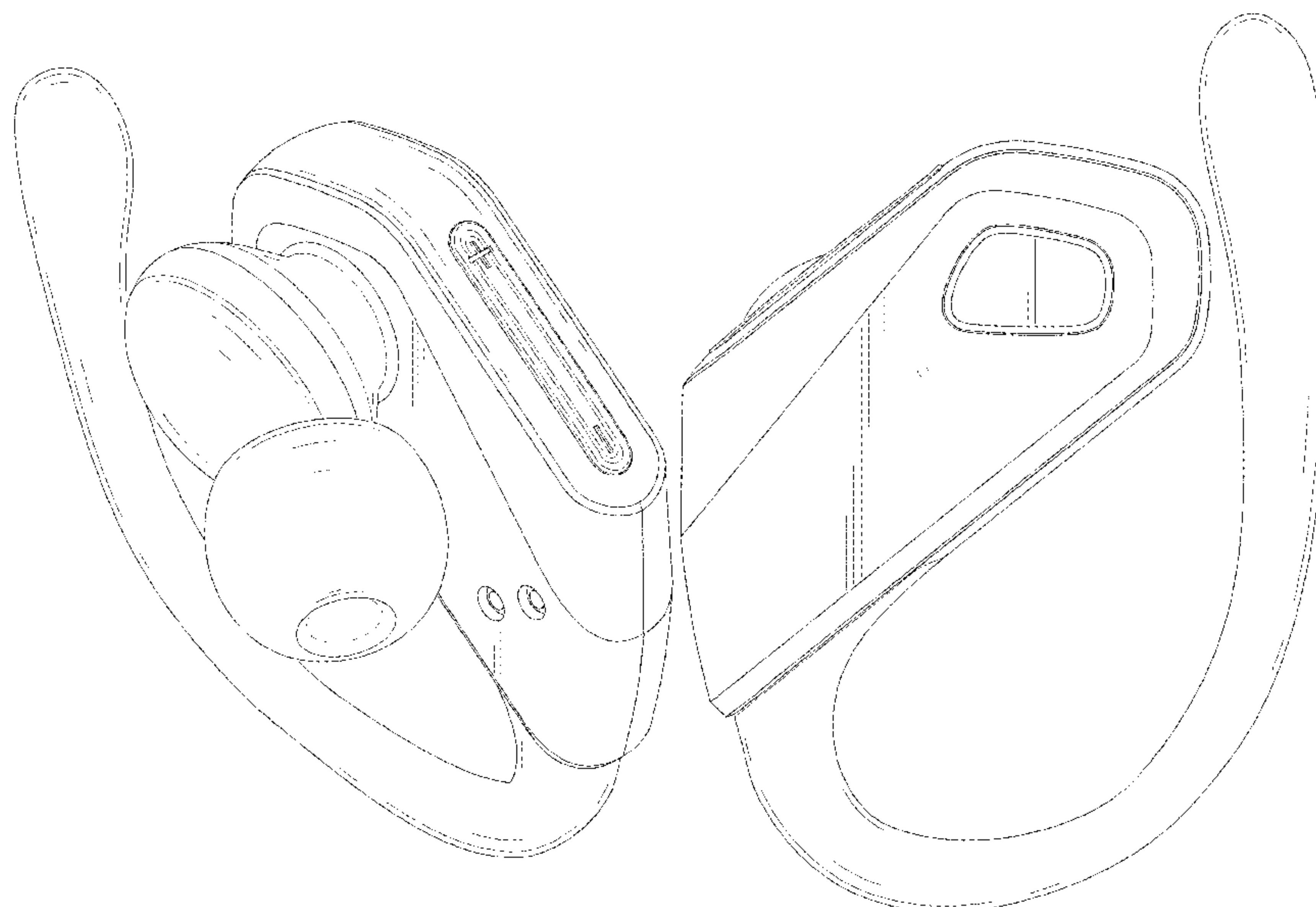
FIG. 1 is a perspective view of an earphone, showing my design.

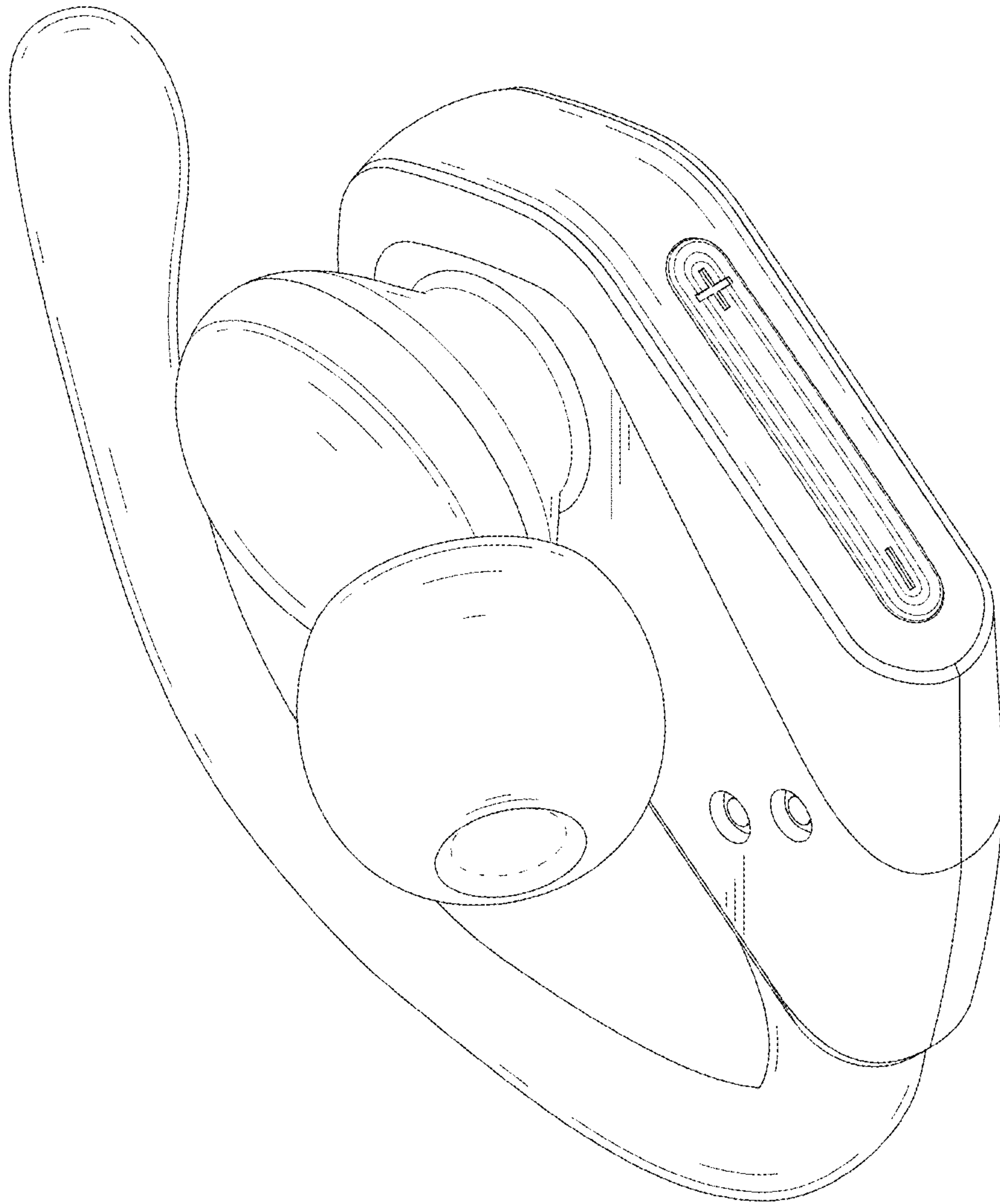

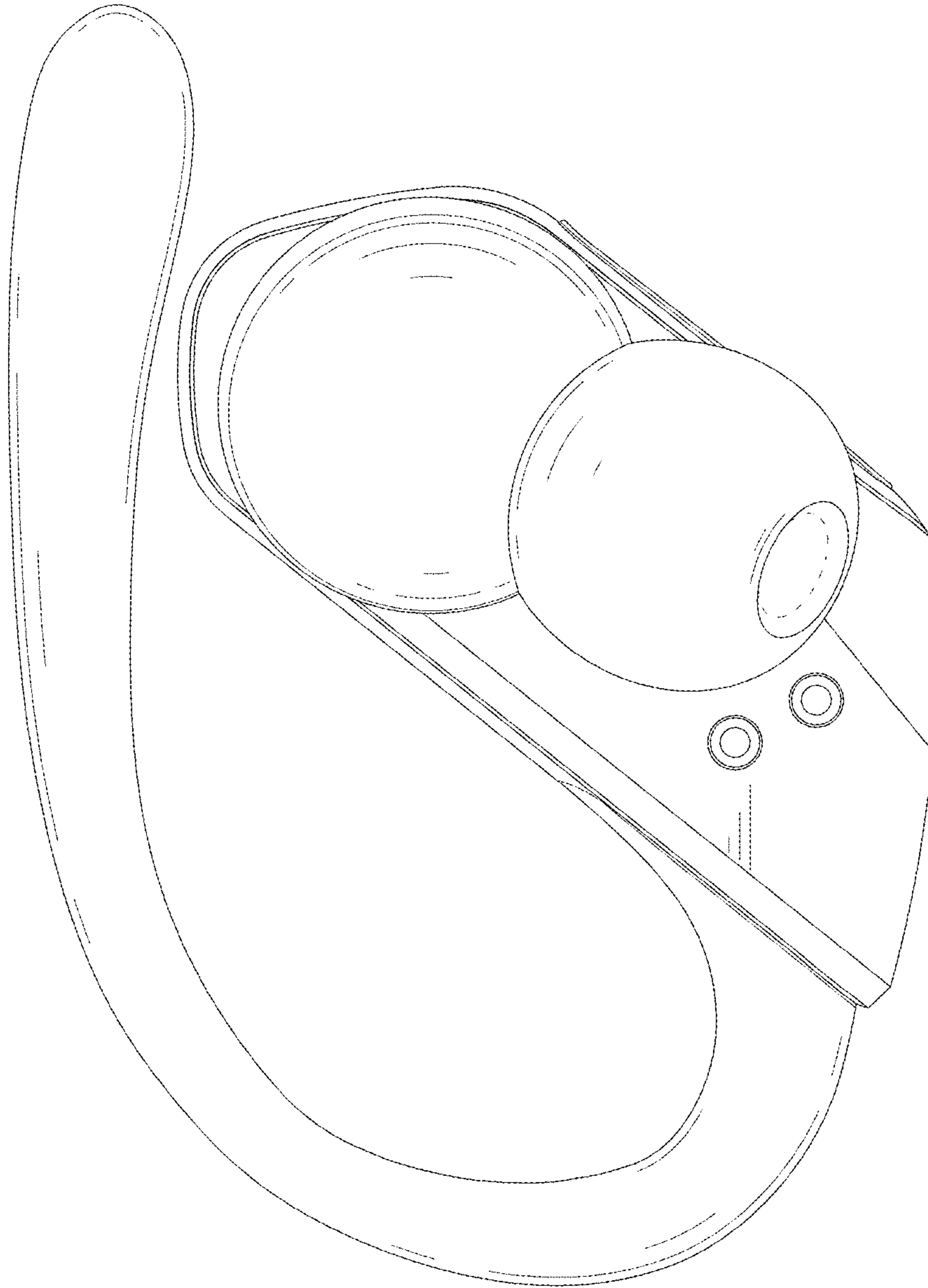

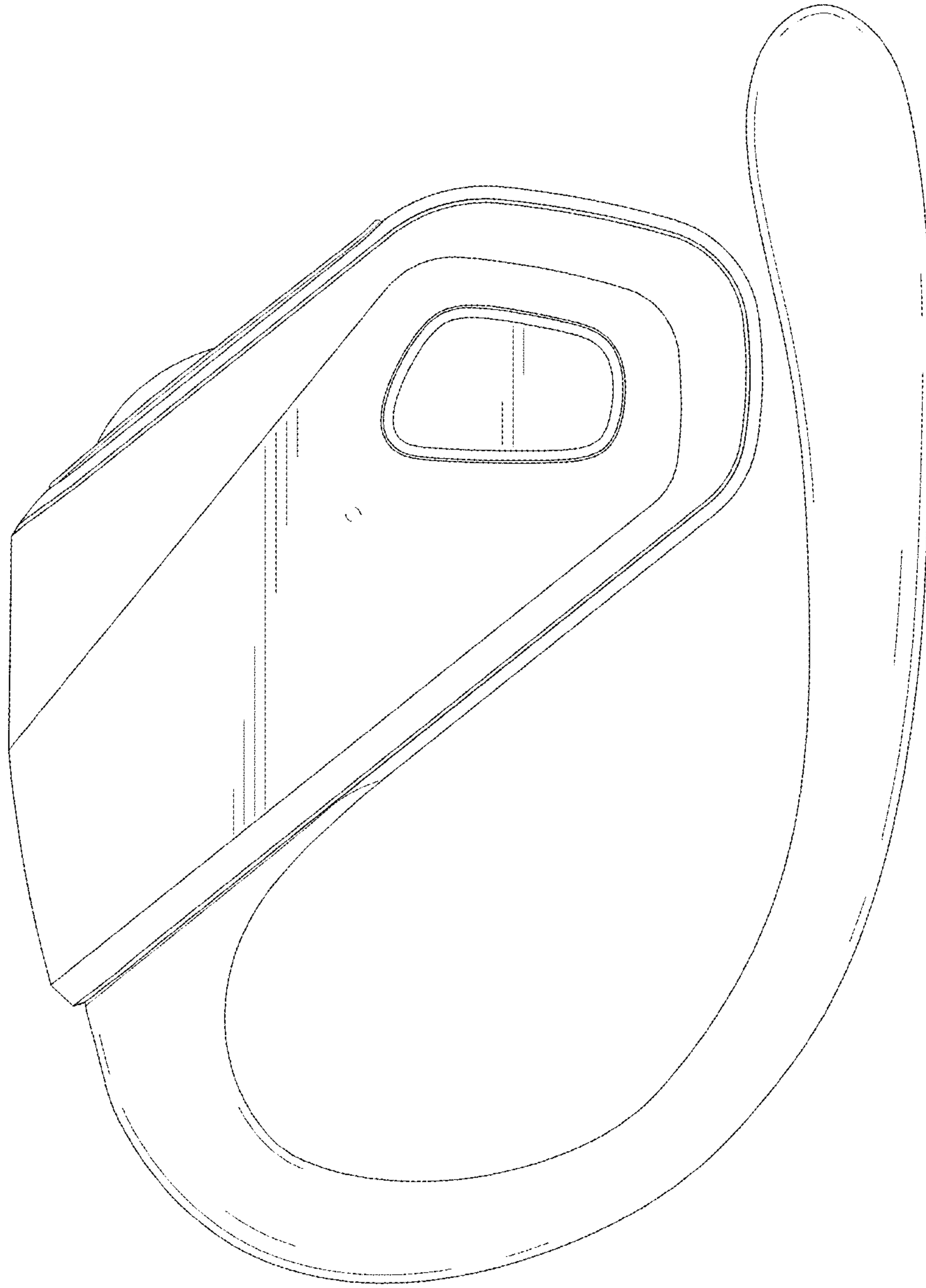

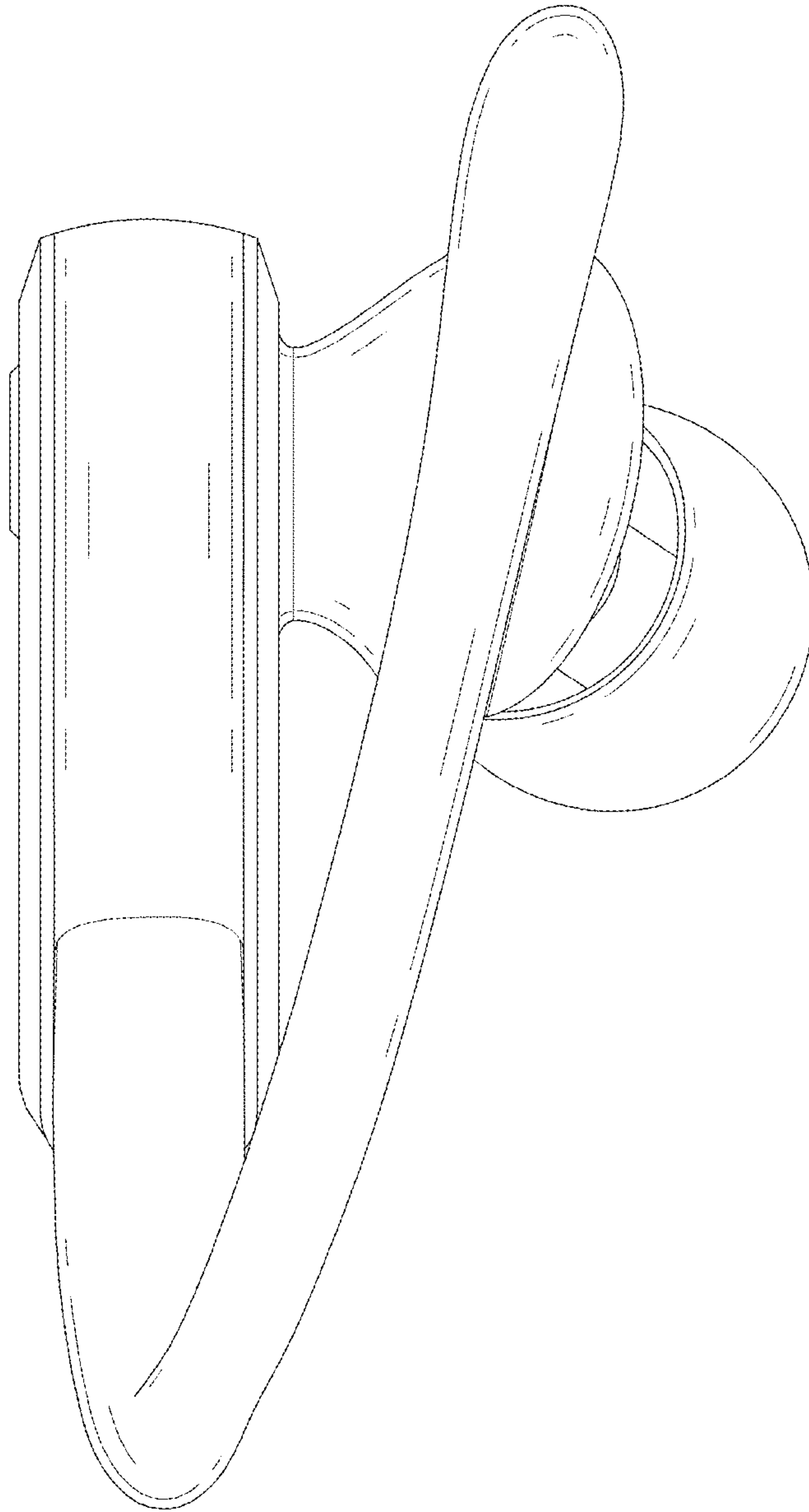

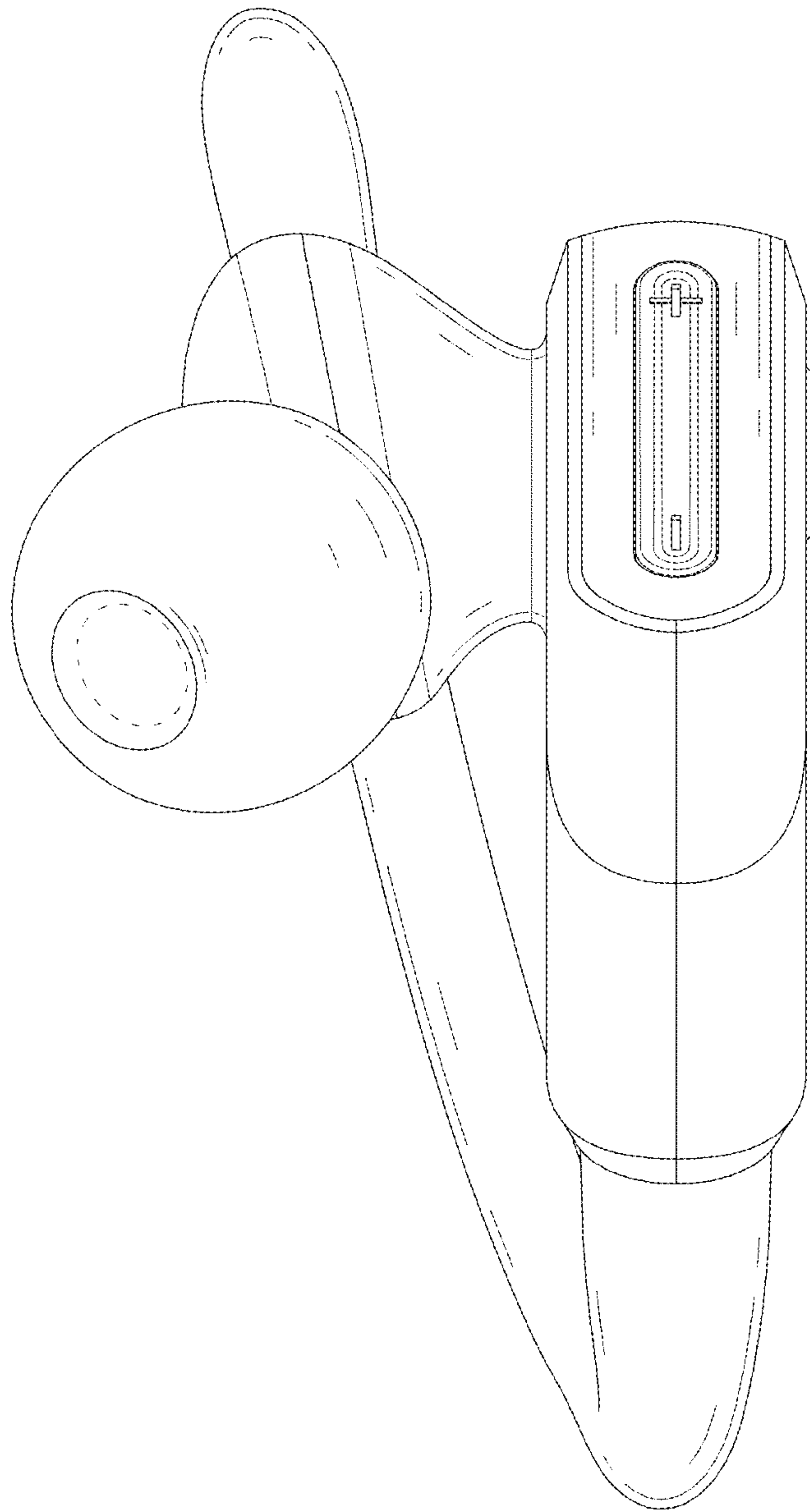

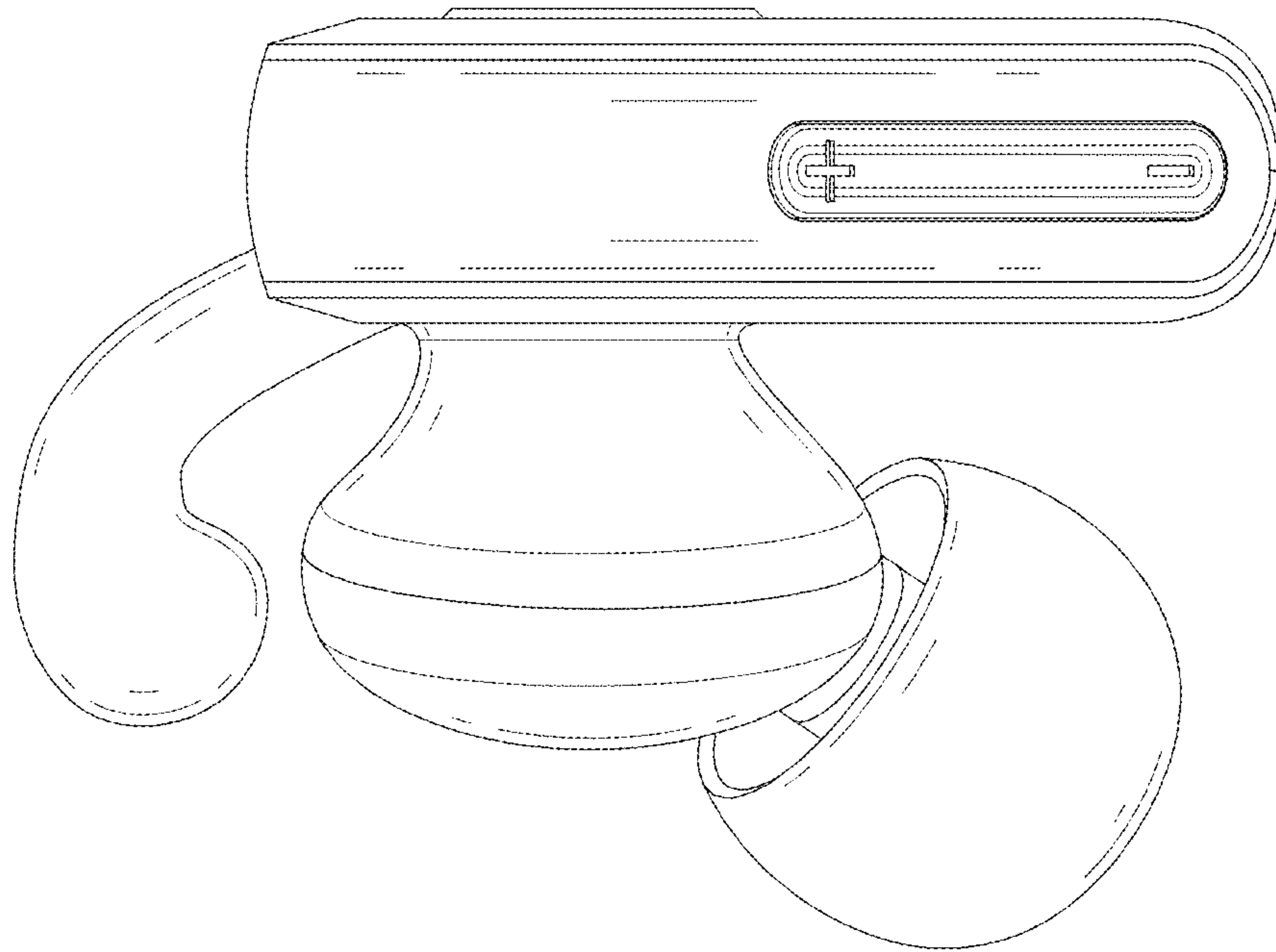

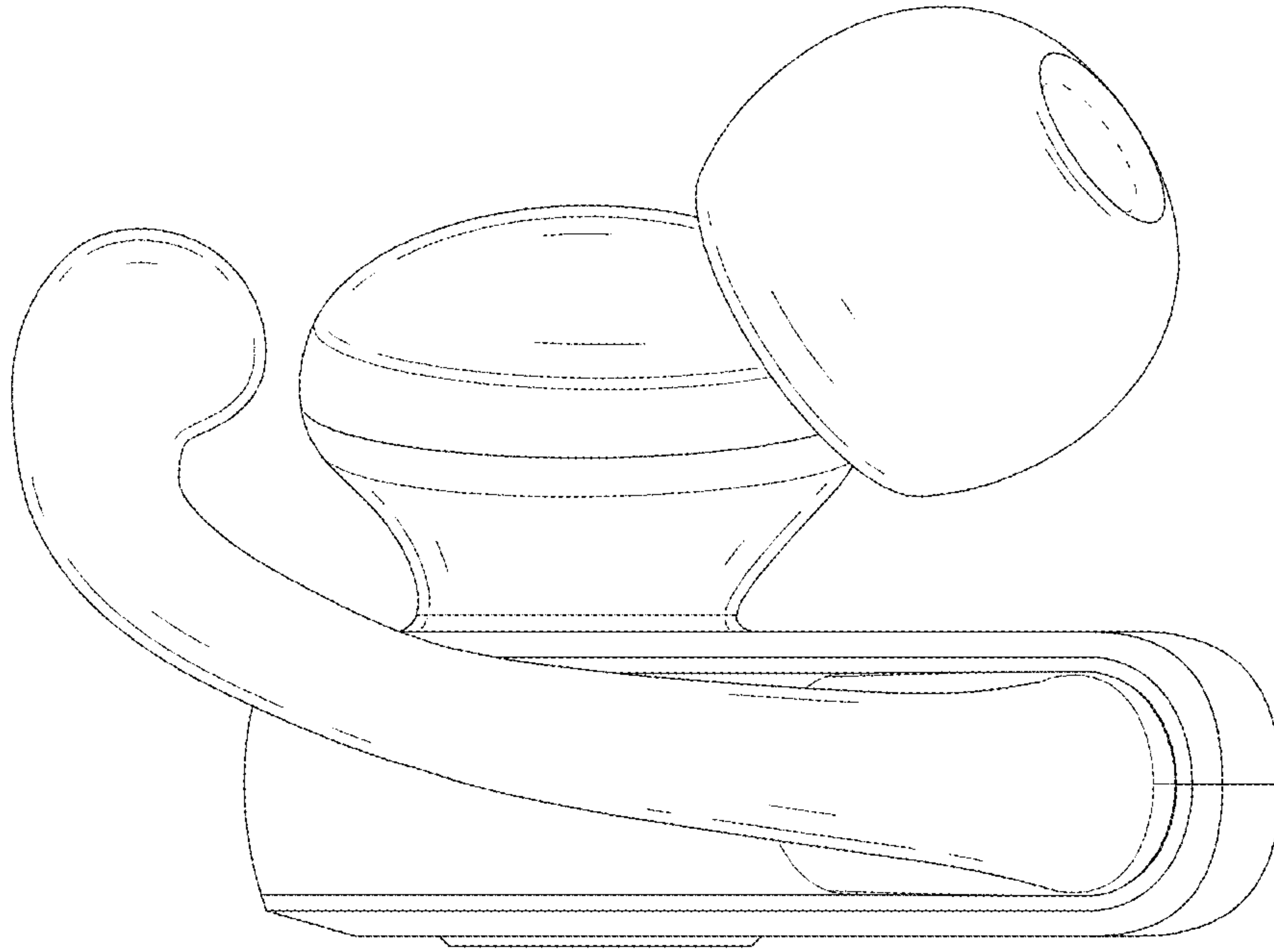
