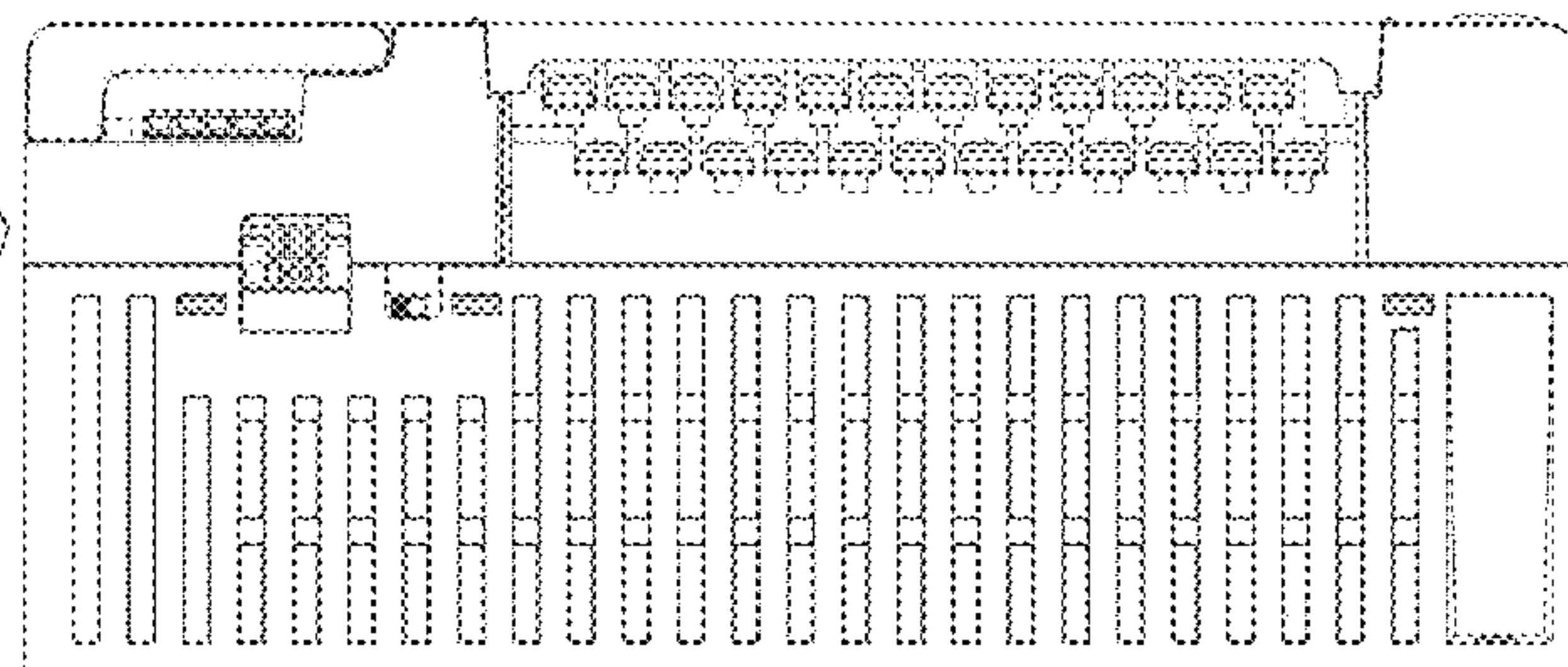
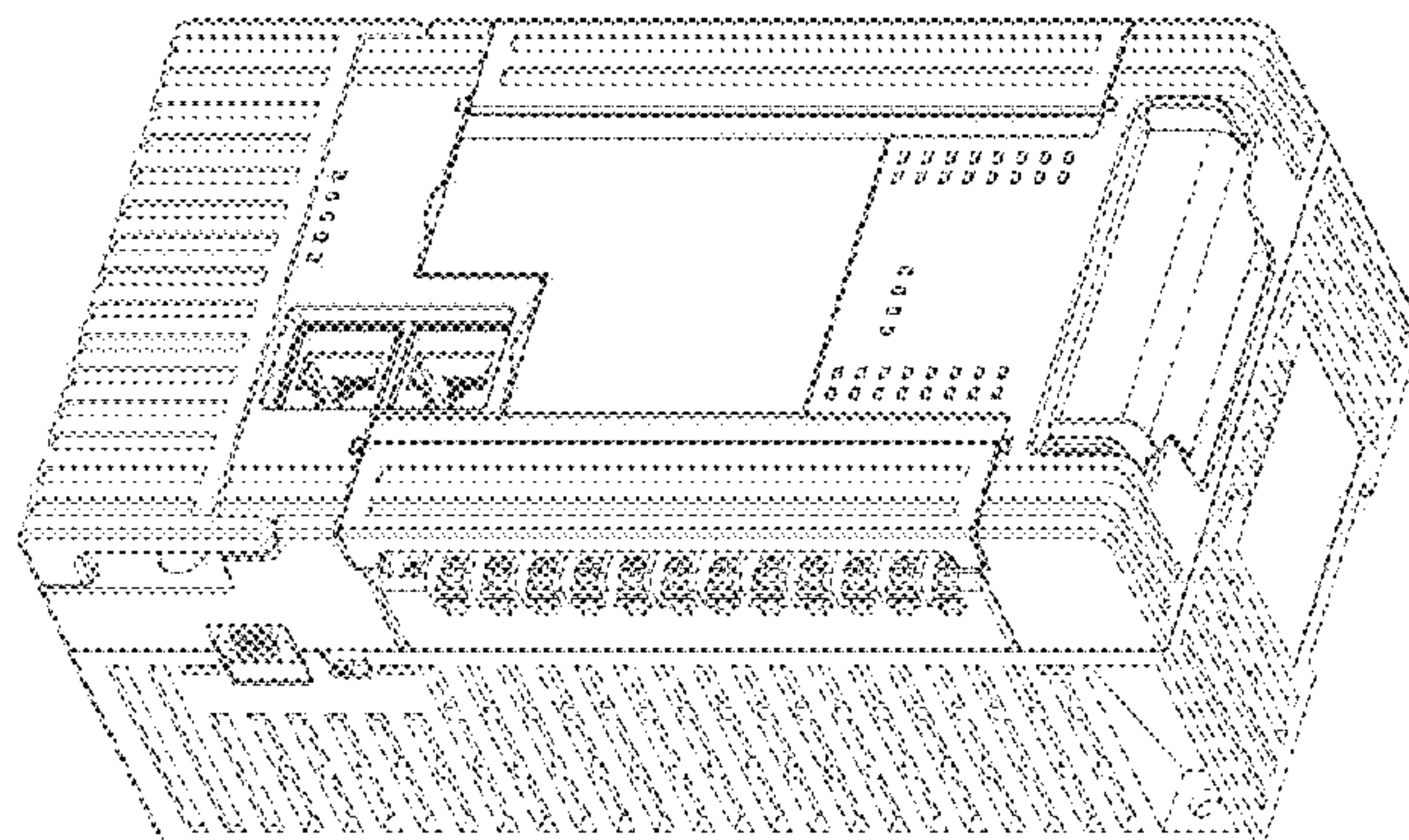
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a smart gateway; FIG. 2 is a front elevational view of a smart gateway; FIG. 3 is a rear elevational view of a smart gateway; FIG. 4 is a left side elevational view of a smart gateway; FIG. 5 is a right side elevational view of a smart gateway; FIG. 6 is a top plan view of a smart gateway; and, FIG. 7 is a bottom plan view of a smart gateway. 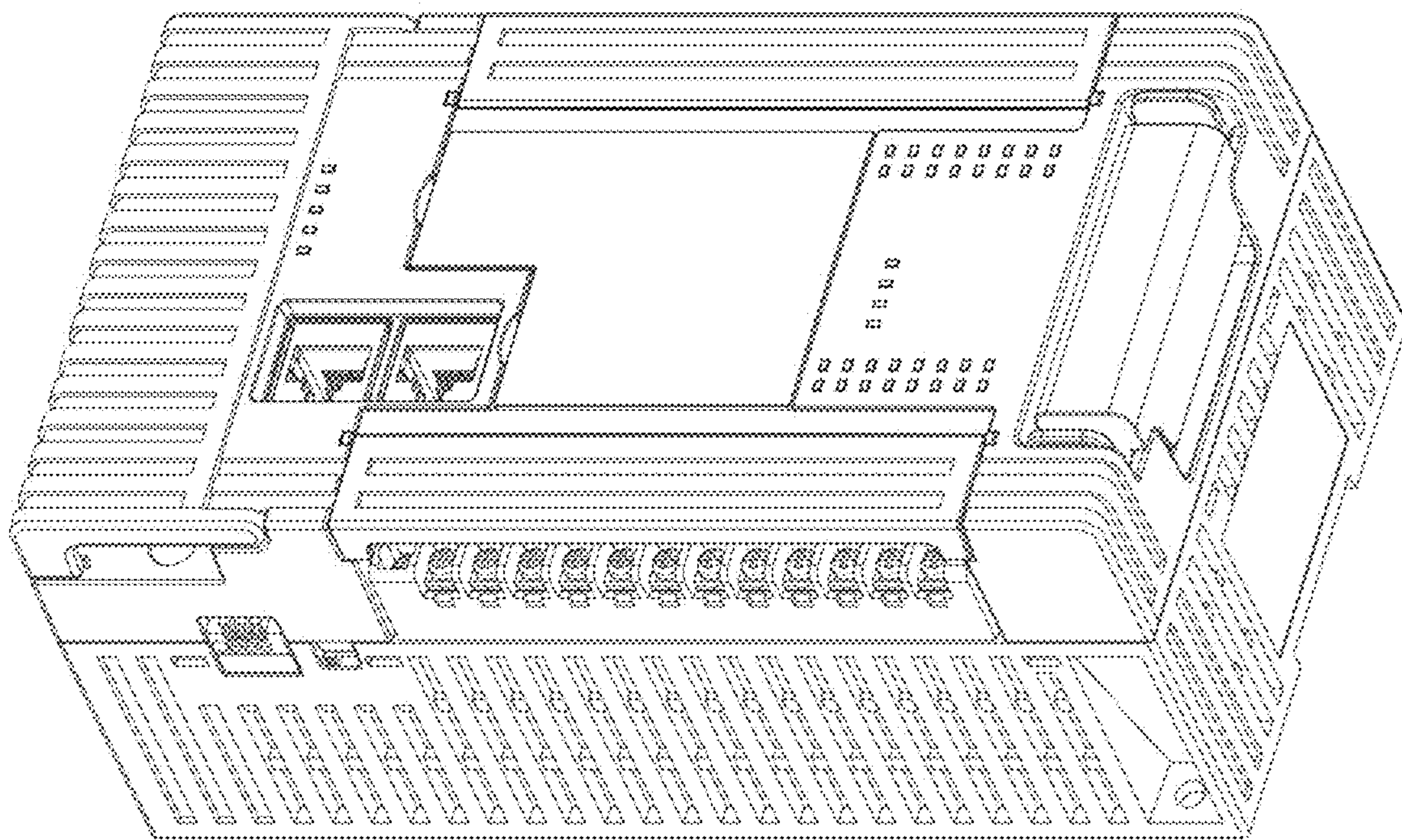

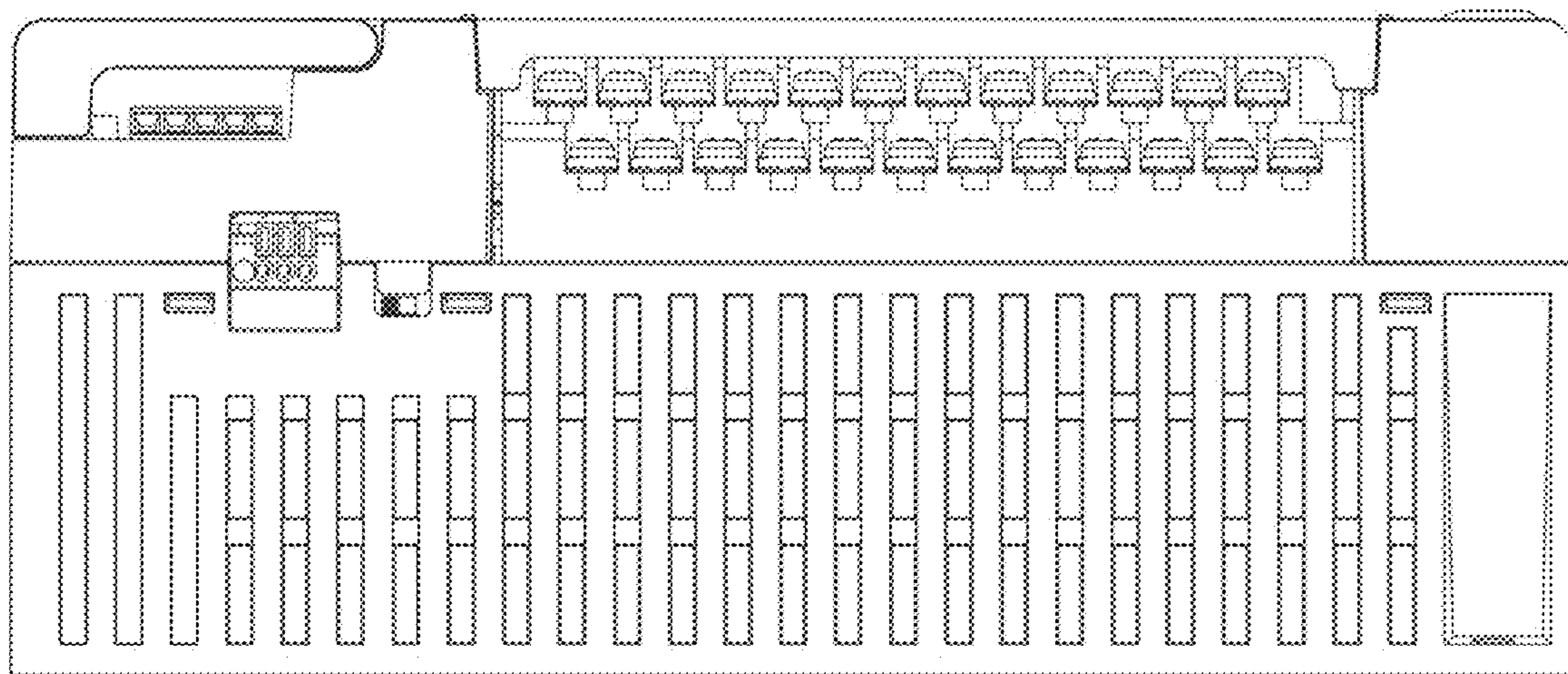

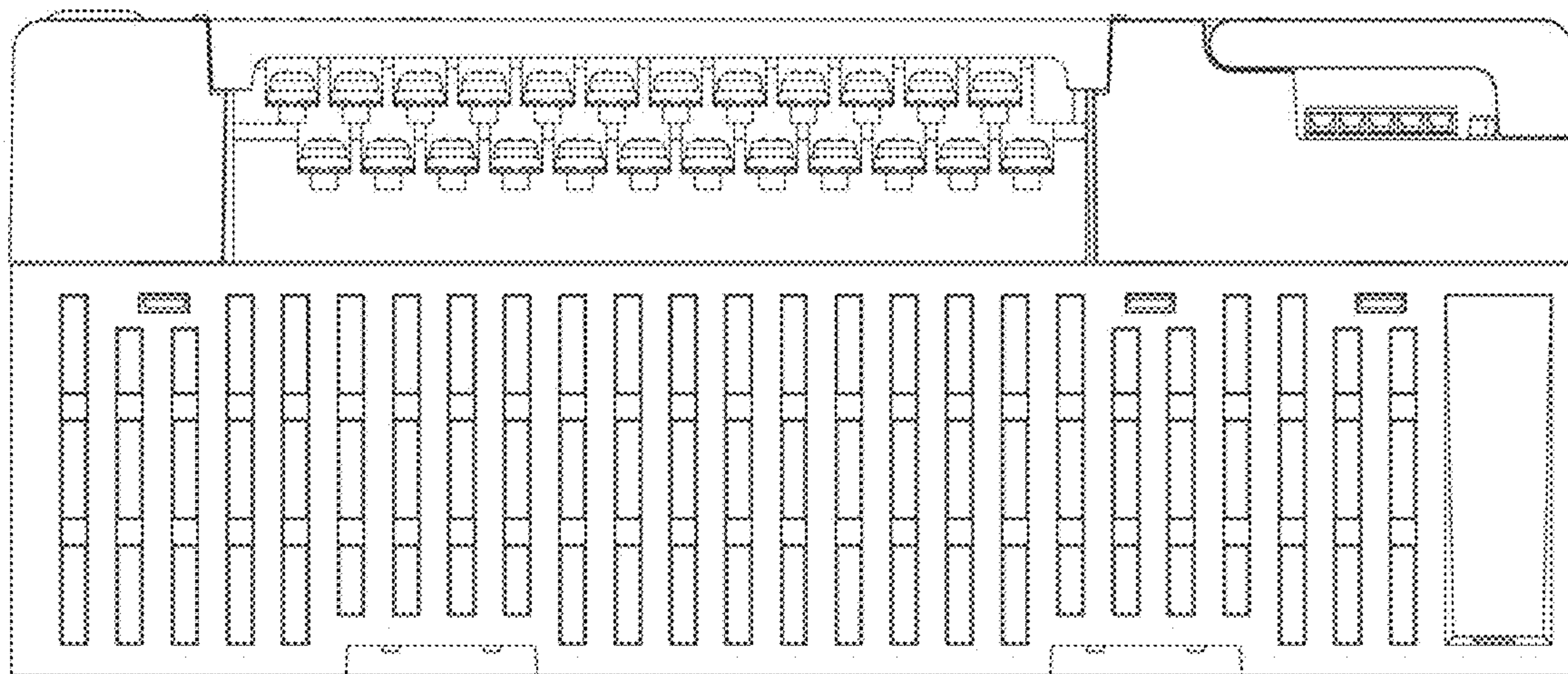

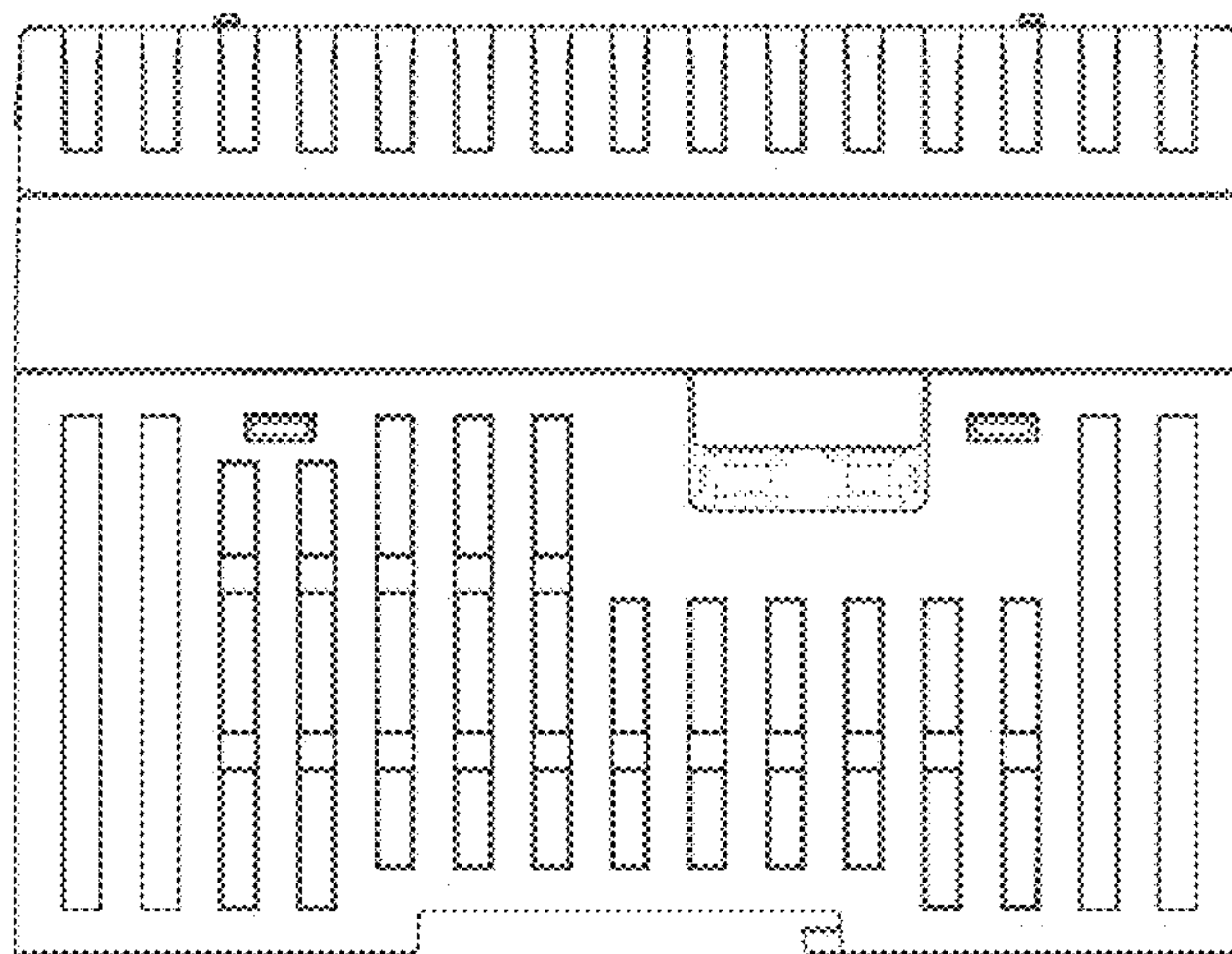

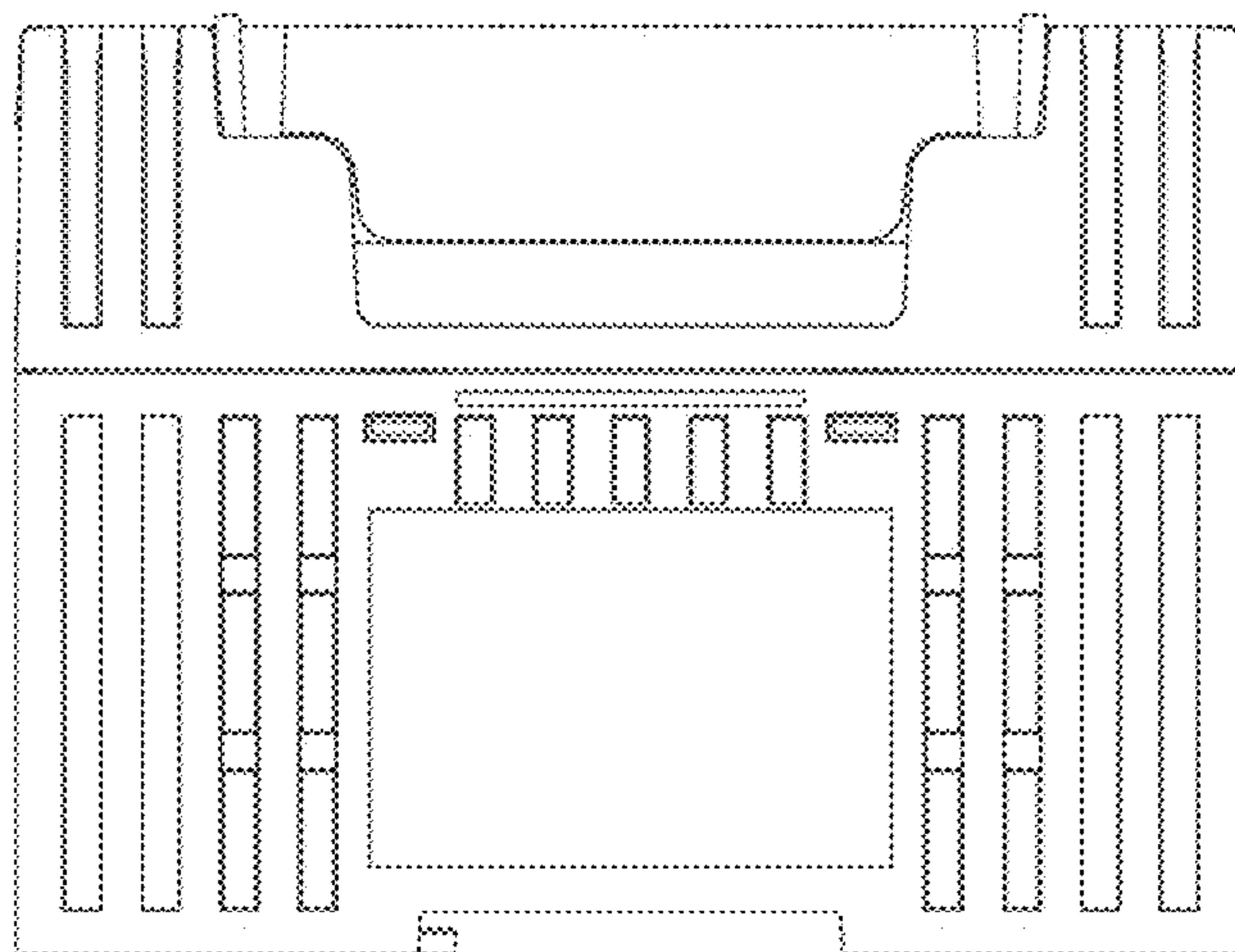

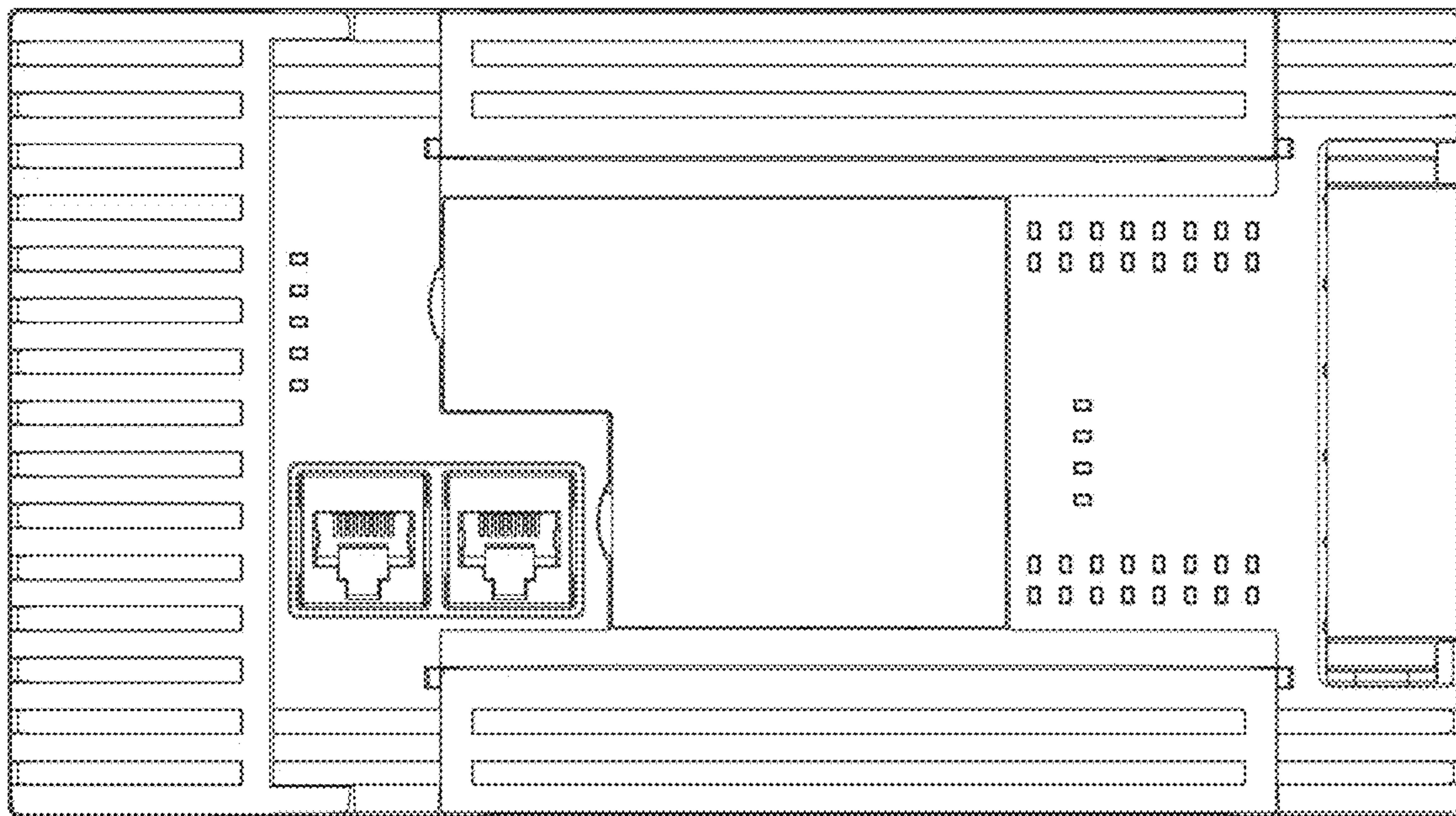

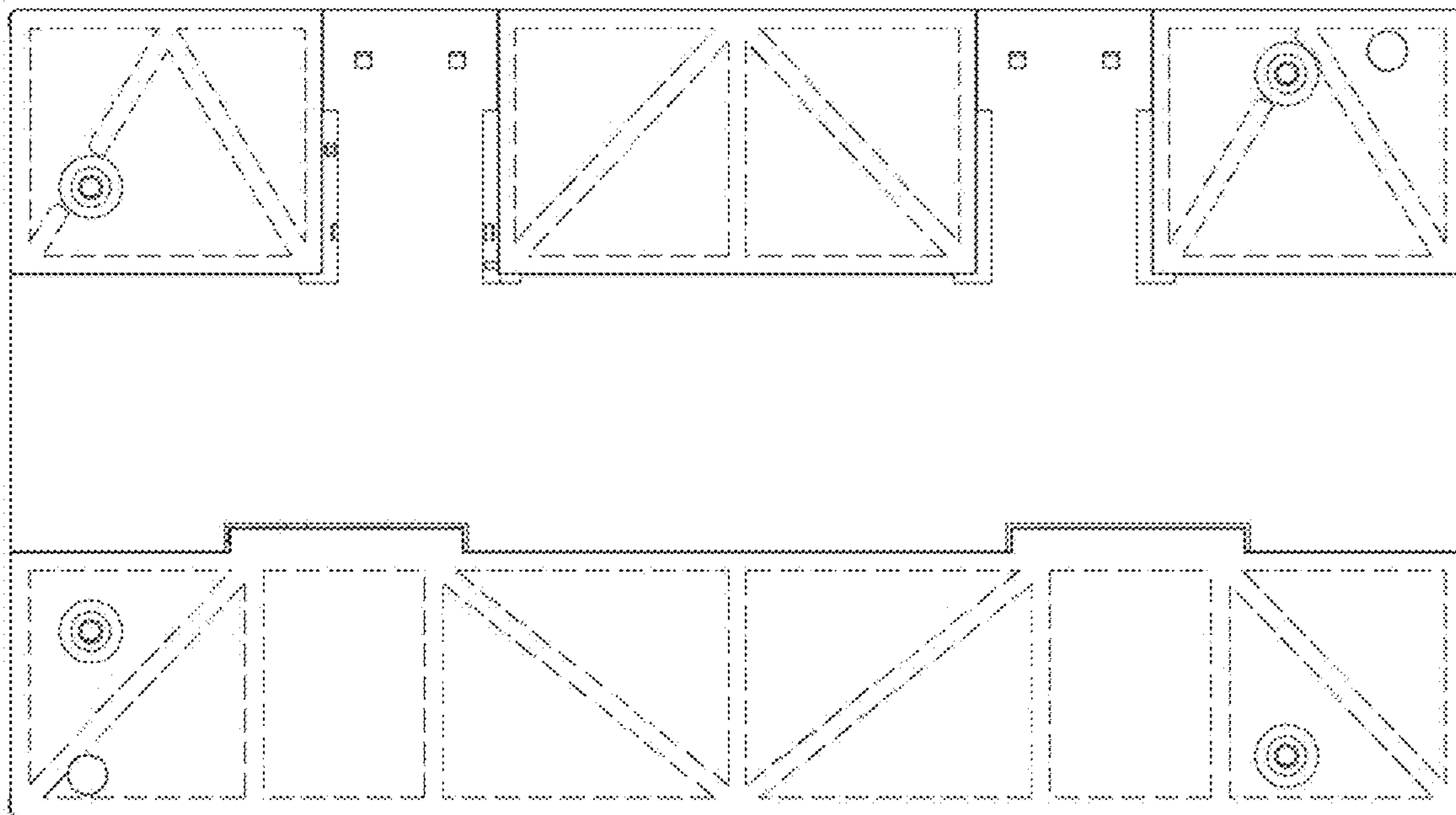
