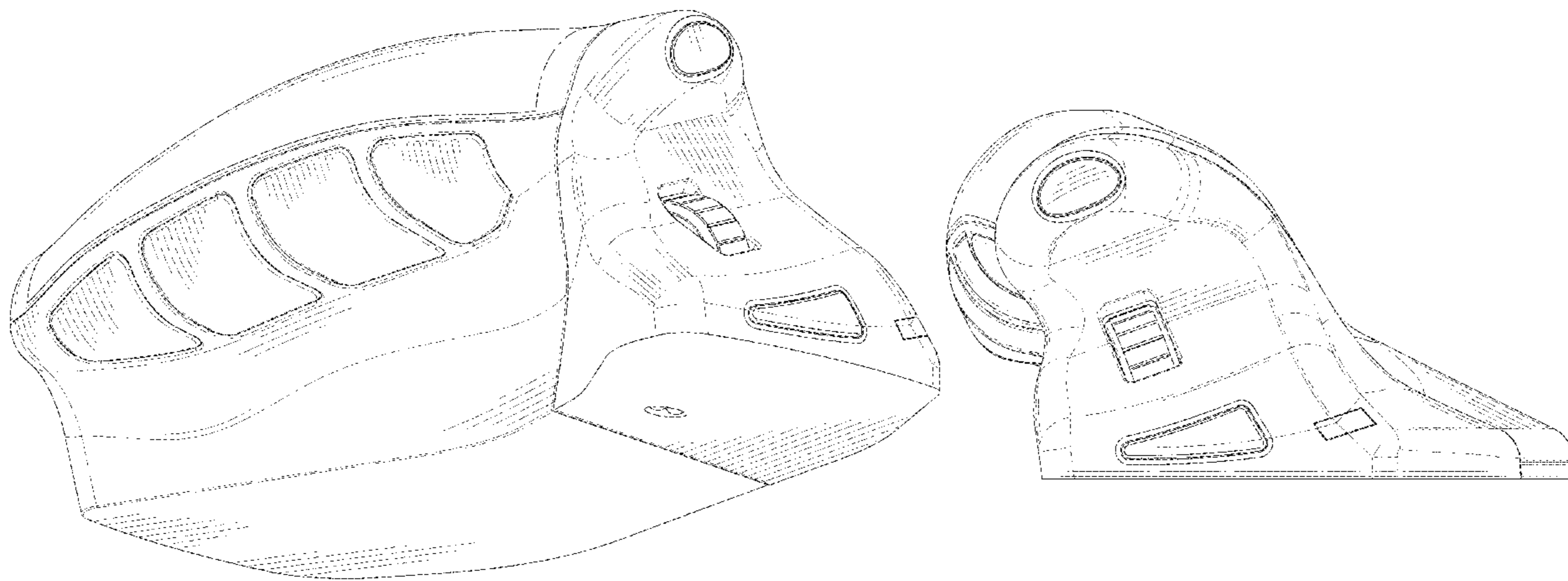
The modified design for “computer mouse”, as shown and described.

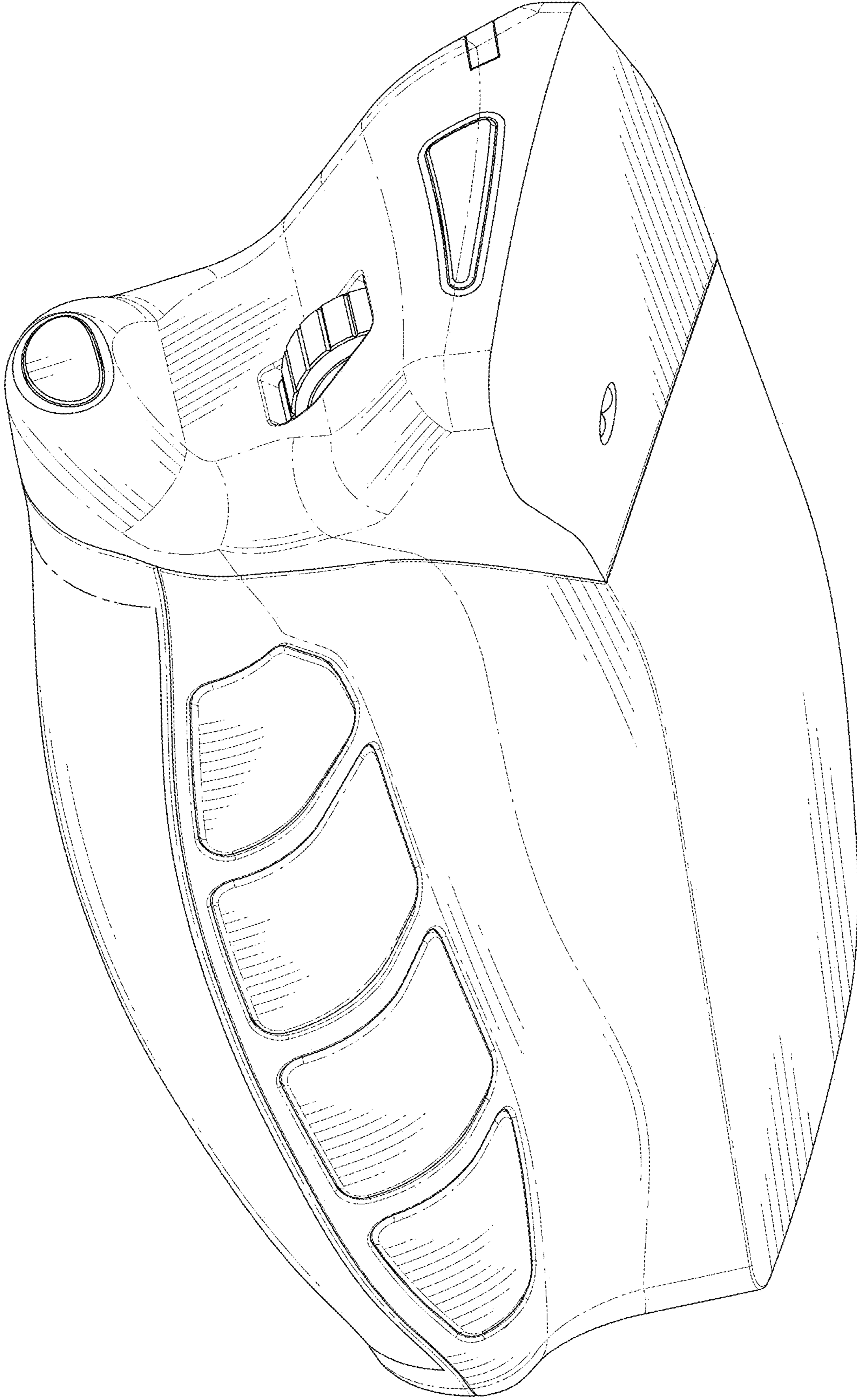

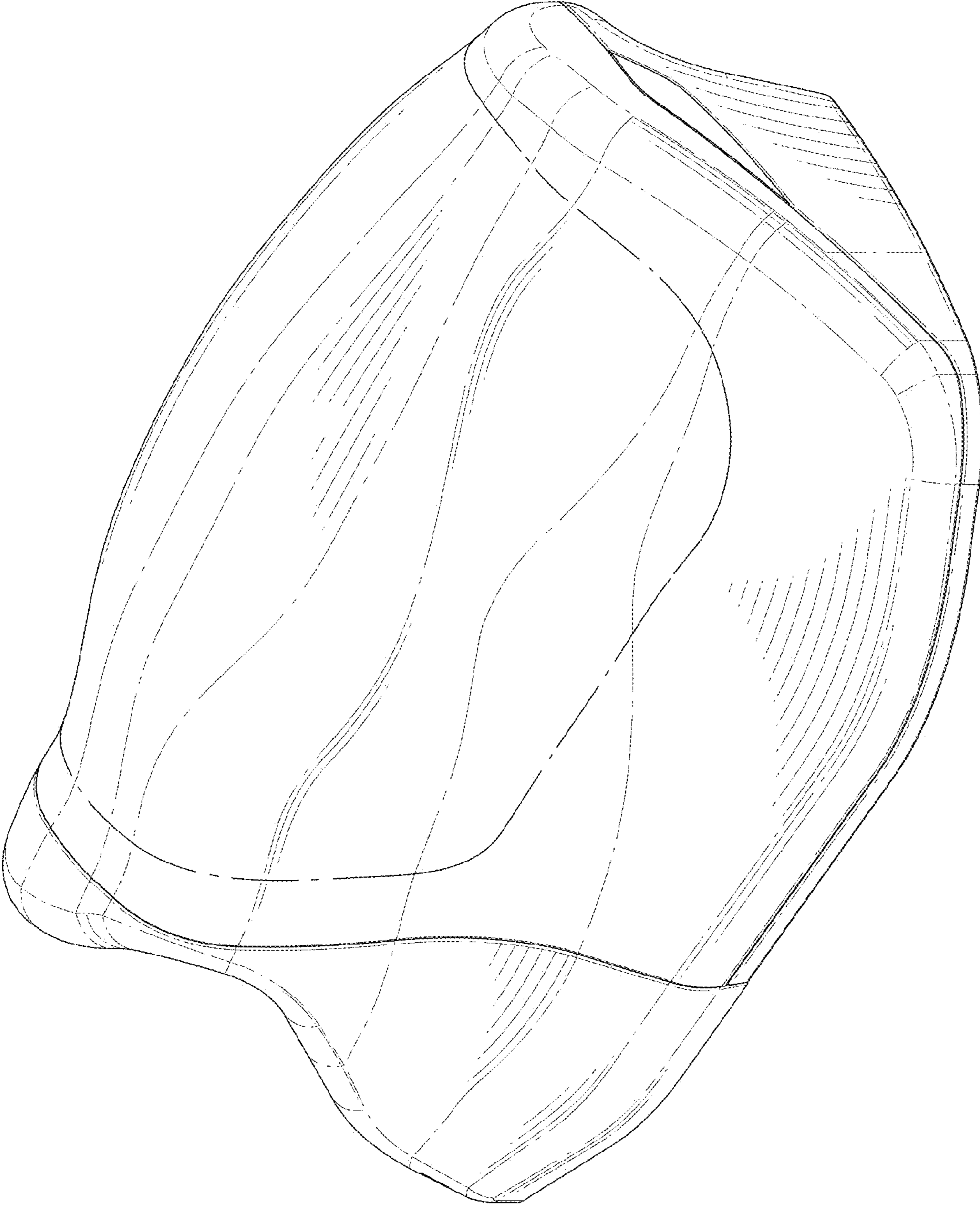

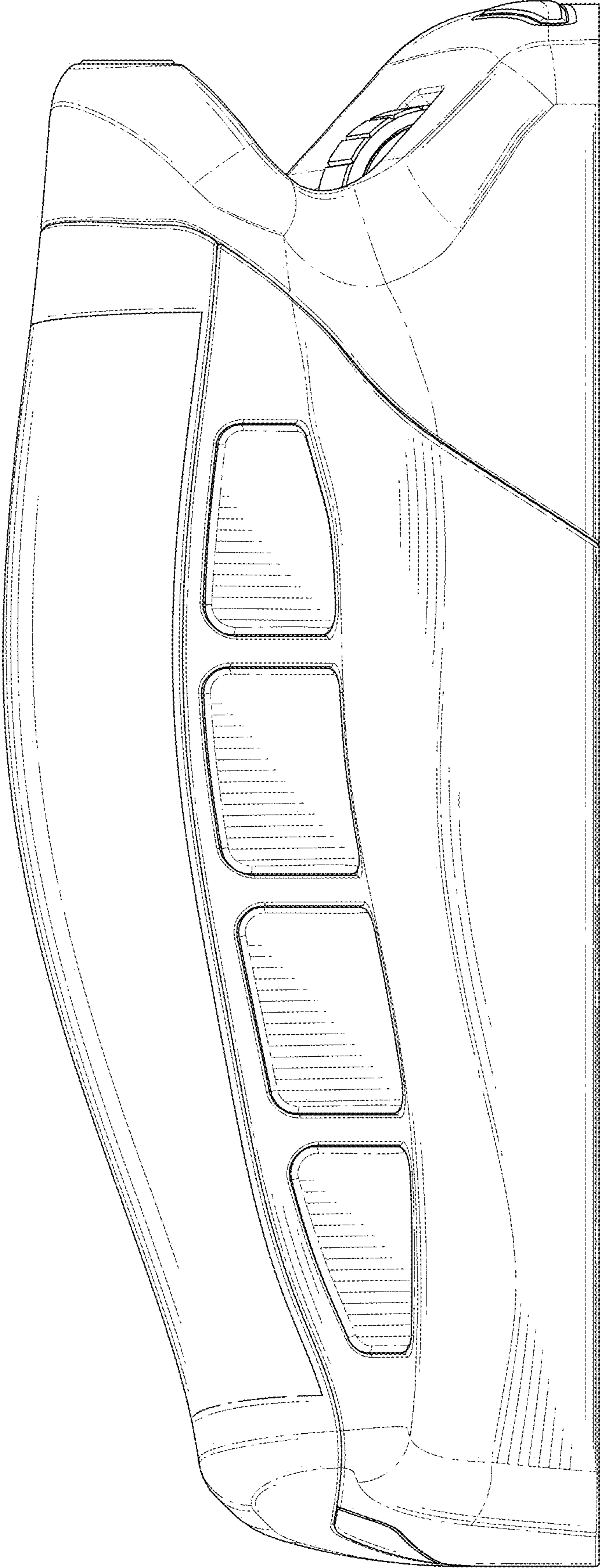

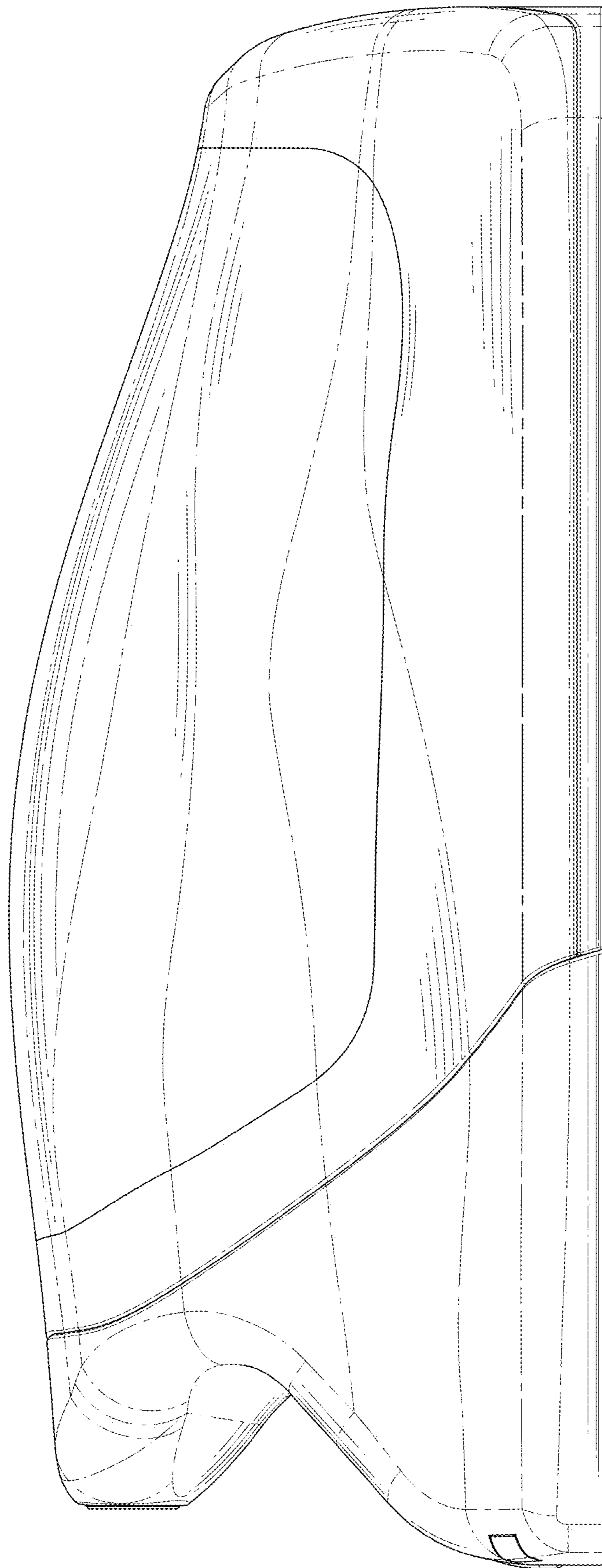

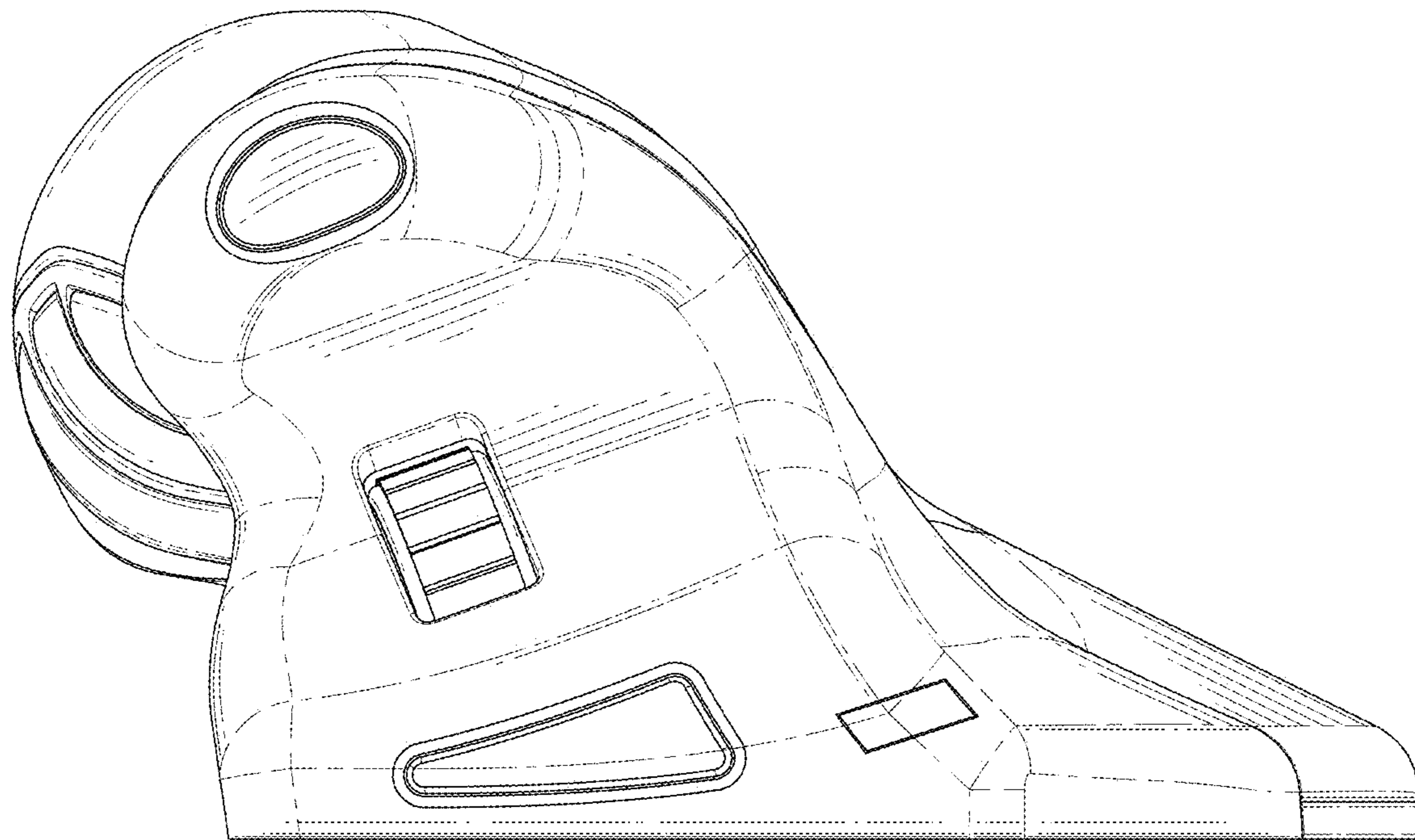

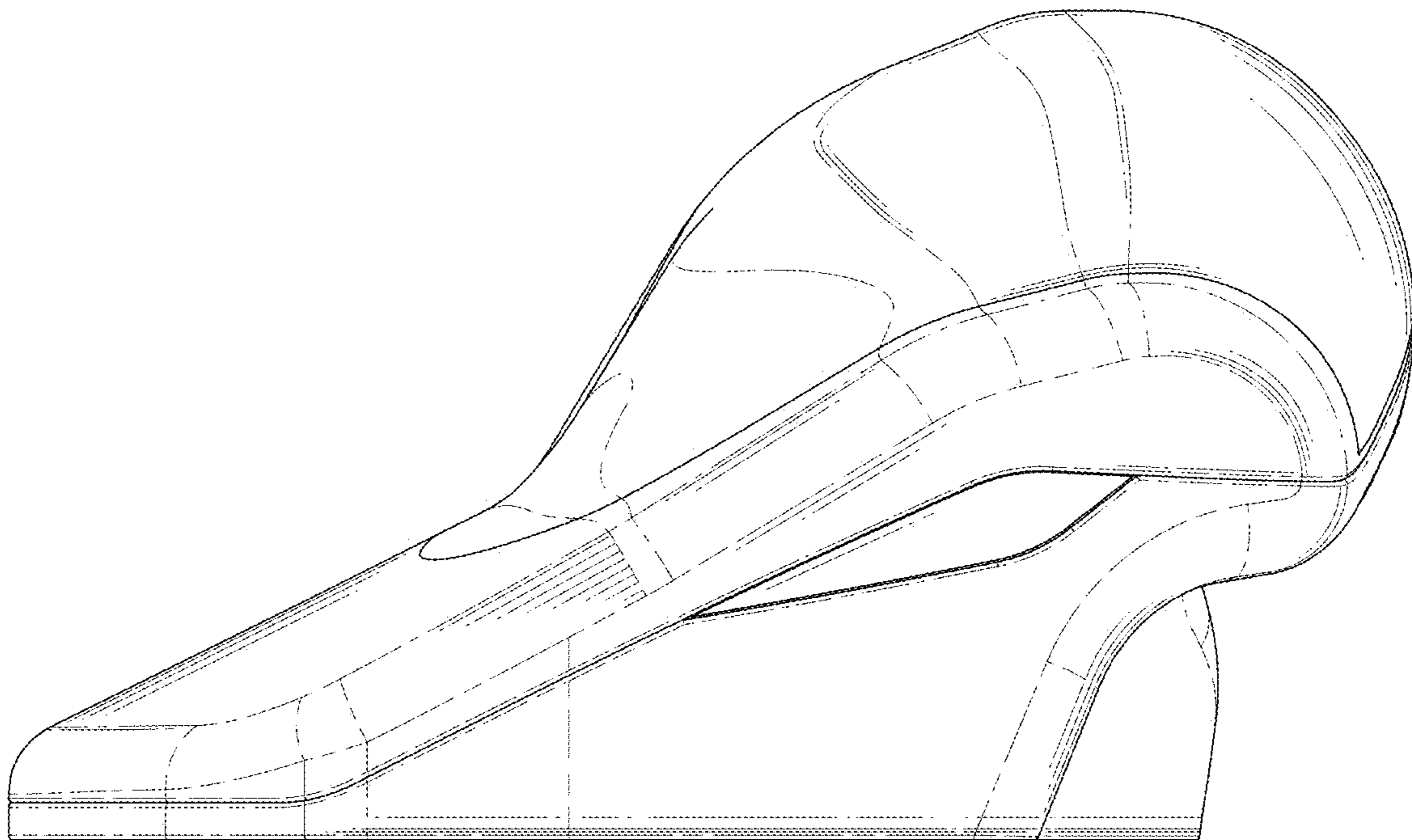

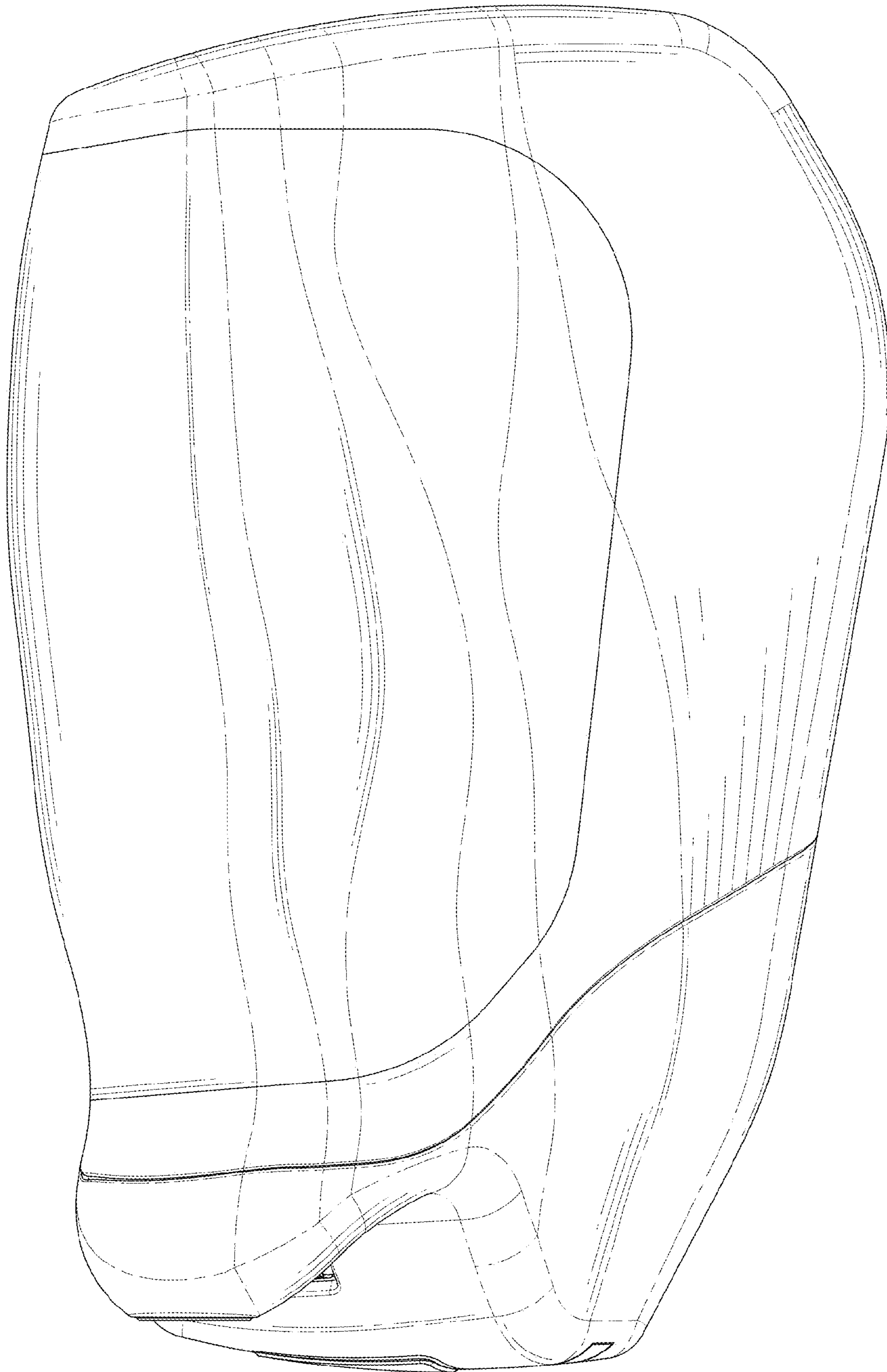

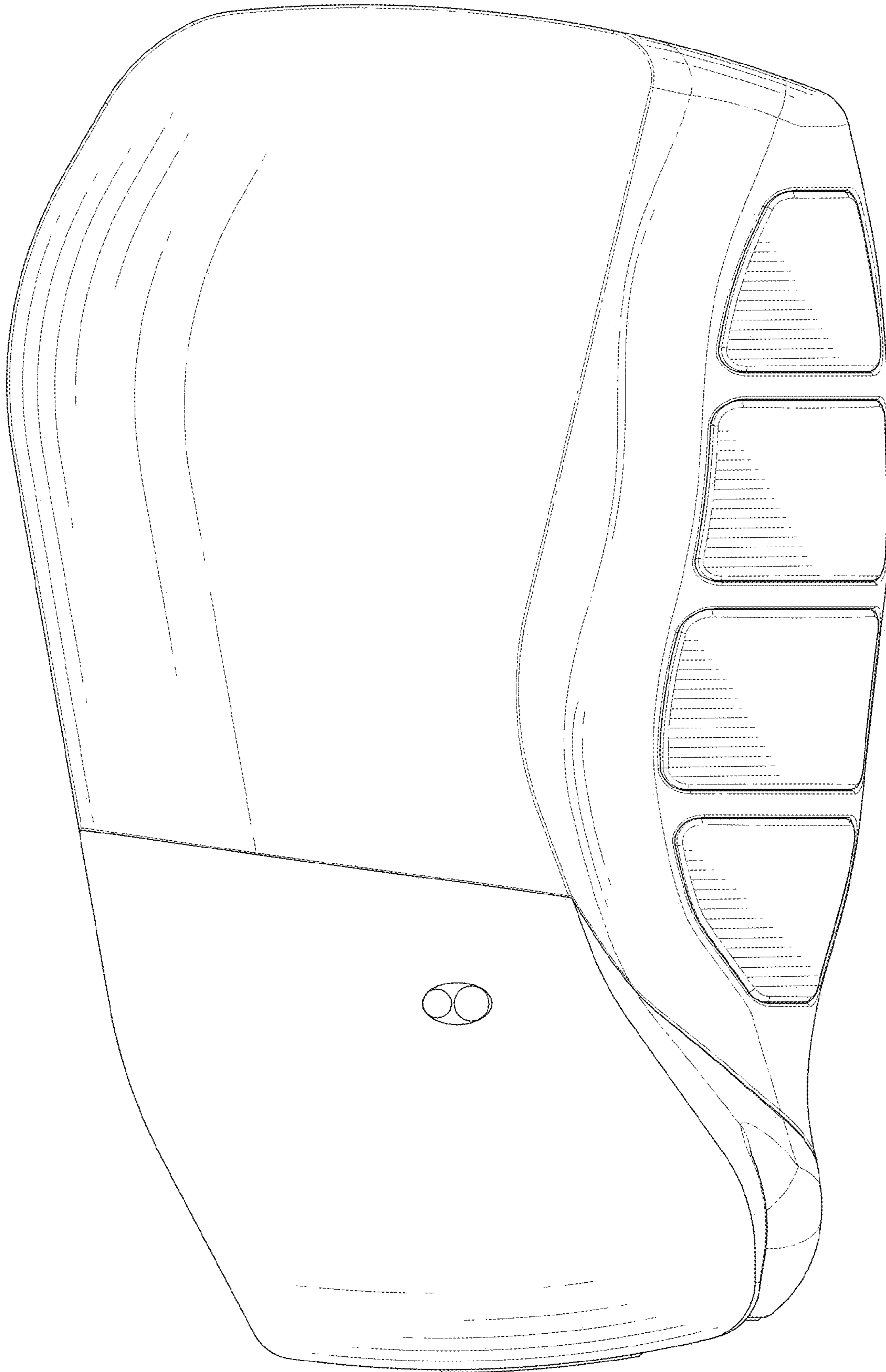
