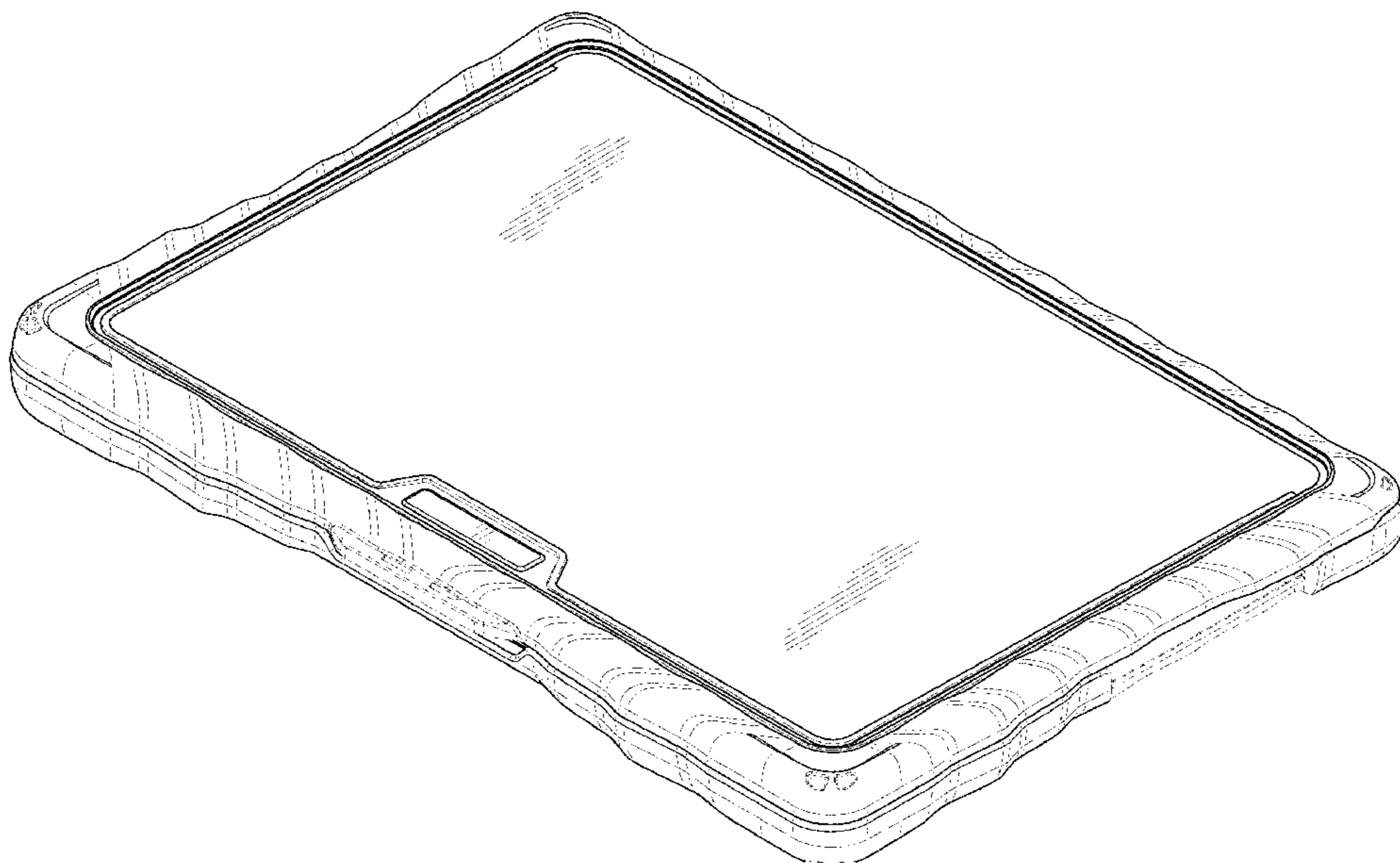
(57) **CLAIM**

The ornamental design for a case for portable electronic computing device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a case for portable electronic computing device showing our new design. FIG. 2 is a front elevational view thereof. FIG. 3 is a rear elevational view thereof. FIG. 4 is a right elevational view thereof. FIG. 5 is a left elevational view thereof. FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. 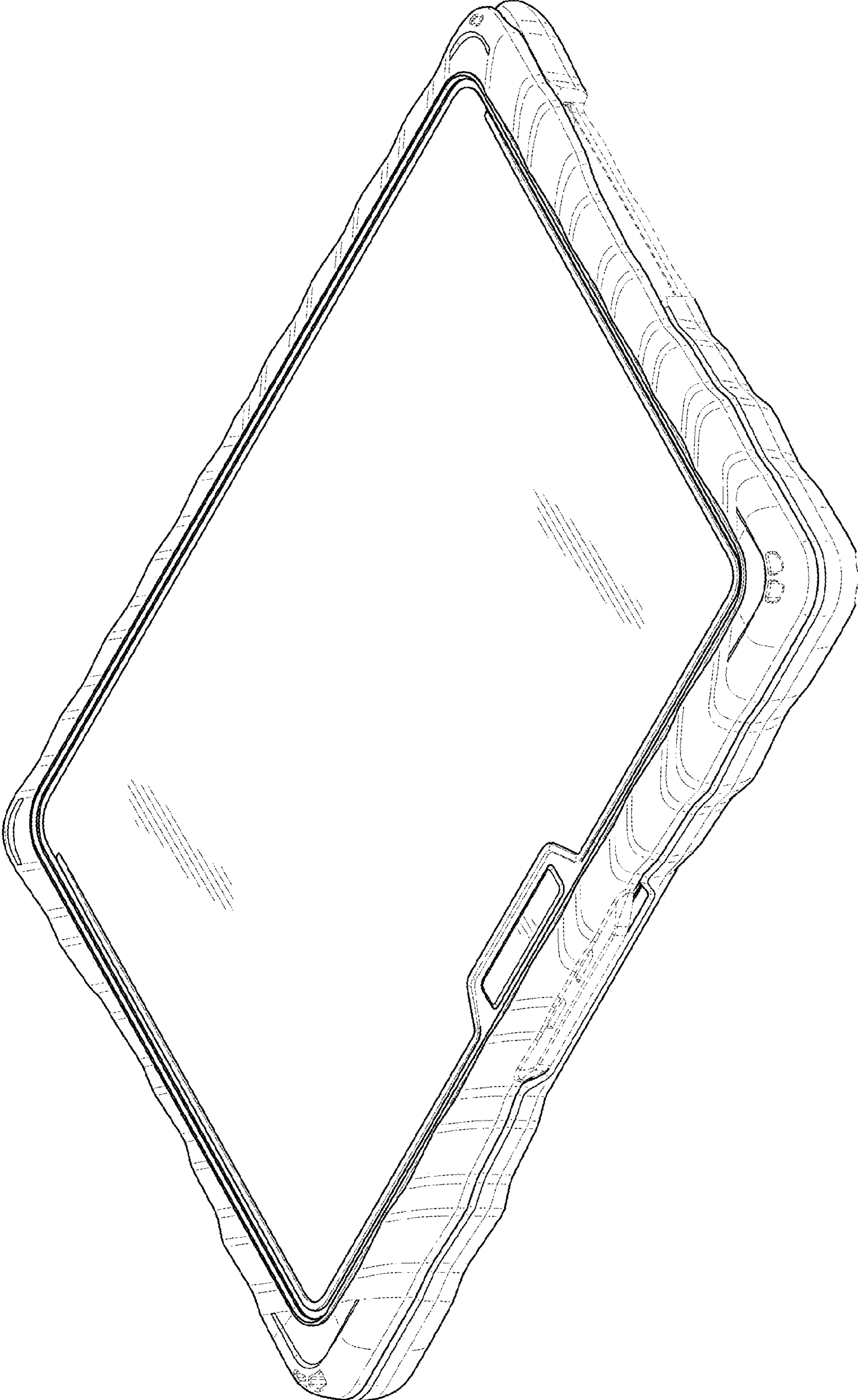

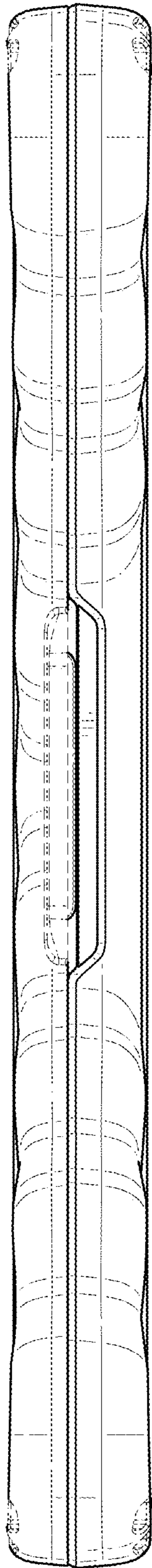

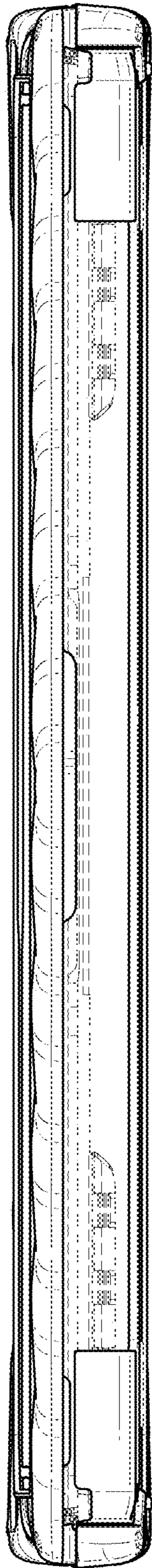

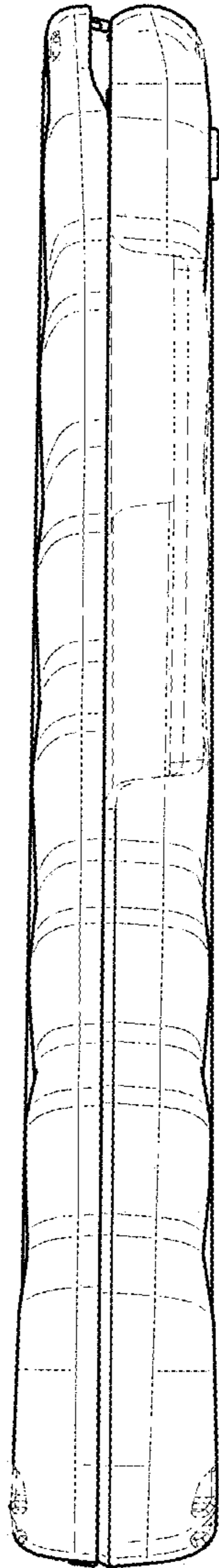

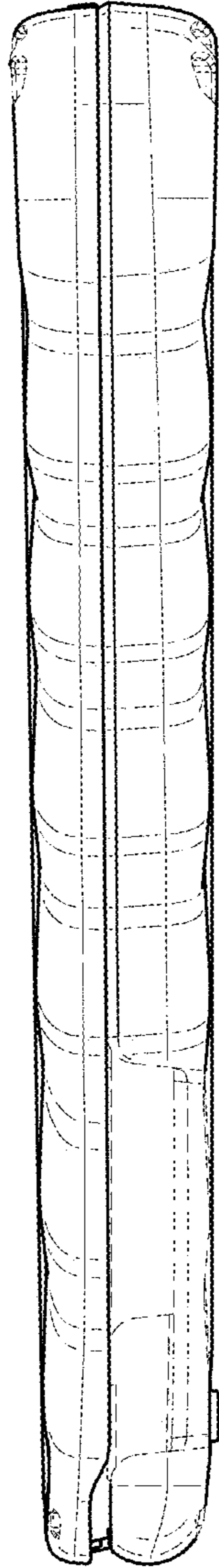

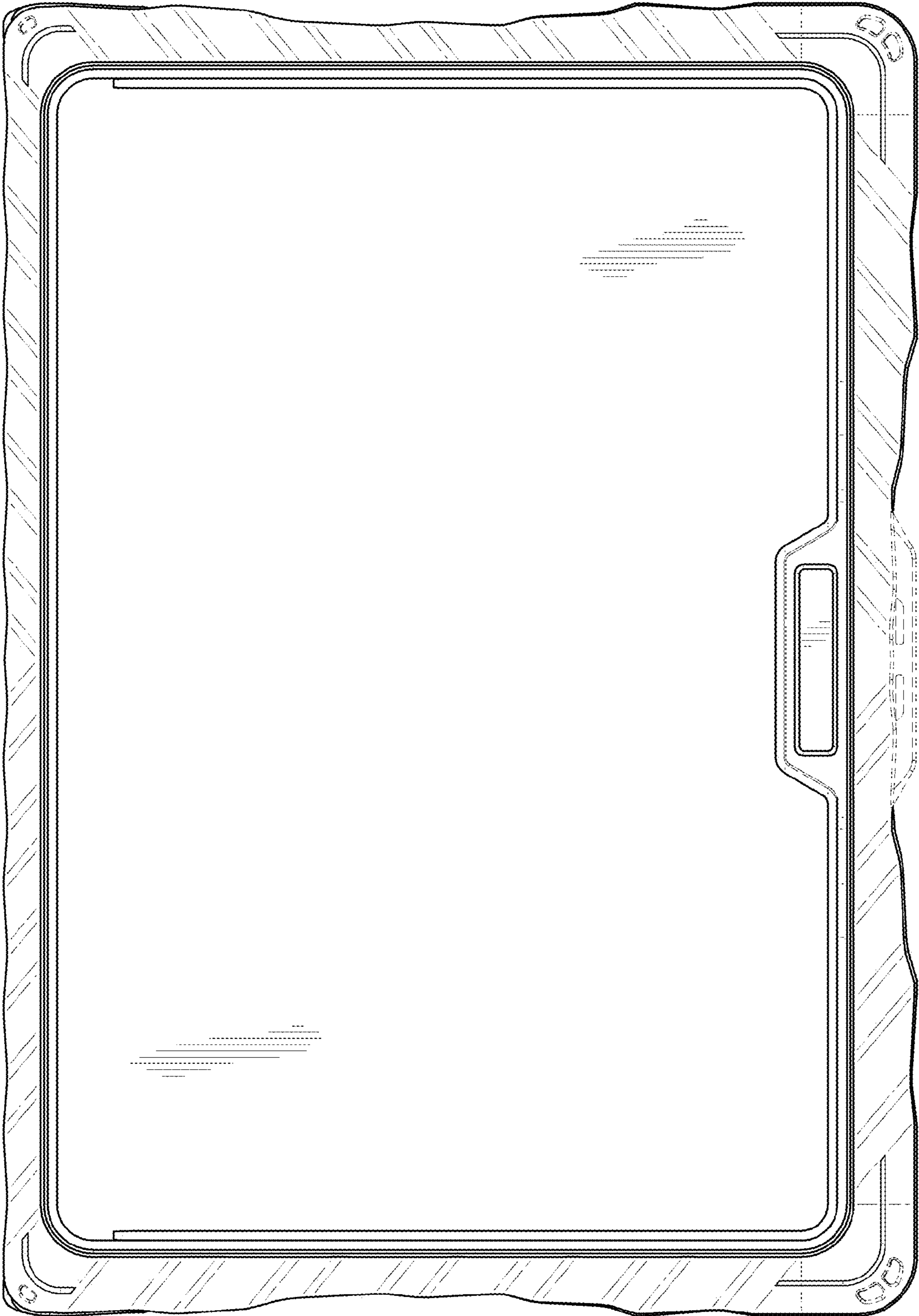

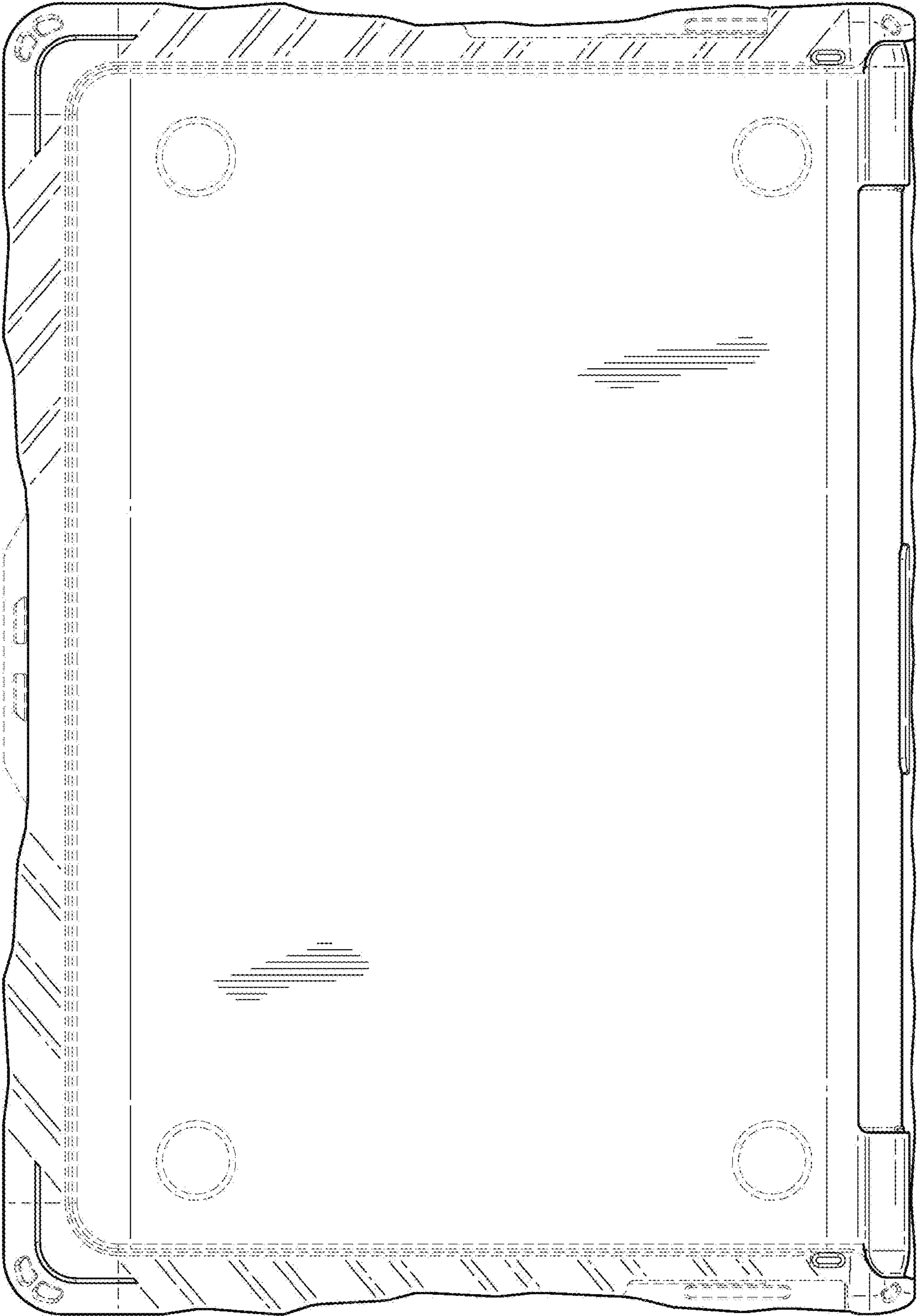
