FIG. 12 is a fifth image thereof;

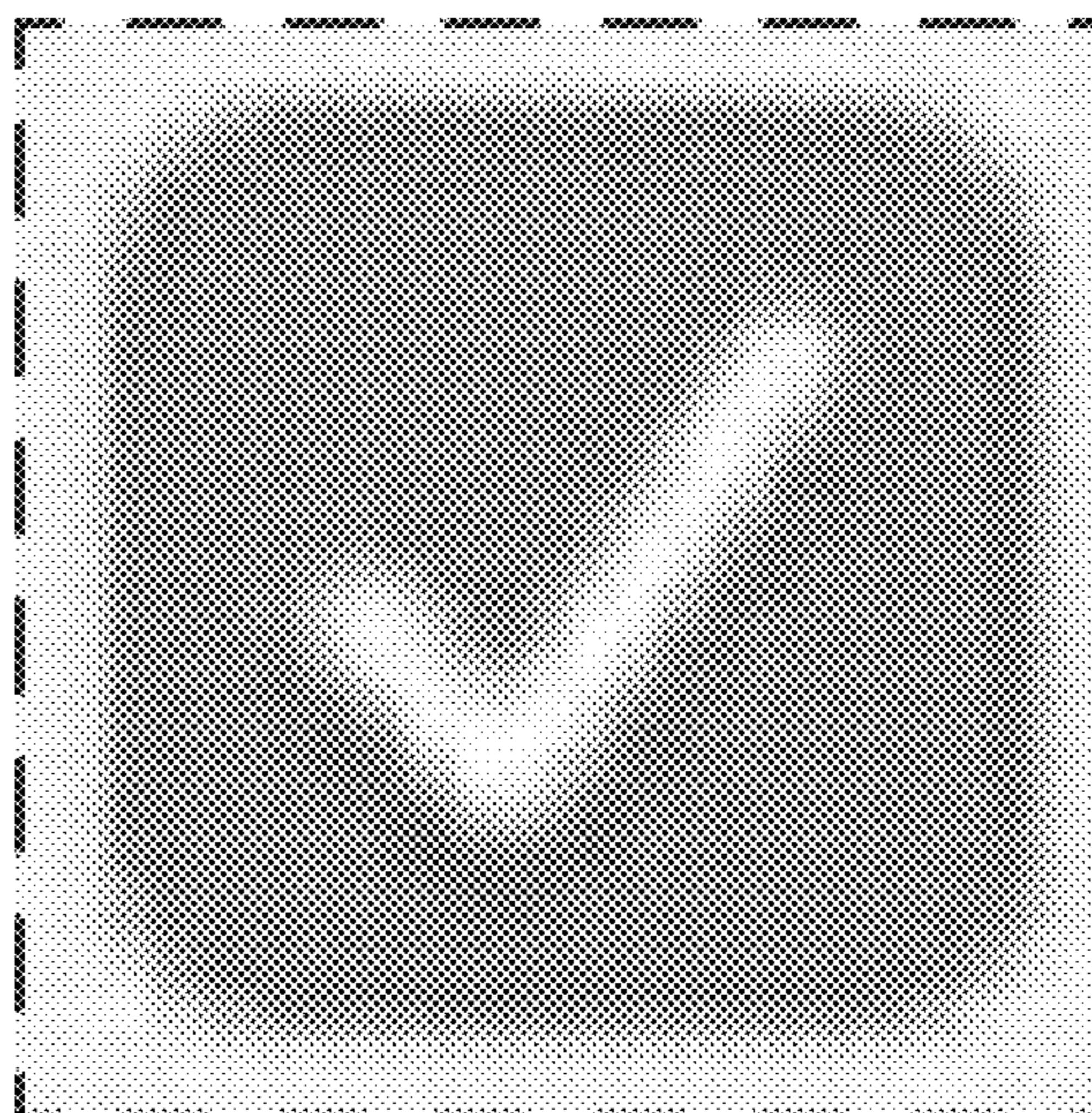
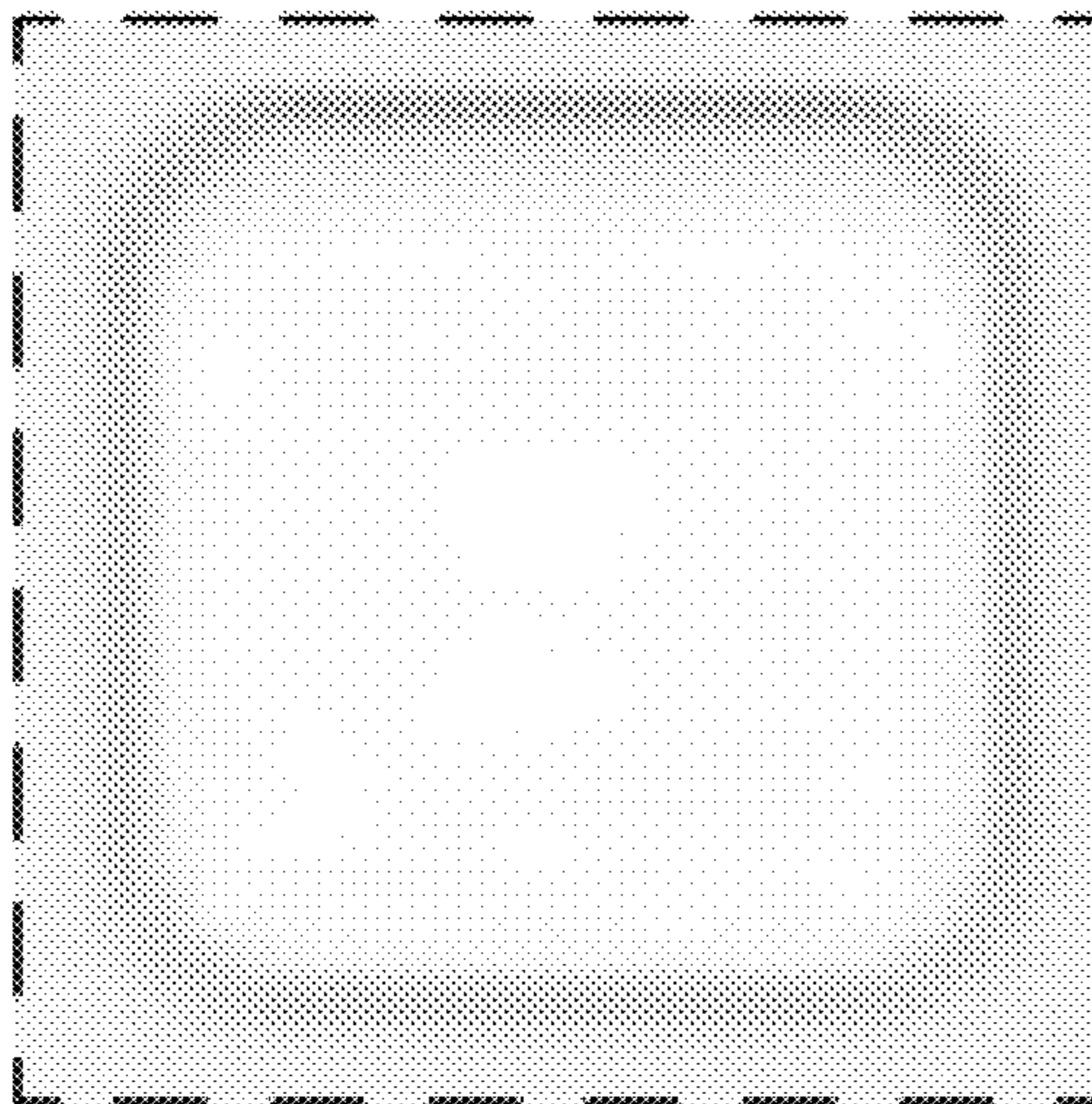
FIG. 13 is a sixth image thereof; and,

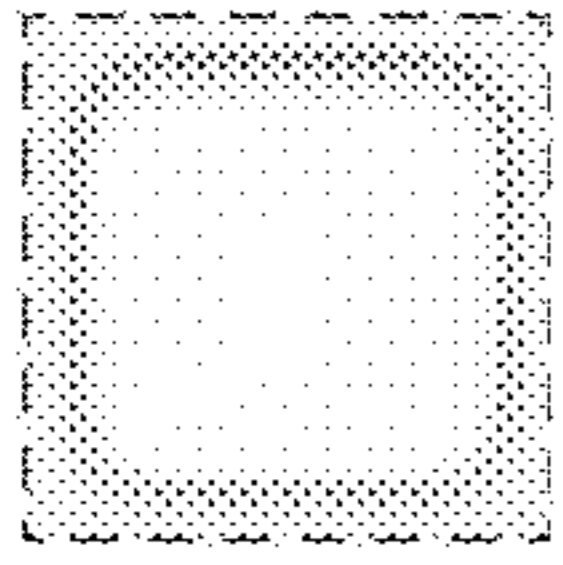

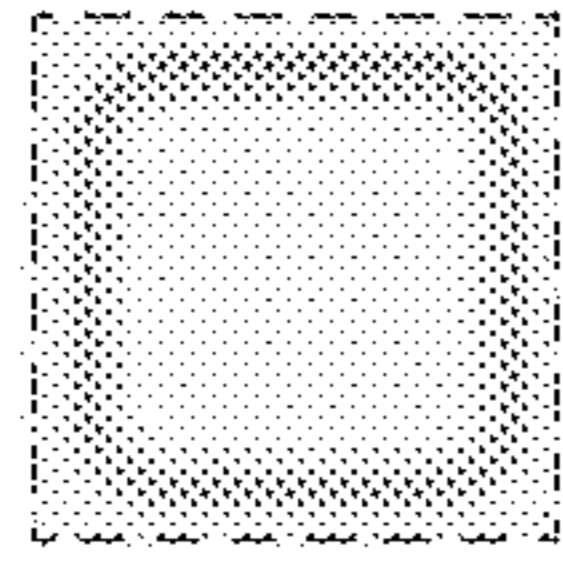

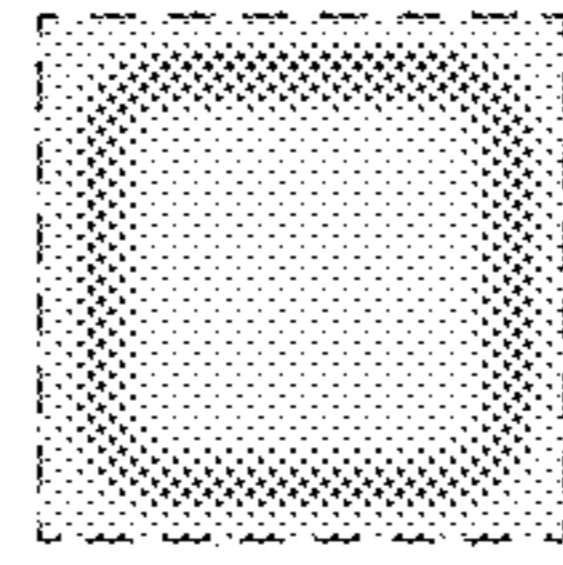




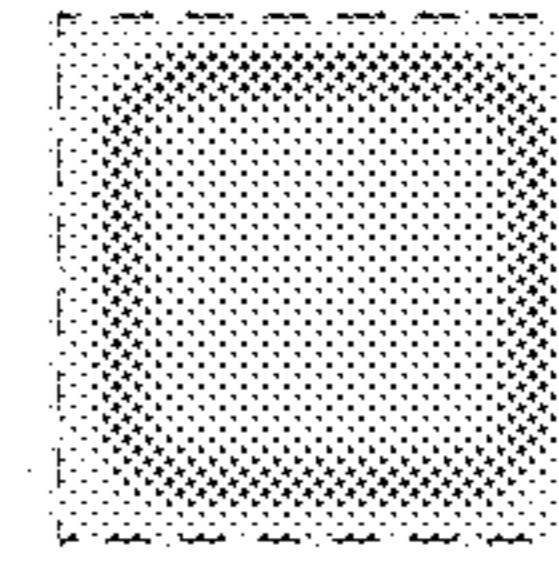

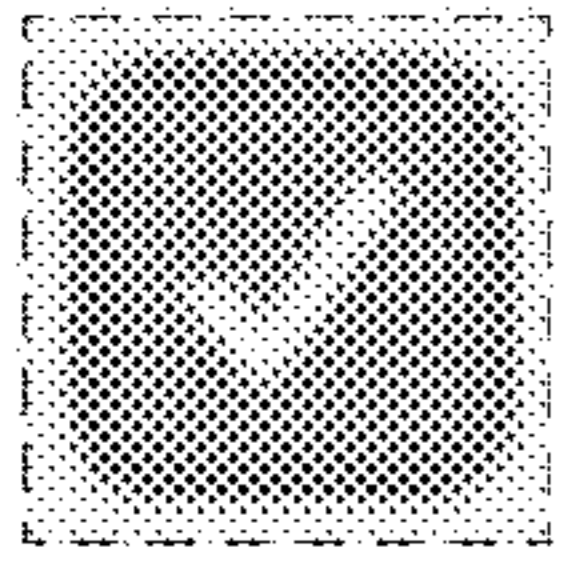

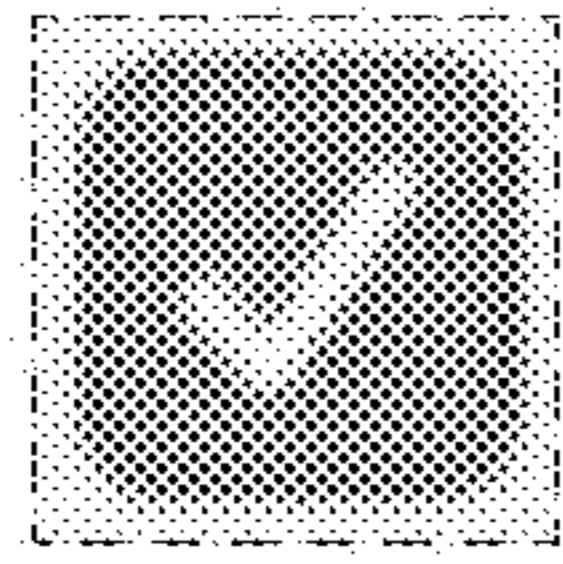

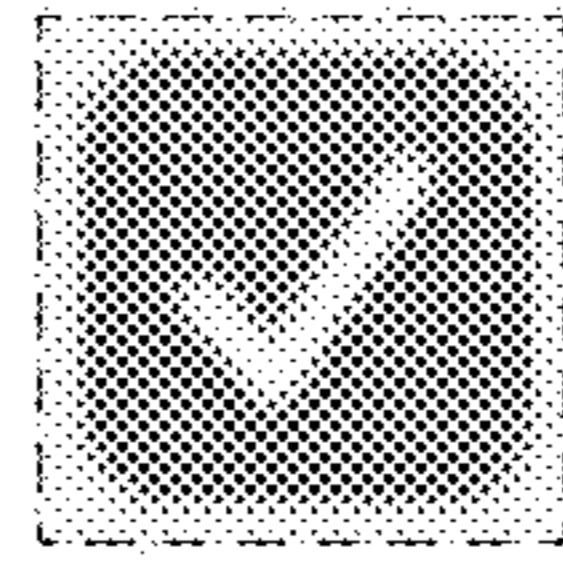

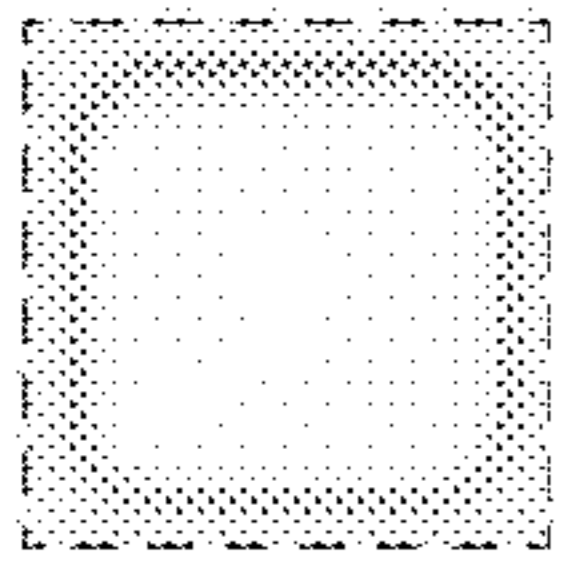

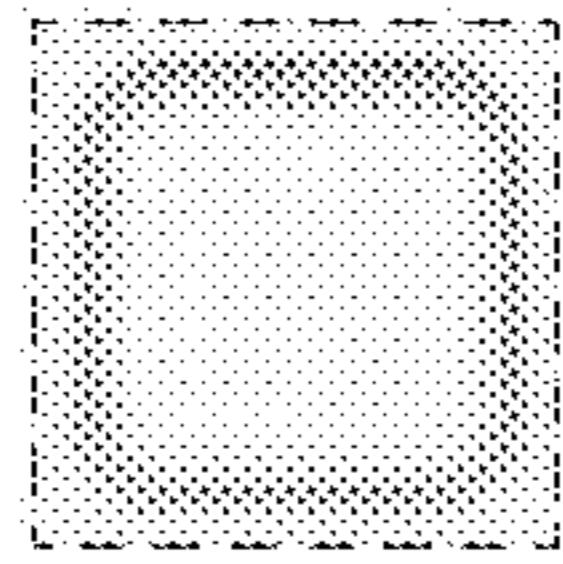

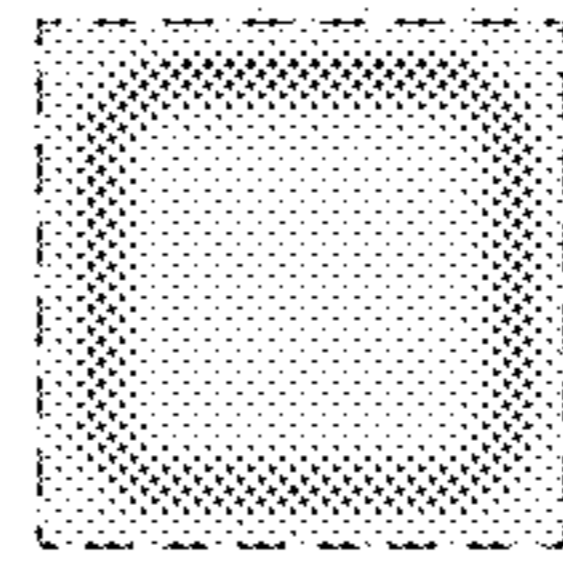

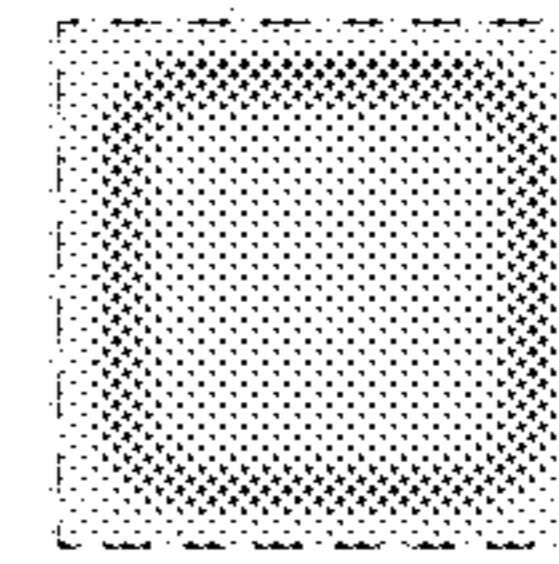

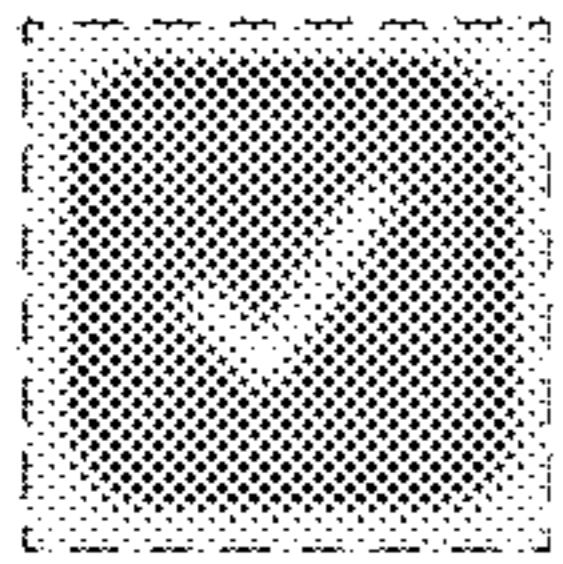

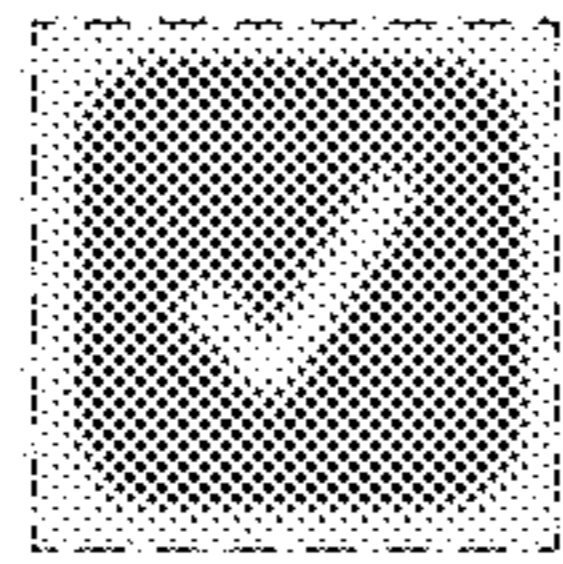

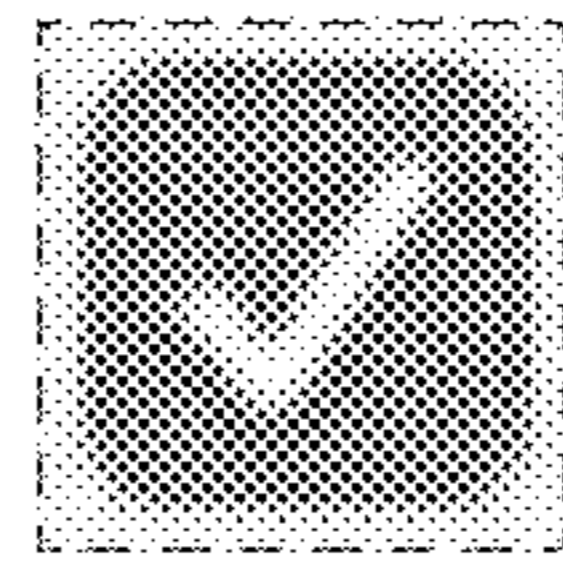
