(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 7 is an enlarged view of the portion shown in dot-dash broken lines in FIG. 3, for ease of illustration; and,

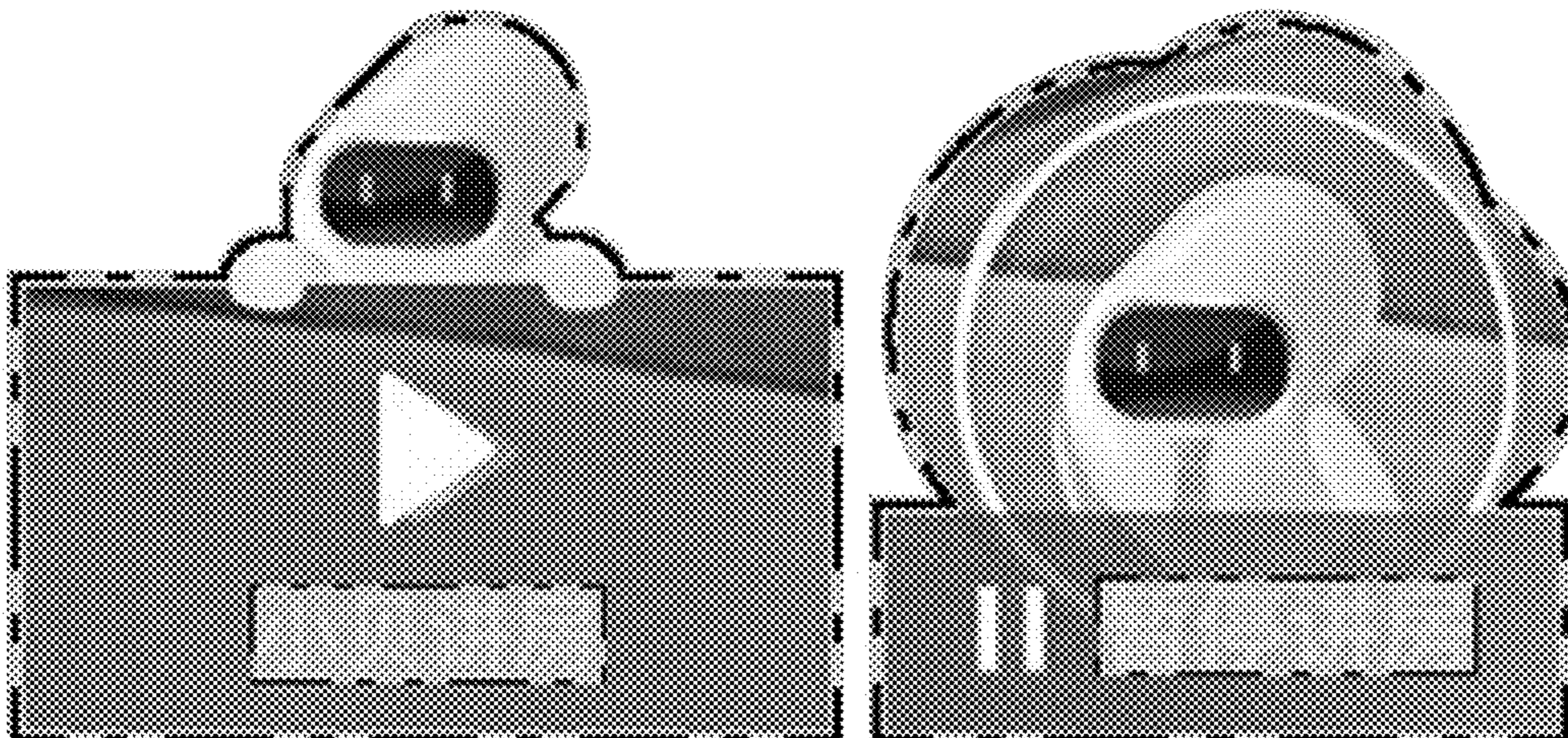
FIG. 8 is an enlarged view of the portion shown in dot-dash broken lines in FIG. 4, for ease of illustration.

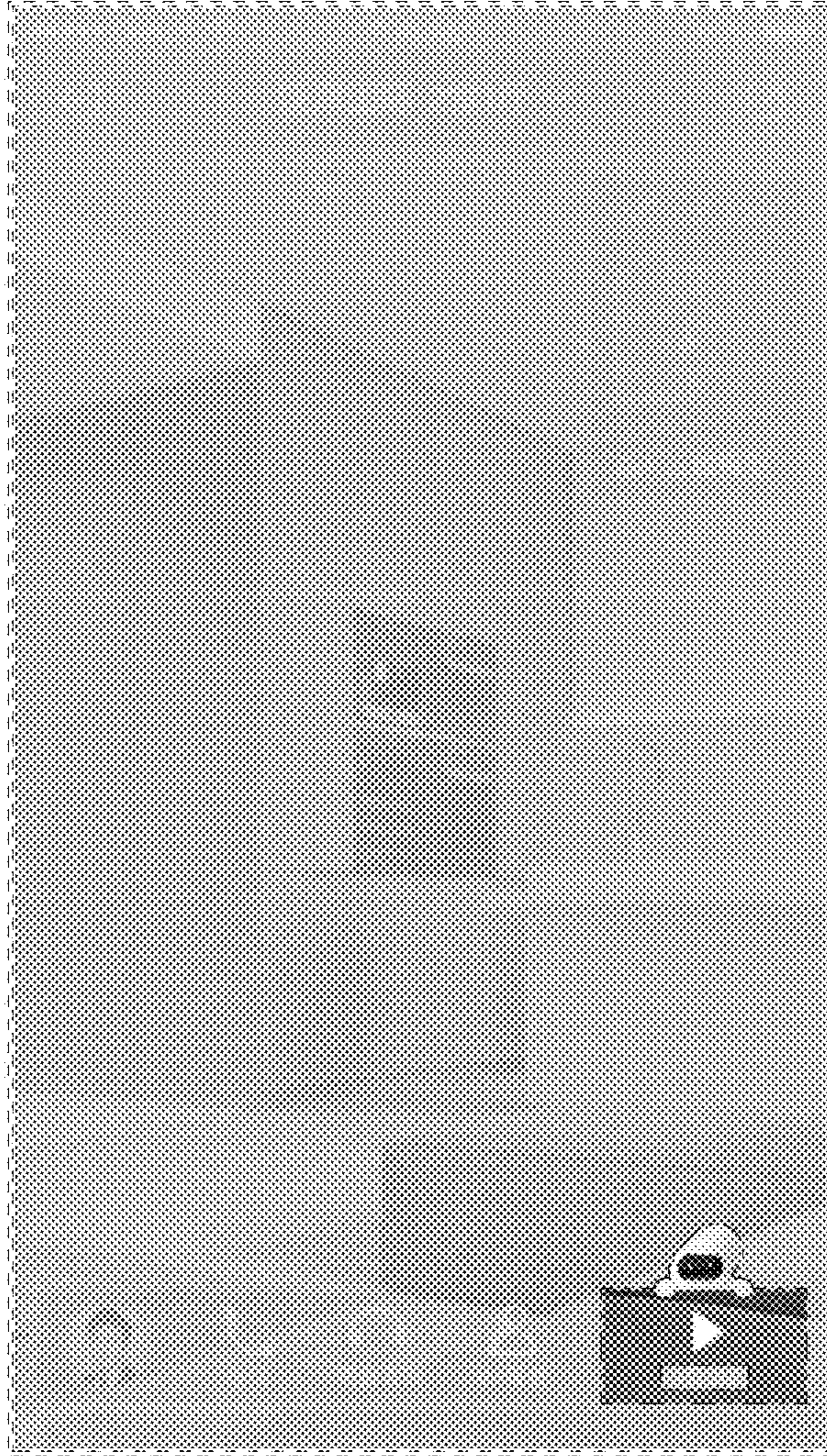

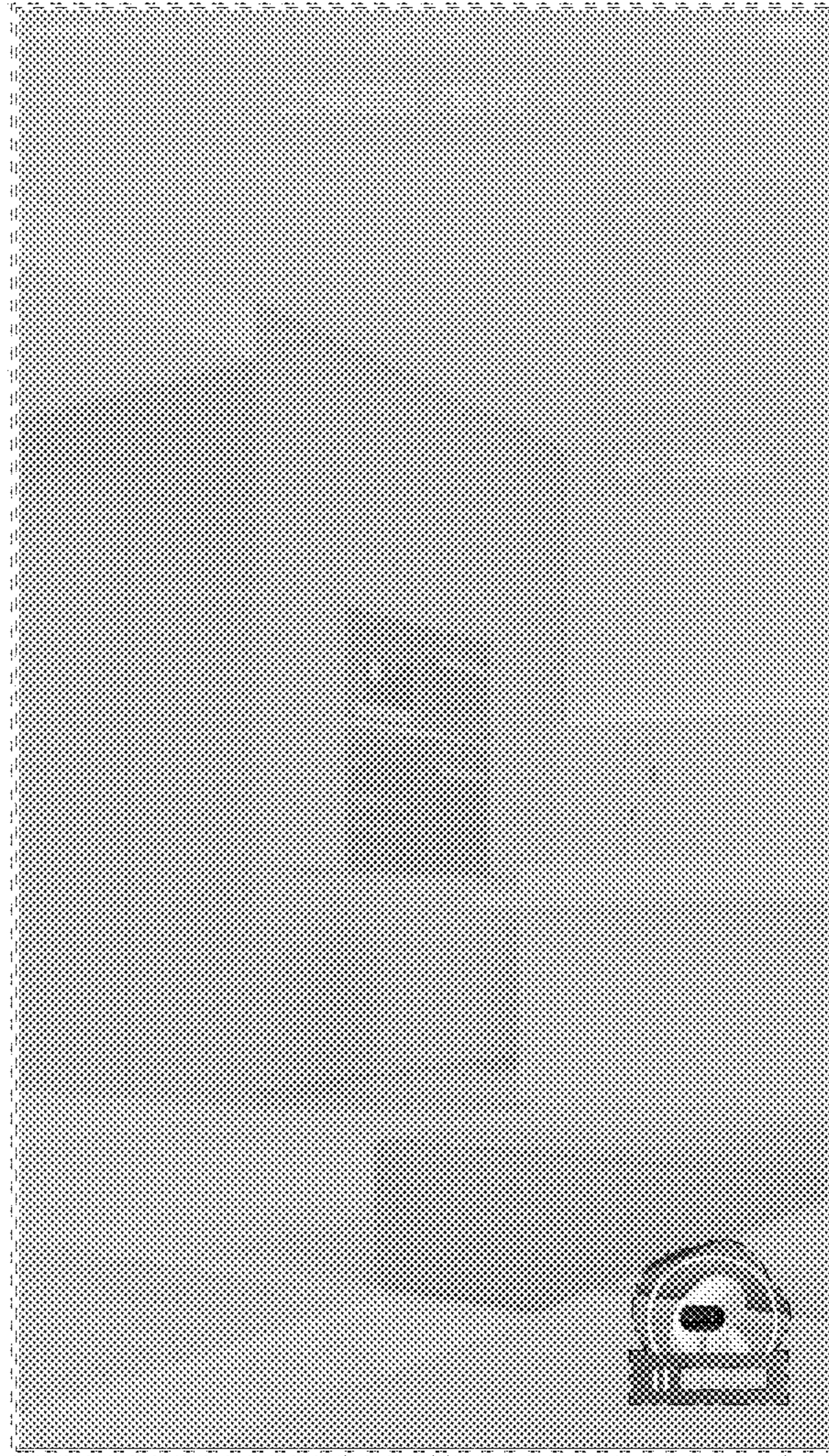

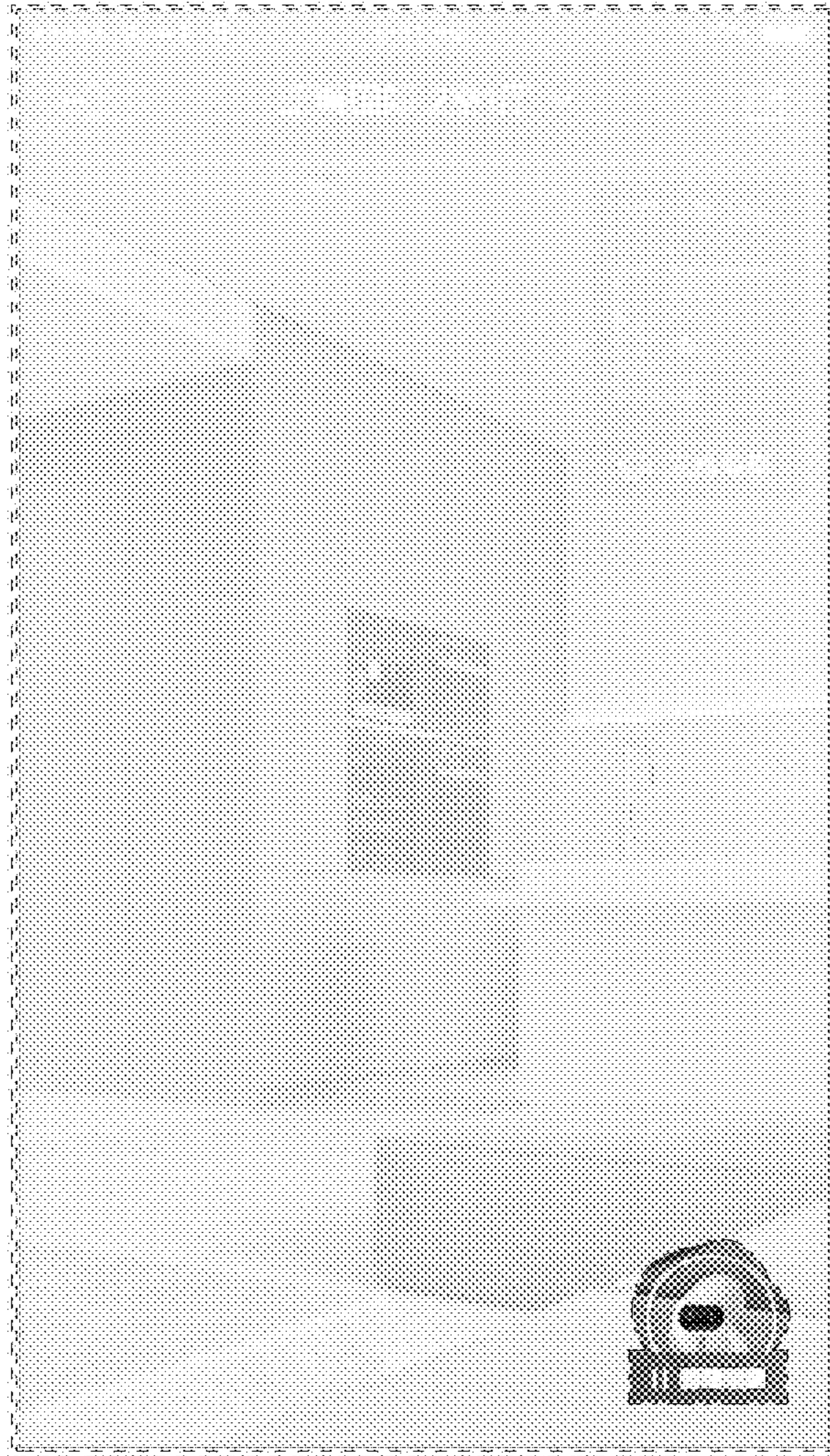

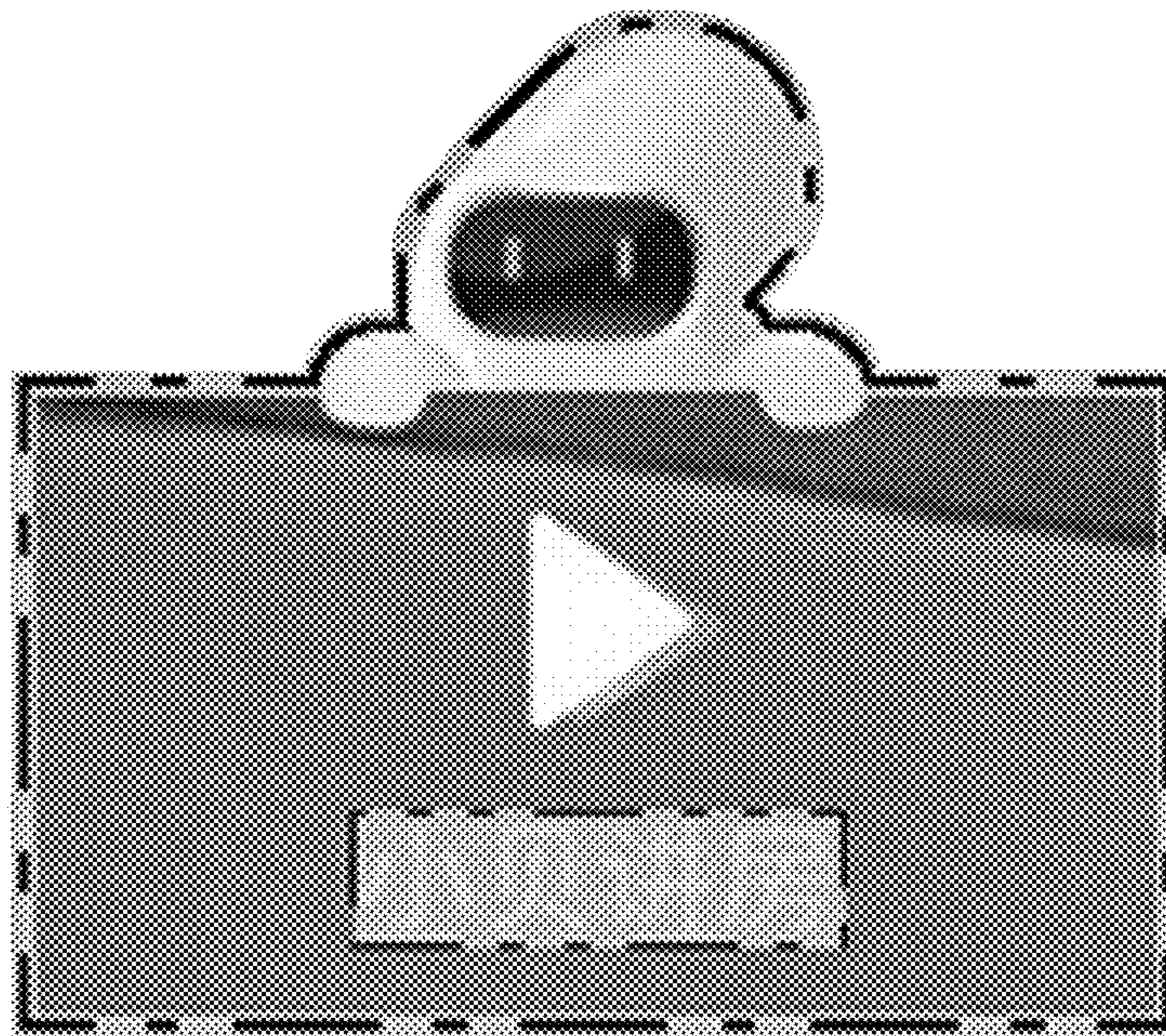

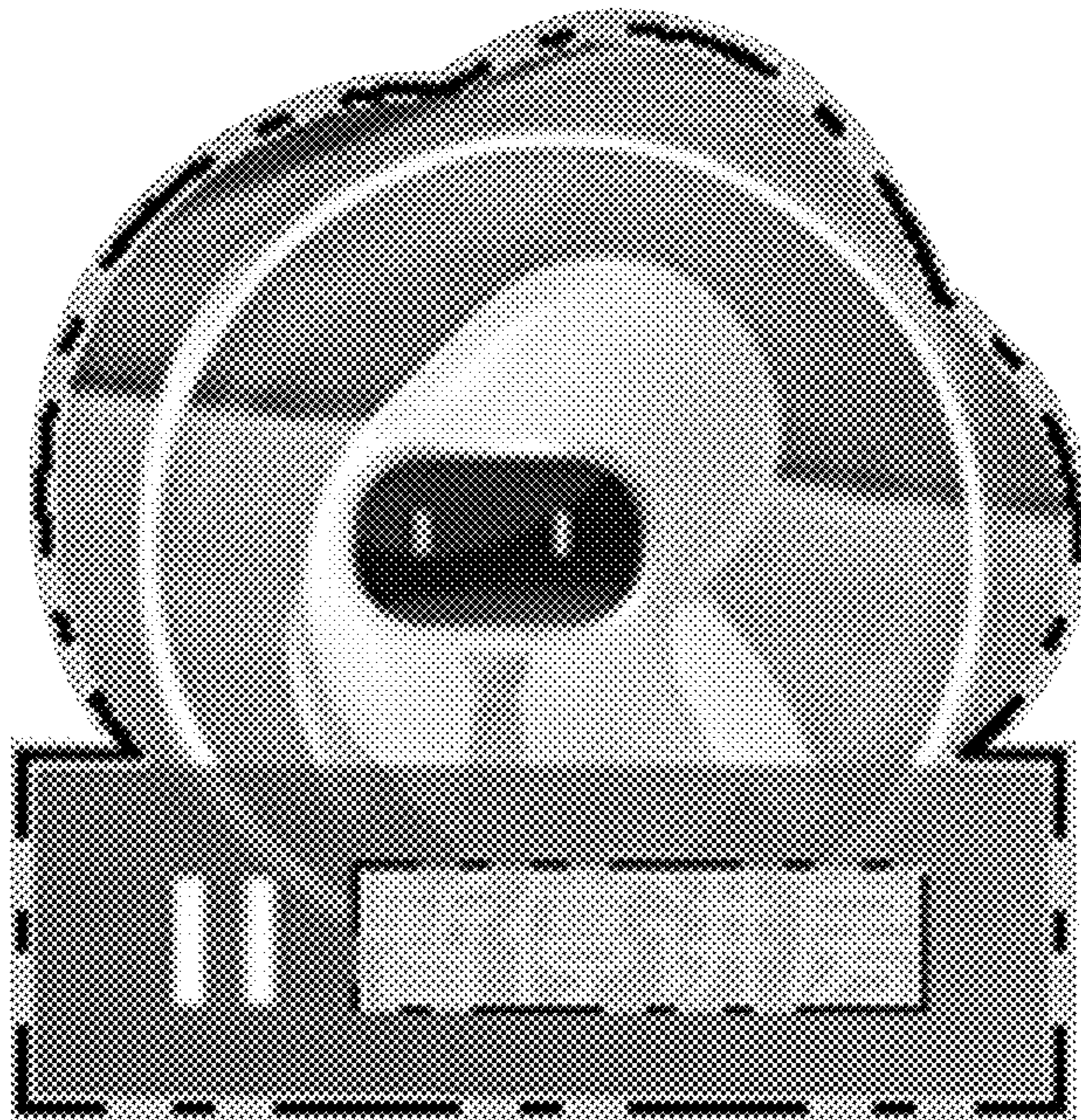

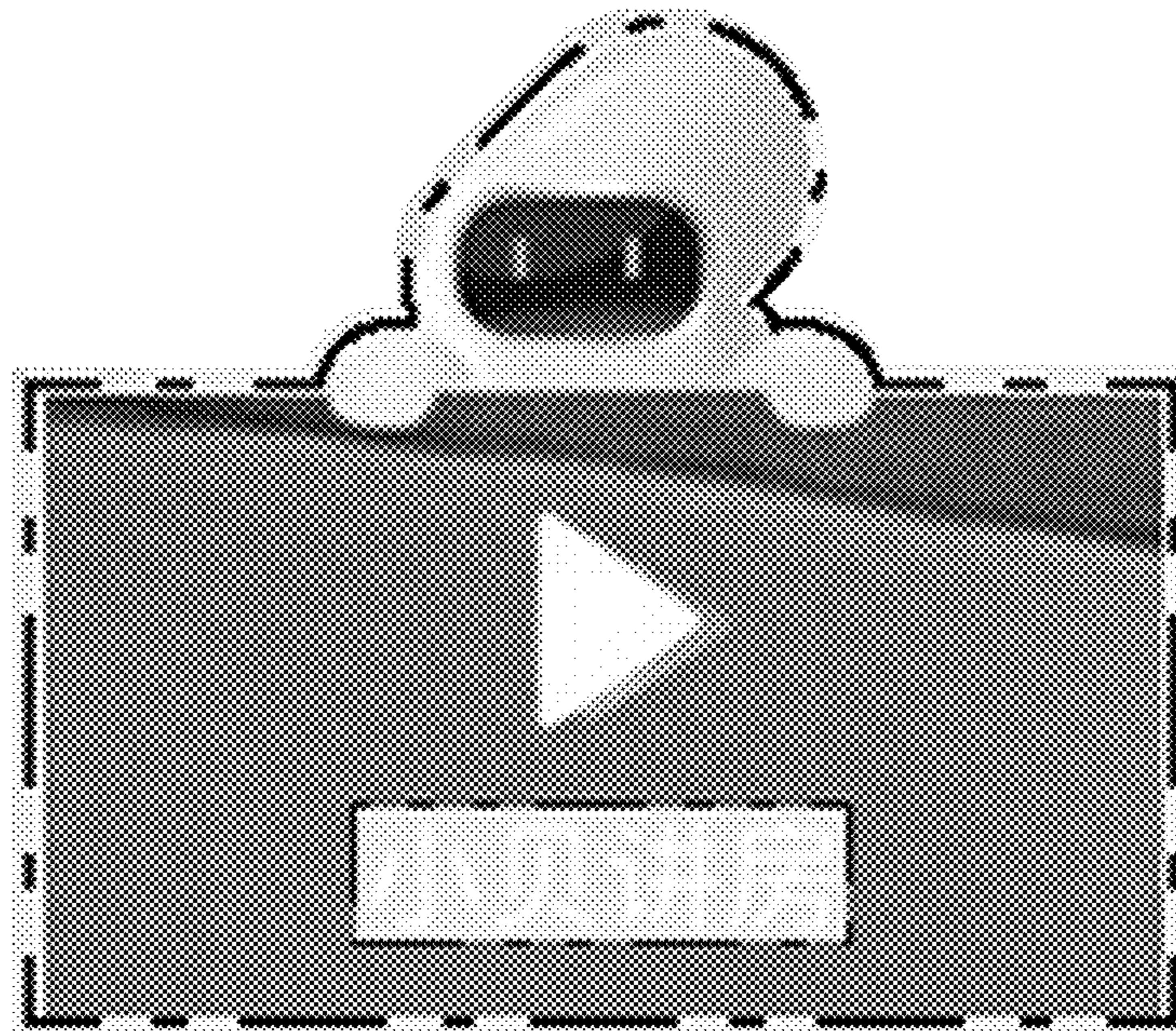
