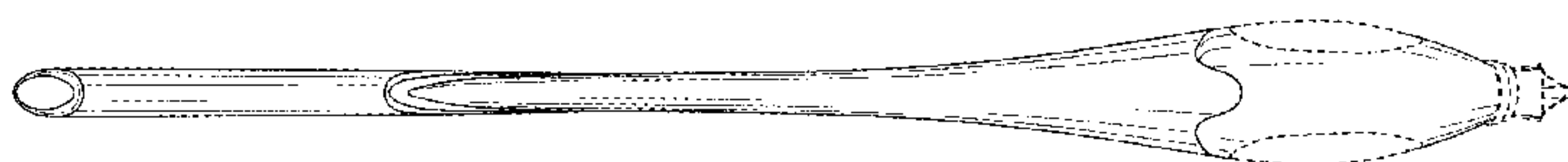
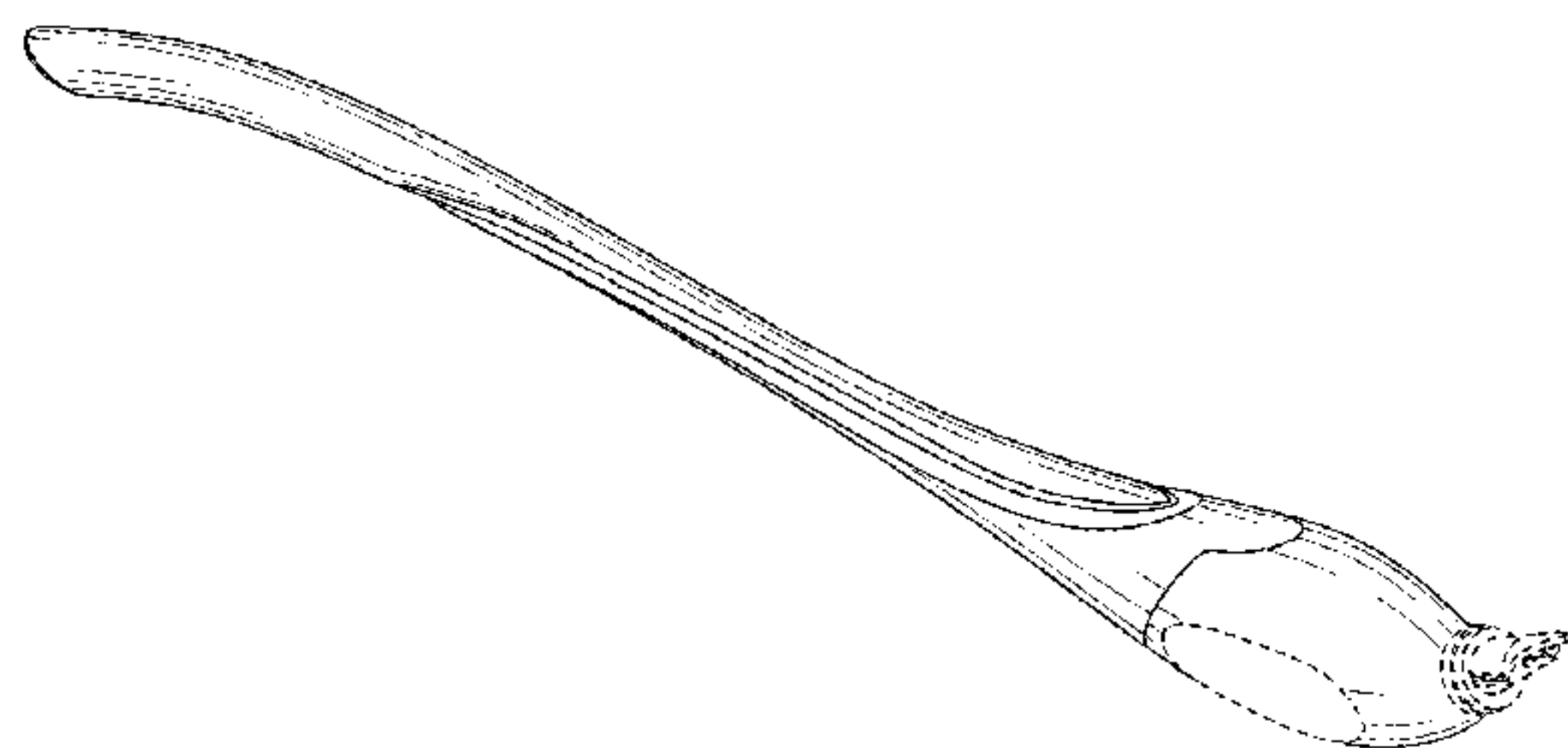
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-top perspective view of a pen showing my new design;
FIG. 2 is a front-bottom perspective view thereof;
FIG. 3 is a rear-top perspective view thereof;
FIG. 4 is a rear-bottom perspective view thereof;
FIG. 5 is a front elevational view thereof, where the rear elevational view is mirrored thereto;
FIG. 6 is an enlarged left elevational view thereof;
FIG. 7 is an enlarged right elevational view thereof;
FIG. 8 is a top plan view thereof; and,
FIG. 9 is a bottom plan view thereof.

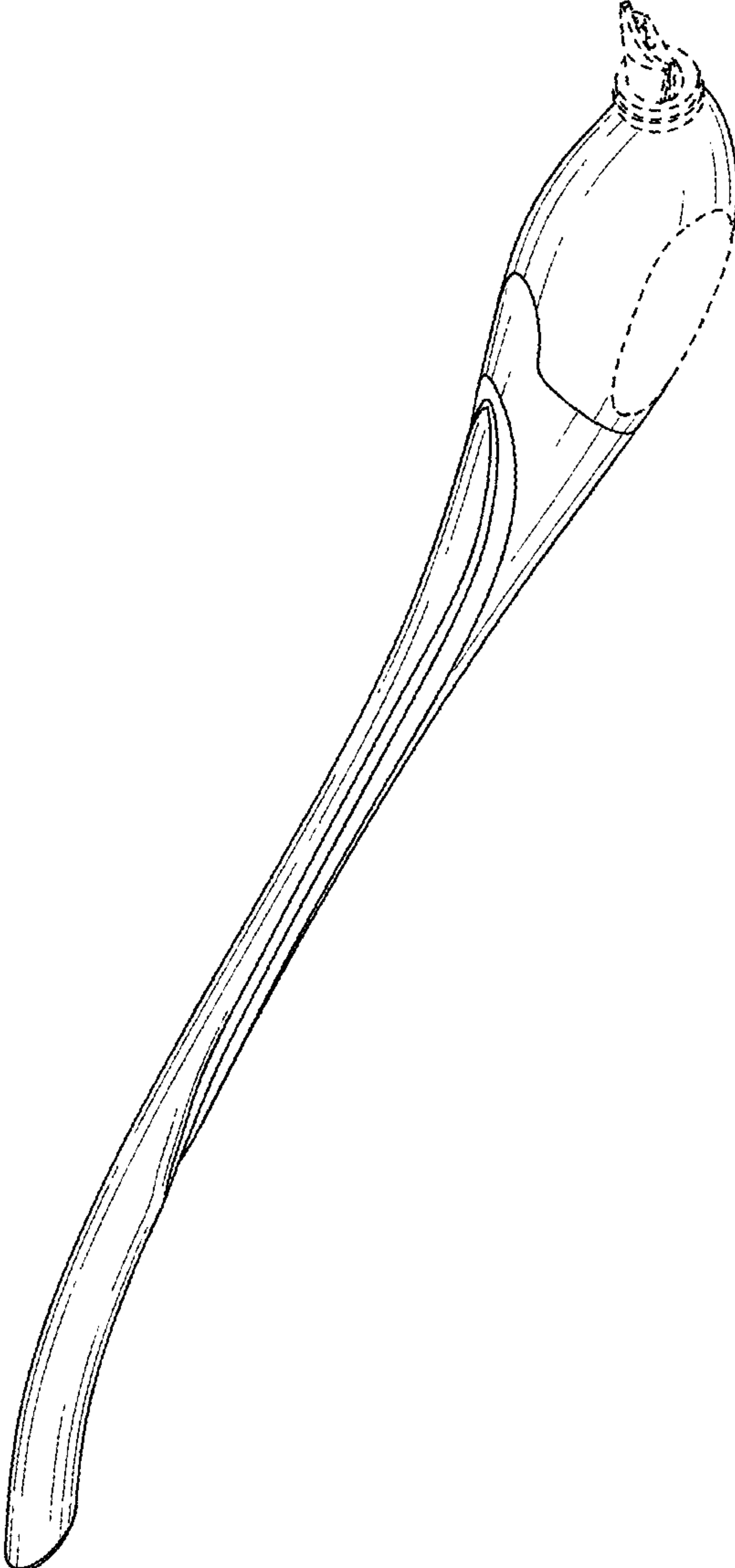

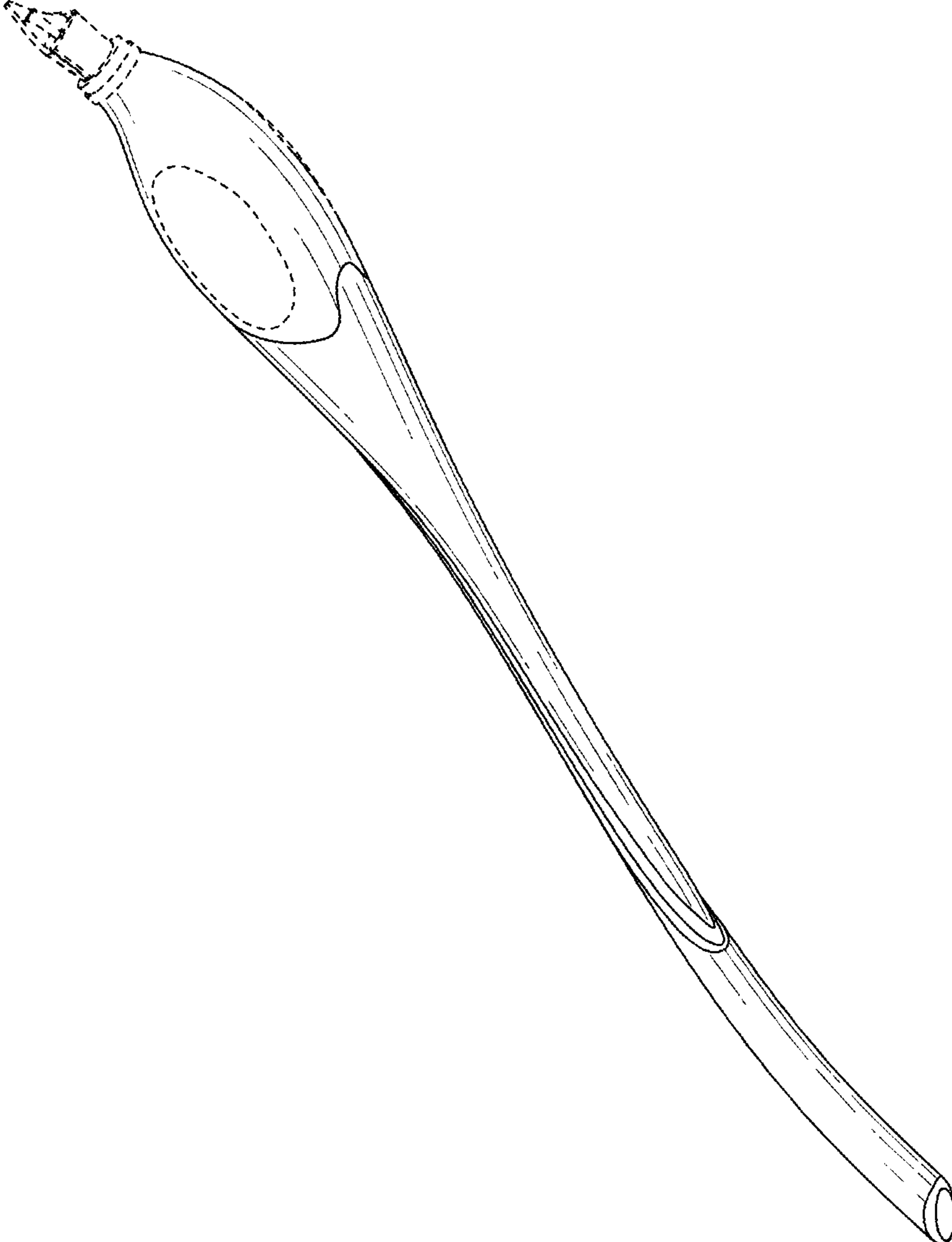

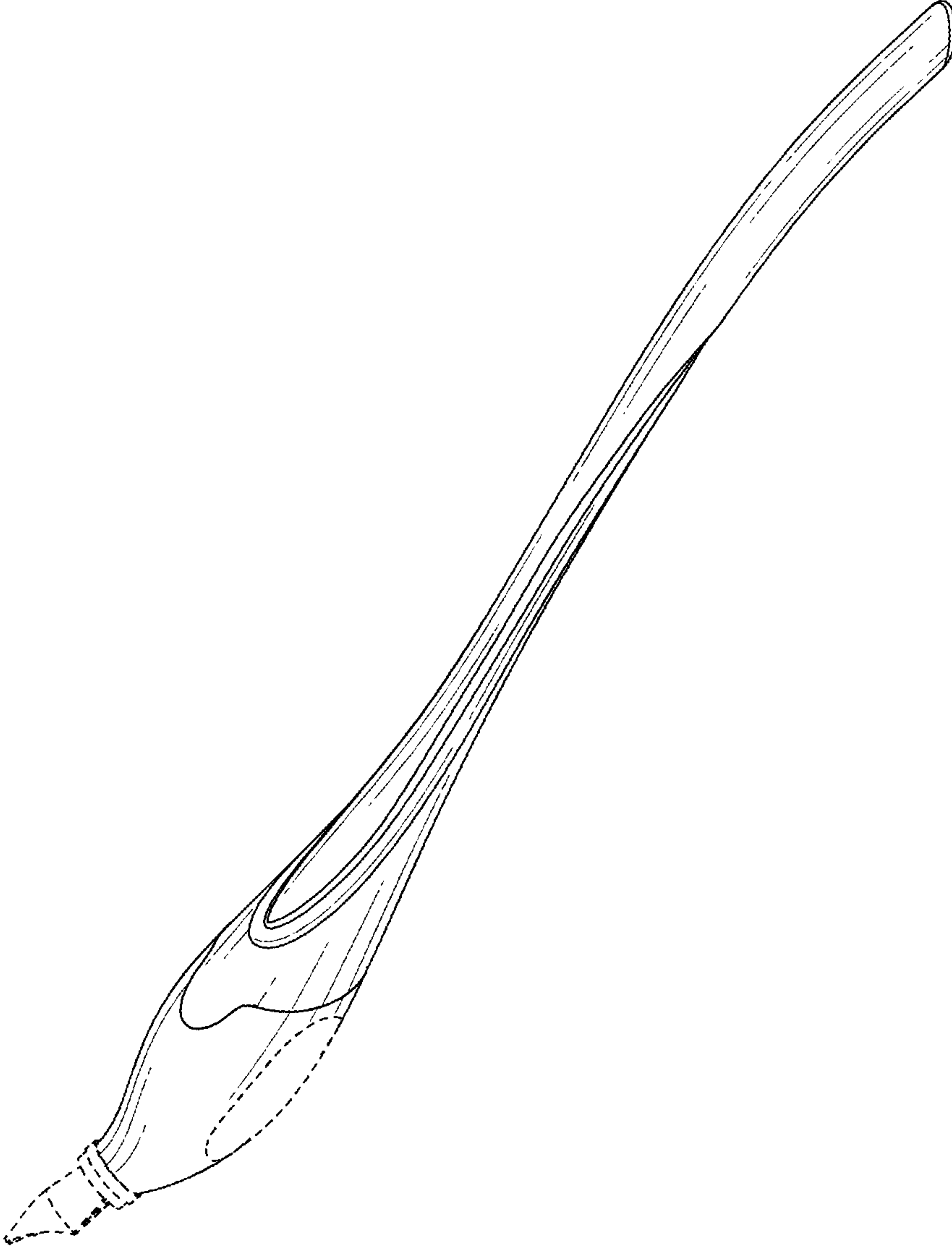

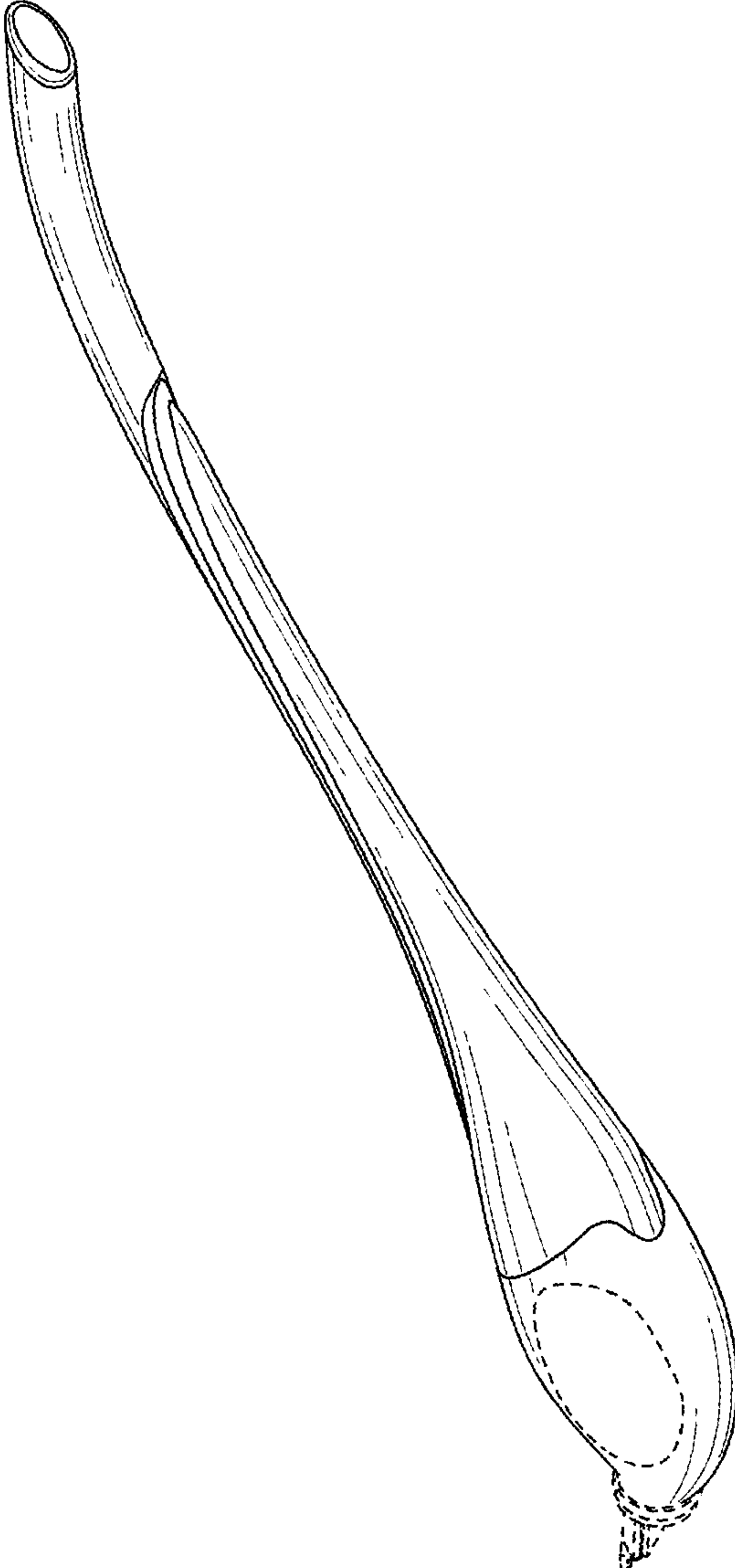

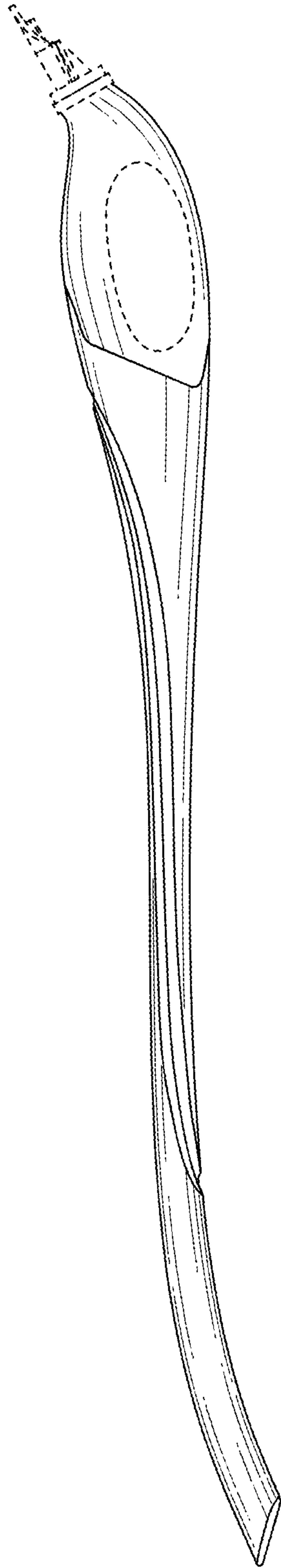

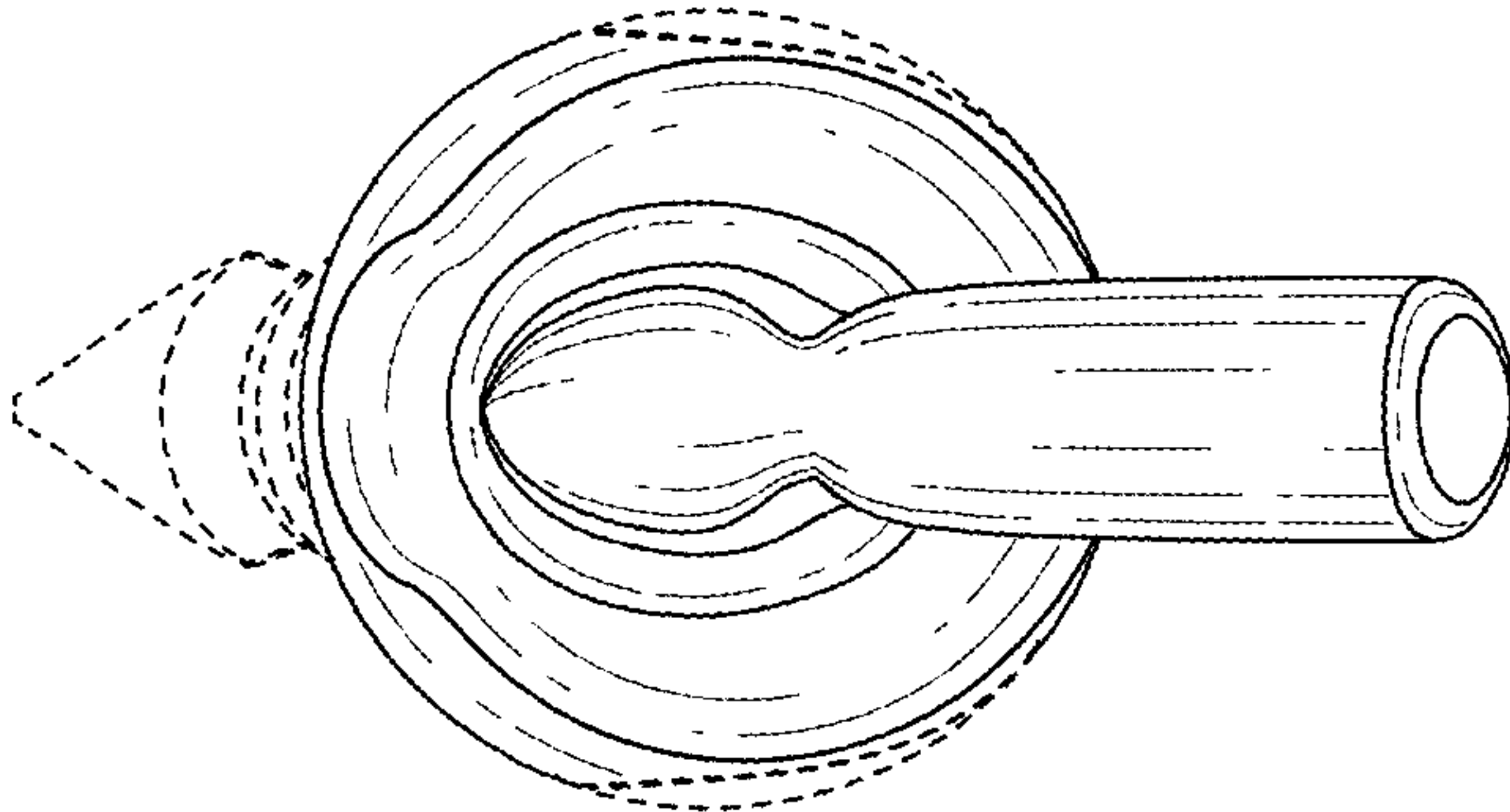

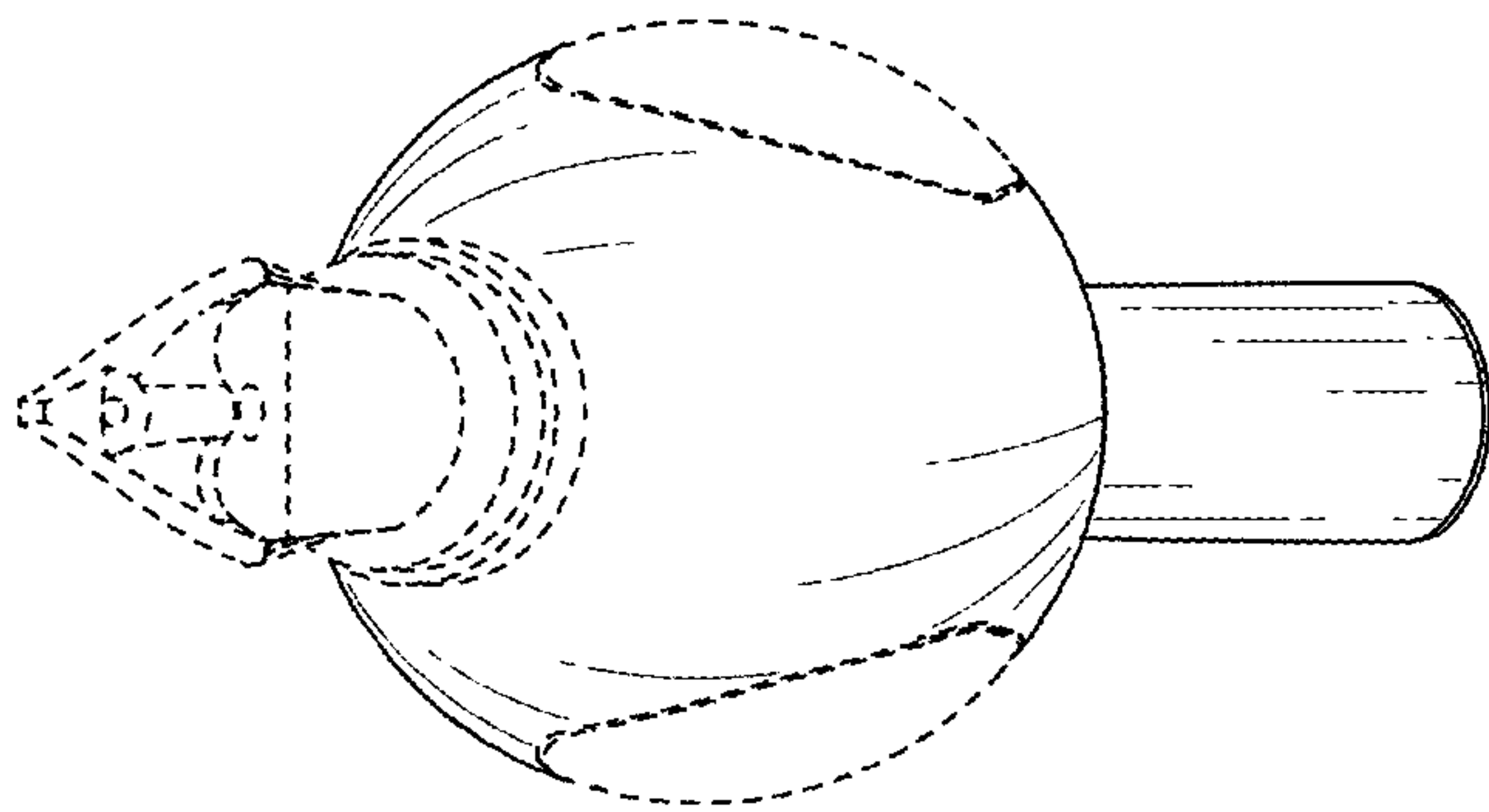

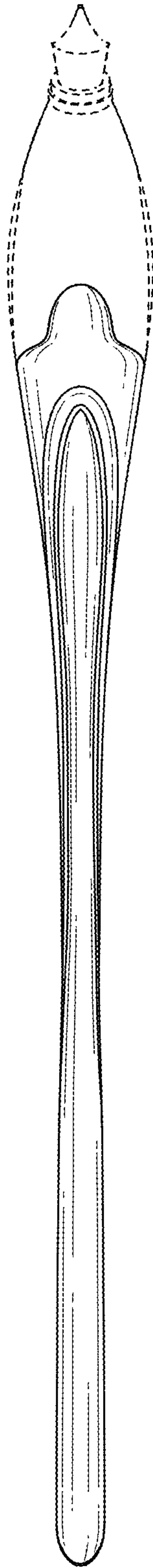

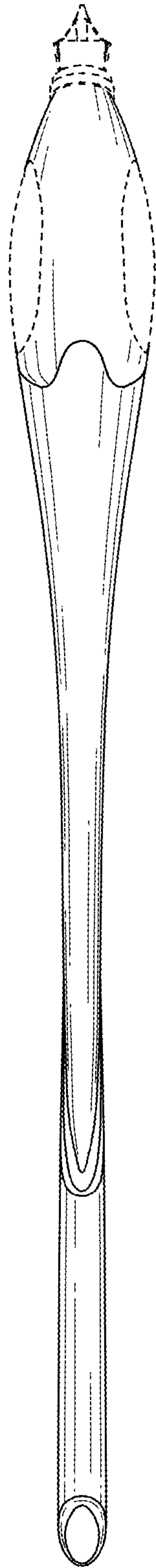
