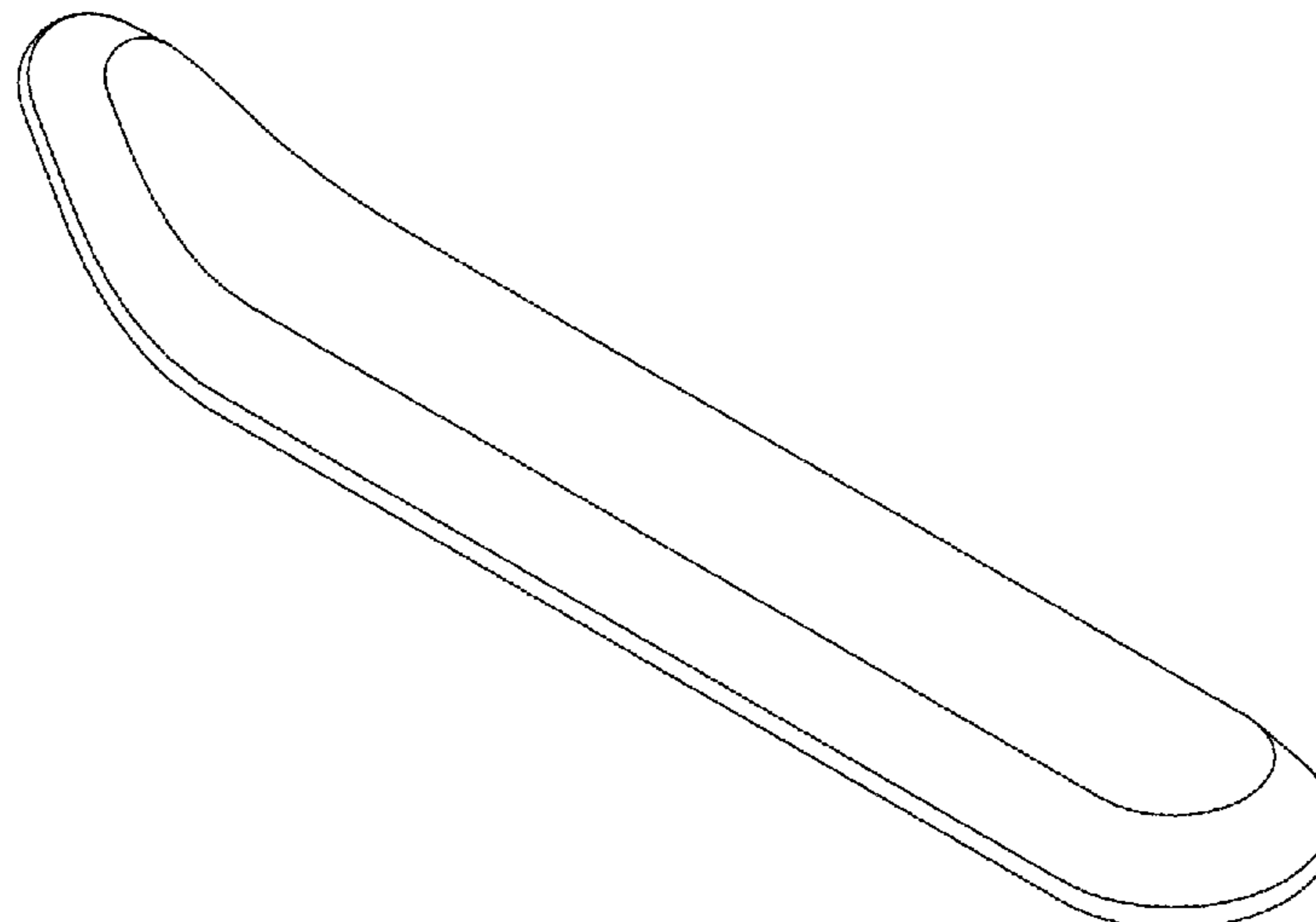
The ornamental design for a cosmetic skin care device, as shown and described.

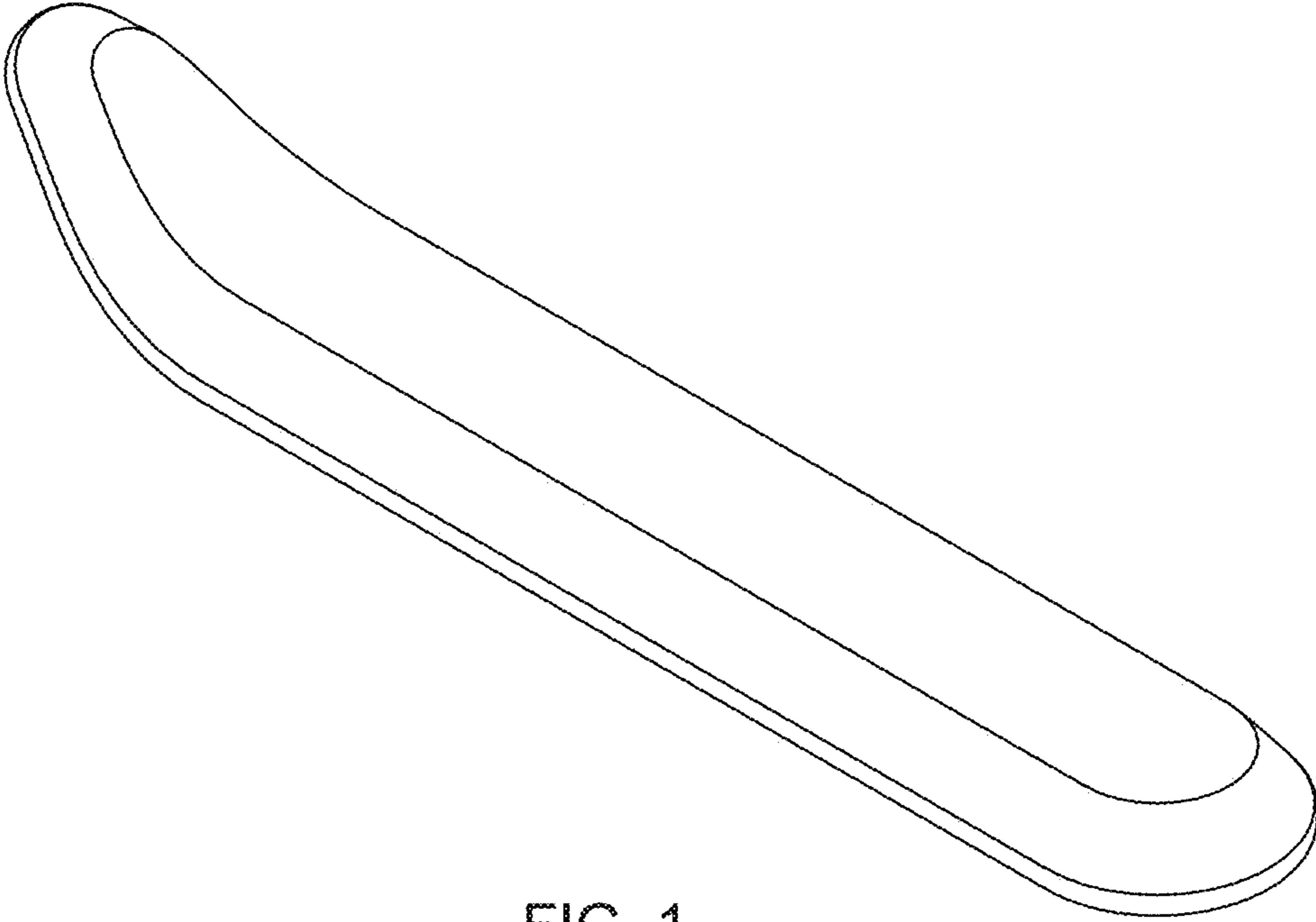

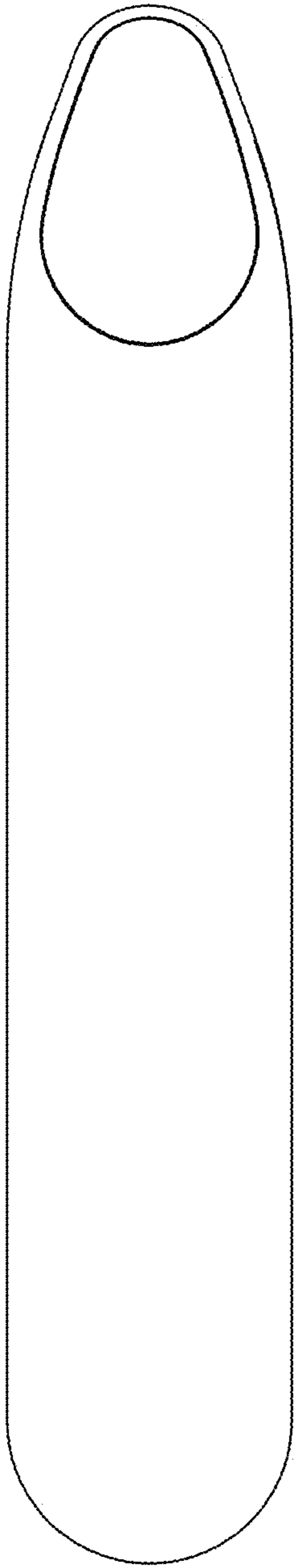

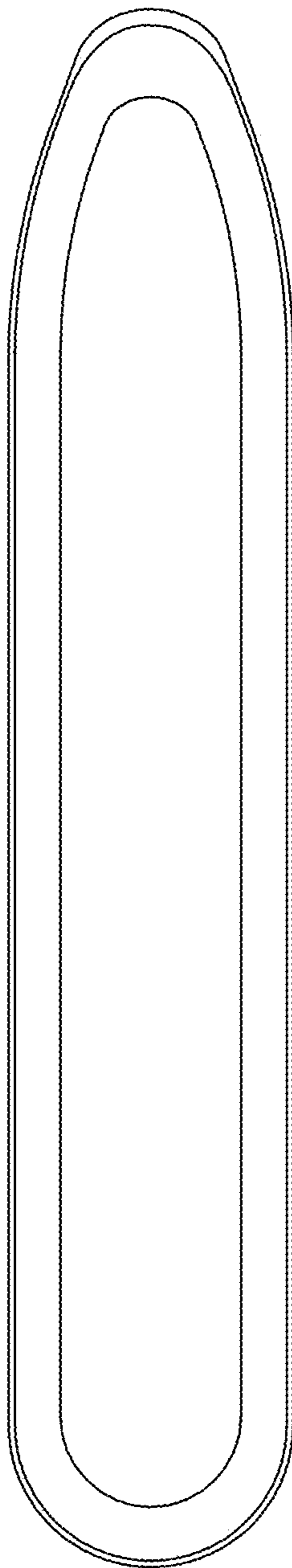

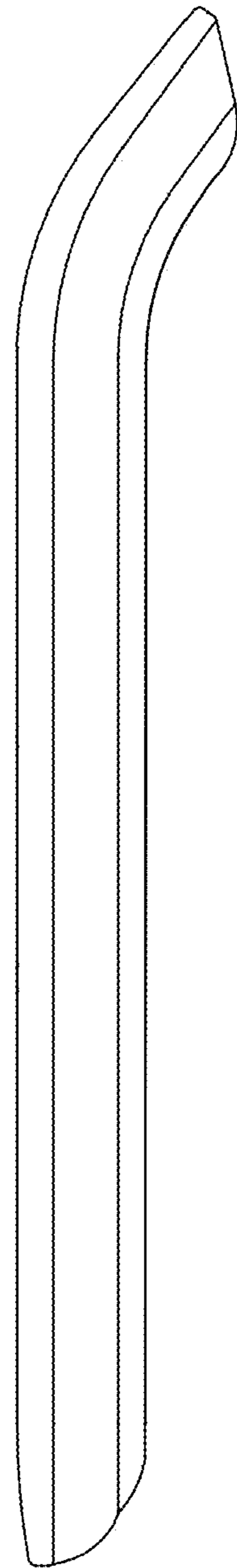

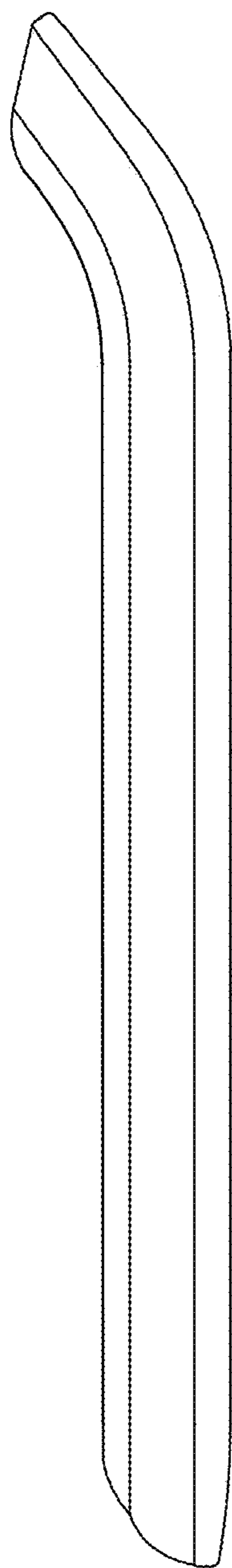

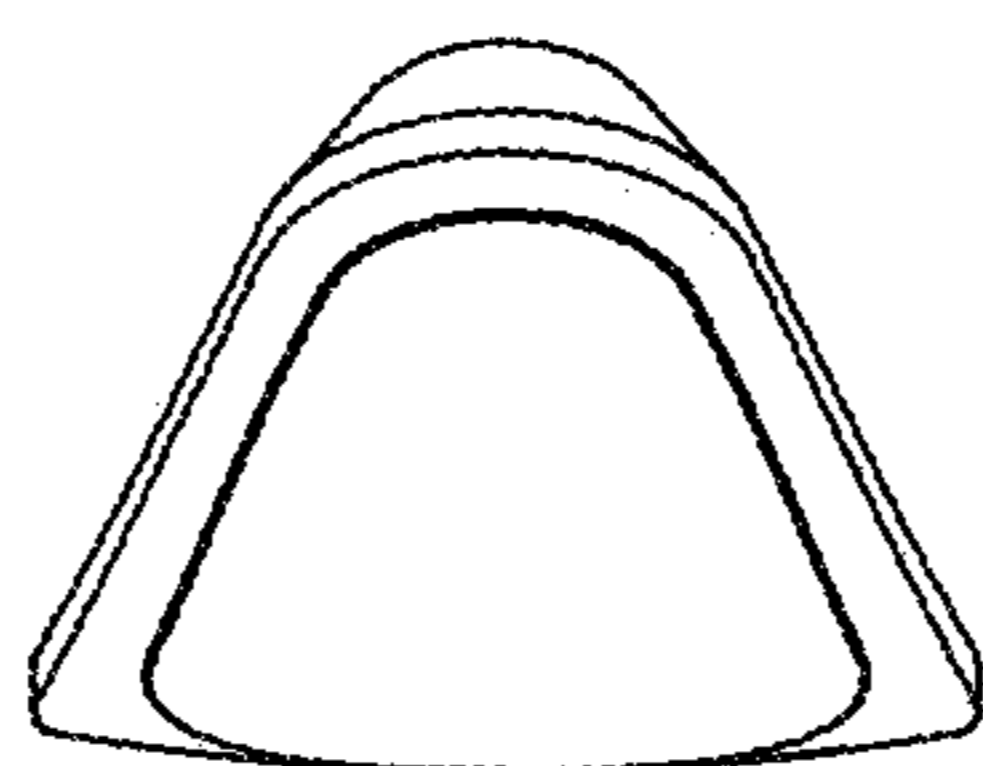

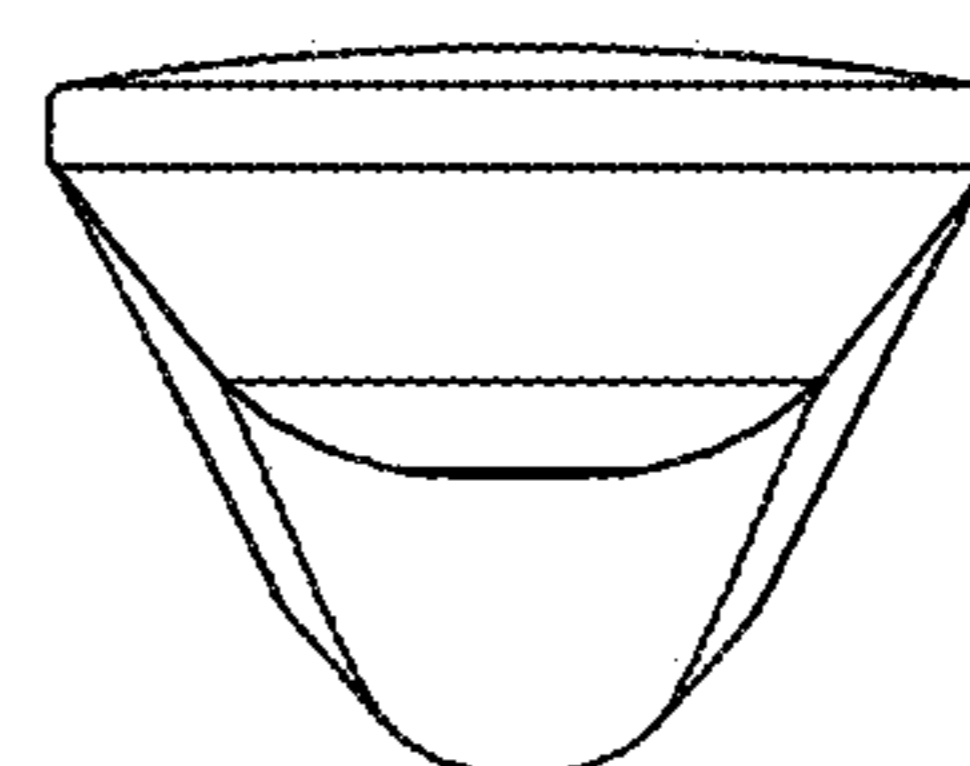

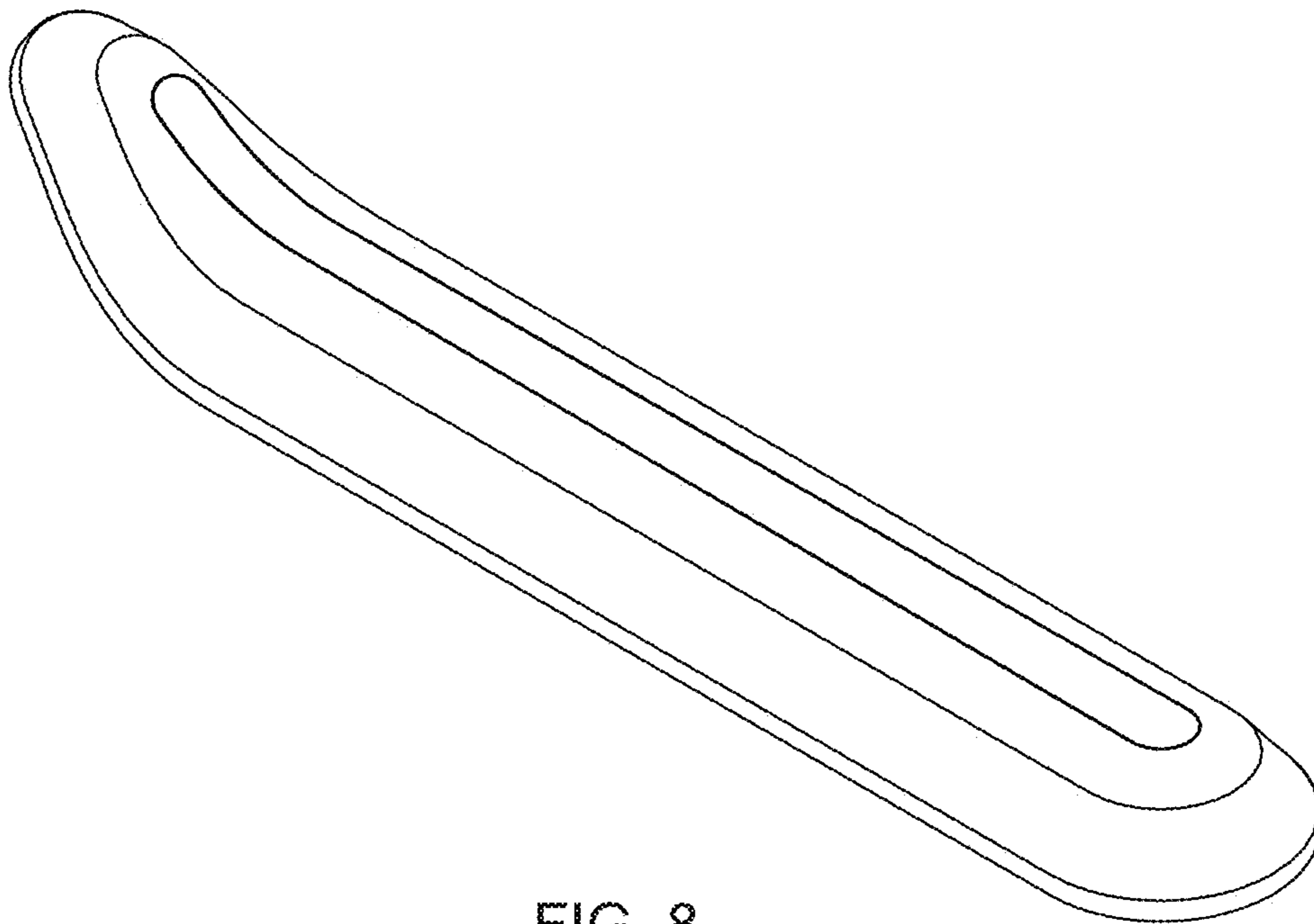

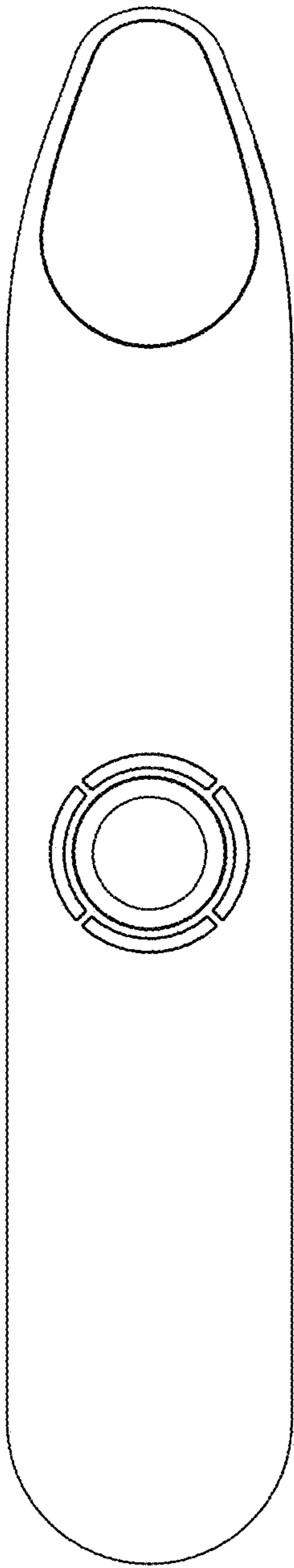

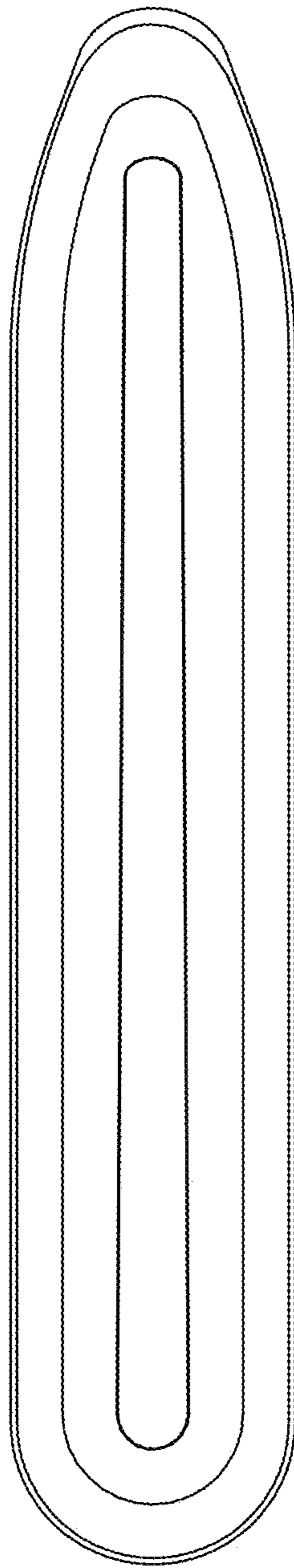

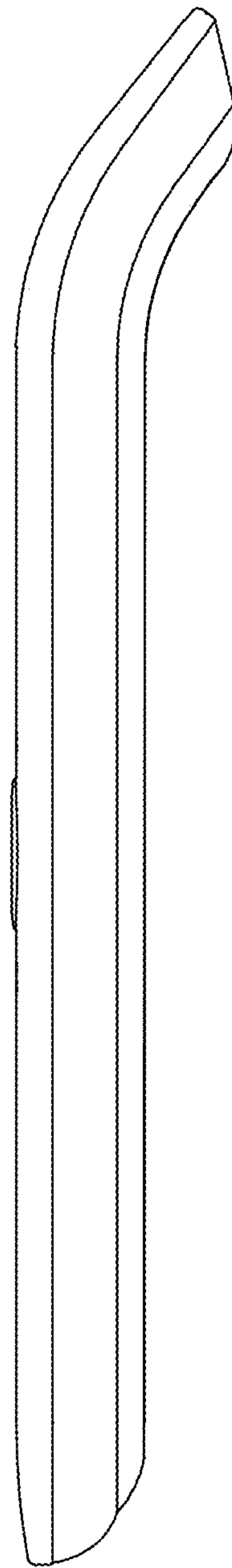

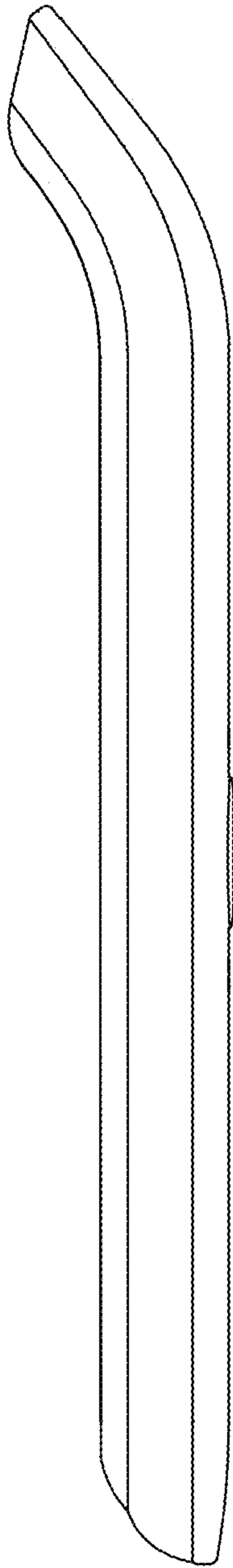

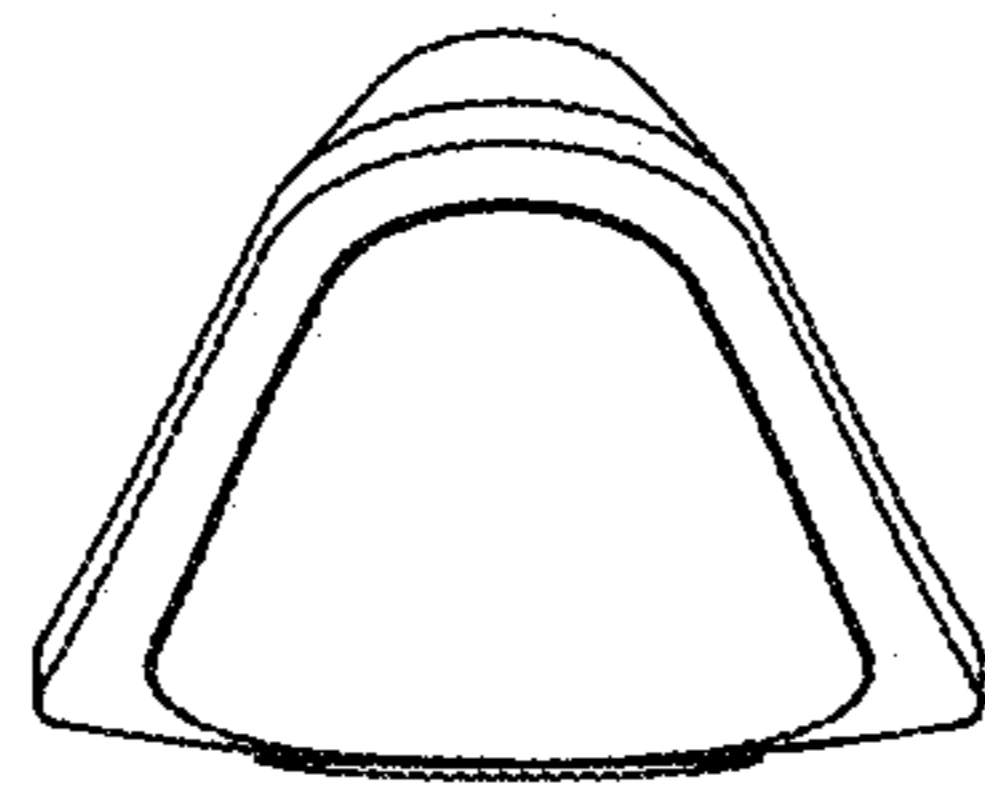

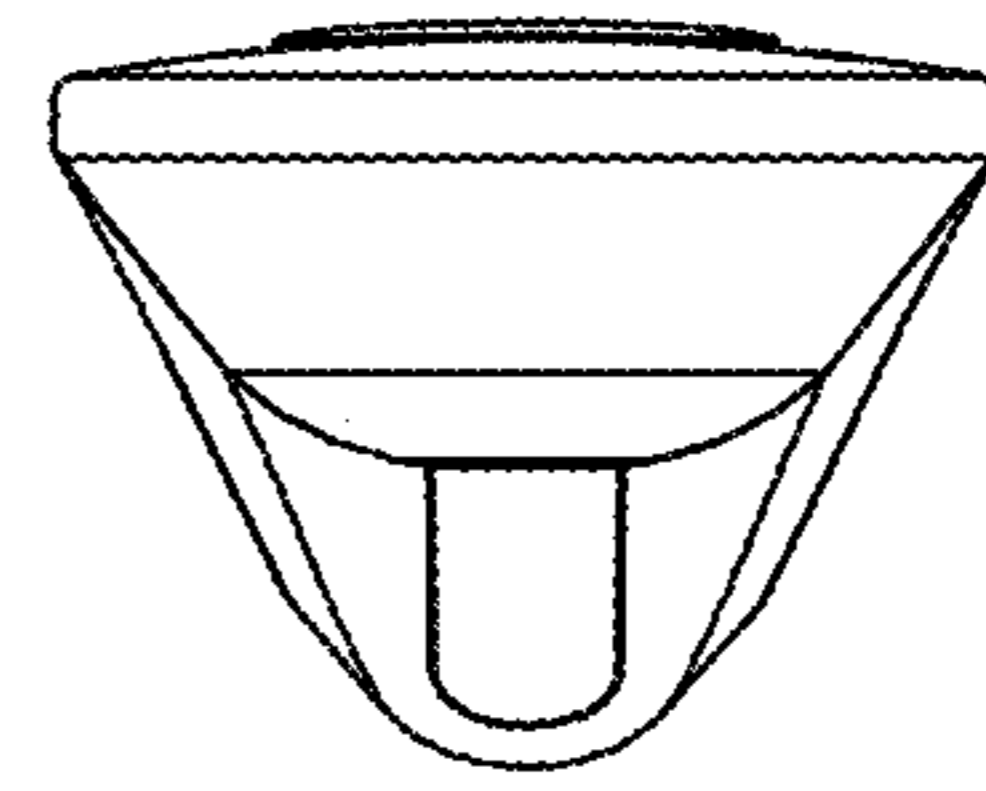

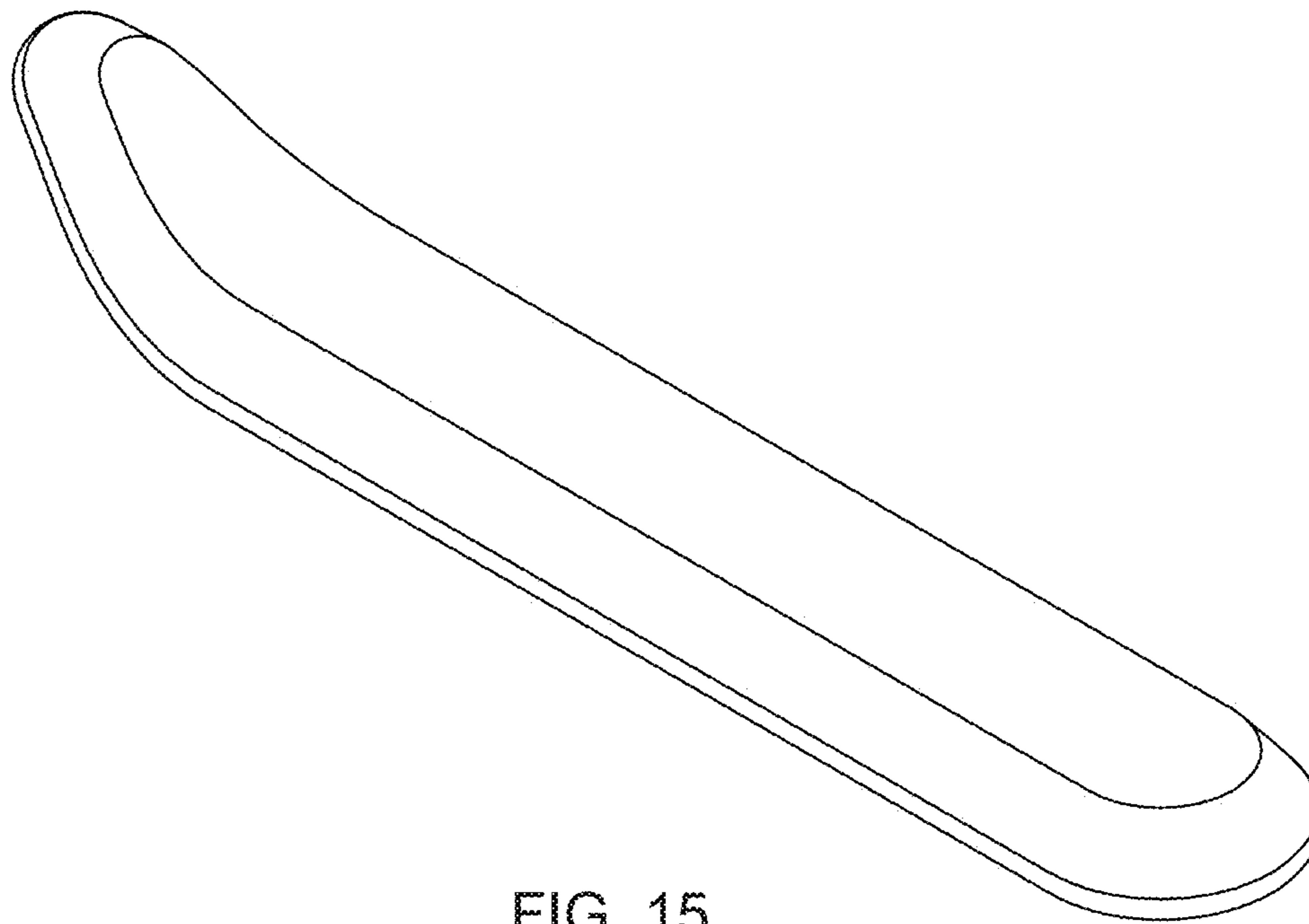

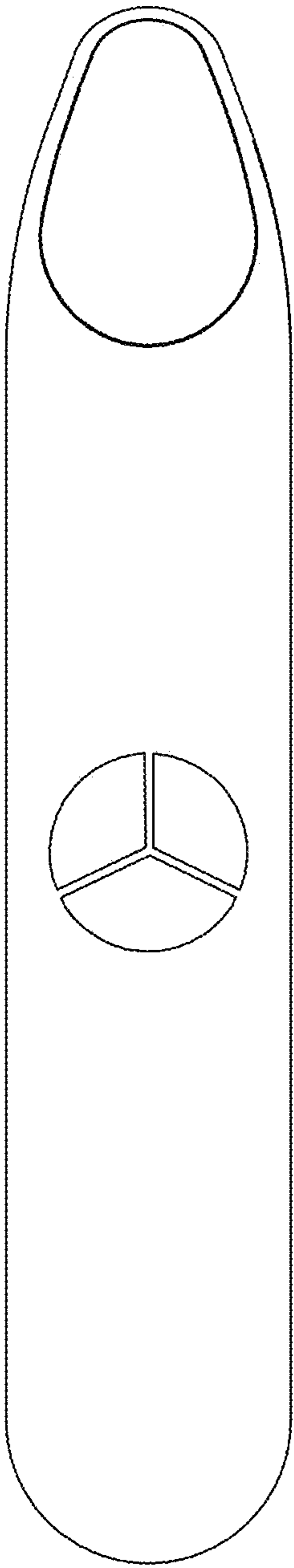

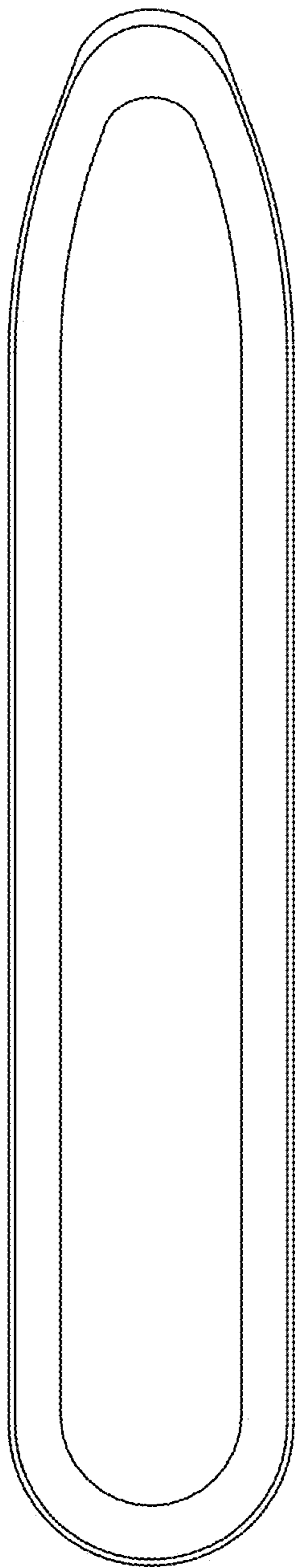

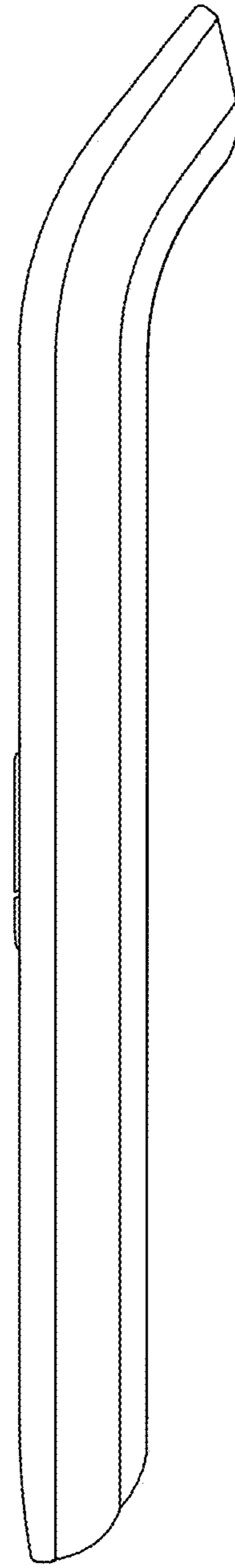

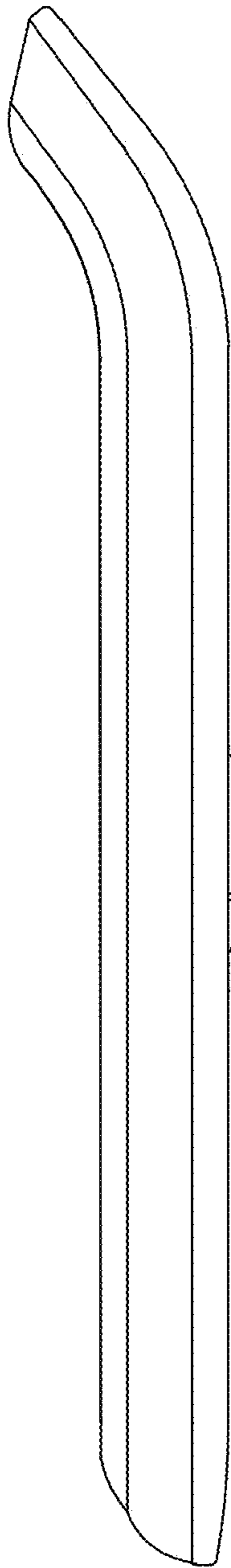

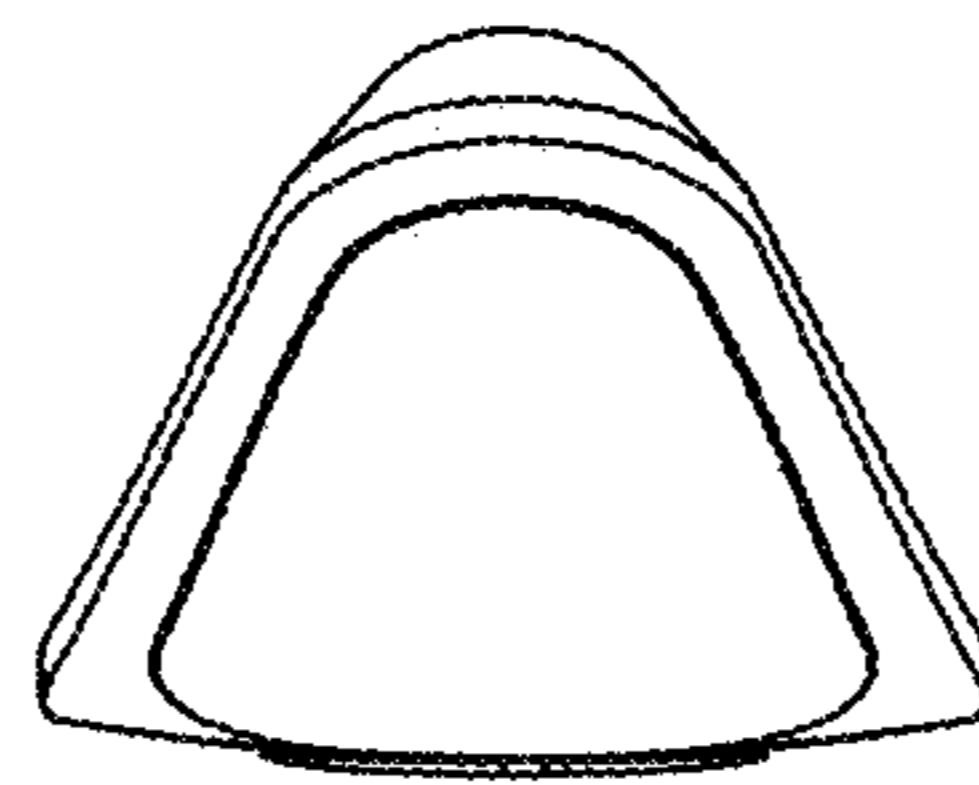

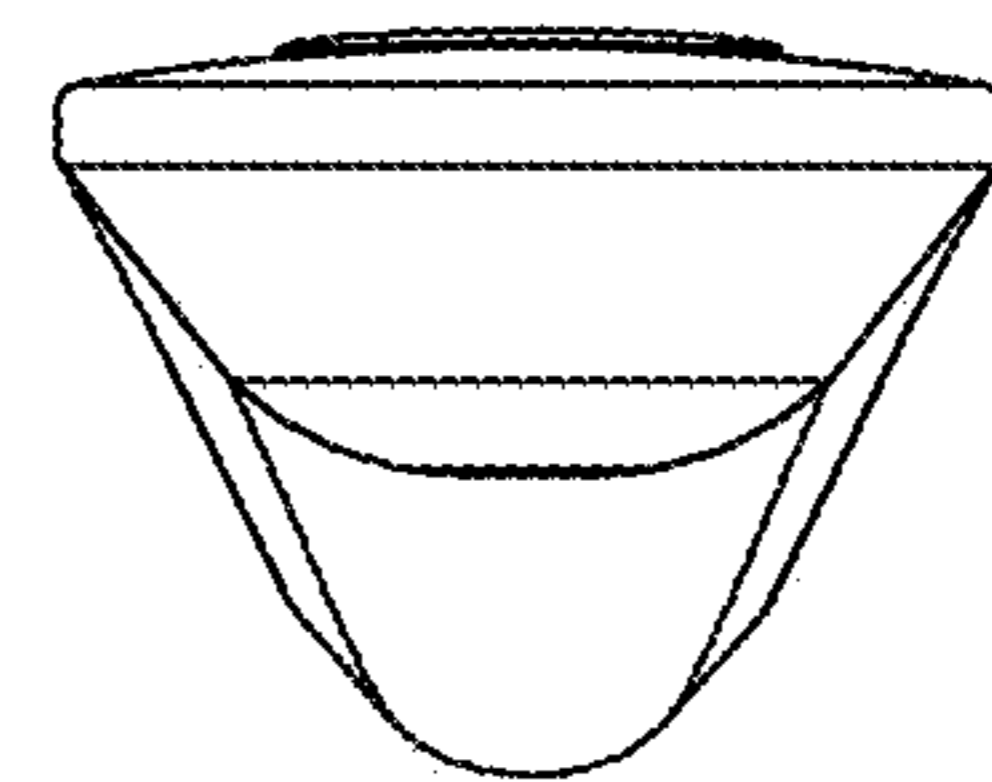

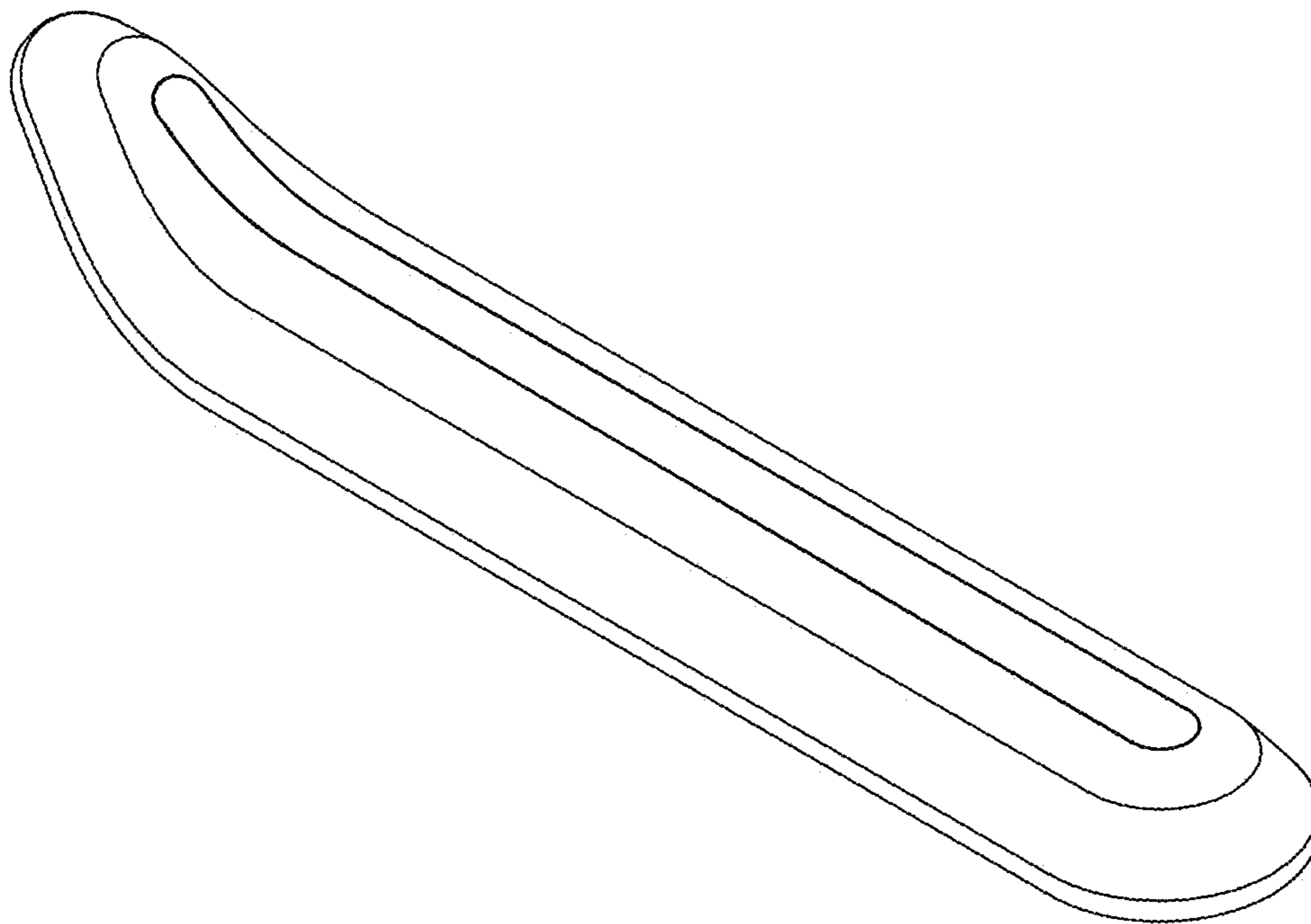

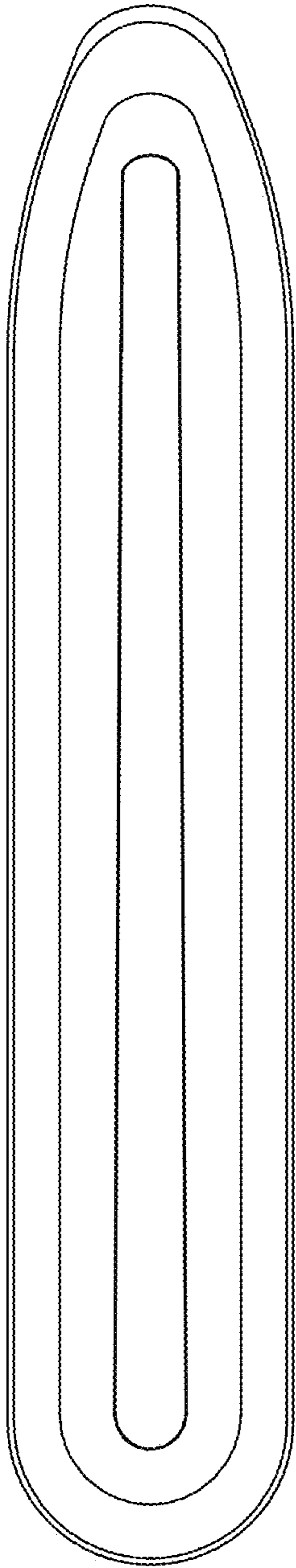

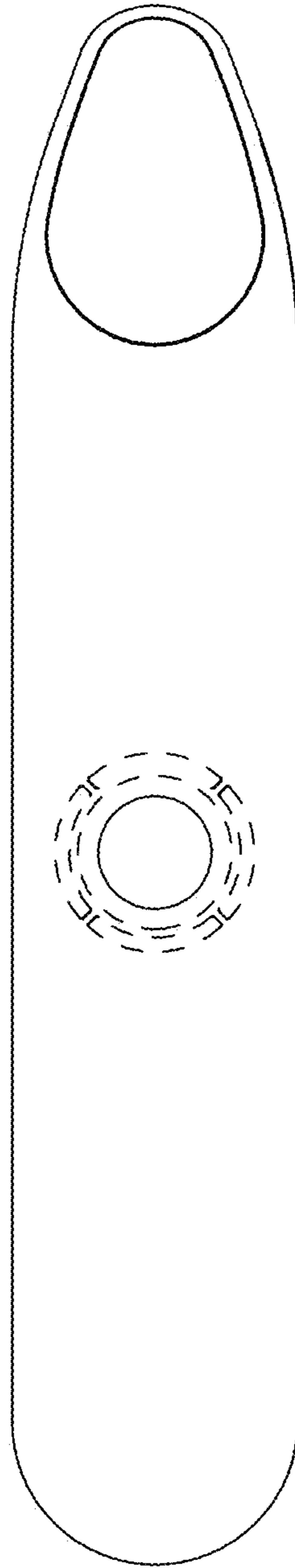

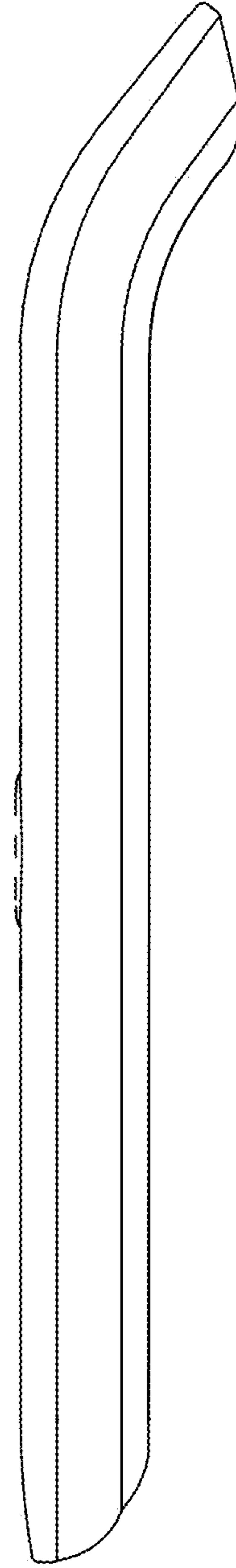

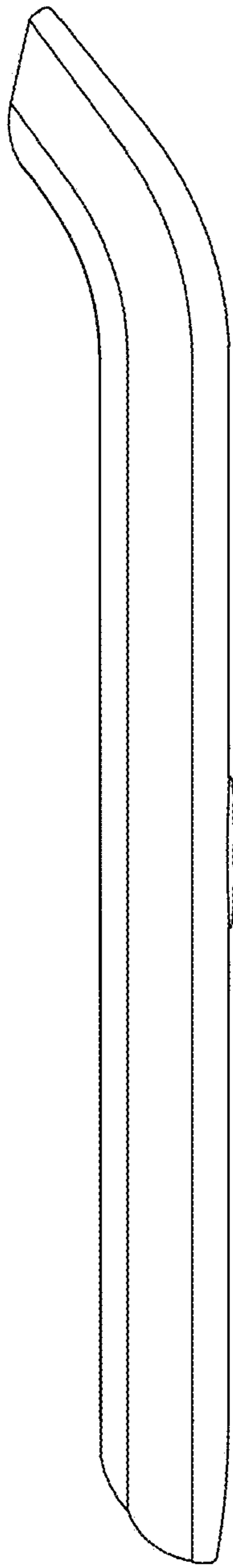

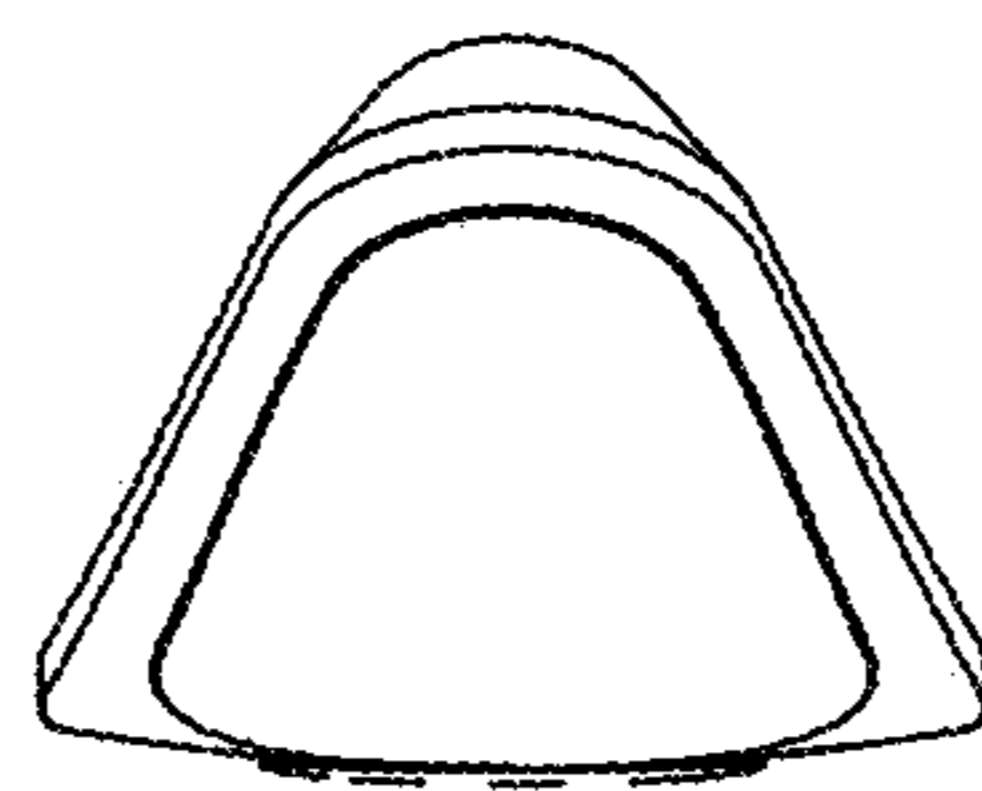

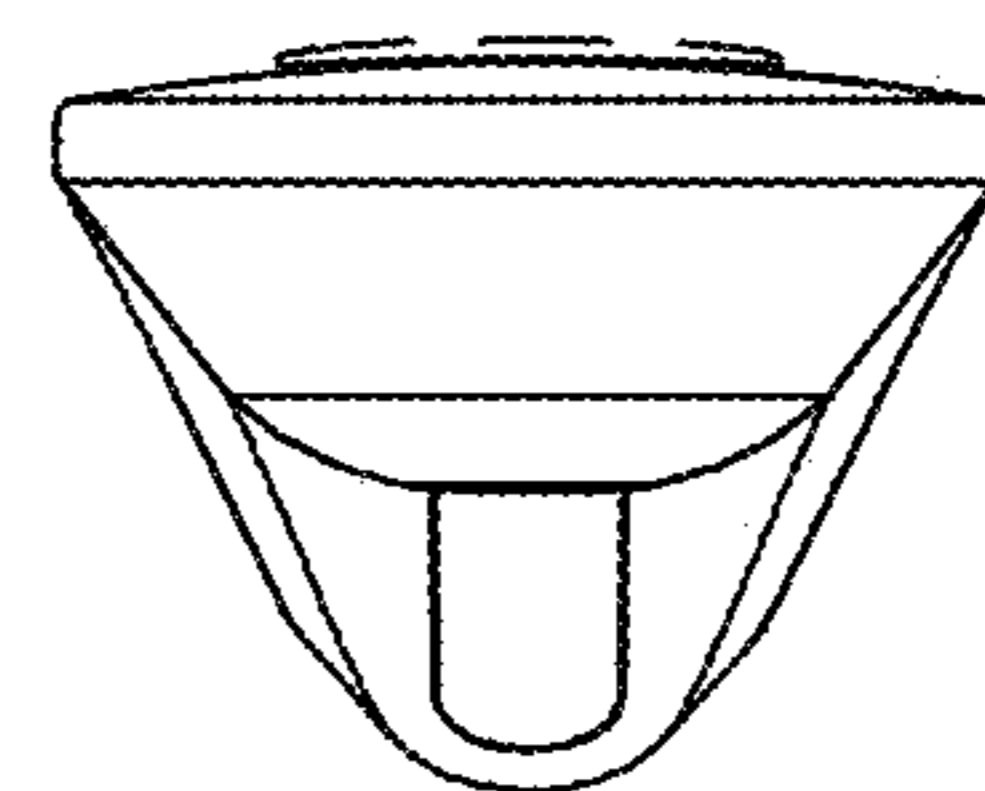

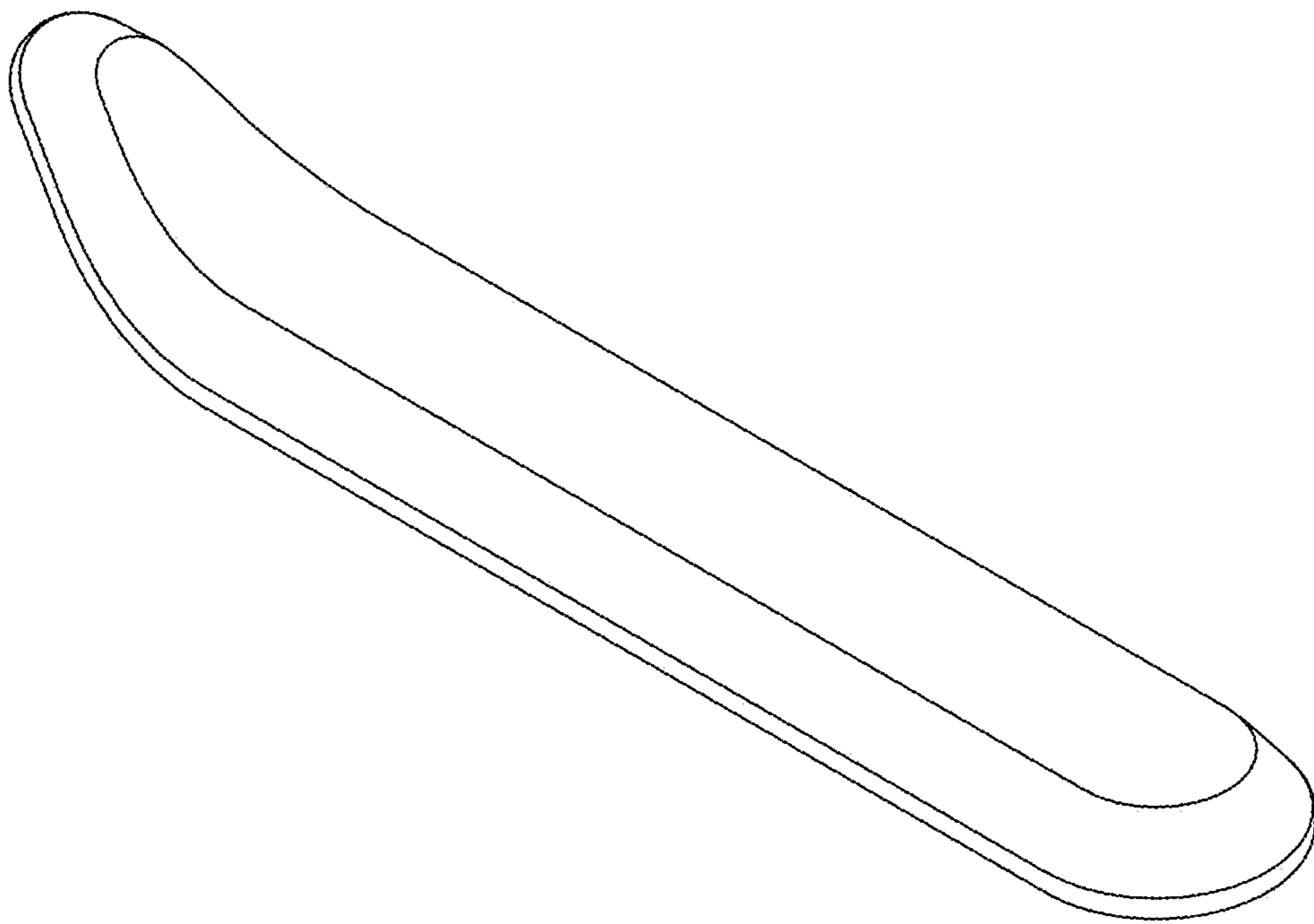

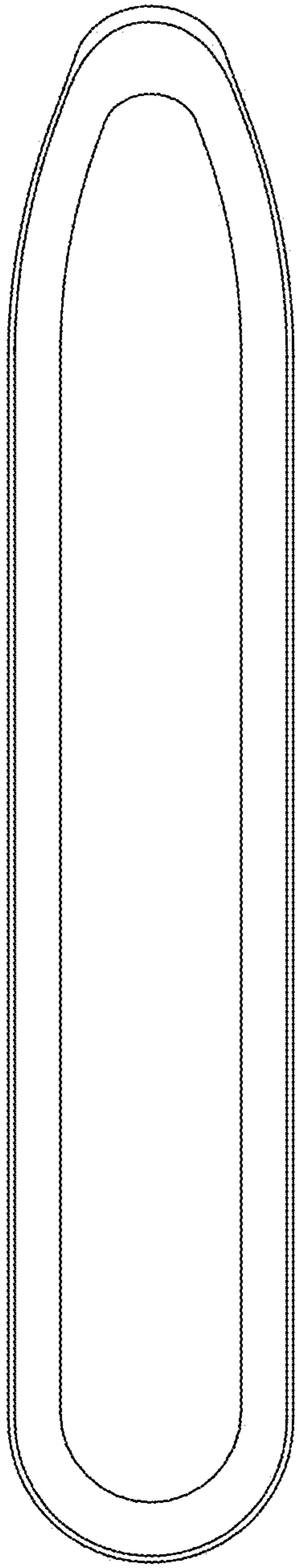

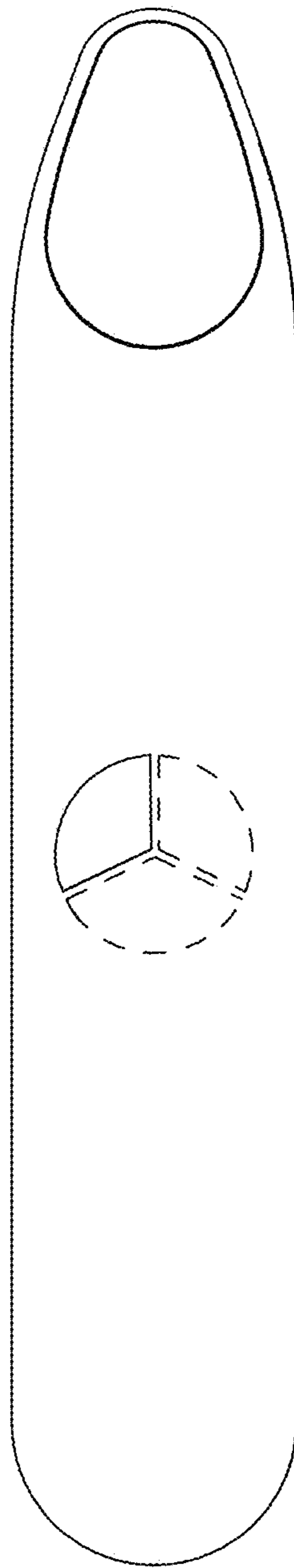

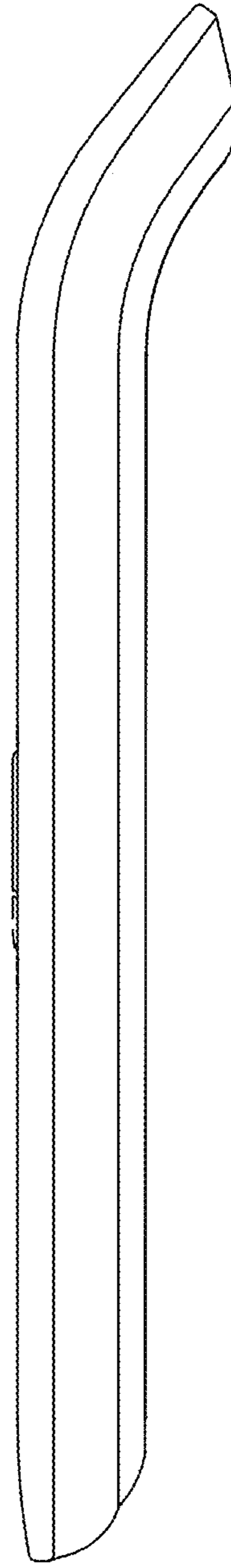

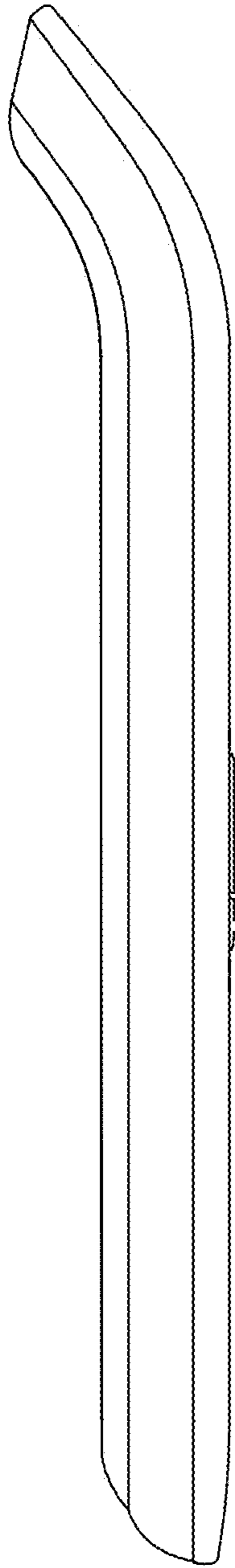

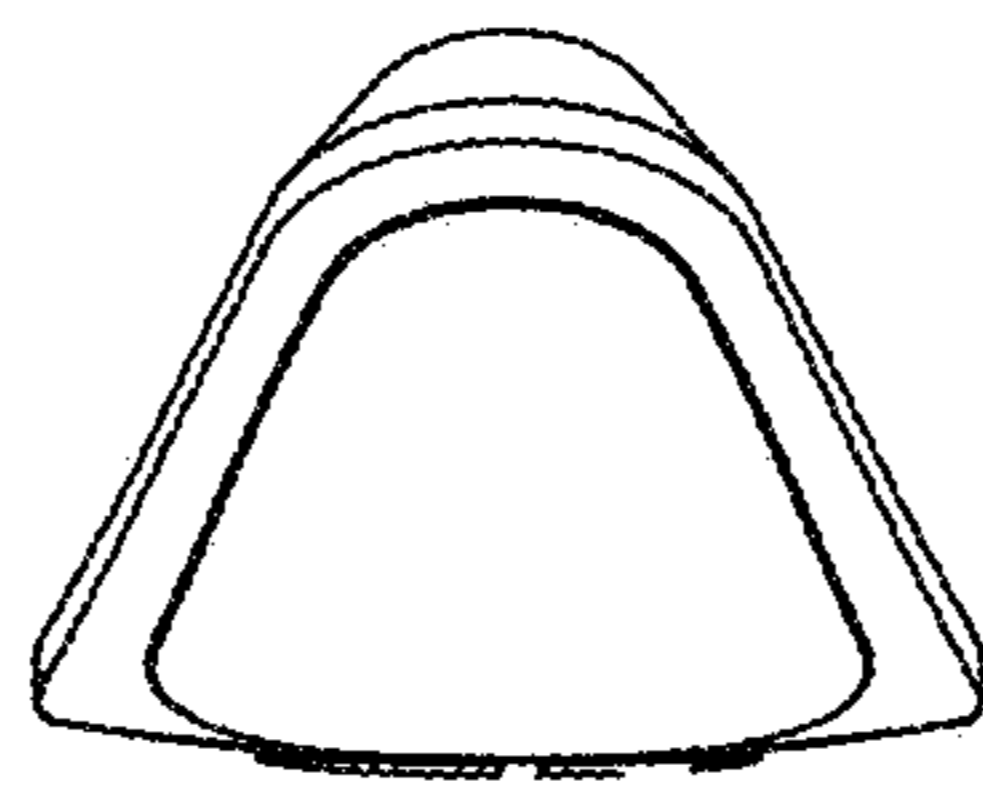

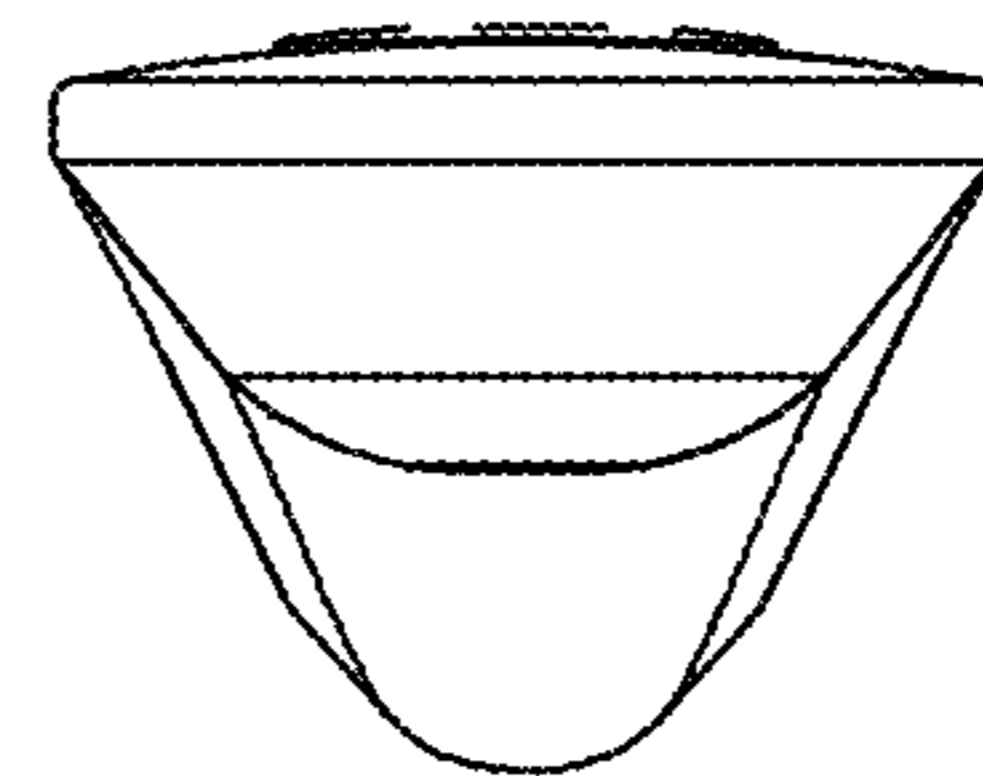
