DESCRIPTION

FIG. 1 is a top view of the candle jar according to the present invention;

FIG. 2 is an underside view thereof;

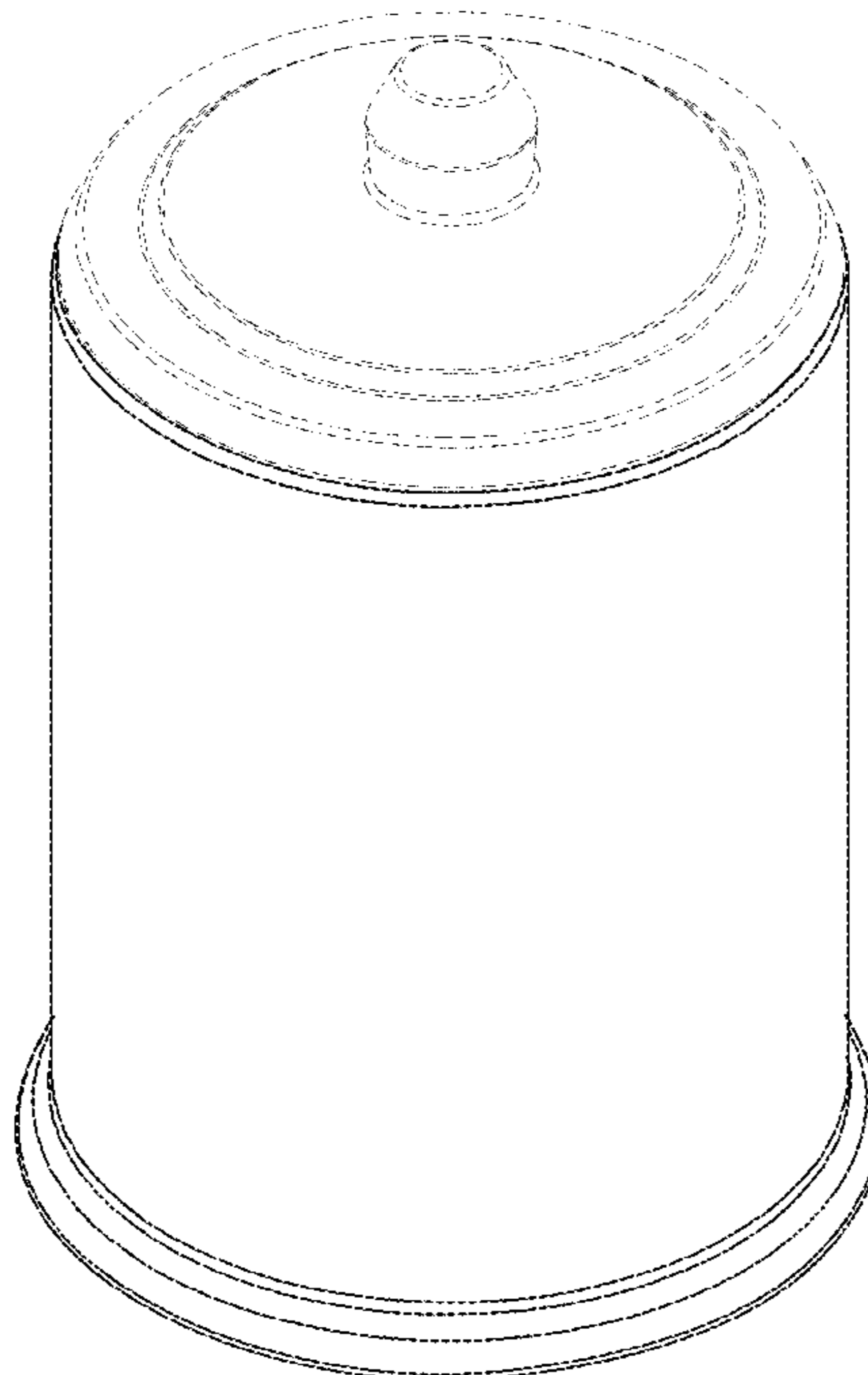
FIG. 3 is a side view thereof, all other sides being identical;

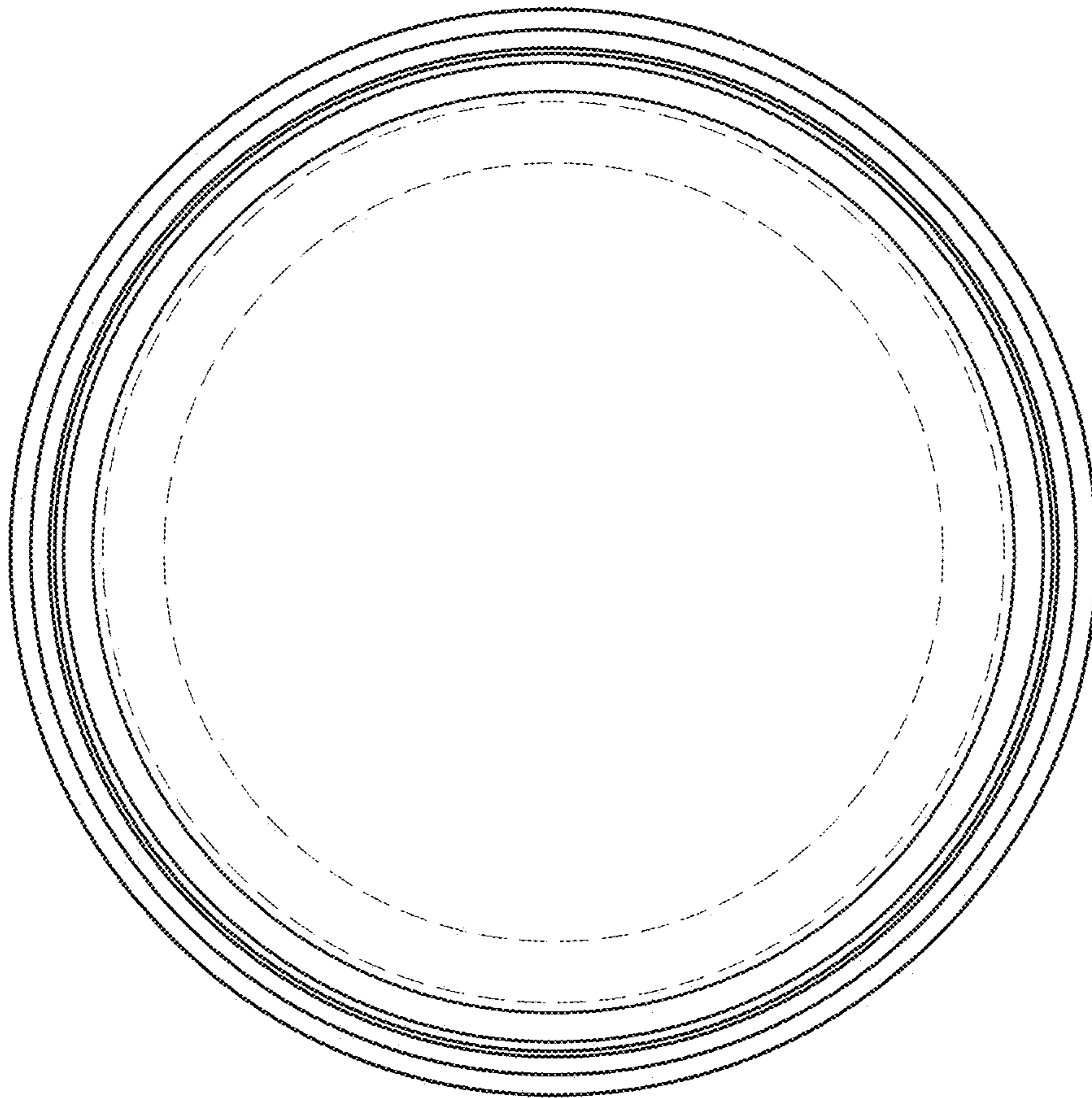

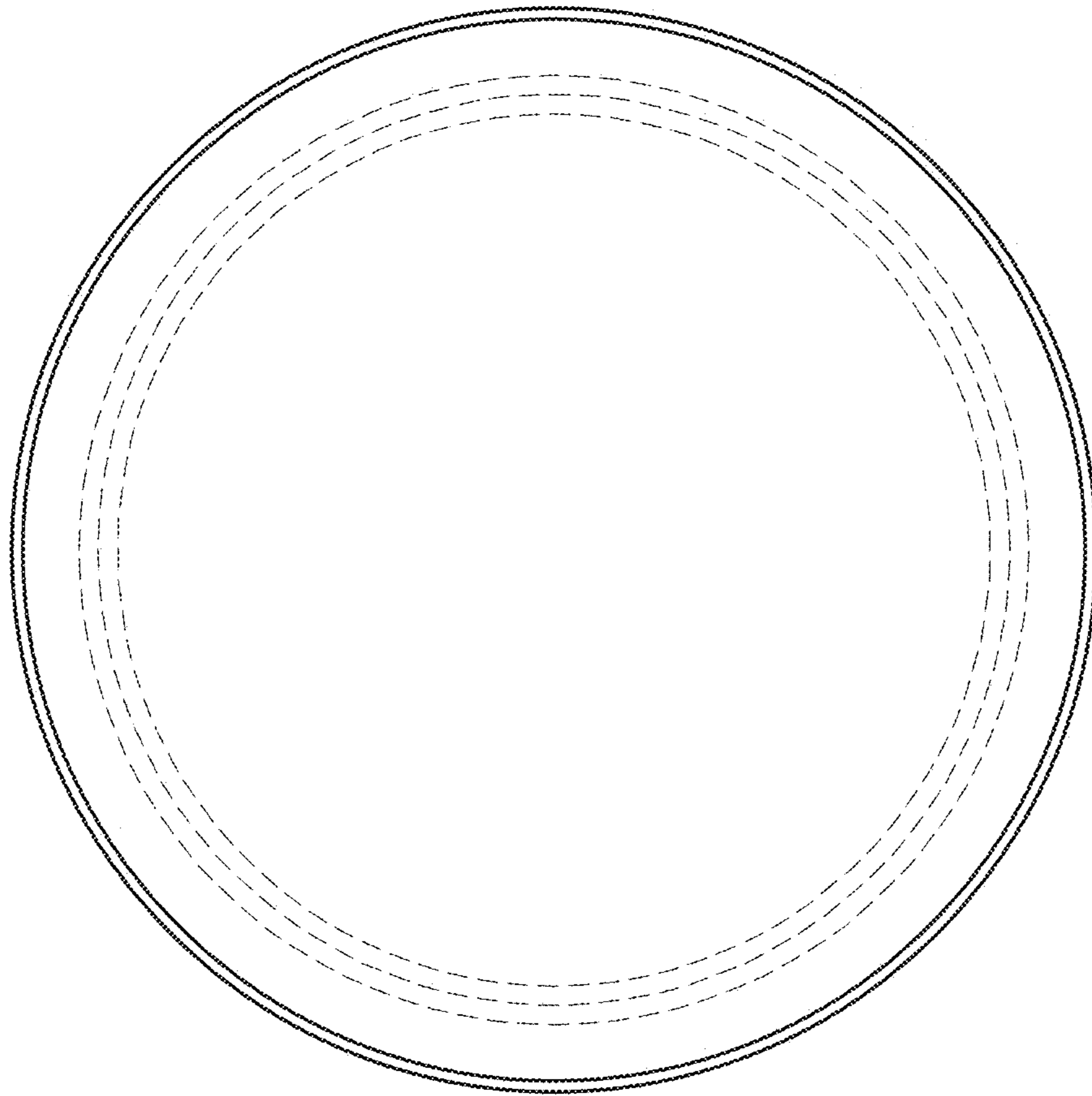

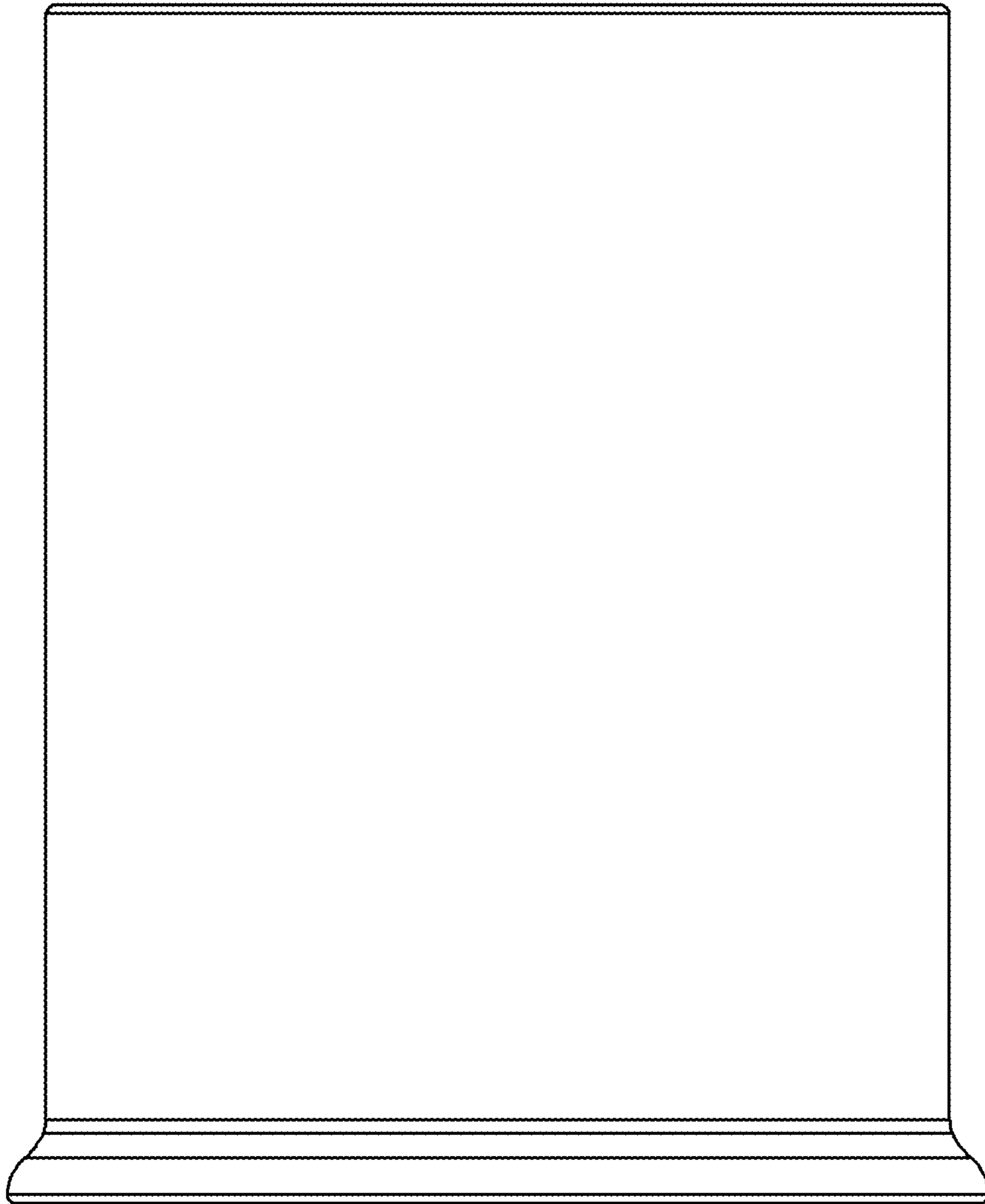

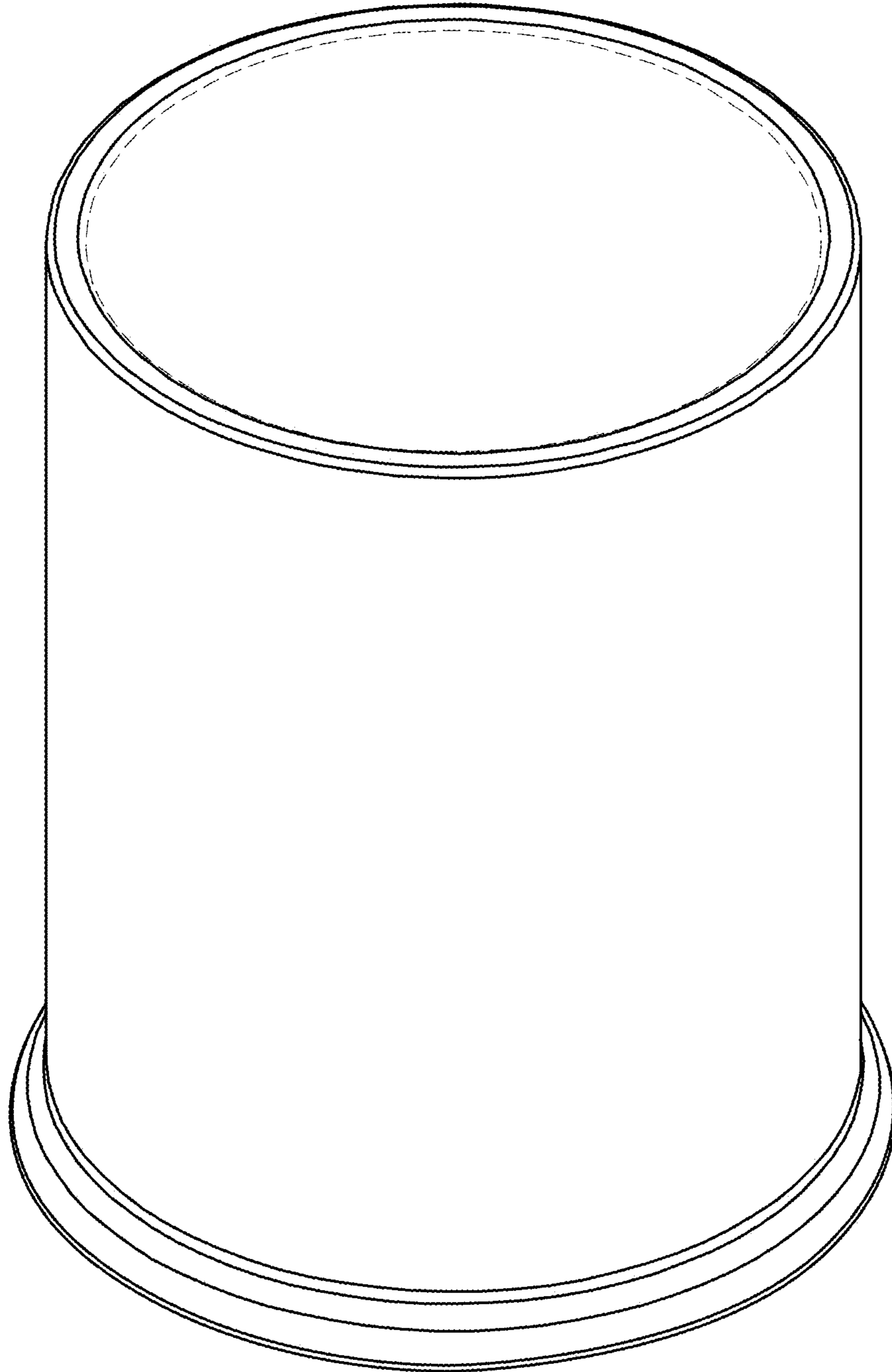

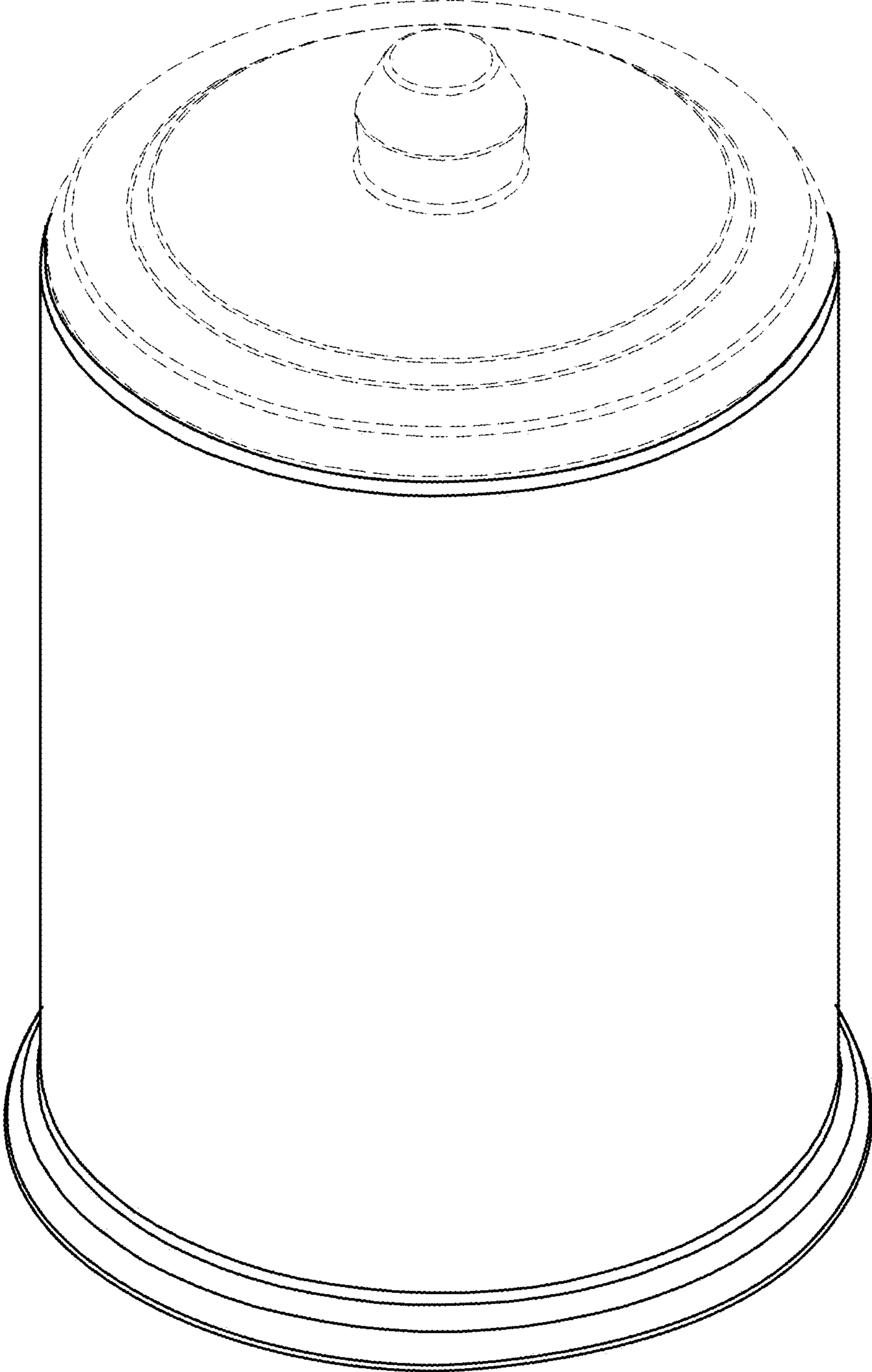
