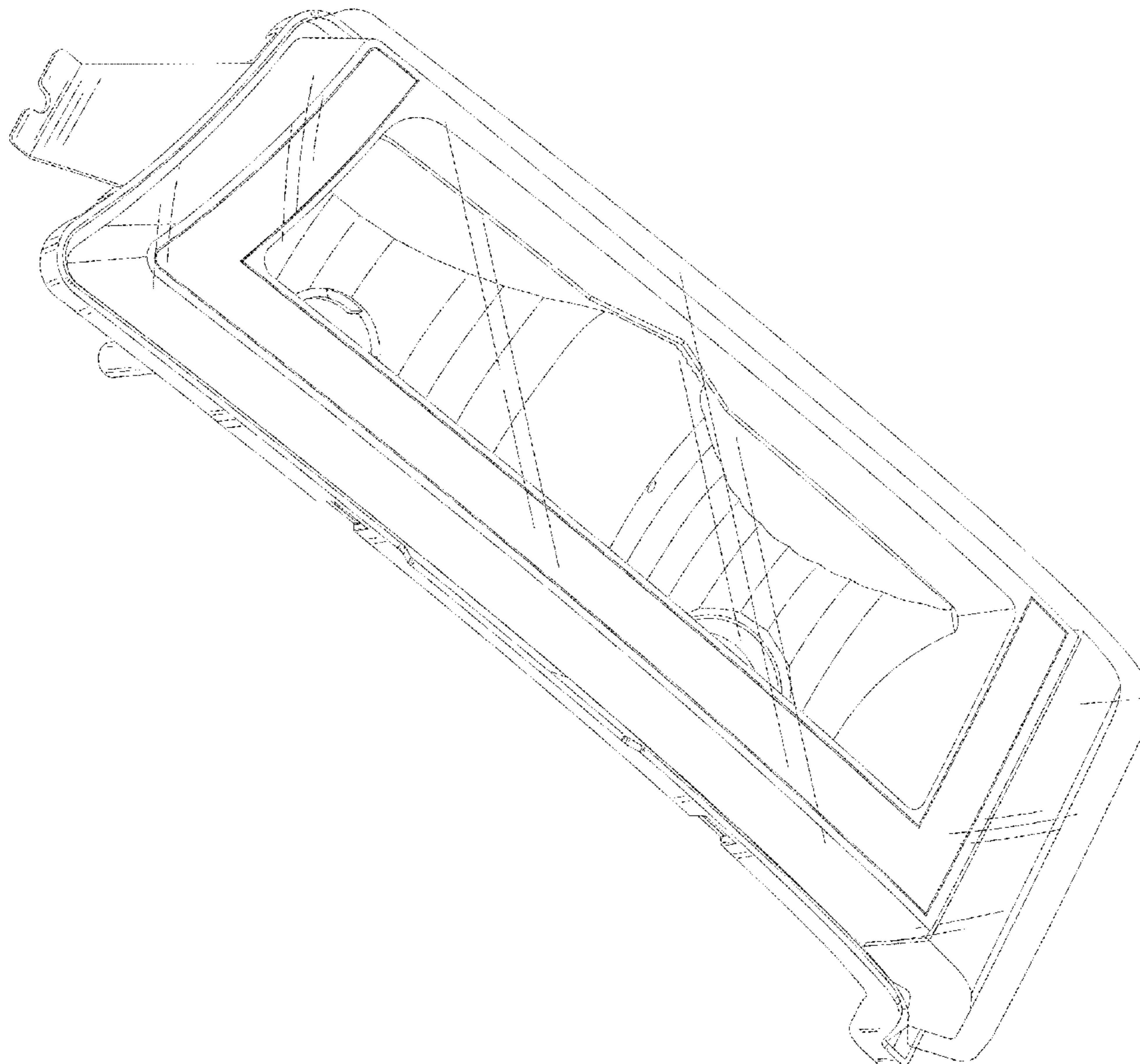
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of vehicle headlight showing our new design;

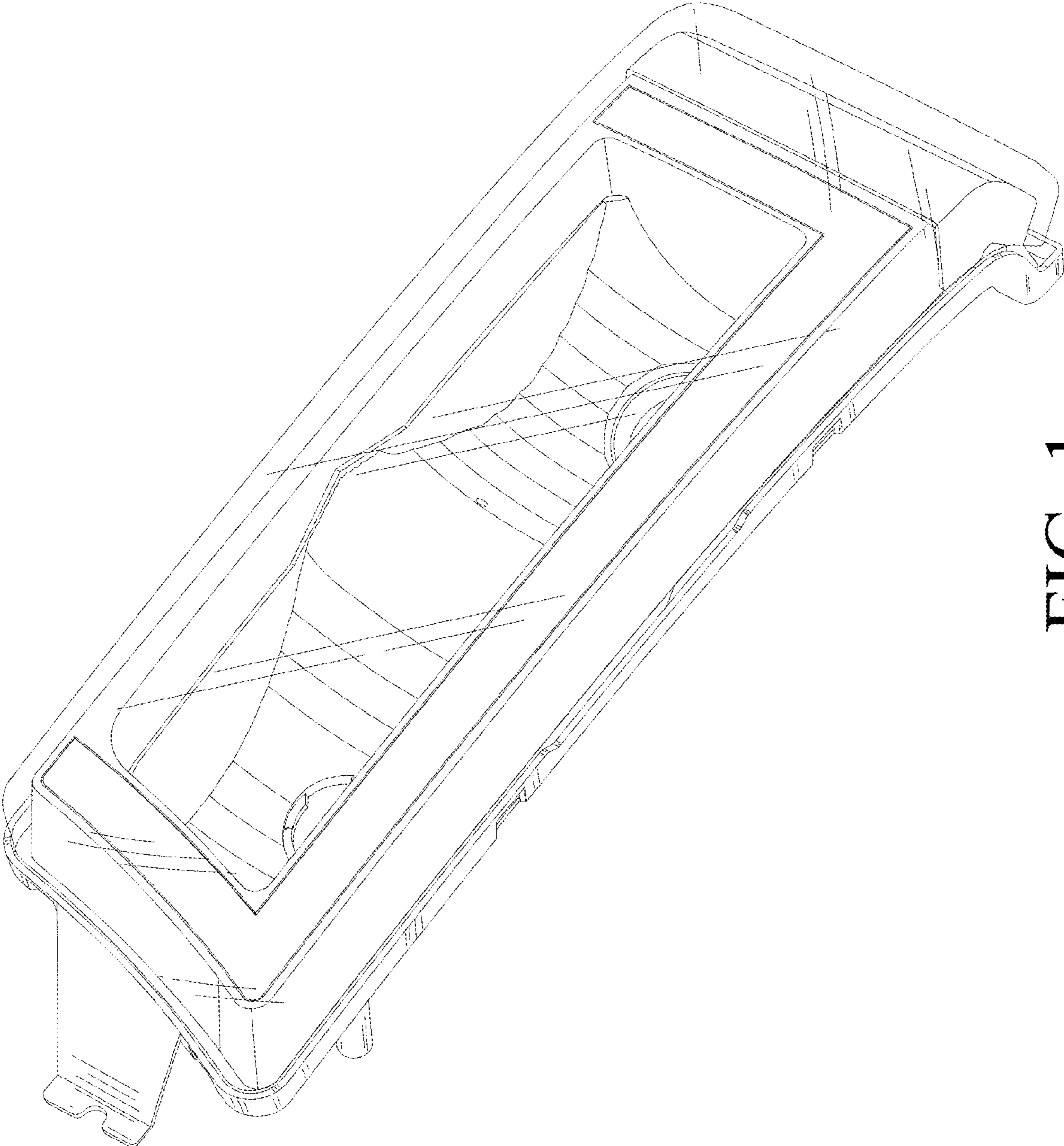

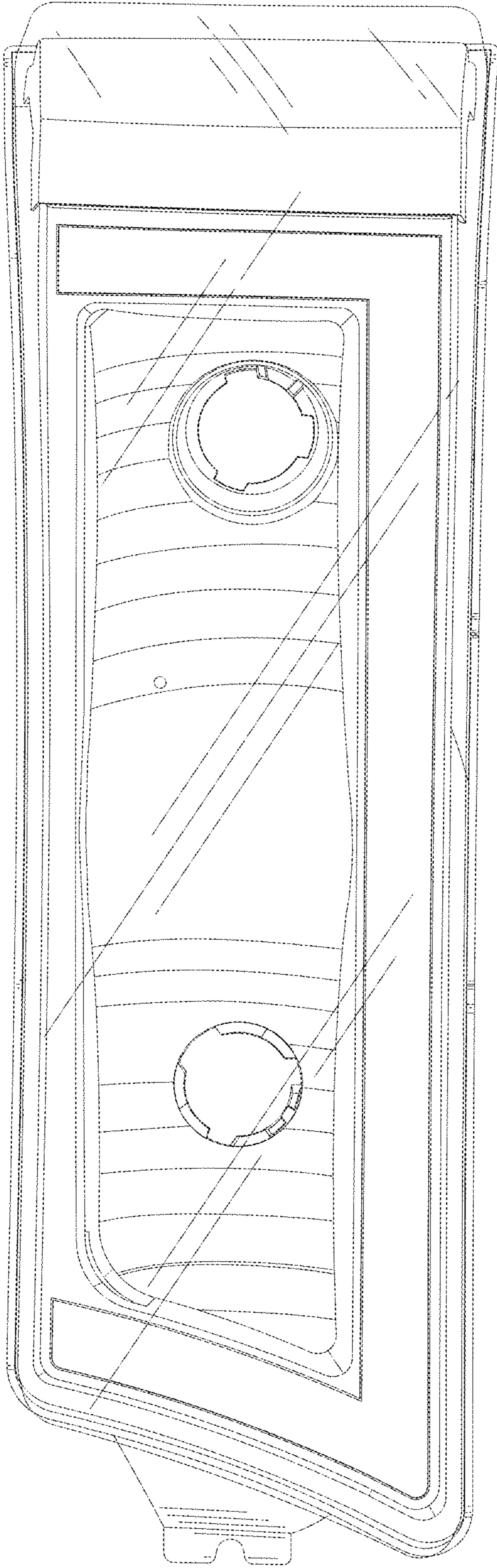

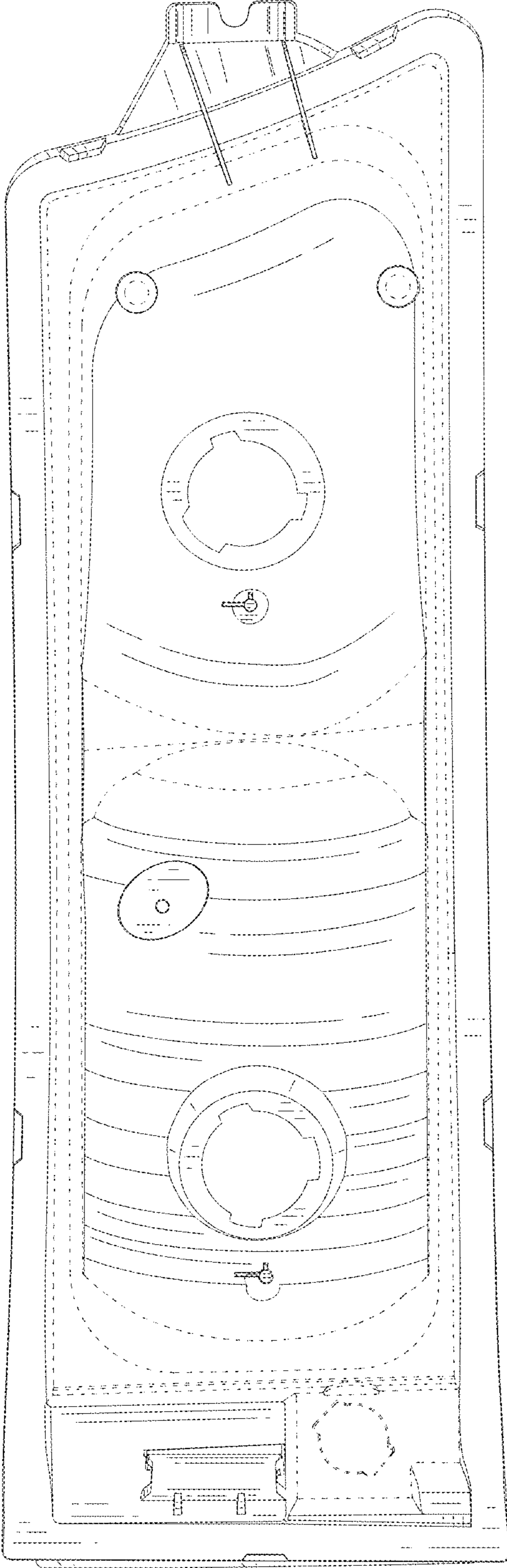

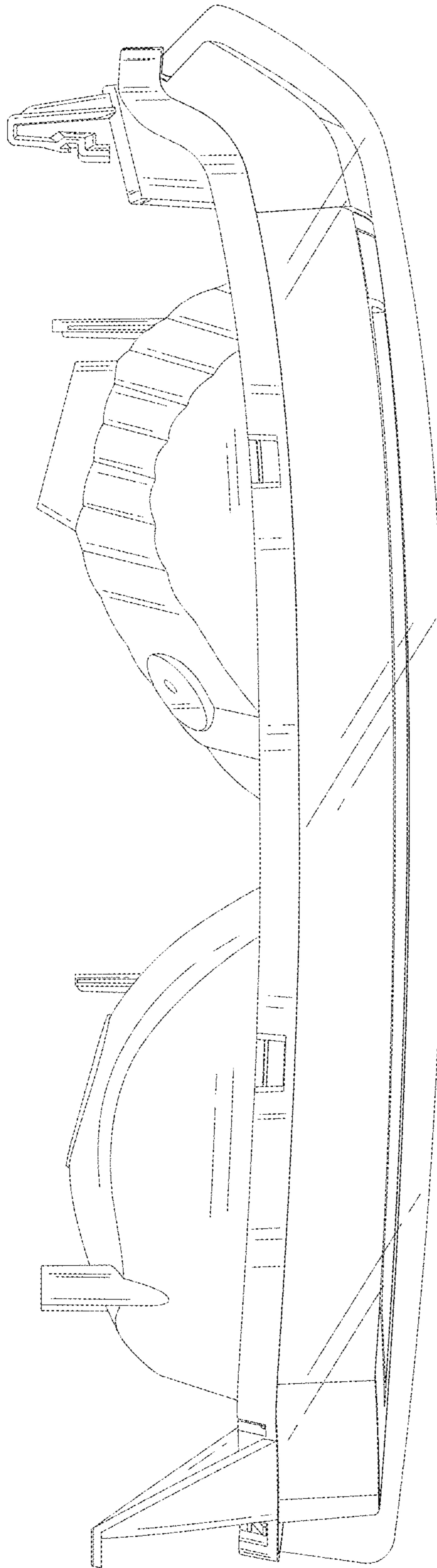

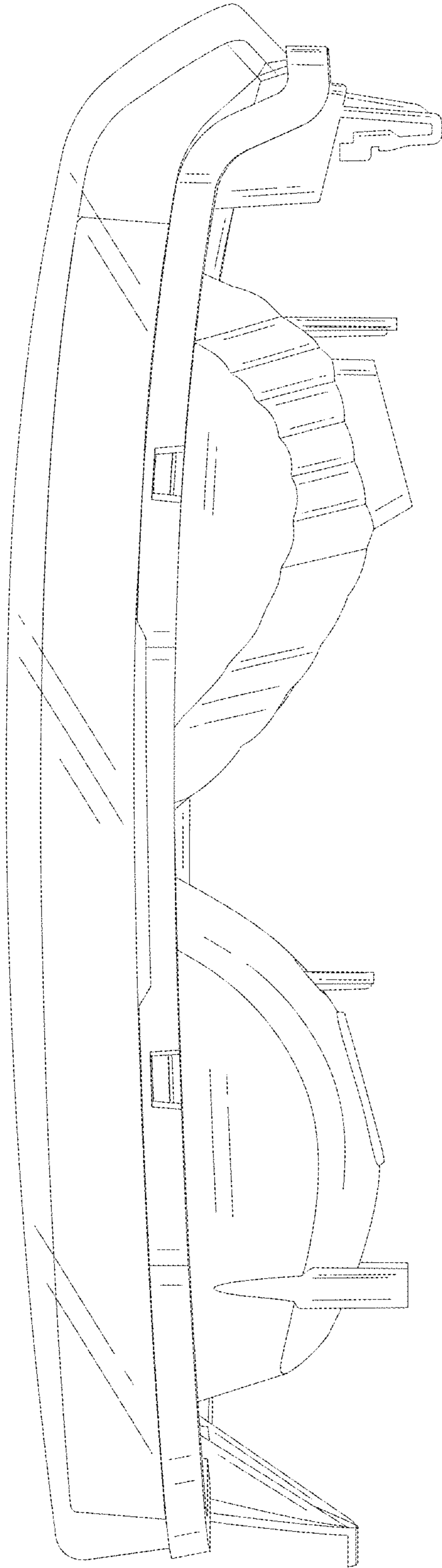

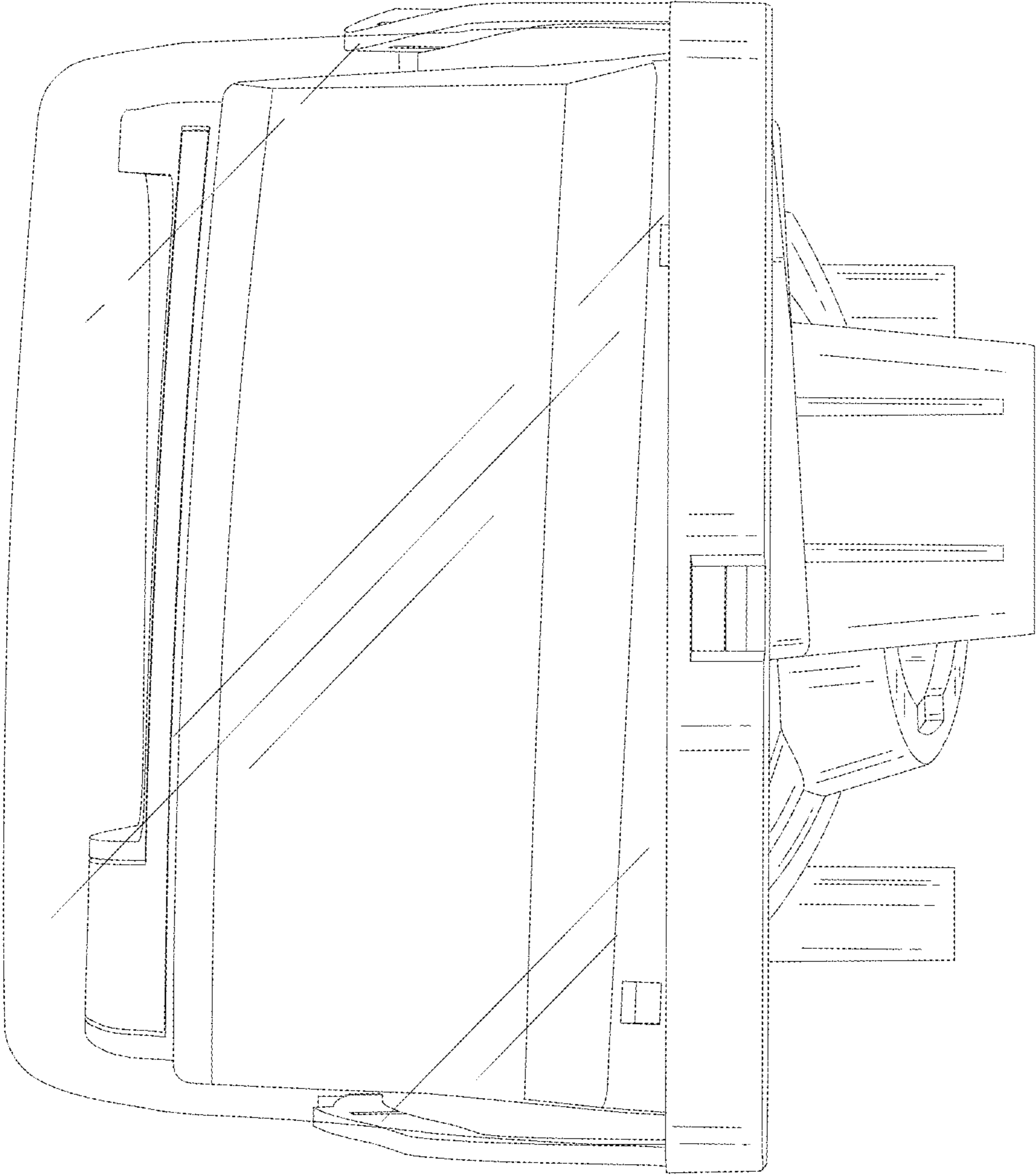

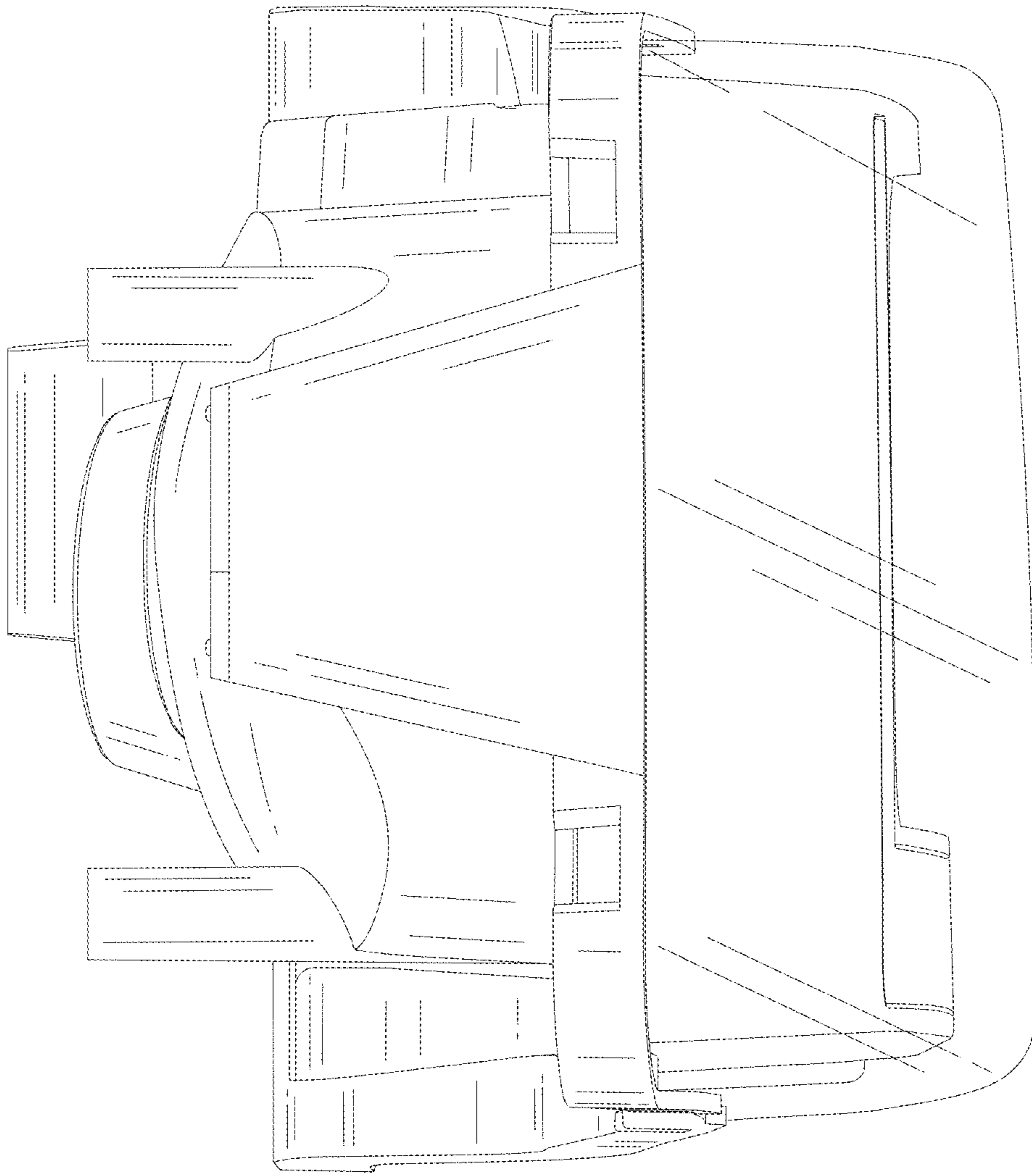
